DESCRIPTION

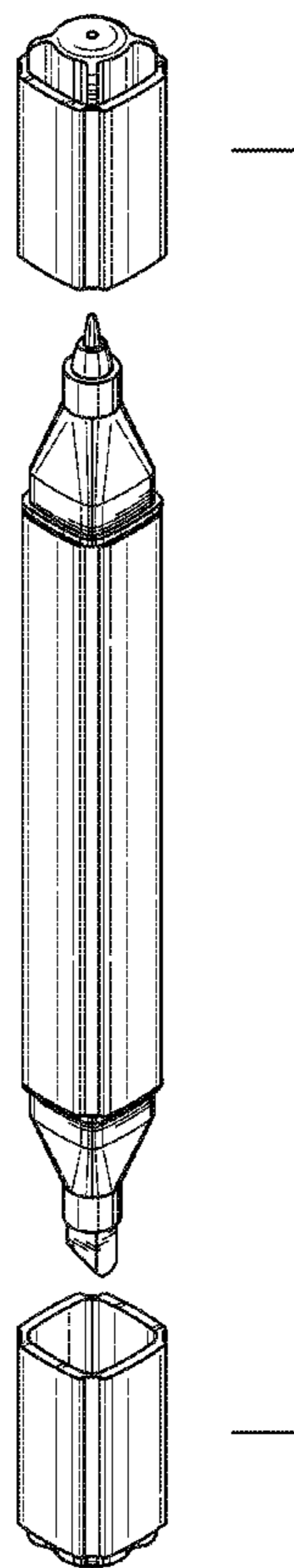
FIG. 1 is a perspective view of a marker showing my new design;

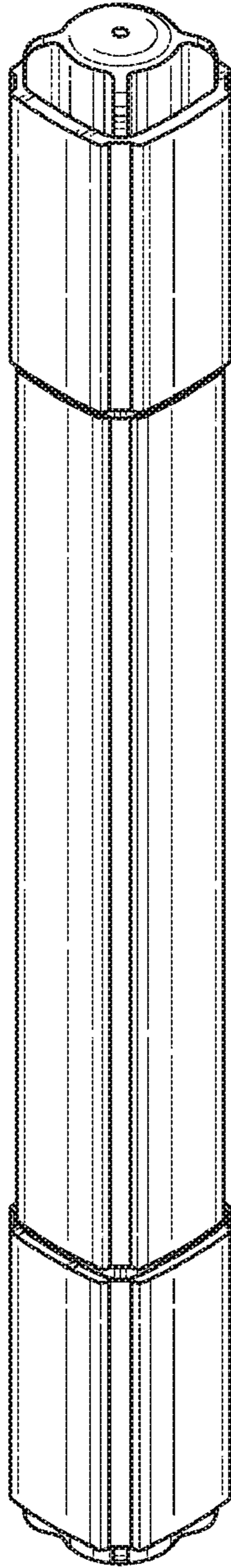

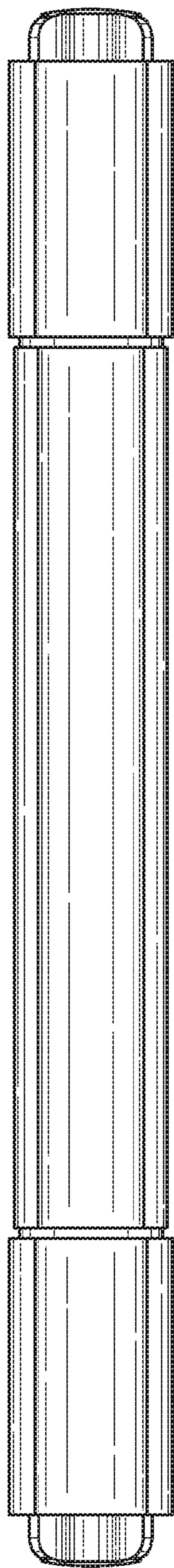

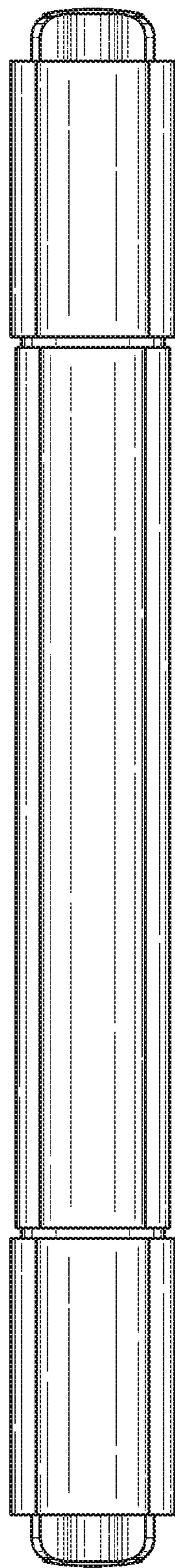

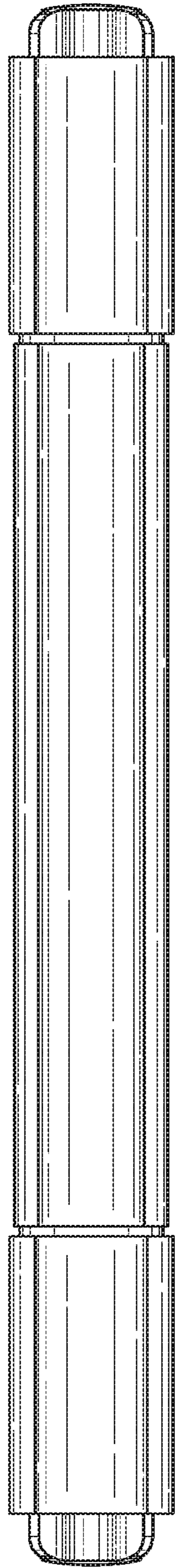

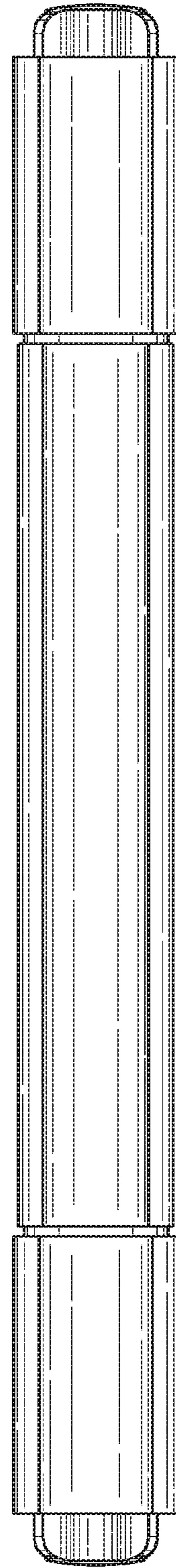

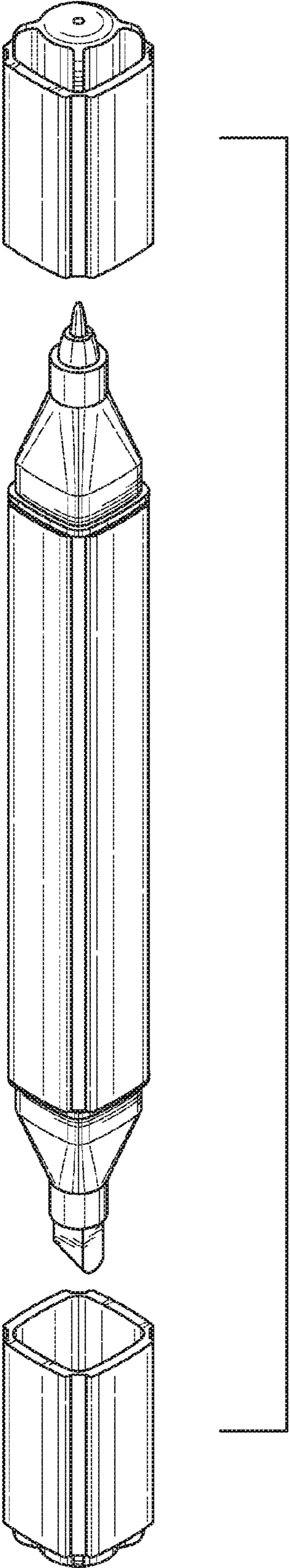
