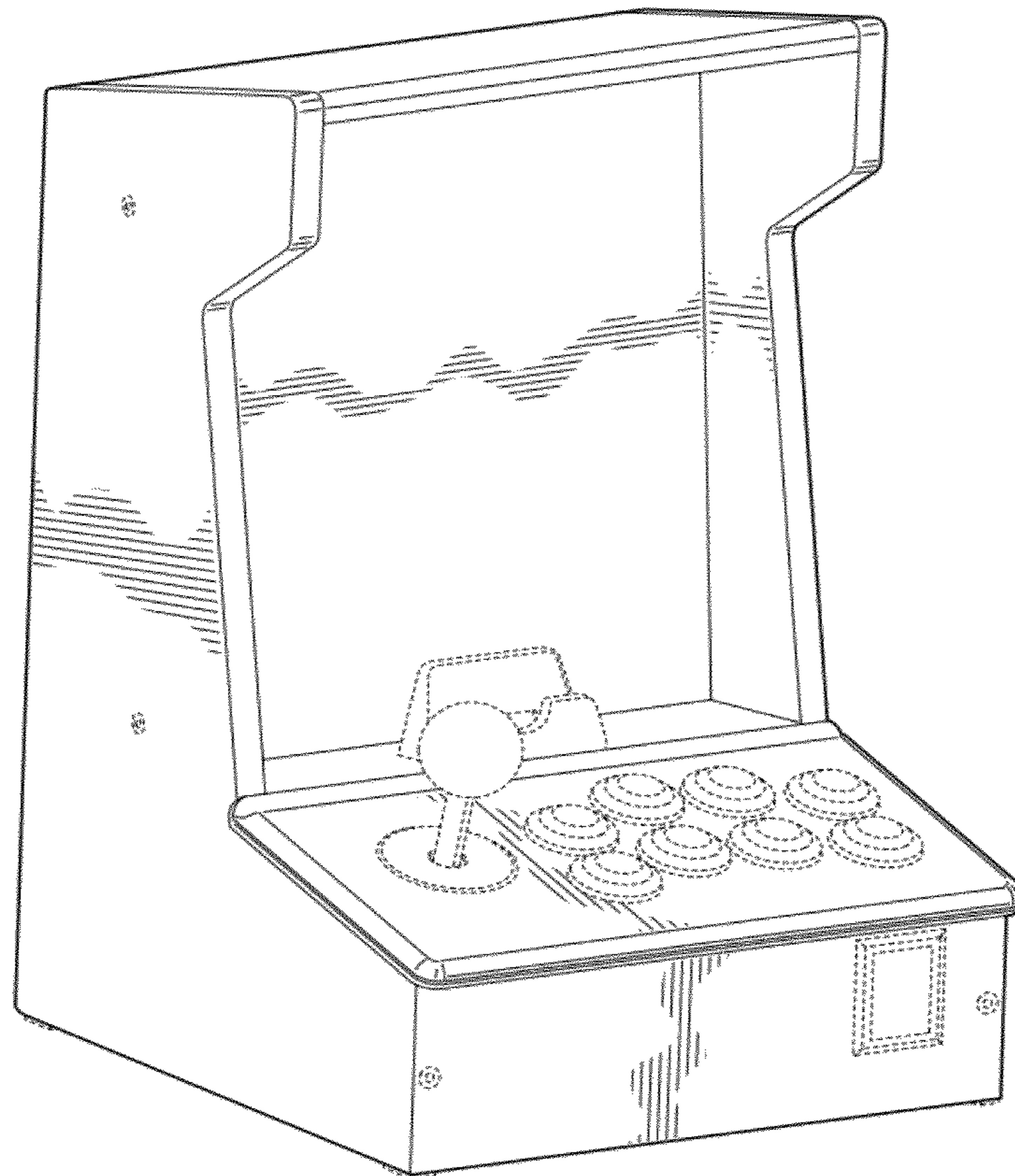
(57) **CLAIM**

The ornamental design for an arcade-style cabinet for a tablet computer, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left perspective view of an arcade-style cabinet for a tablet computer showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines structures are for illustrative purpose only and form no part of the claimed design.

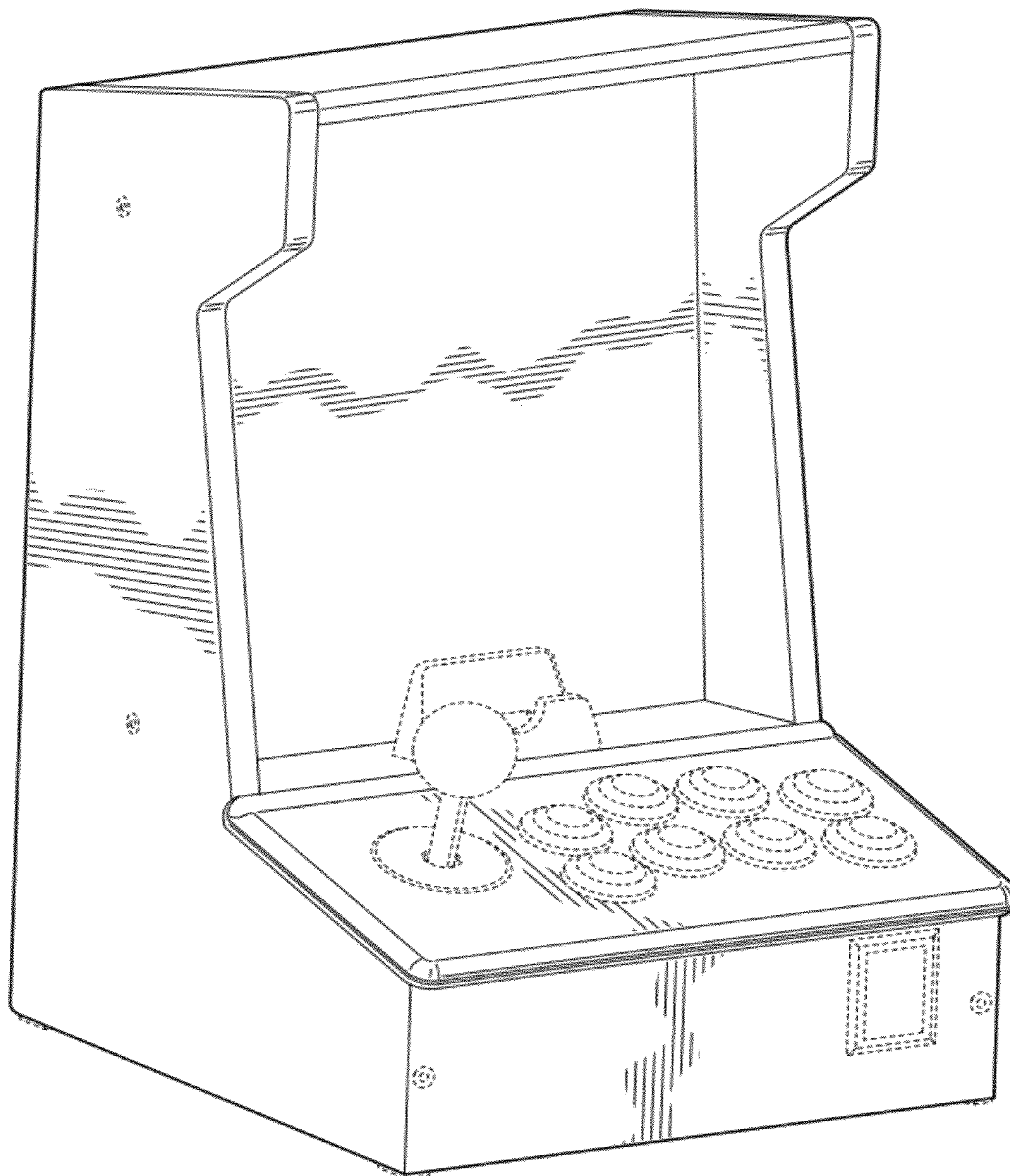

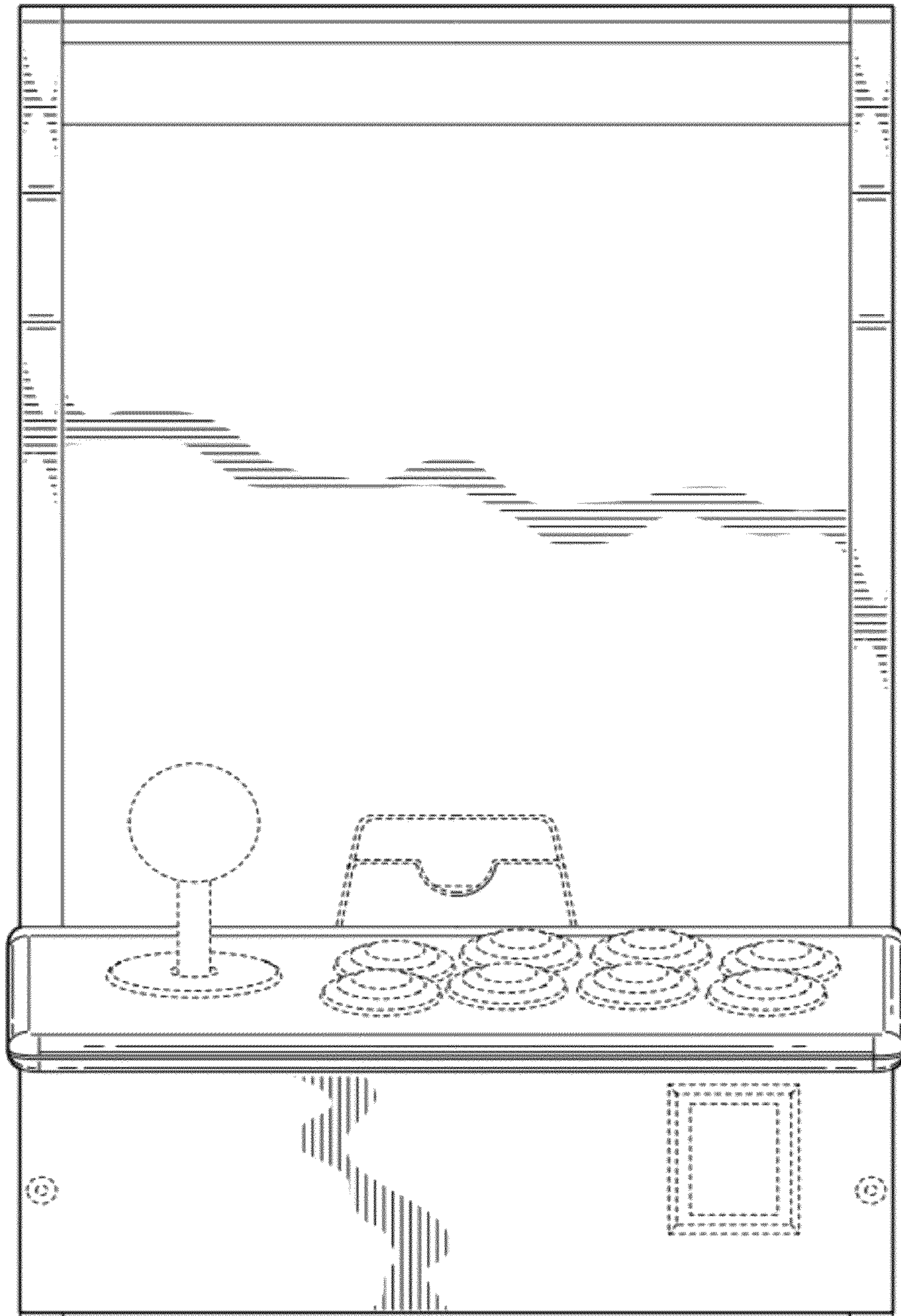

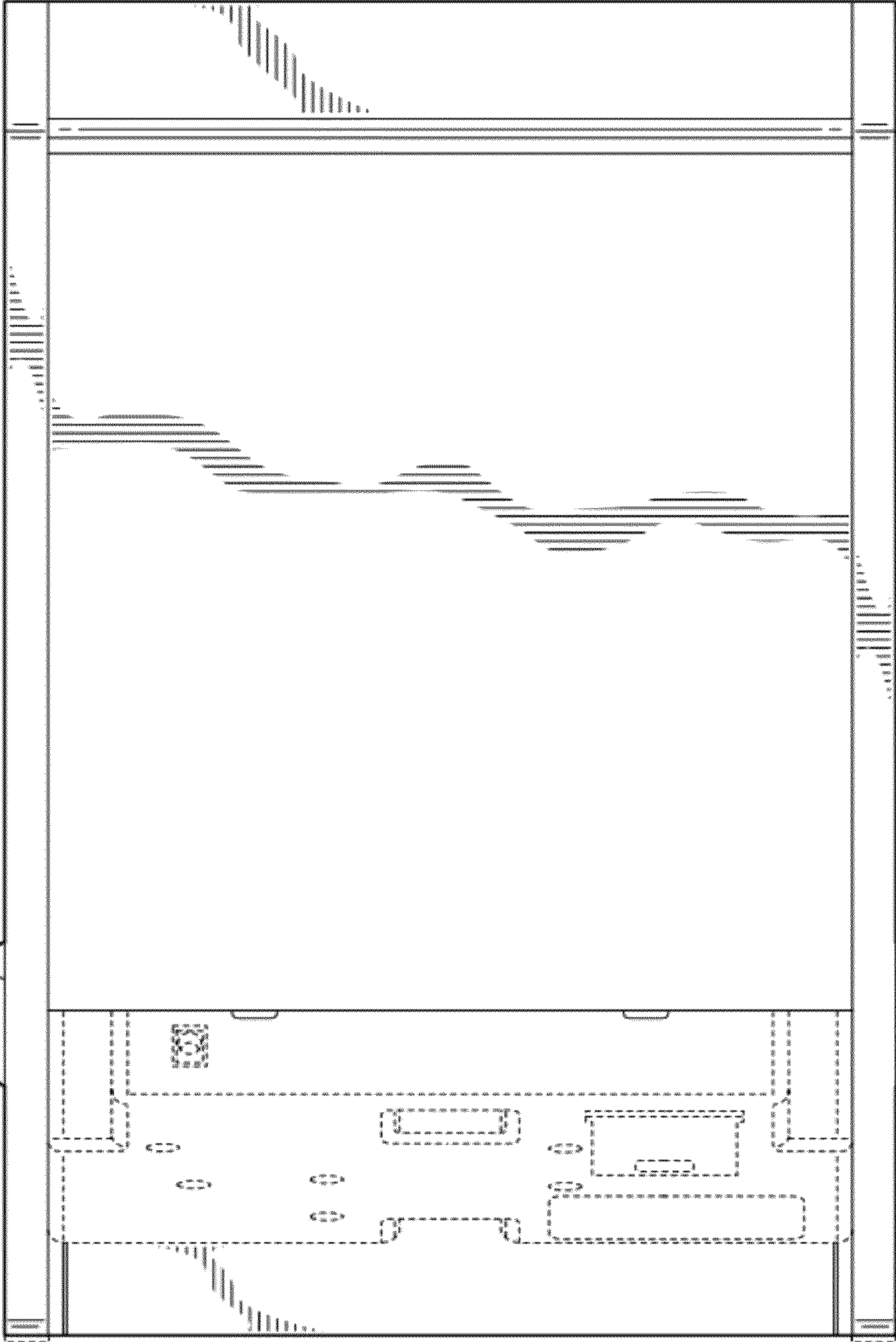

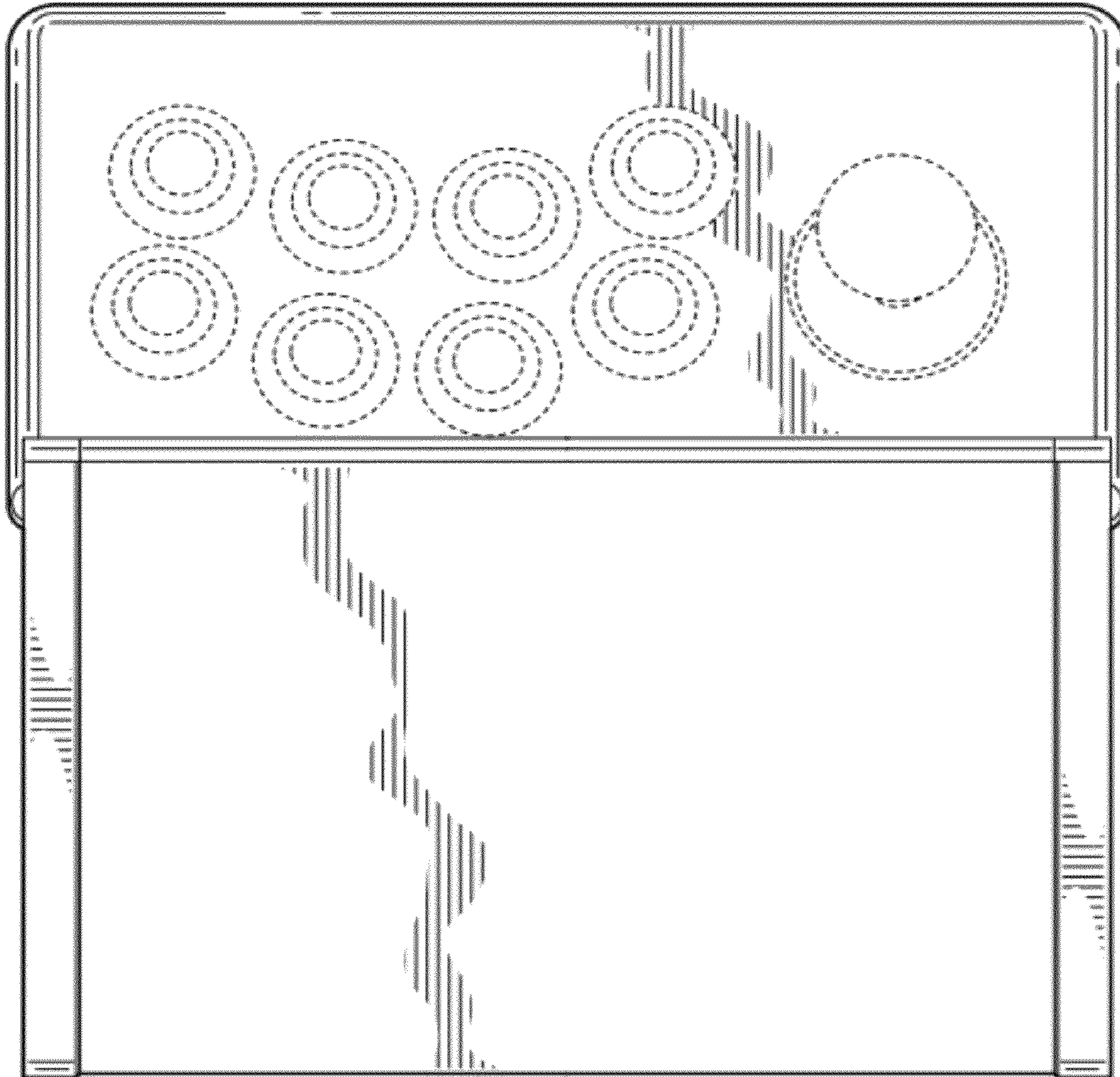

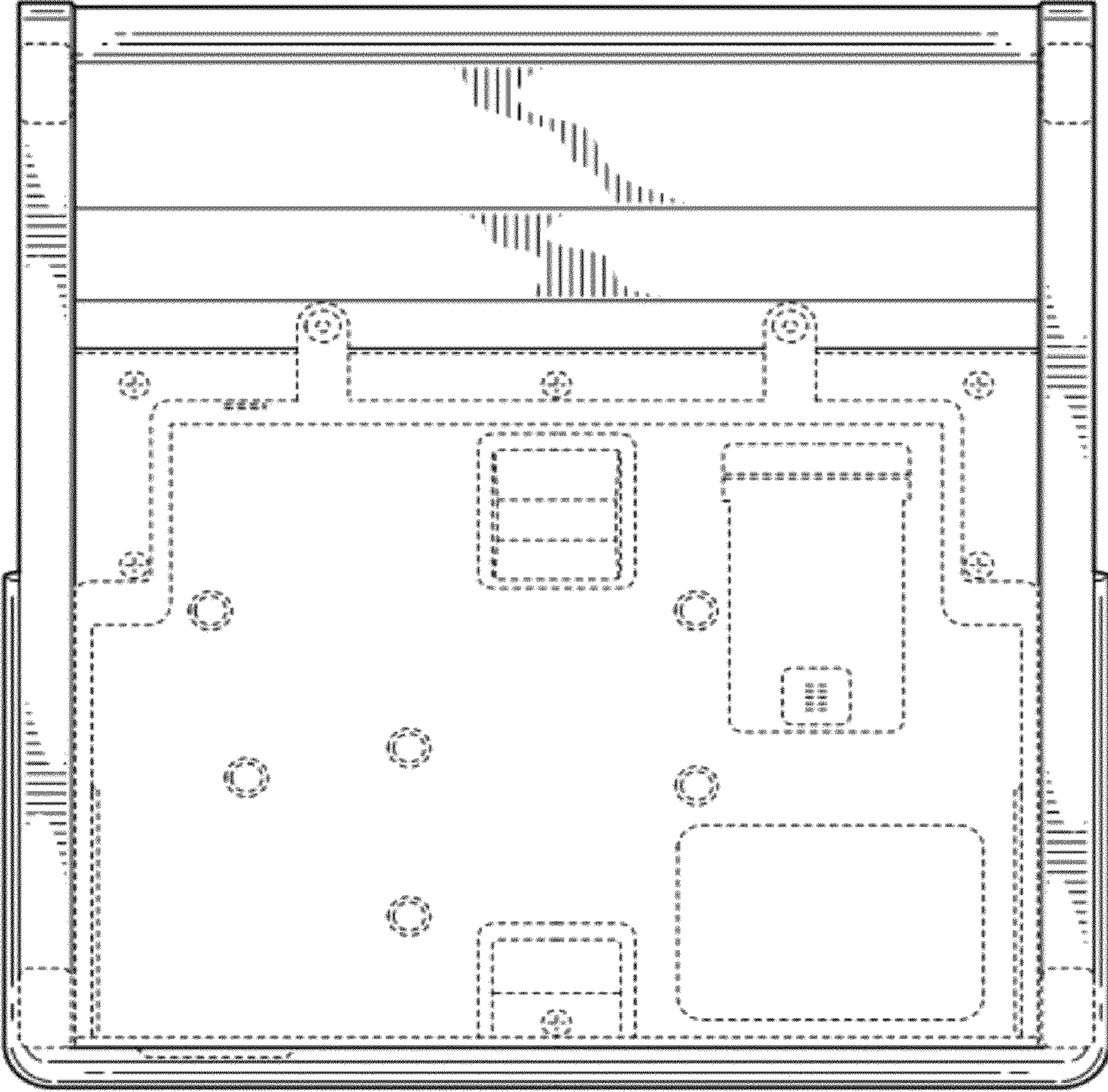

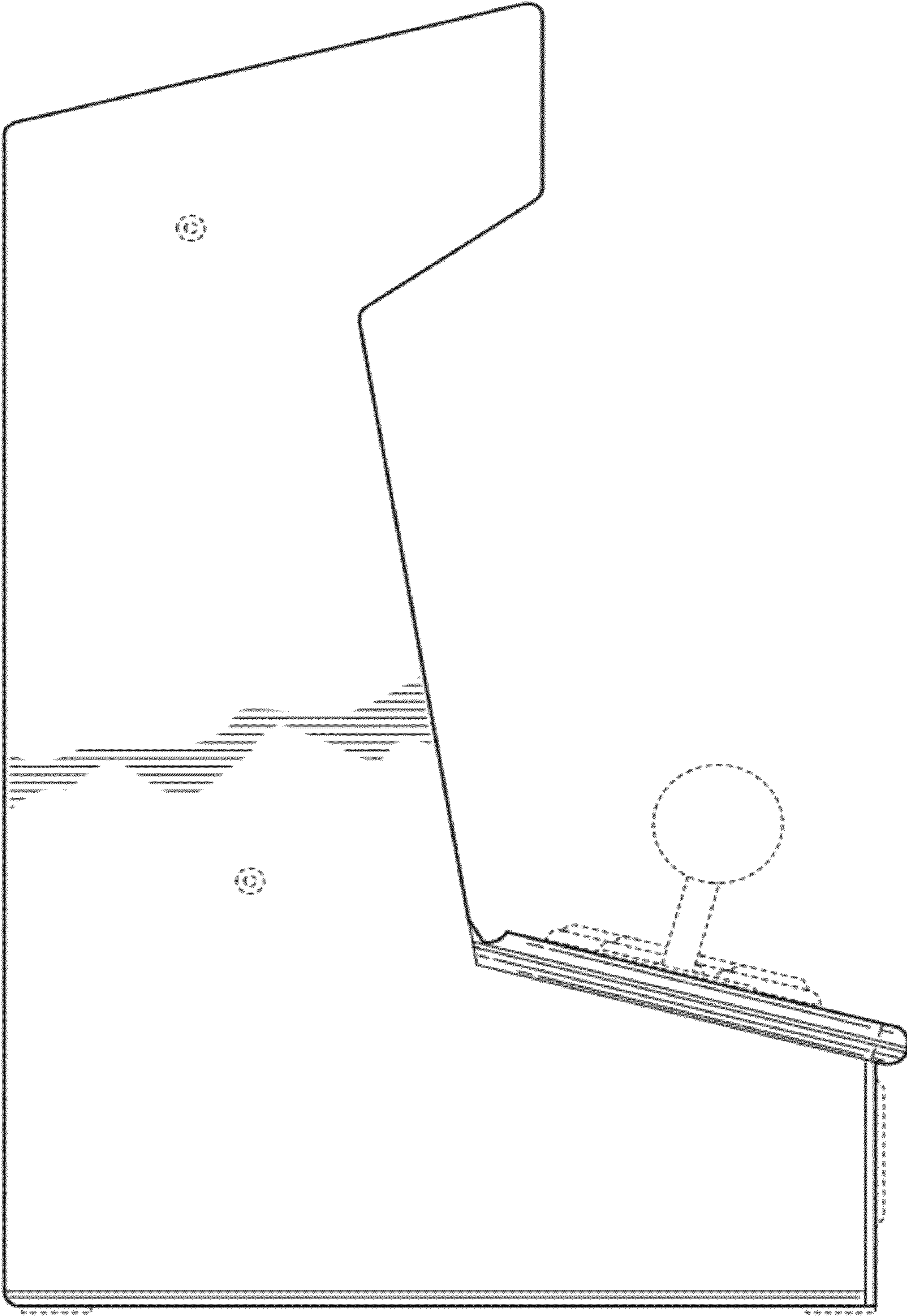

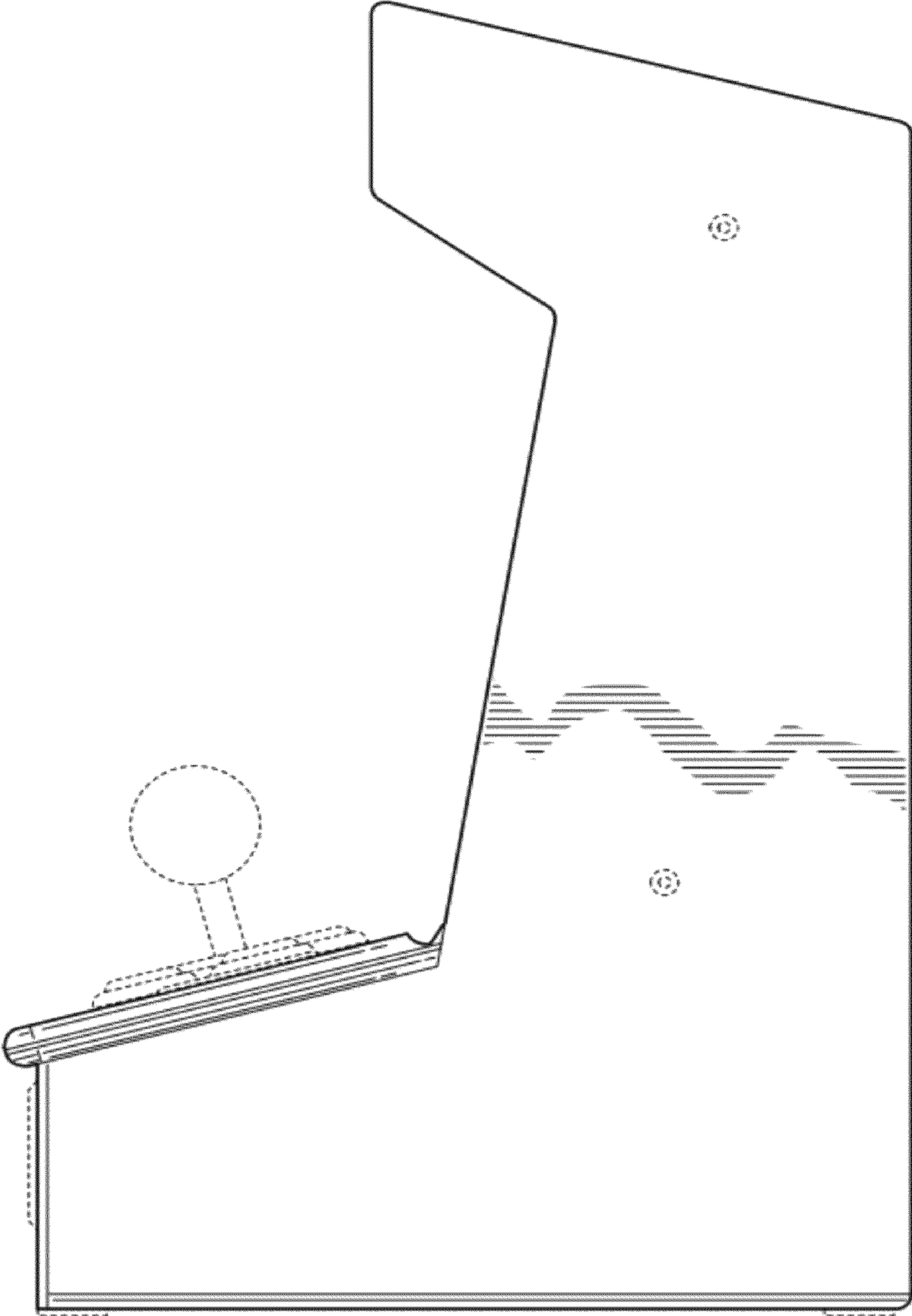
