DESCRIPTION

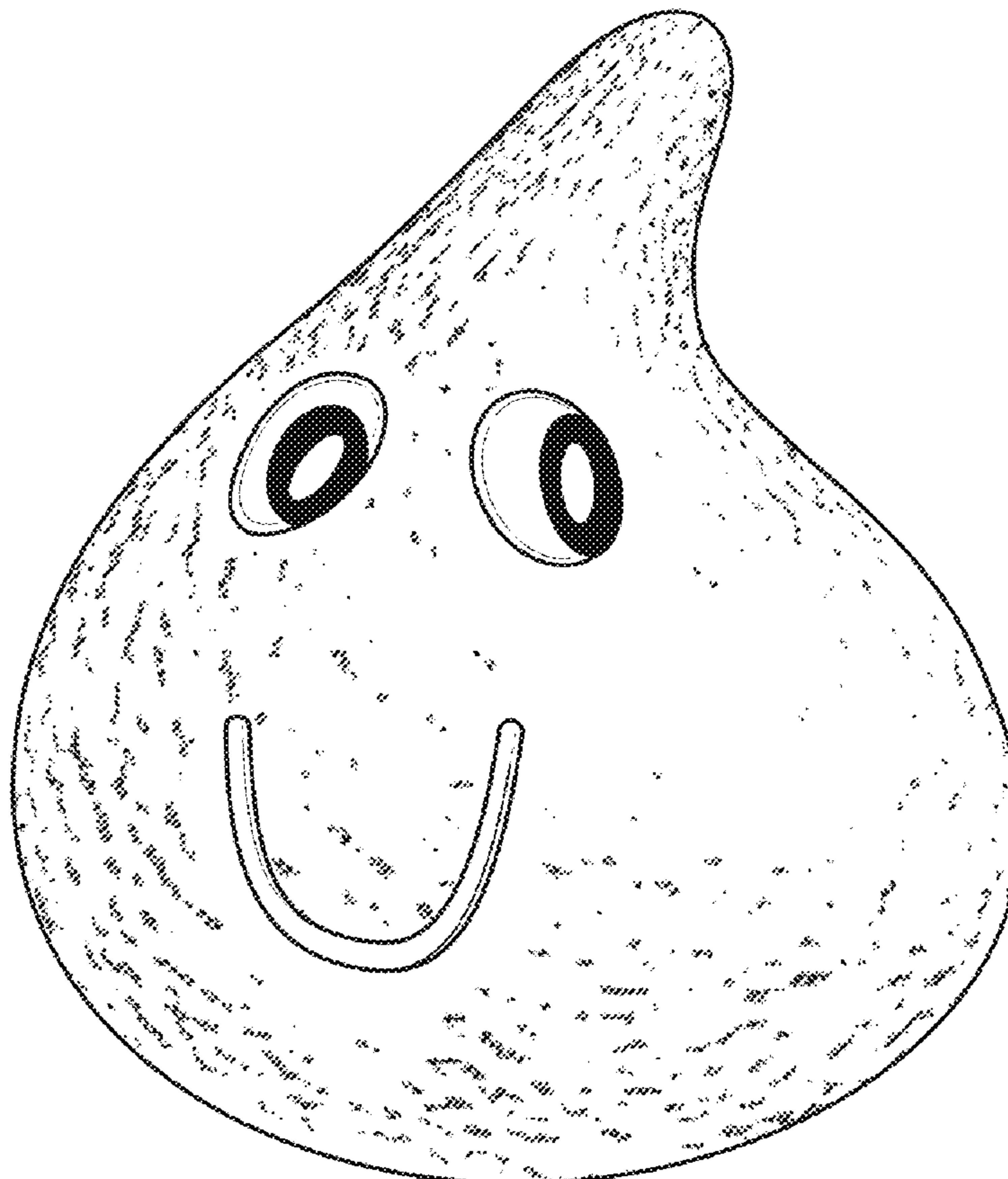
FIG. 1 is a front view of the dew drop shaped toy.

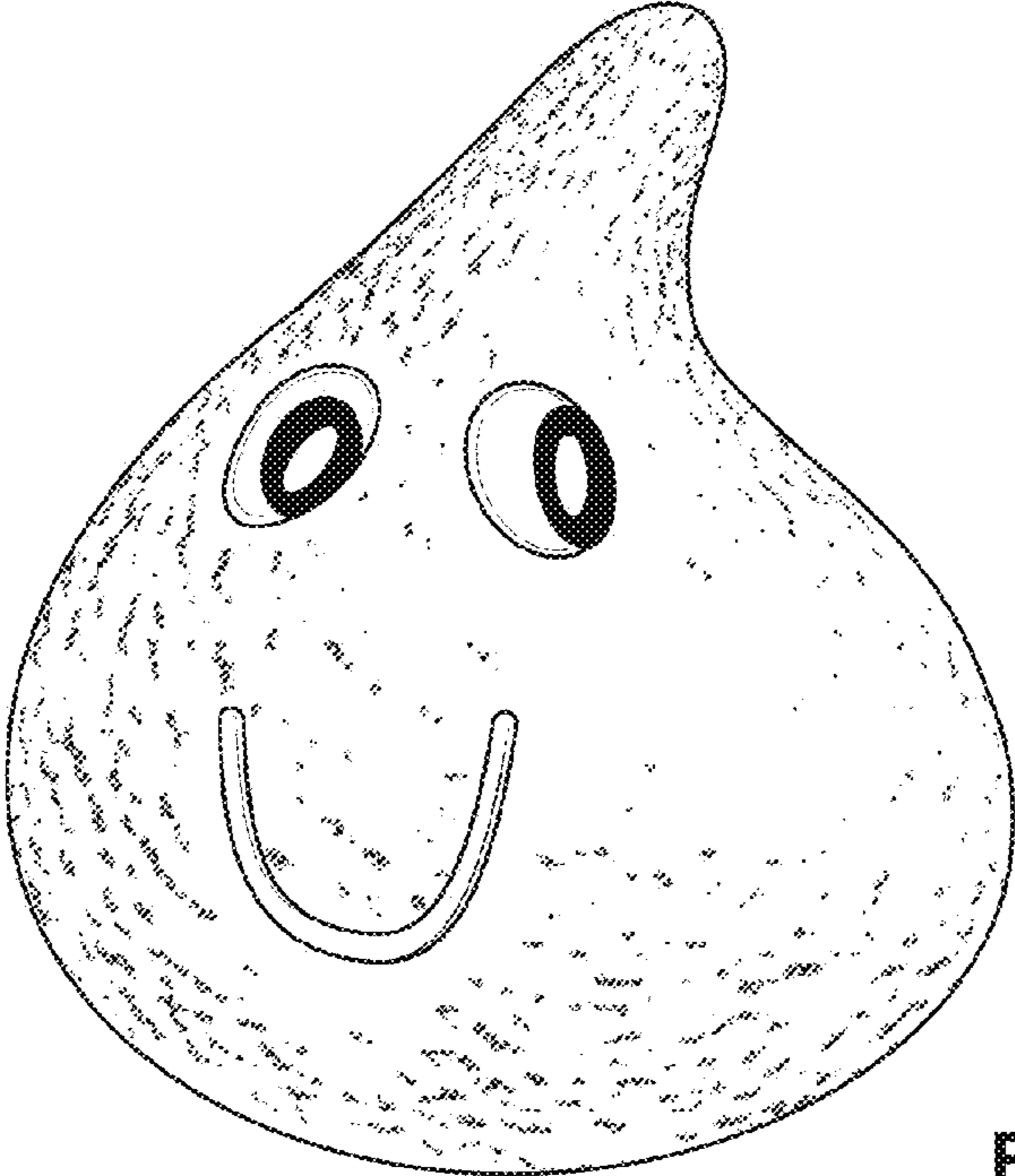

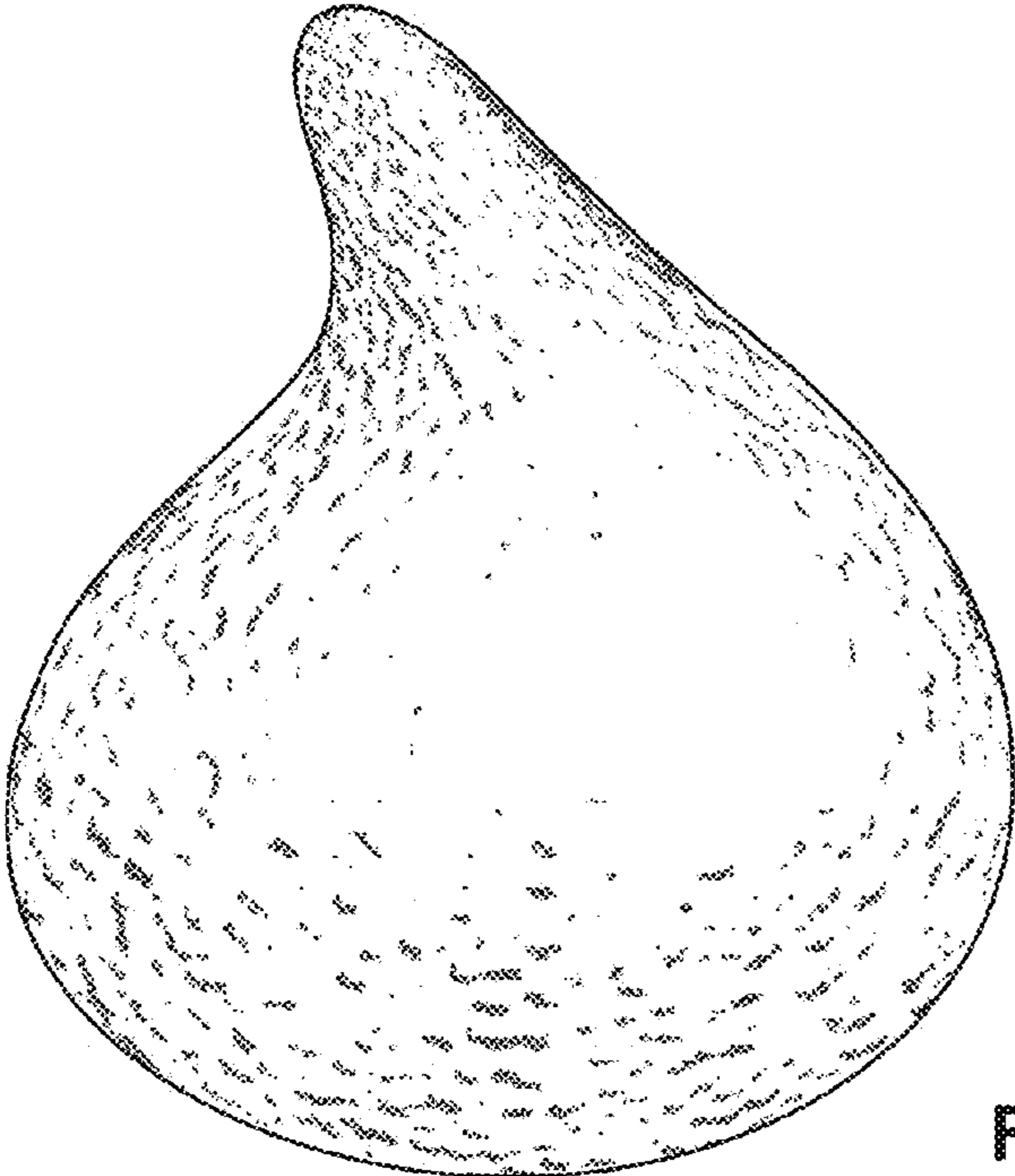

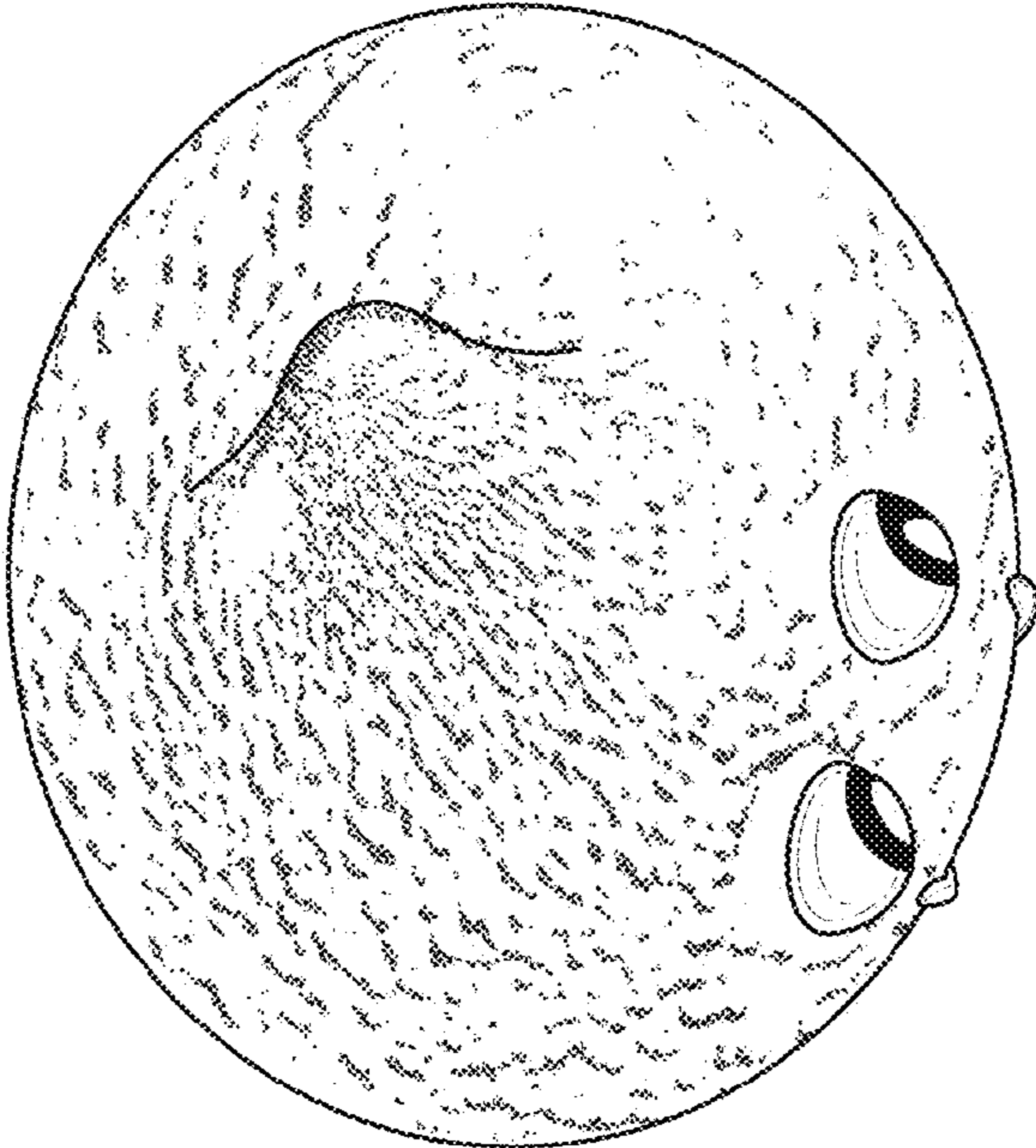

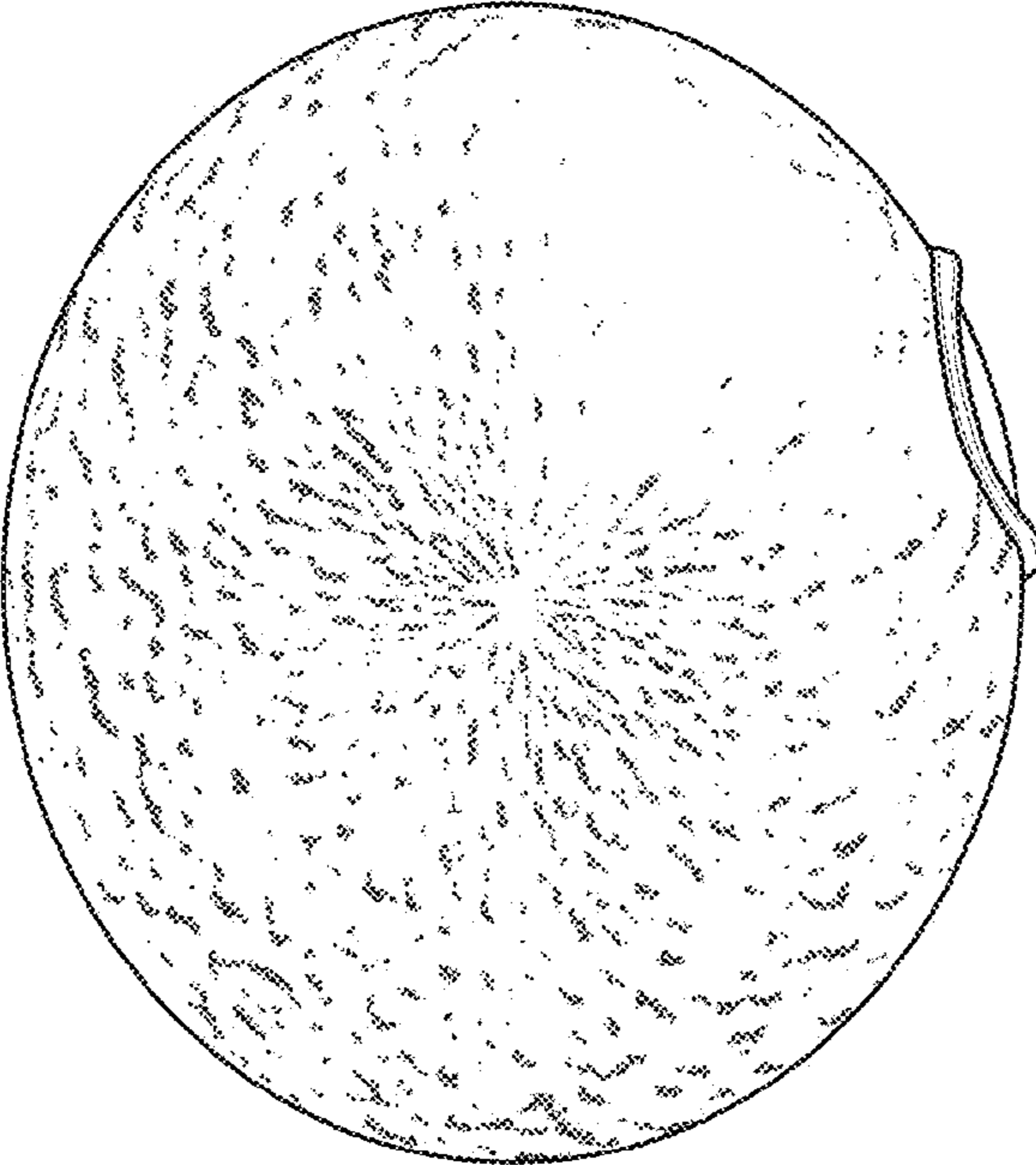

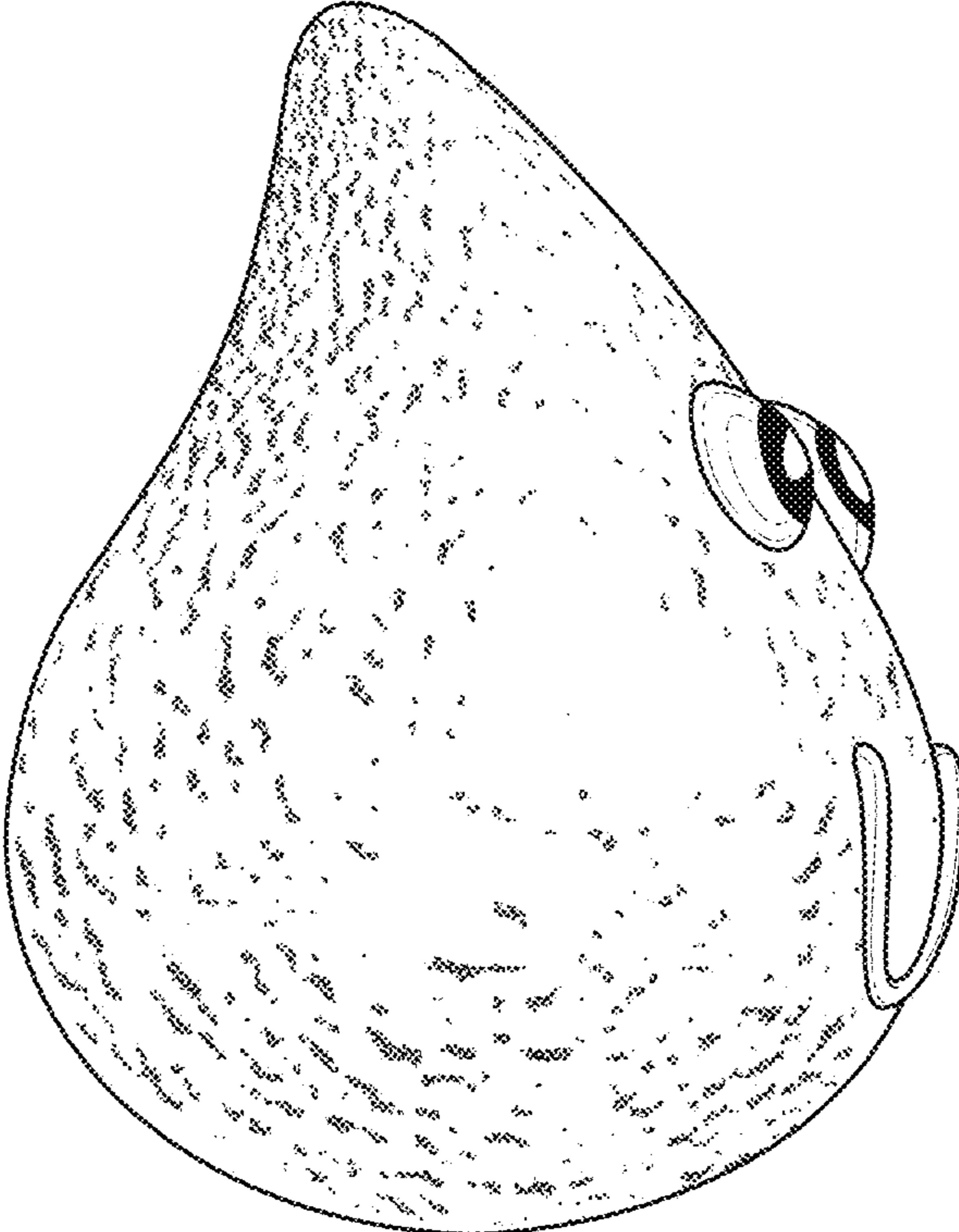

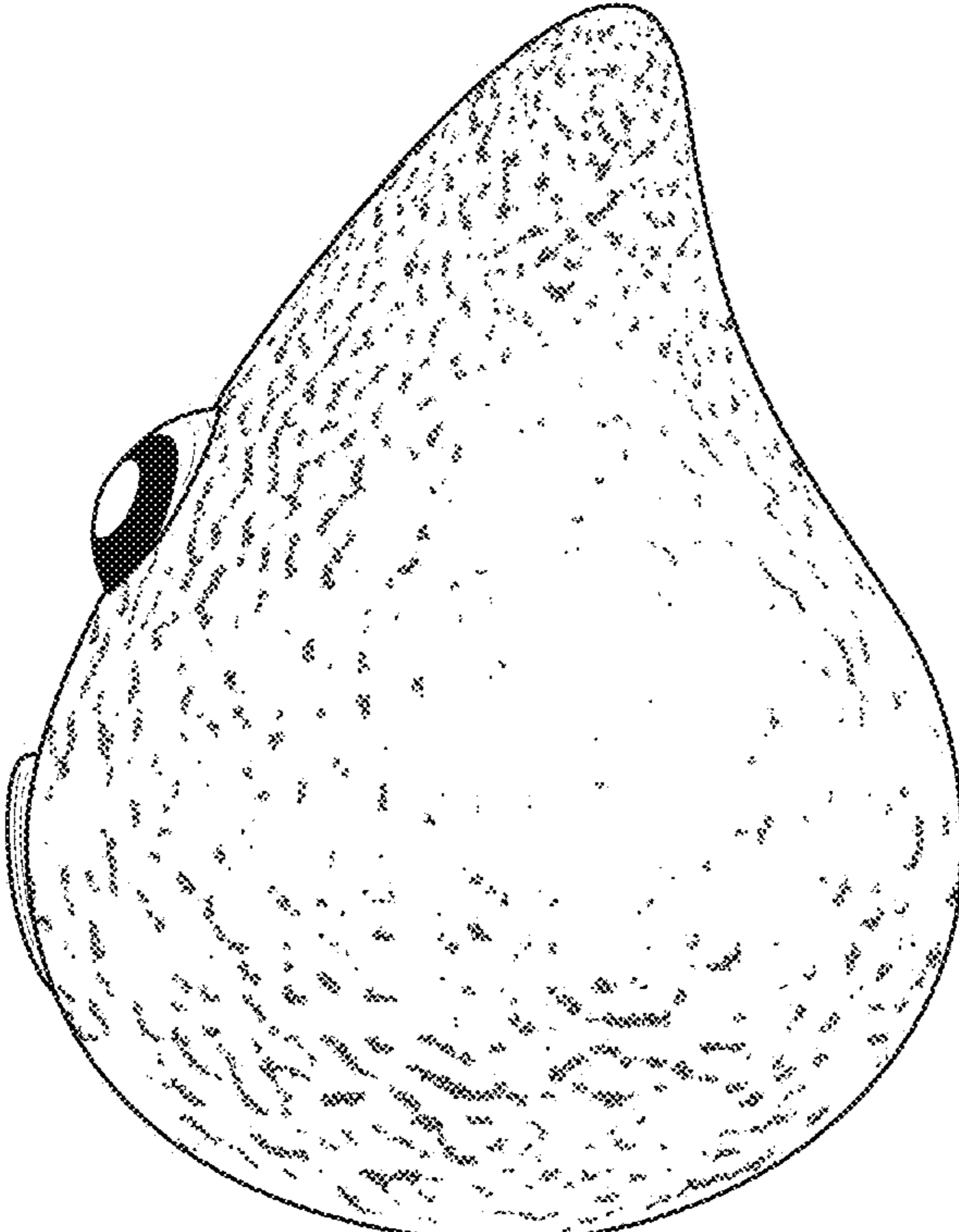
