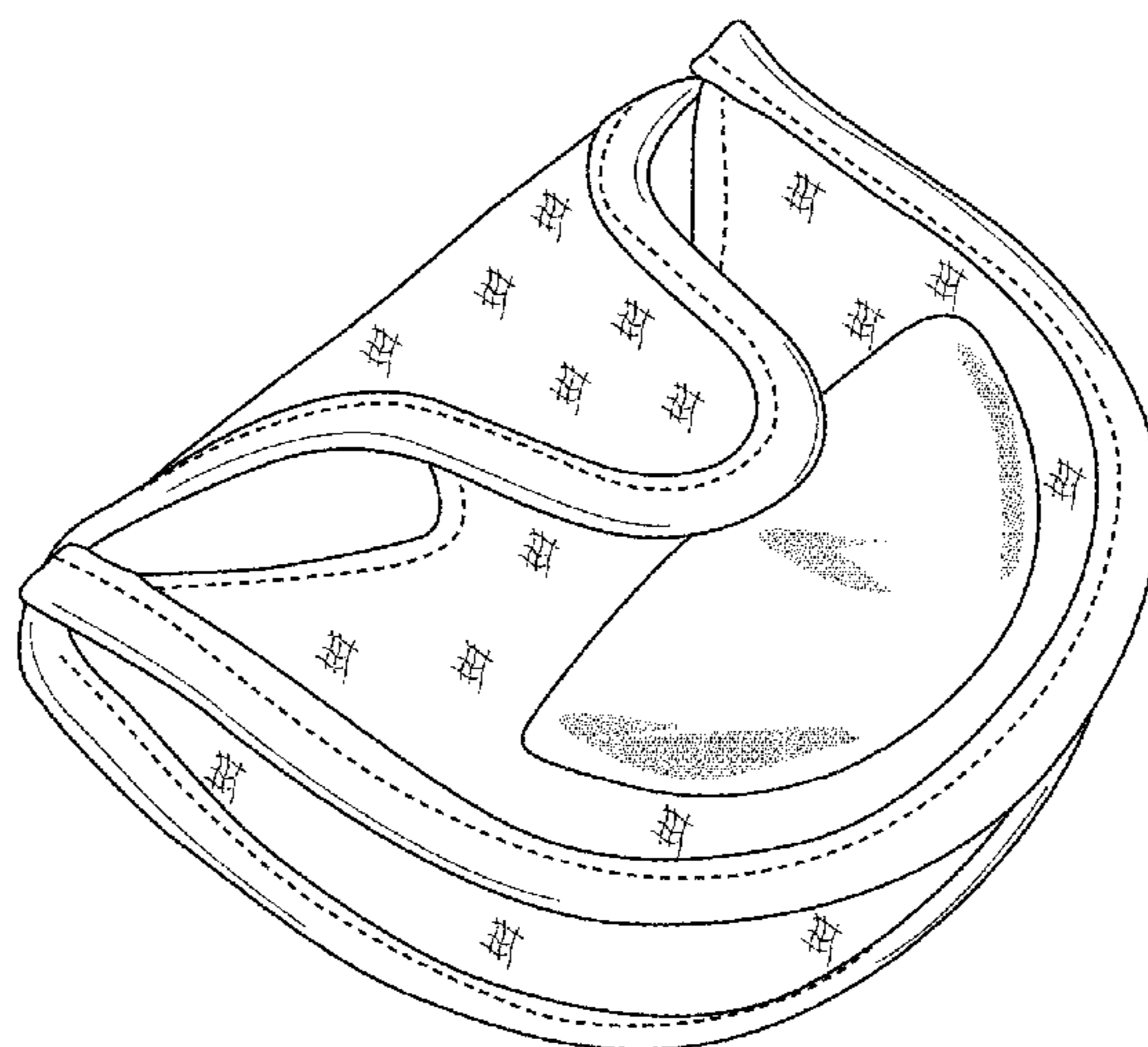

(57) **CLAIM**

The ornamental design for a golf putter head cover, as shown and described.

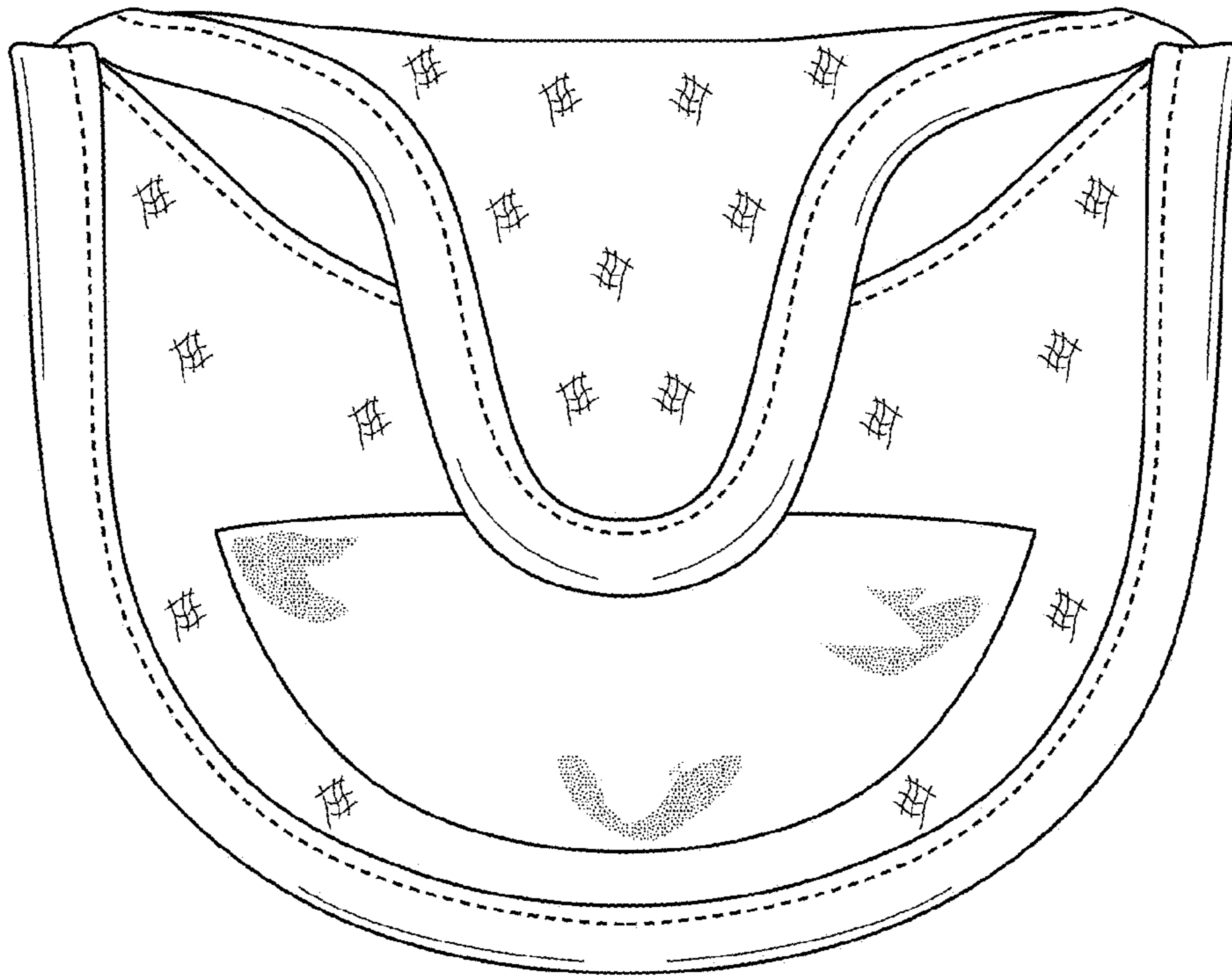

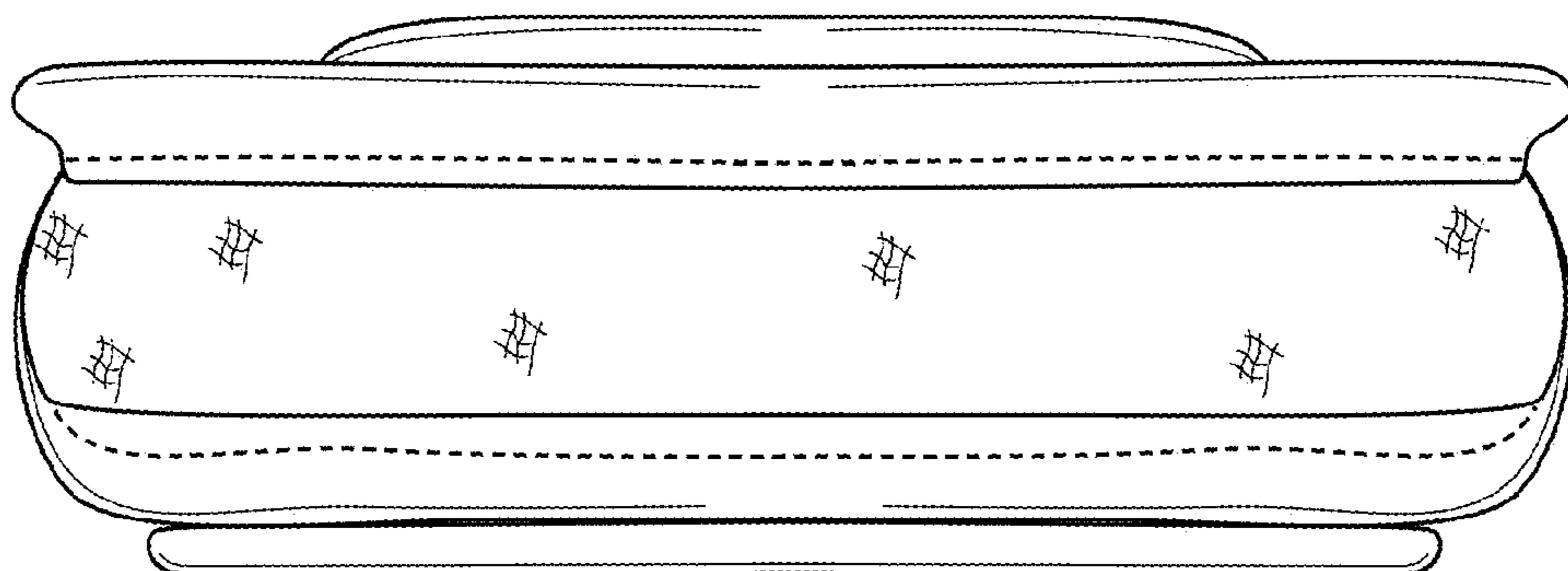
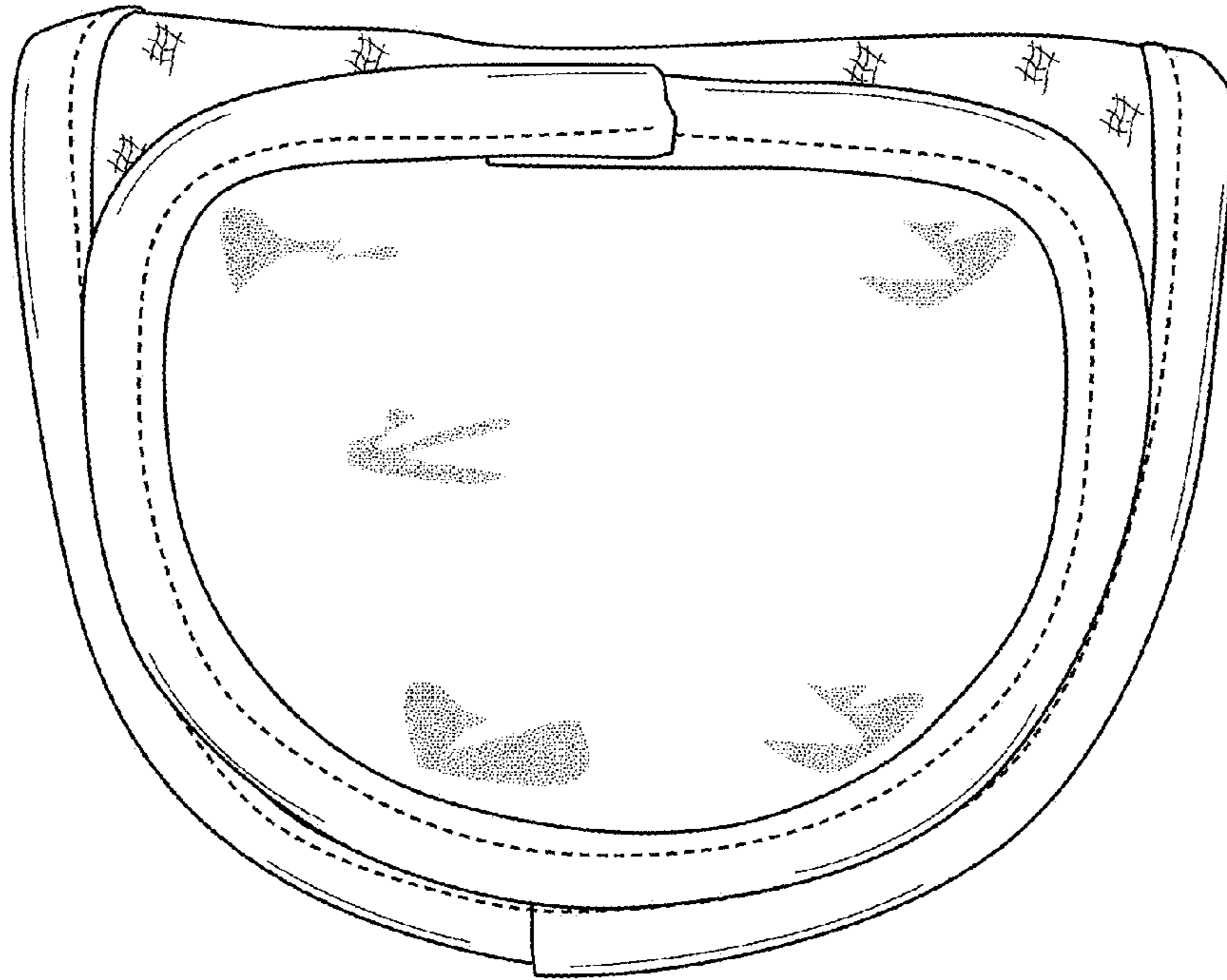
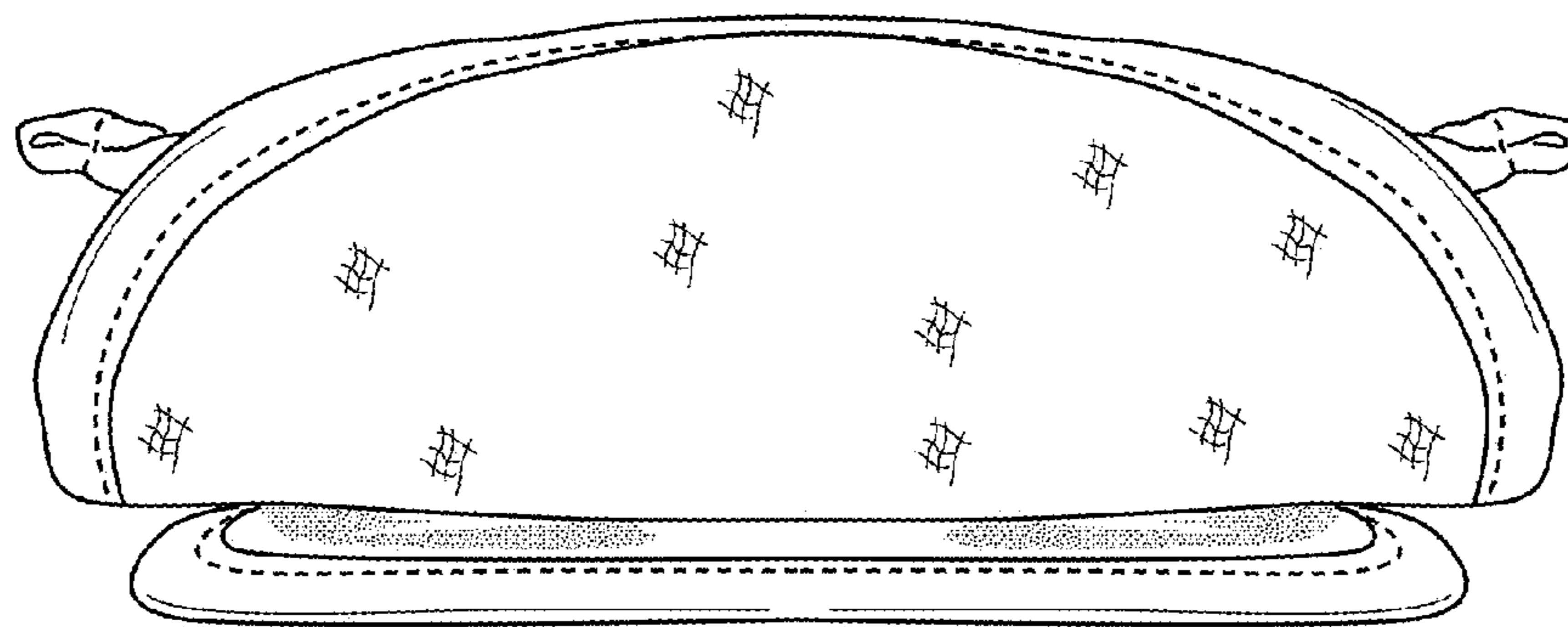


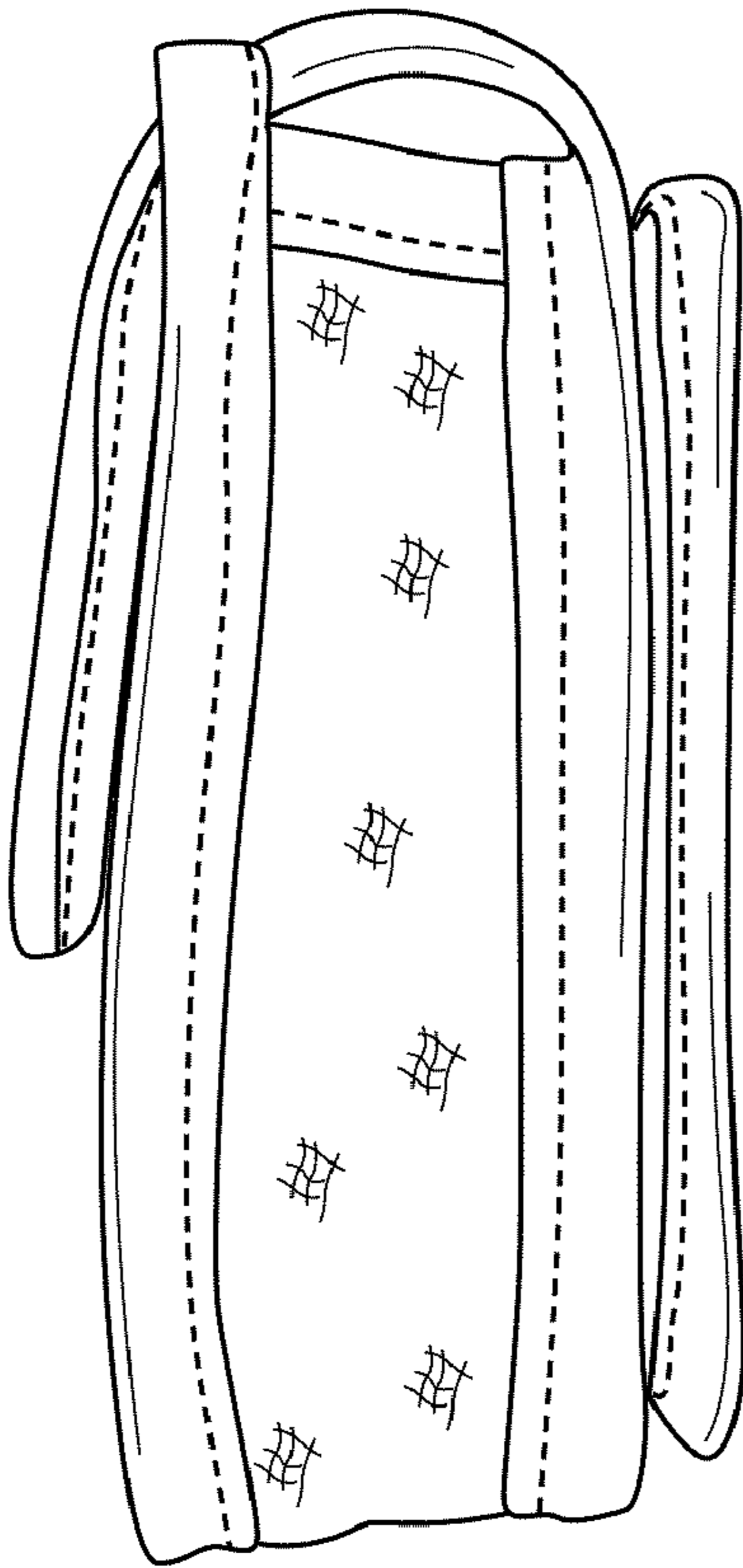

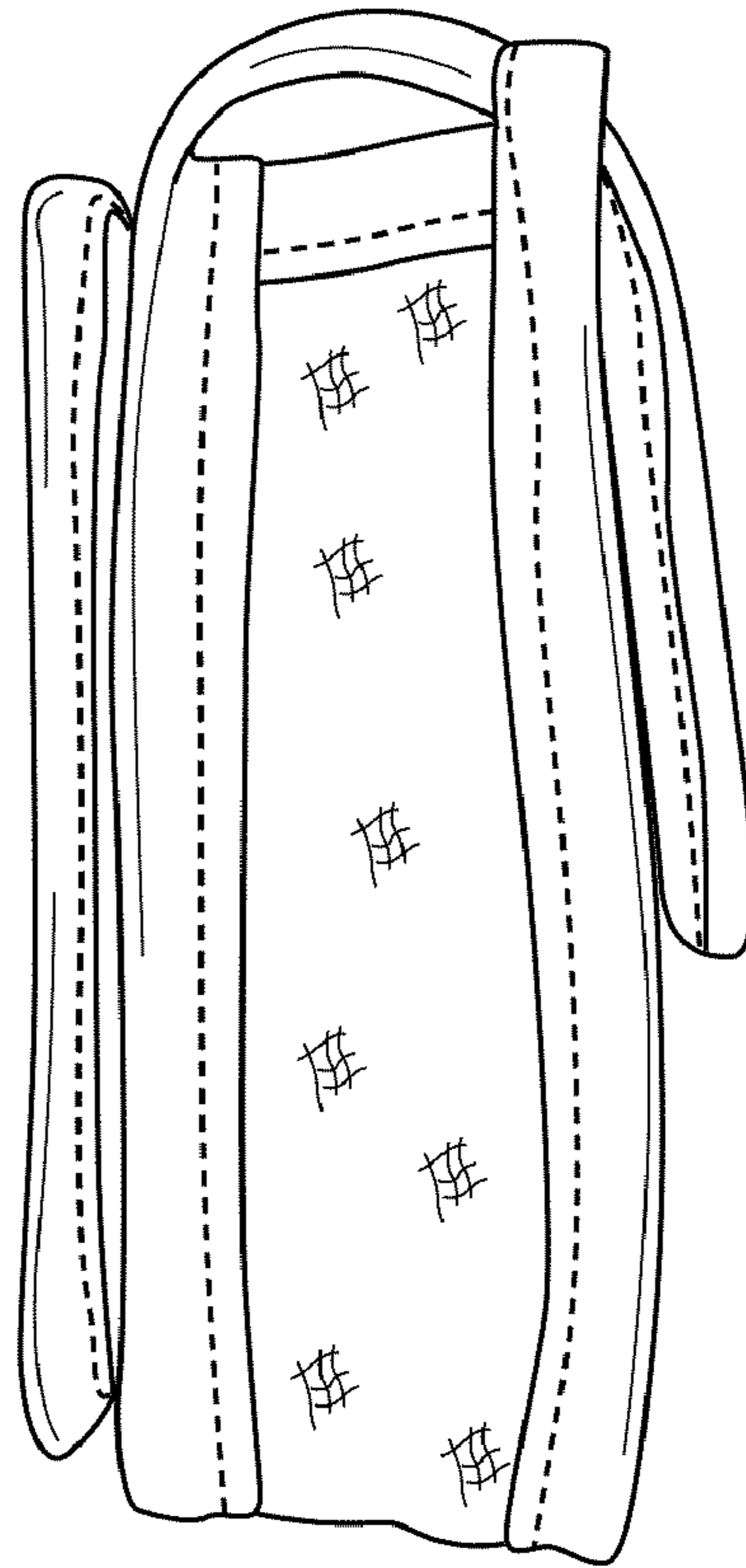

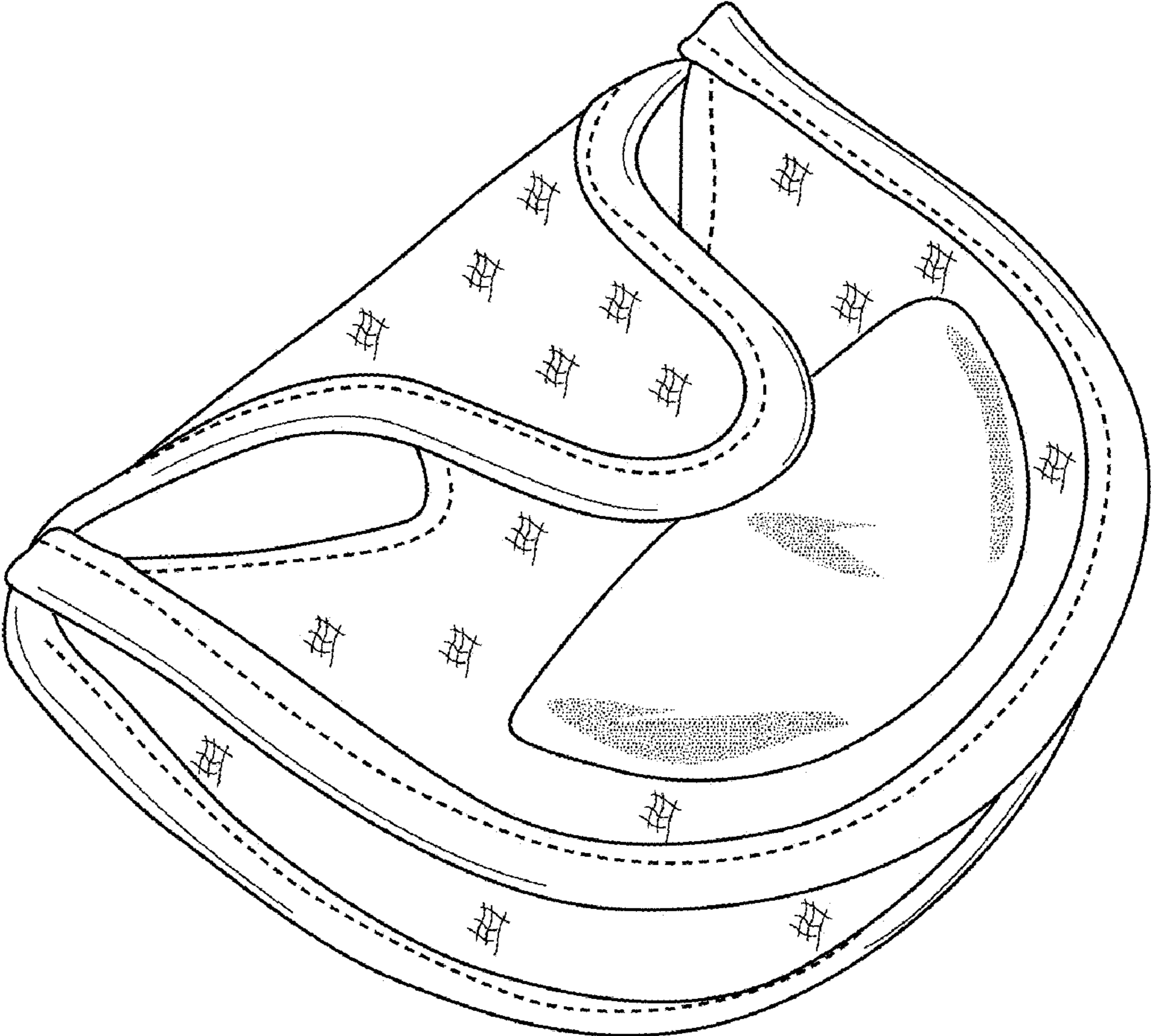

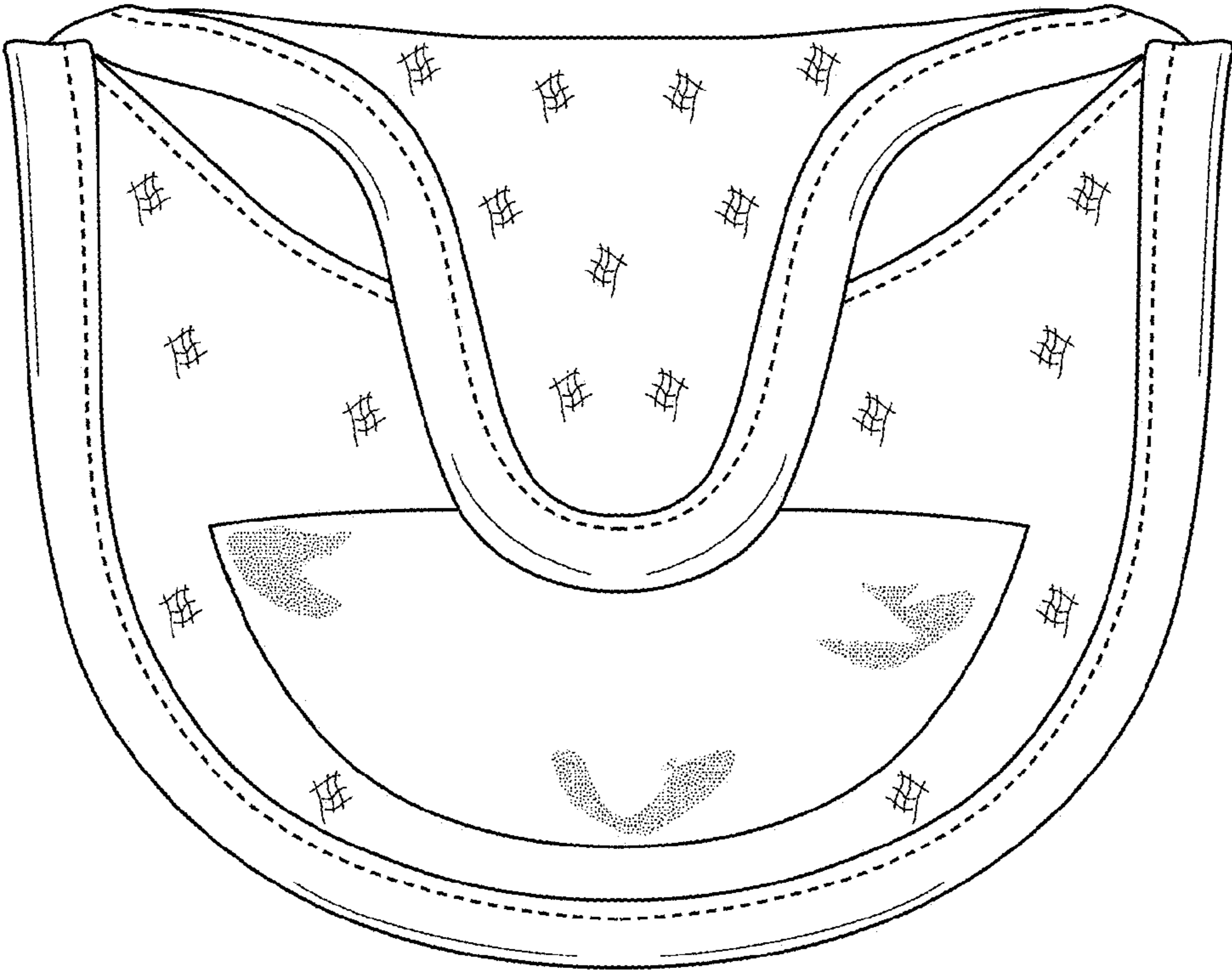

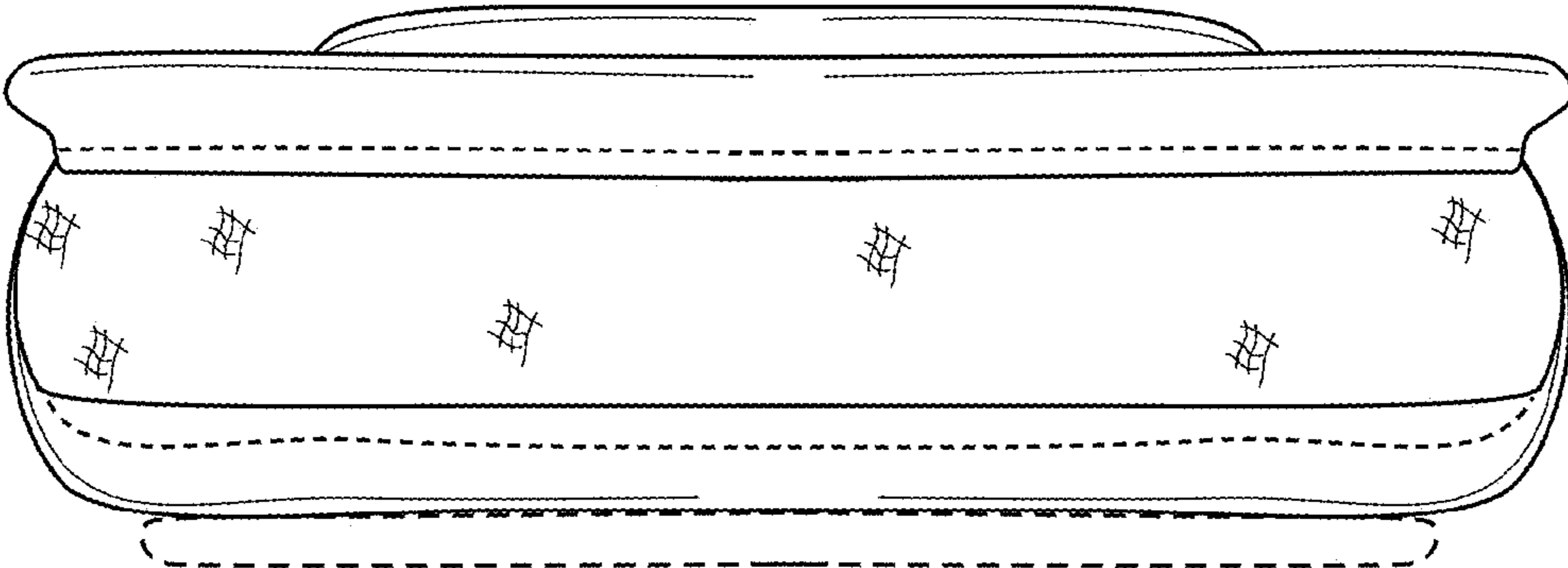
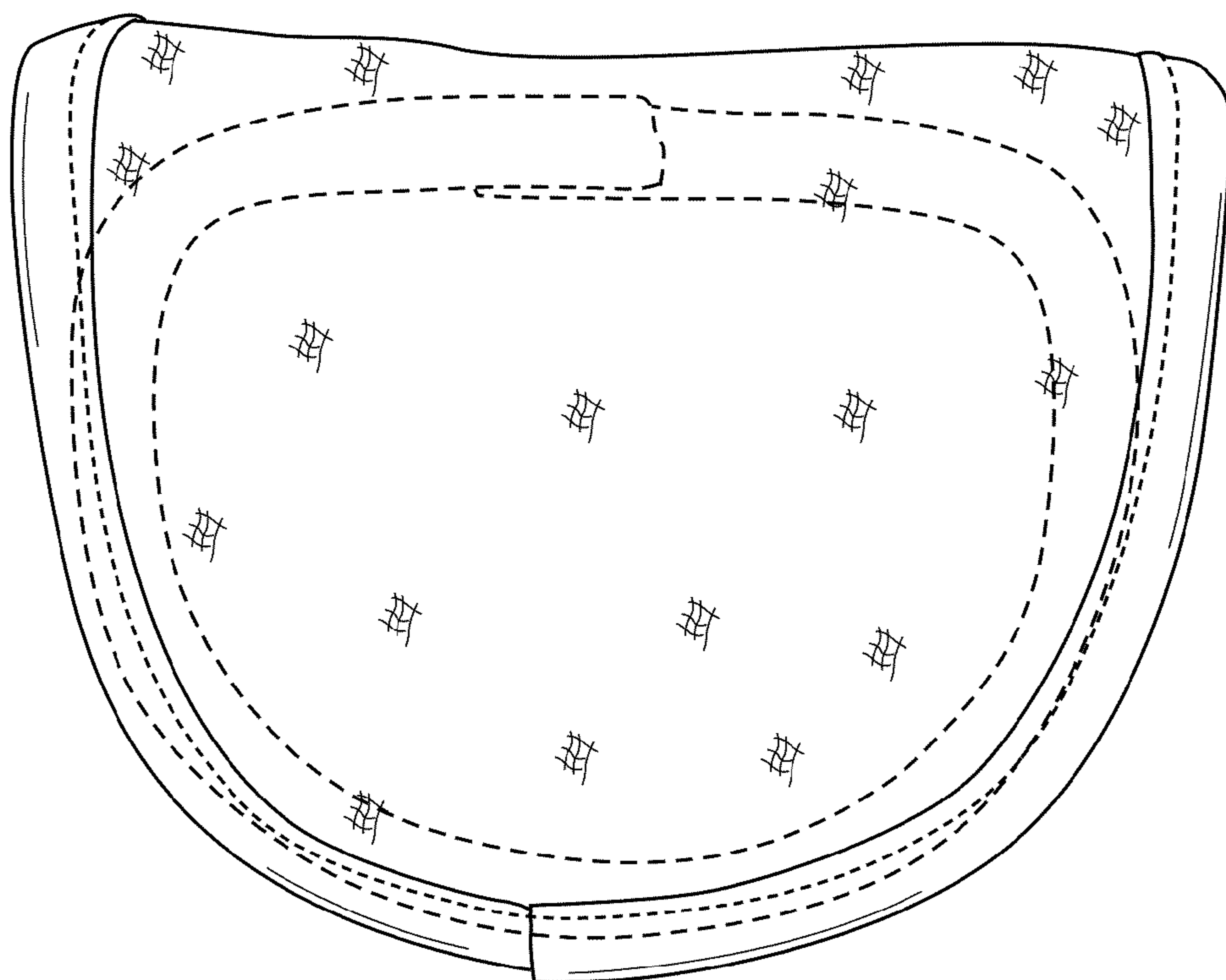
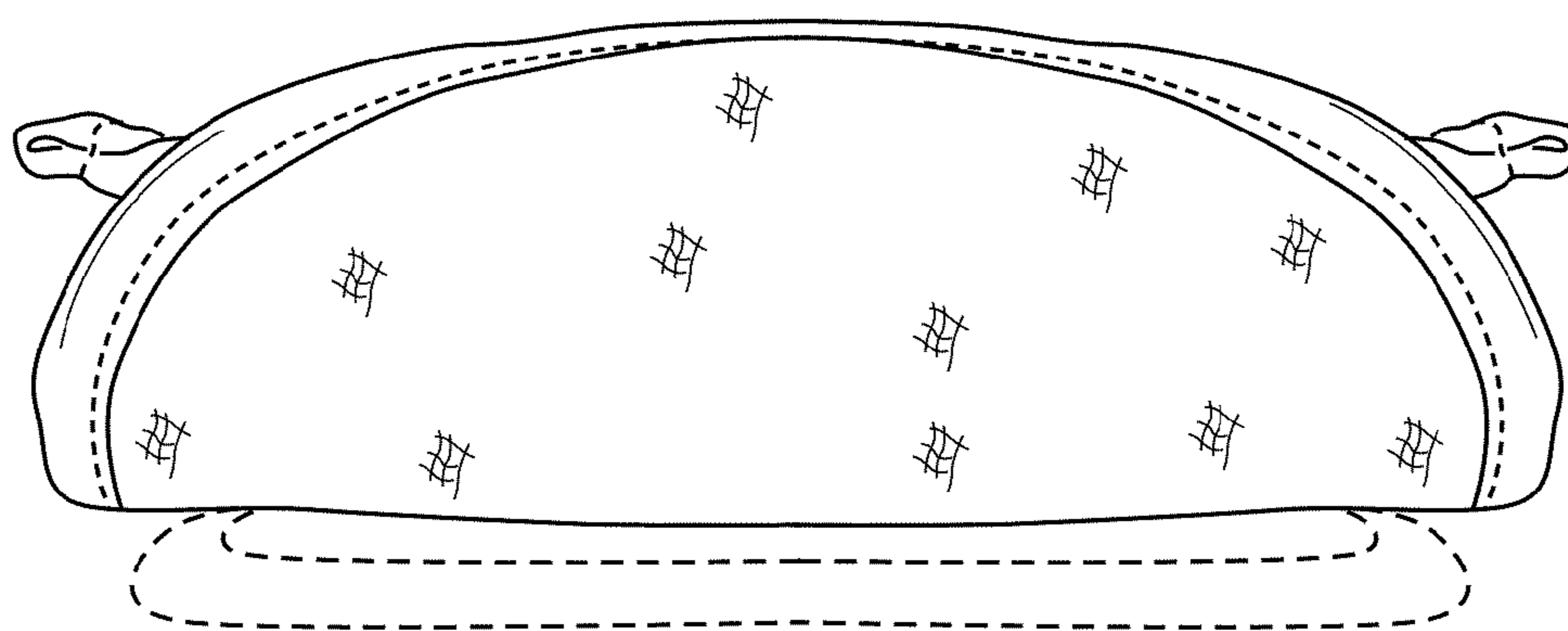


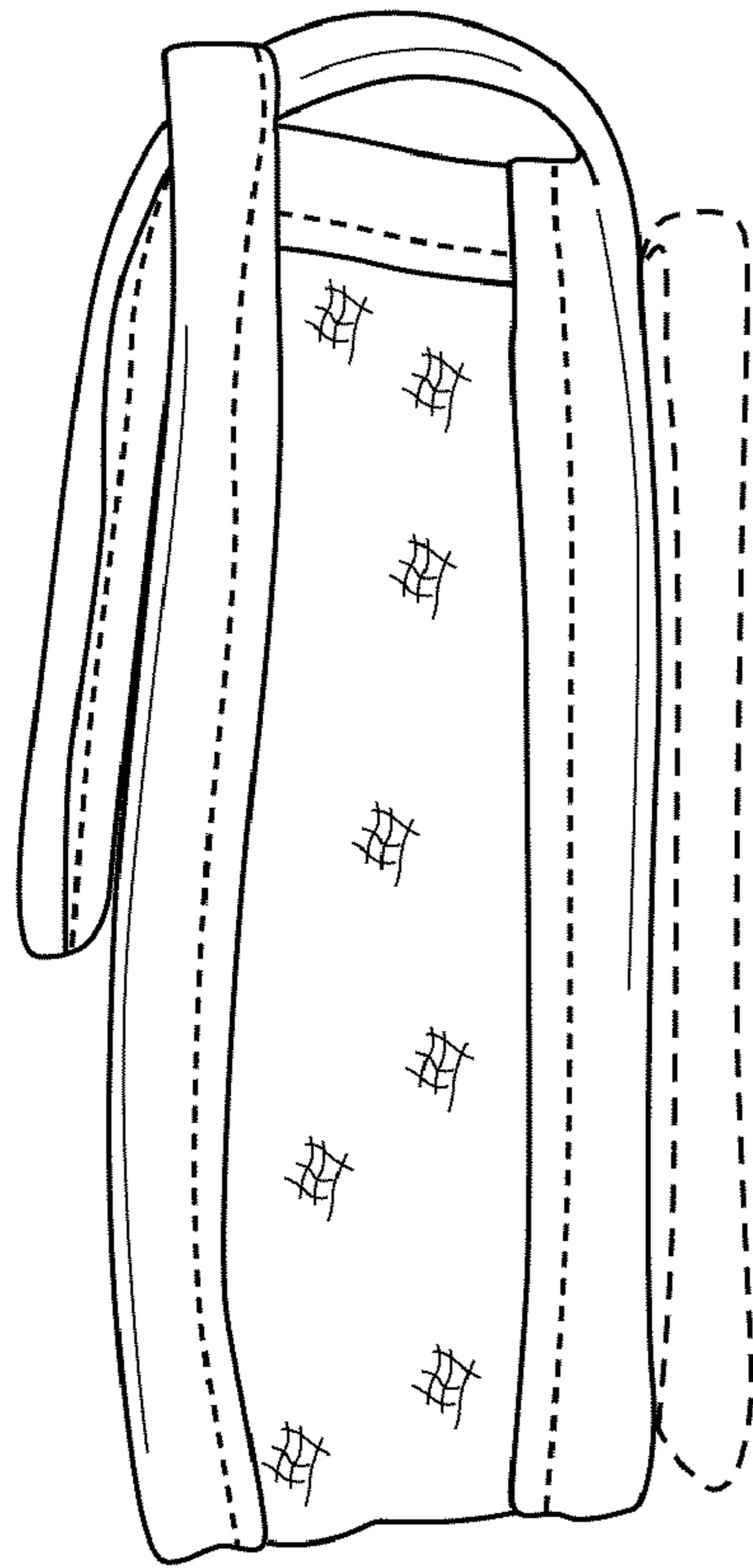

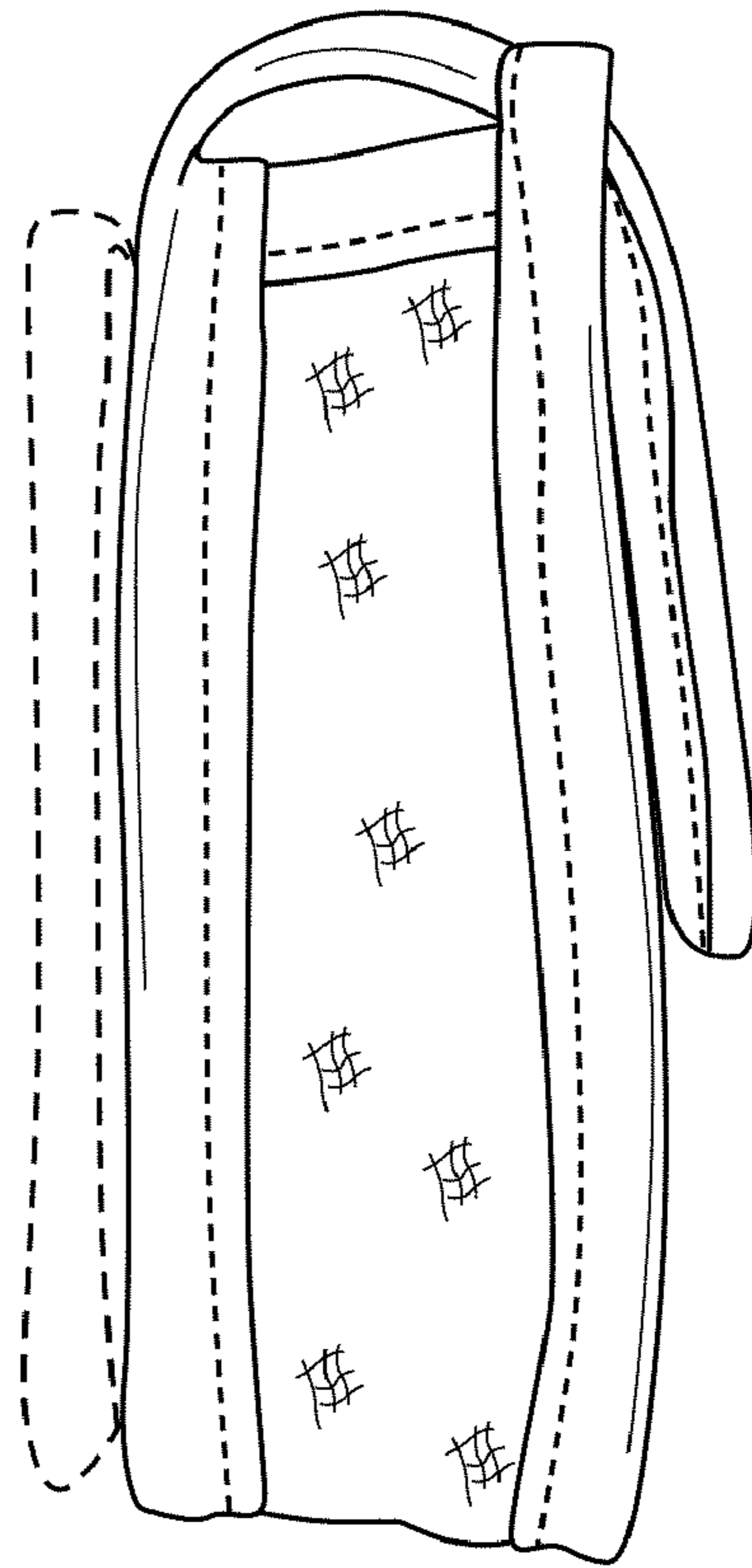

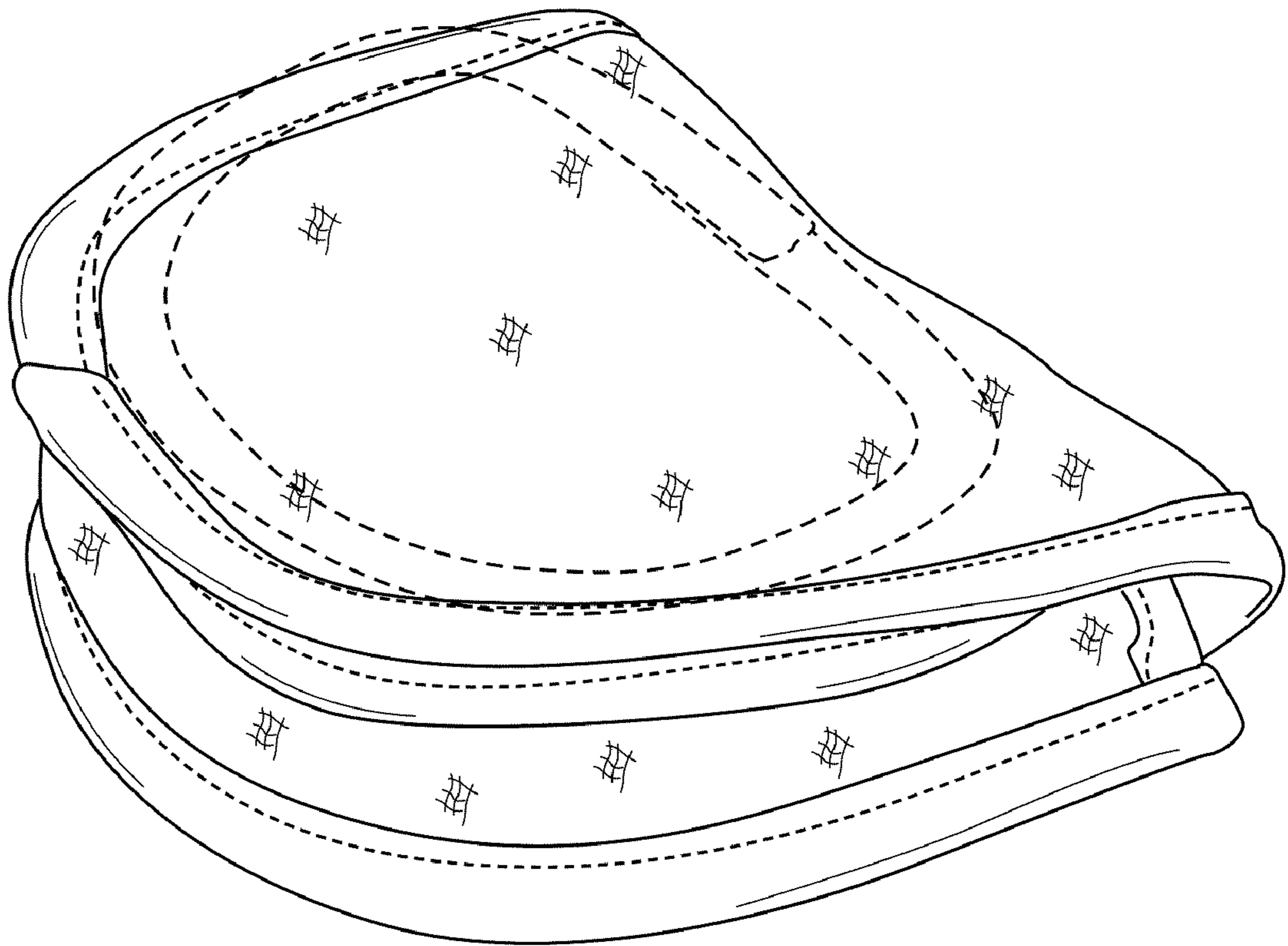

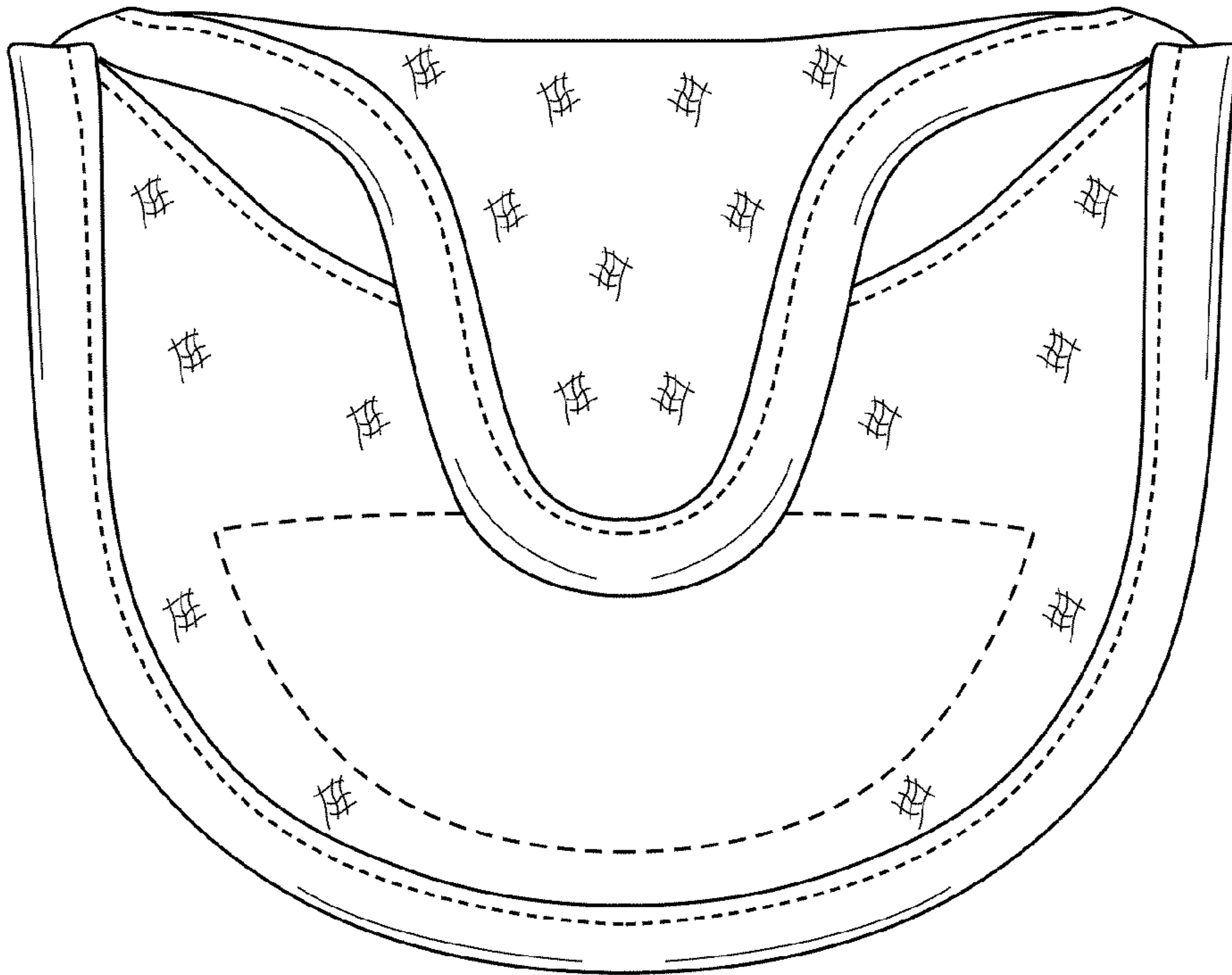

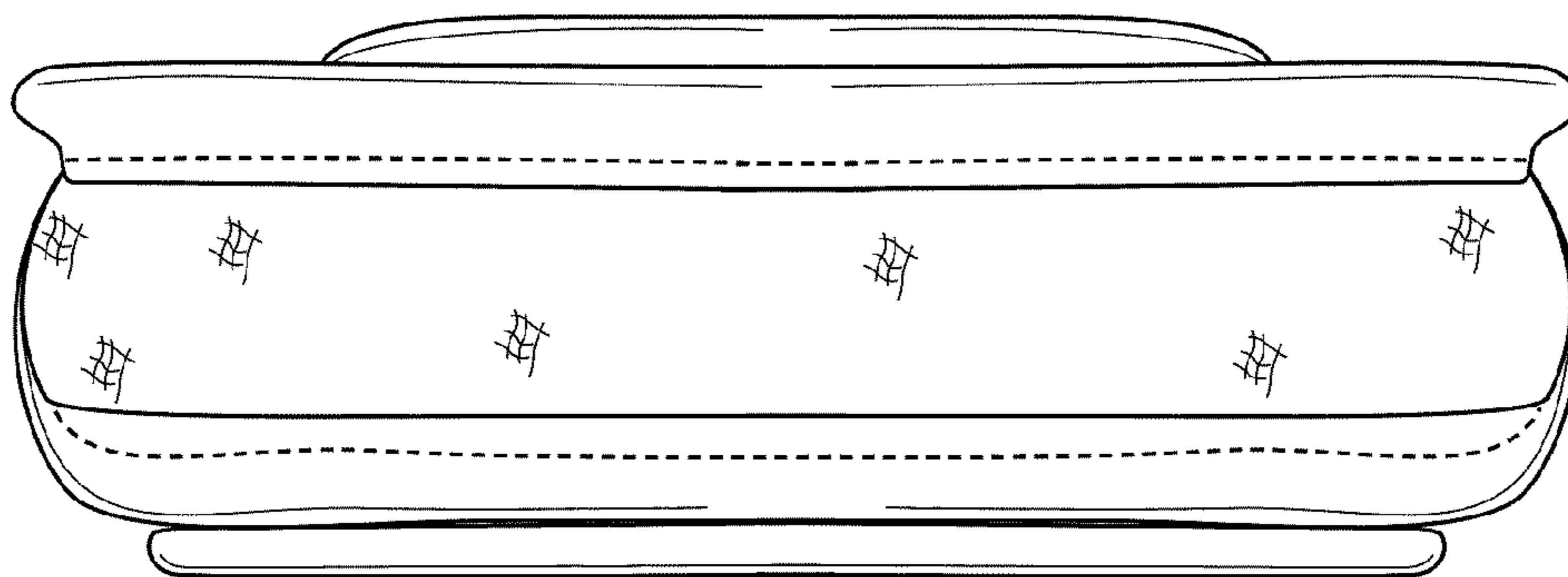
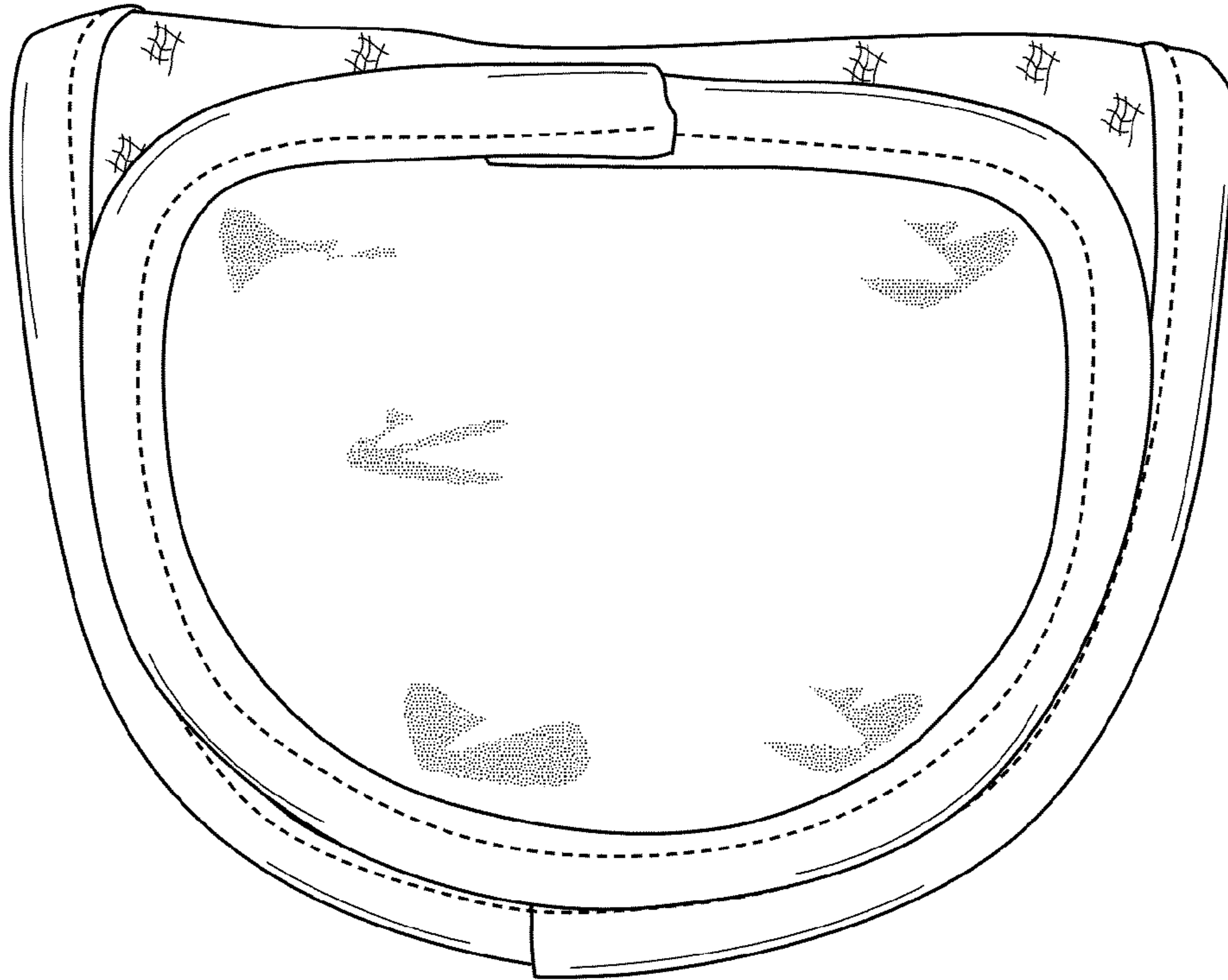
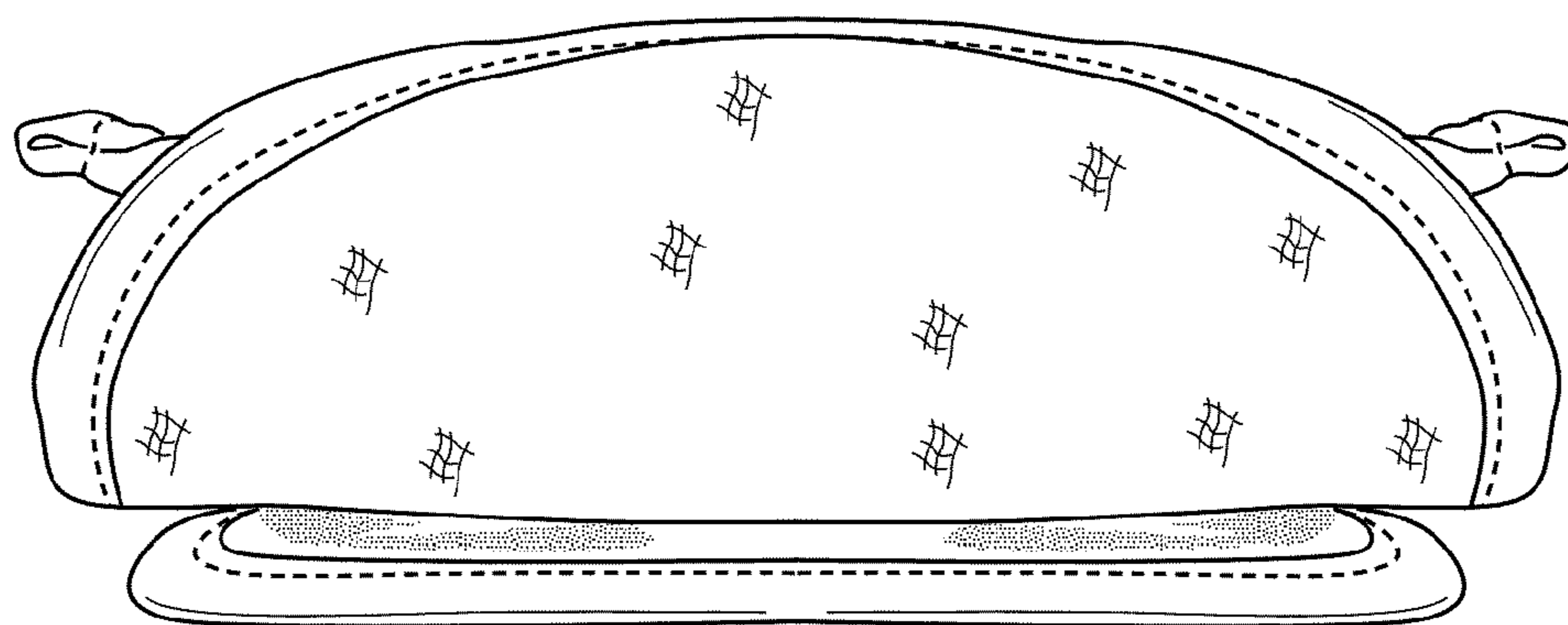


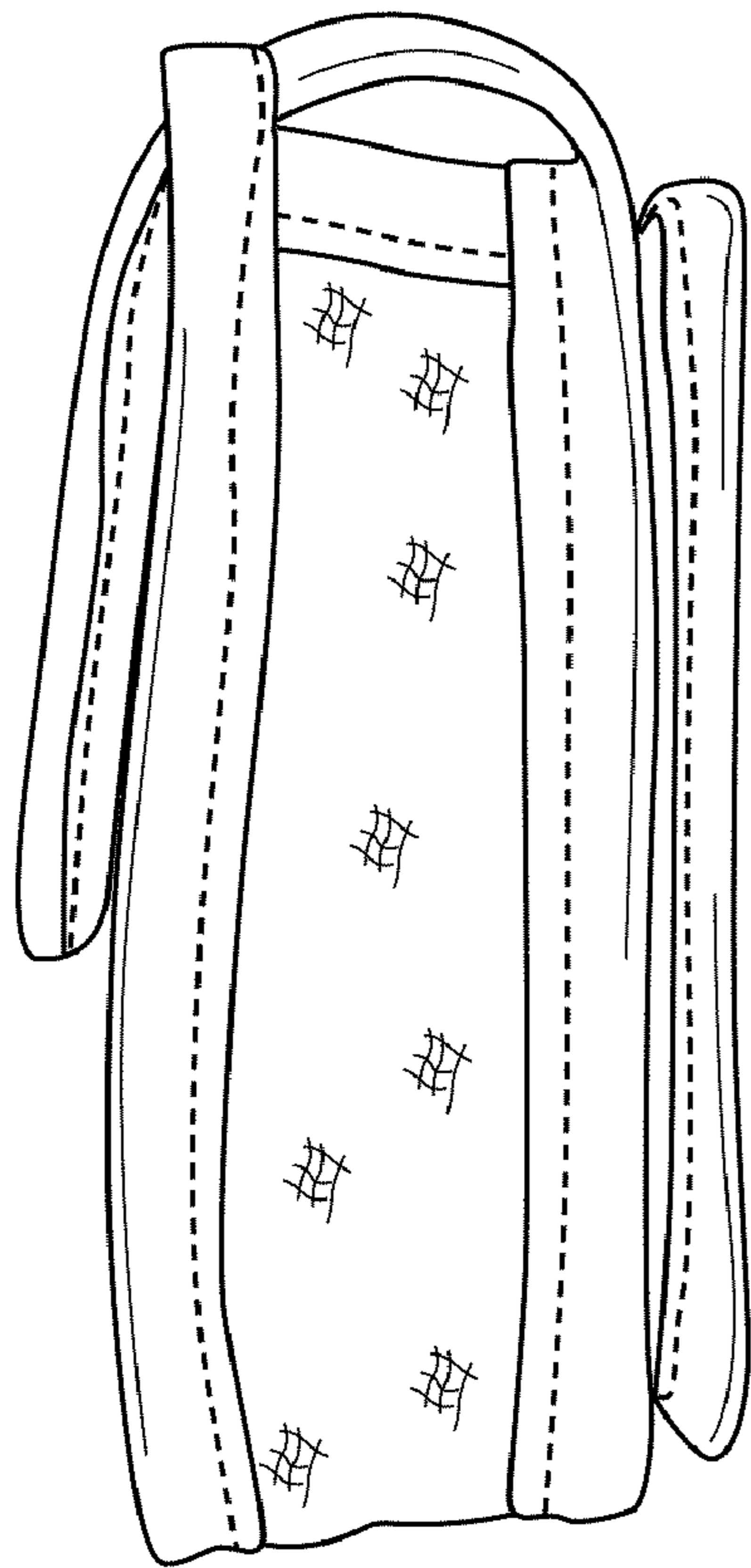

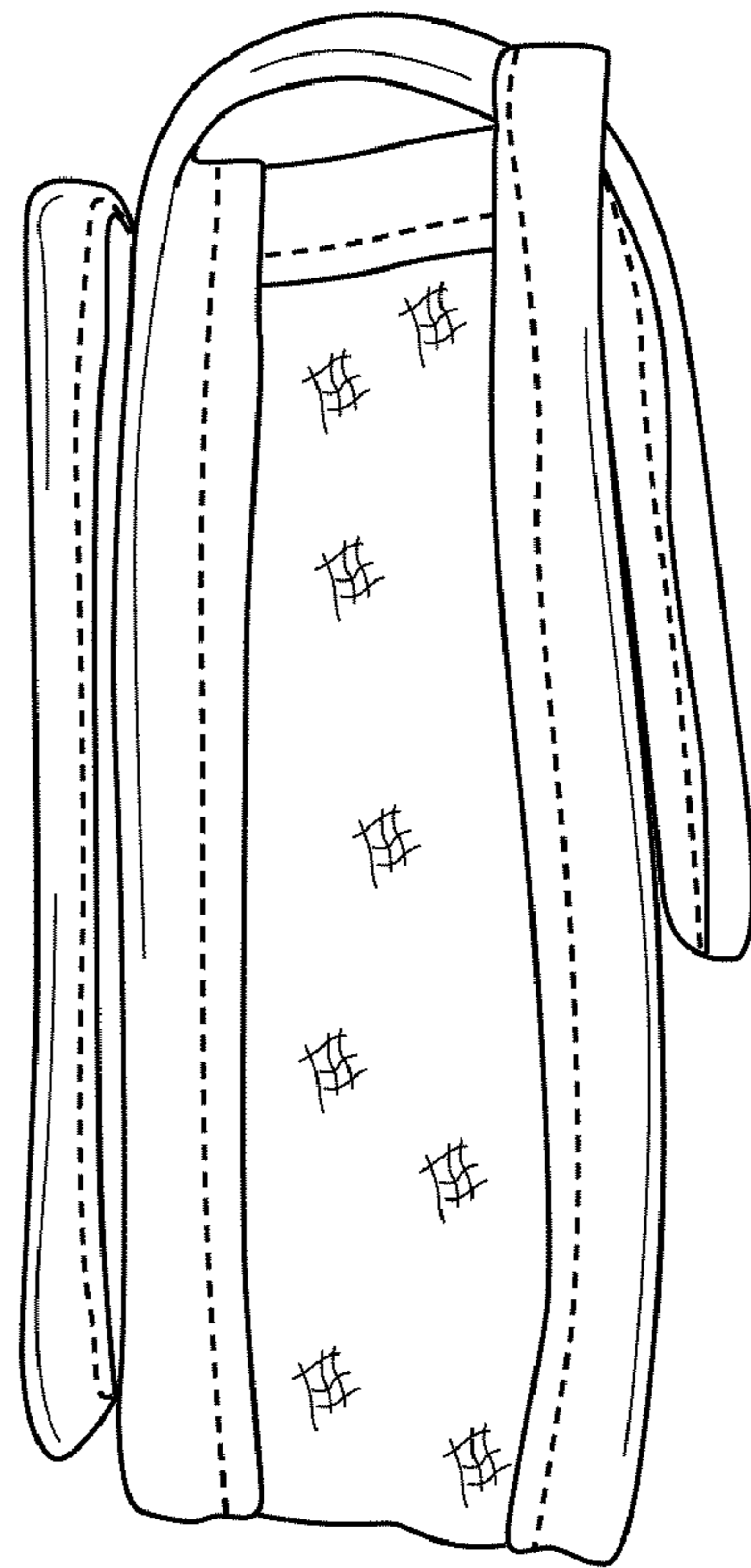

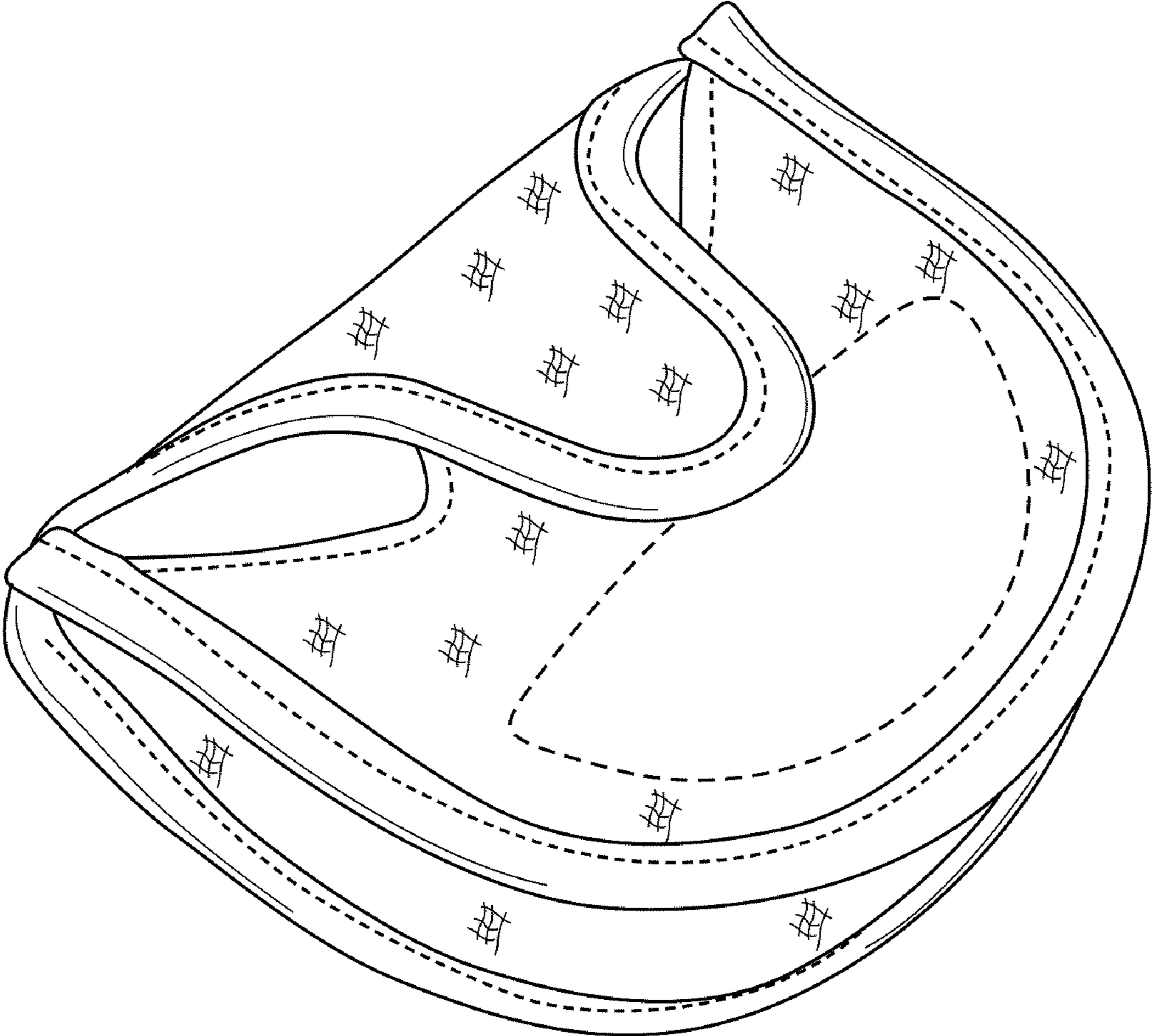
