The ornamental design for a toilet flushing system, as shown and described.

FIG. 17 is a right side elevational view of the third embodiment of the flushing system;

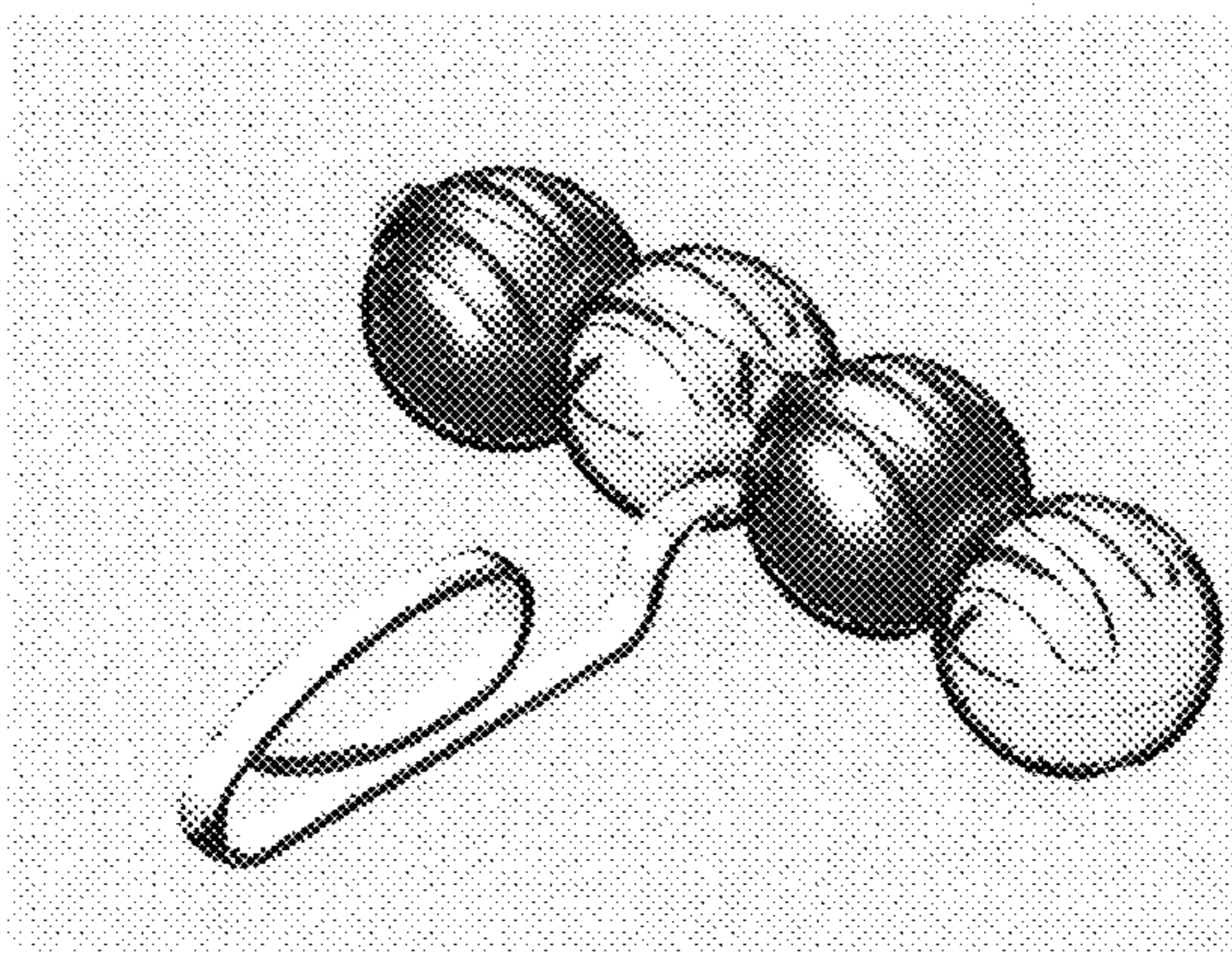
FIG. 18 is a front elevational view of the third embodiment of the flushing system;

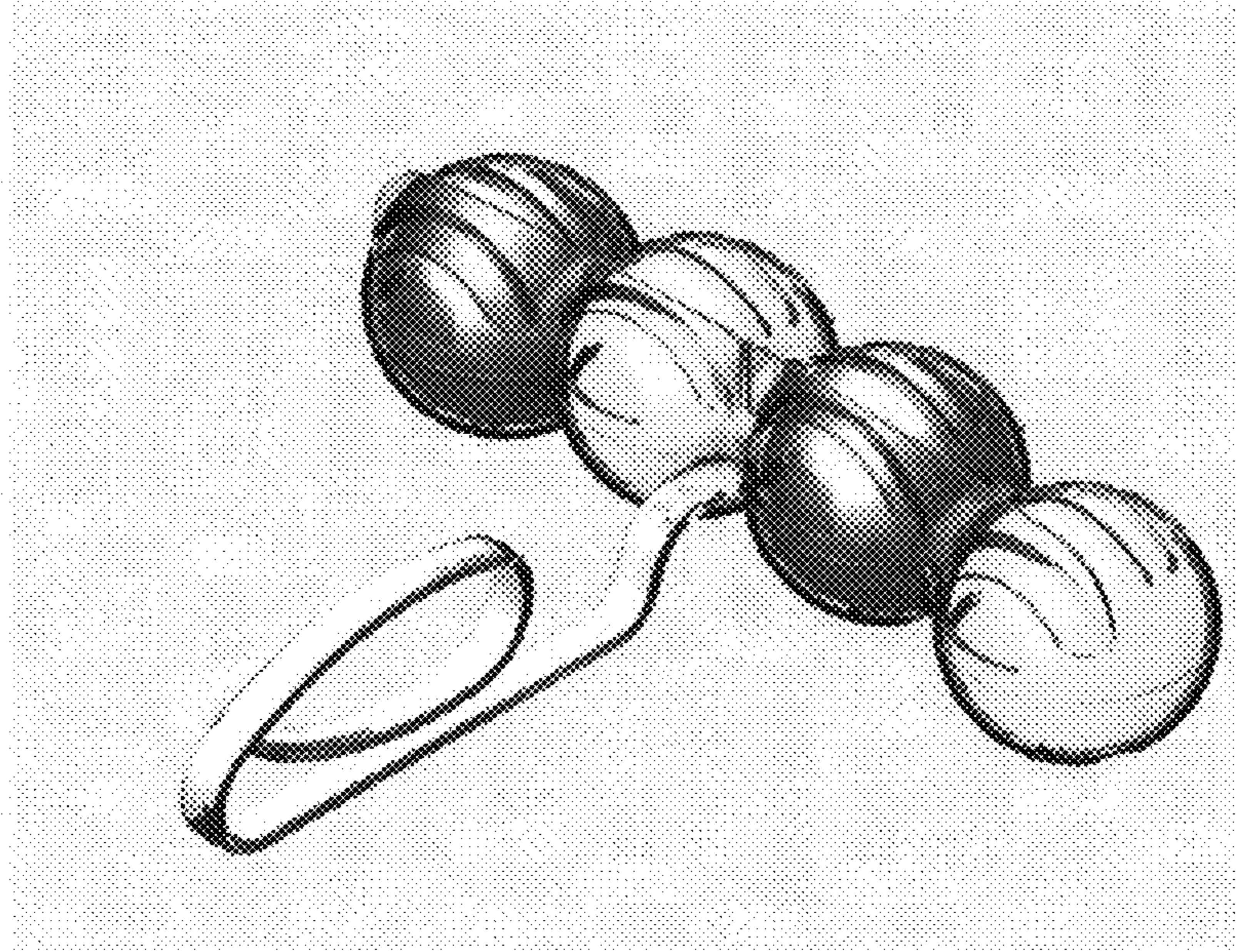

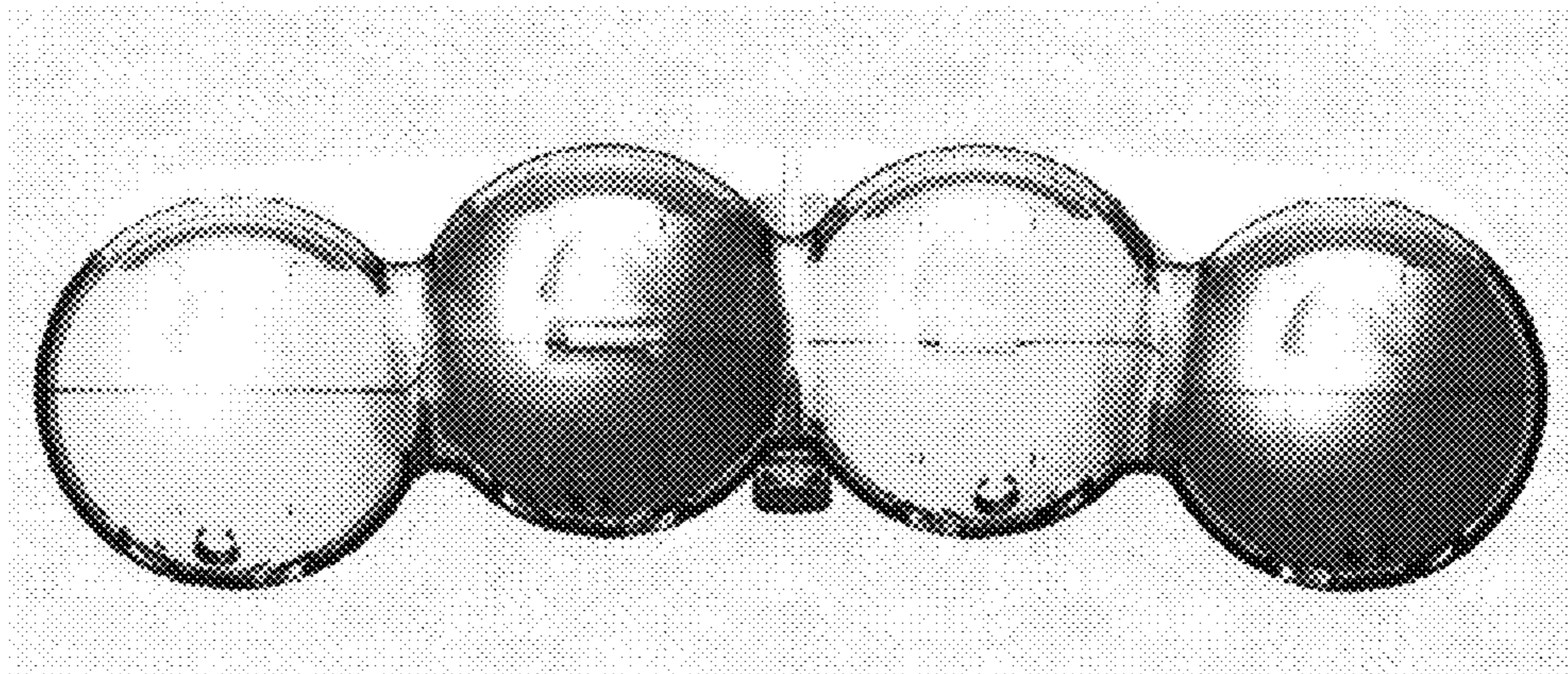

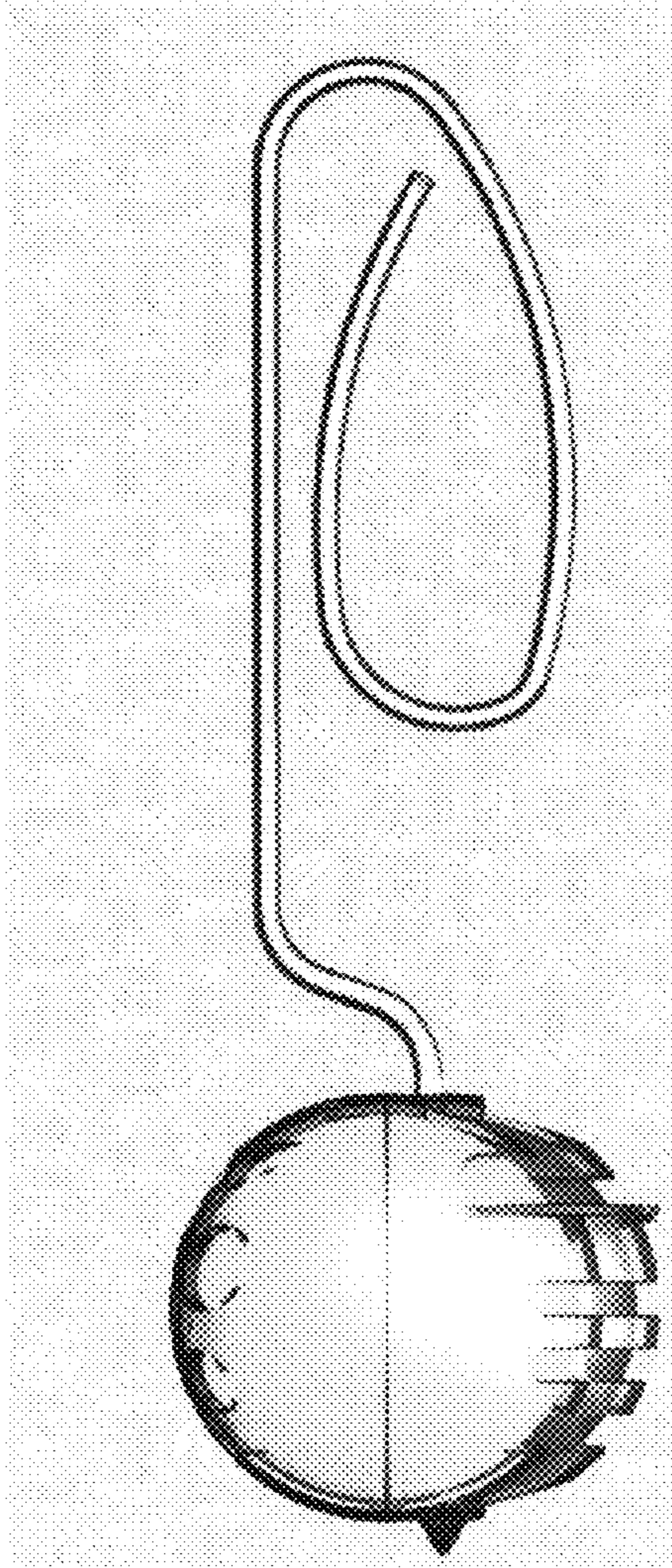

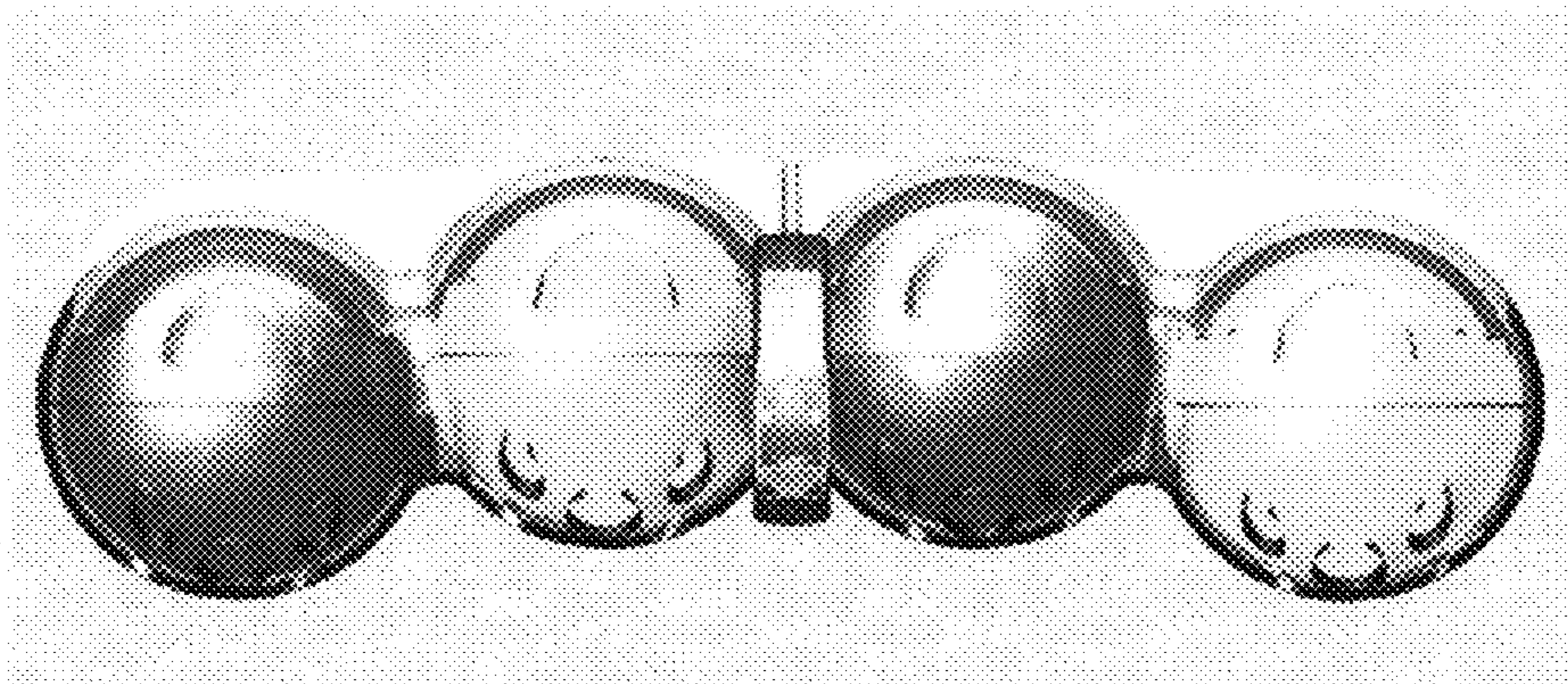

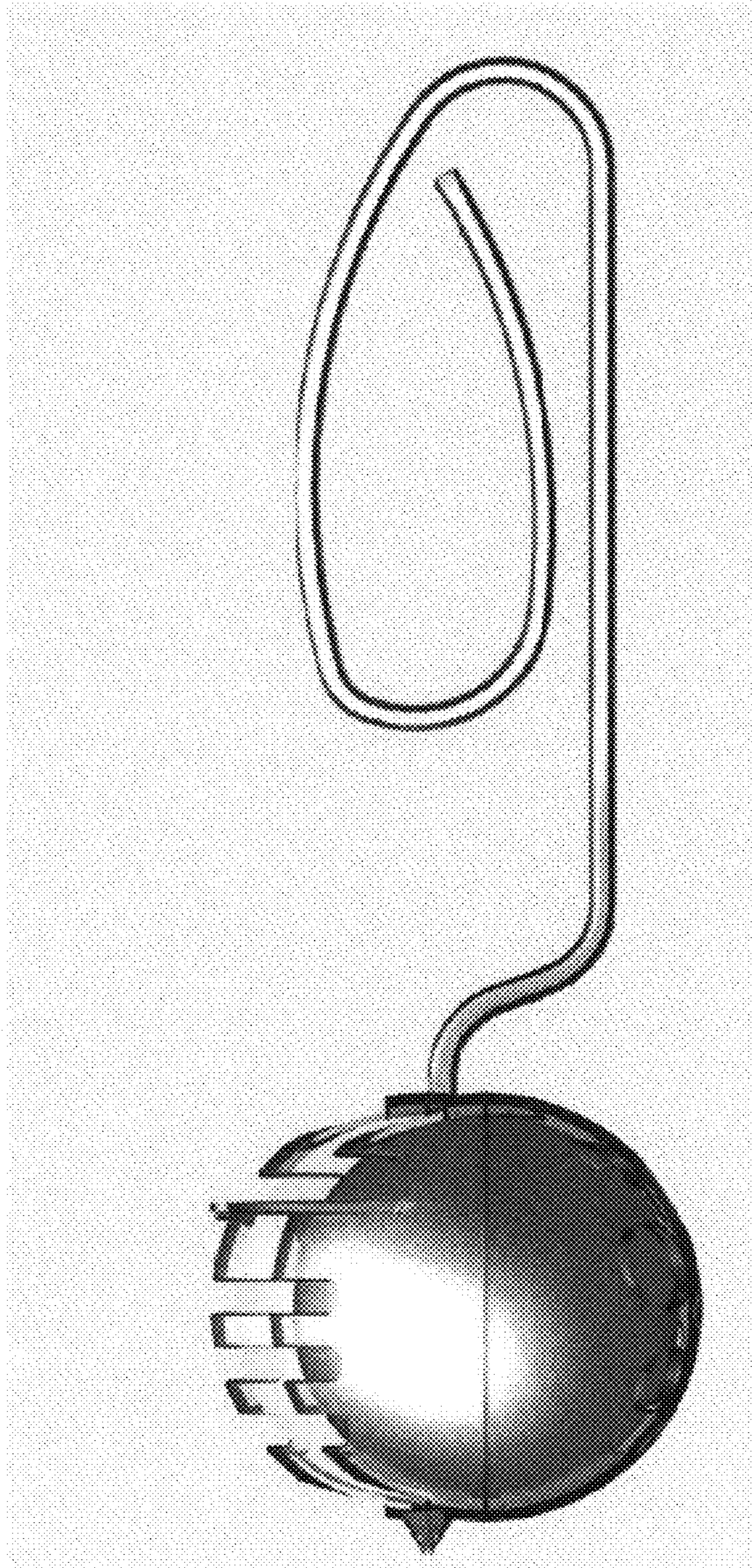

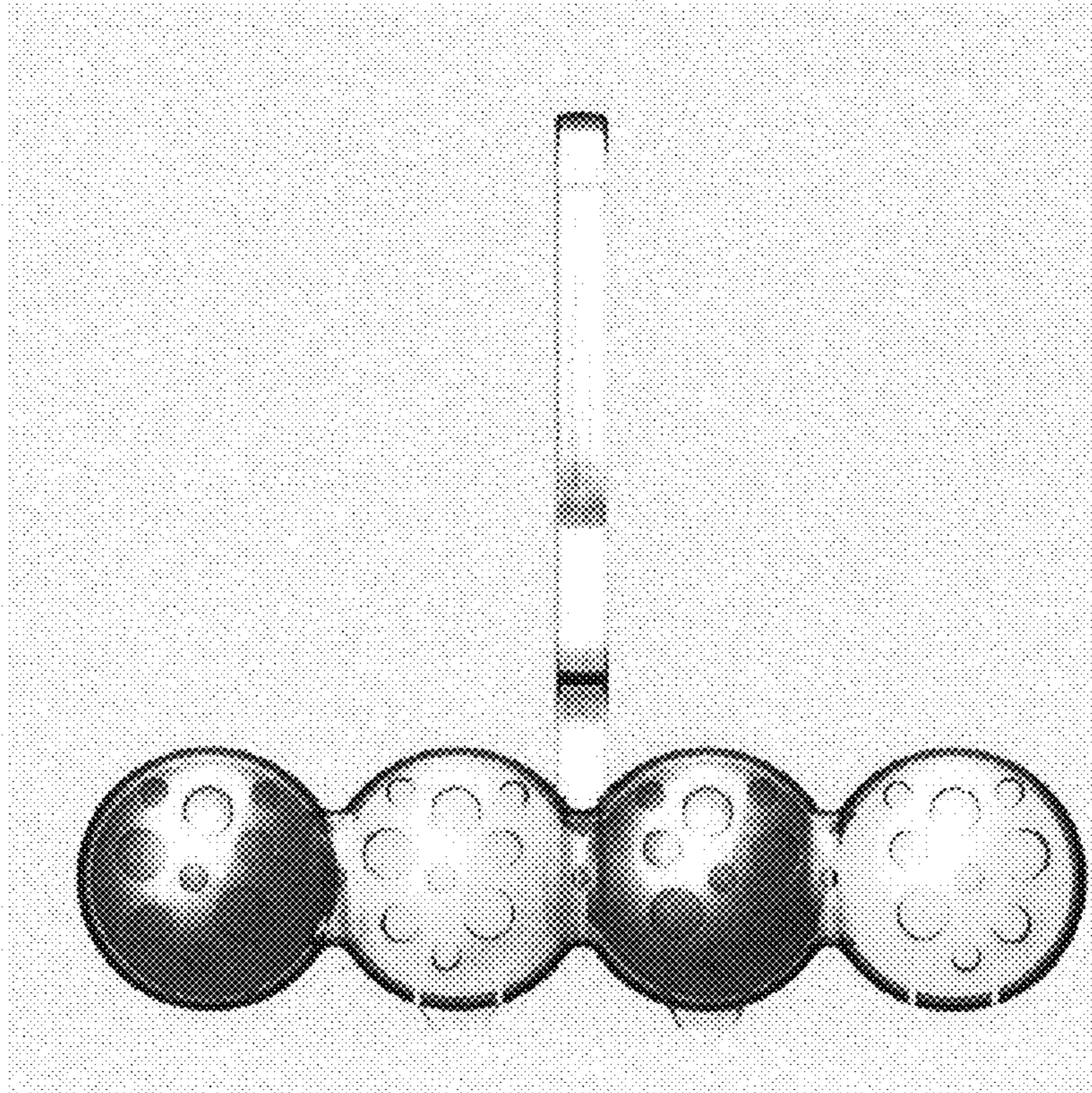

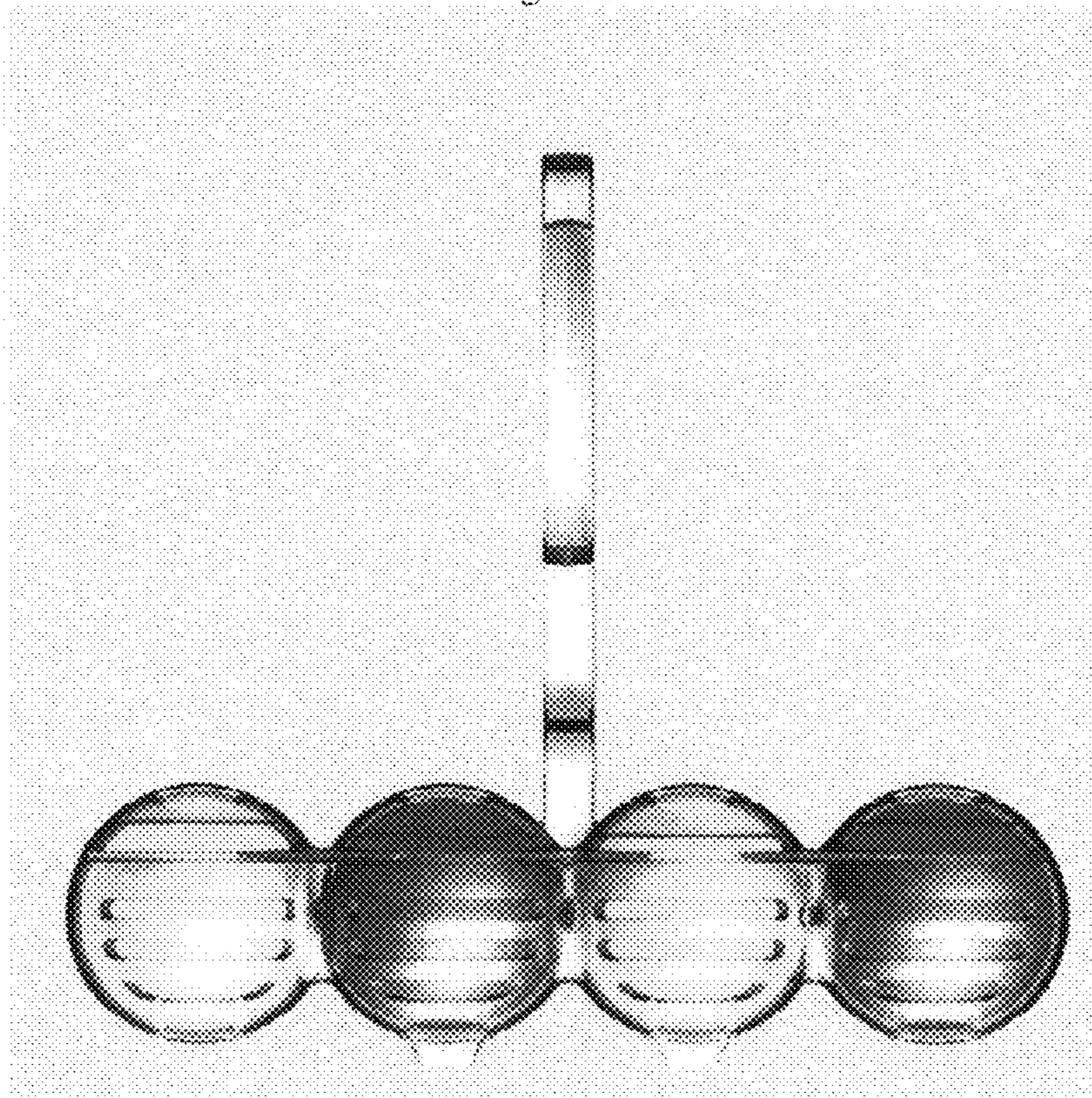

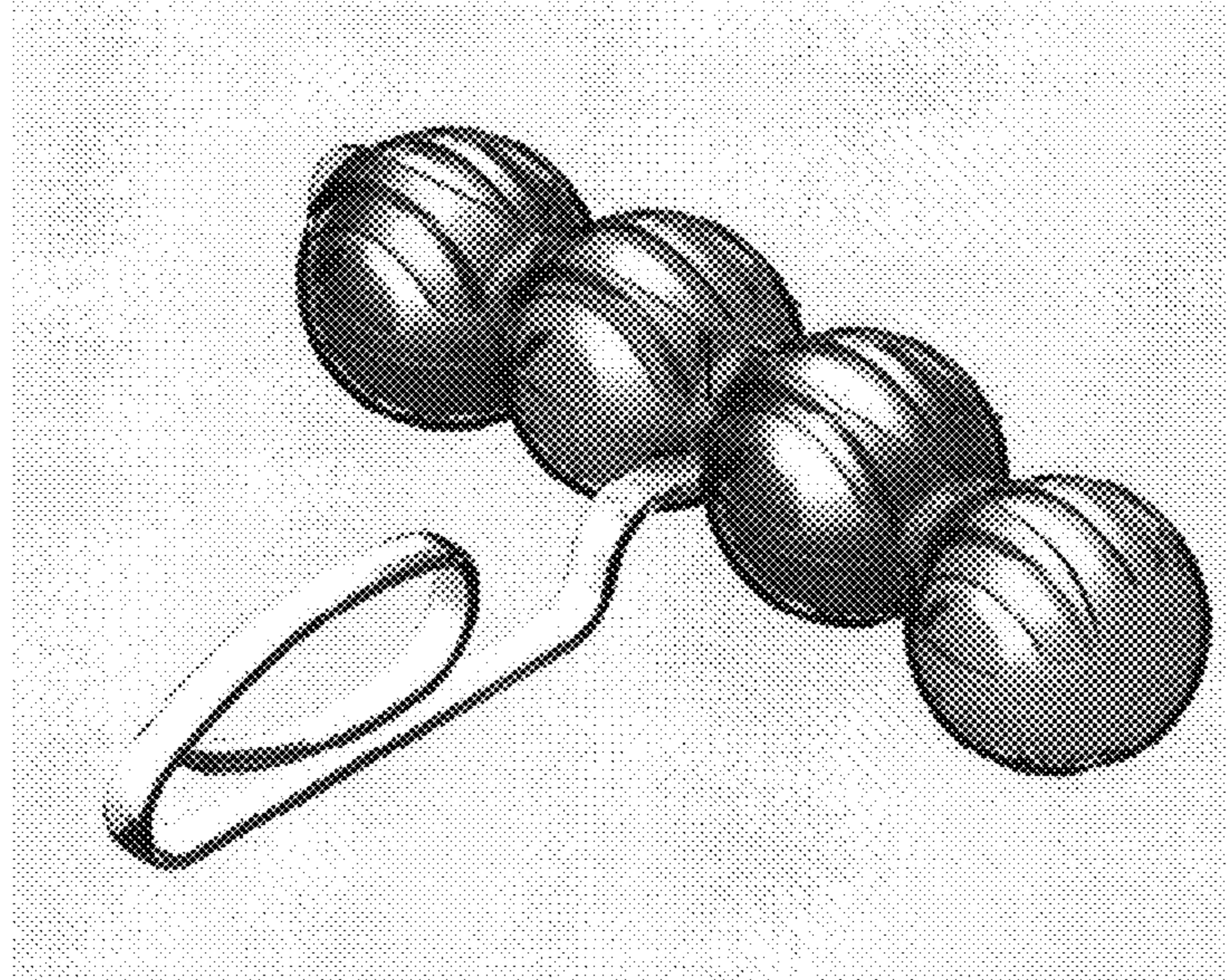

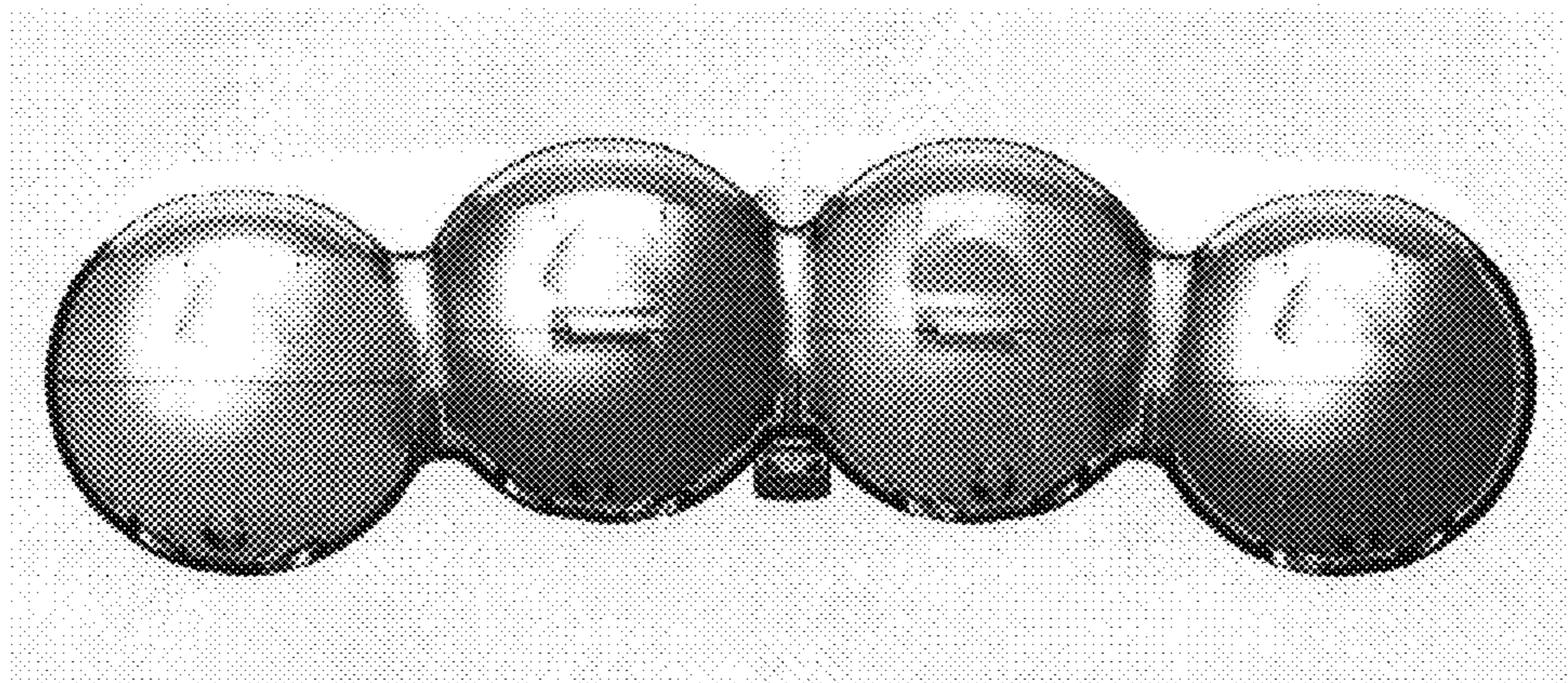

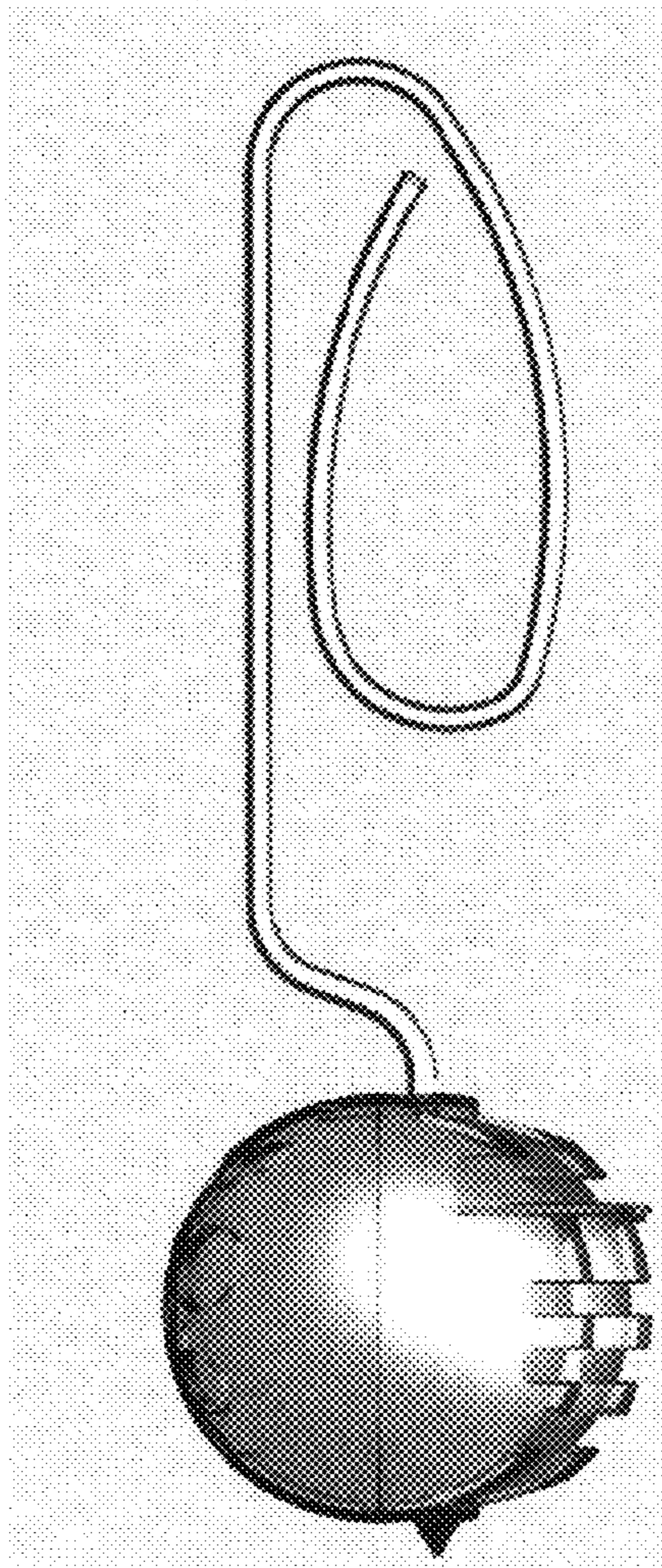

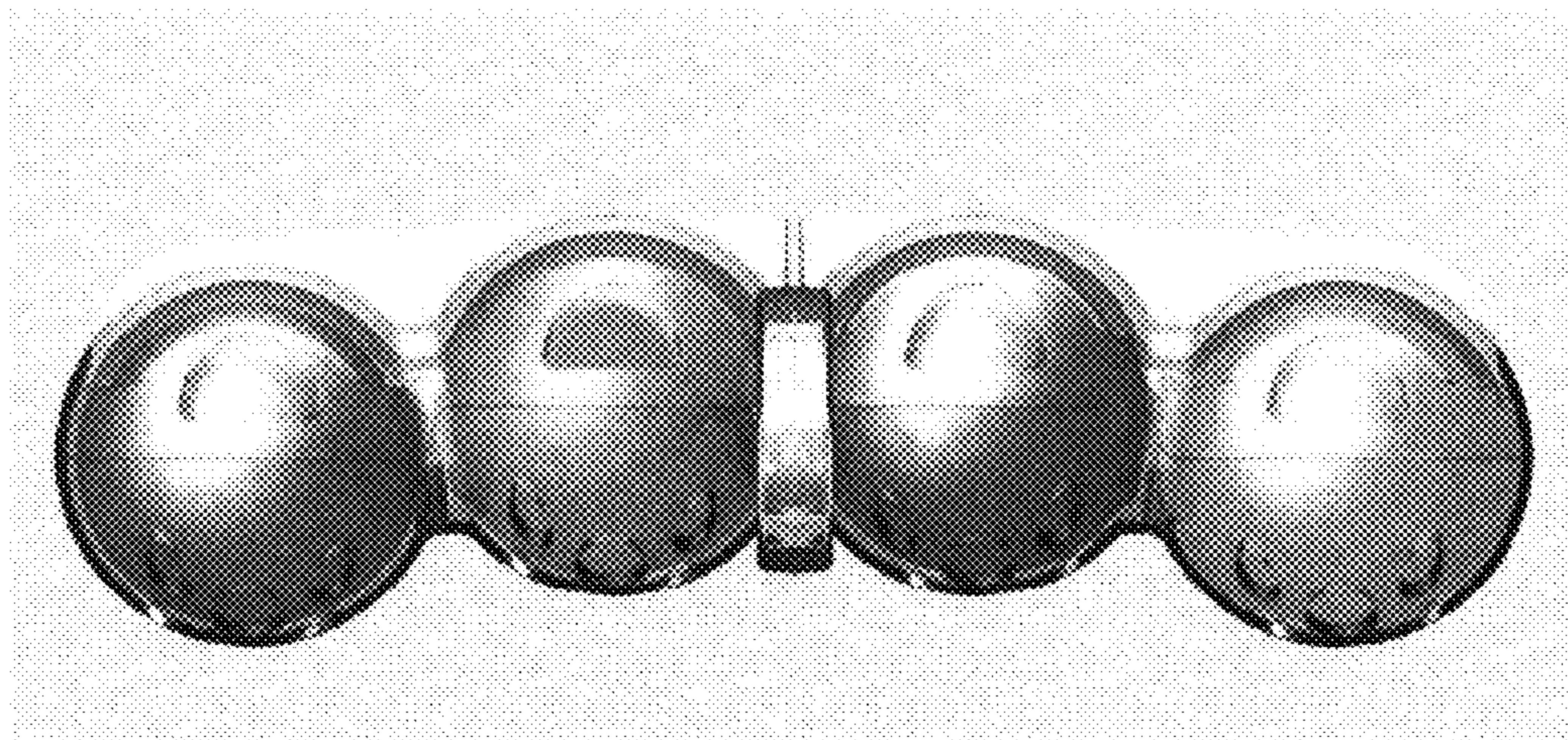

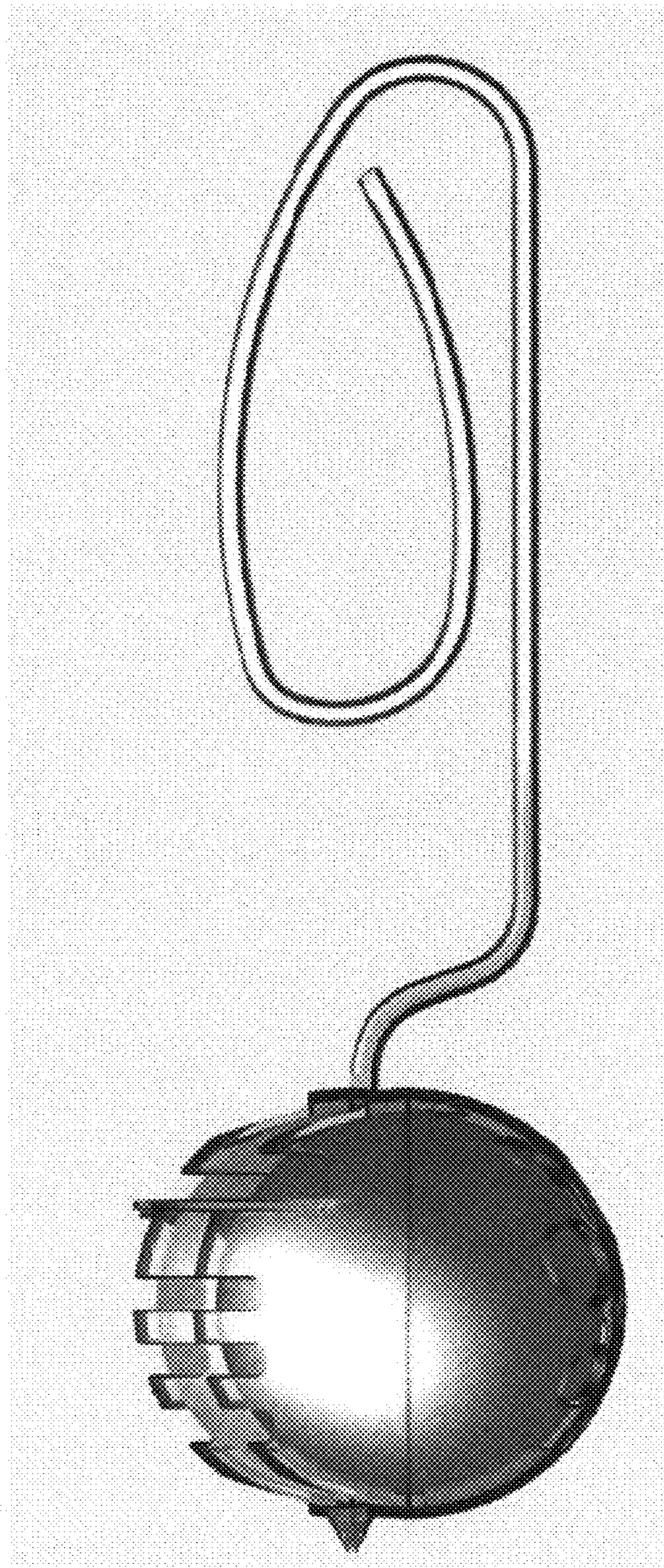

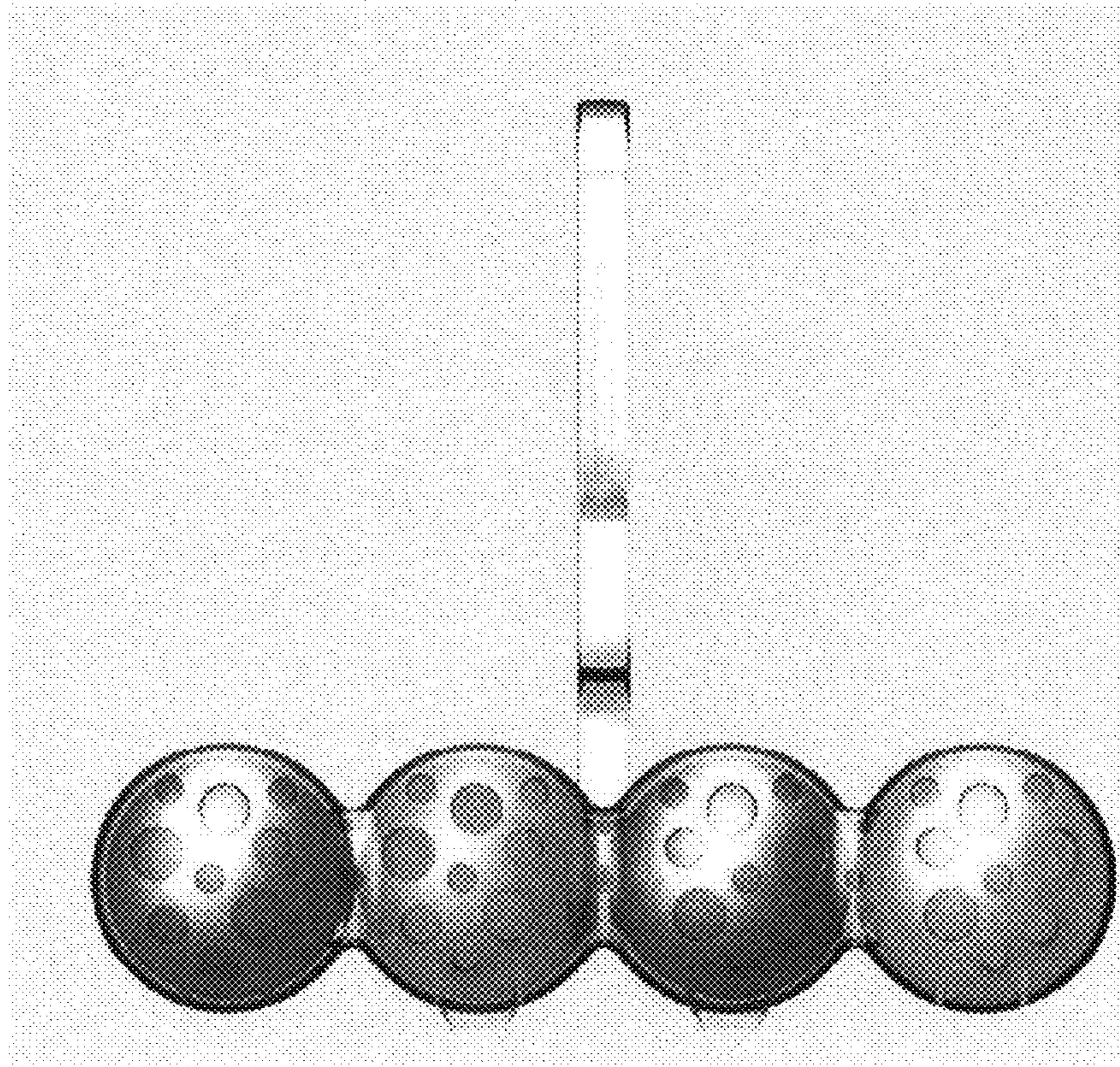

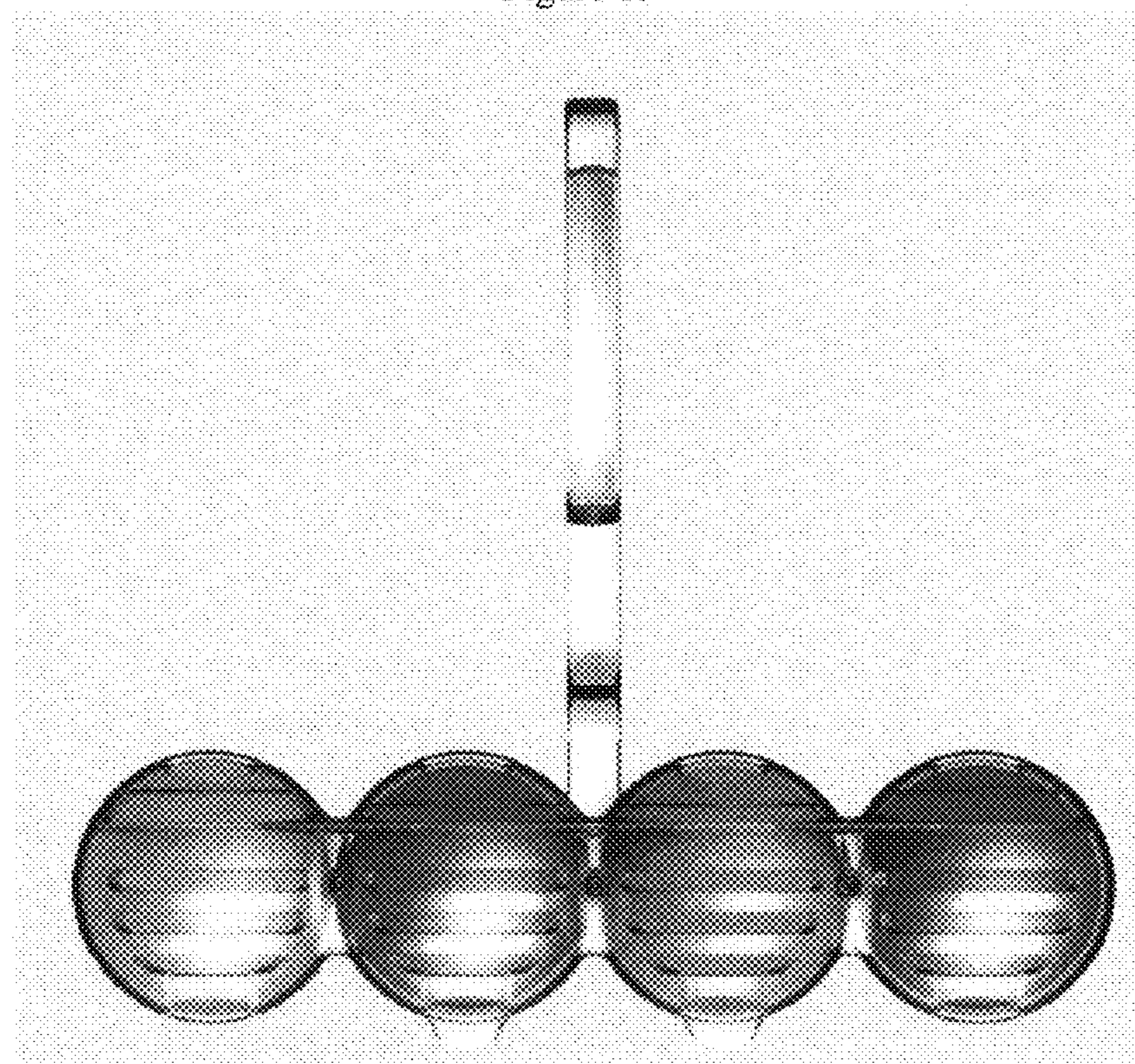

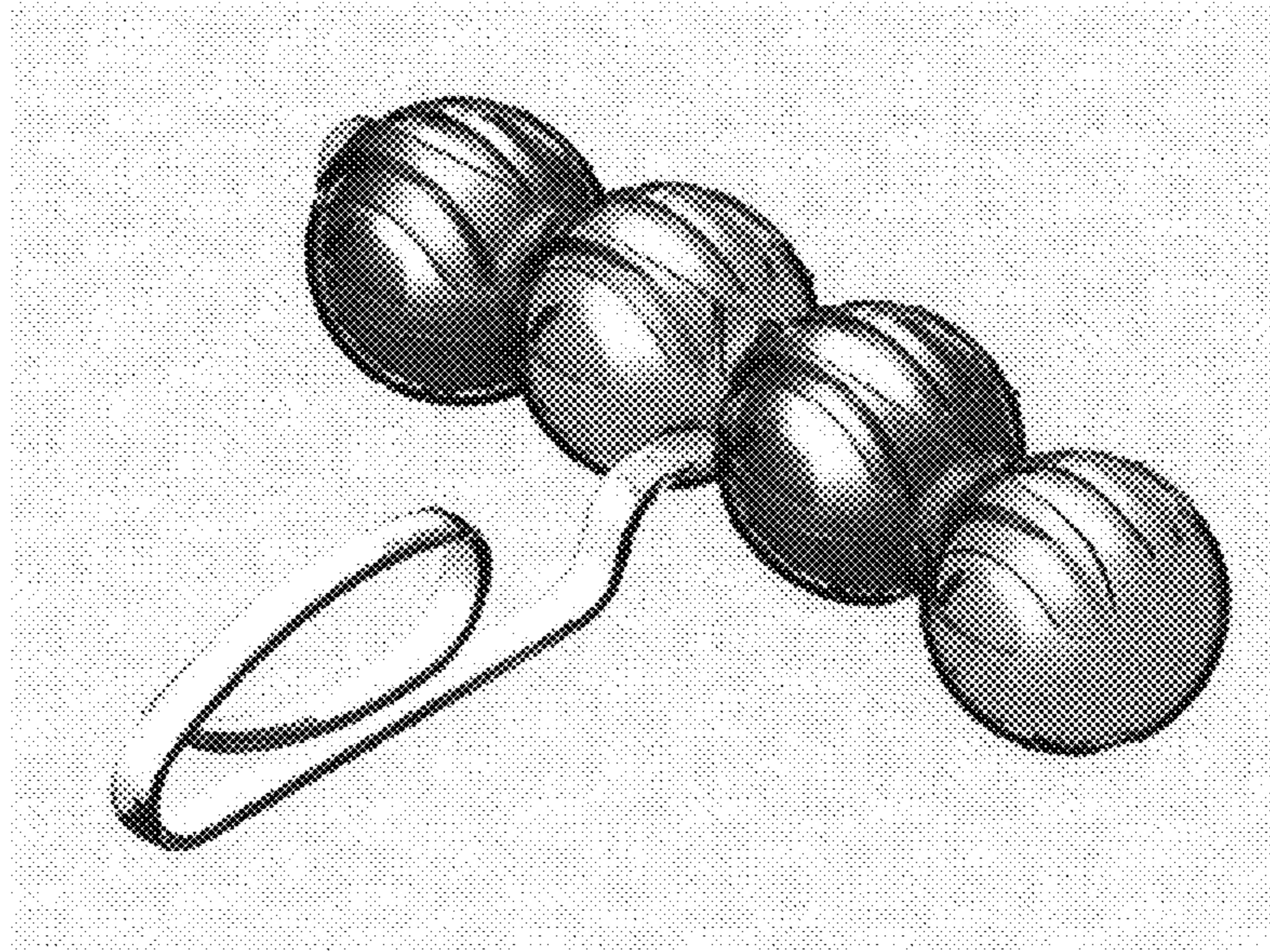

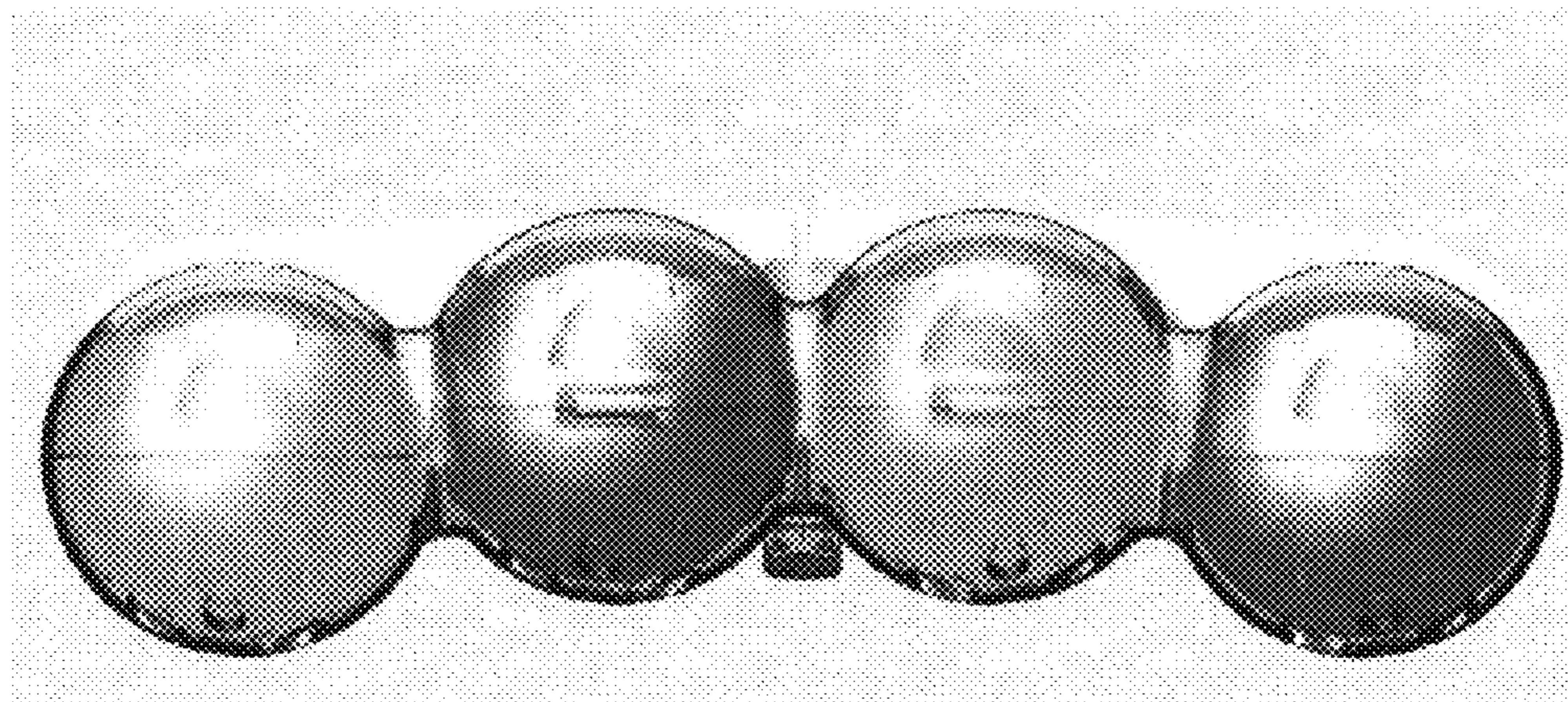

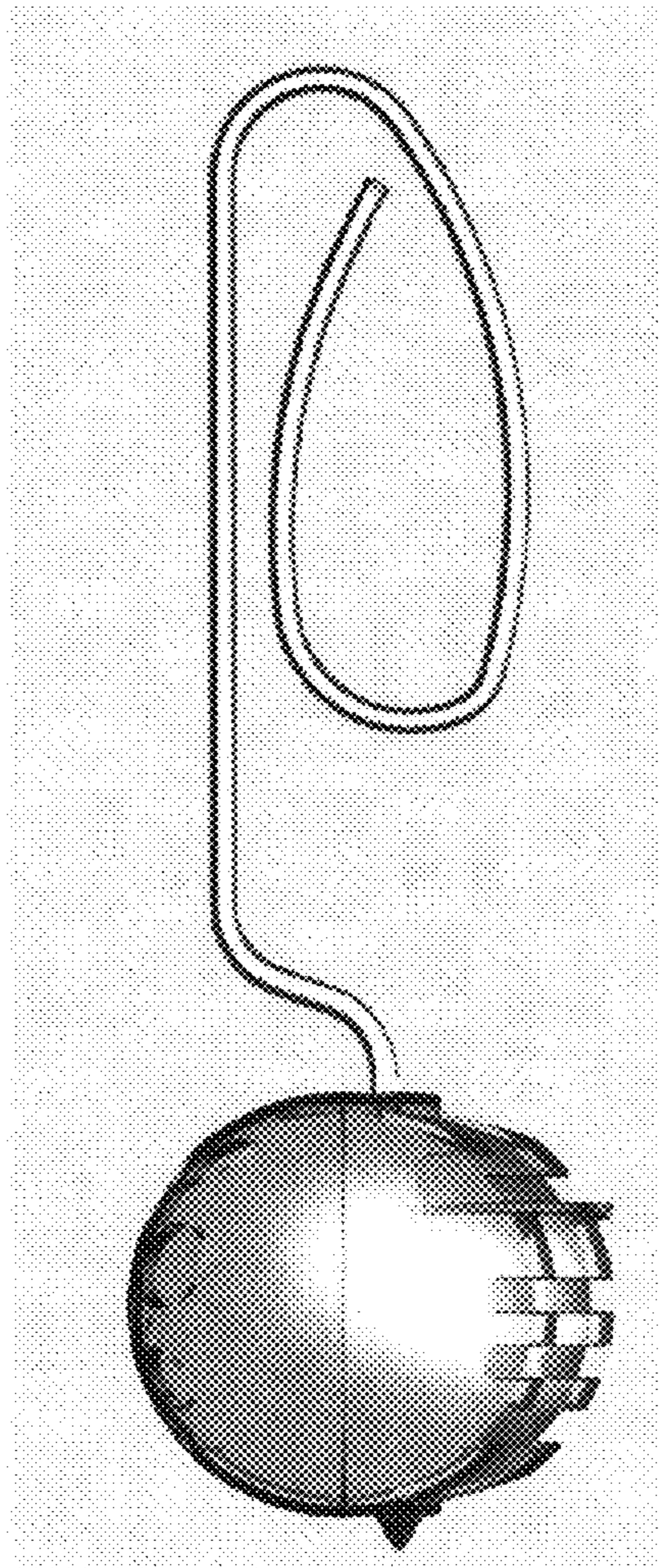

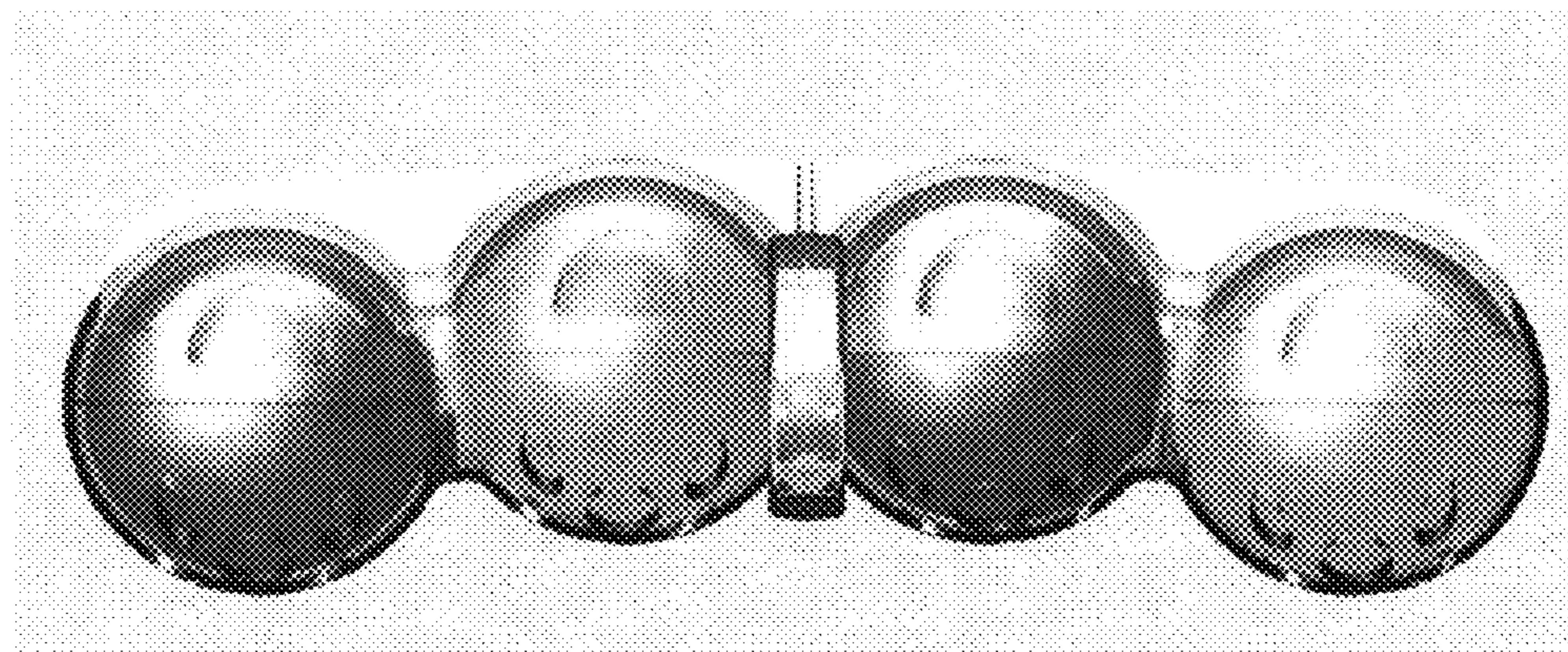

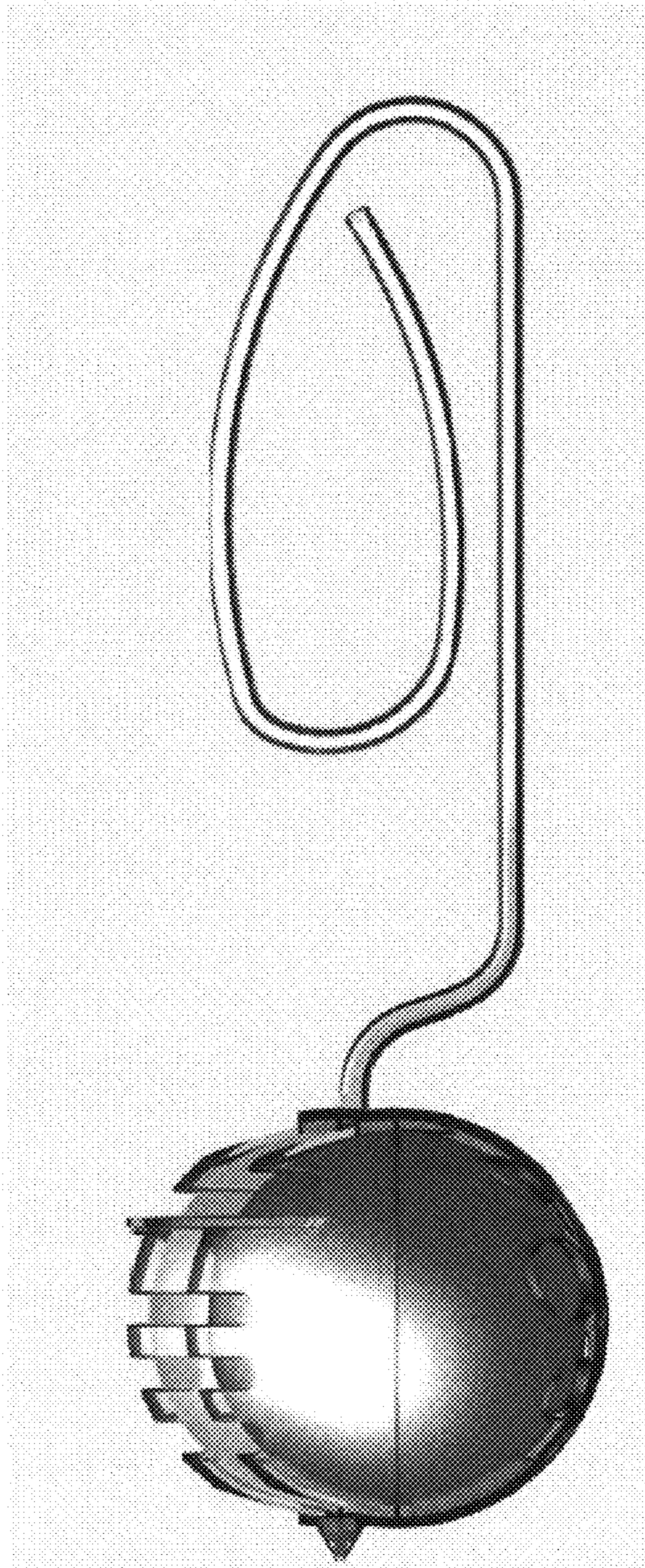

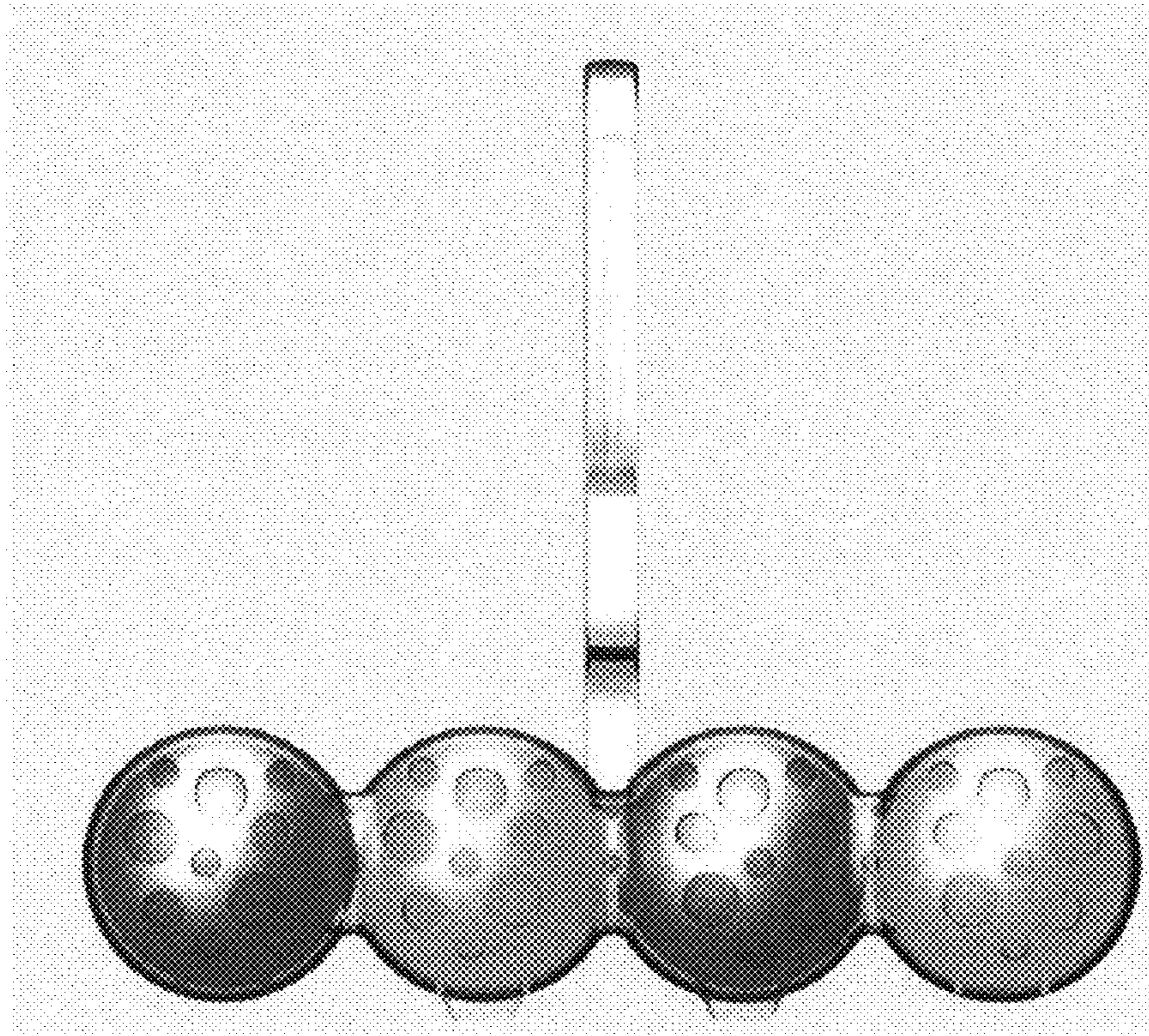

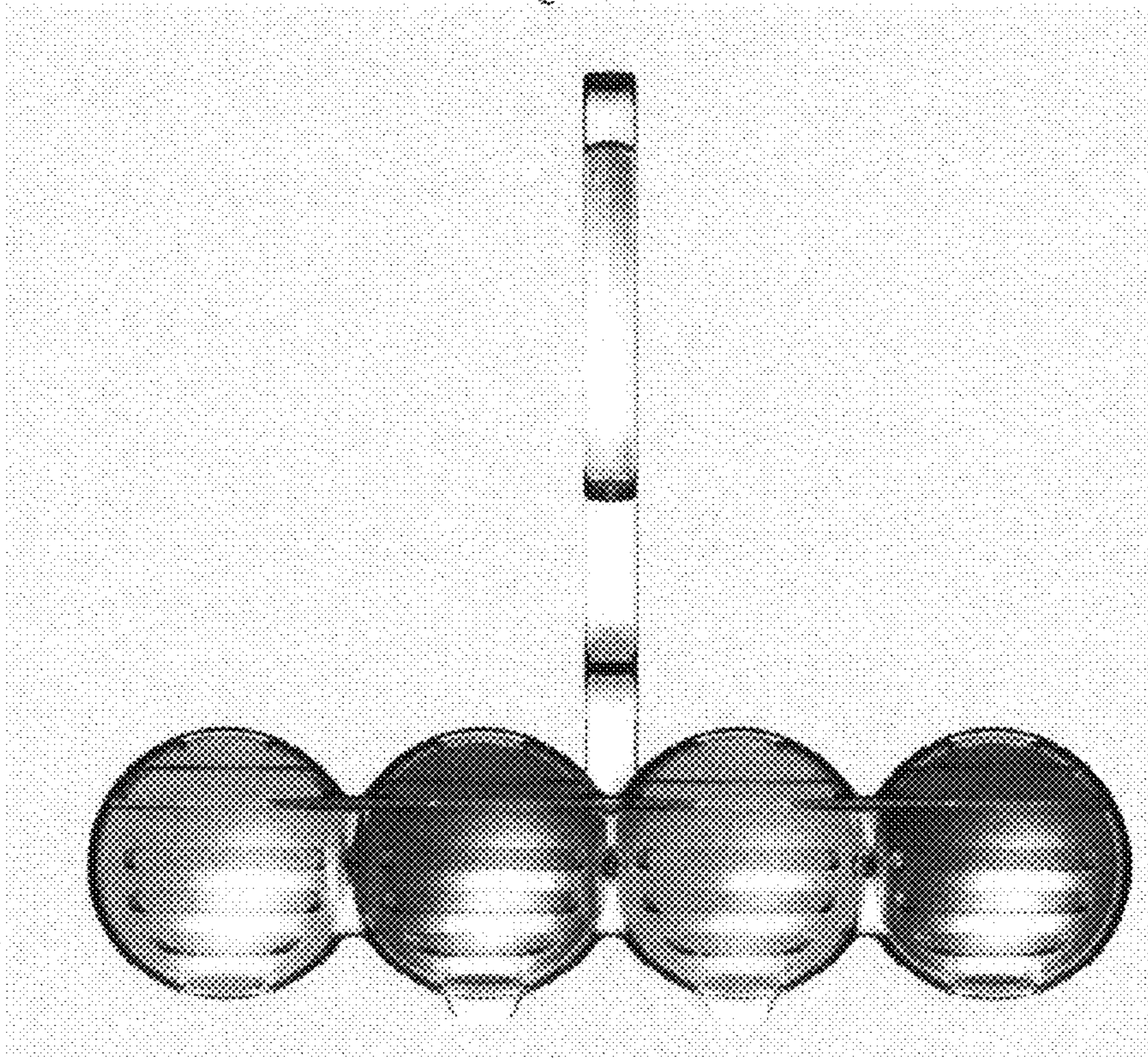
