FIG. 1 is a perspective view of a digital radiography (DR) imager protector;

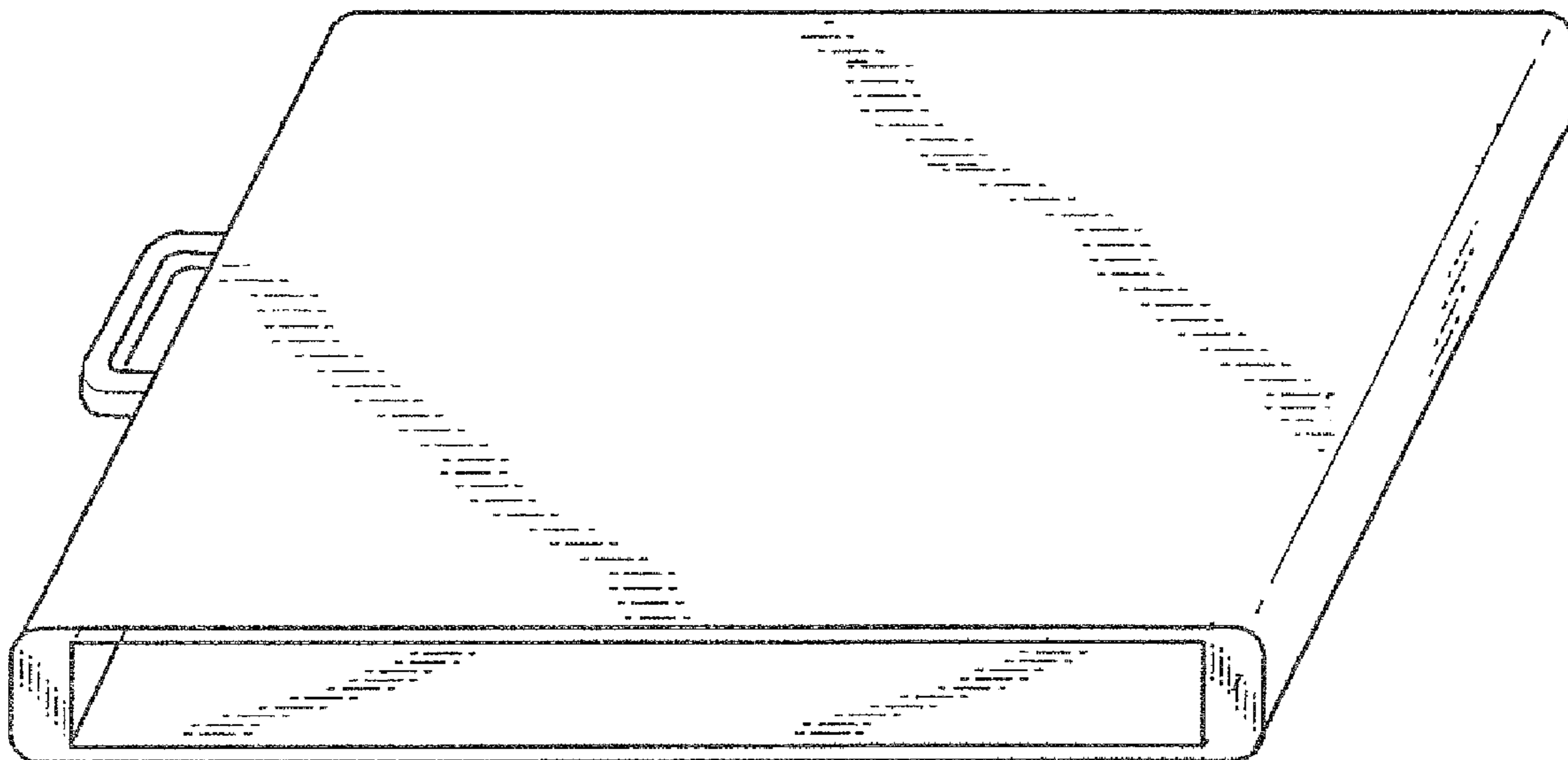
FIG. 2 is a top view thereof;

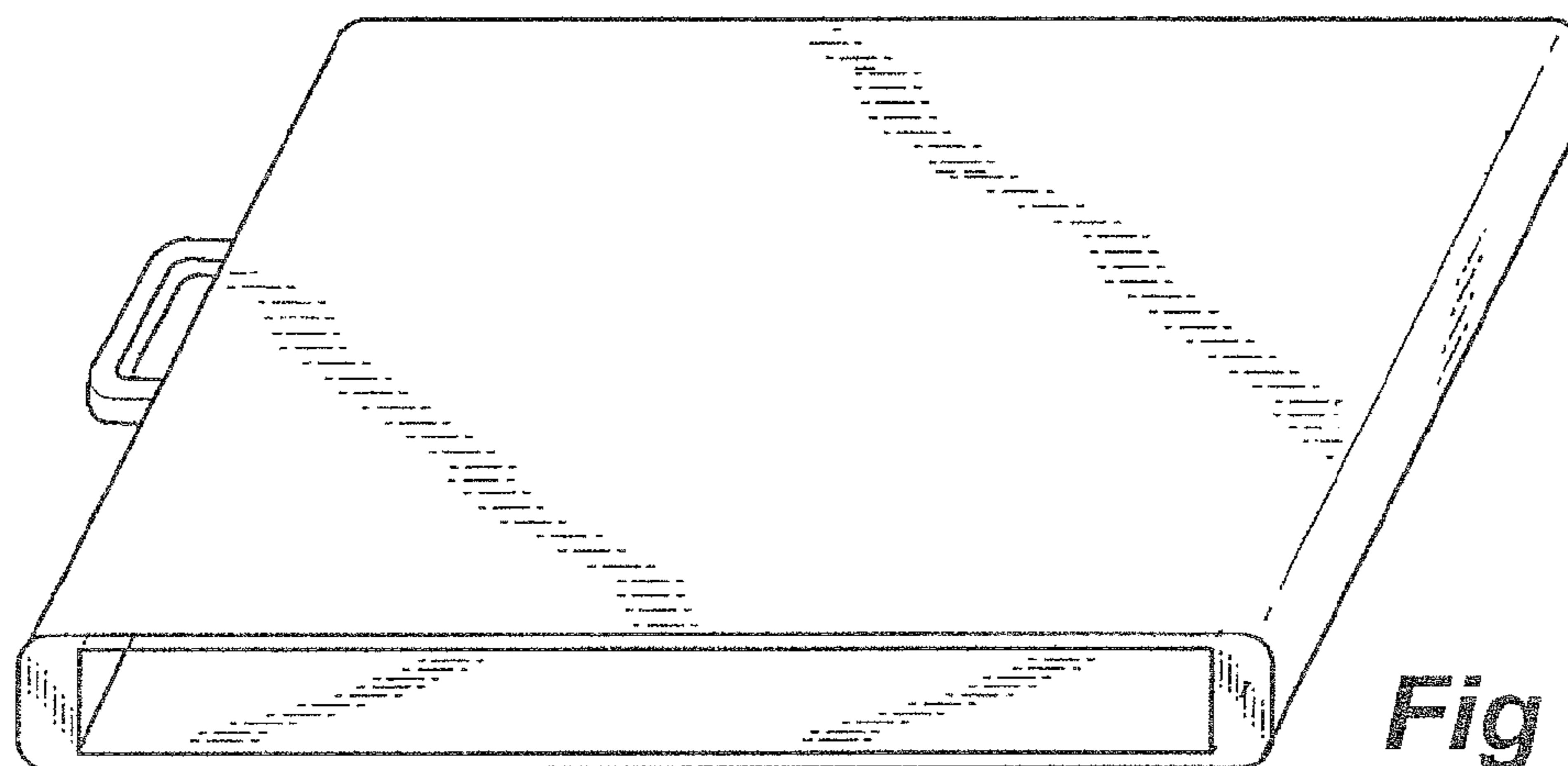

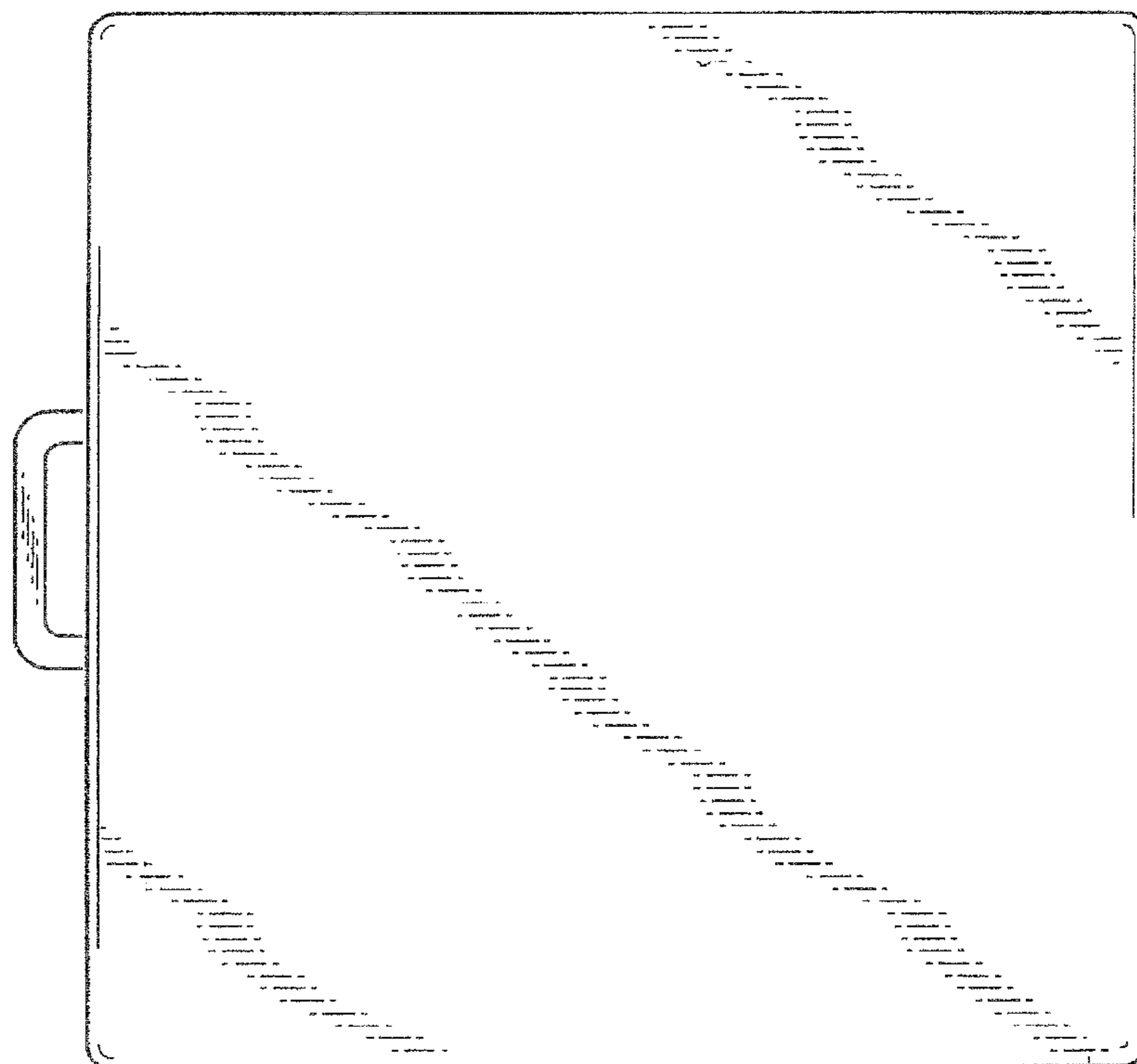

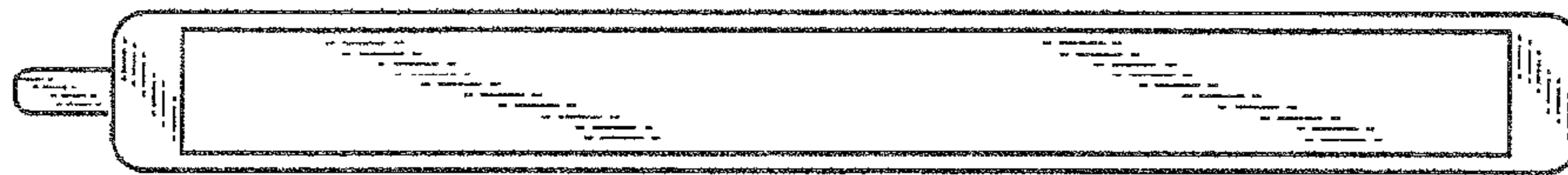
