DESCRIPTION

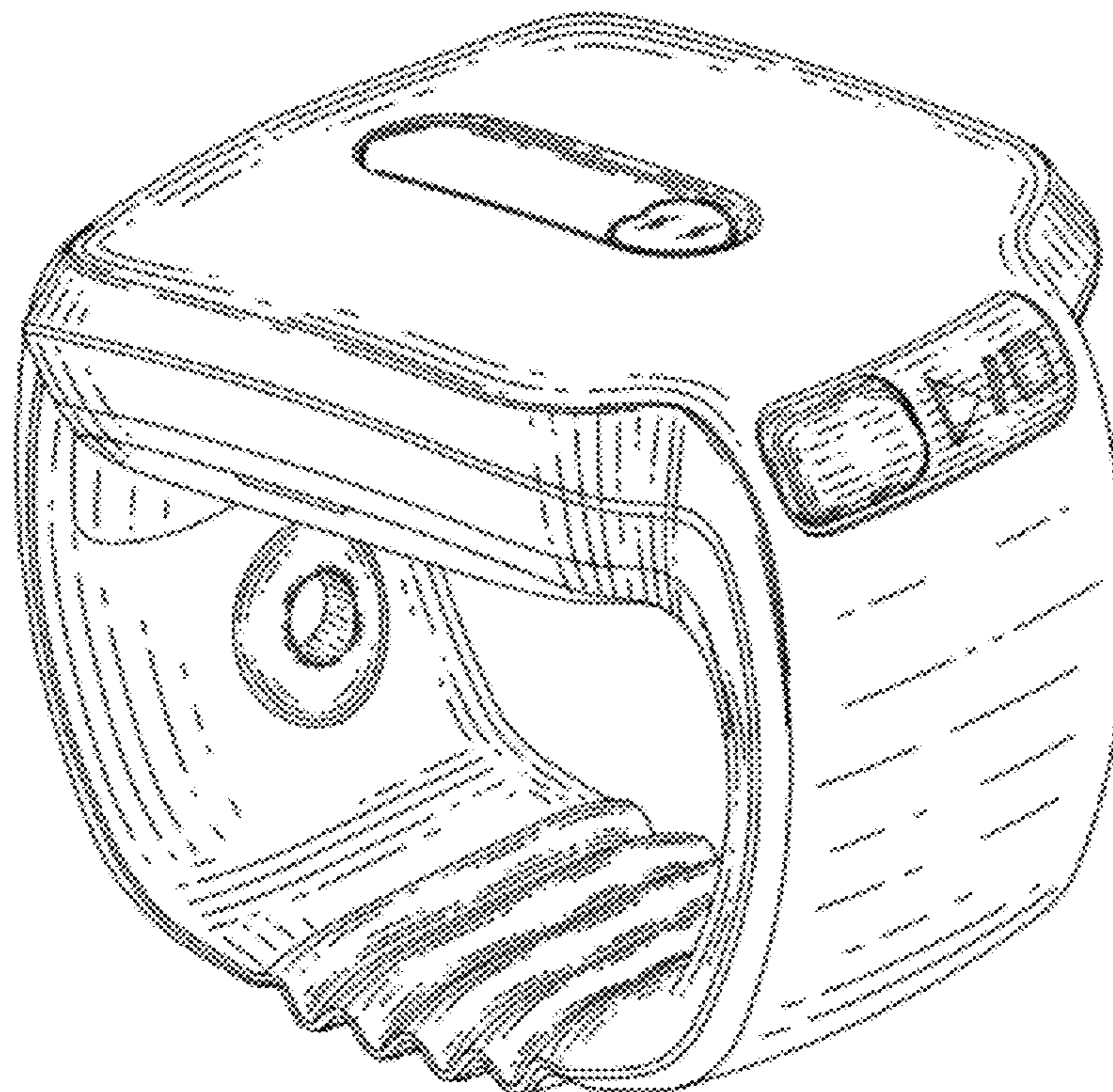
FIG. 1 is a perspective view of a heartbeat ring showing my new design;

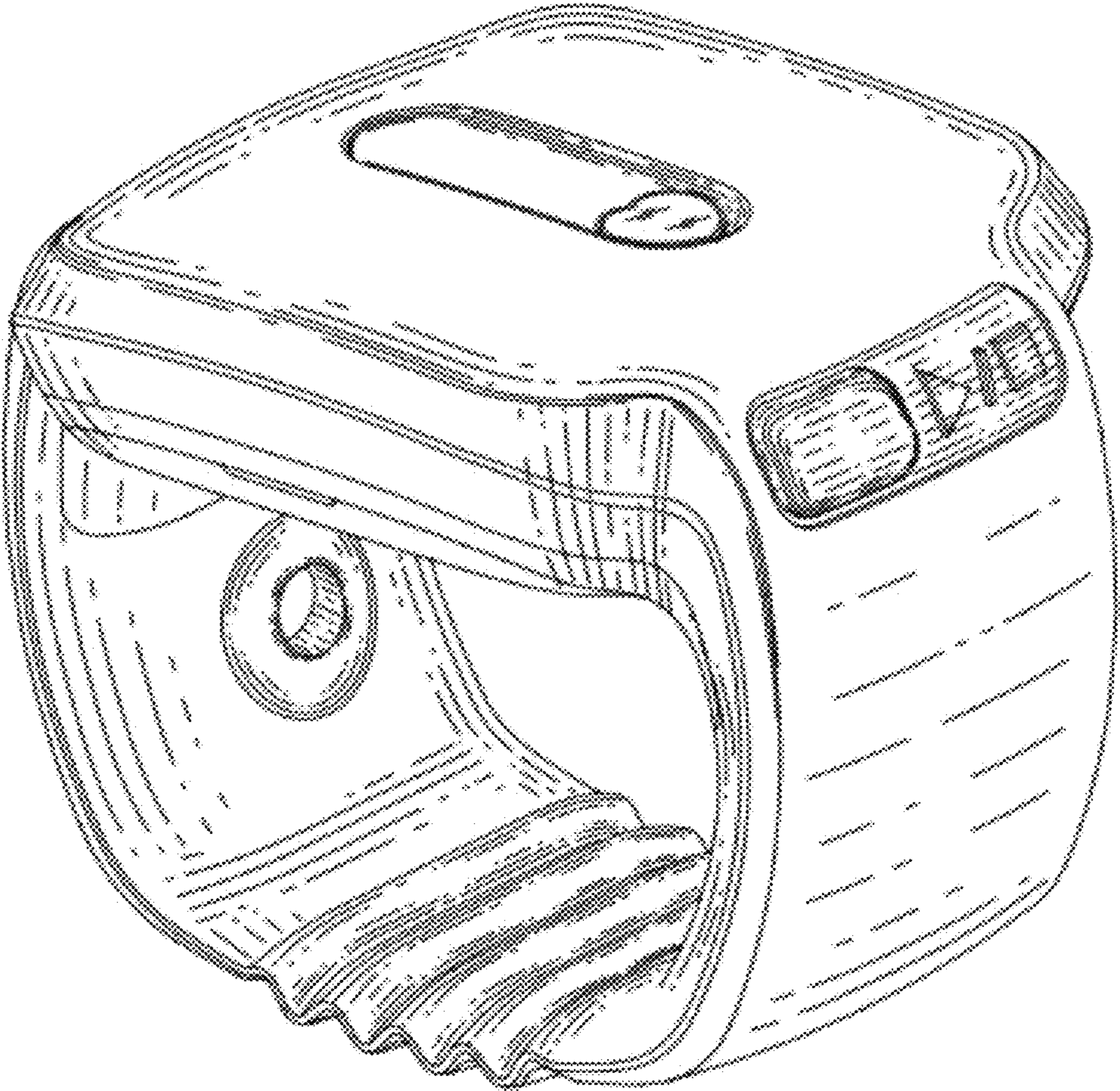

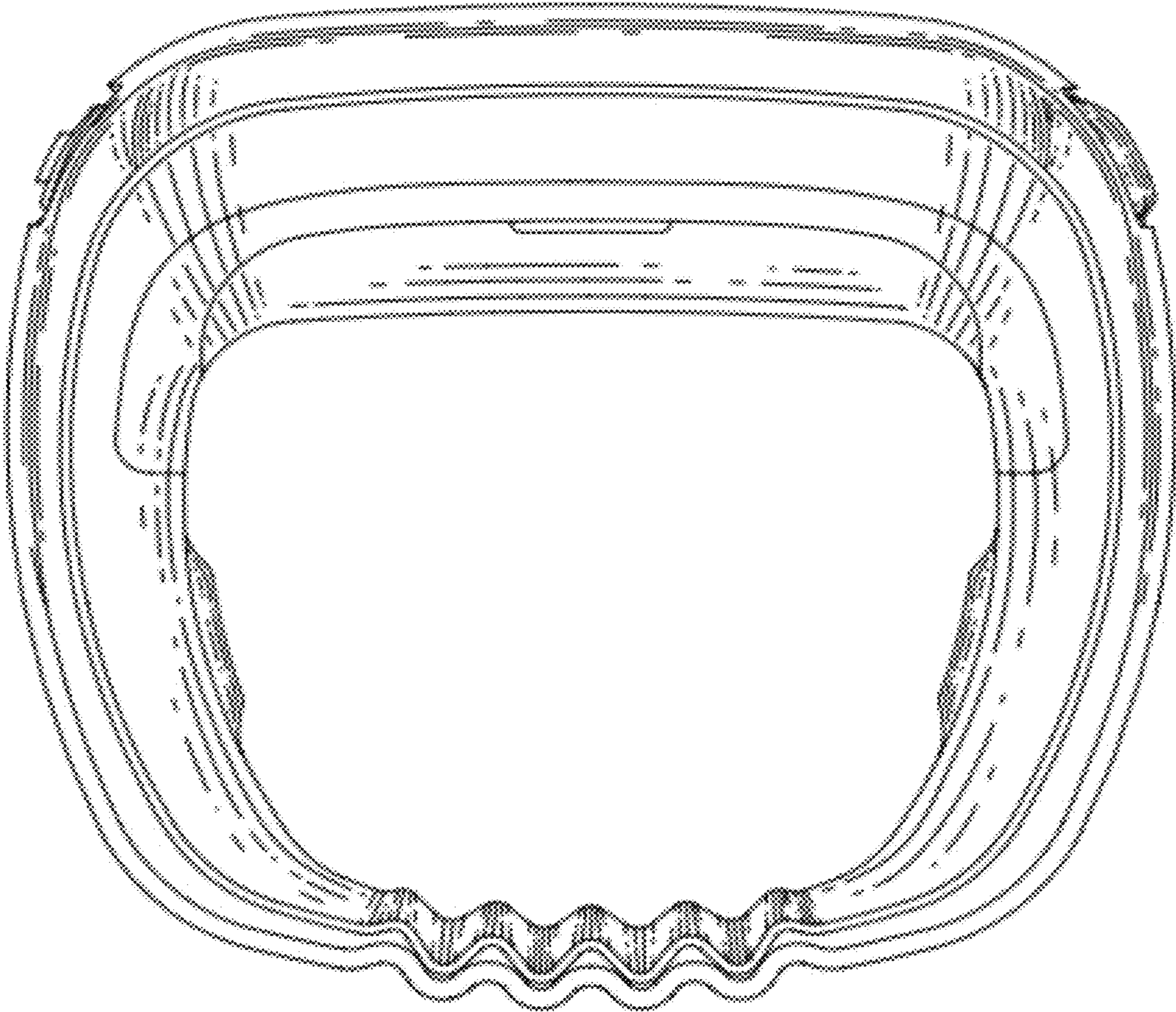

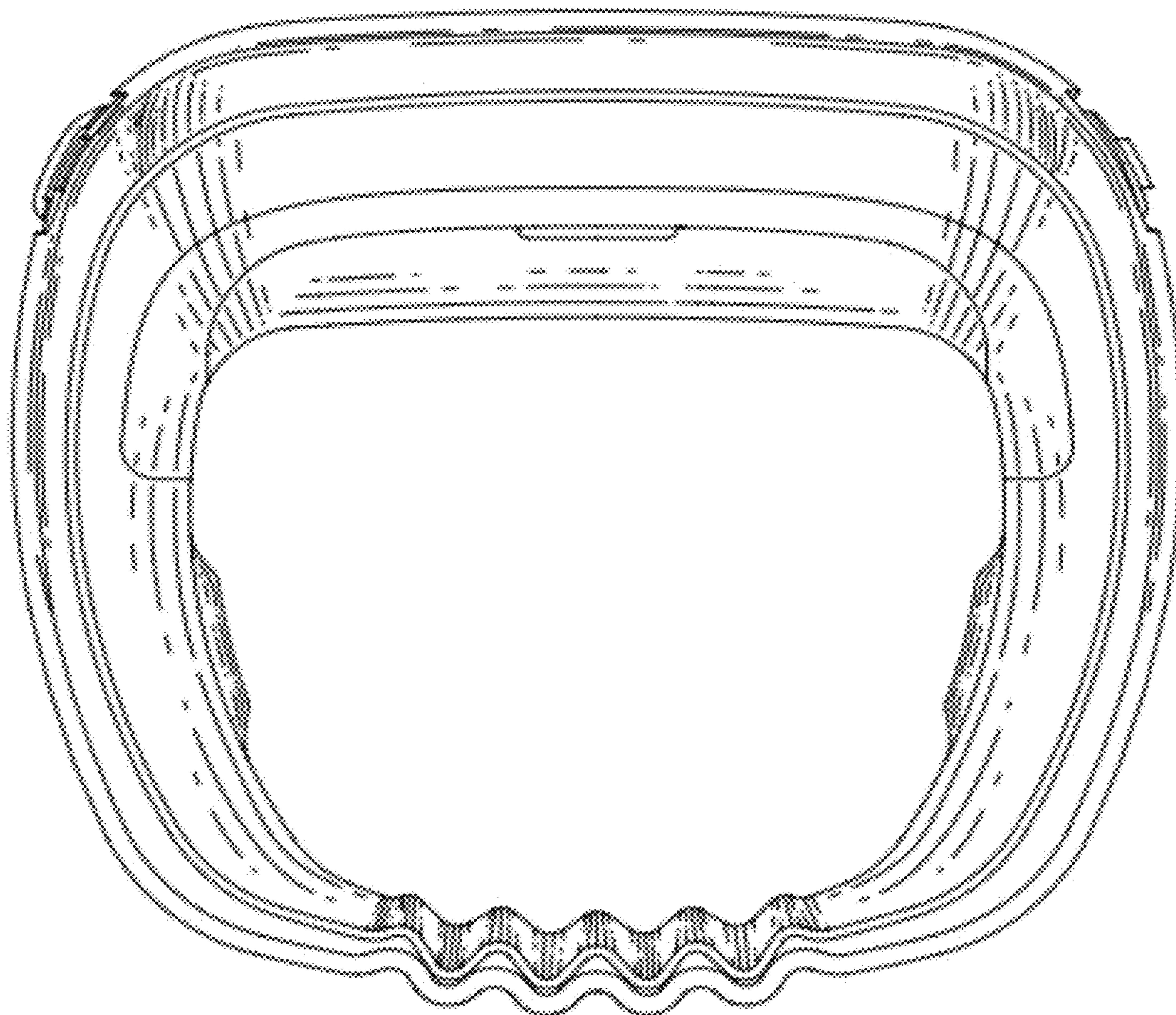

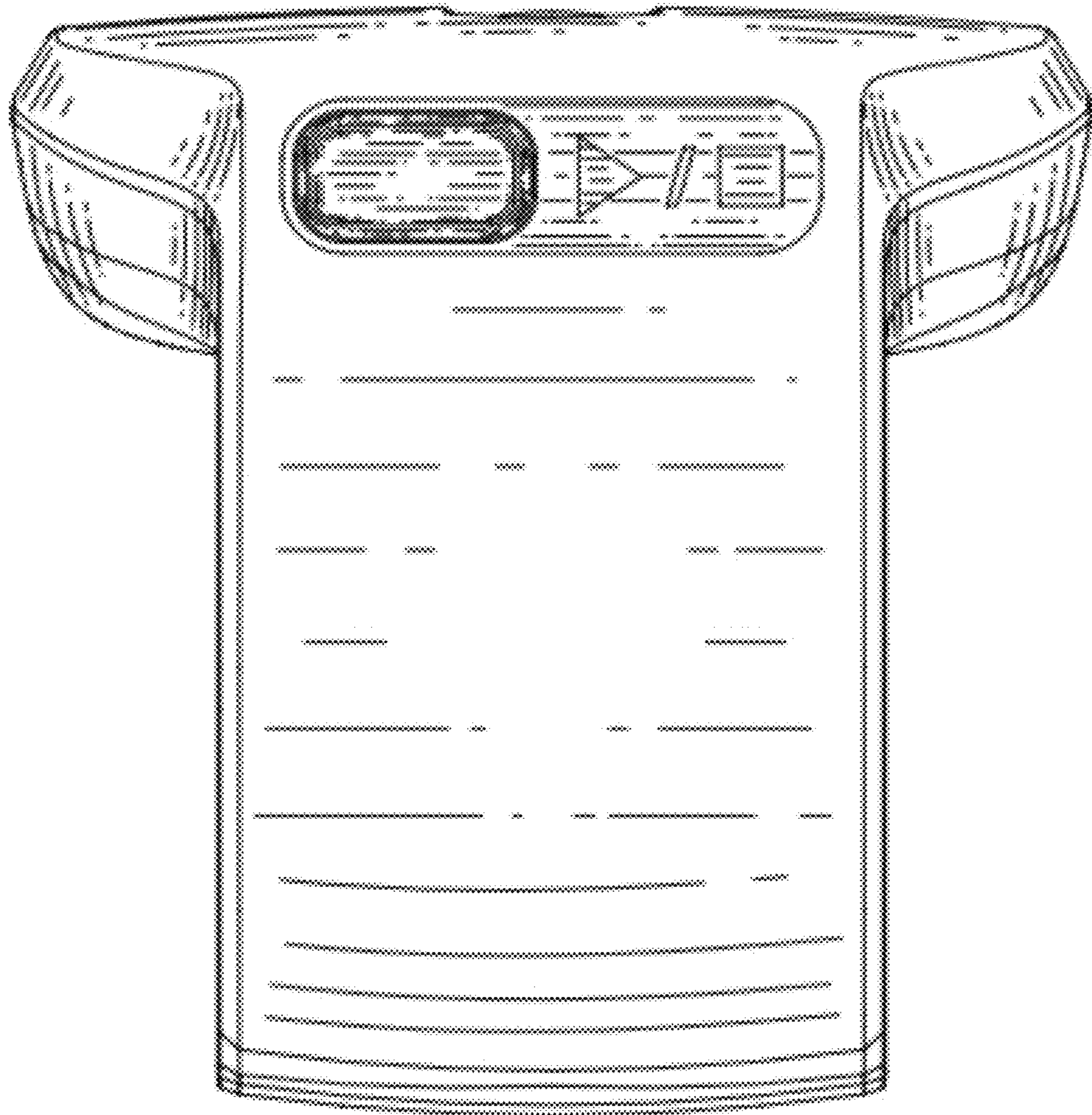

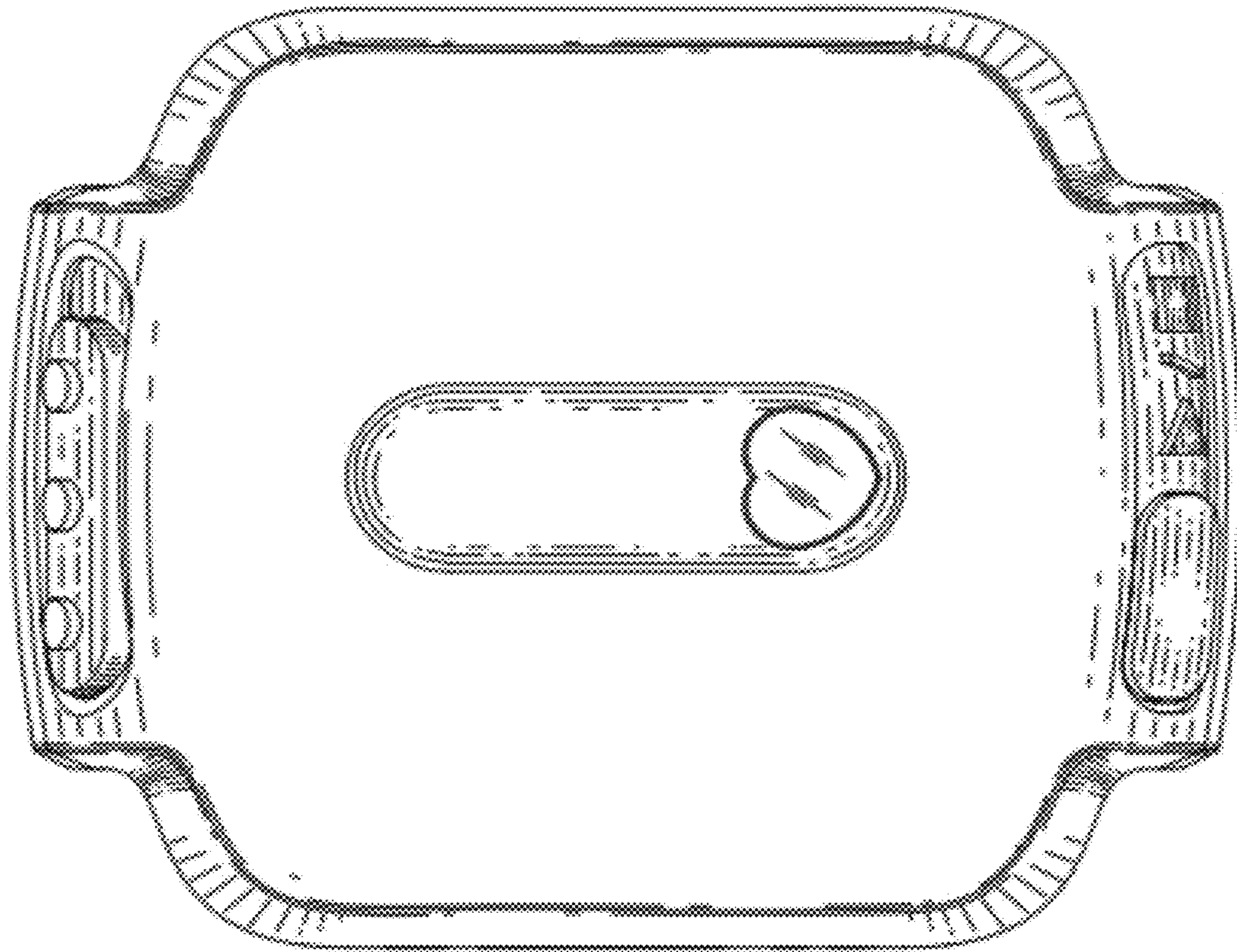

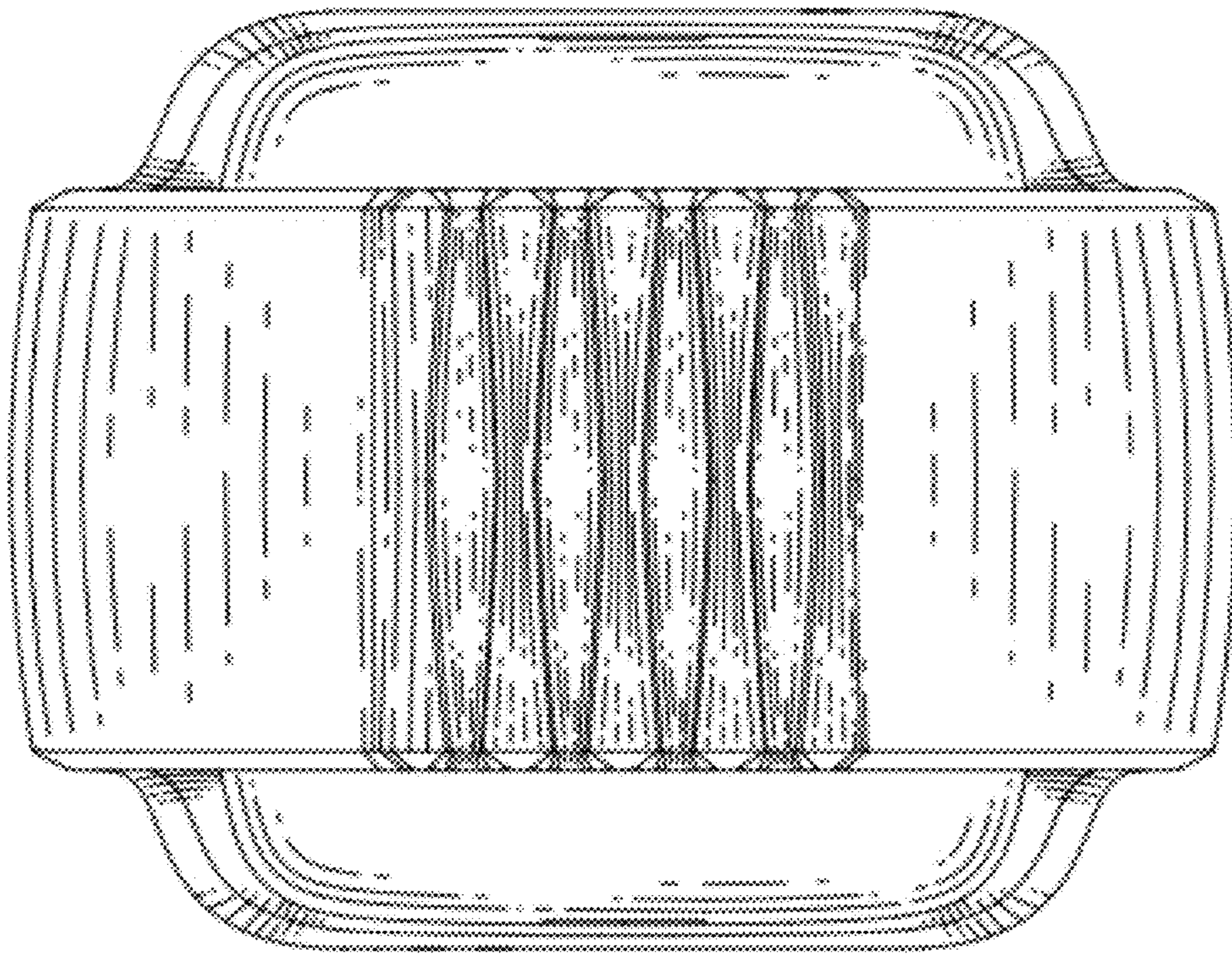
