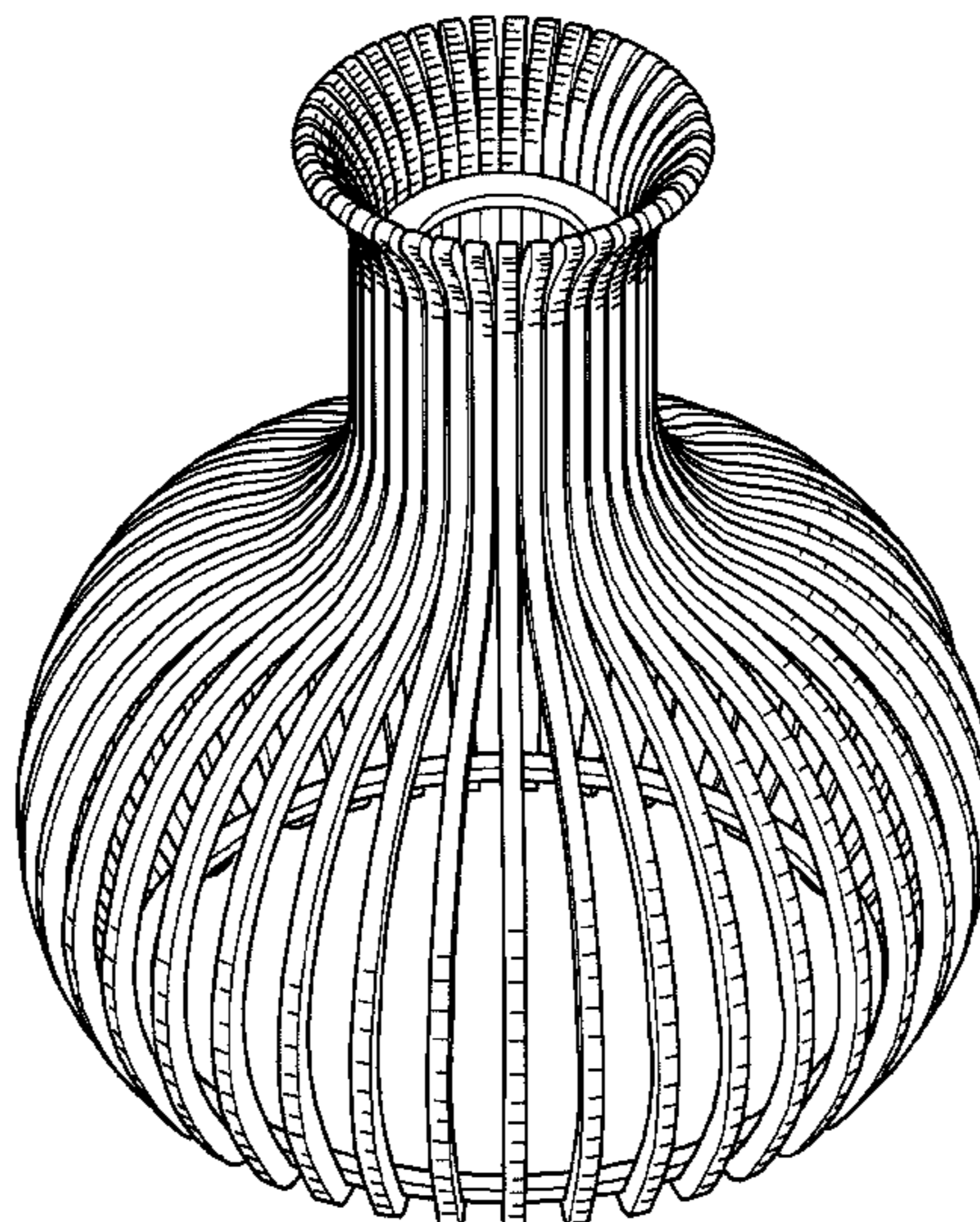
(57) **CLAIM**

I claim the ornamental design for a lamp shade, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view from above of a lamp shade; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left-elevation view thereof, all side views being substantially identical to that shown; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.

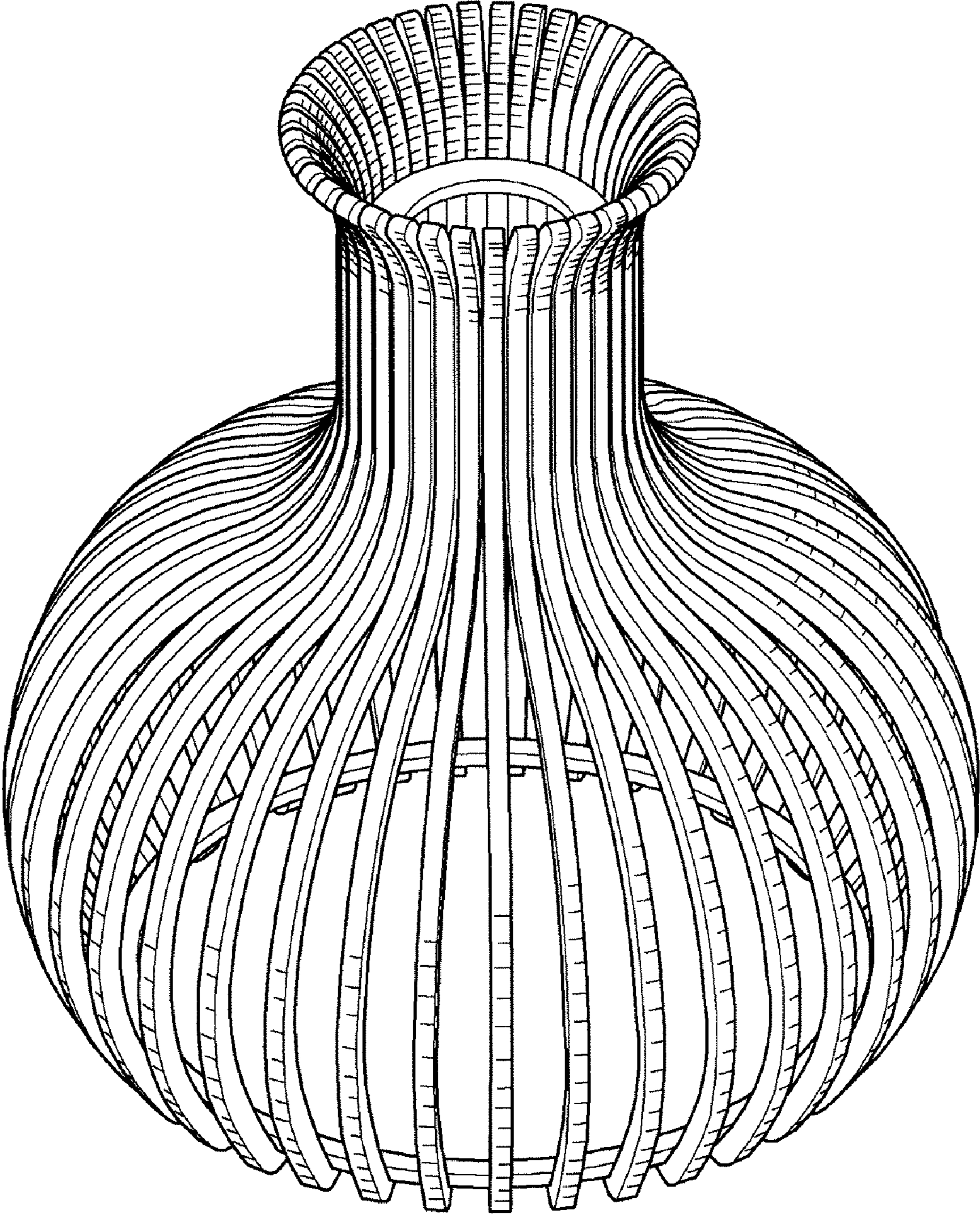

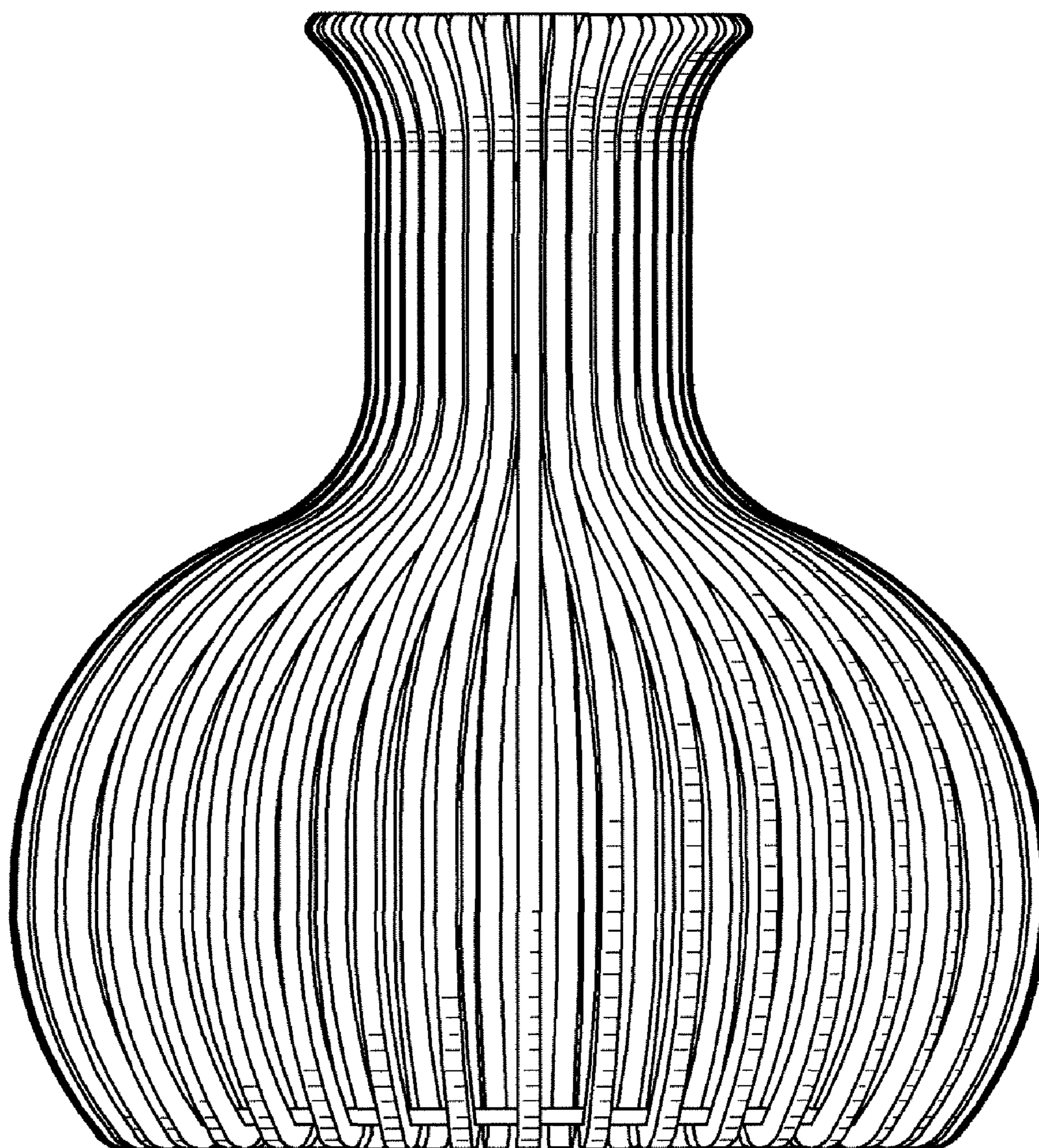

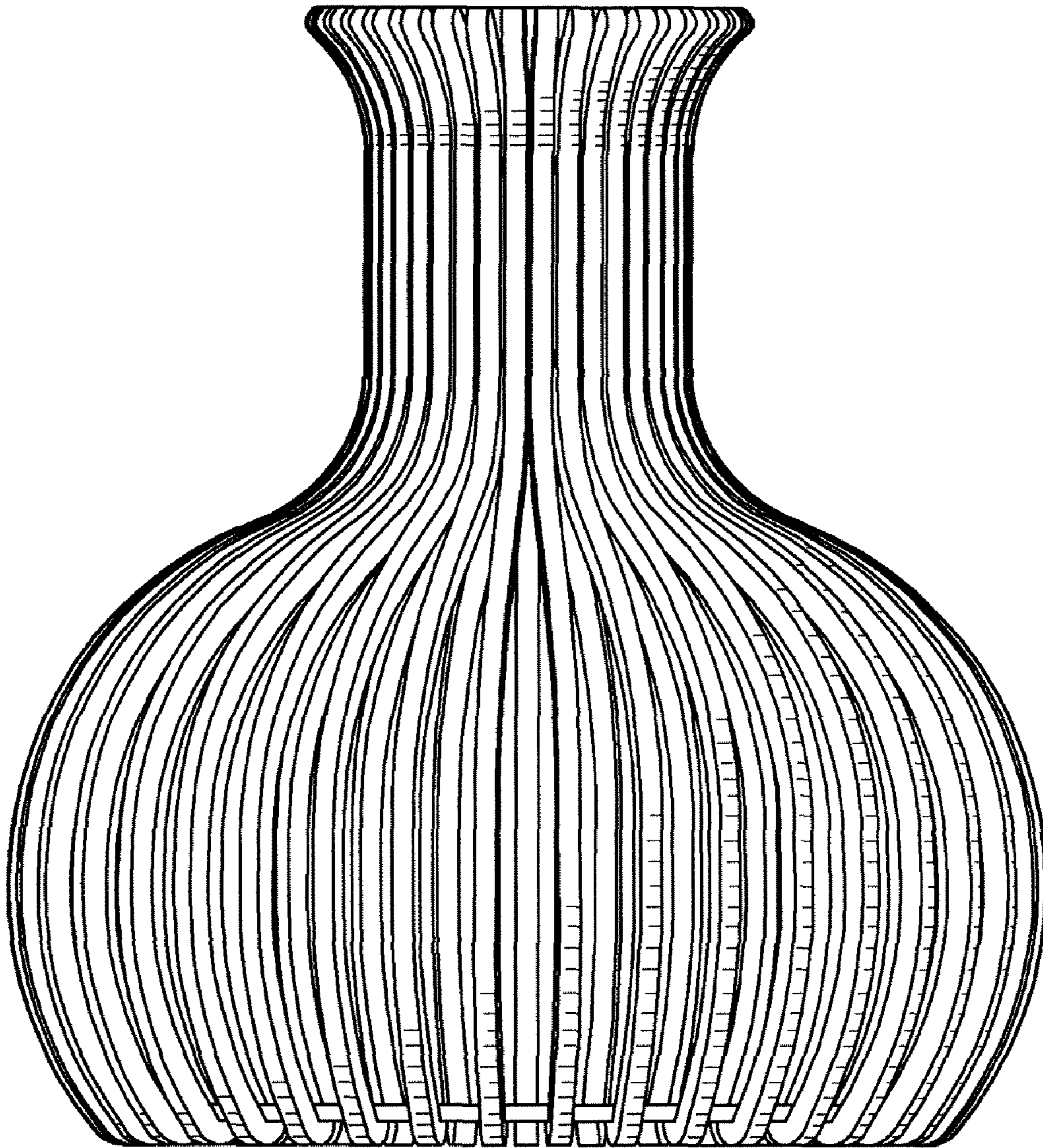

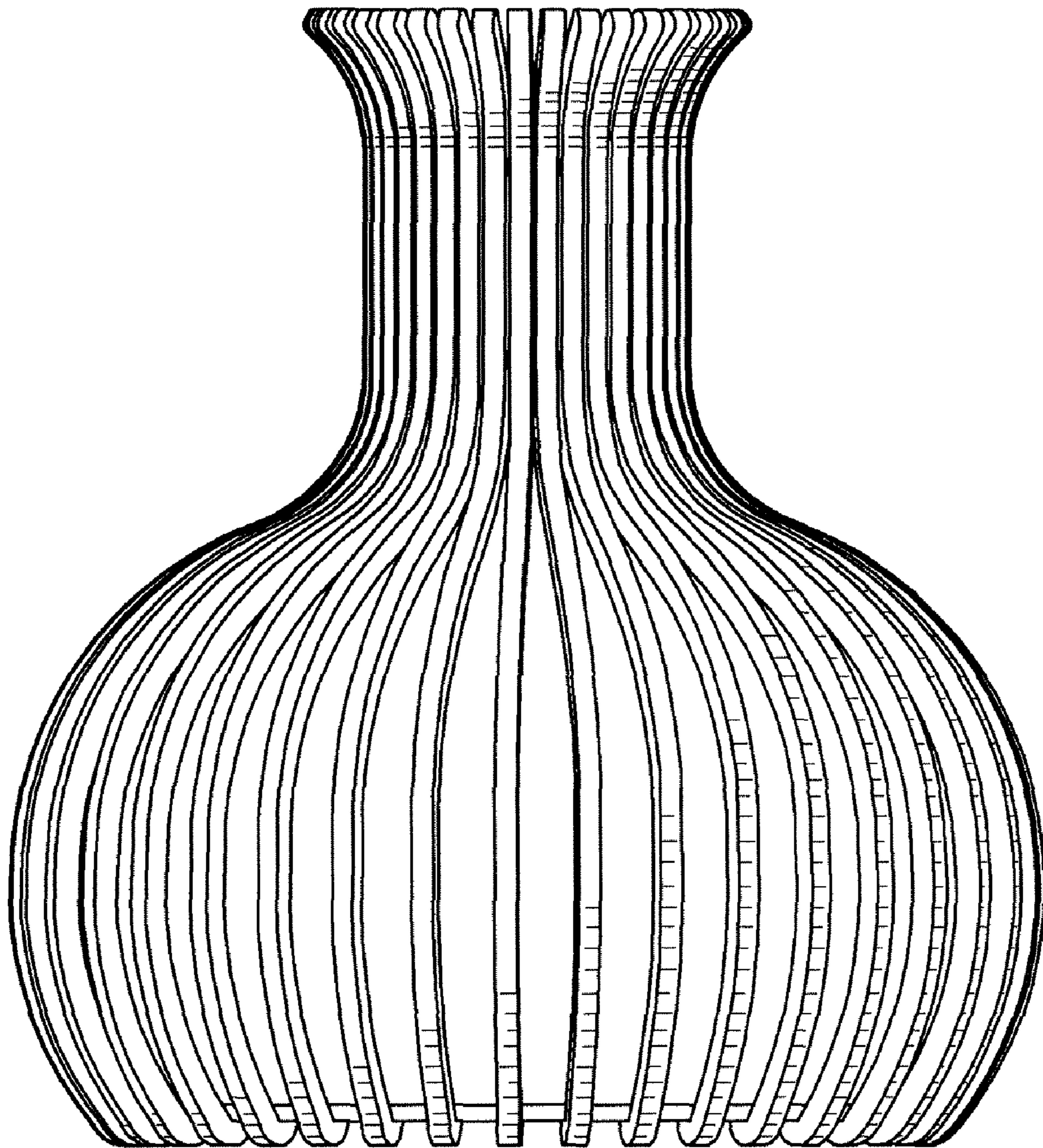

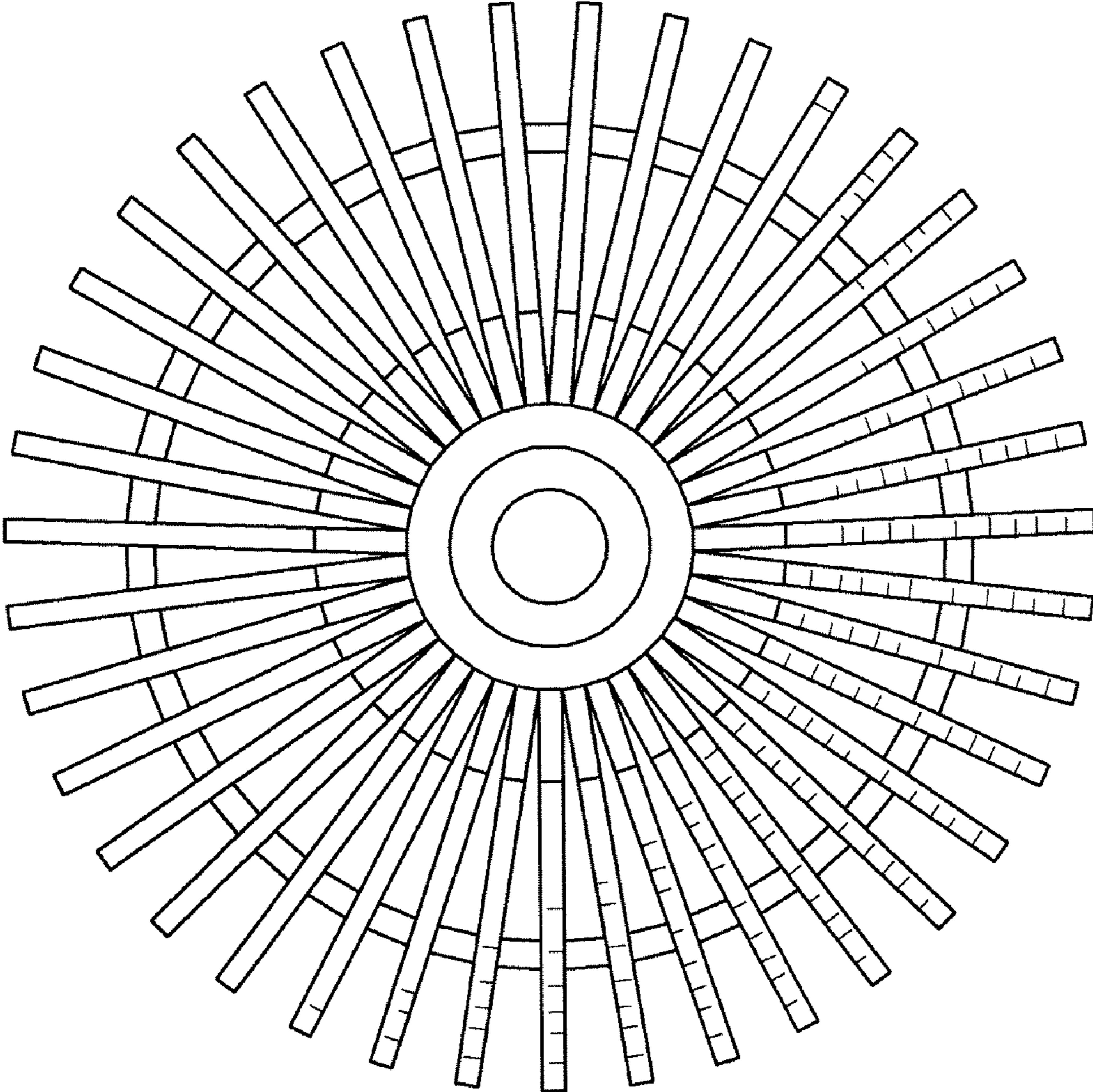
