(57) **CLAIM**

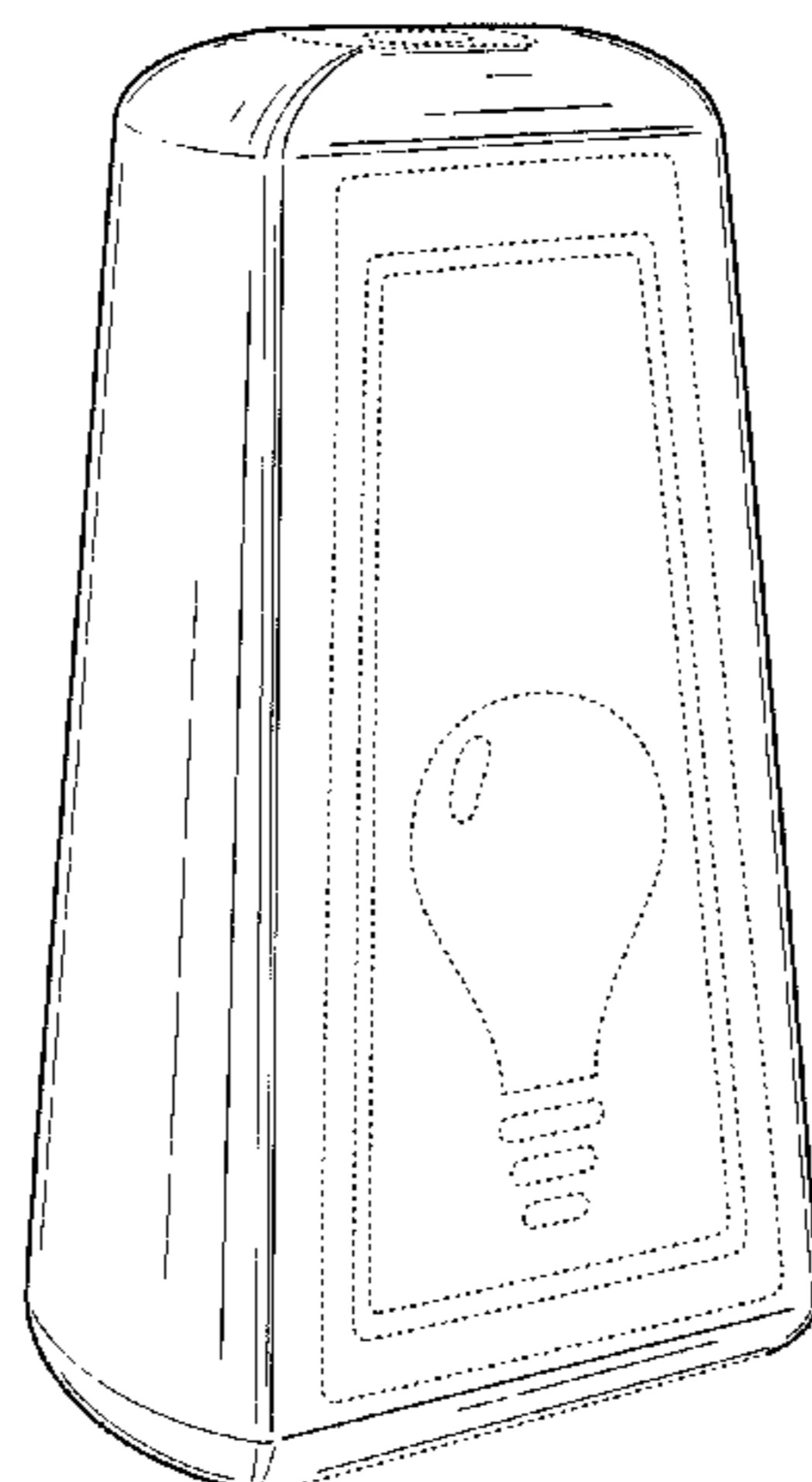
The ornamental design for a fob for a light and/or fan switch, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and left perspective view of a fob for a light and/or fan switch;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

The broken lines shown in the drawings illustrate unclaimed portions of the fob for a light and/or fan switch and form no part of the claimed design. In addition, the surface shading illustrated in the drawings is provided merely to highlight the contour of the design; it is not intended to be illustrative of texture or gloss.

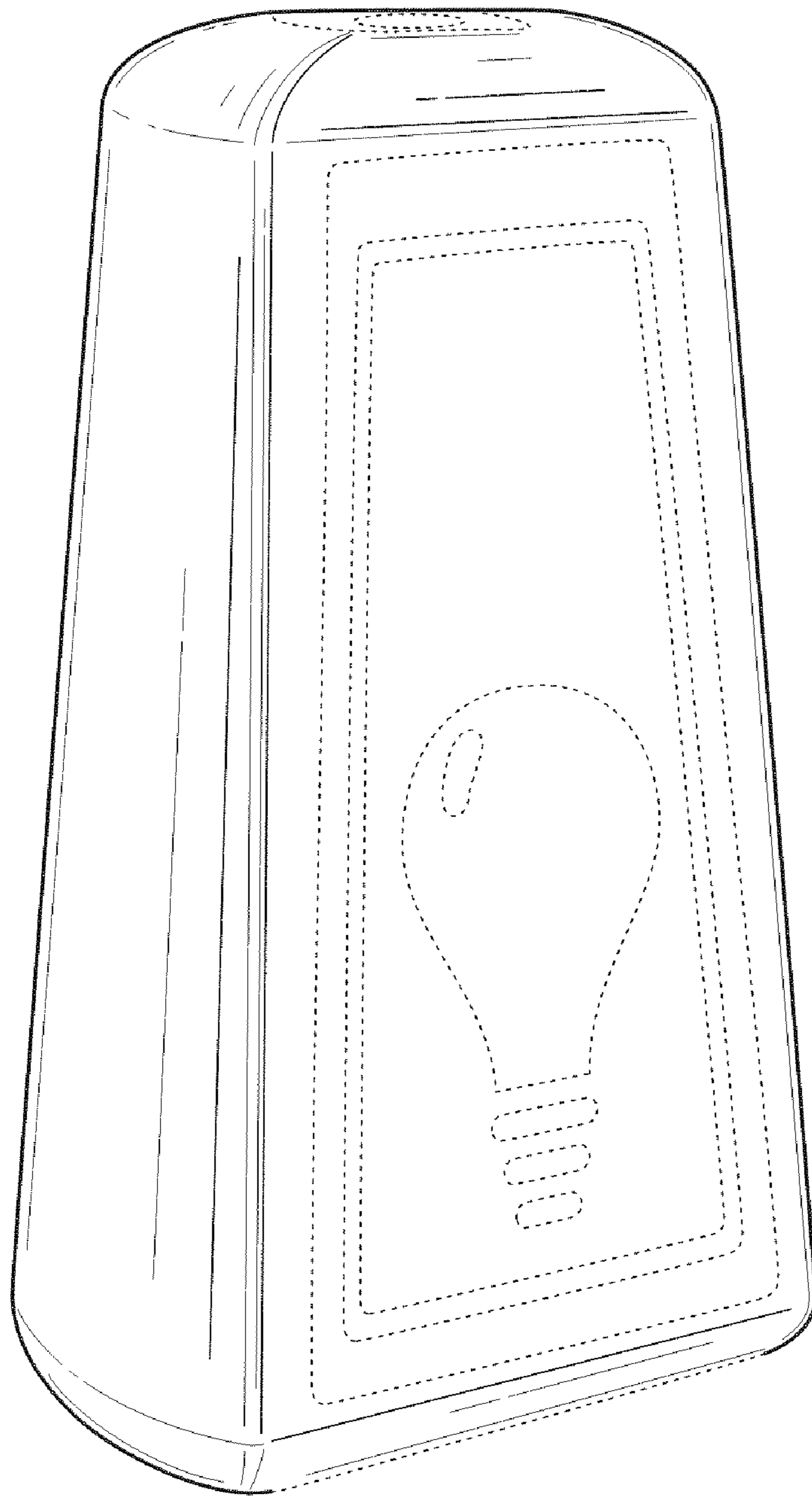

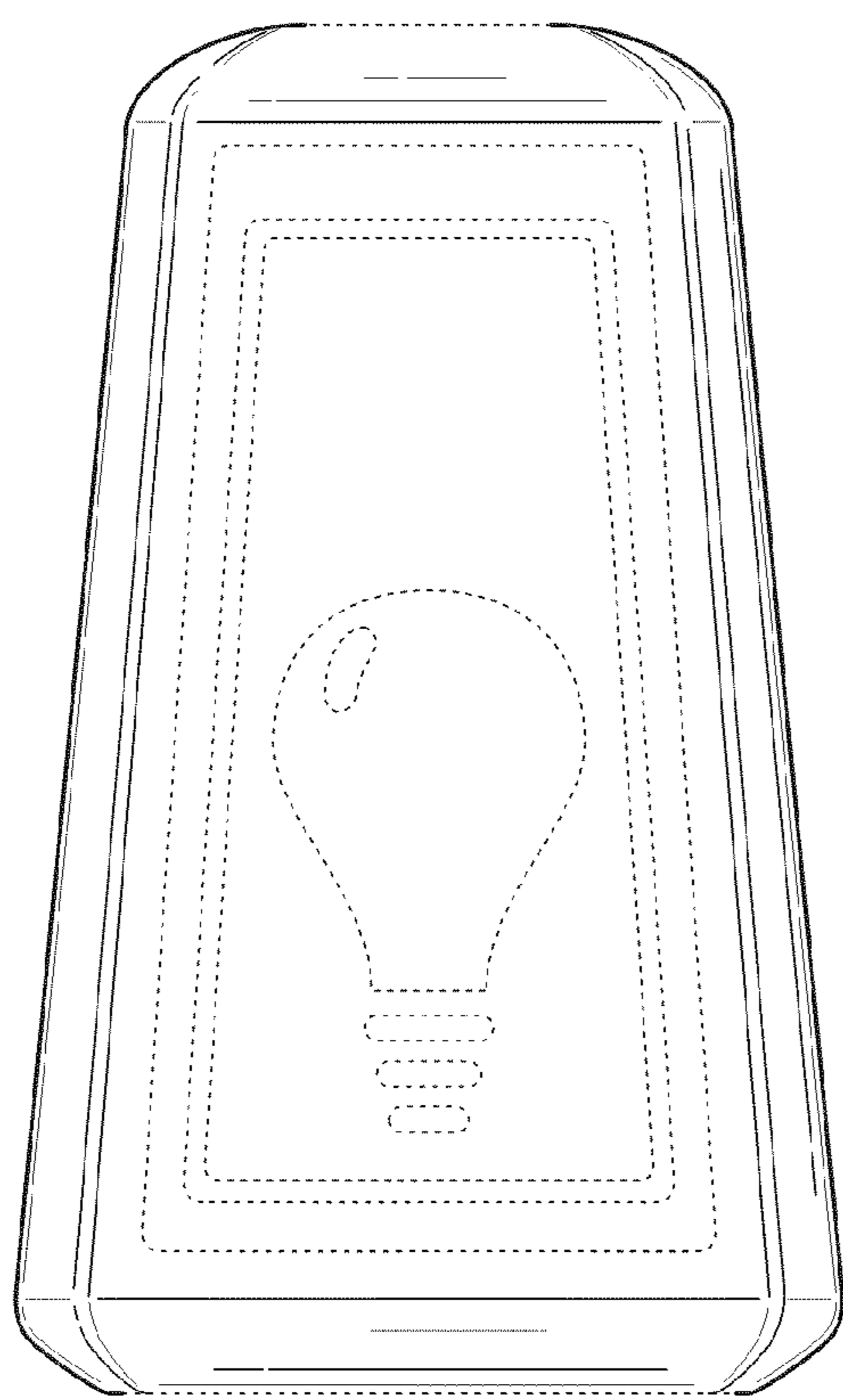

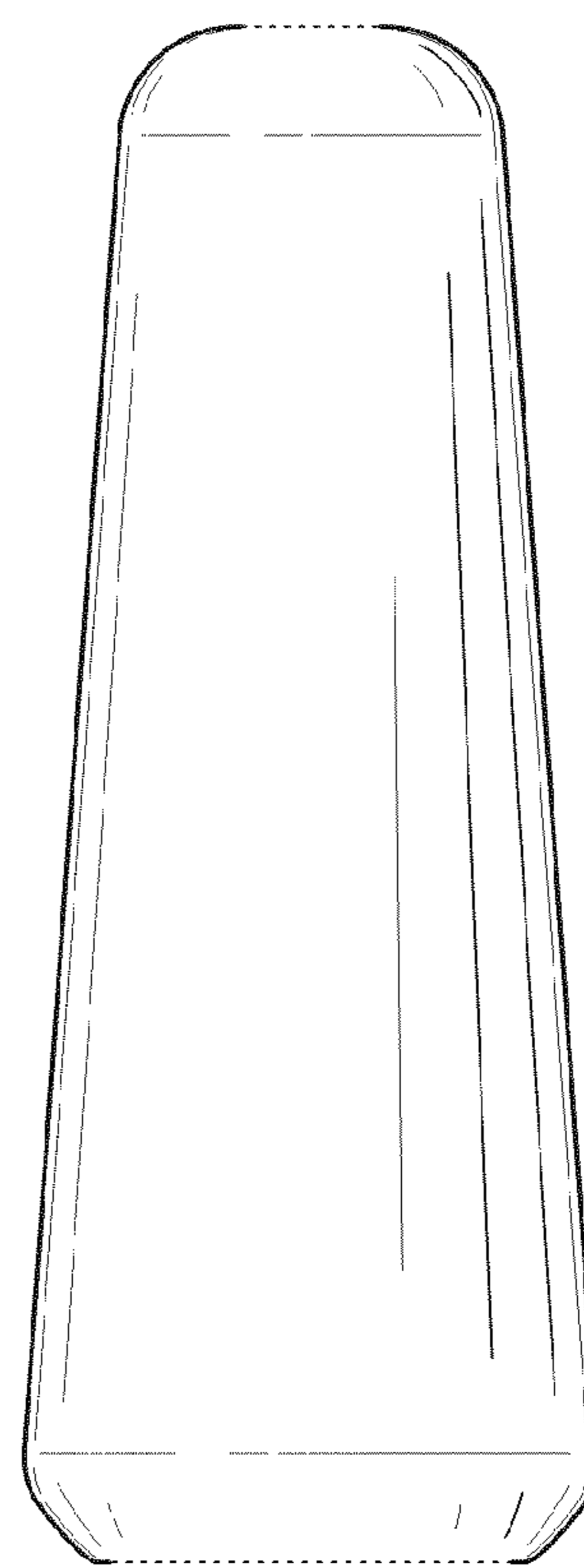

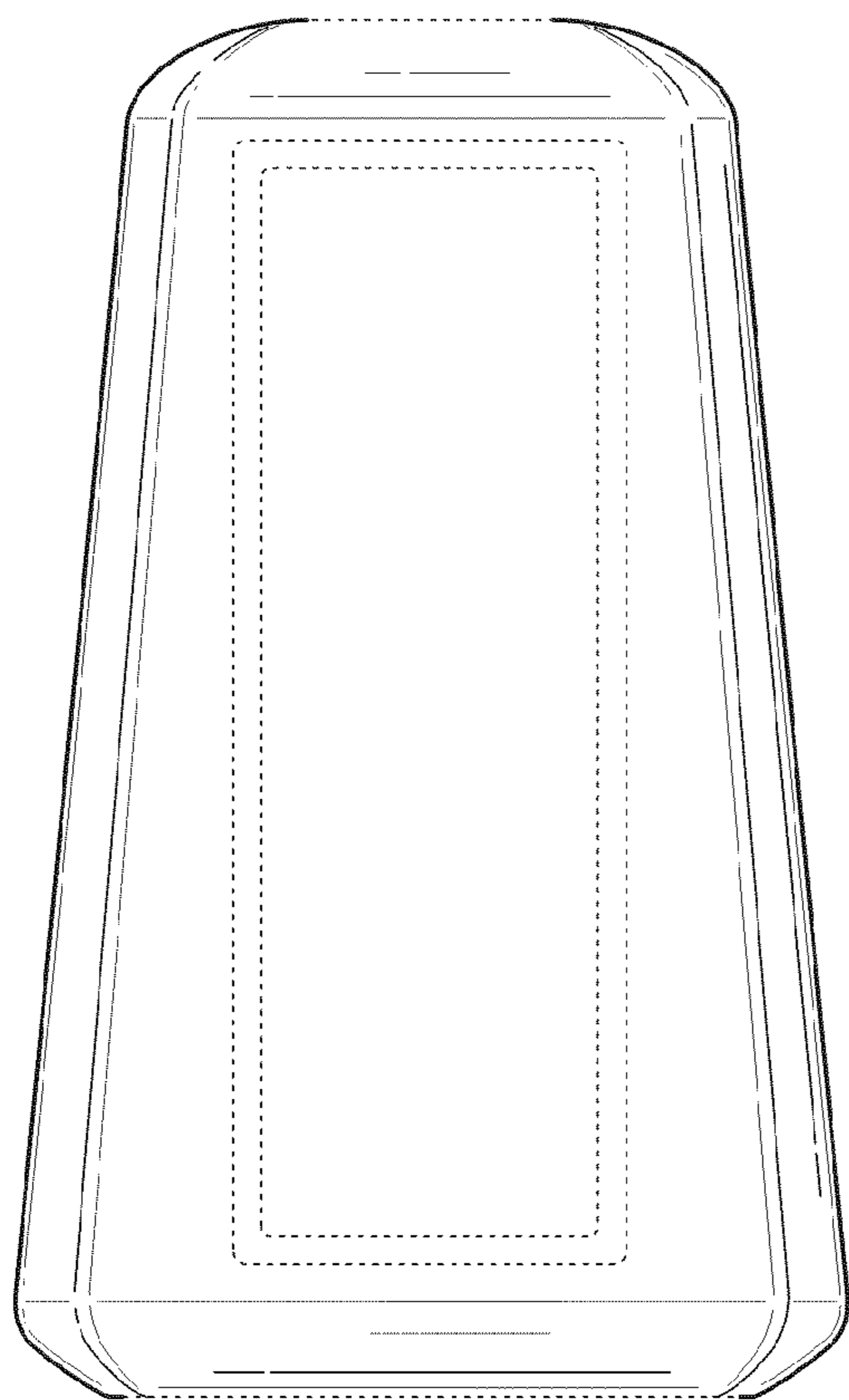

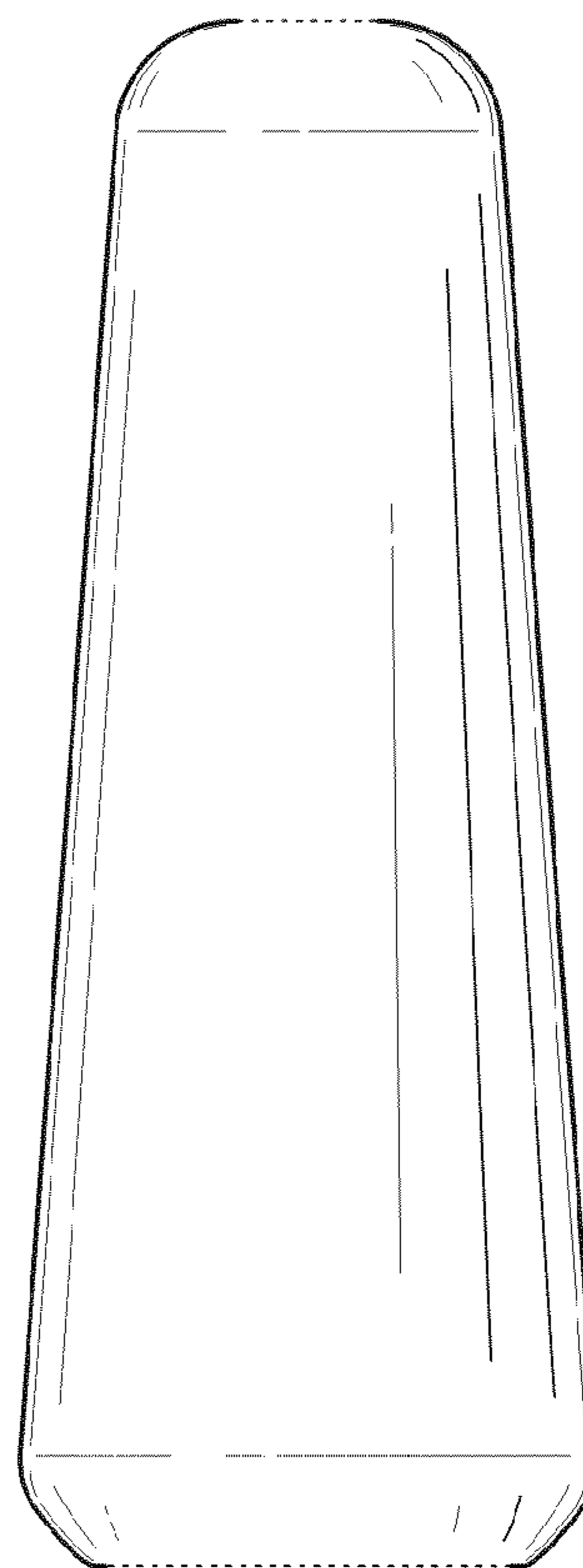

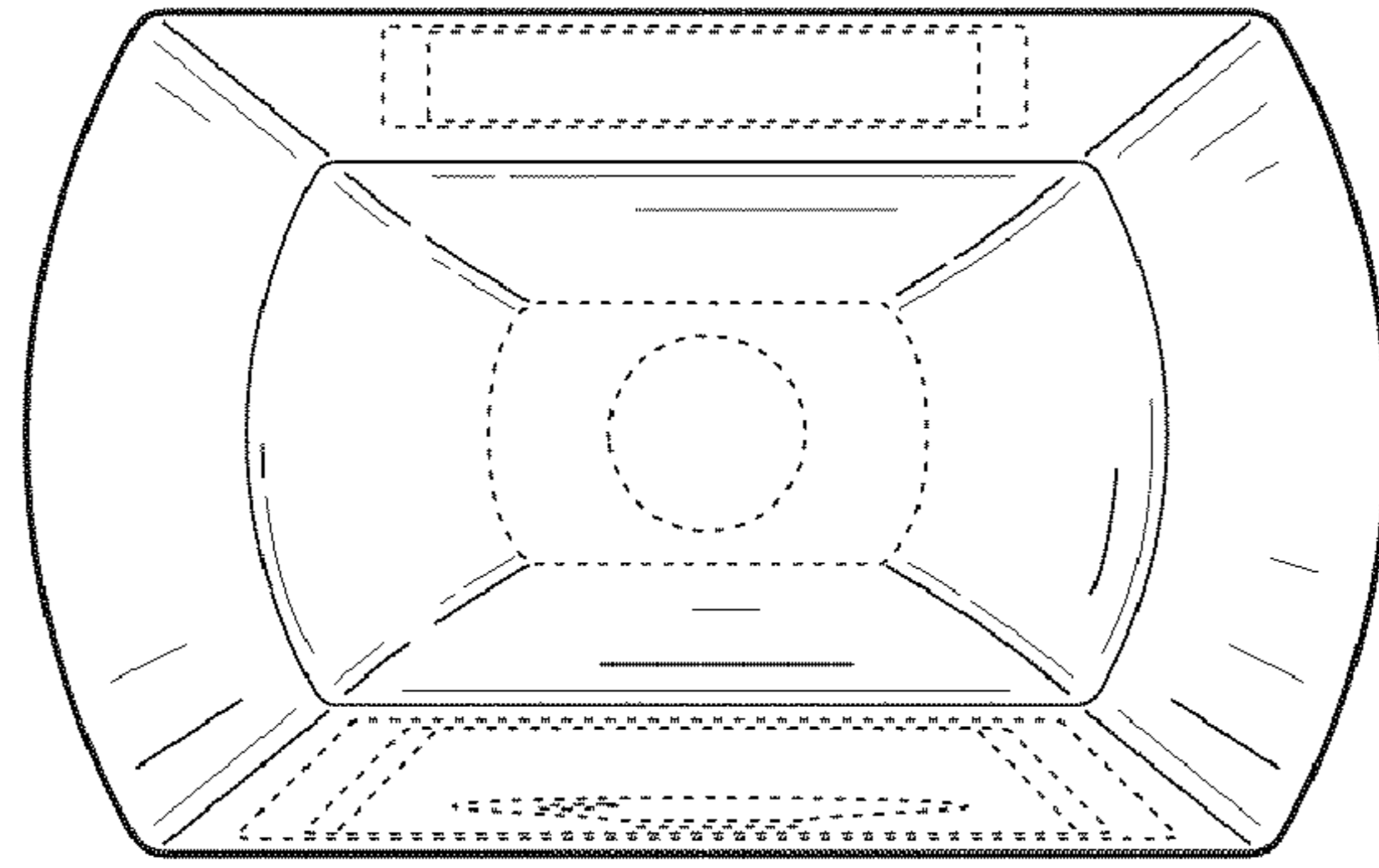

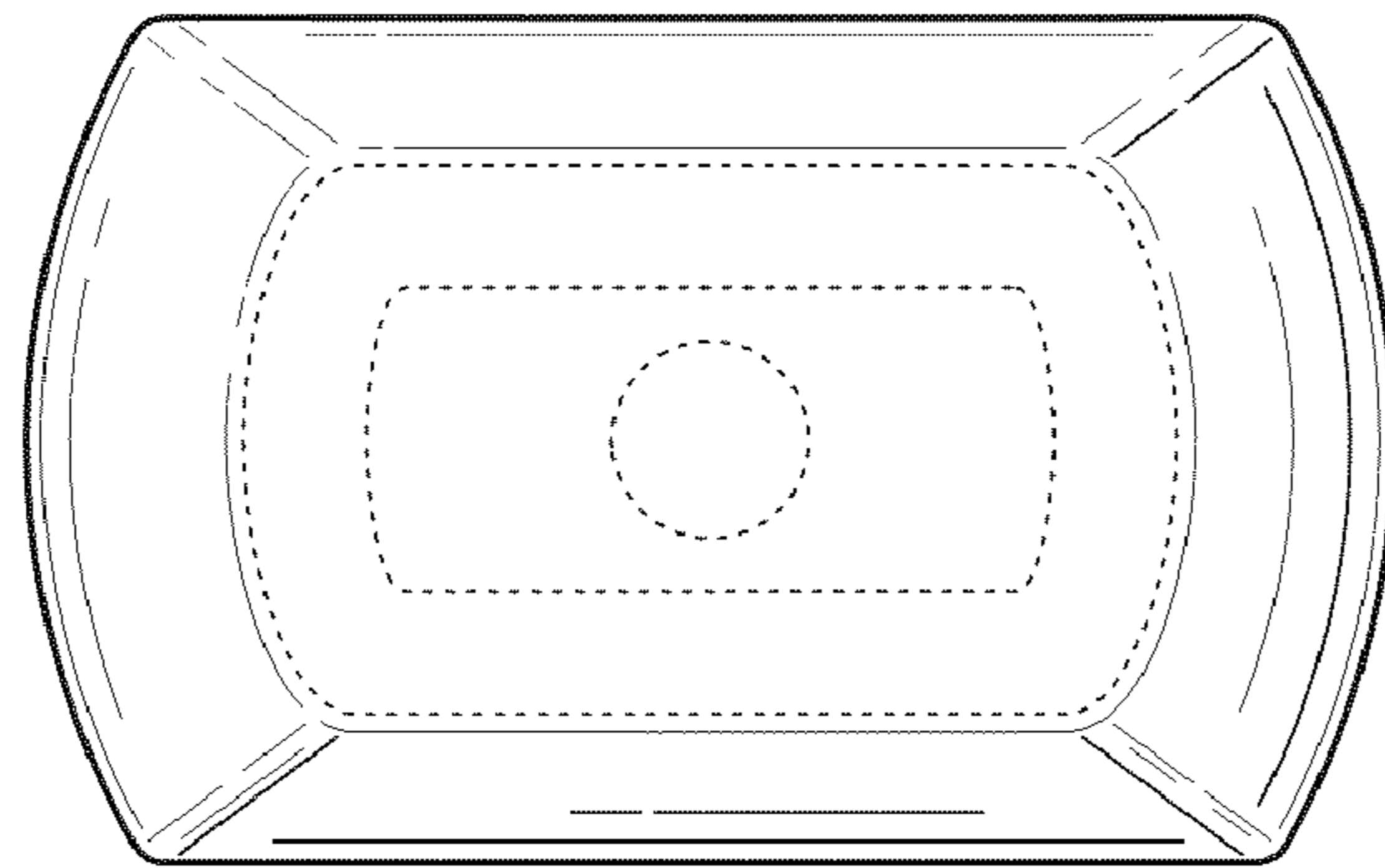
