The ornamental design for a pouch for liquid/powdery content, as shown and described.

**DESCRIPTION**

FIG. 11 is a back side elevational view thereof;

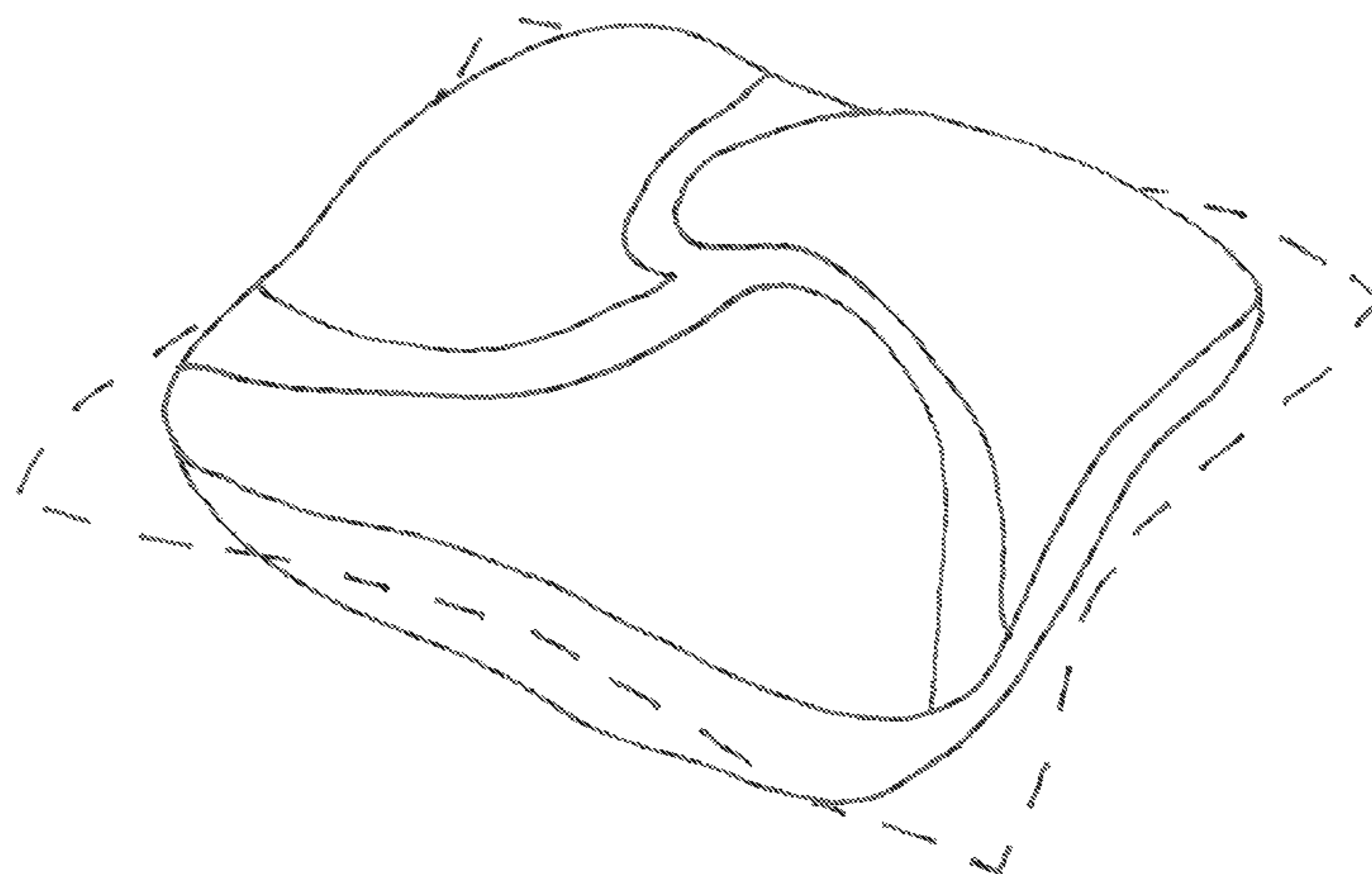
FIG. 12 is a left side elevational view thereof;

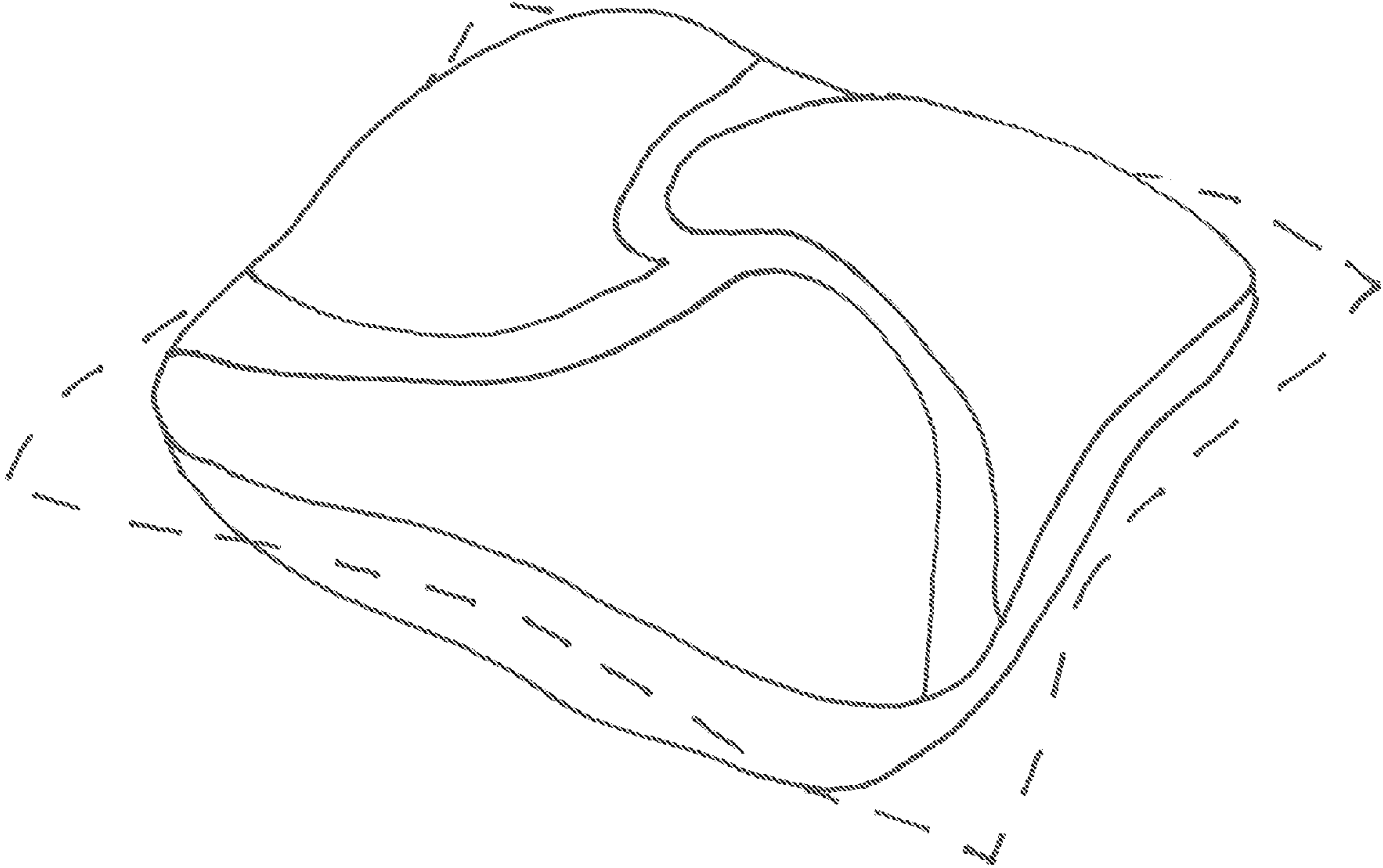

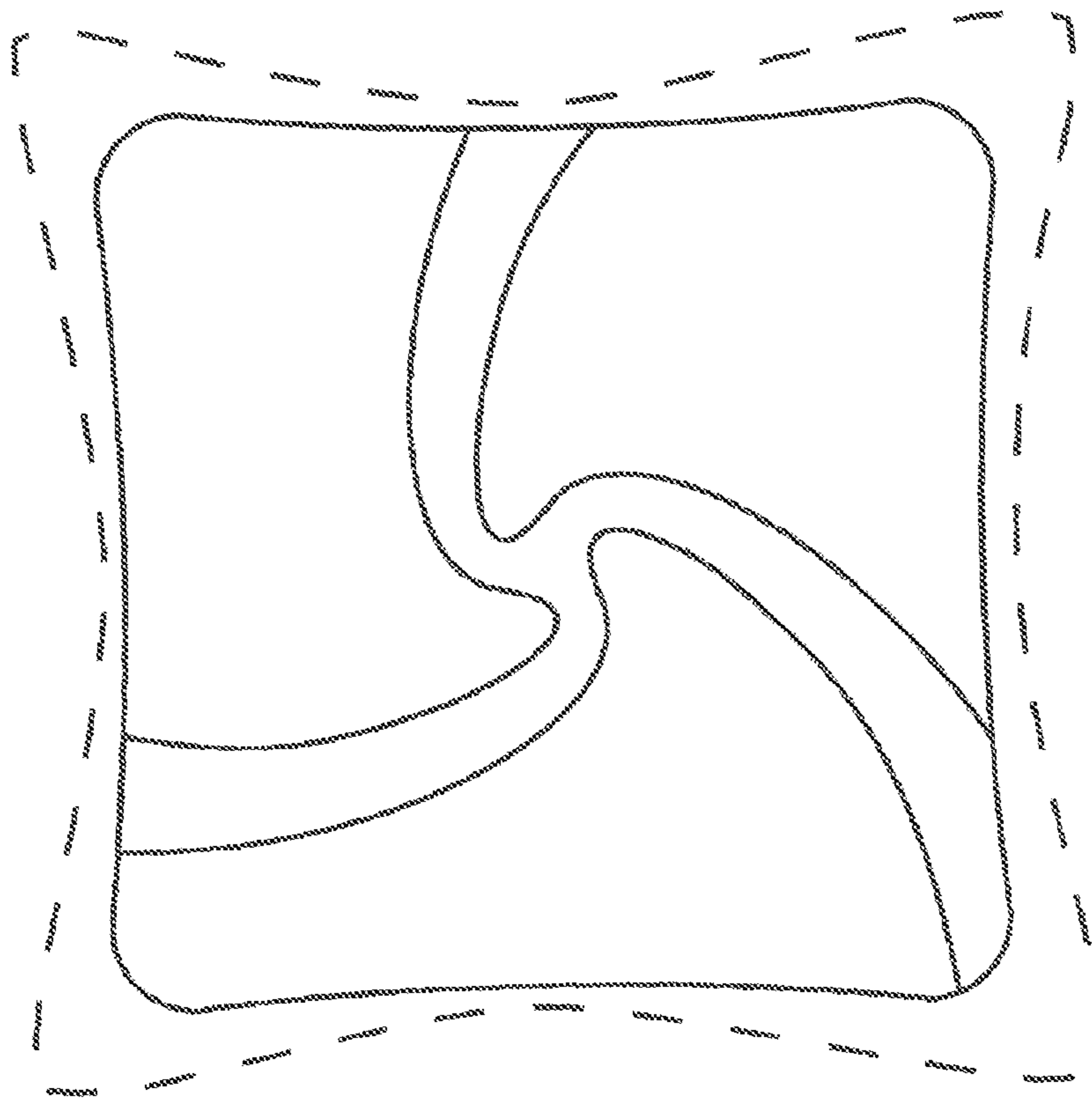

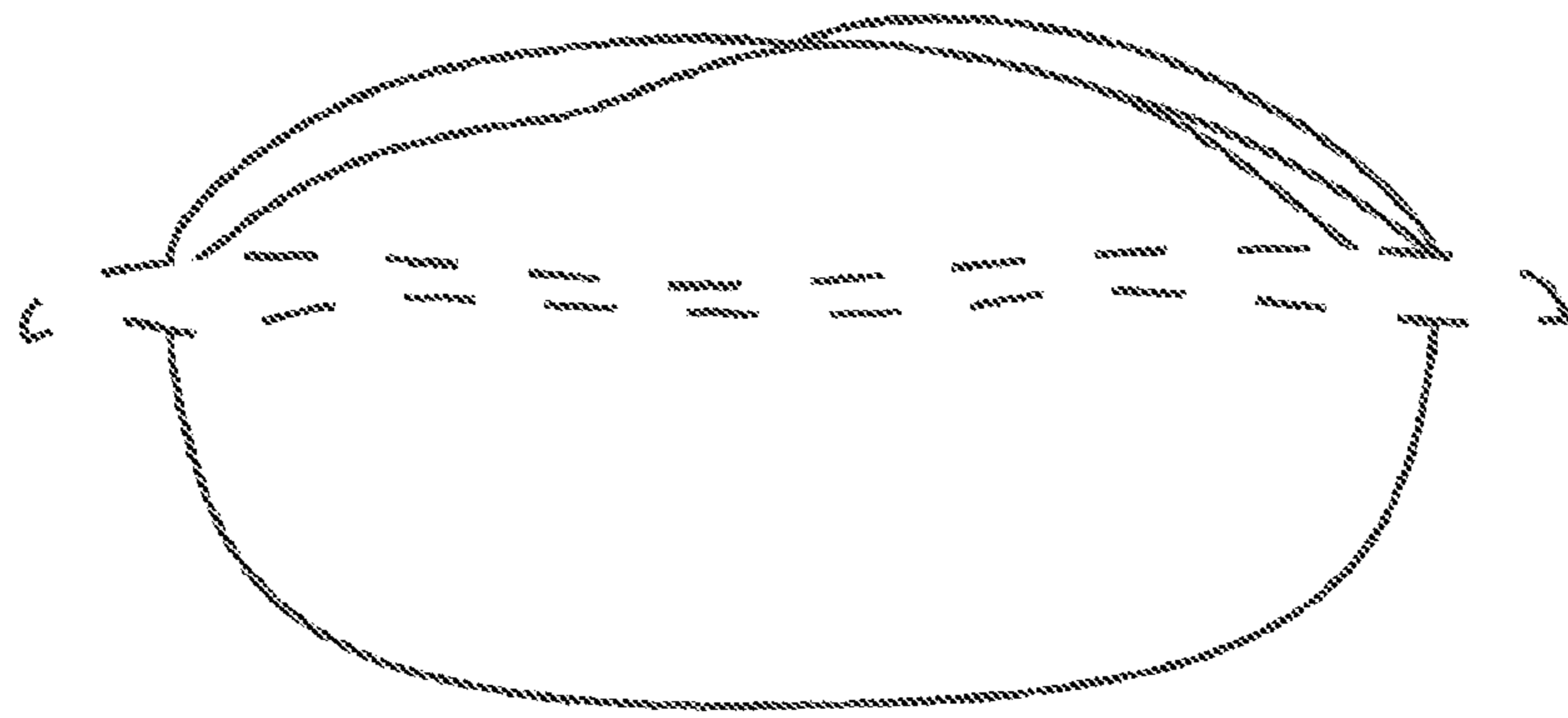

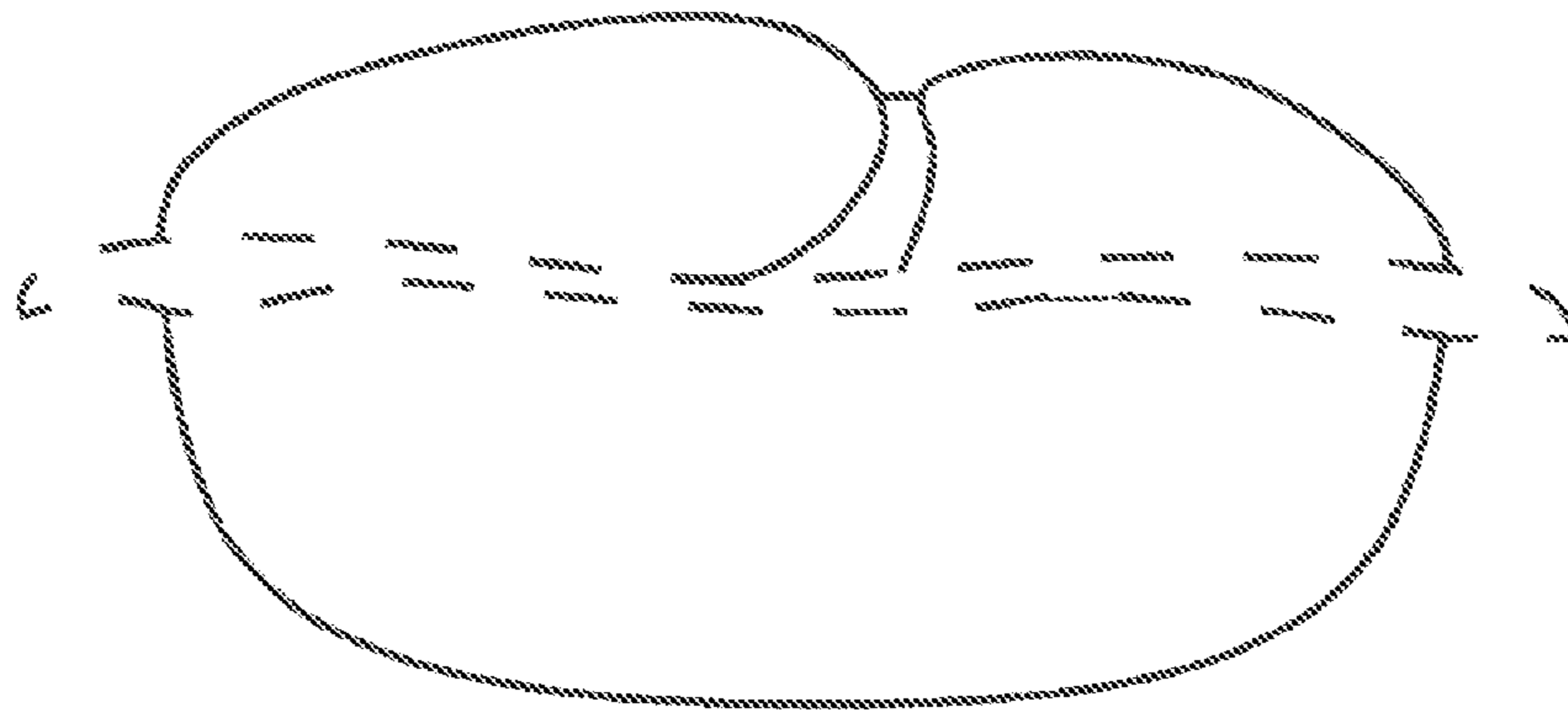

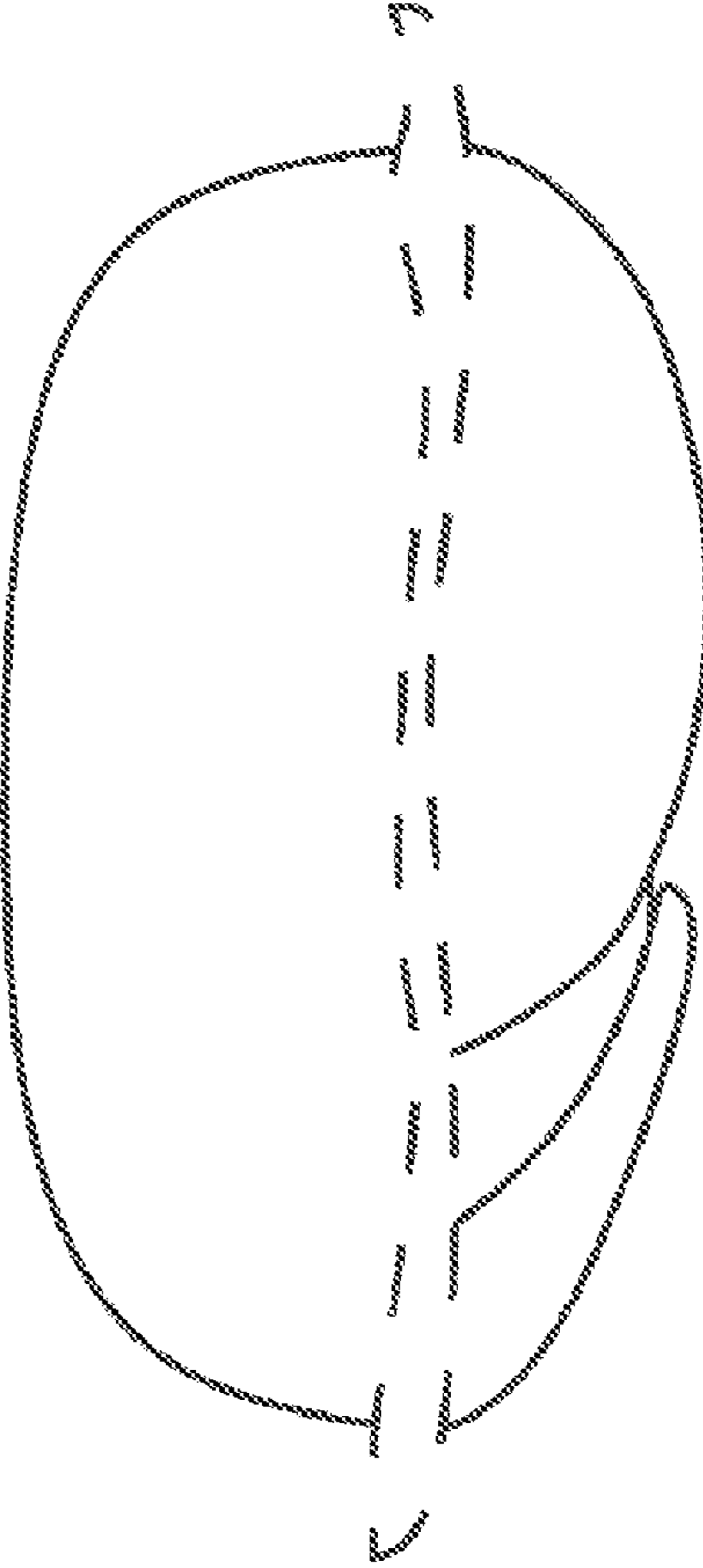

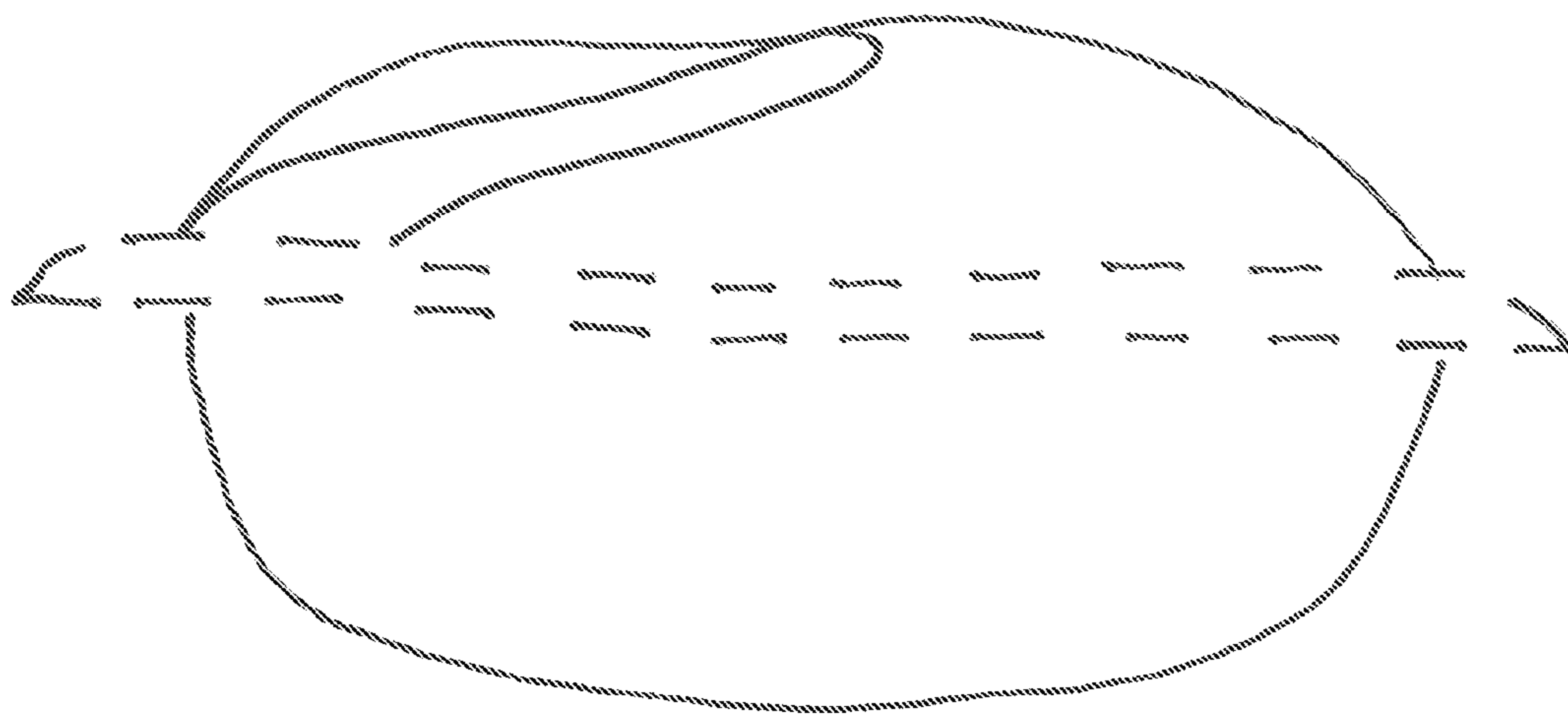

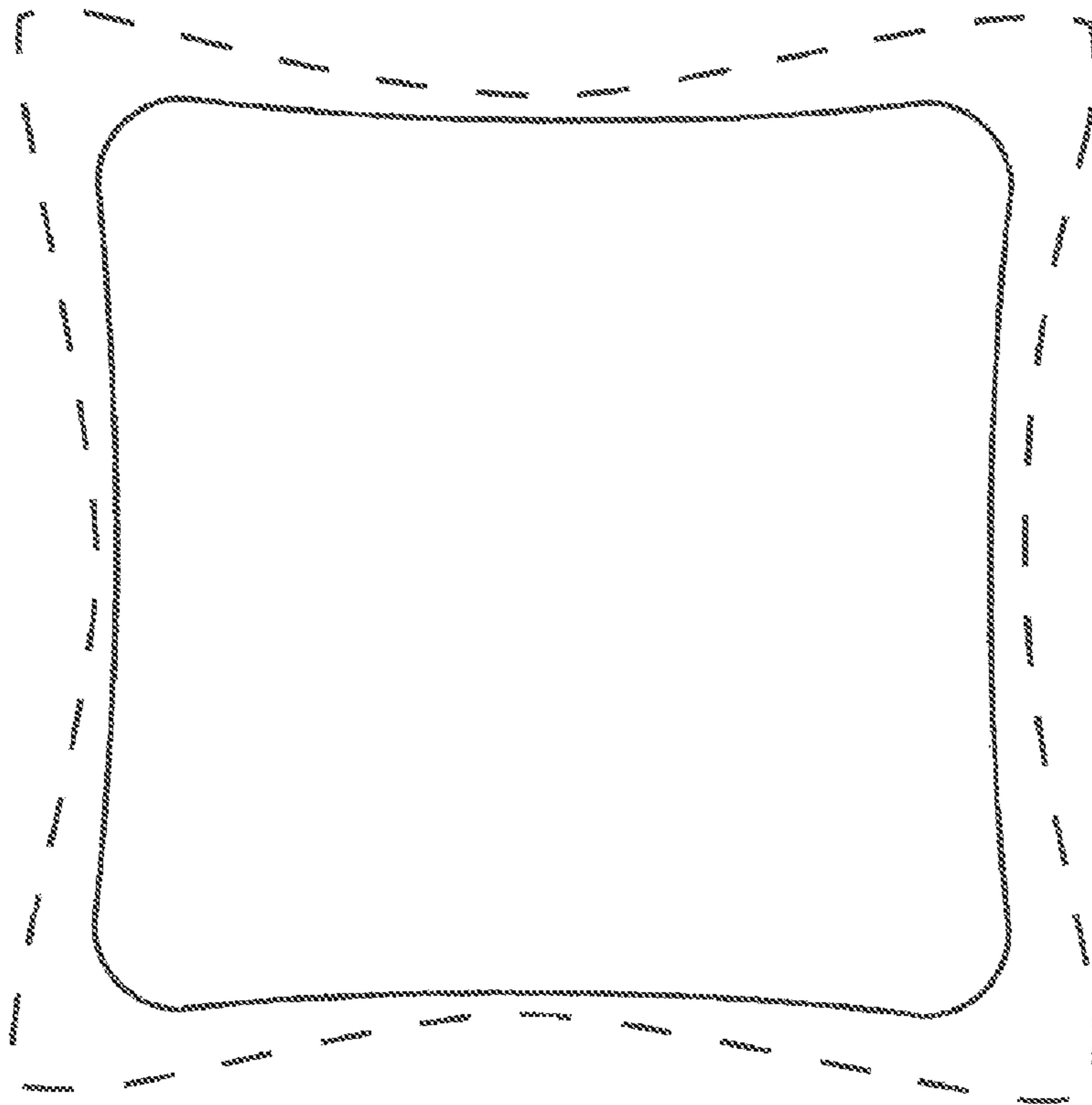

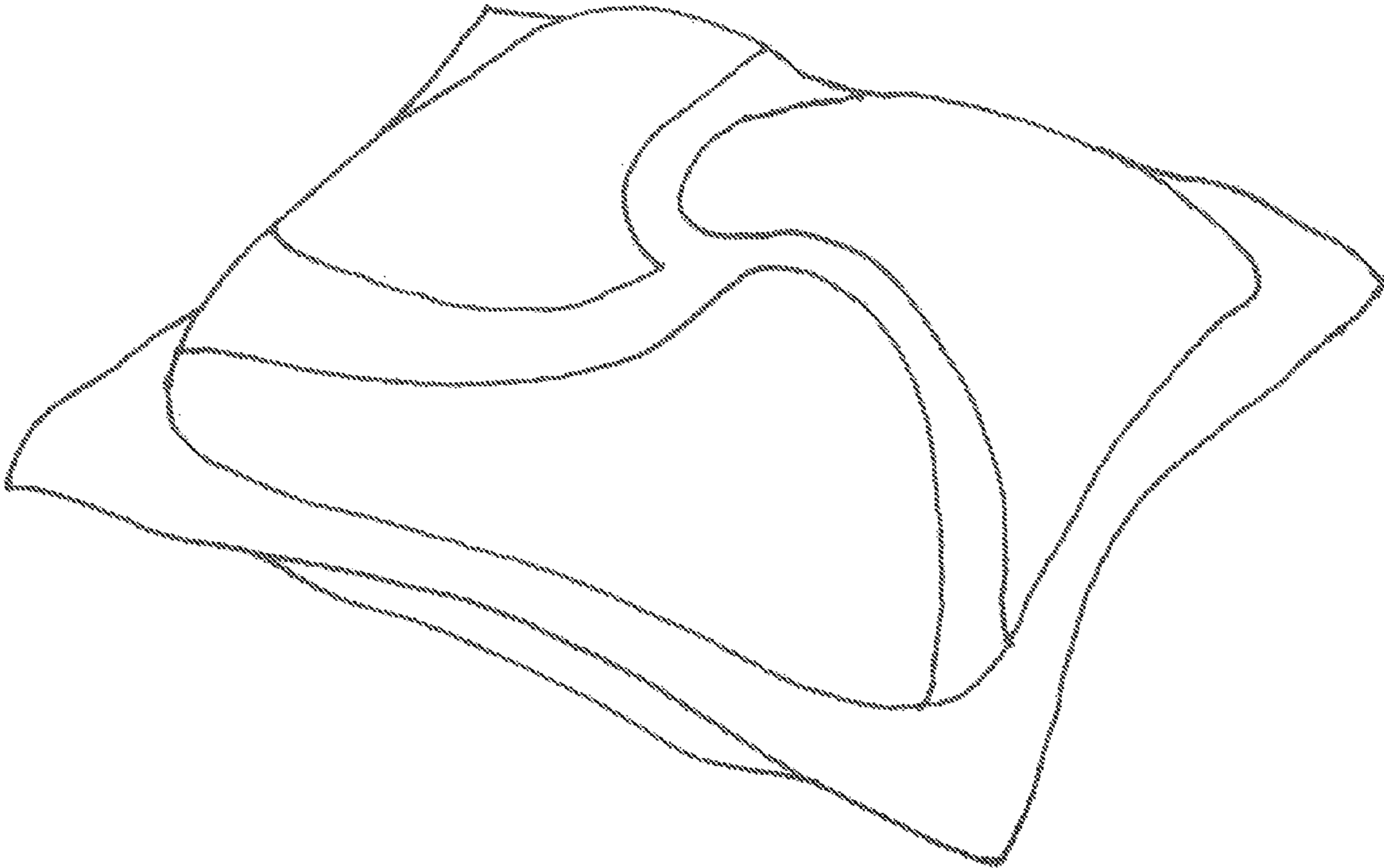

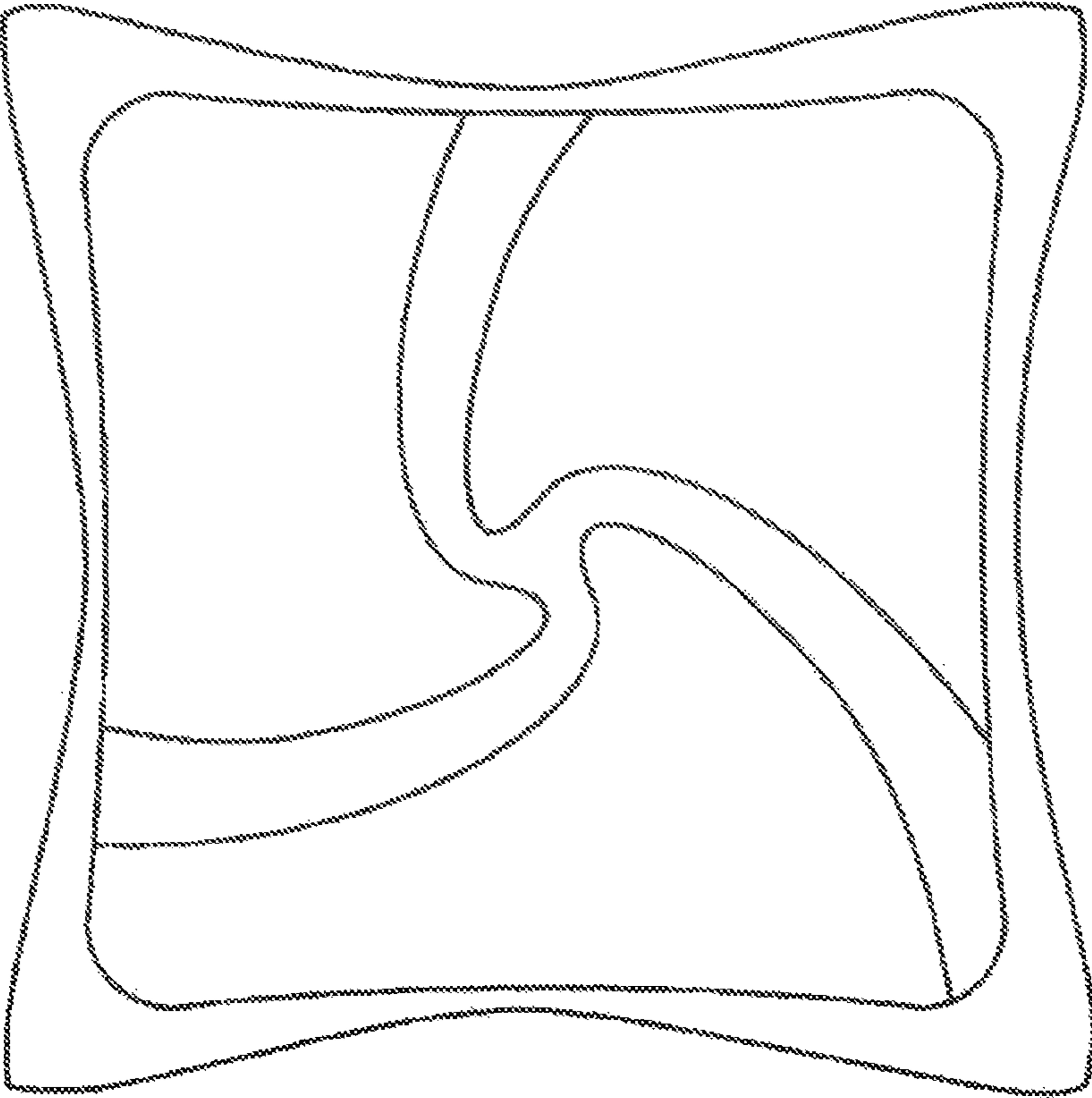

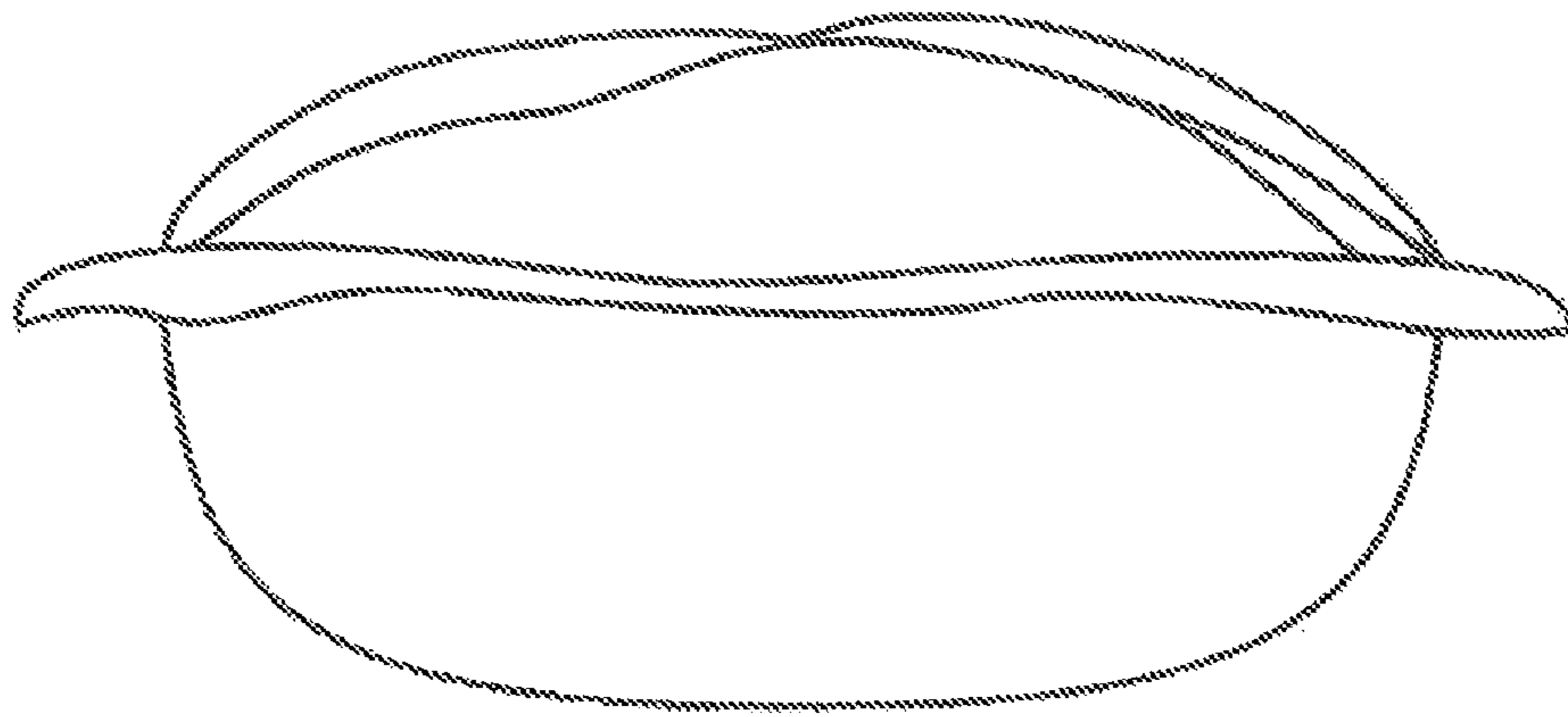

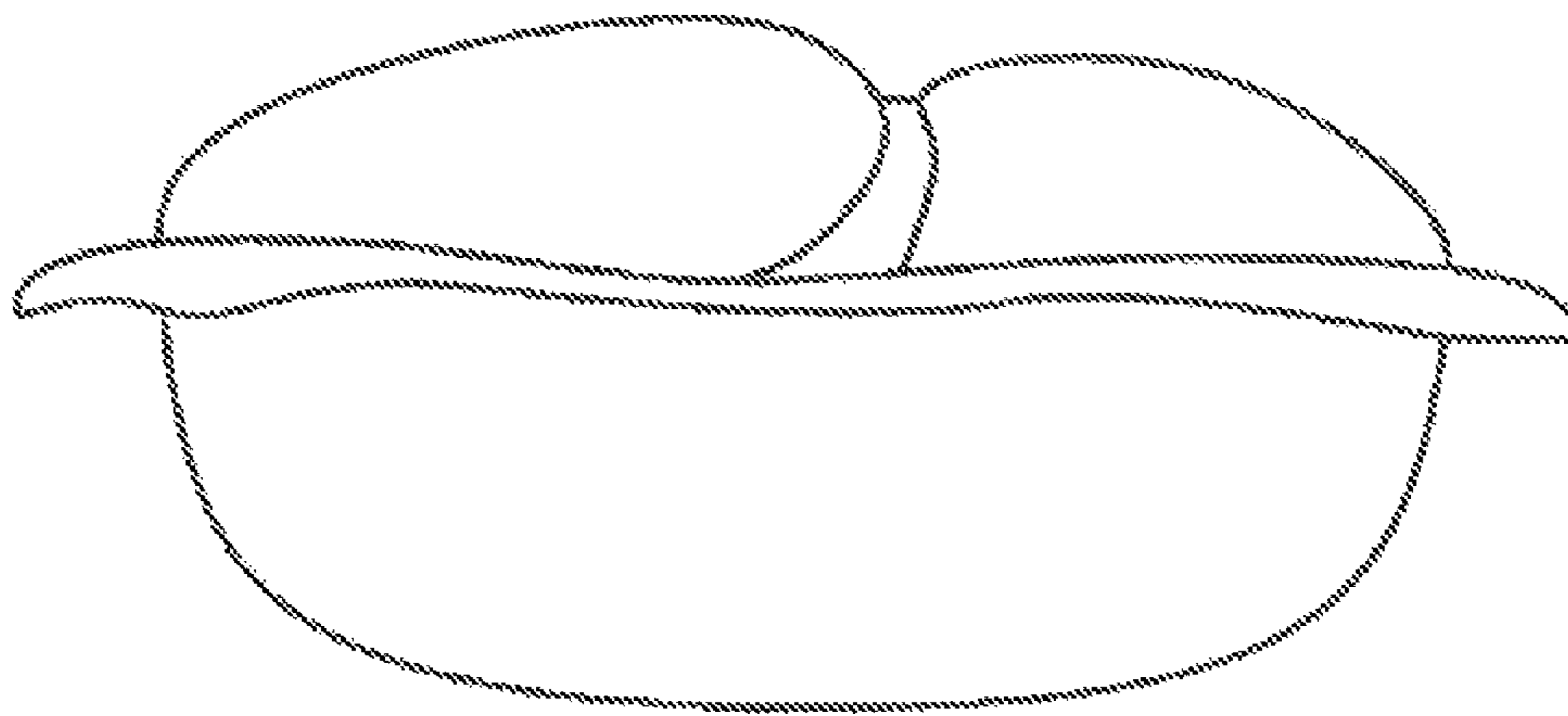

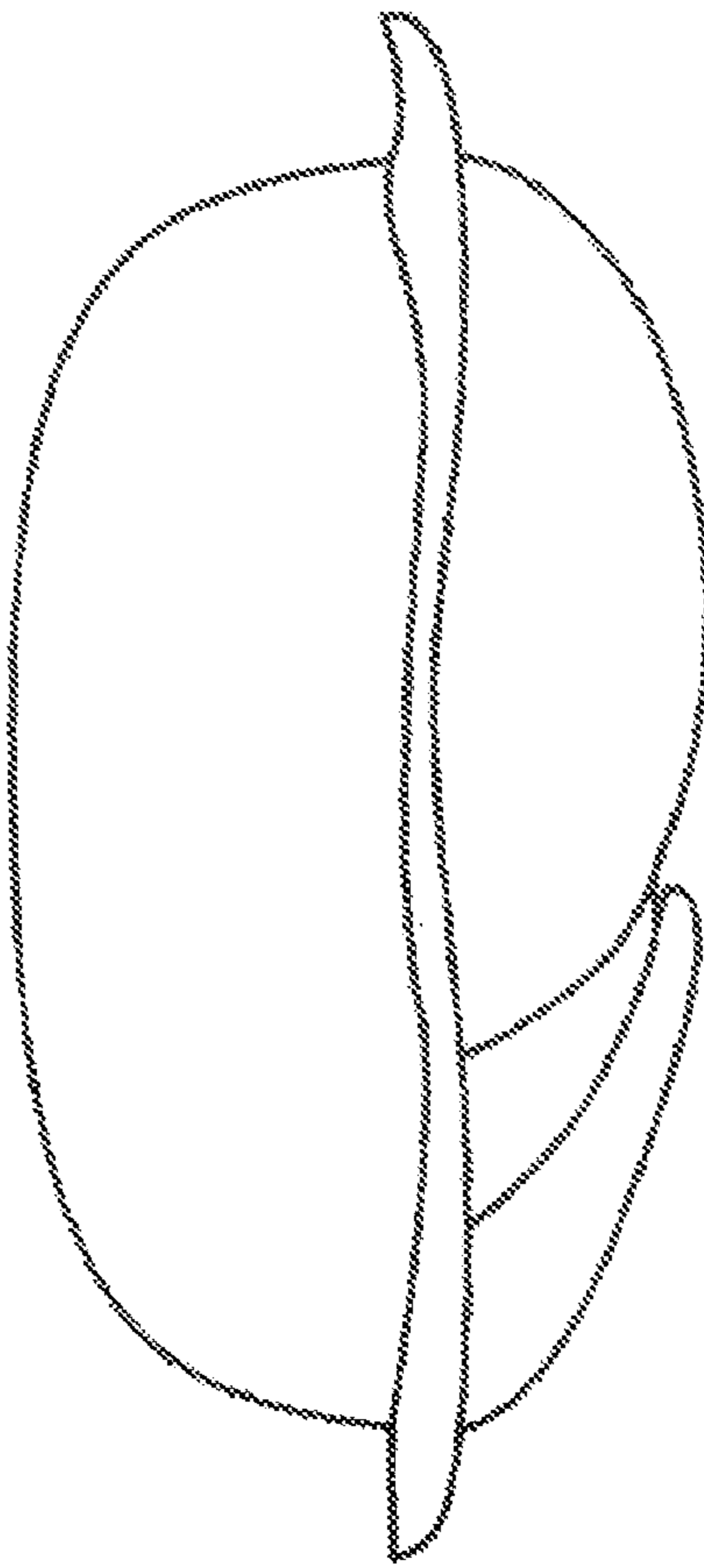

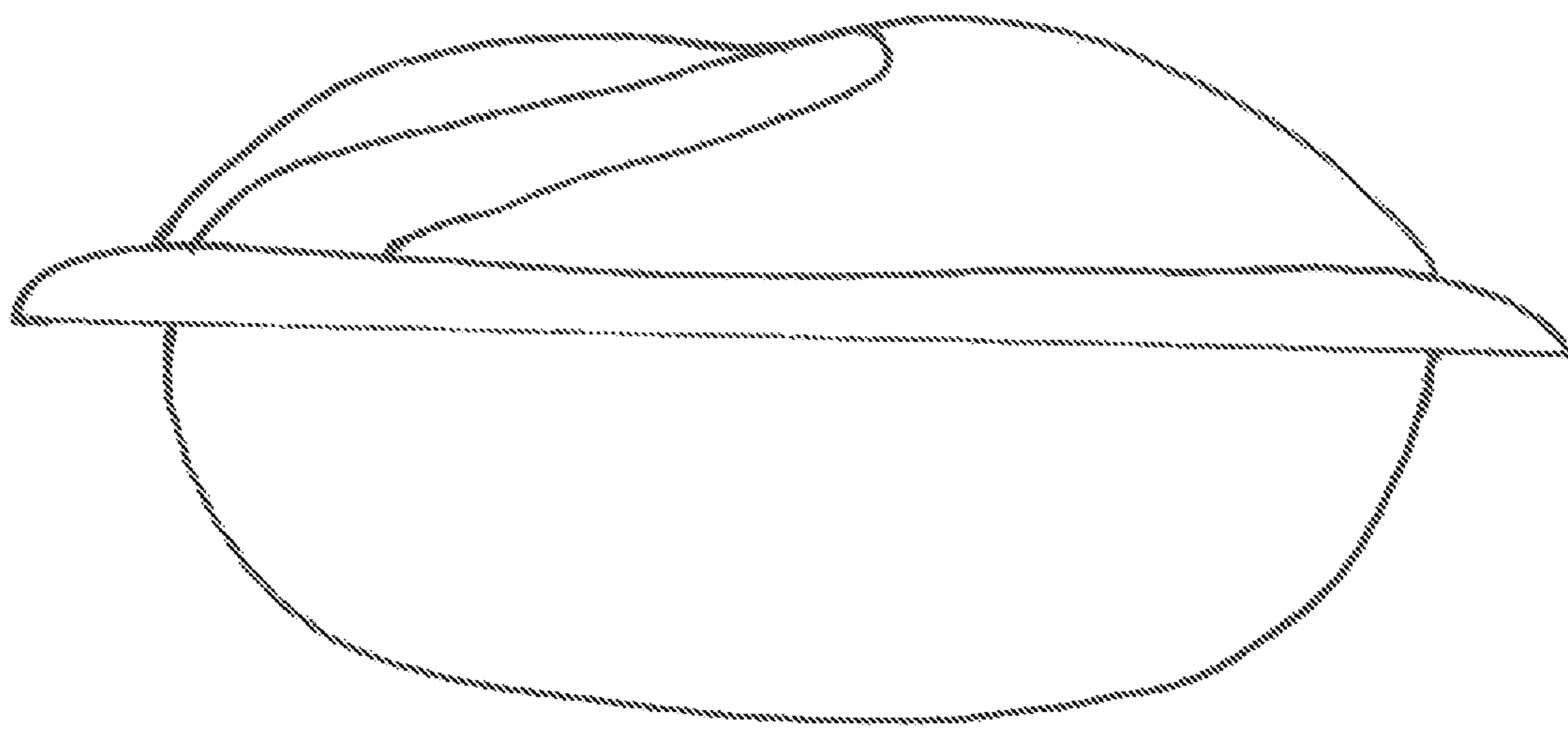

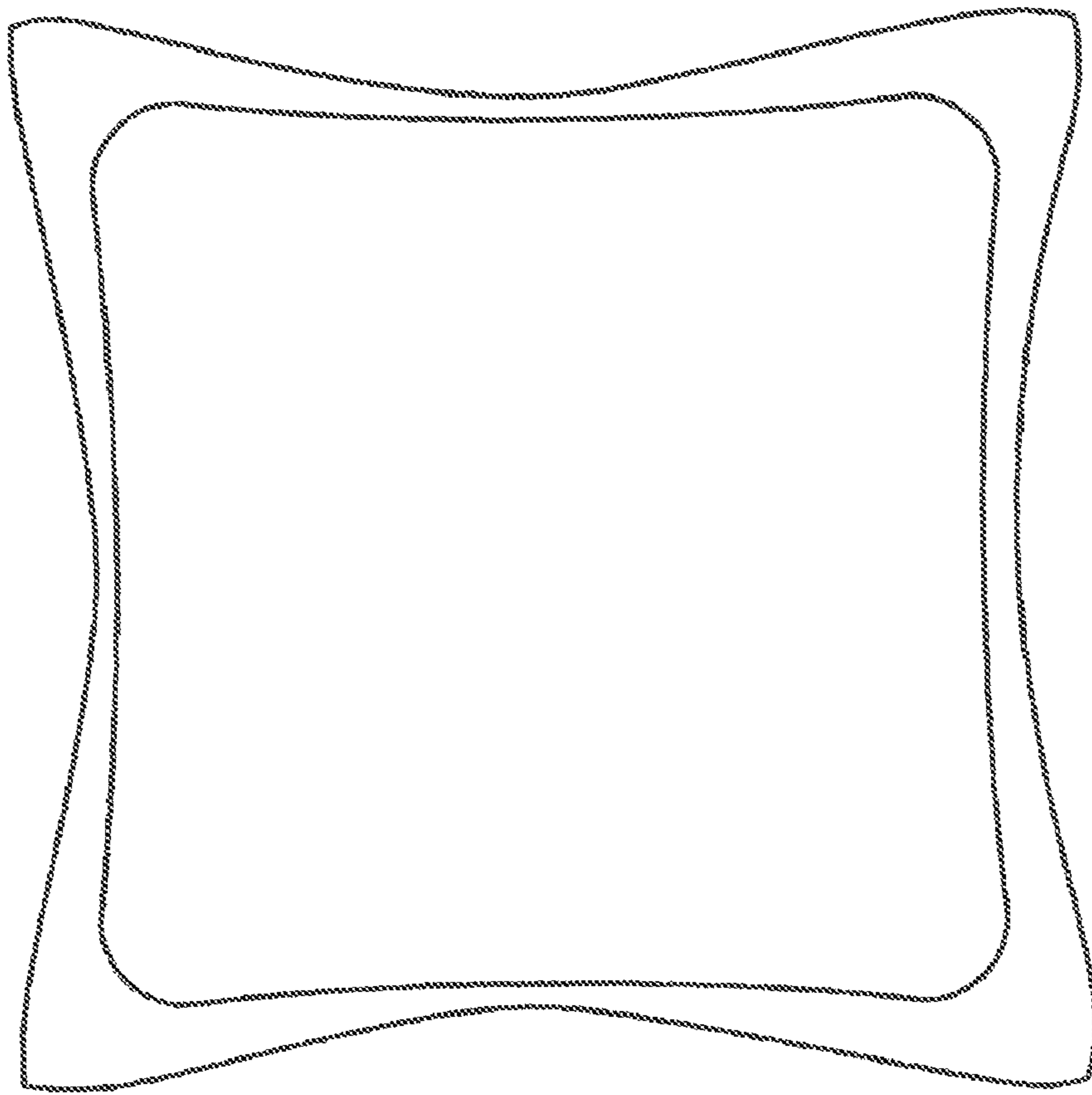
