The ornamental design for vest, as shown and described.

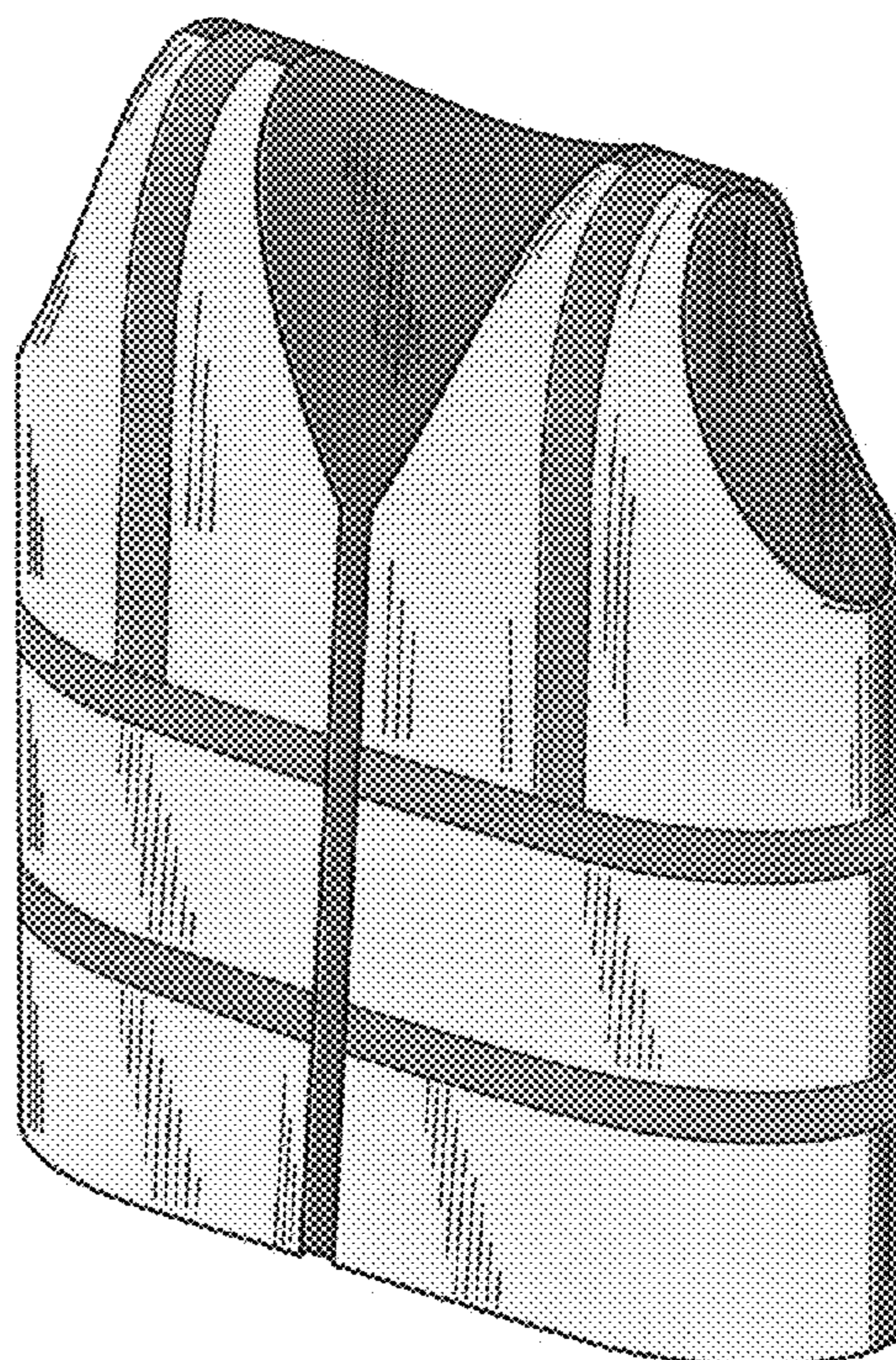
DESCRIPTION

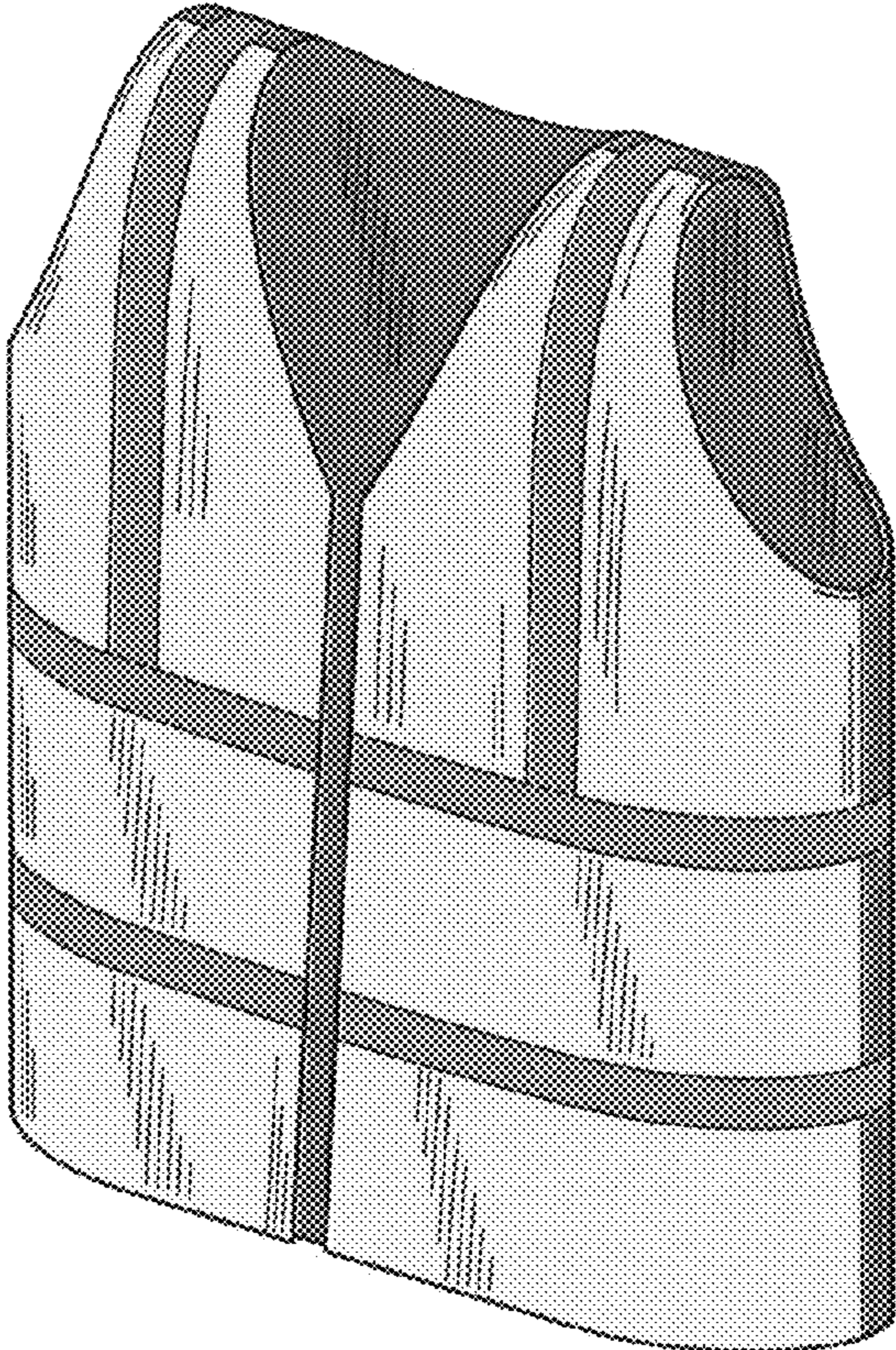

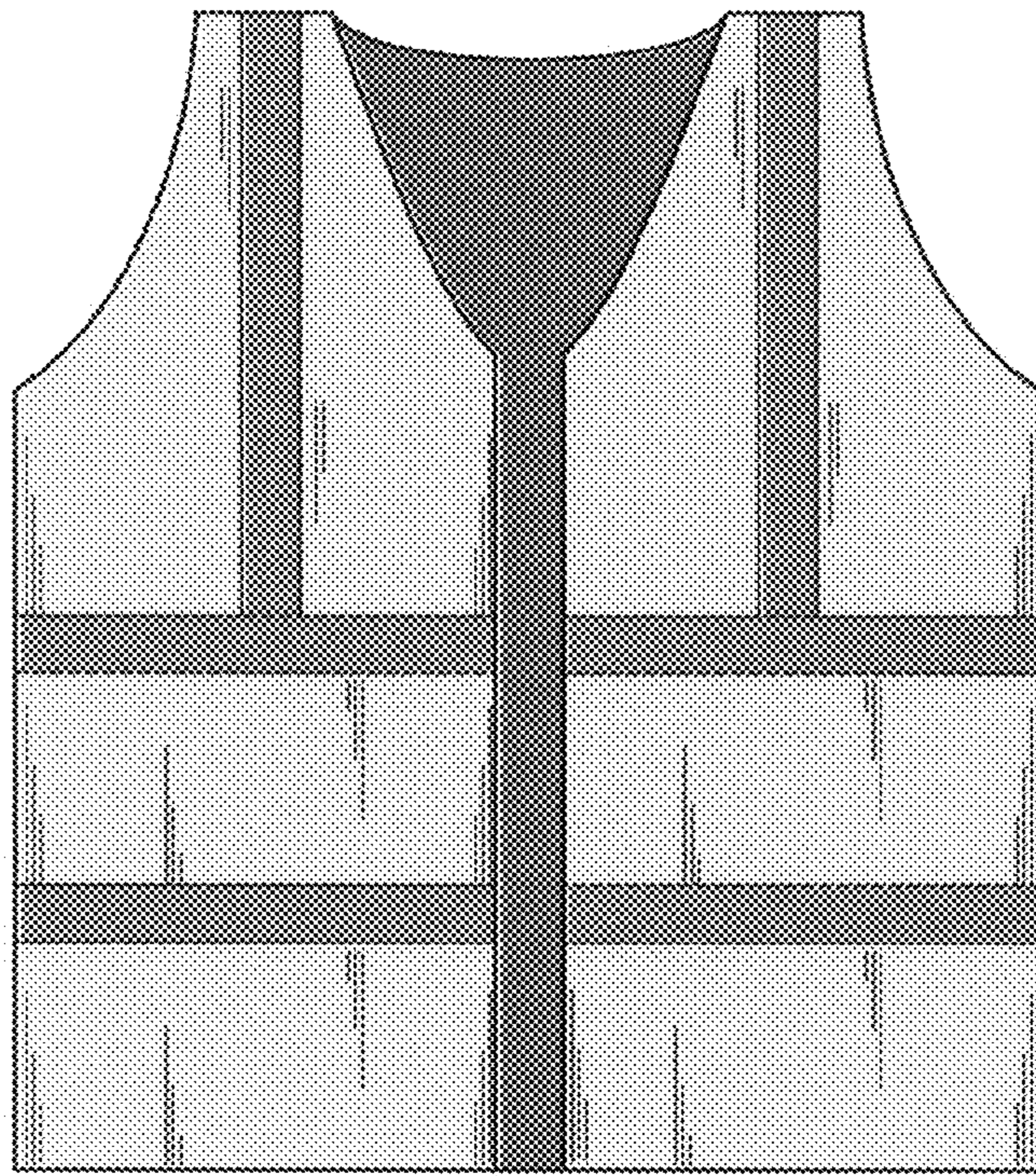

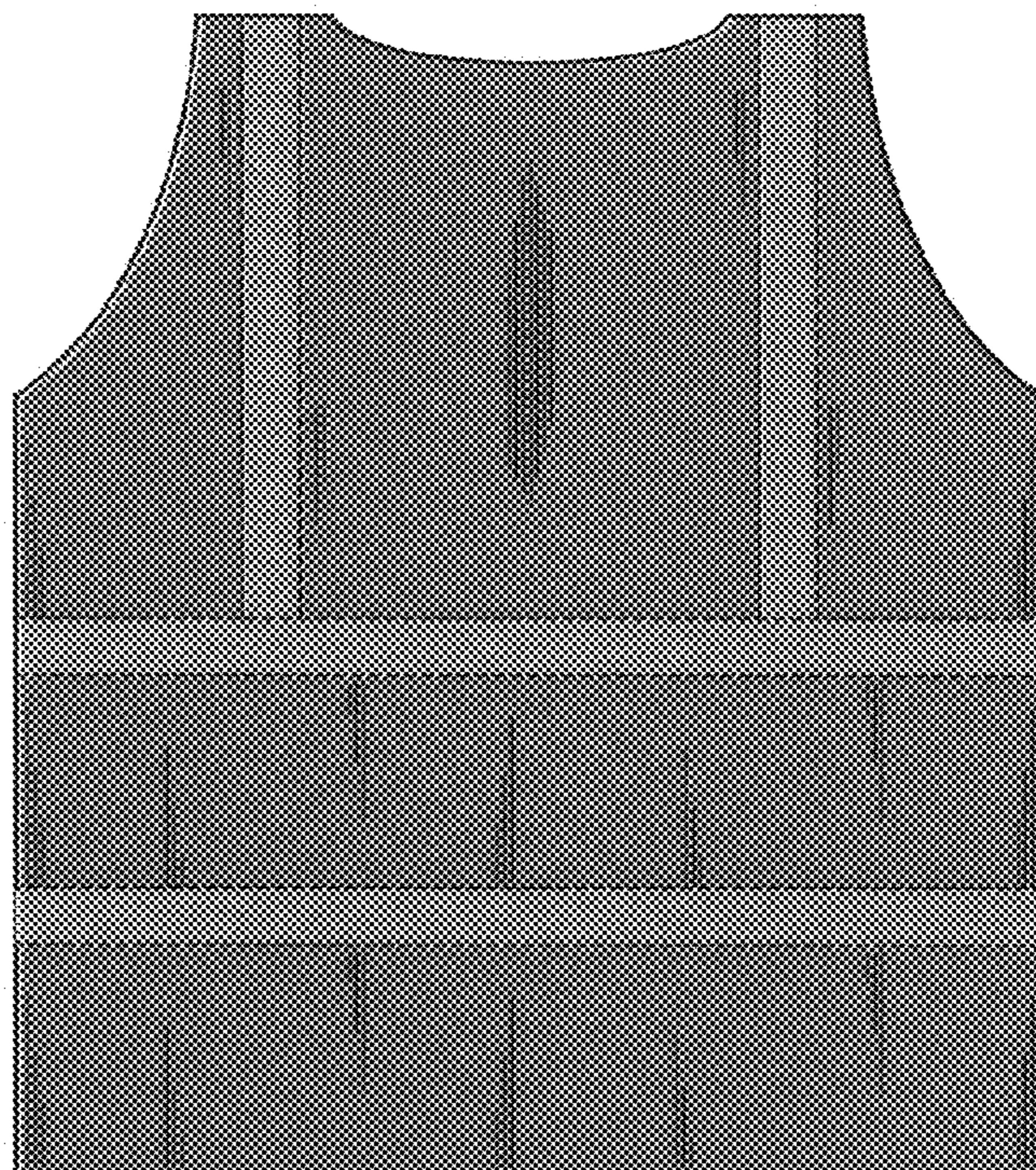

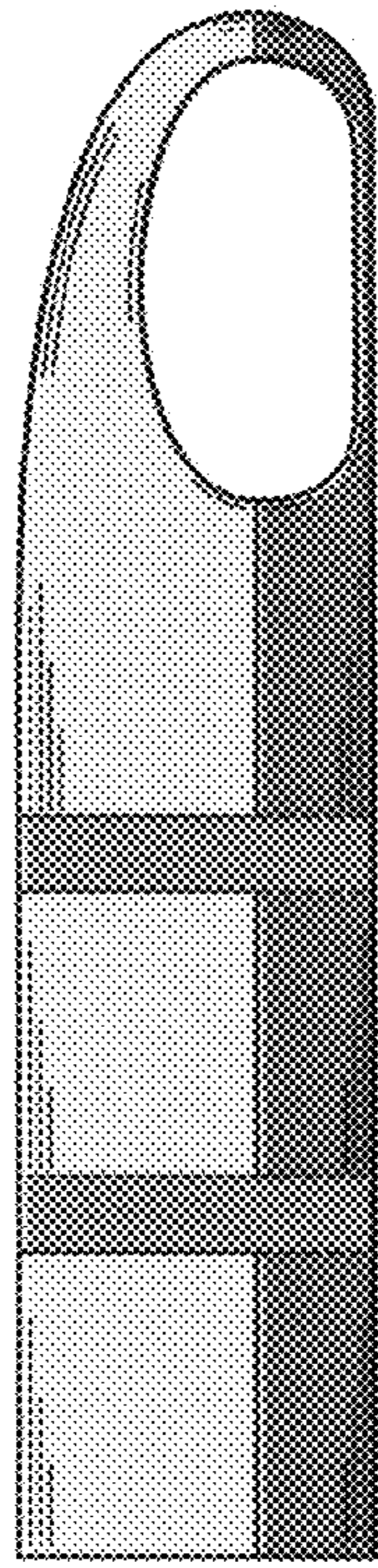

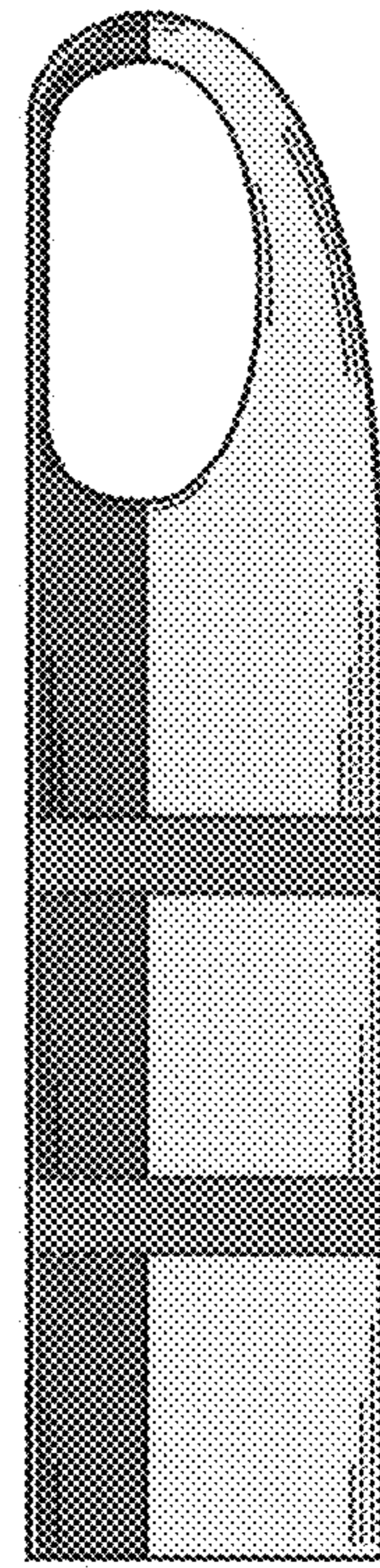

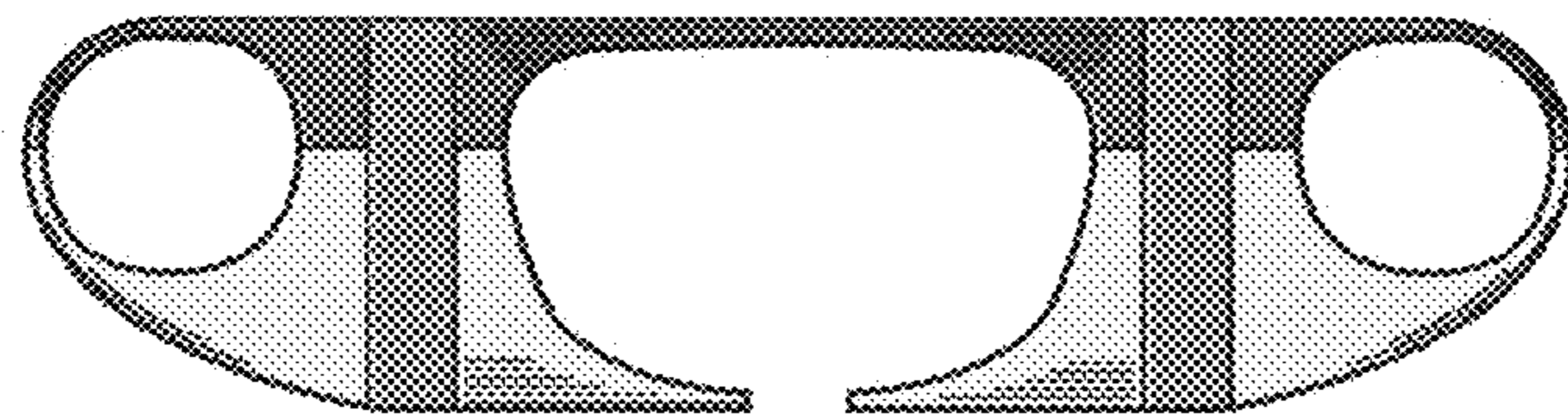

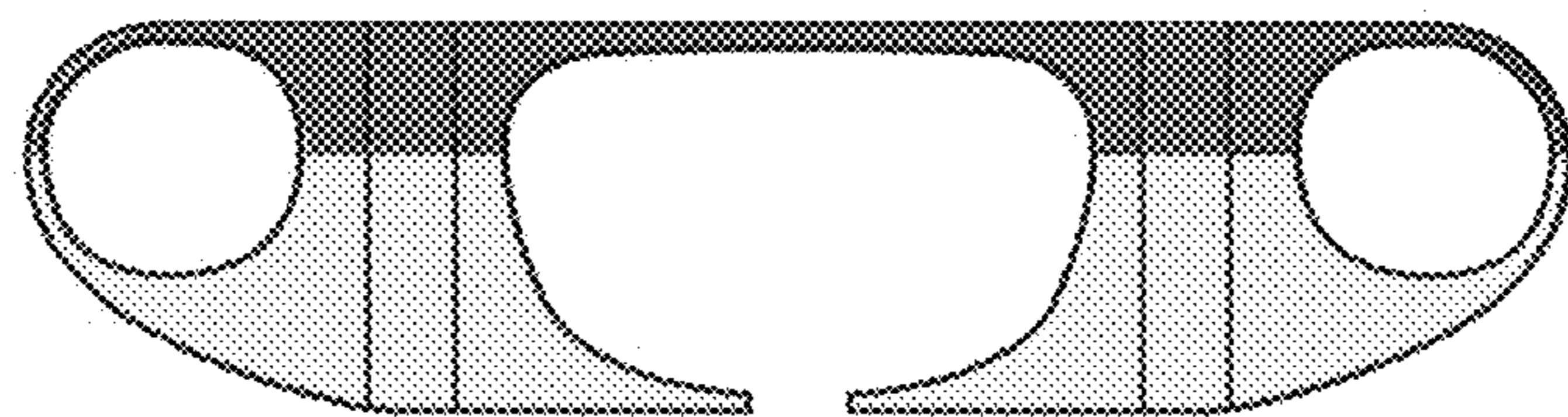

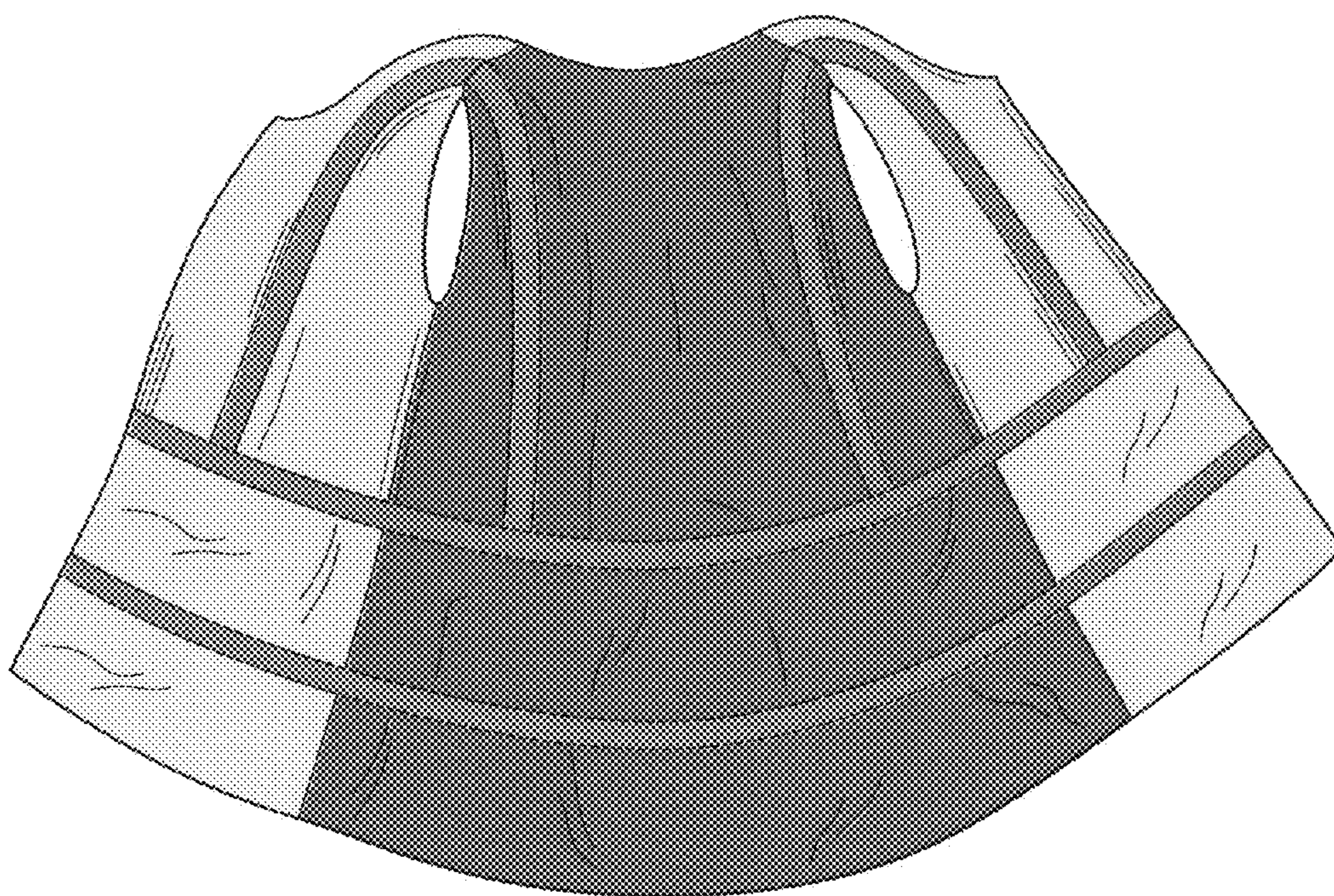
