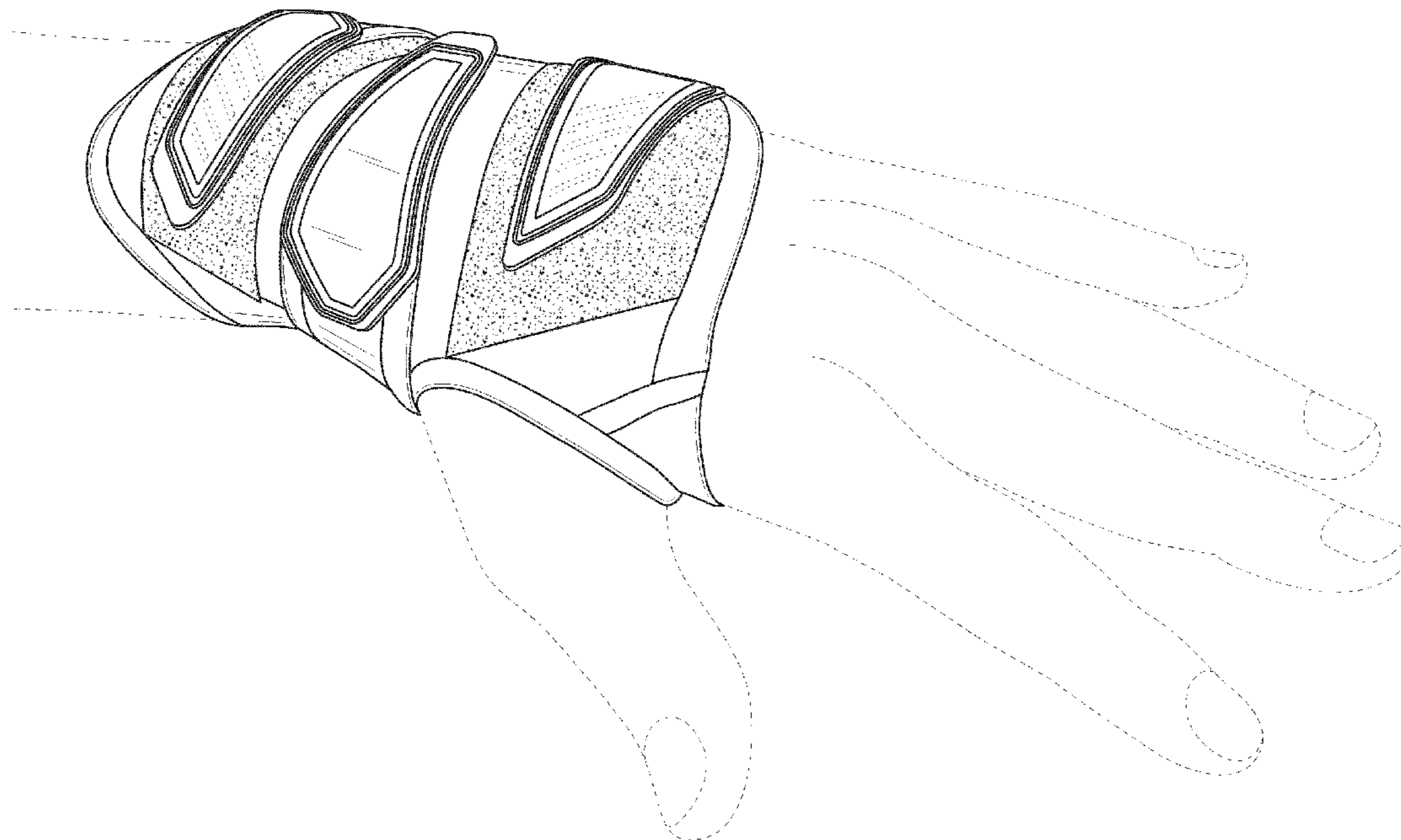
(57) **CLAIM**

The ornamental design for a wrist guard with stiffeners, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wrist guard with stiffeners. FIG. 2 is a top view of a wrist guard with stiffeners. FIG. 3 is a bottom view of a wrist guard with stiffeners. FIG. 4 is a first side view of a wrist guard with stiffeners. FIG. 5 is a second, opposing, side view of a wrist guard with stiffeners; and, FIG. 6 is an end view of a wrist guard with stiffeners. The broken lines in the Figures do not form a part of the claimed design.

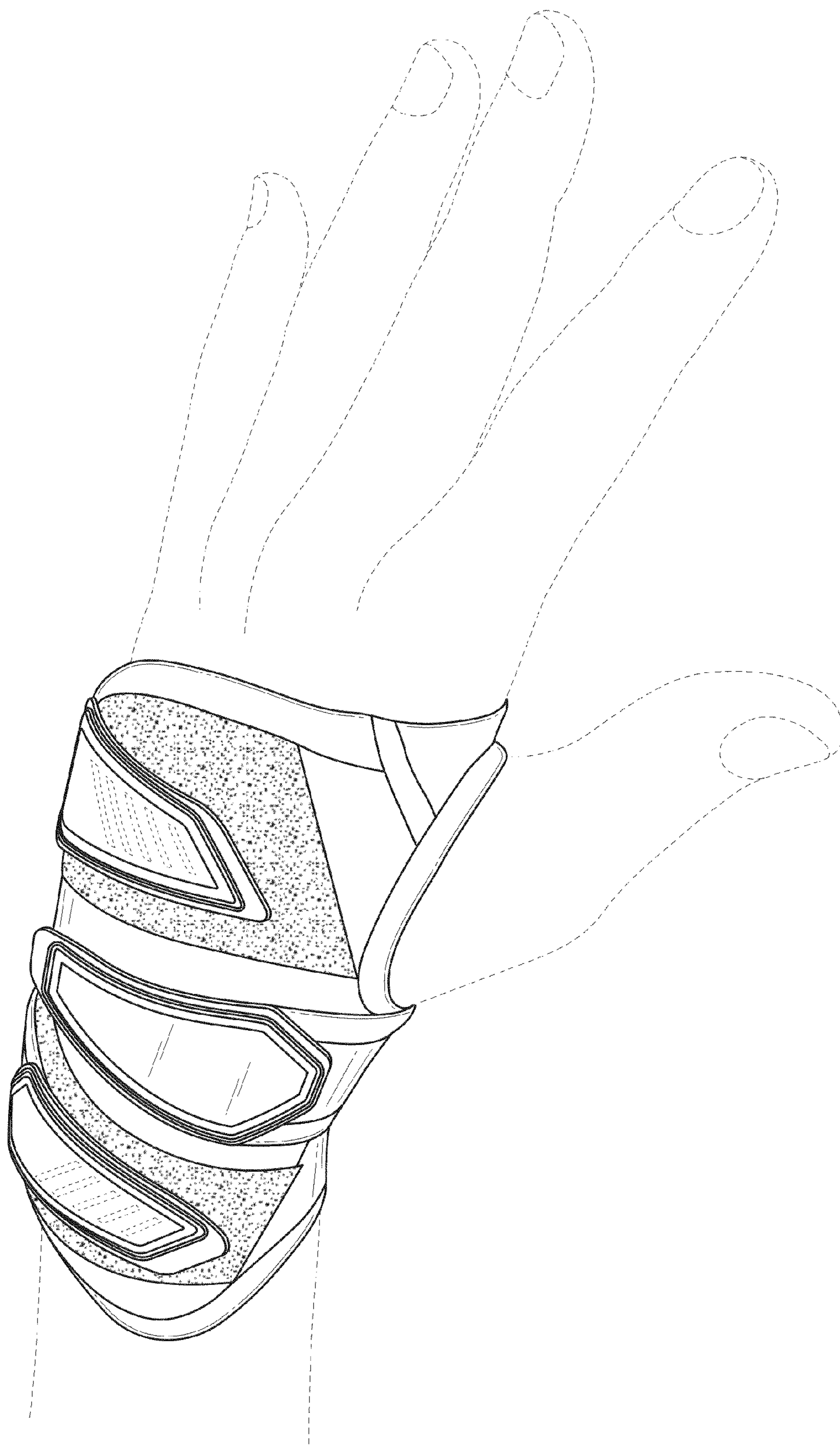

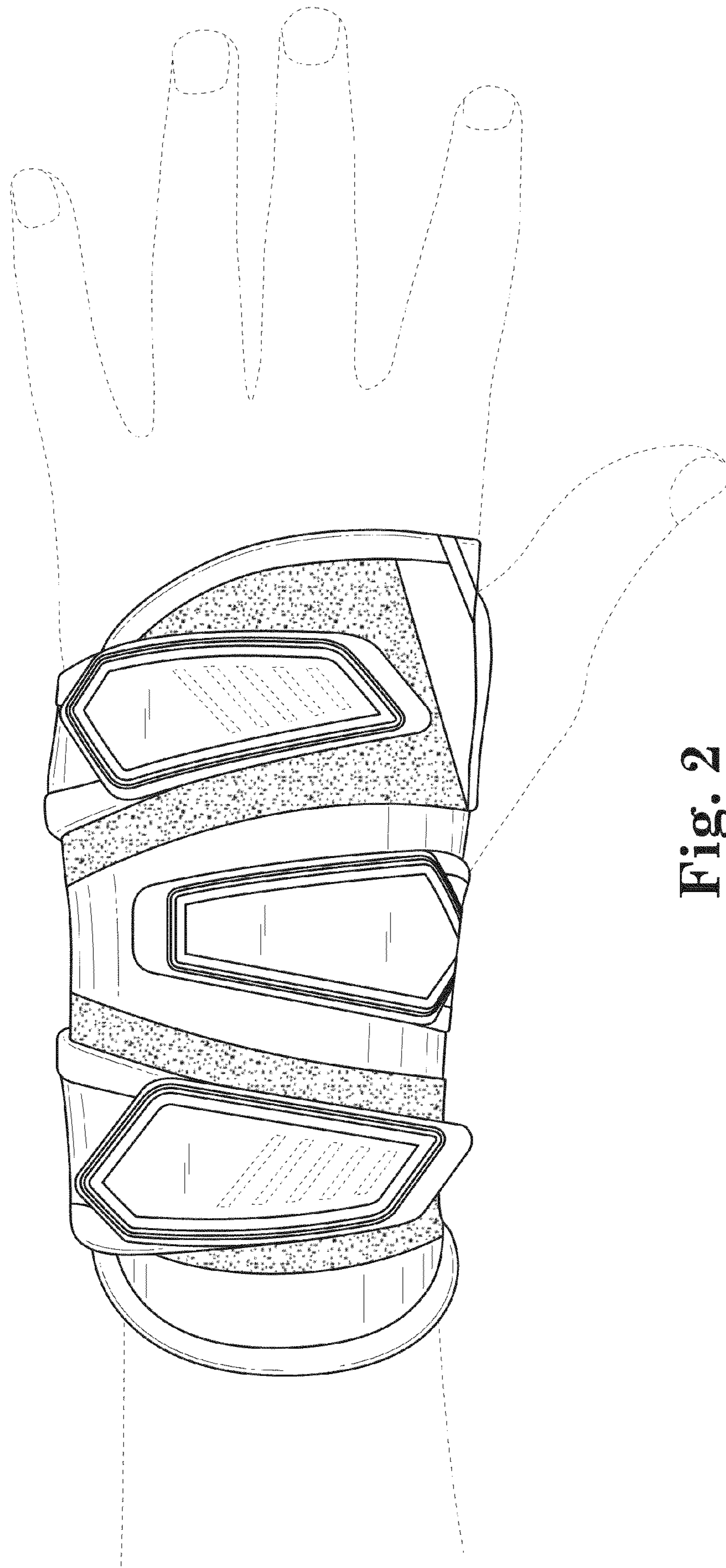

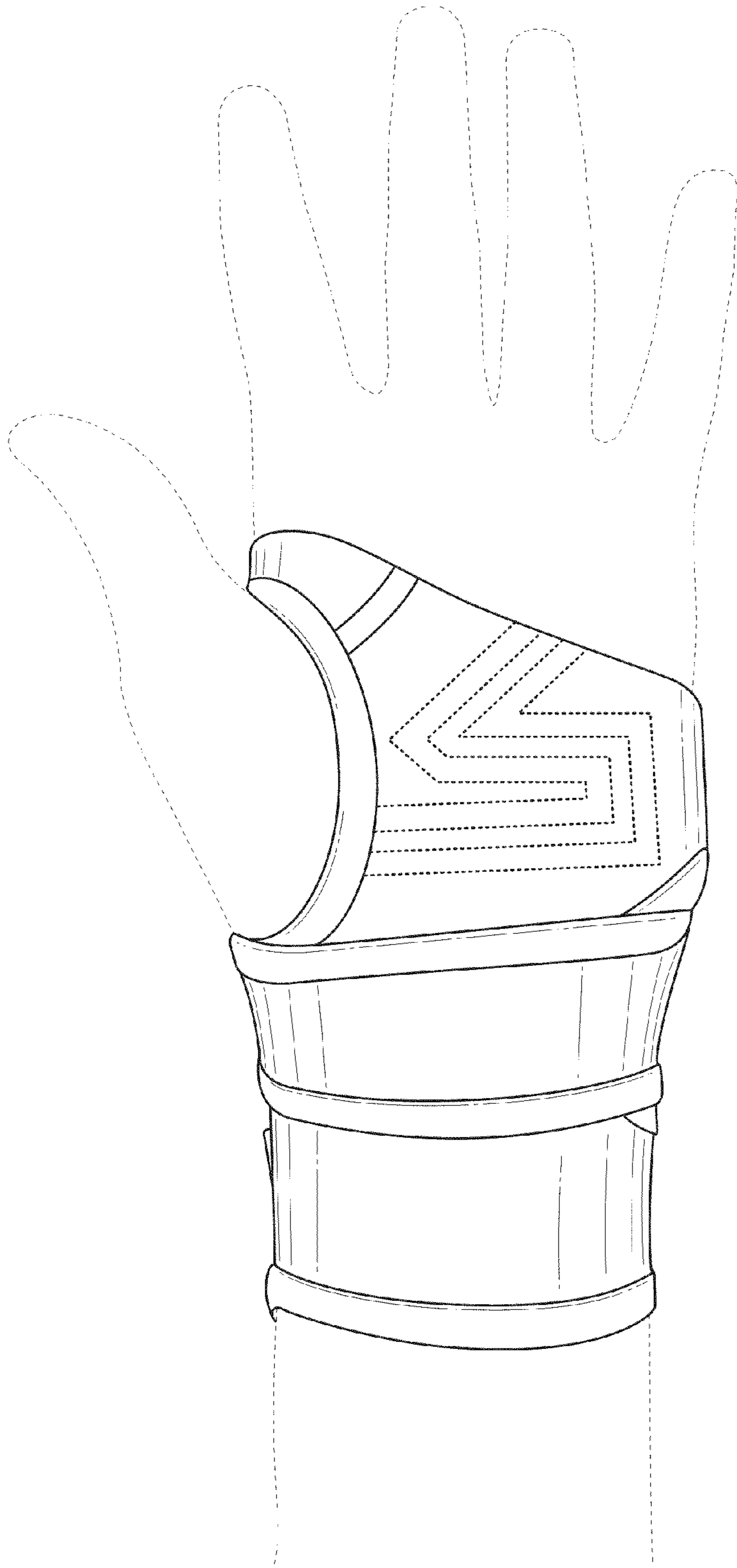

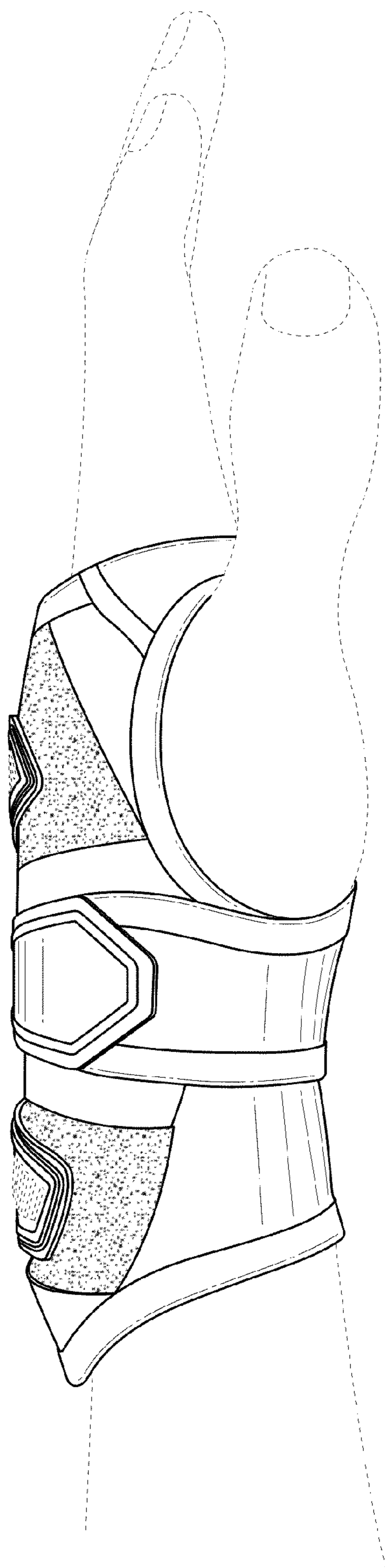

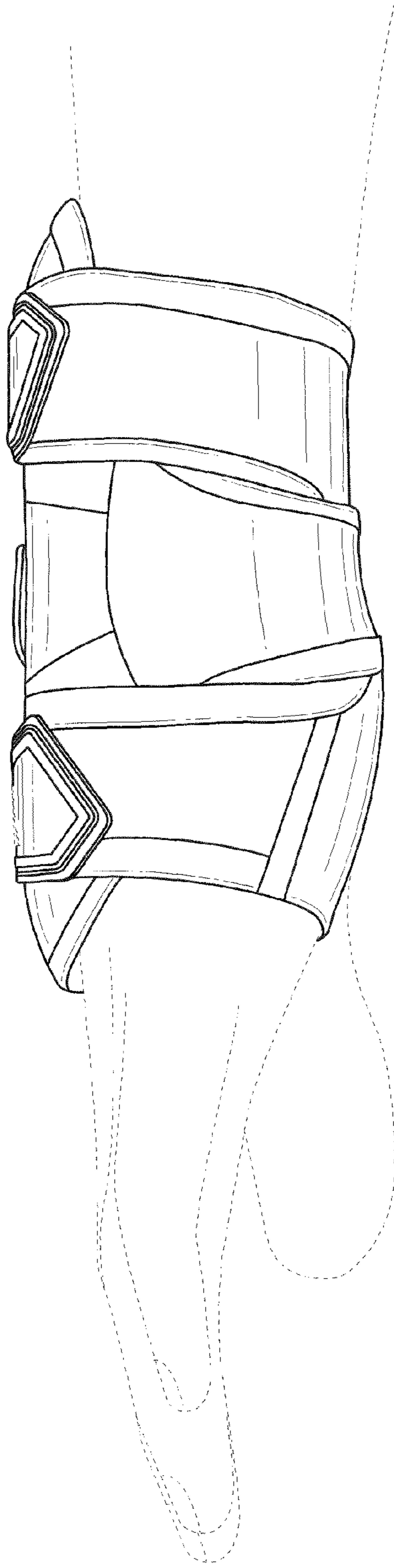

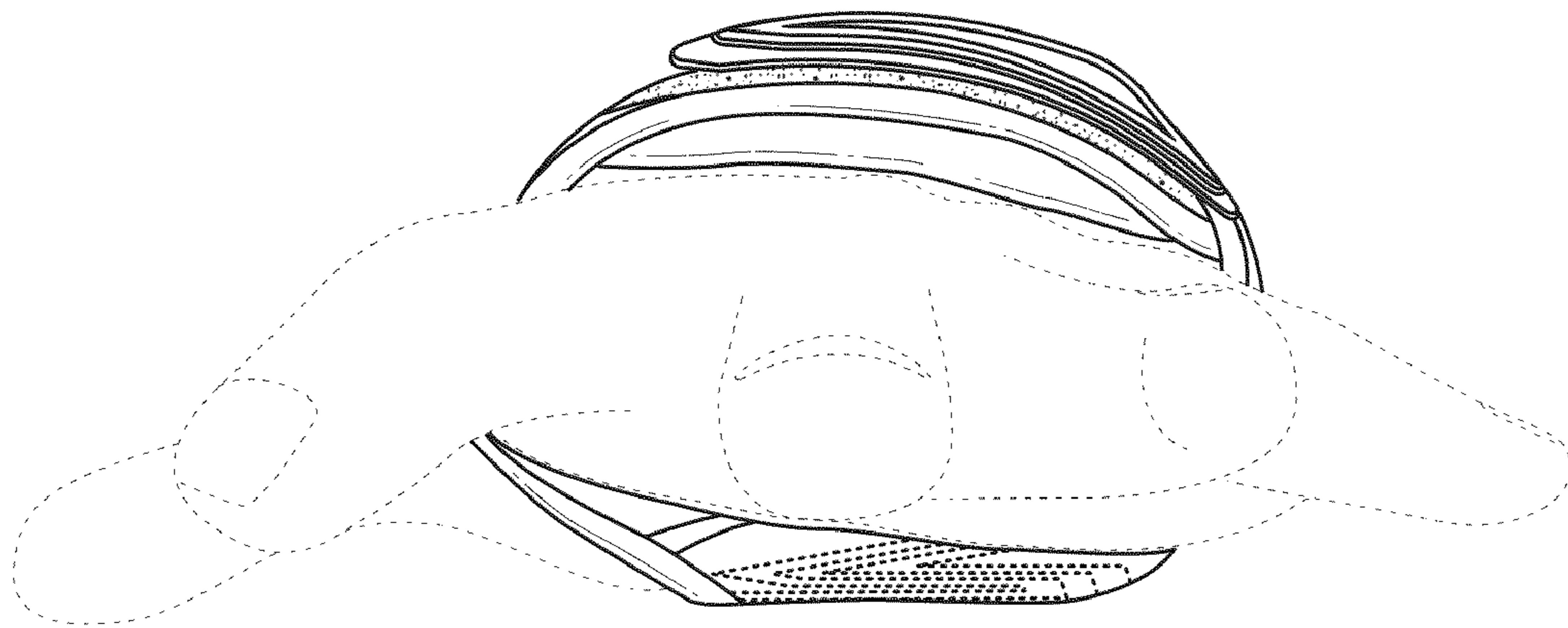
