(57) **CLAIM**

What is claimed is the ornamental design for a one-piece garment for children, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a one-piece garment for children, showing the new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a right-side elevational view thereof;

FIG. 11 is a right-side elevational view of FIG. 8;

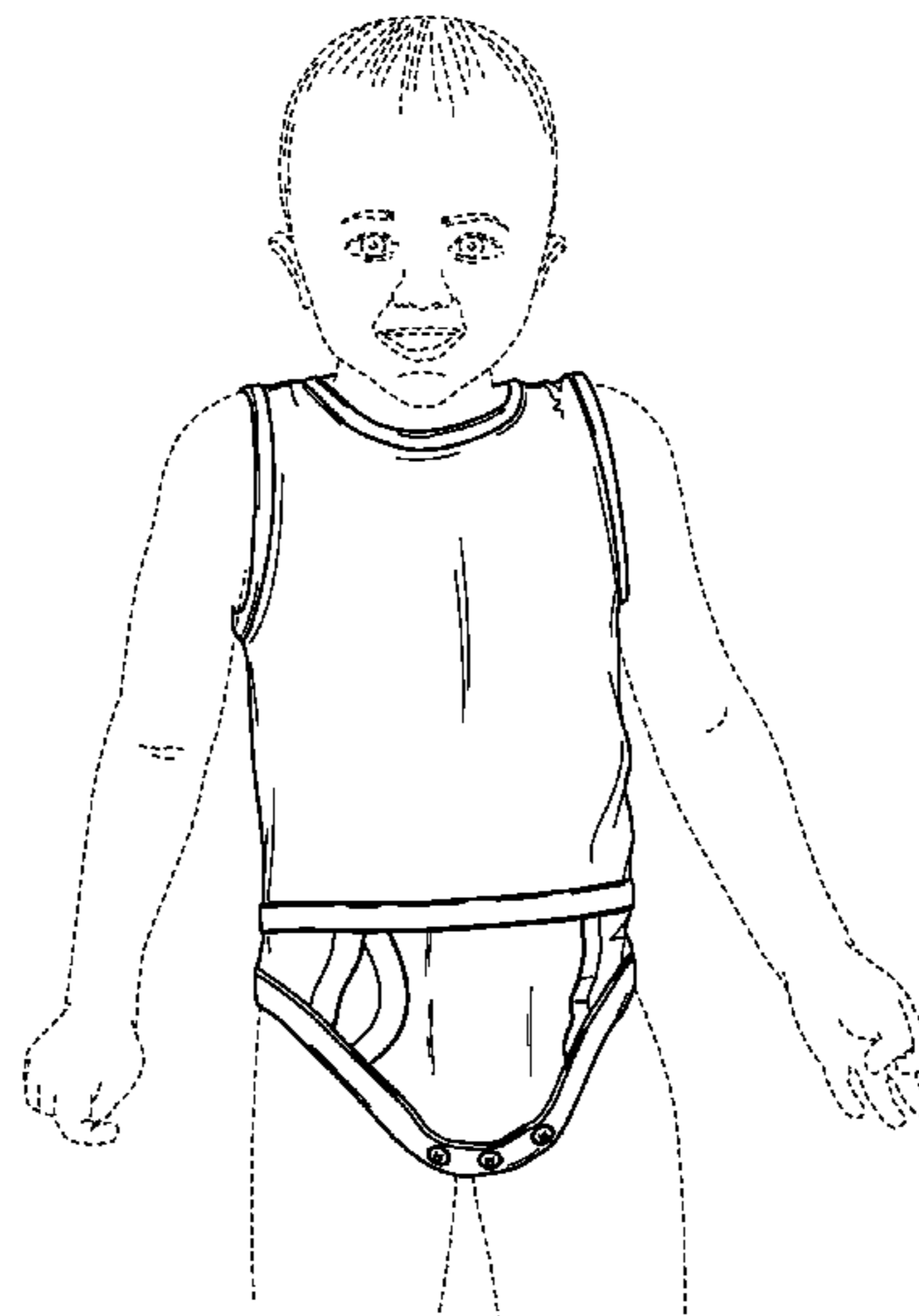
FIG. 12 is a left-side elevational view of FIG. 8;

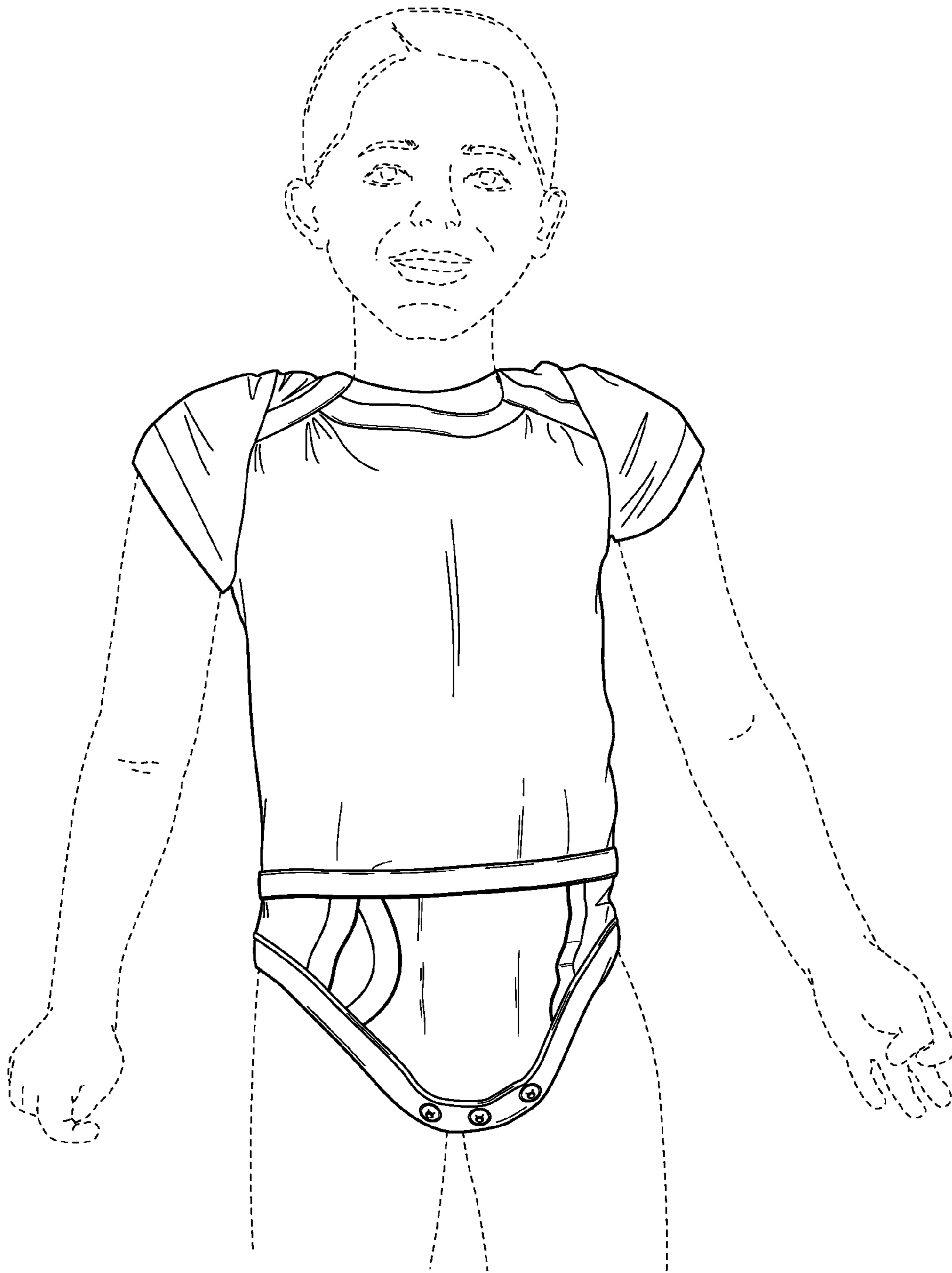

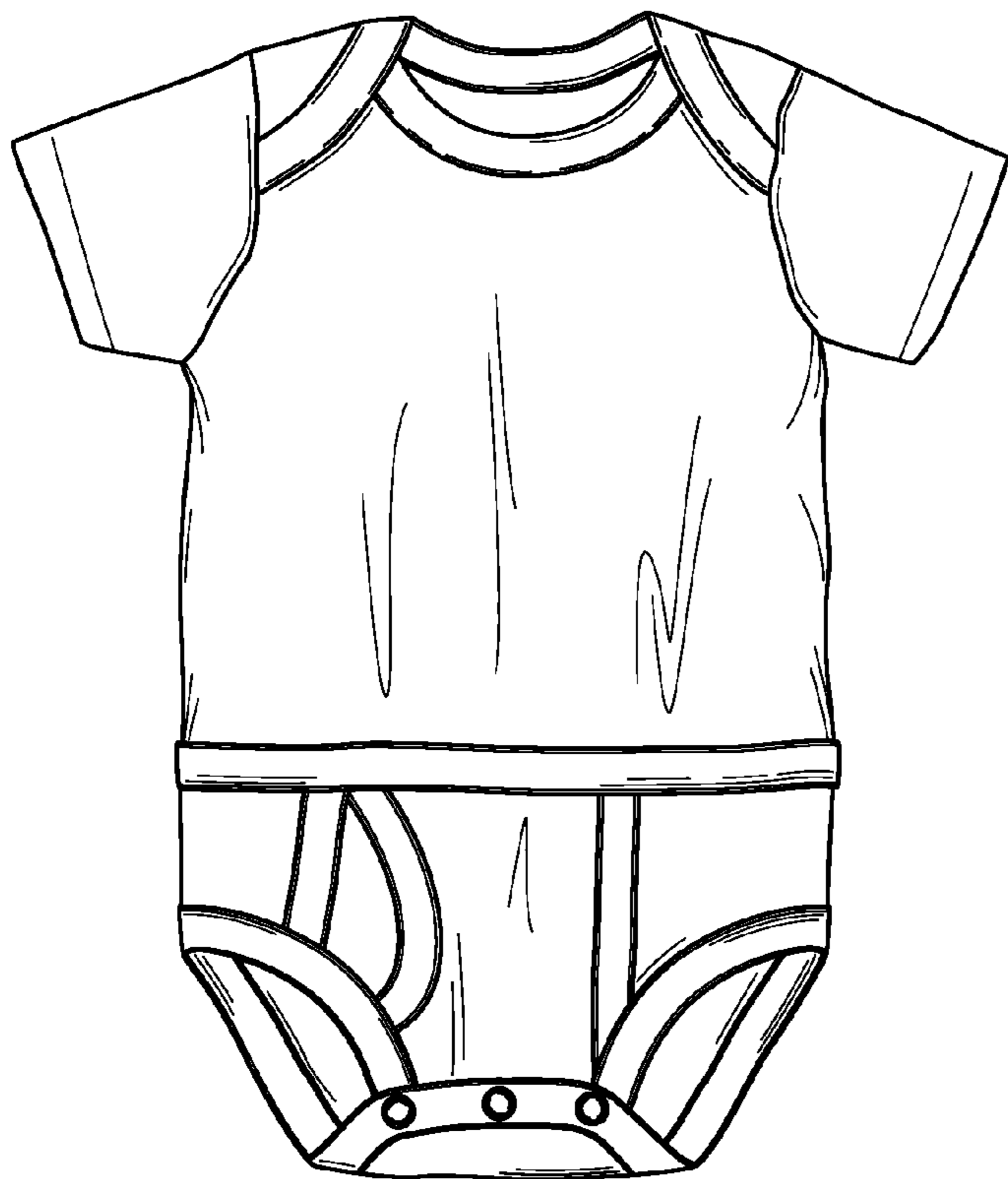

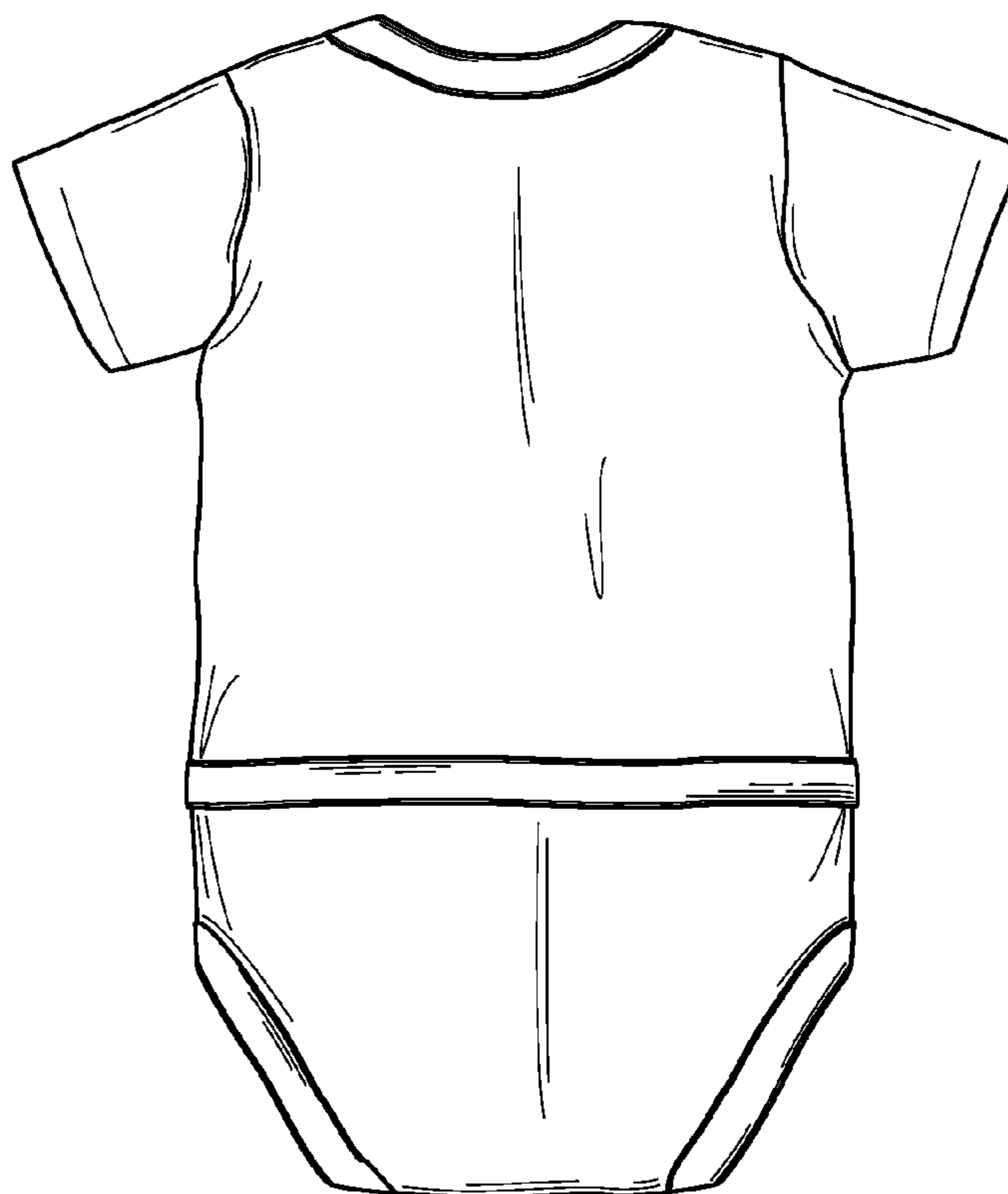

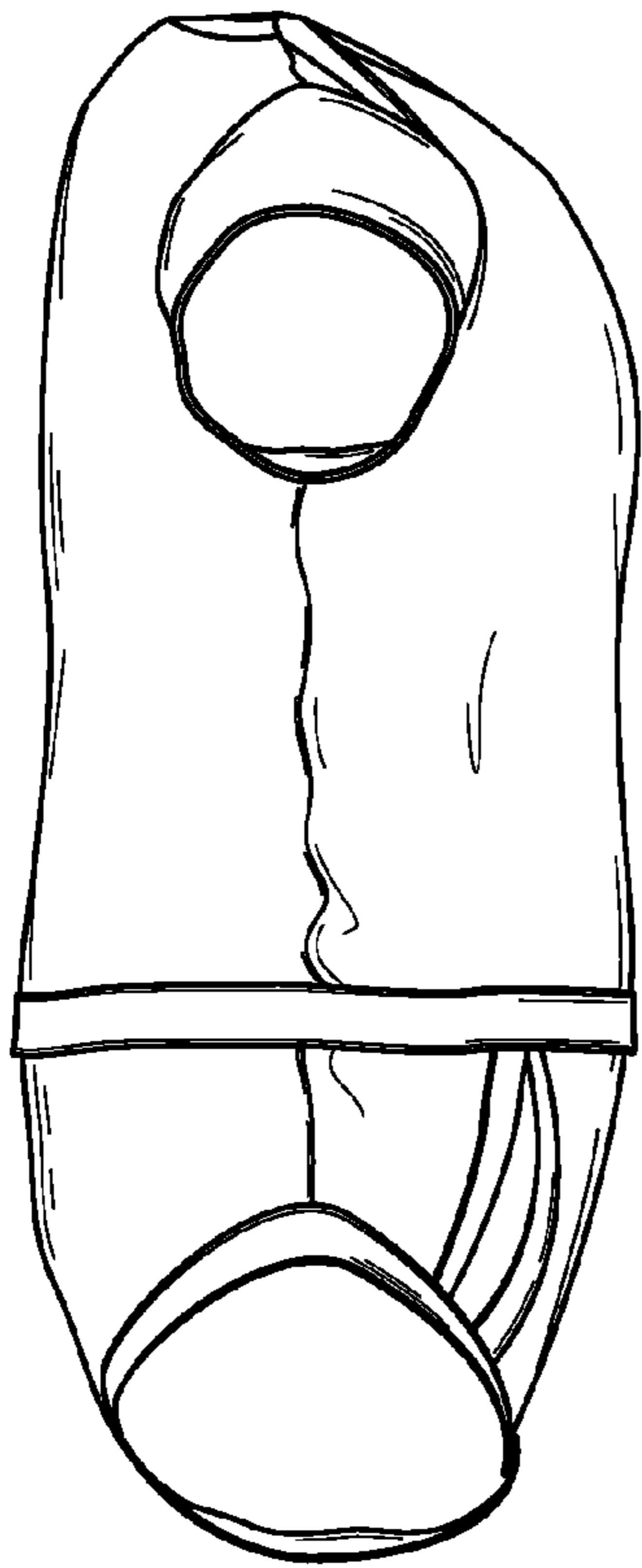

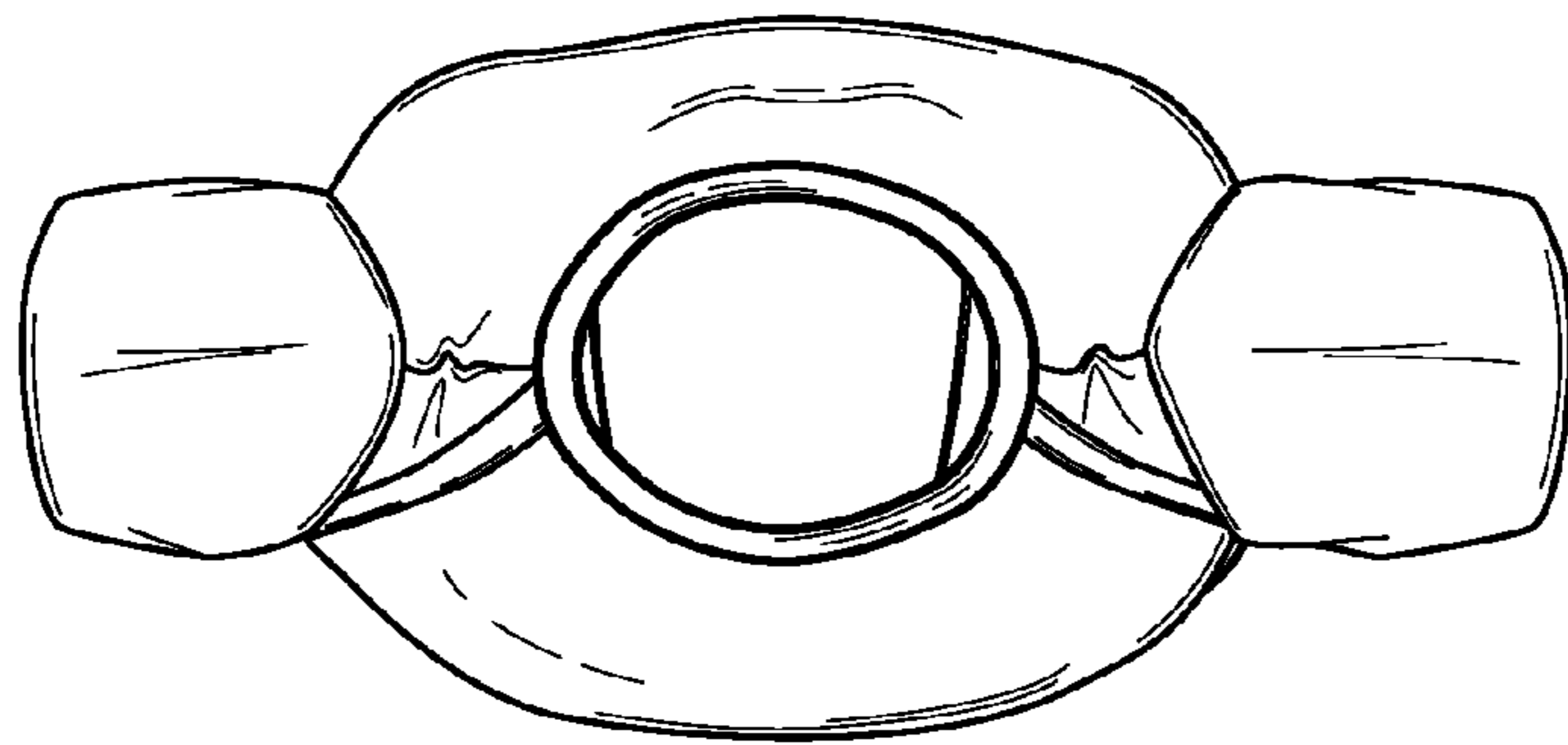

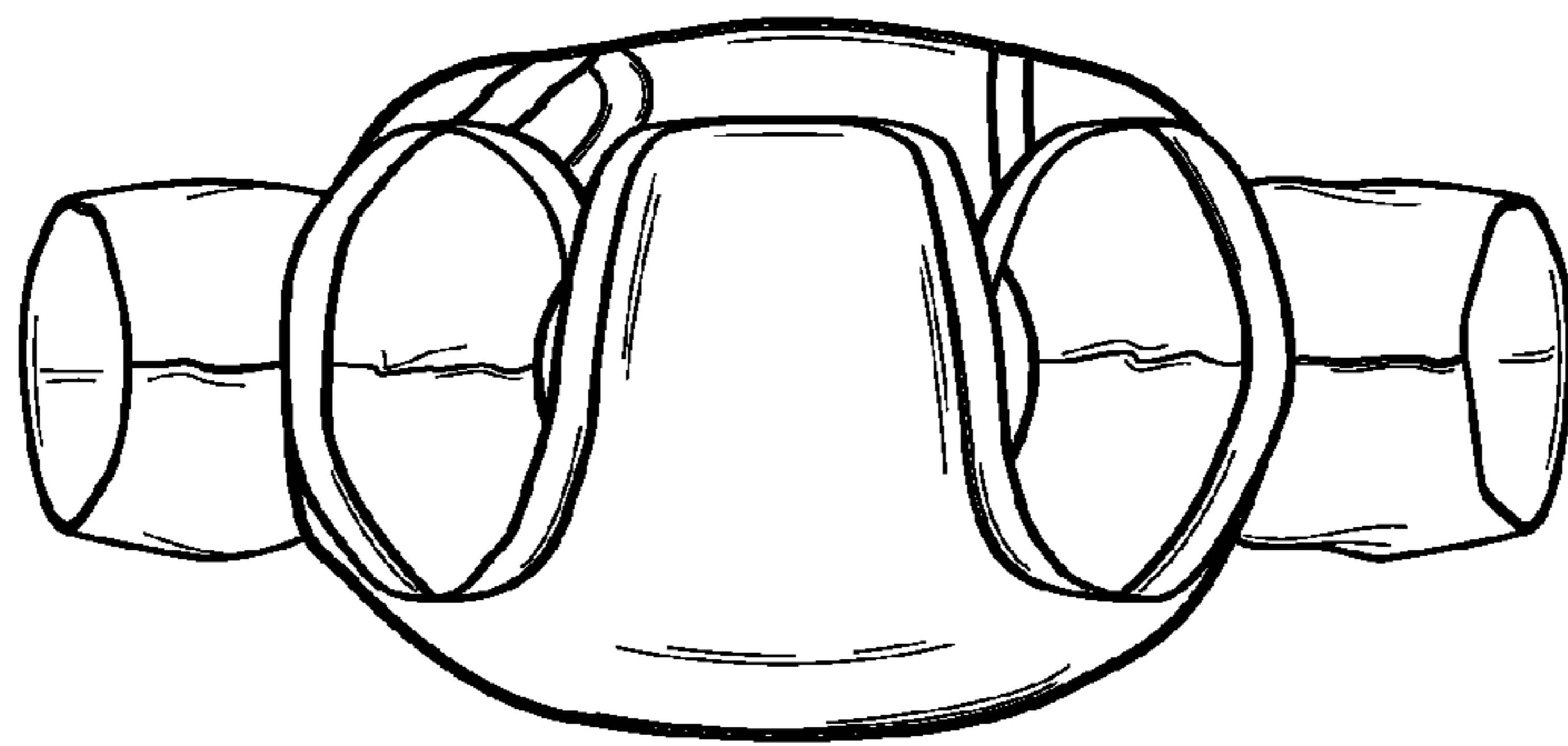

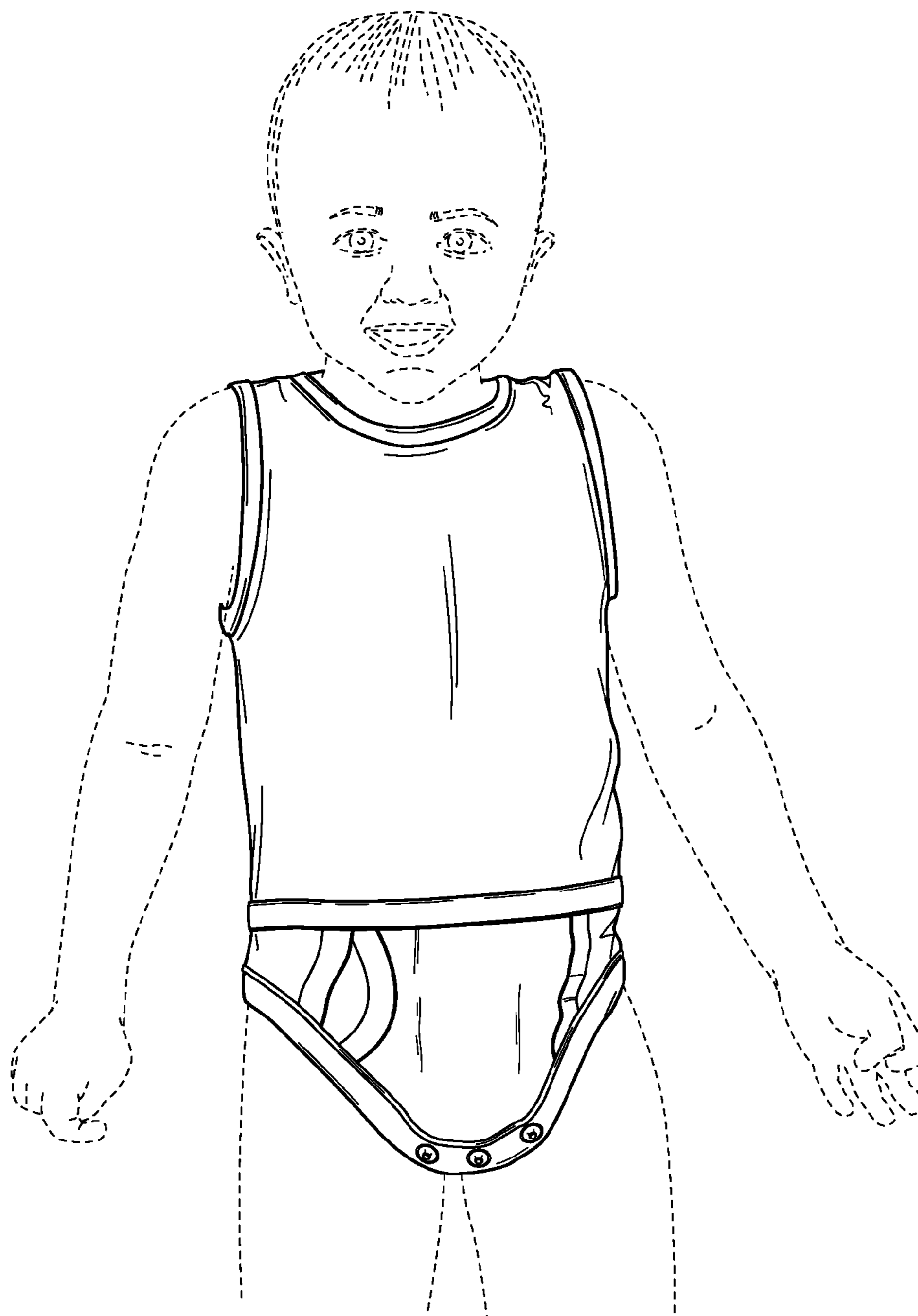

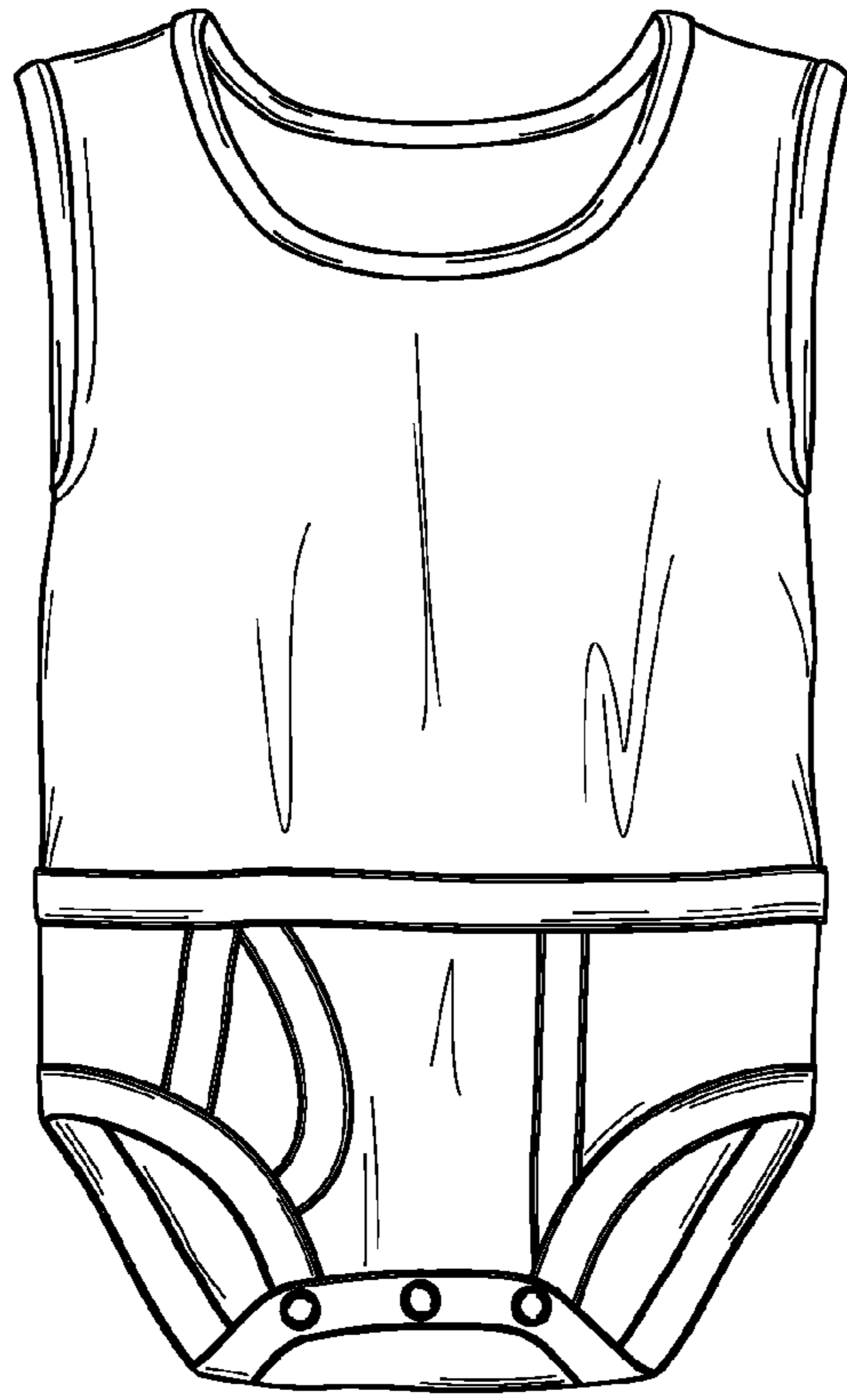

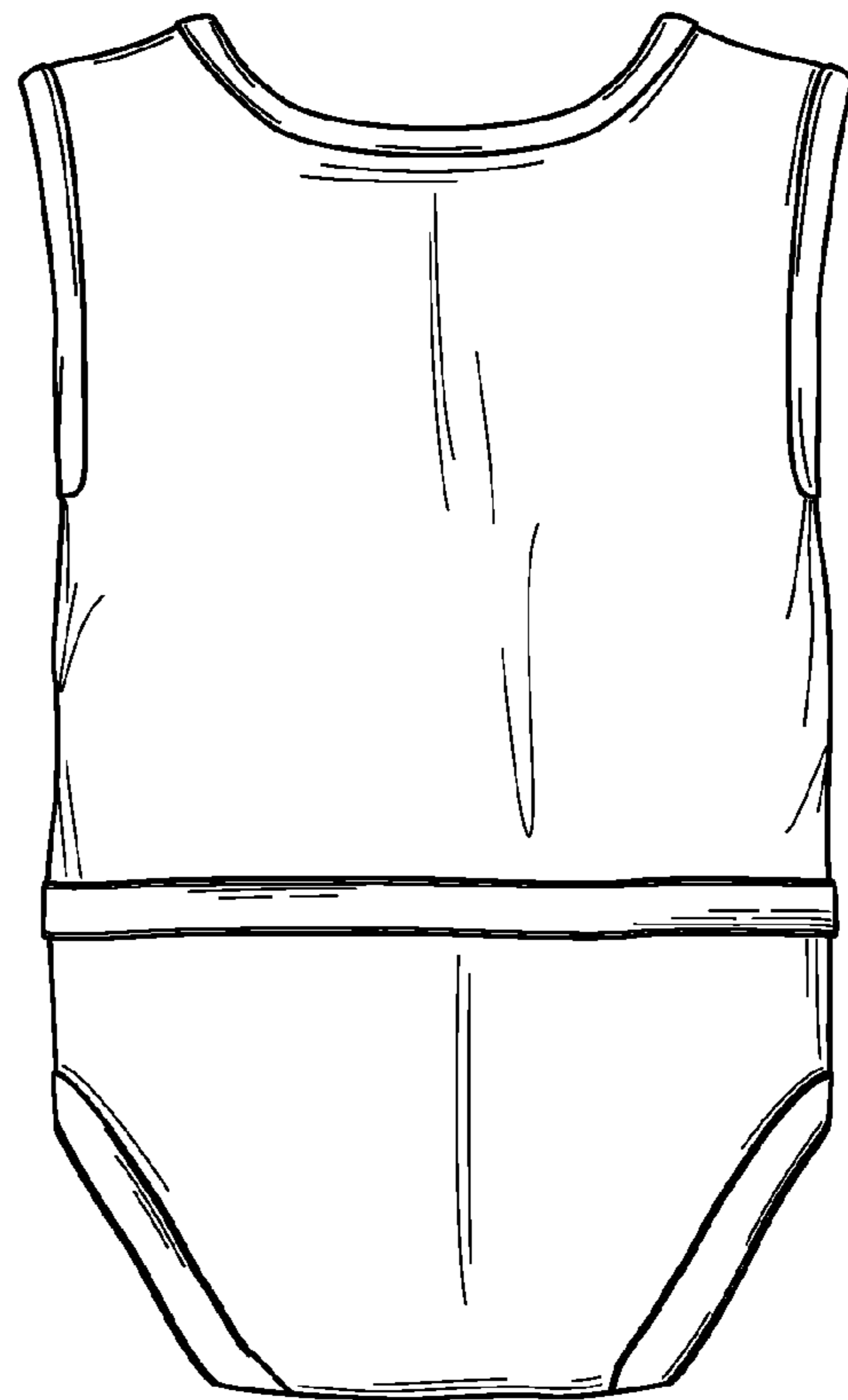

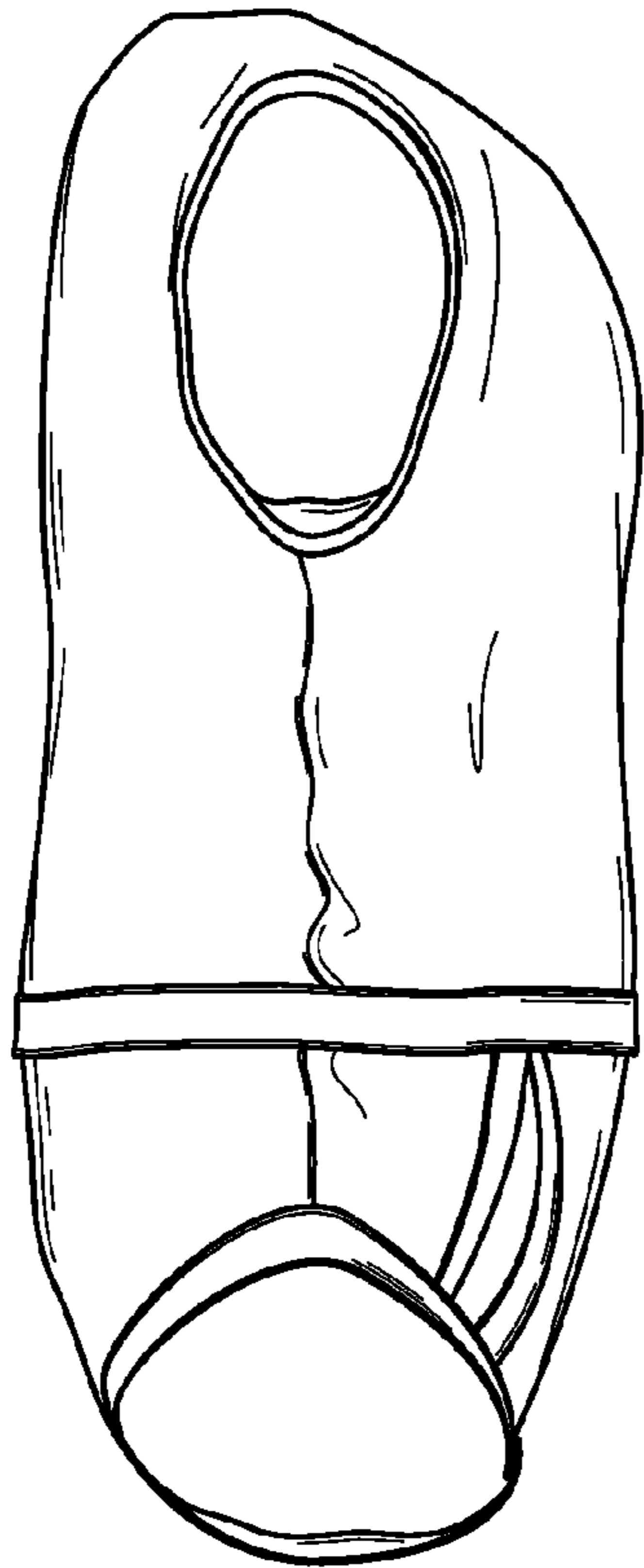

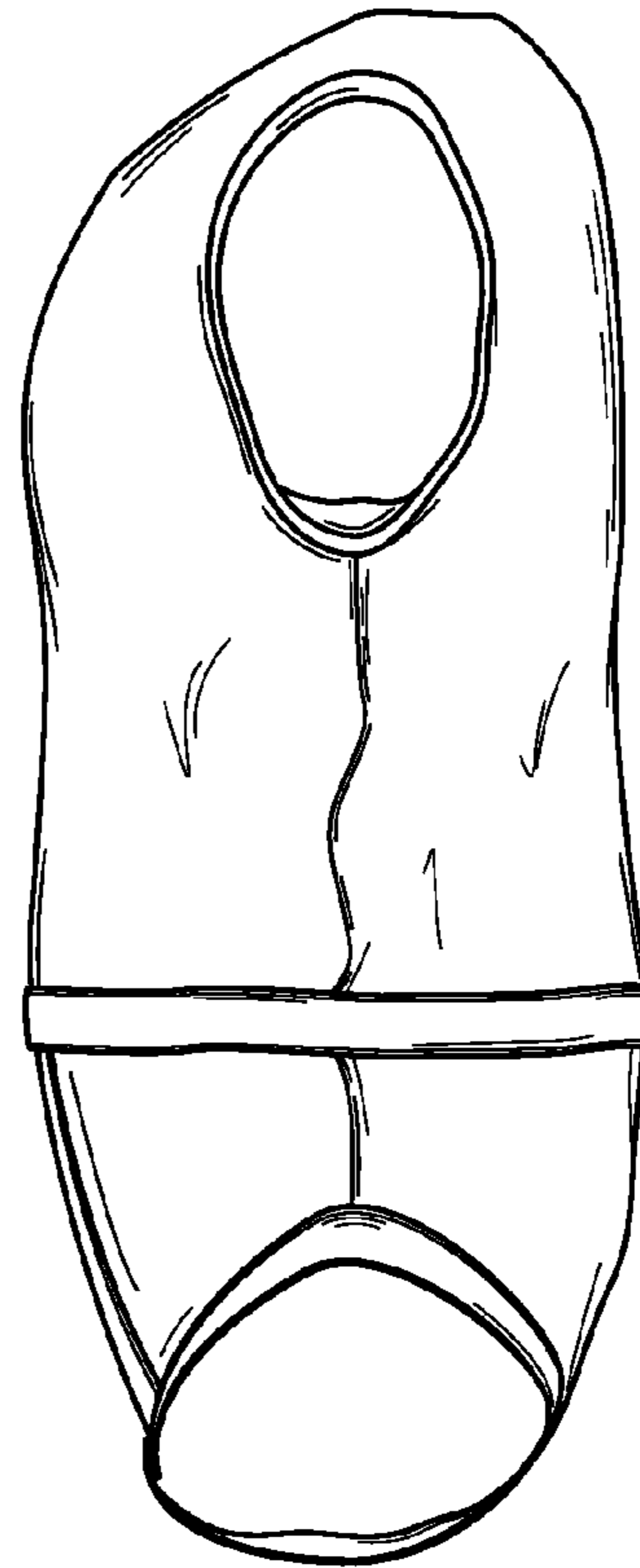

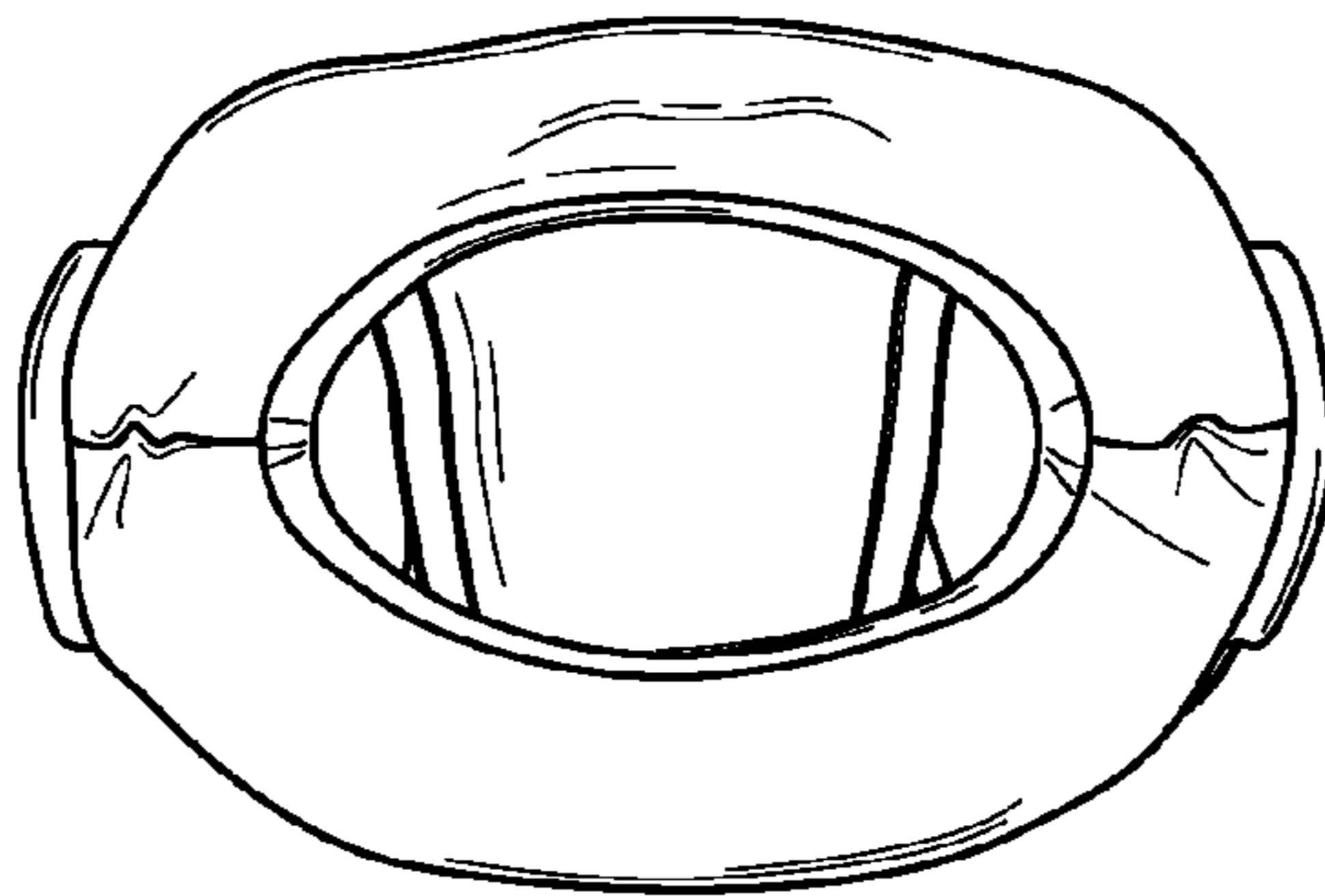

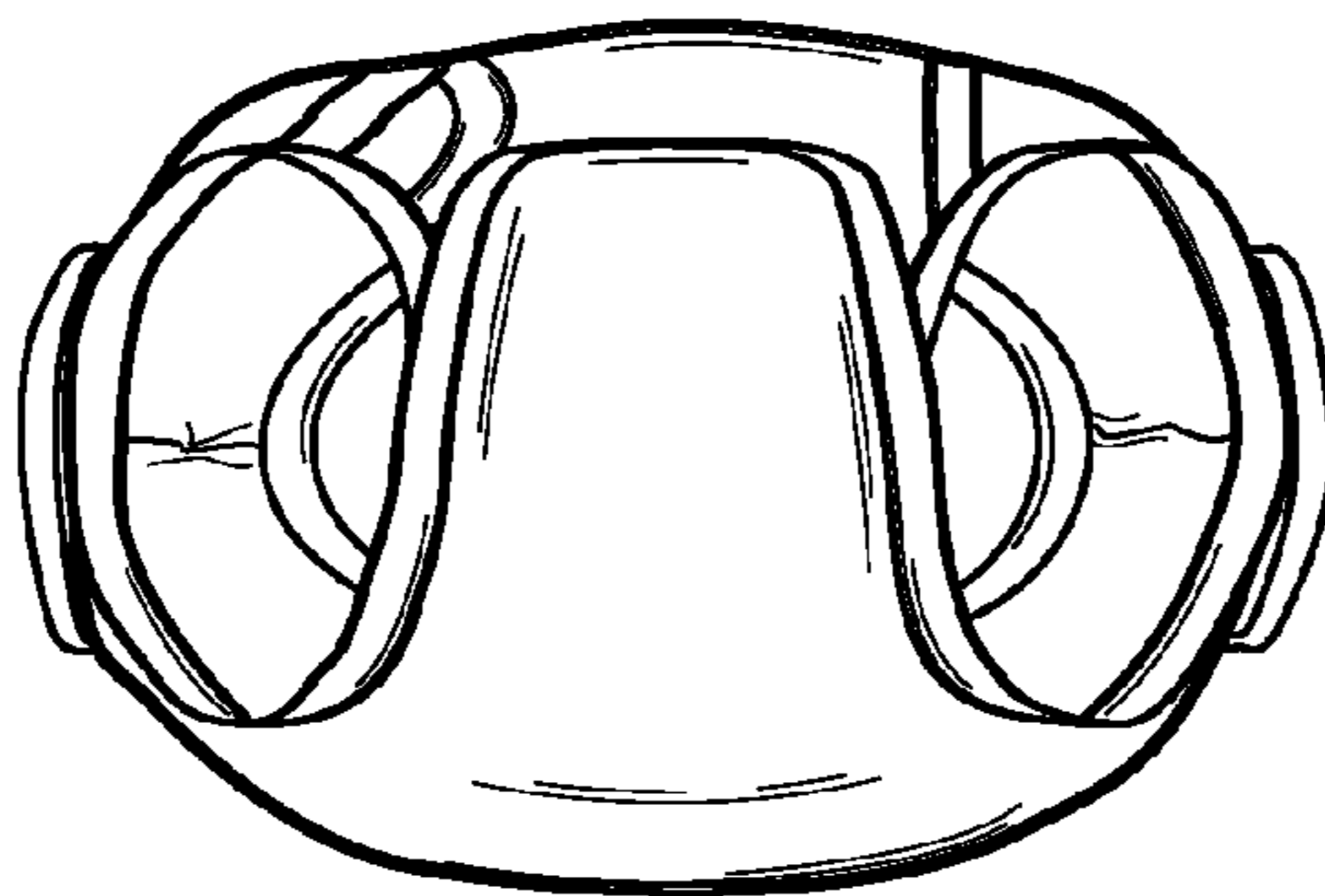
