DESCRIPTION

FIG. 1 is a perspective view of a globe picture frame, showing the new design;

FIG. 2 is a front elevational view thereof;

FIG. 4 is a right-side elevational view thereof;

FIG. 5 is a left-side elevational view thereof;

FIG. 6 is a top plan view thereof; and,

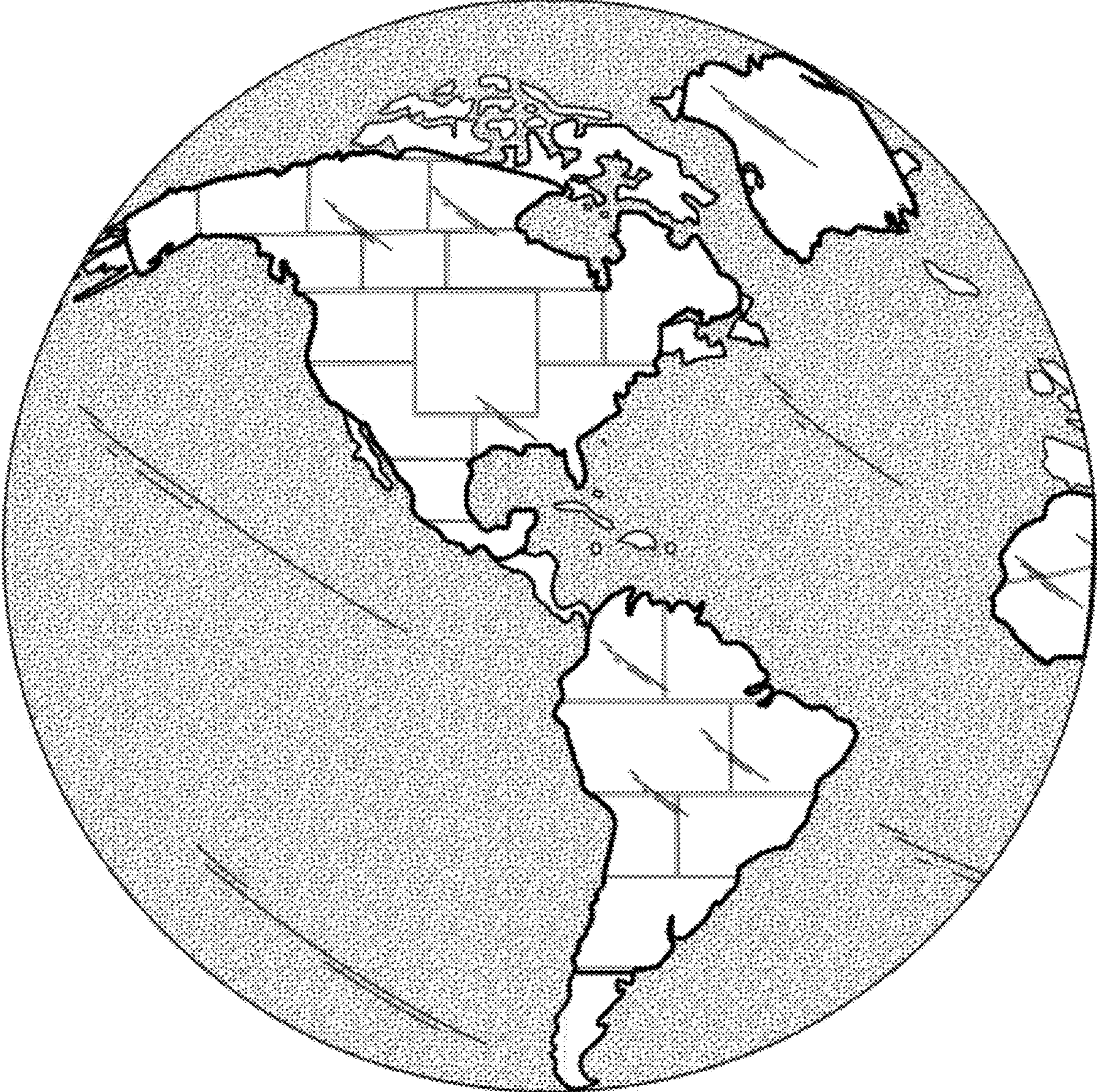

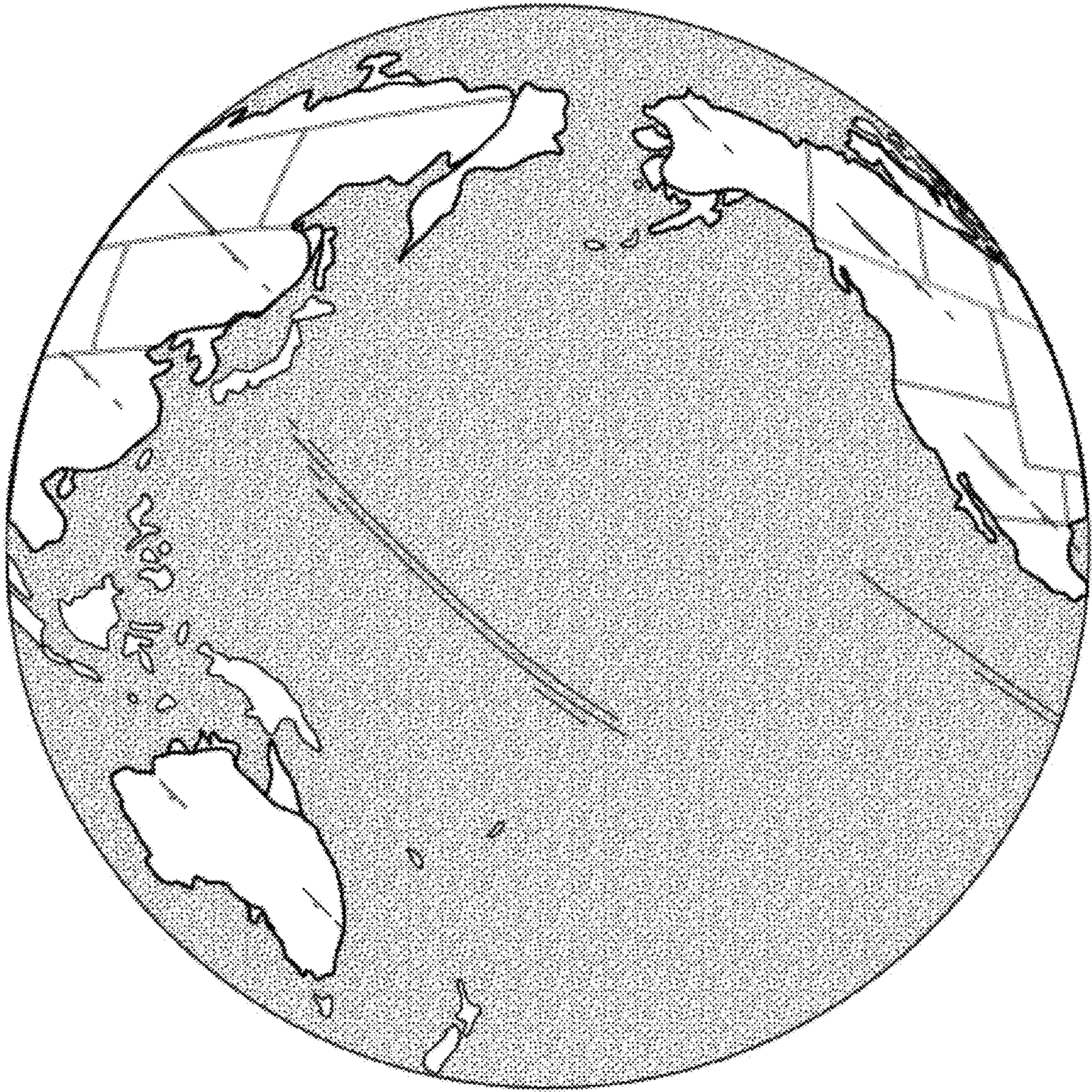

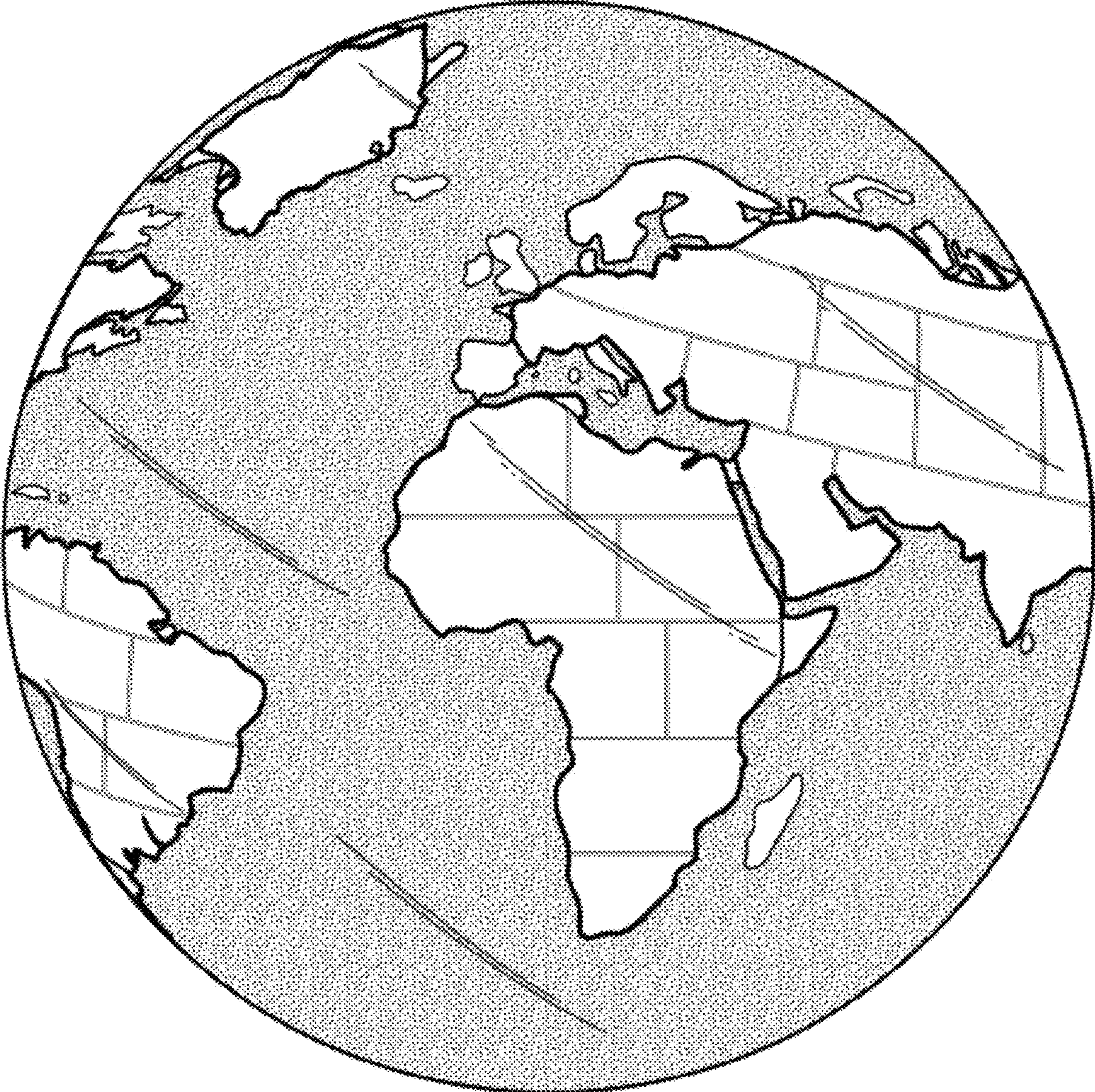

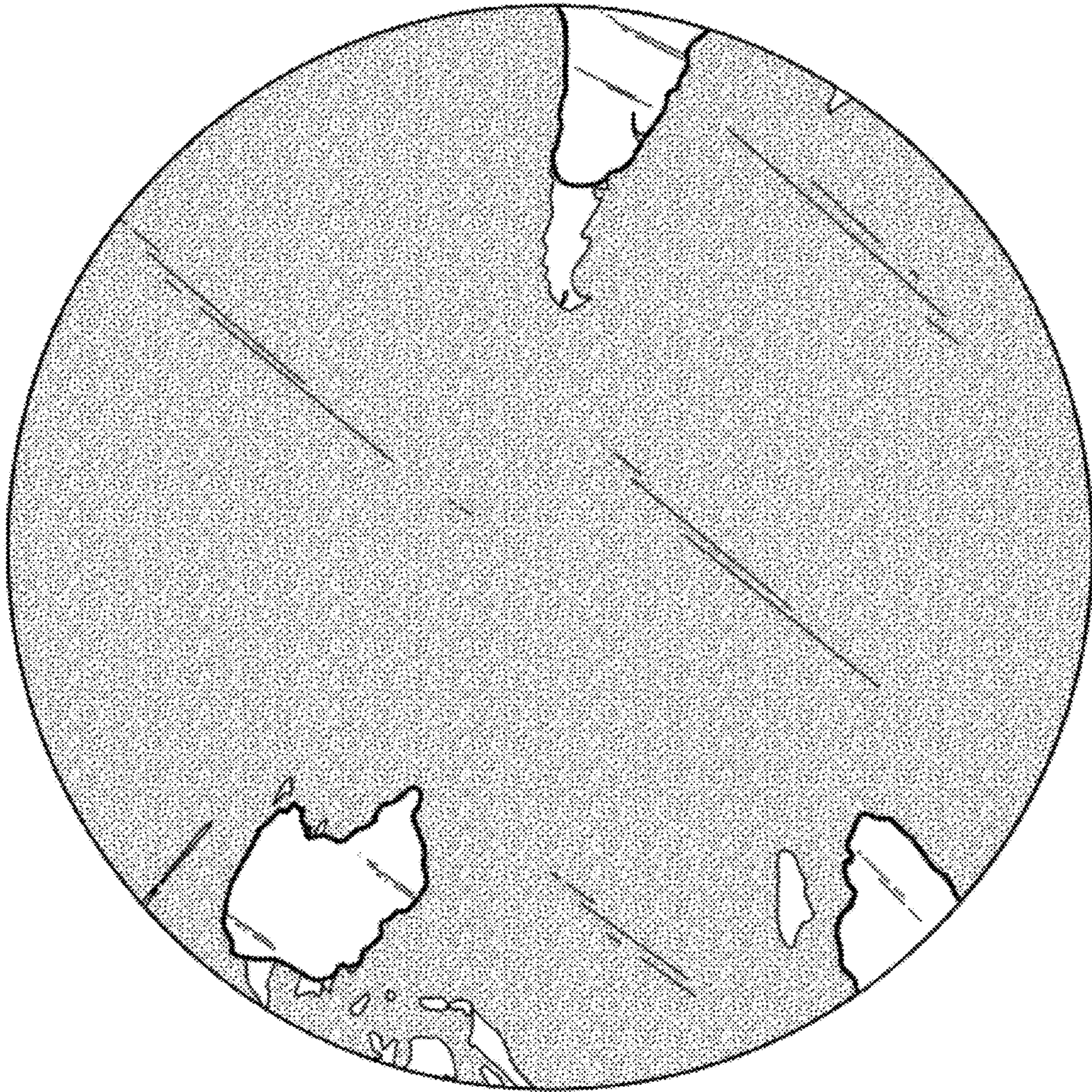
