FIG. 5 is the opposite side view of FIG. 4 thereof;

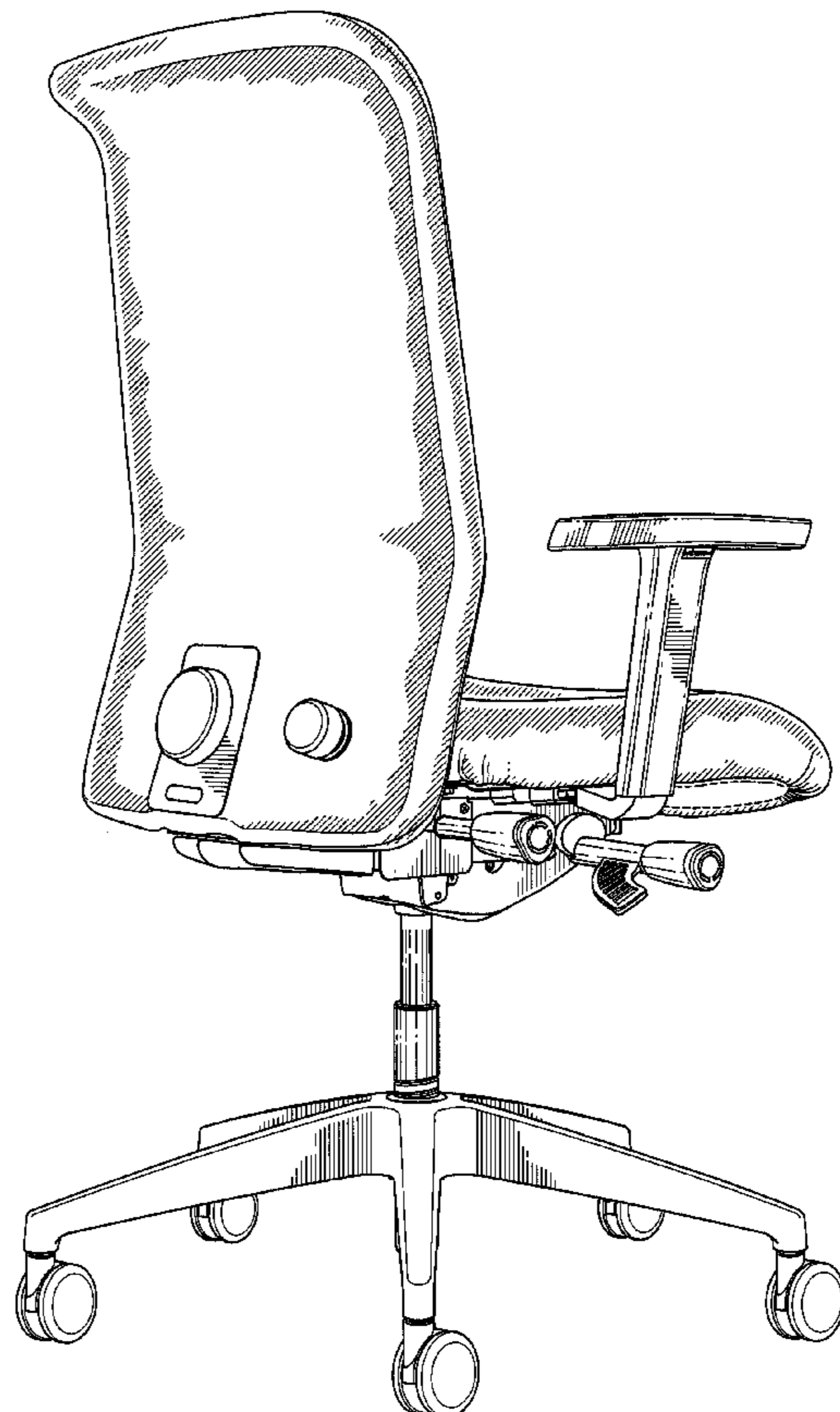
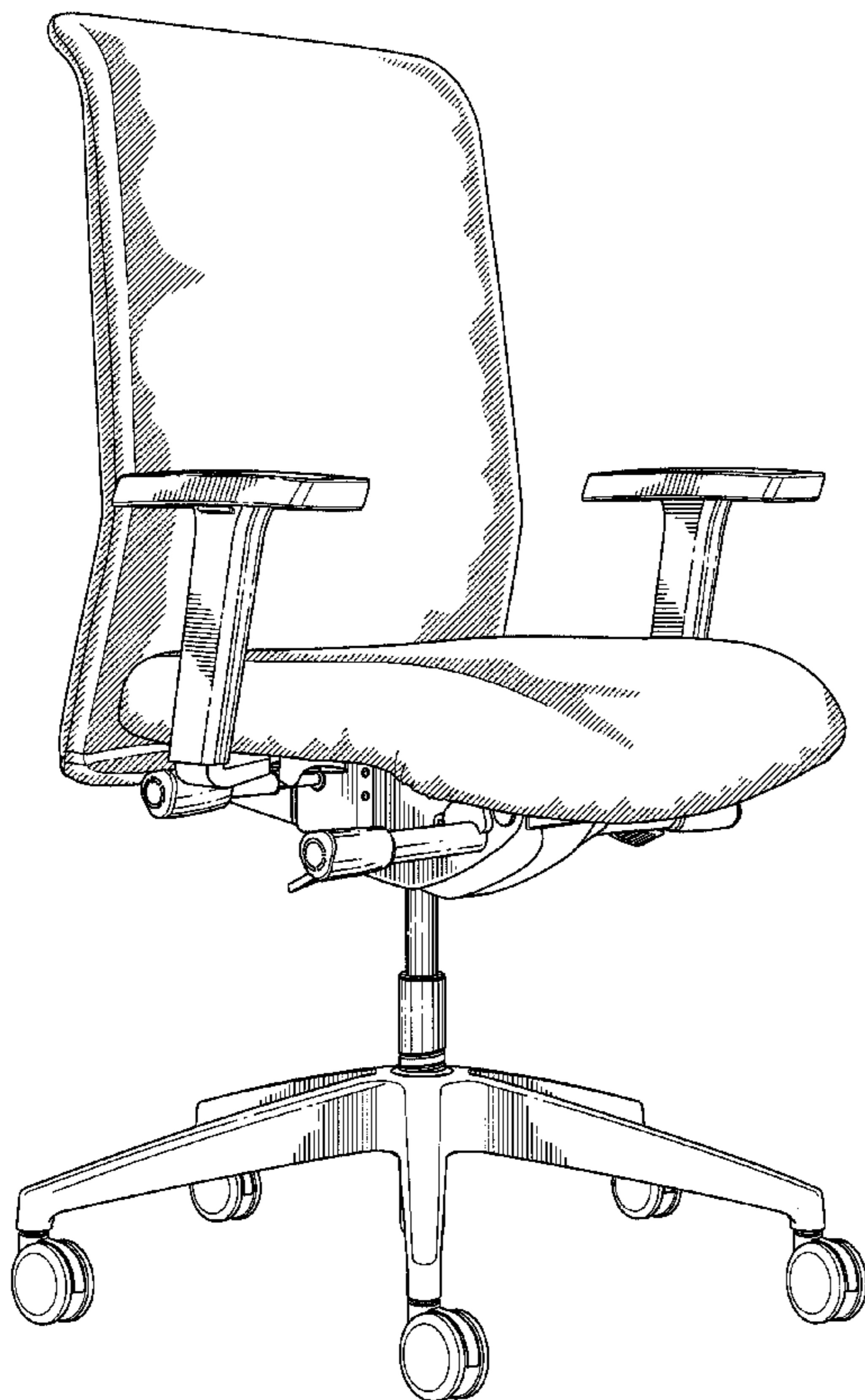
FIG. 6 is a rear view thereof;

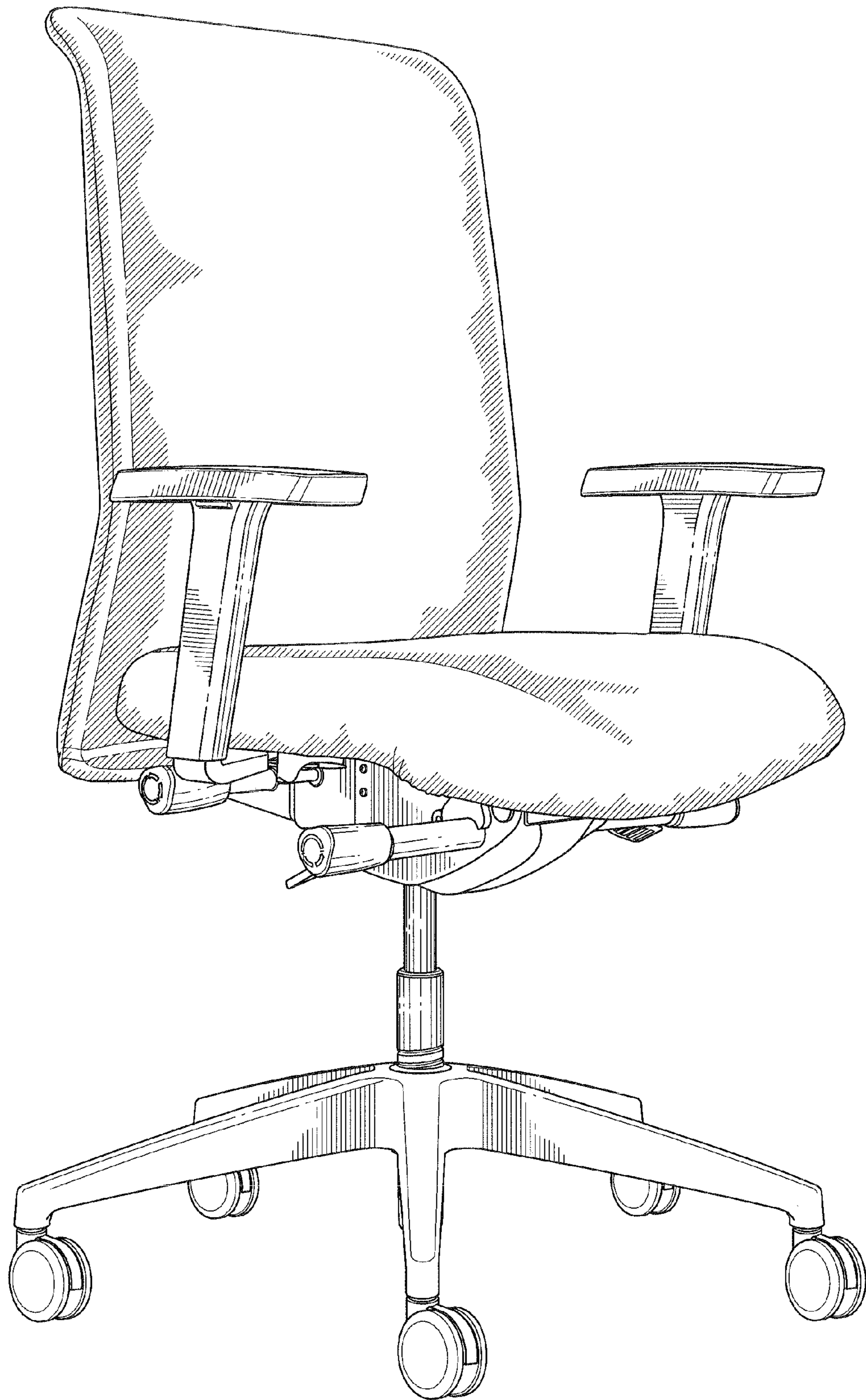

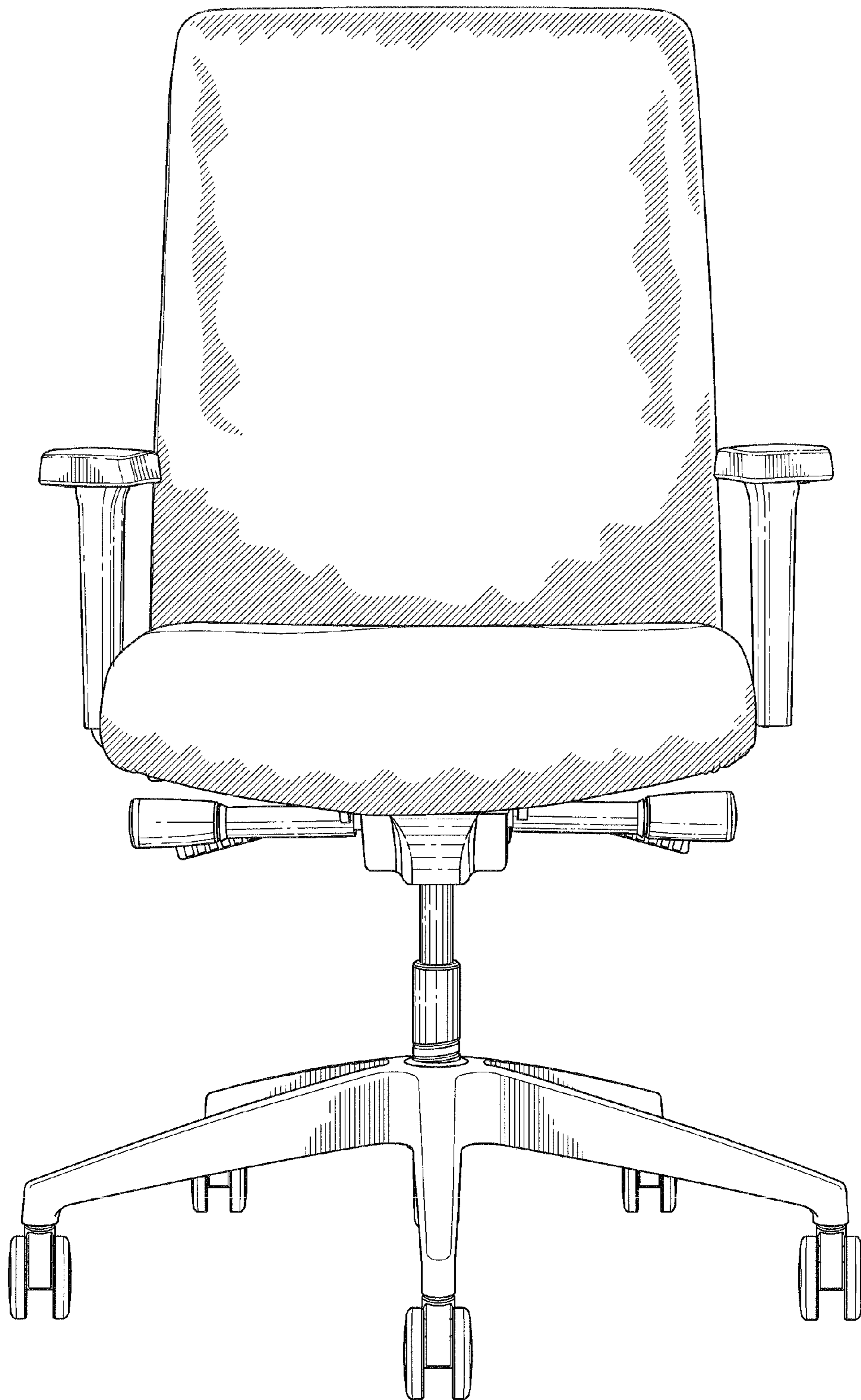

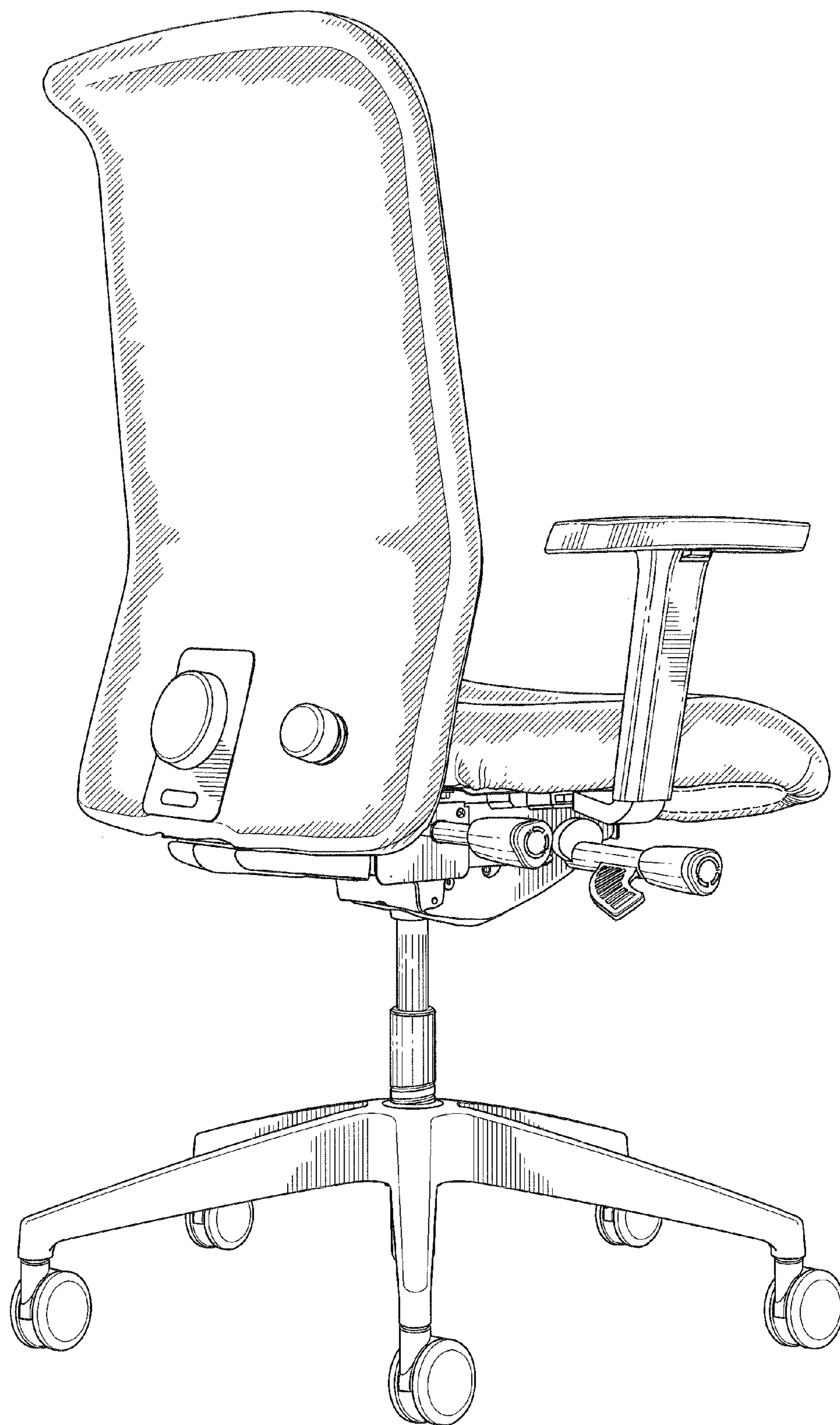

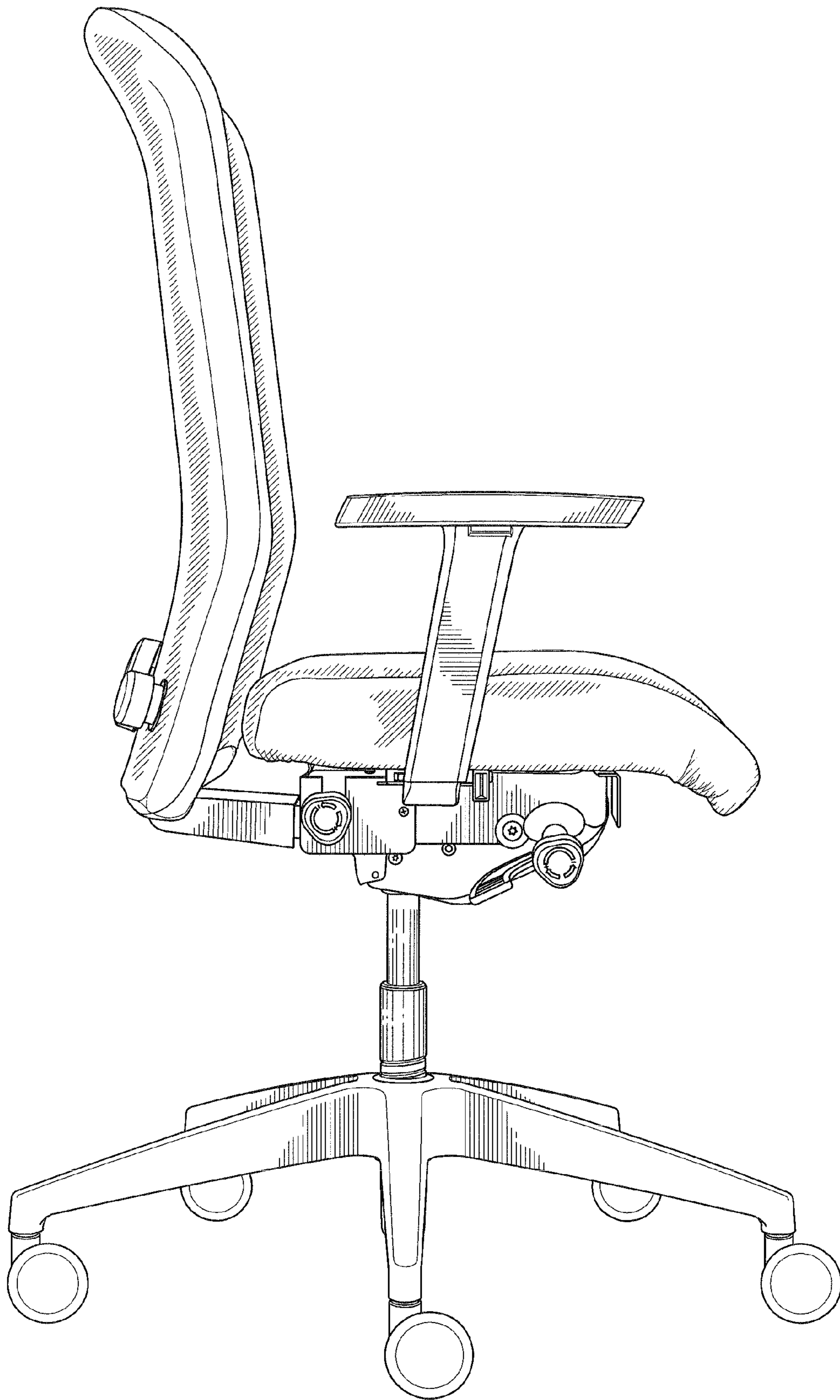

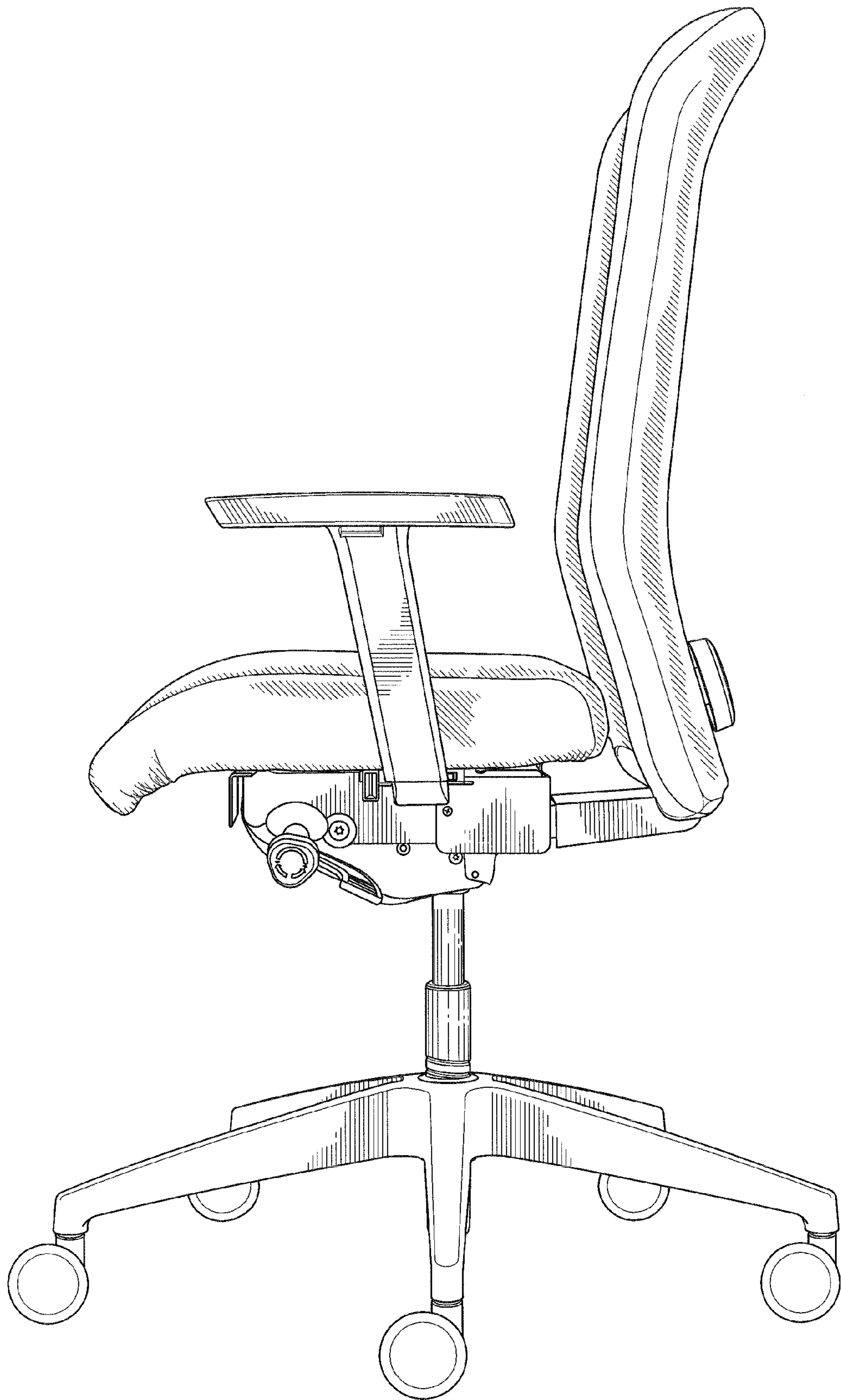

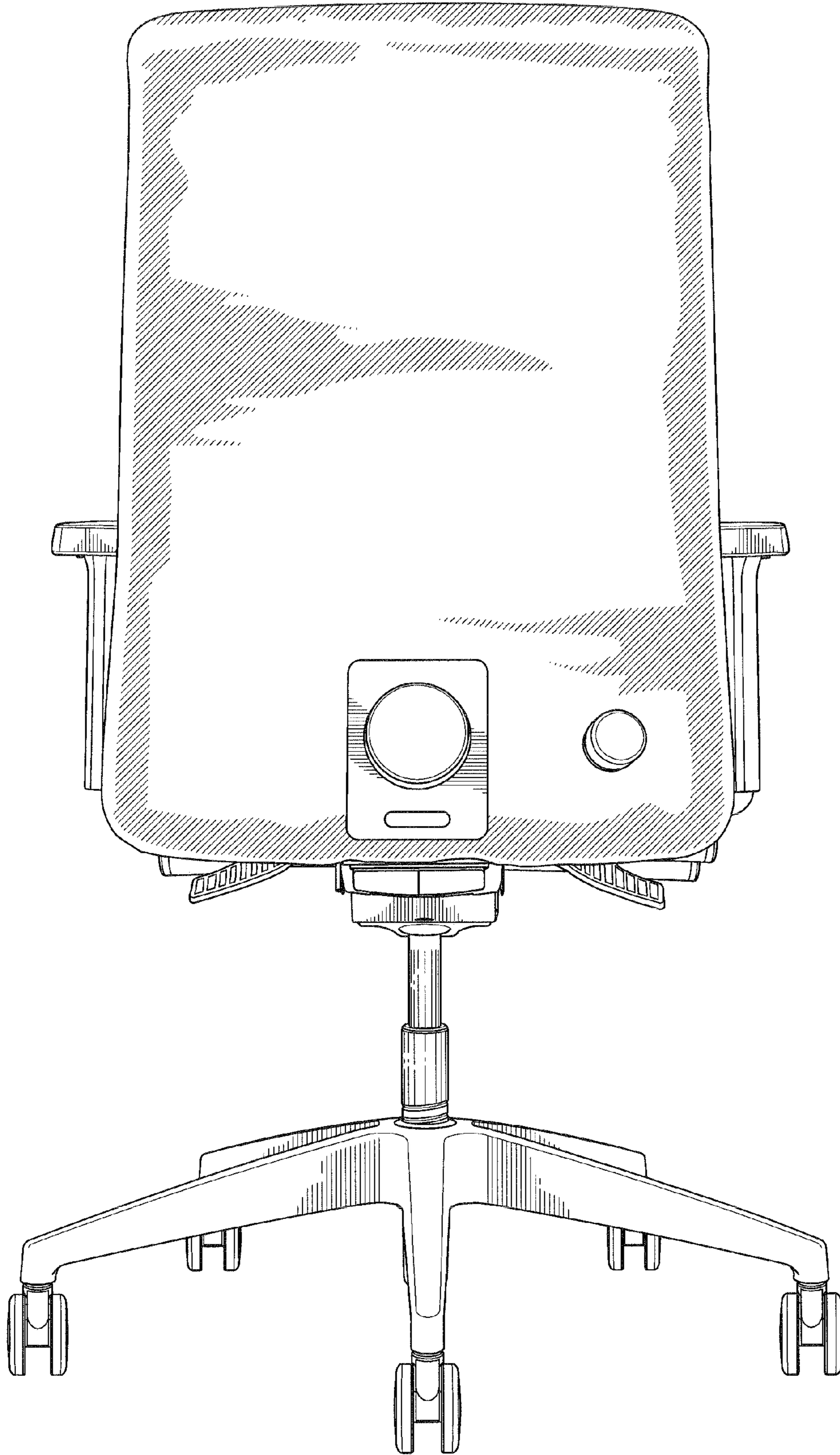

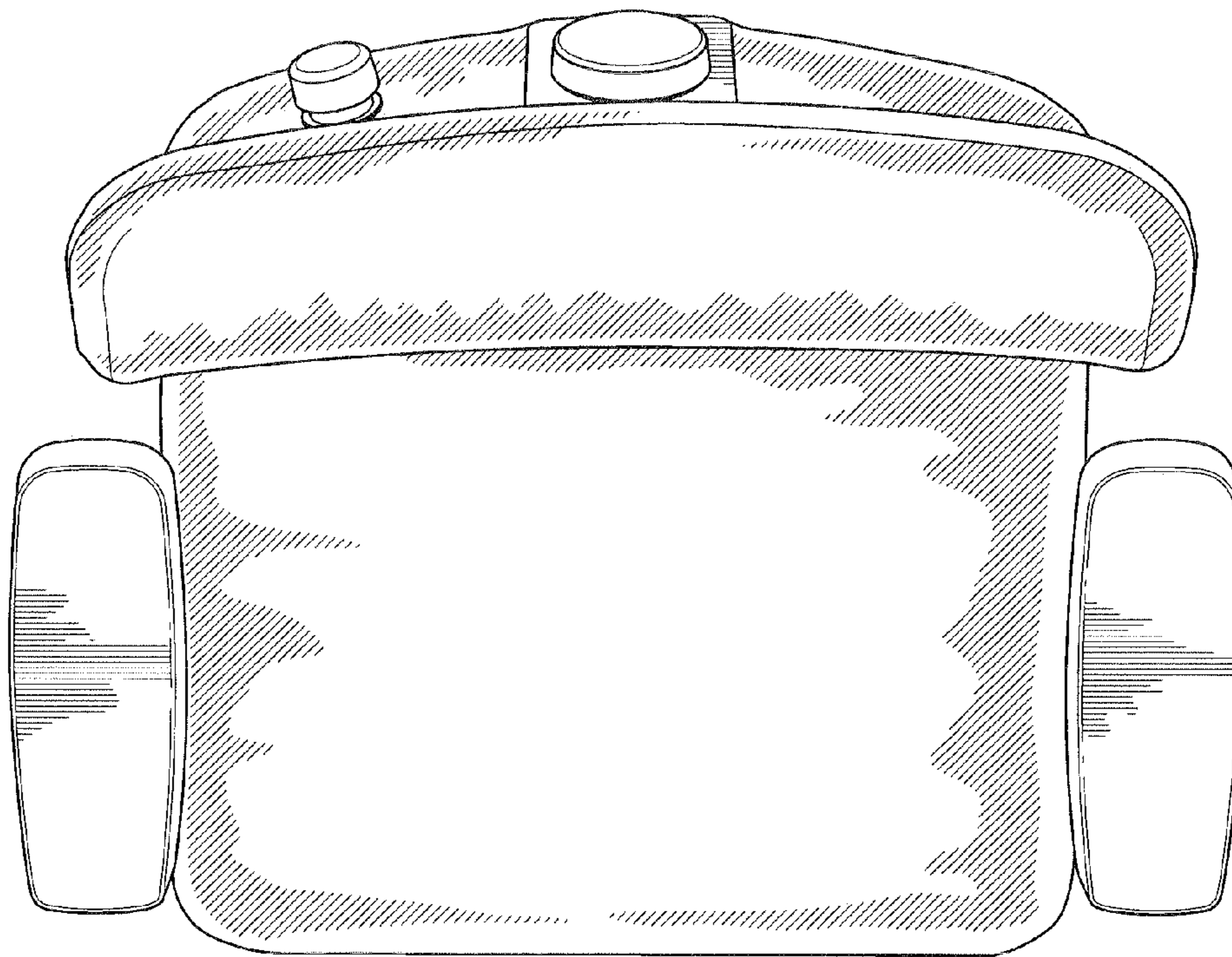

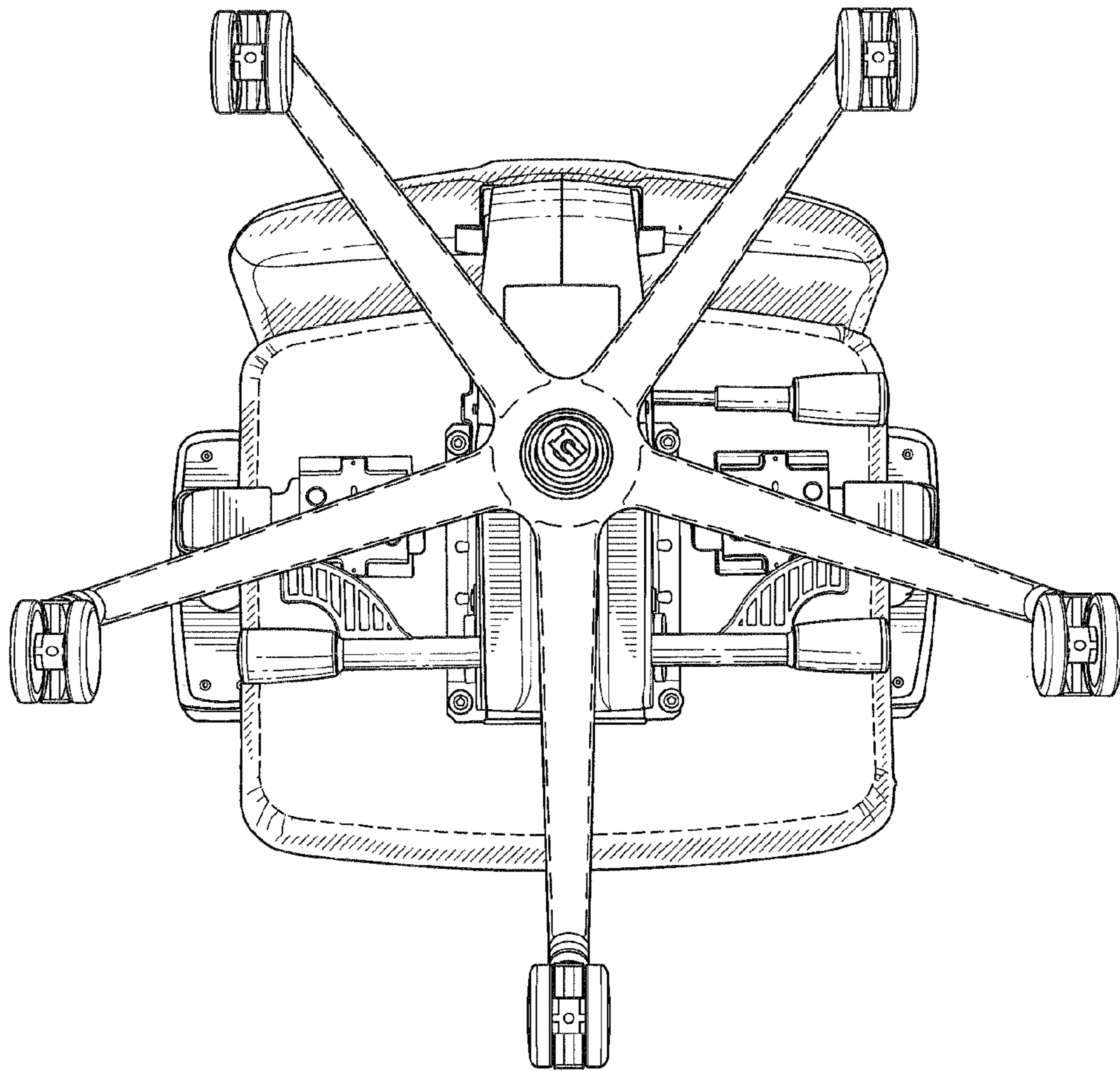
