mental design;

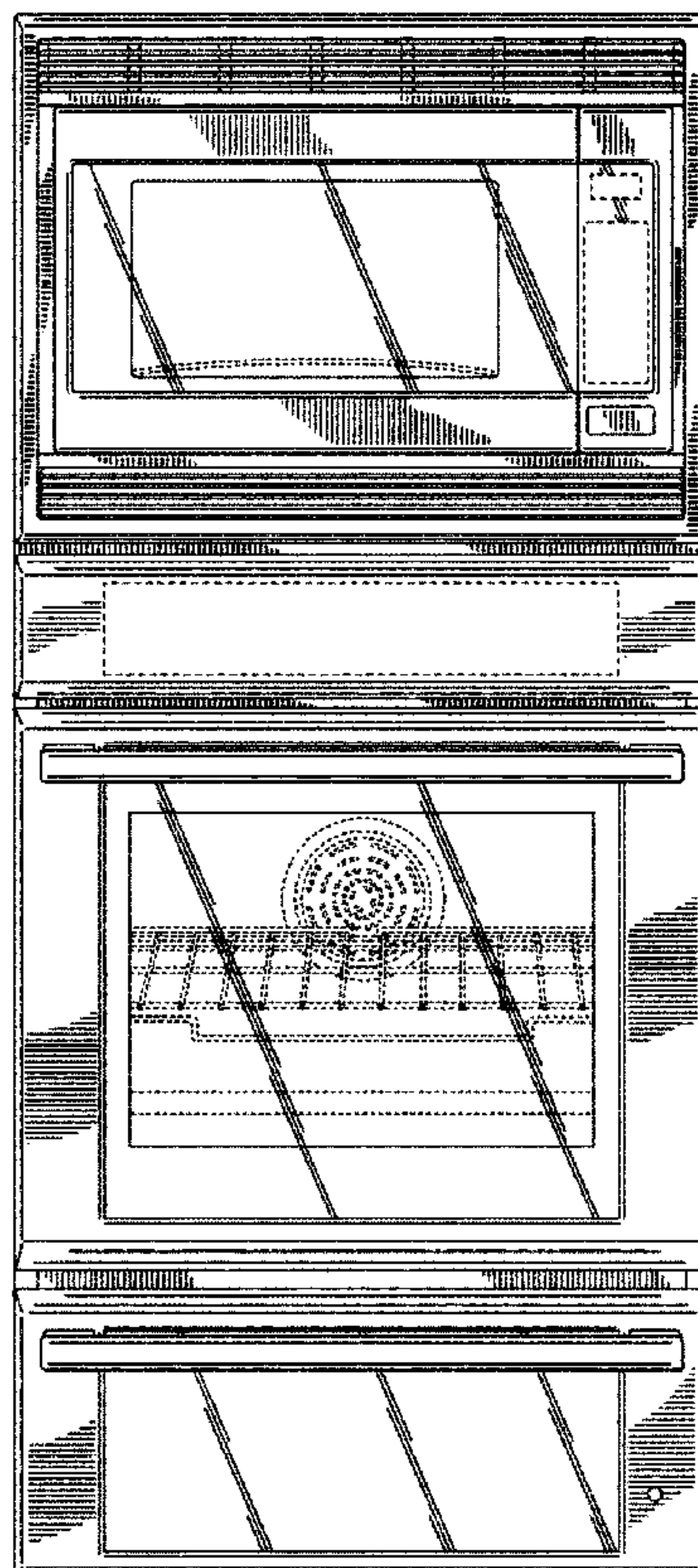
FIG. 2 is a perspective view thereof;

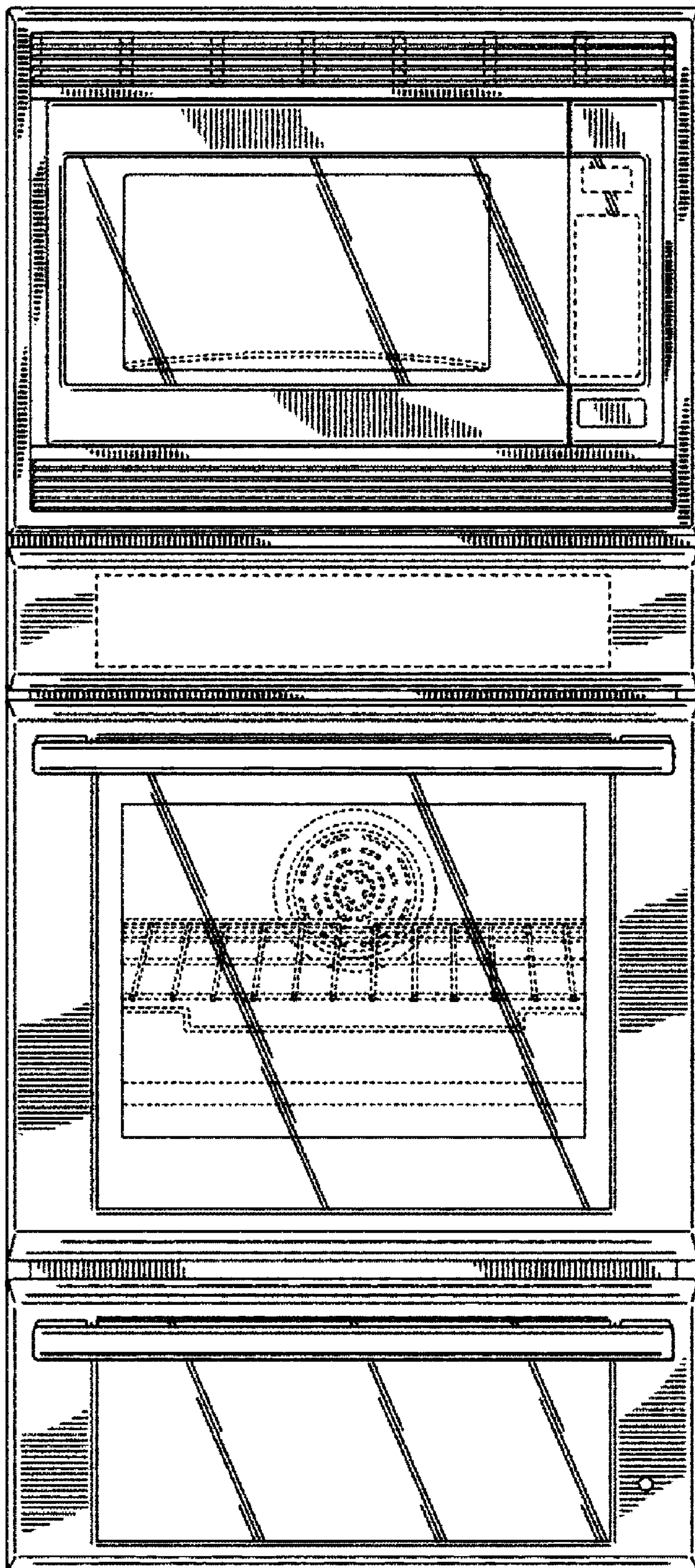

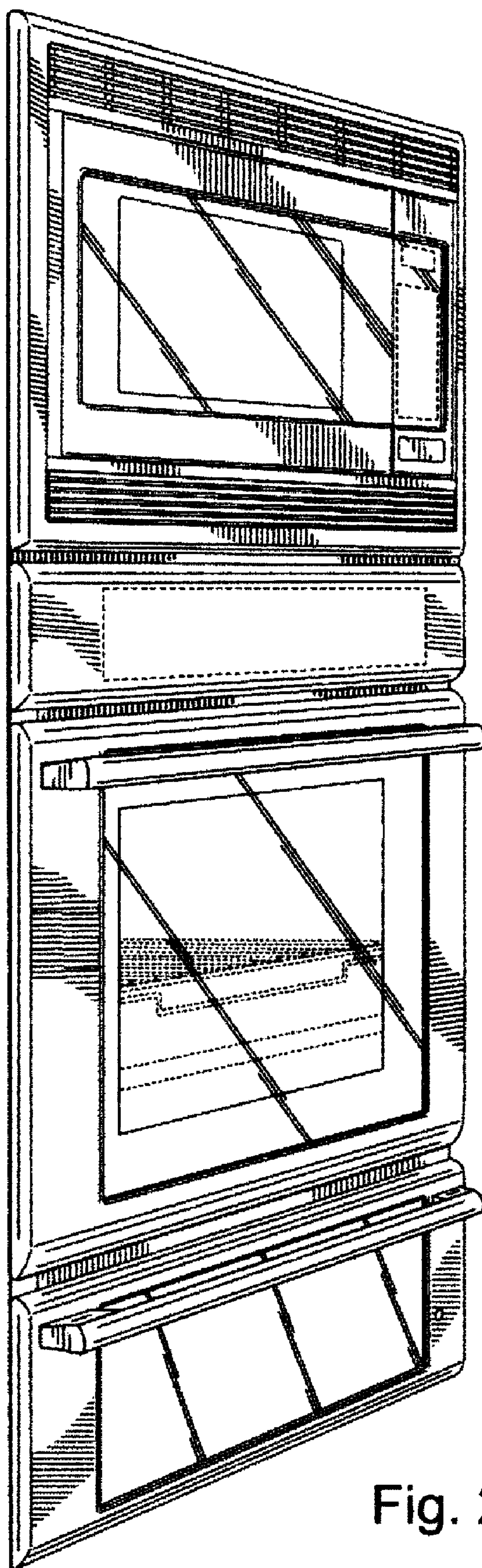

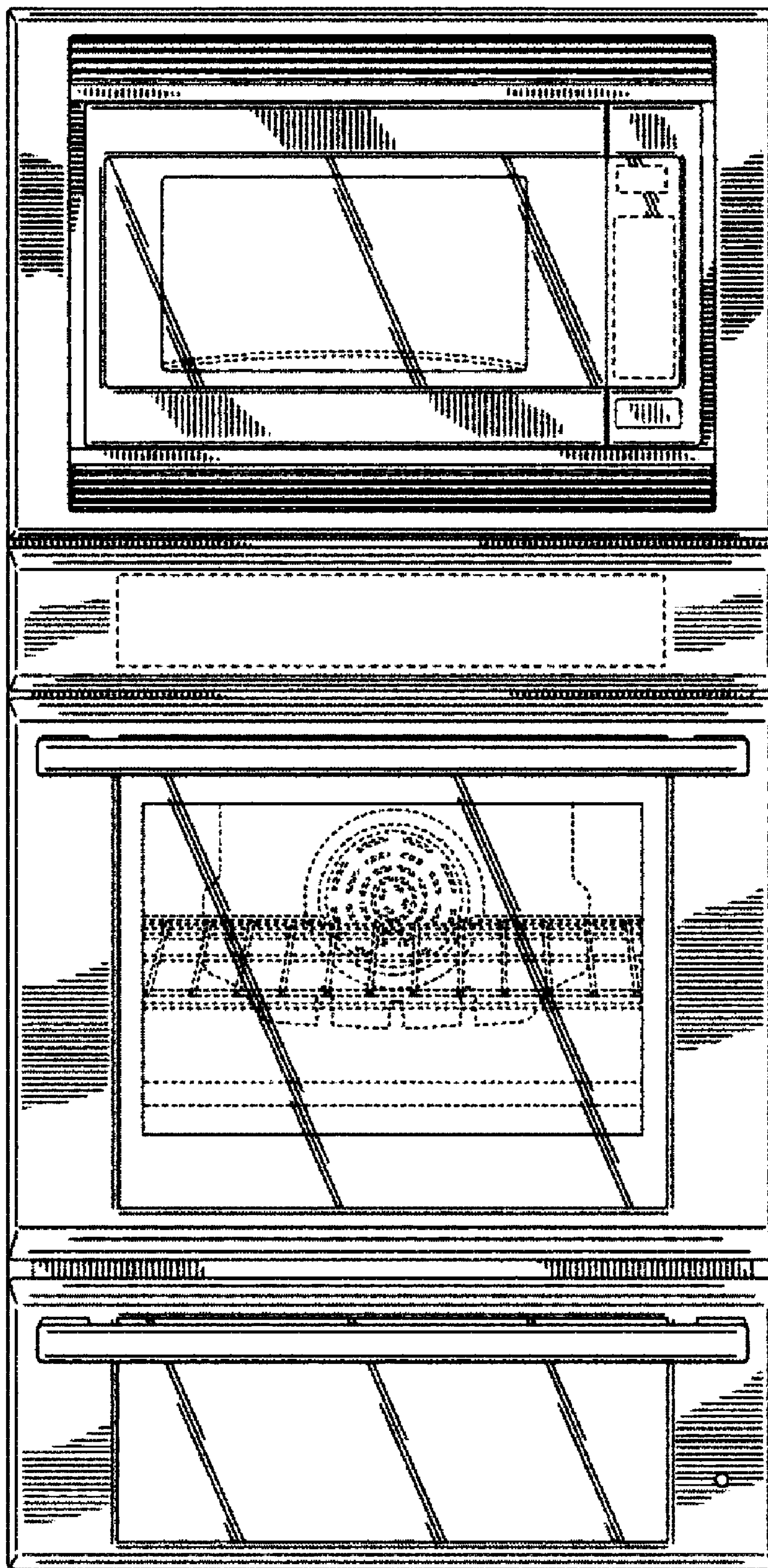

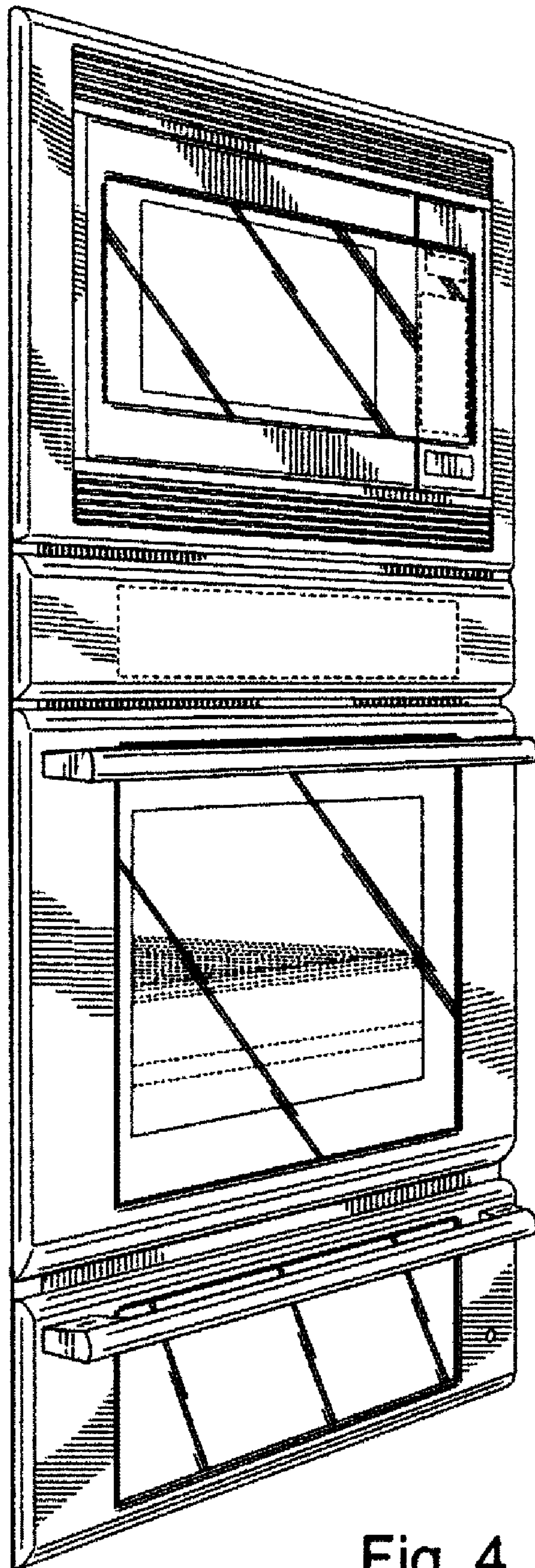
