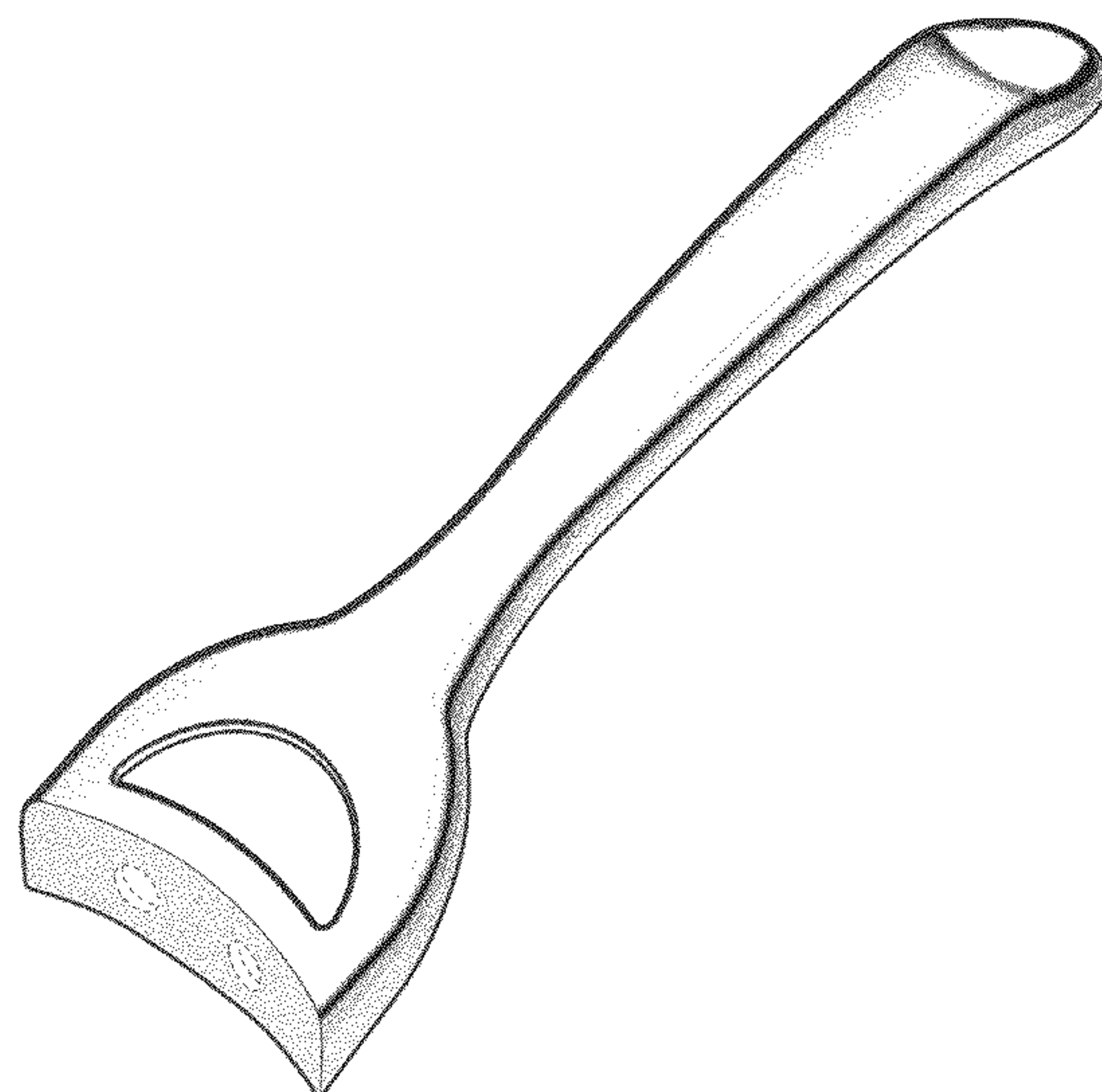
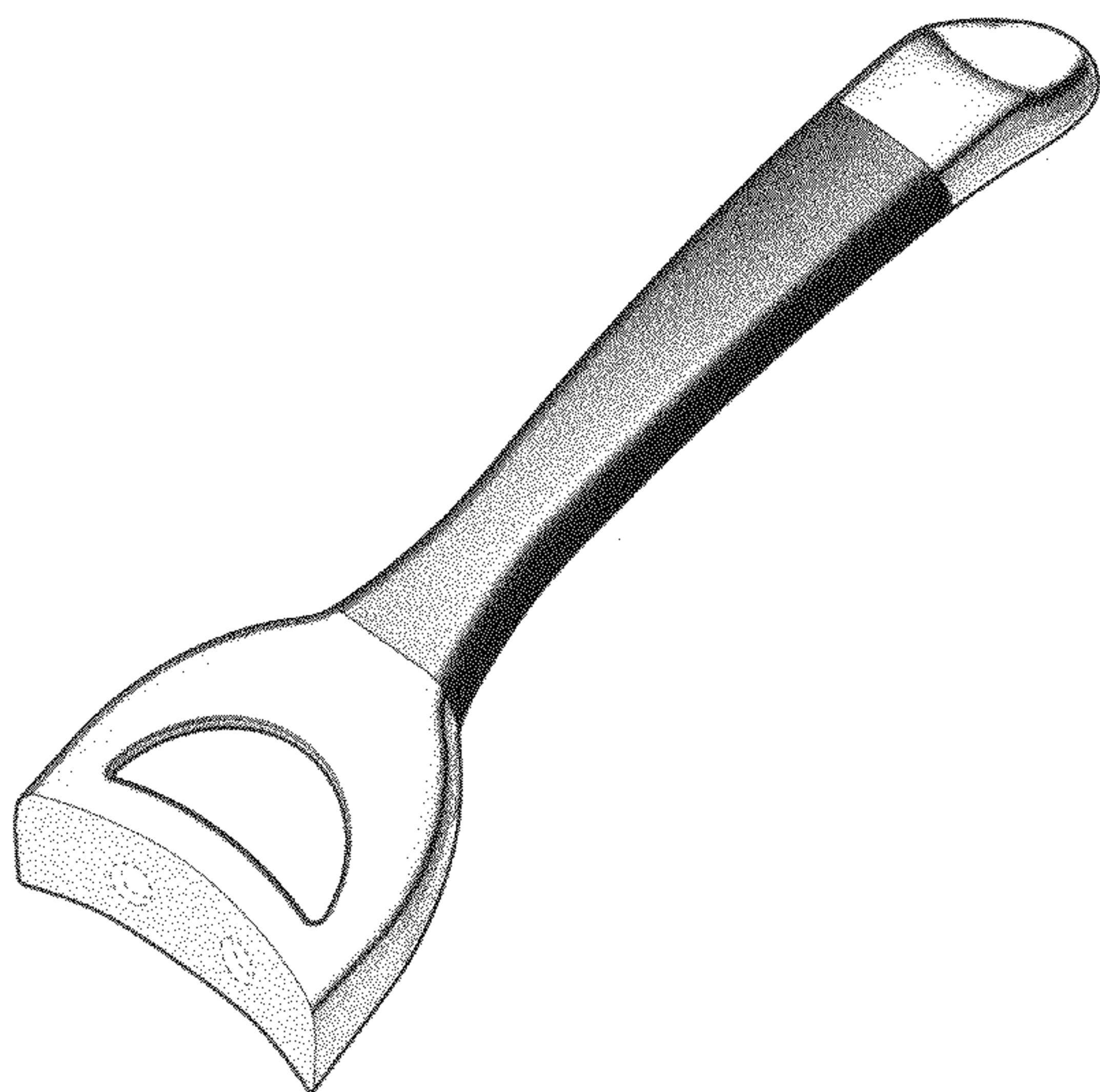
(57) **CLAIM**

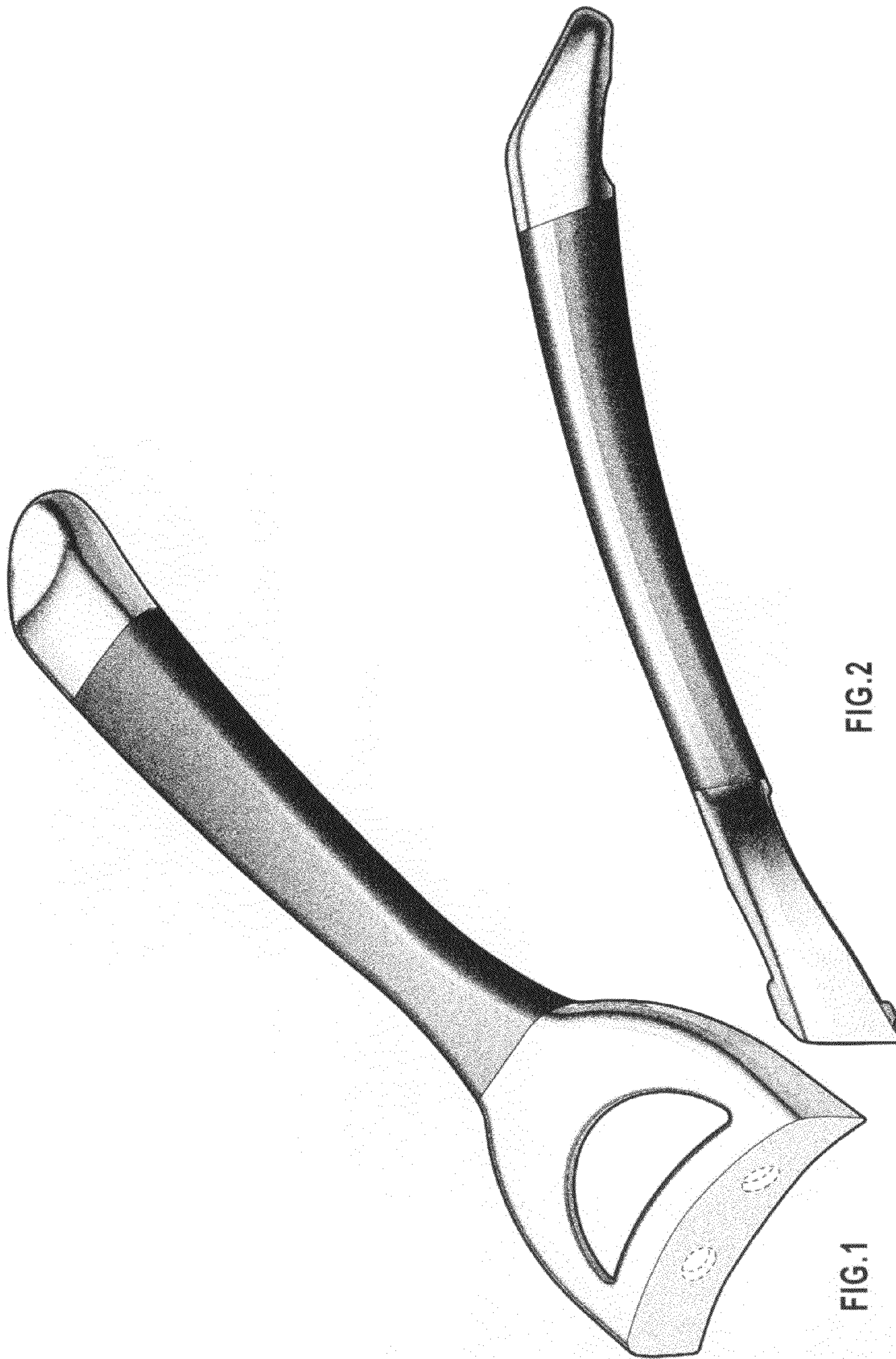
The ornamental design for a “extending cookware handle with open end cavity,” as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the “extending cookware handle with open end cavity” showing my new design; FIG. 2 is a right side elevation view thereof, the left side elevational view thereof, the left side elevation view being a mirror image thereof thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a front elevation thereof; FIG. 6 is a back elevation view thereof; FIG. 7 is a partial cross-sectional view of the terminal portion of the handle taken along the line 7-7 from FIG. 3; FIG. 8 is a perspective view of a second embodiment of the “extending cookware handle with open end cavity” showing my new design; FIG. 9 is a right elevation view thereof, the left side elevational view being a mirror image thereof. FIG. 10 is a top plan view thereof; FIG. 11 is a bottom plan view thereof; FIG. 12 is a front elevation thereof; FIG. 13 is a back elevation view thereof; and, FIG. 14 is a partial cross-section view of the terminal portion of the handle taken along the line 14-14 from FIG. 10. The broken lines in FIGS. 1,5,6, 8,12 and 13 are for illustrative purposes only, depicting the environment of the new design, forming no part thereof as claimed.

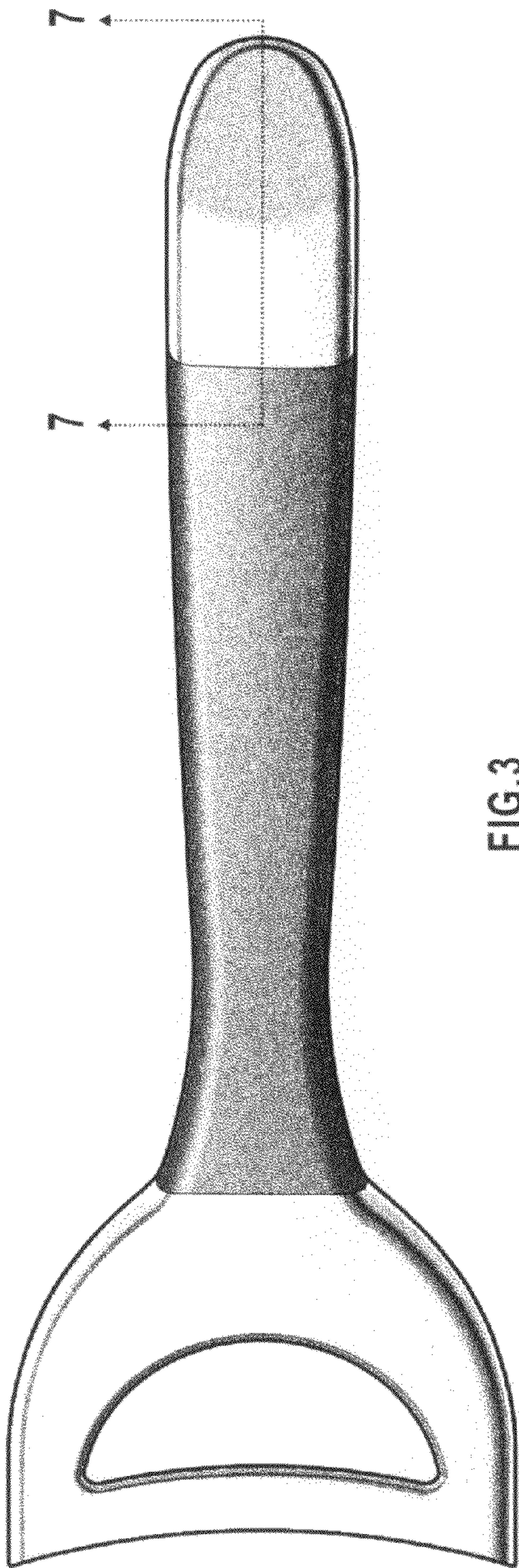

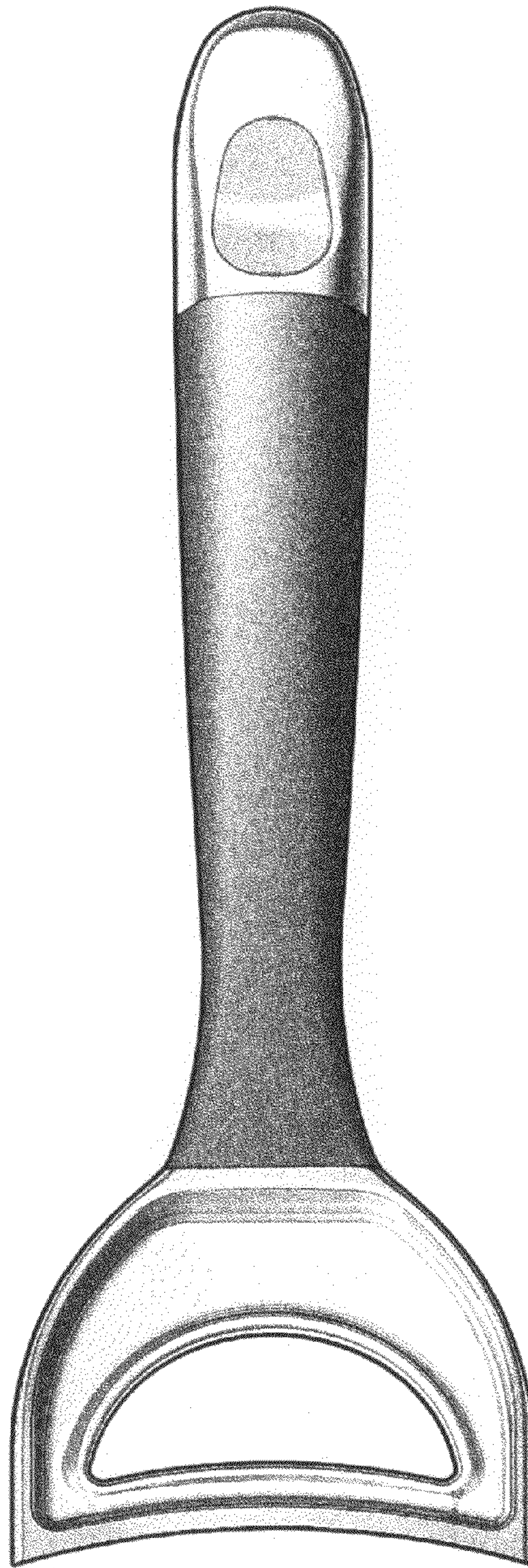

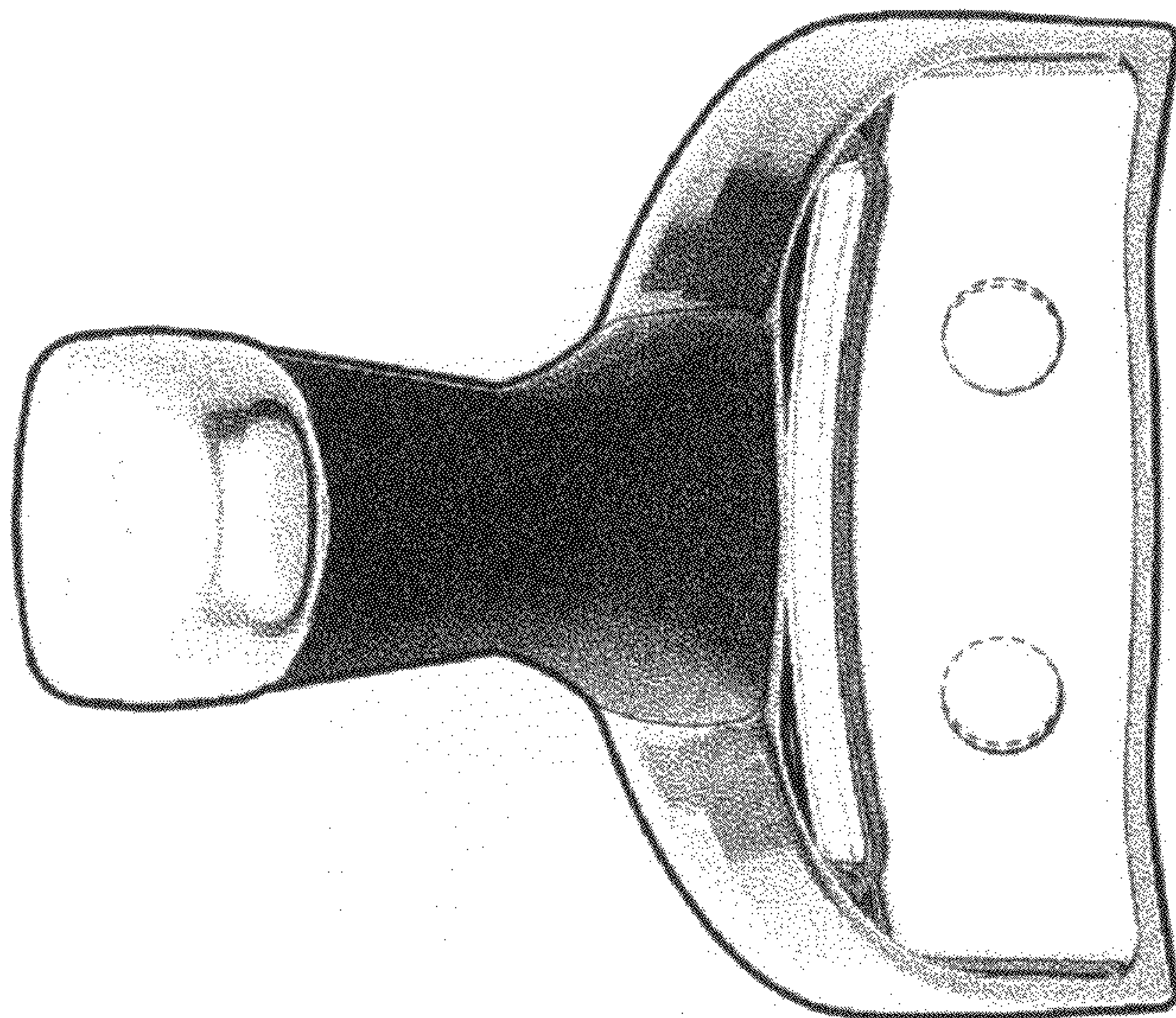

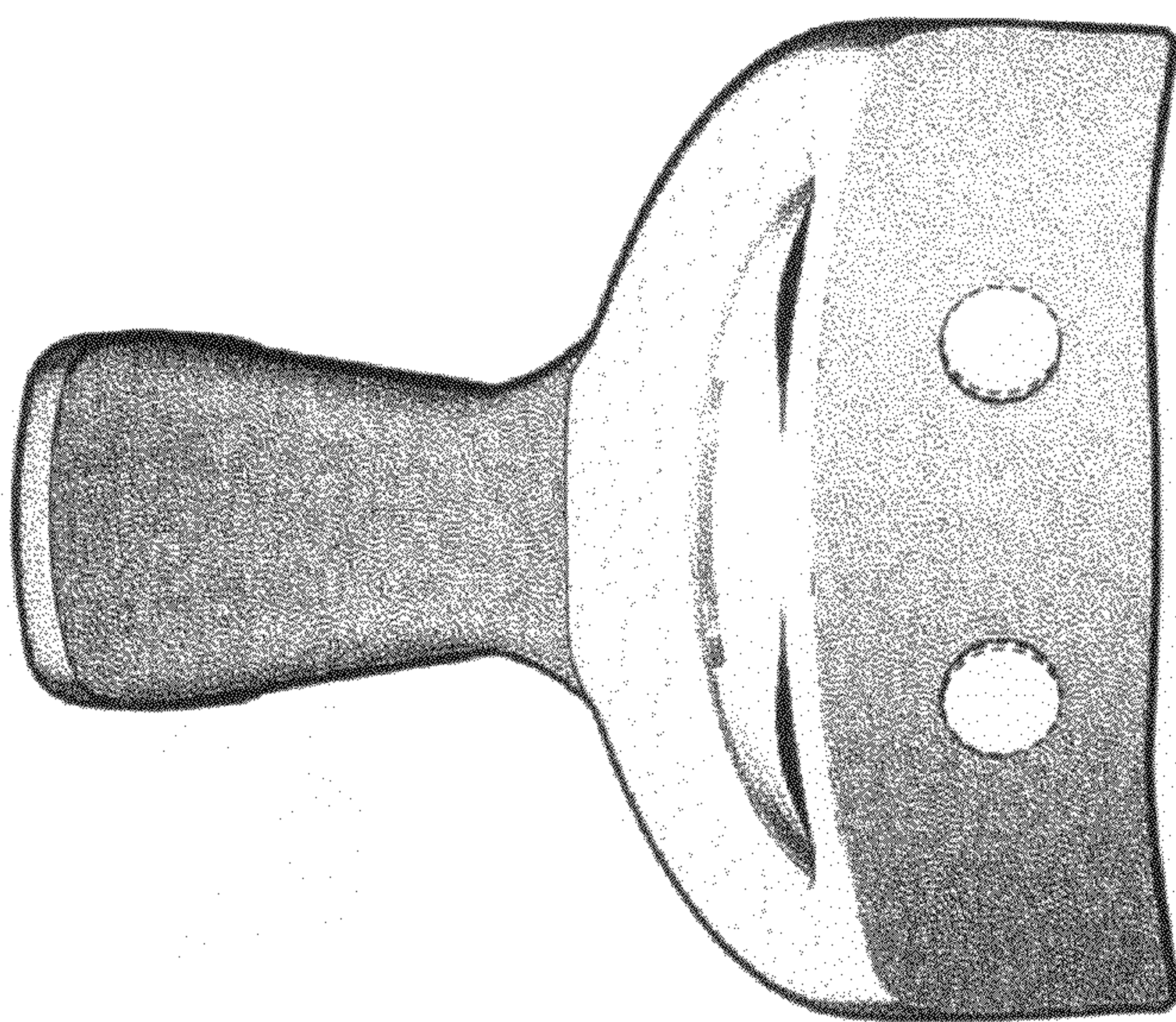

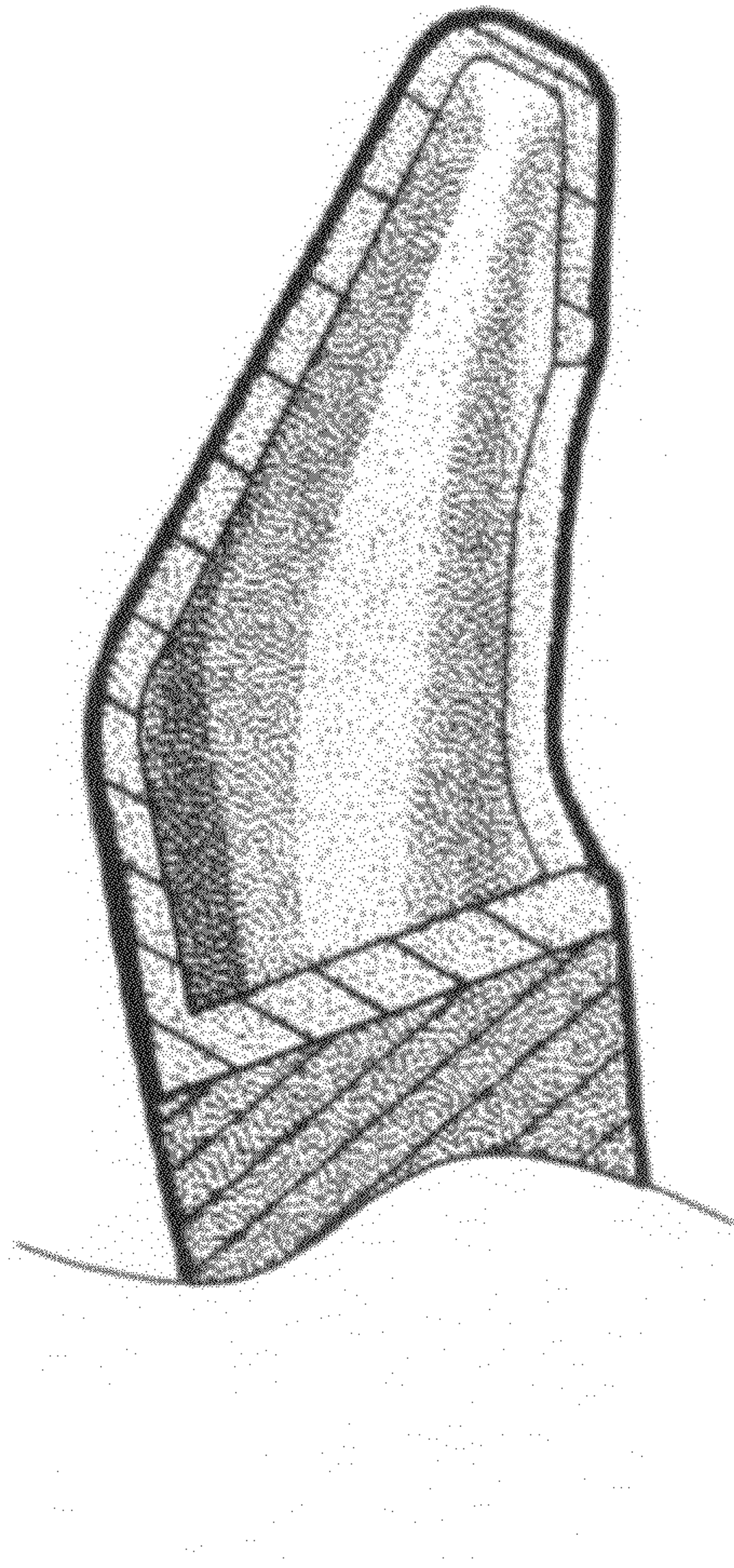

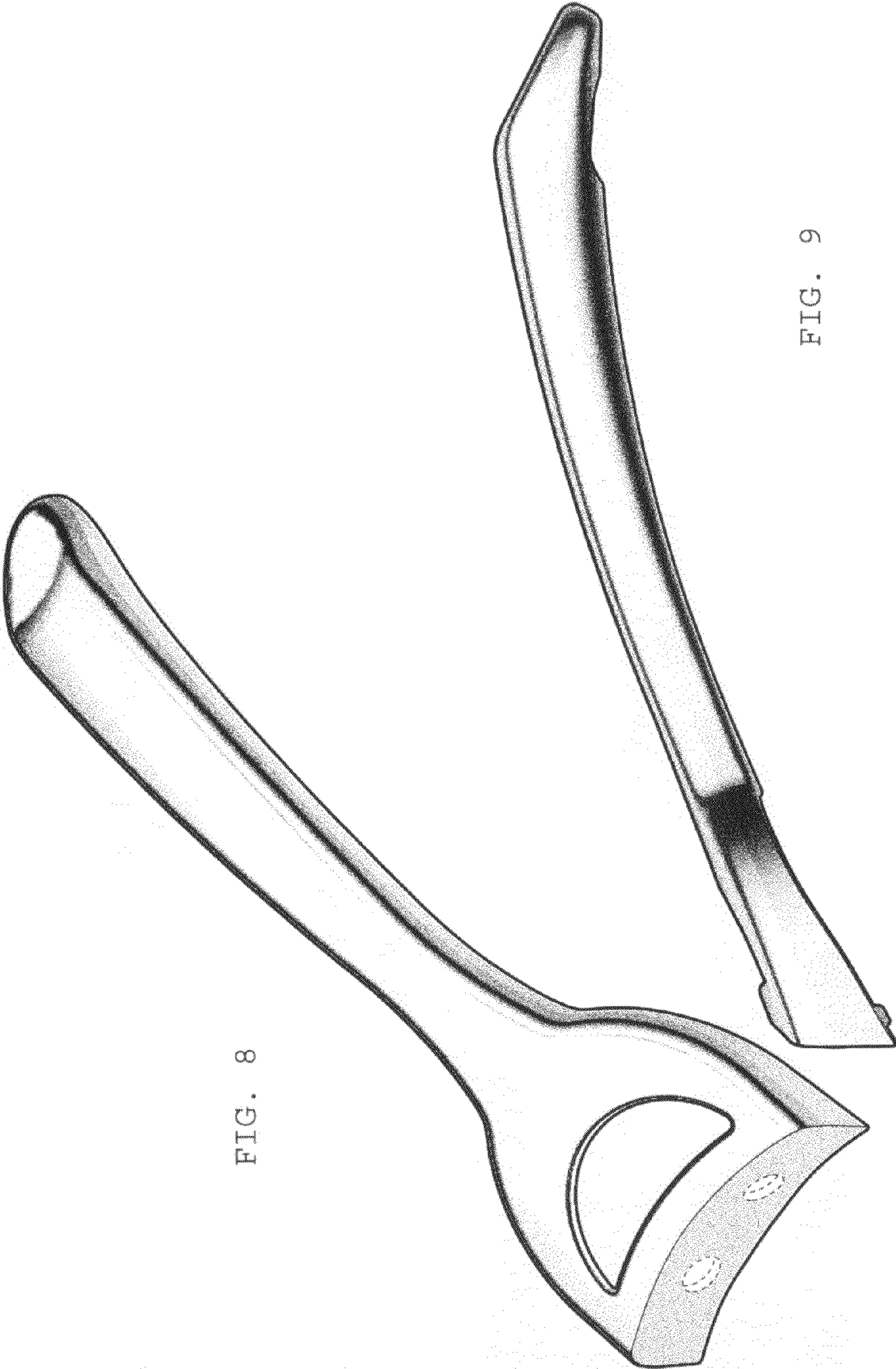
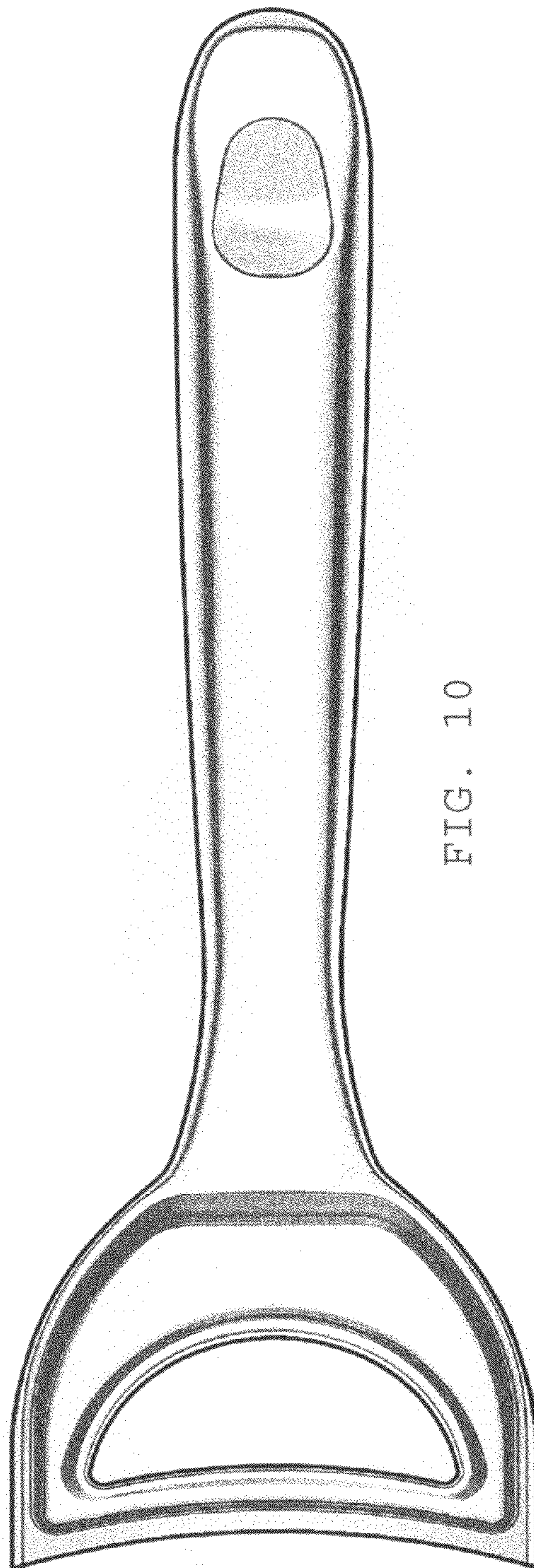
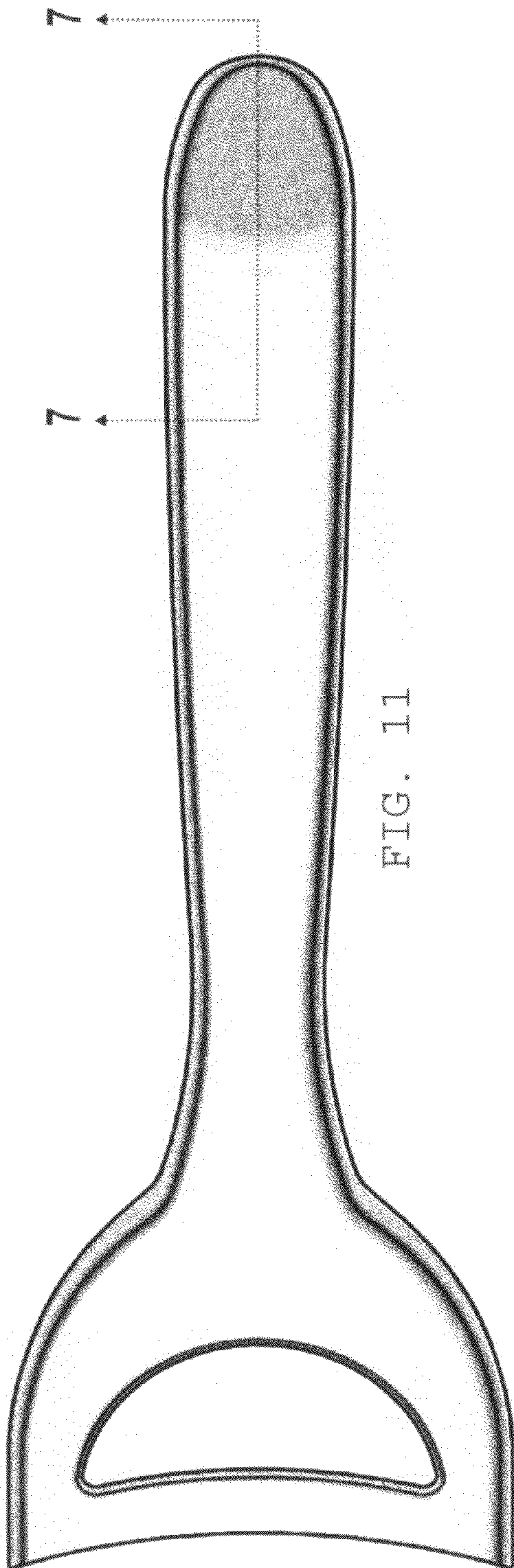

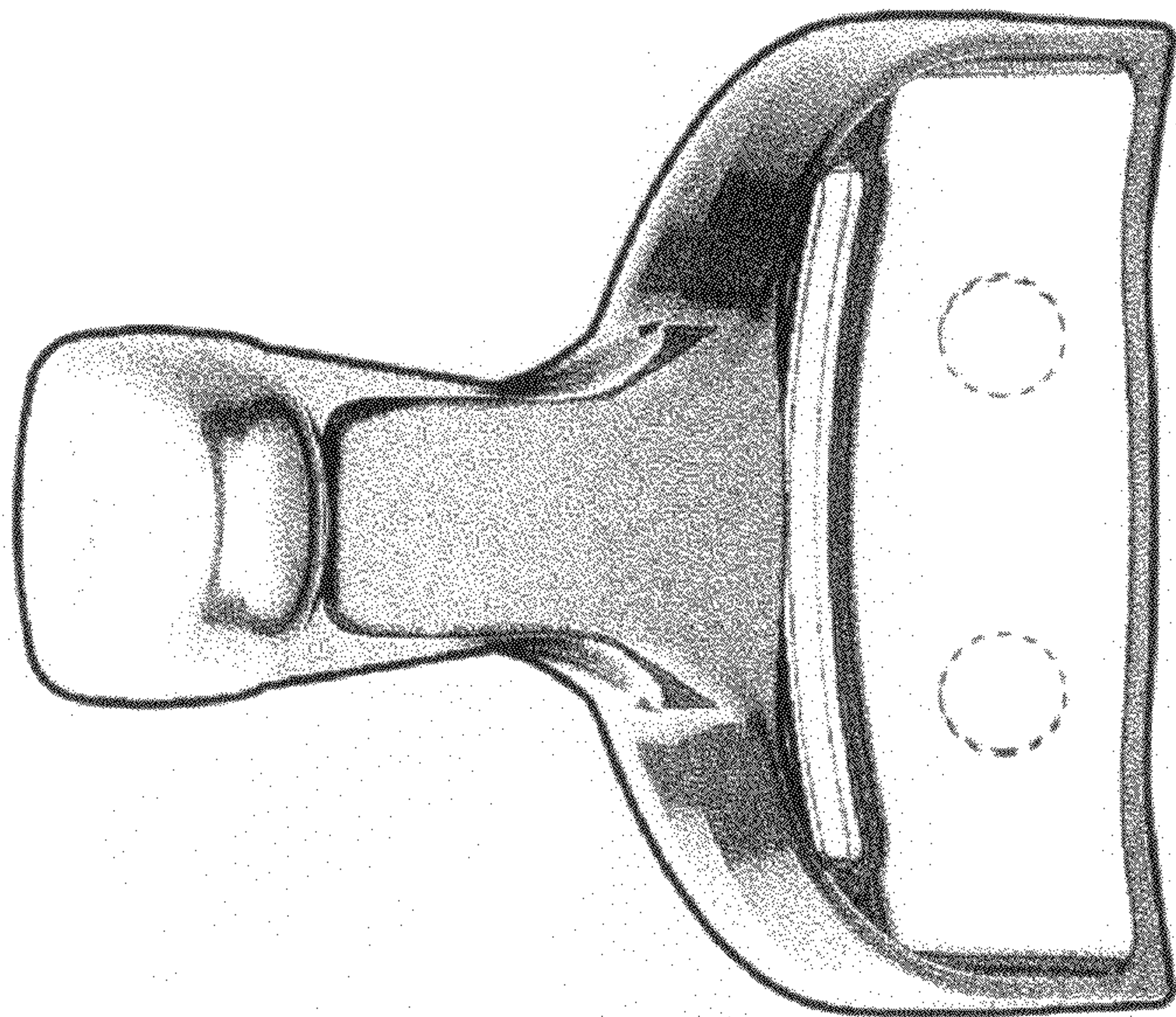

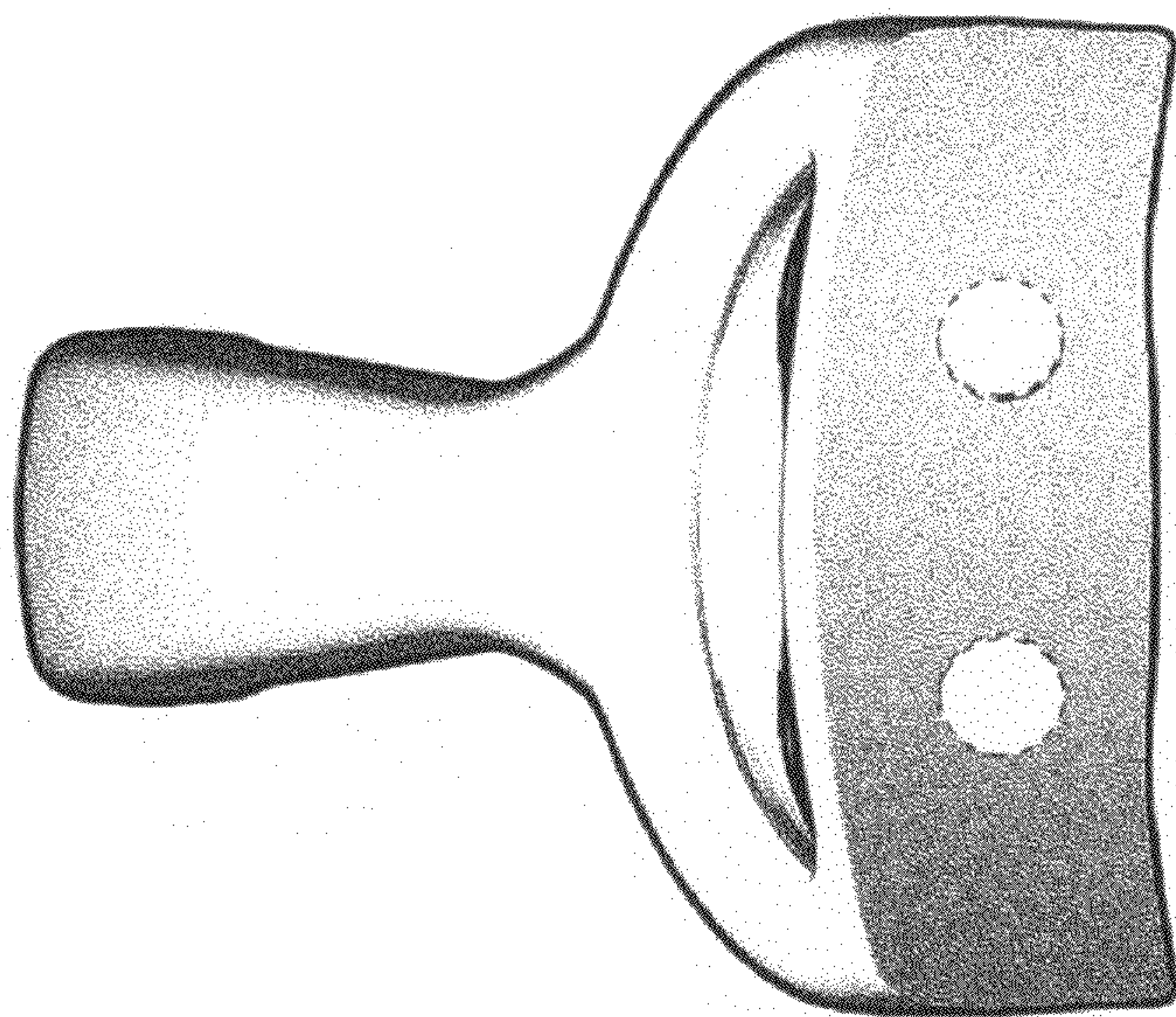
