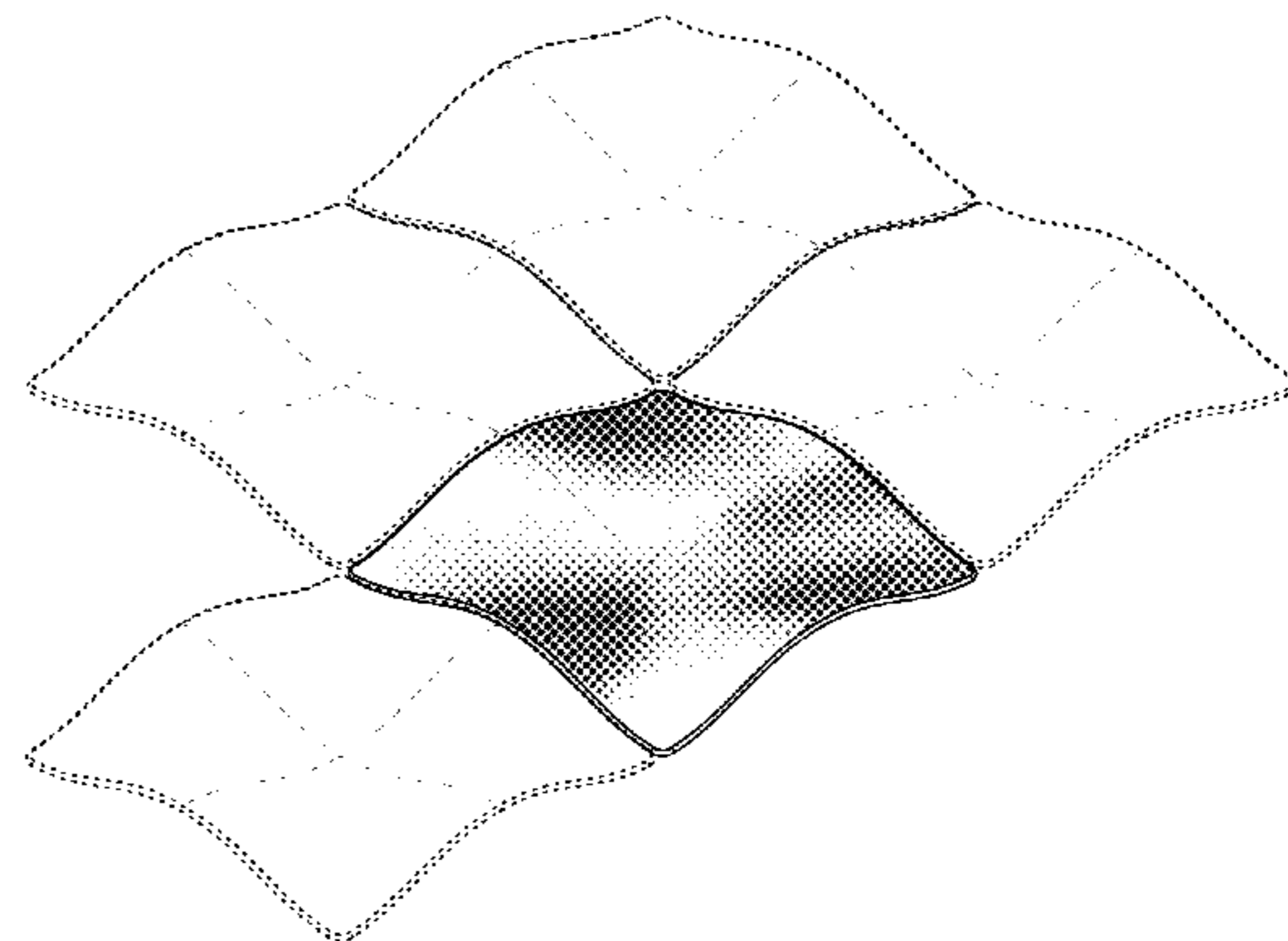
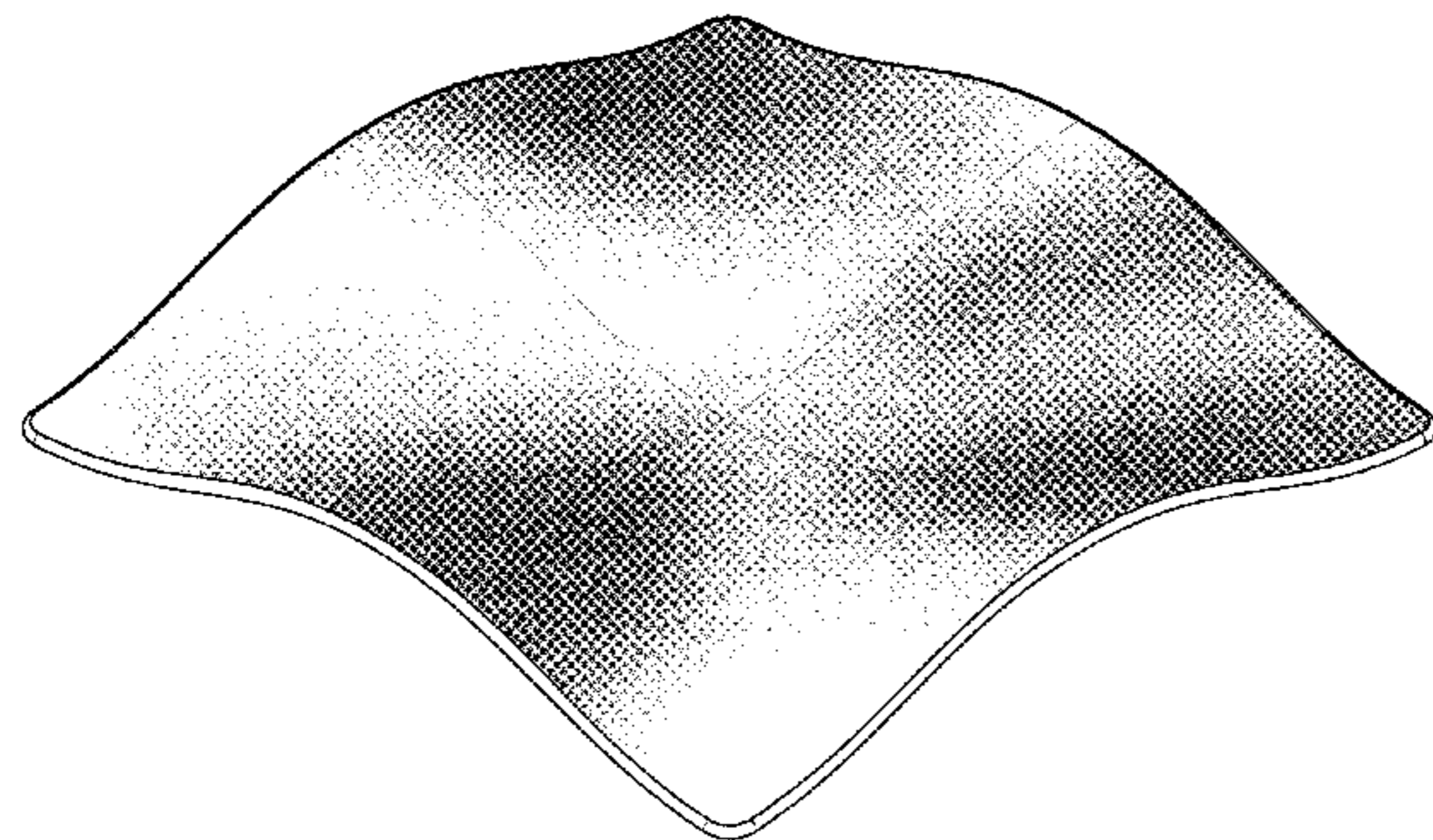
(57) **CLAIM**

I claim the ornamental design for a wave modular tableware tile, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the wave modular tableware tile embodying the present invention;  
FIG. 2 is a bottom perspective view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a bottom view thereof;

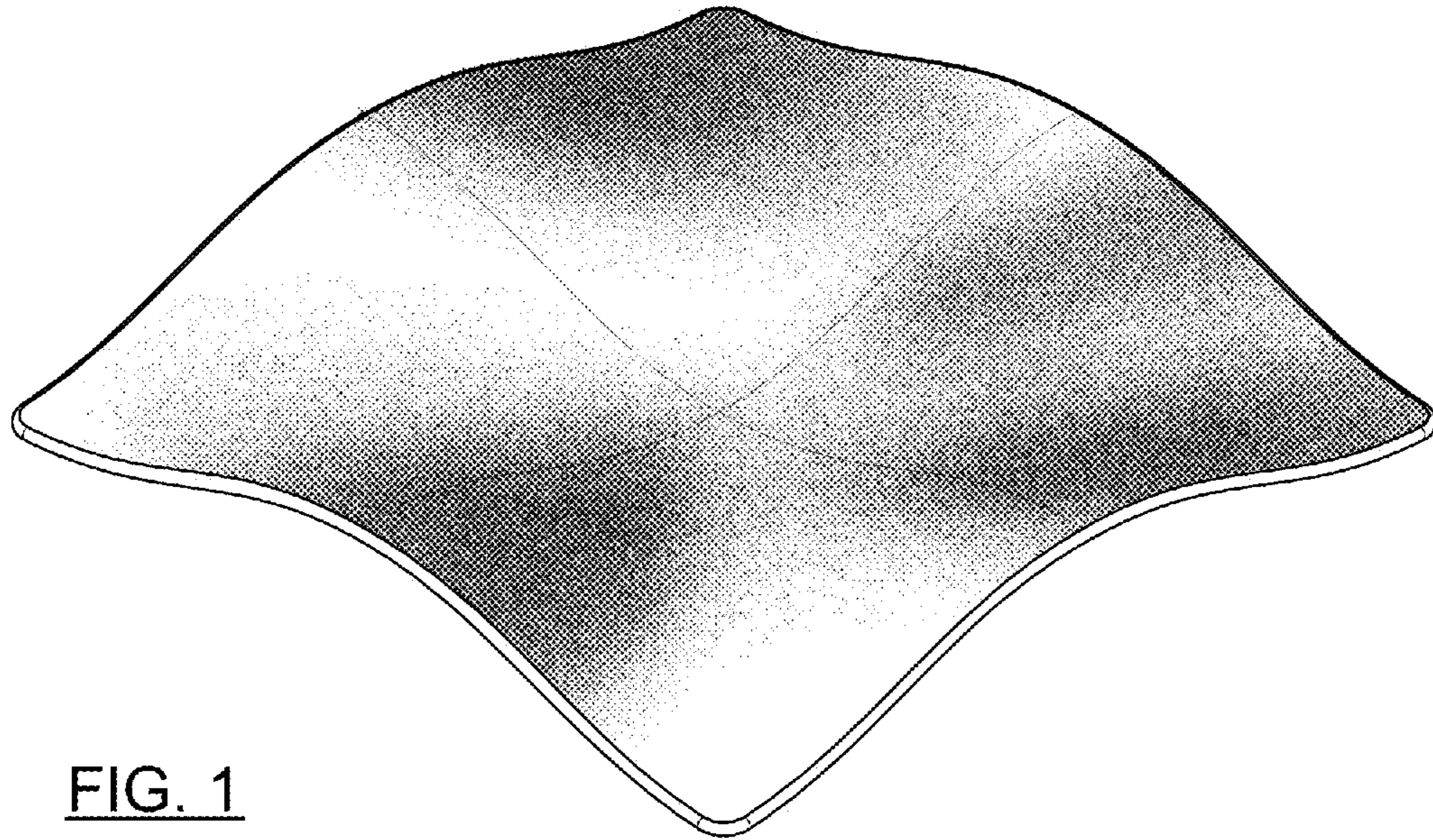

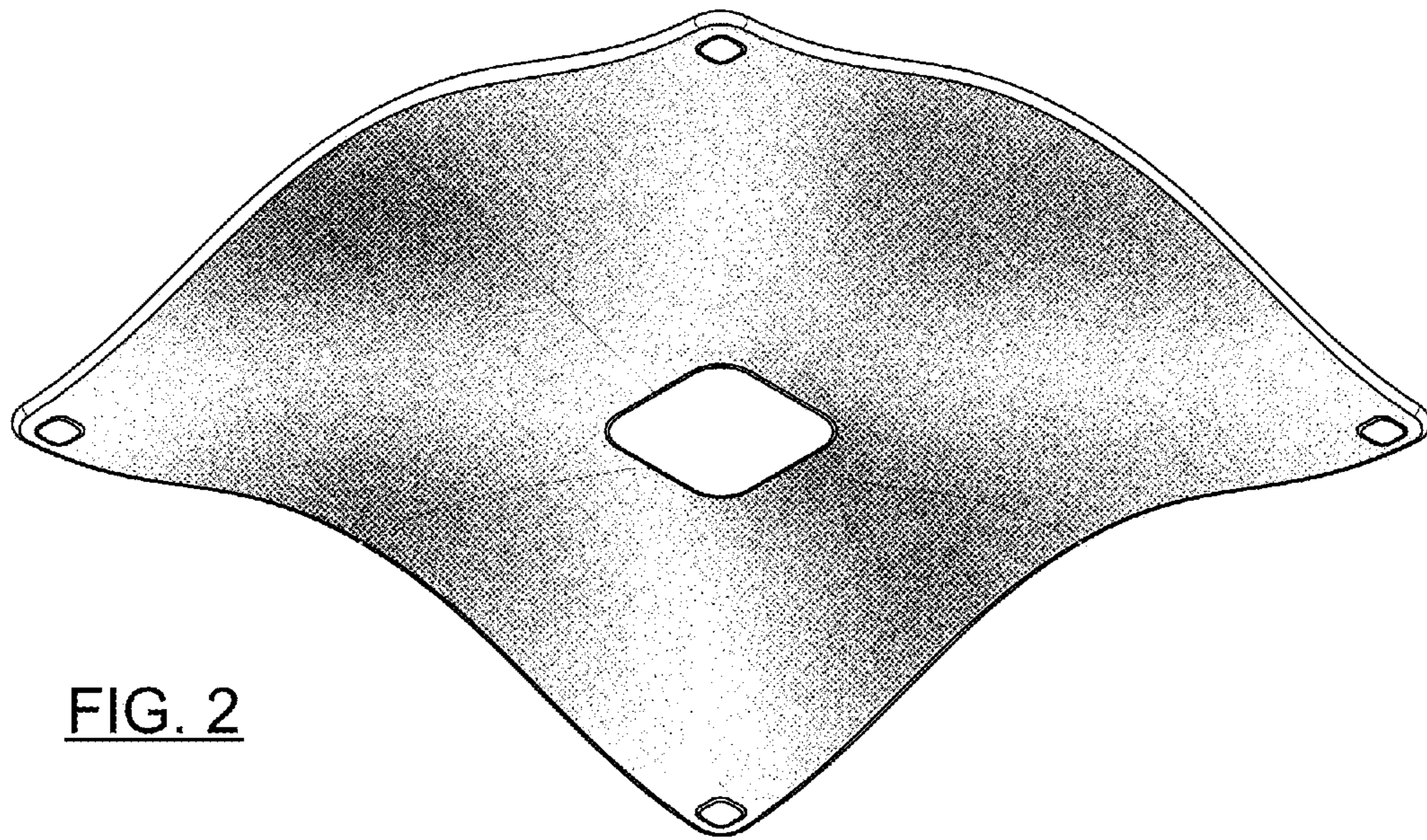

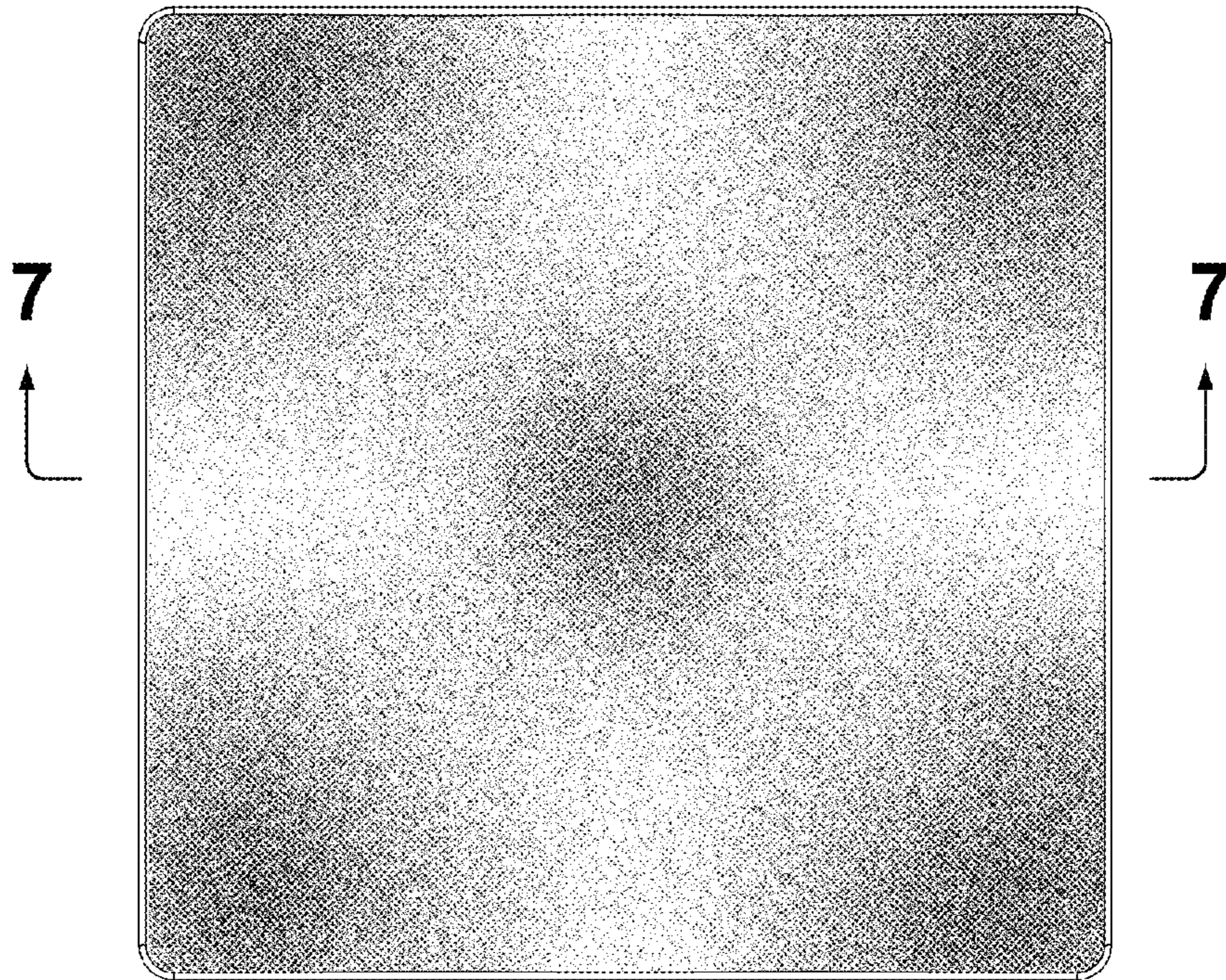

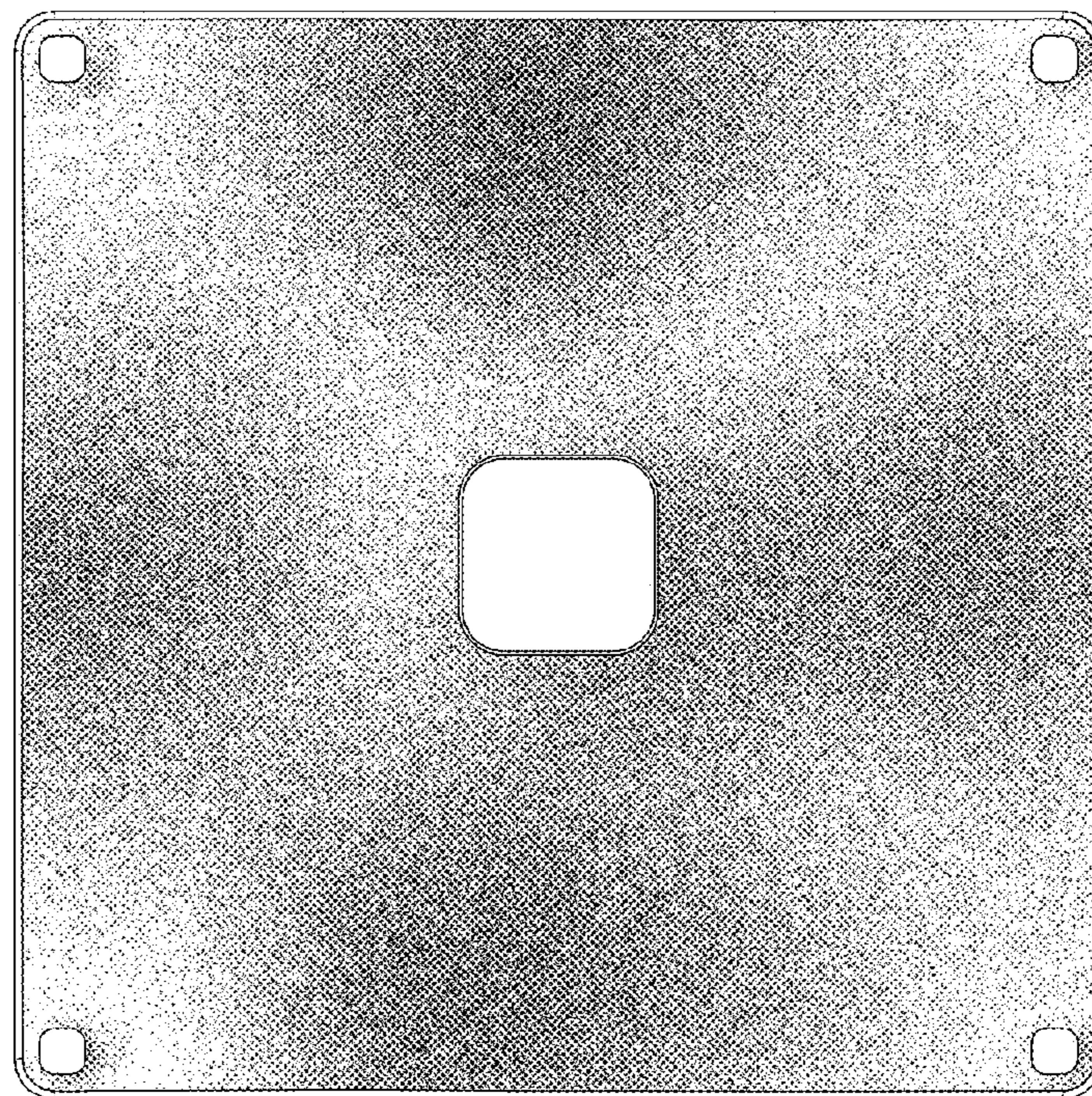

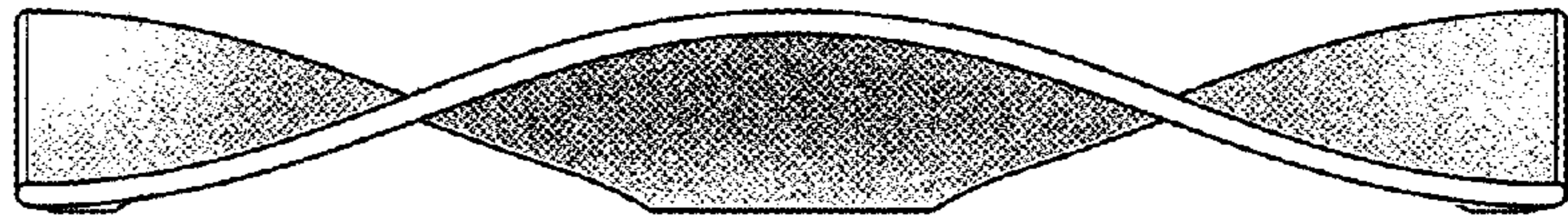

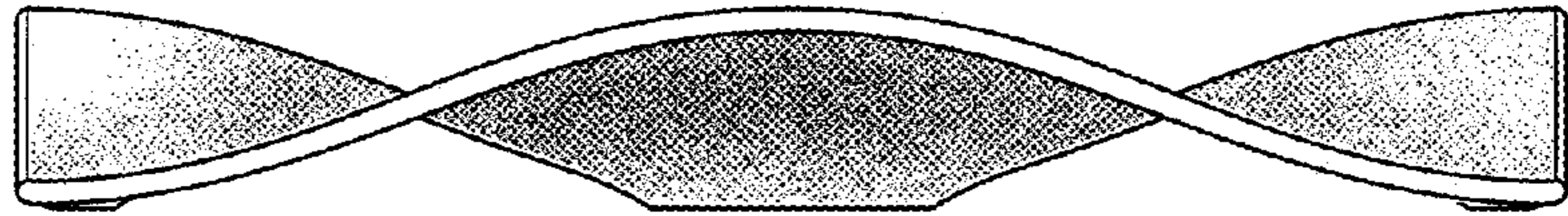
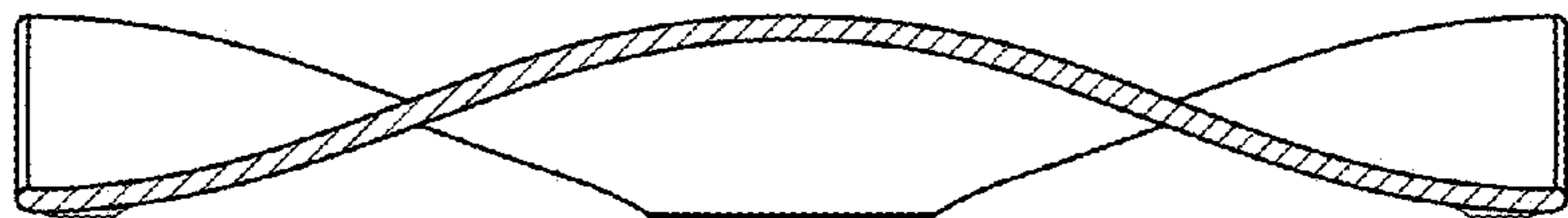

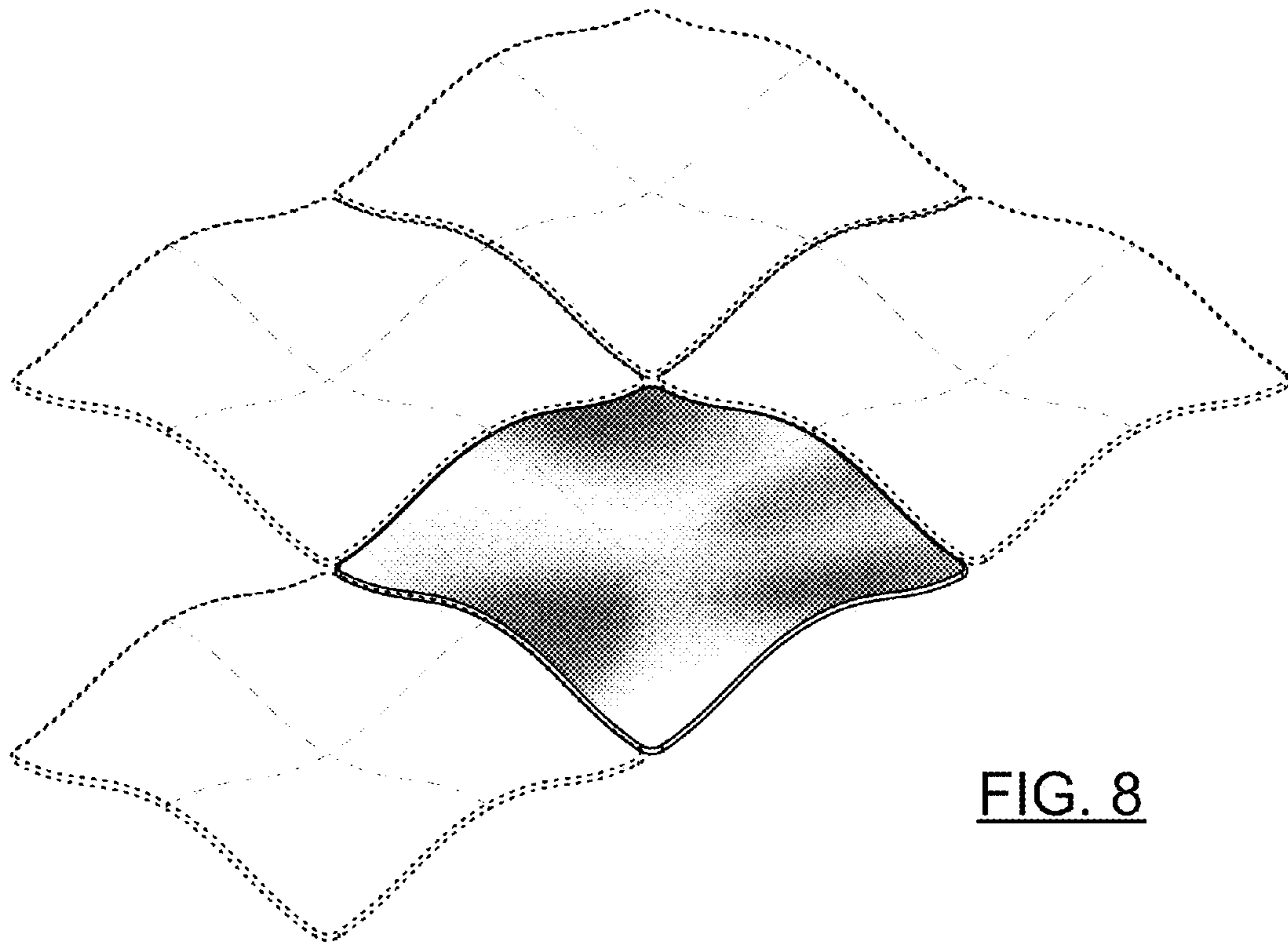
