(57) **CLAIM**

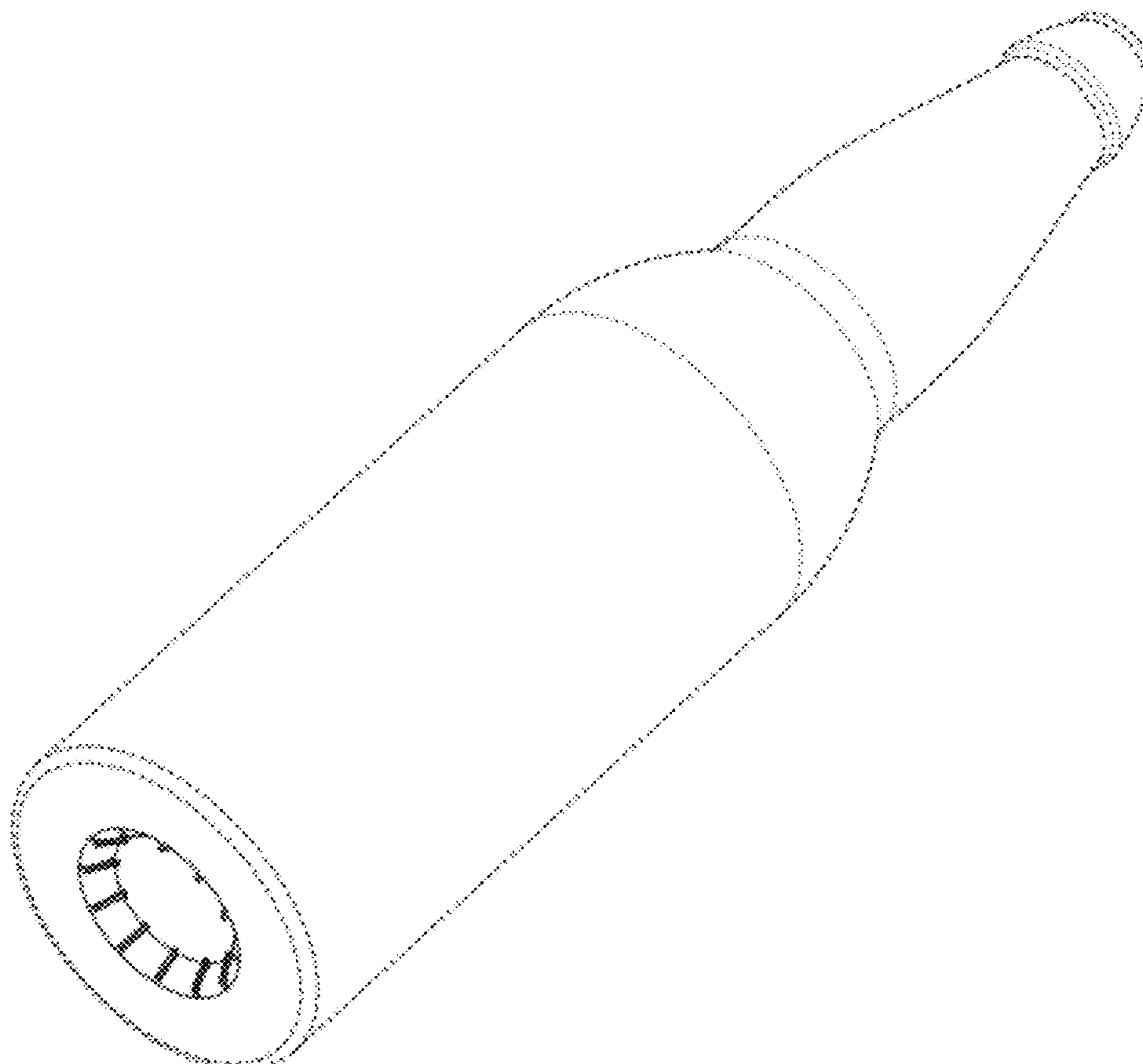
The ornamental design for a bottle opener, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a bottle opener; FIG. 2 is a alternate perspective view thereof; FIG. 3 is a slightly angled perspective view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a front elevational view thereof; and, FIG. 6 is a cross-sectional view thereof, taken on line 6-6 of FIG. 5.

The broken line showing of a bottle is for the purpose of illustrating environmental structure and forms no part of the claimed design.

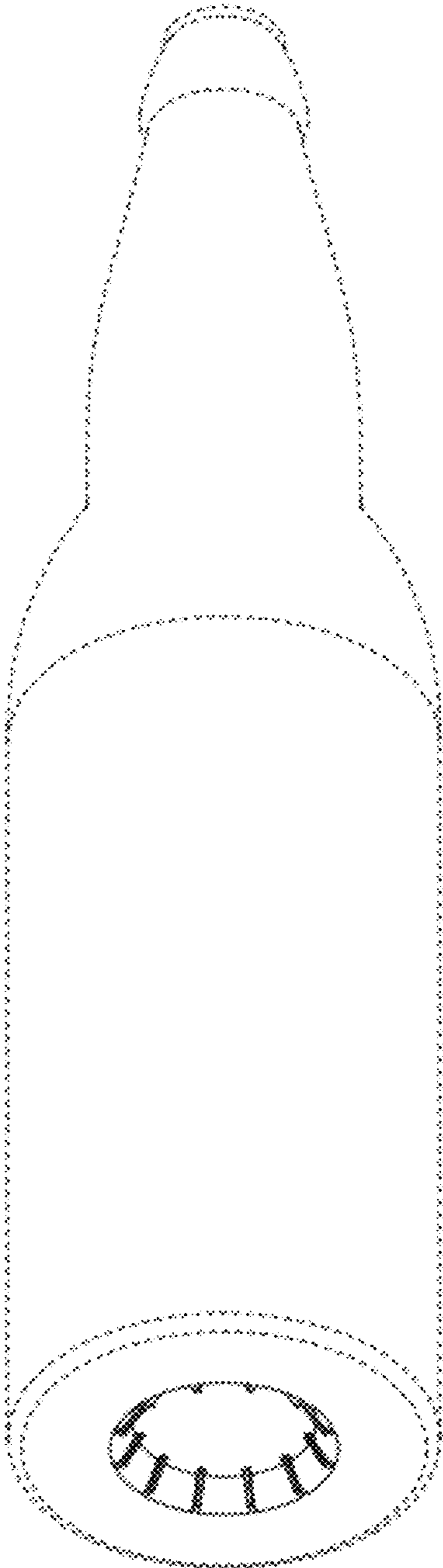

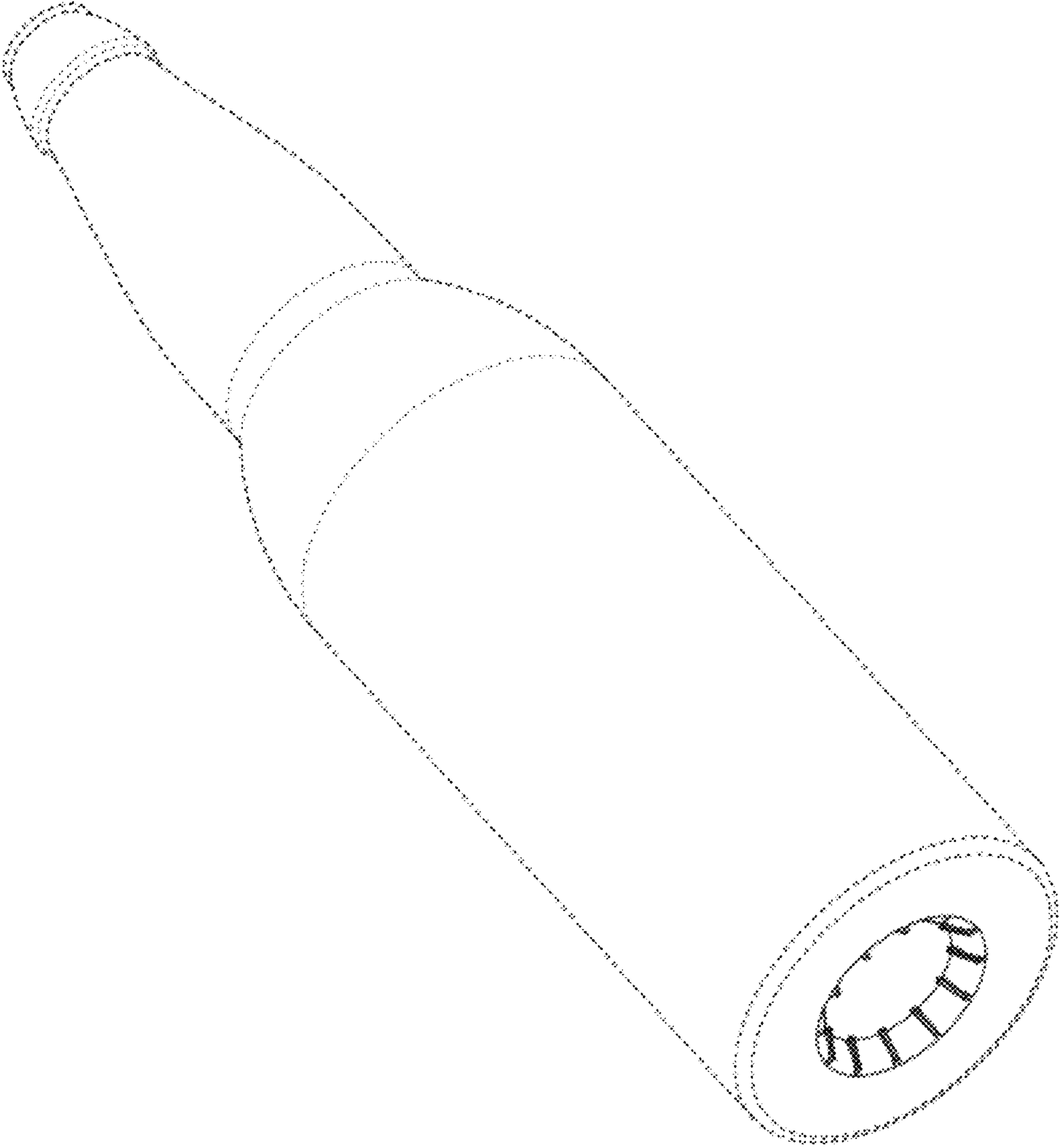

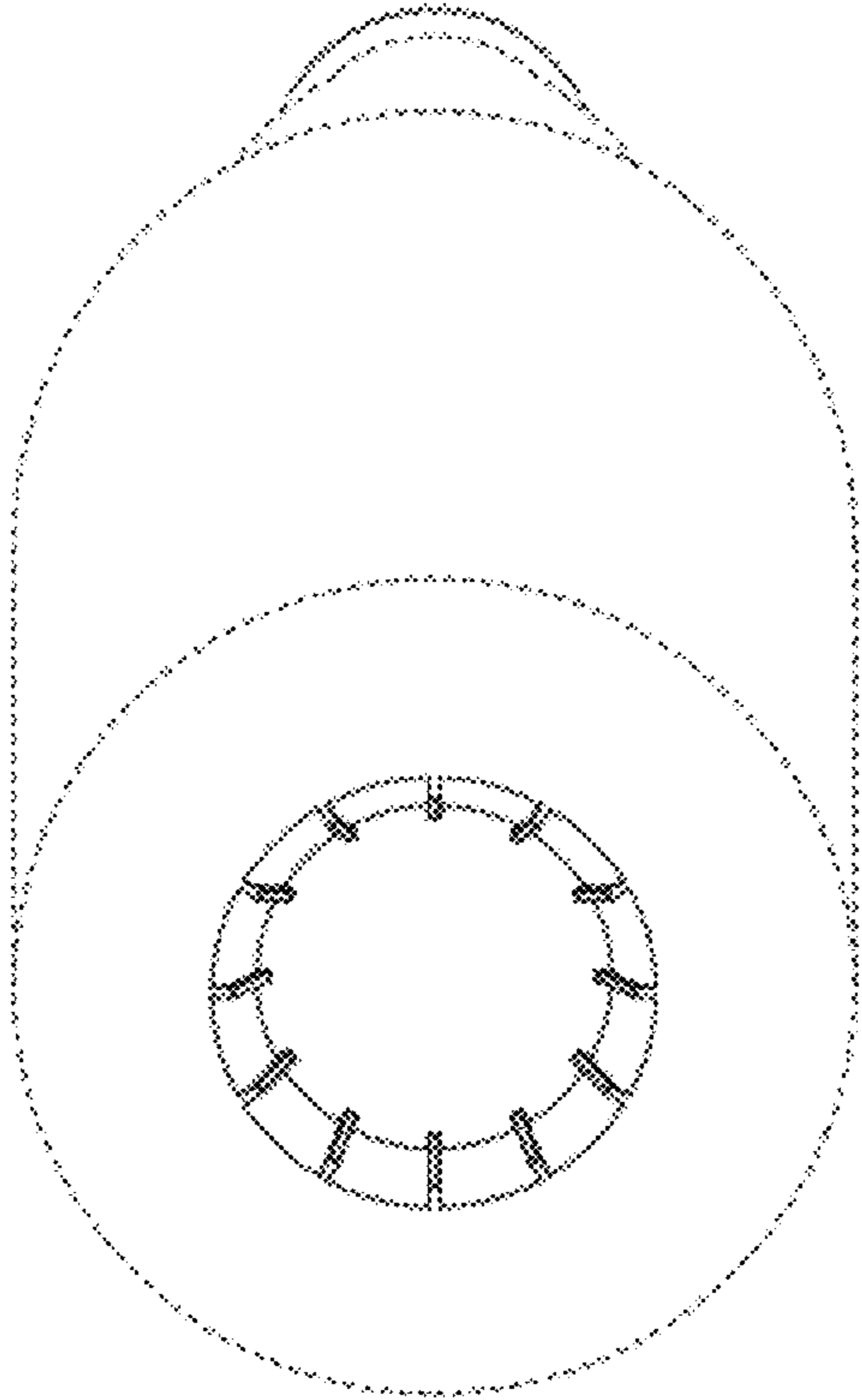

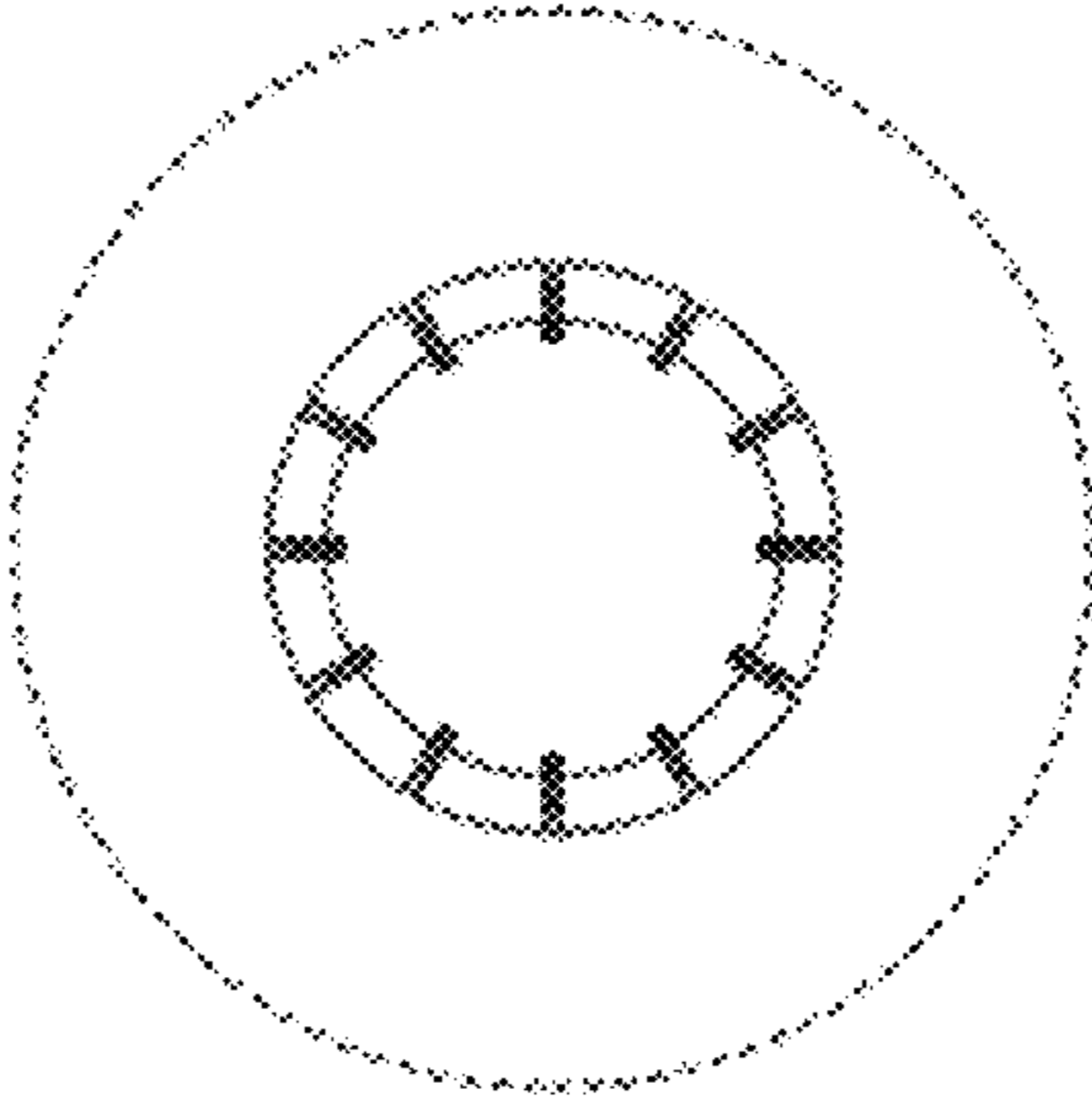

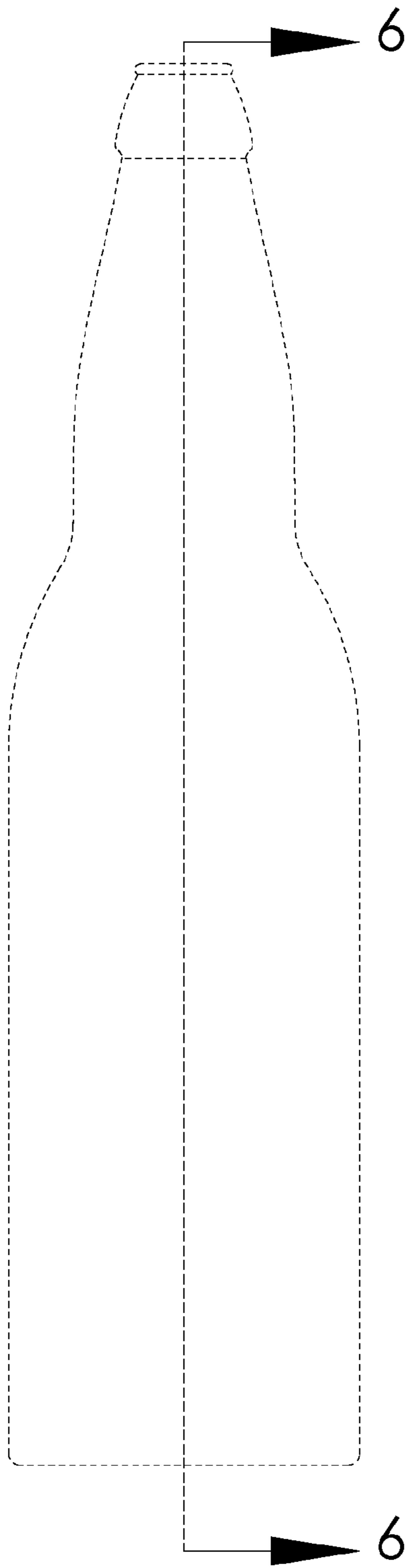

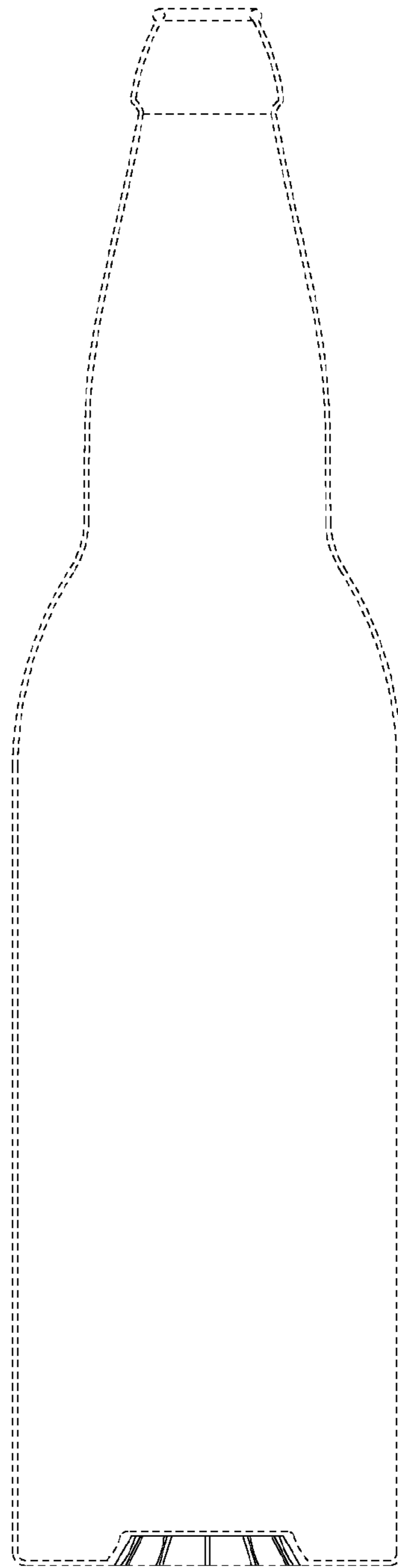
