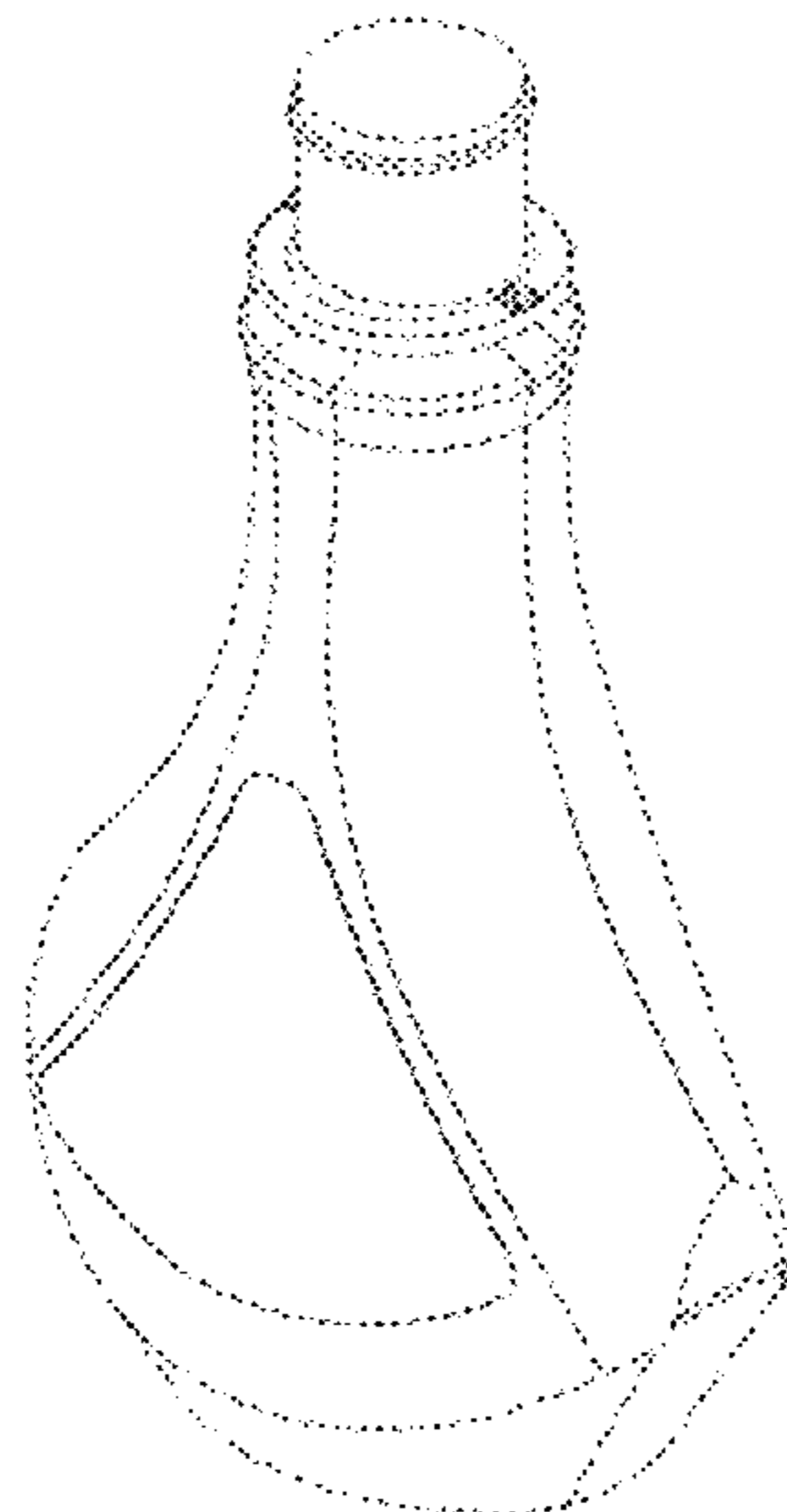
(57) **CLAIM**

The ornamental design for portions of a container and label, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of portions of a bottle container and label incorporating our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIGS. 4 and 5 are side elevational views thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines shown in the drawings depict environmental subject matter only and form no part of the claimed design.

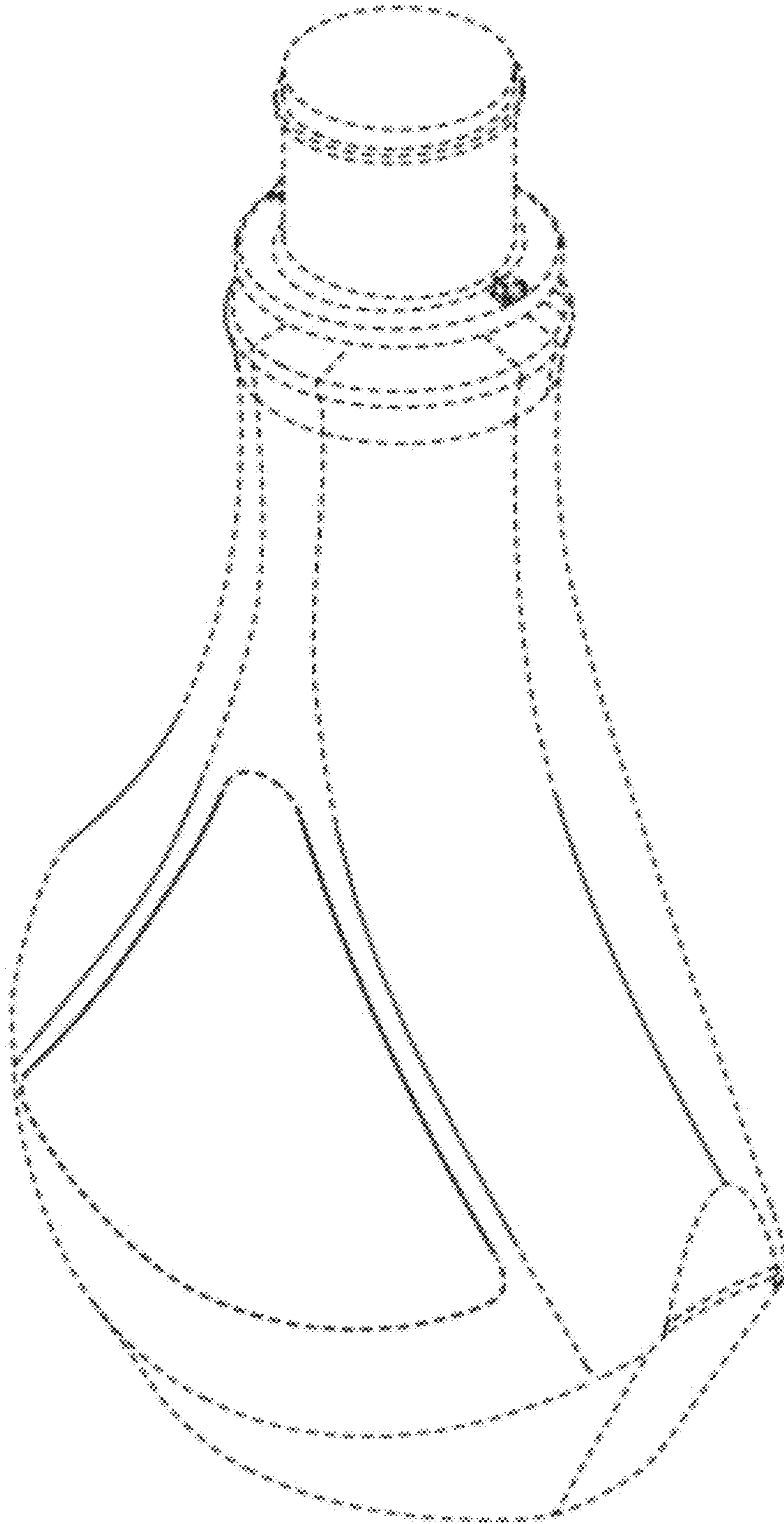

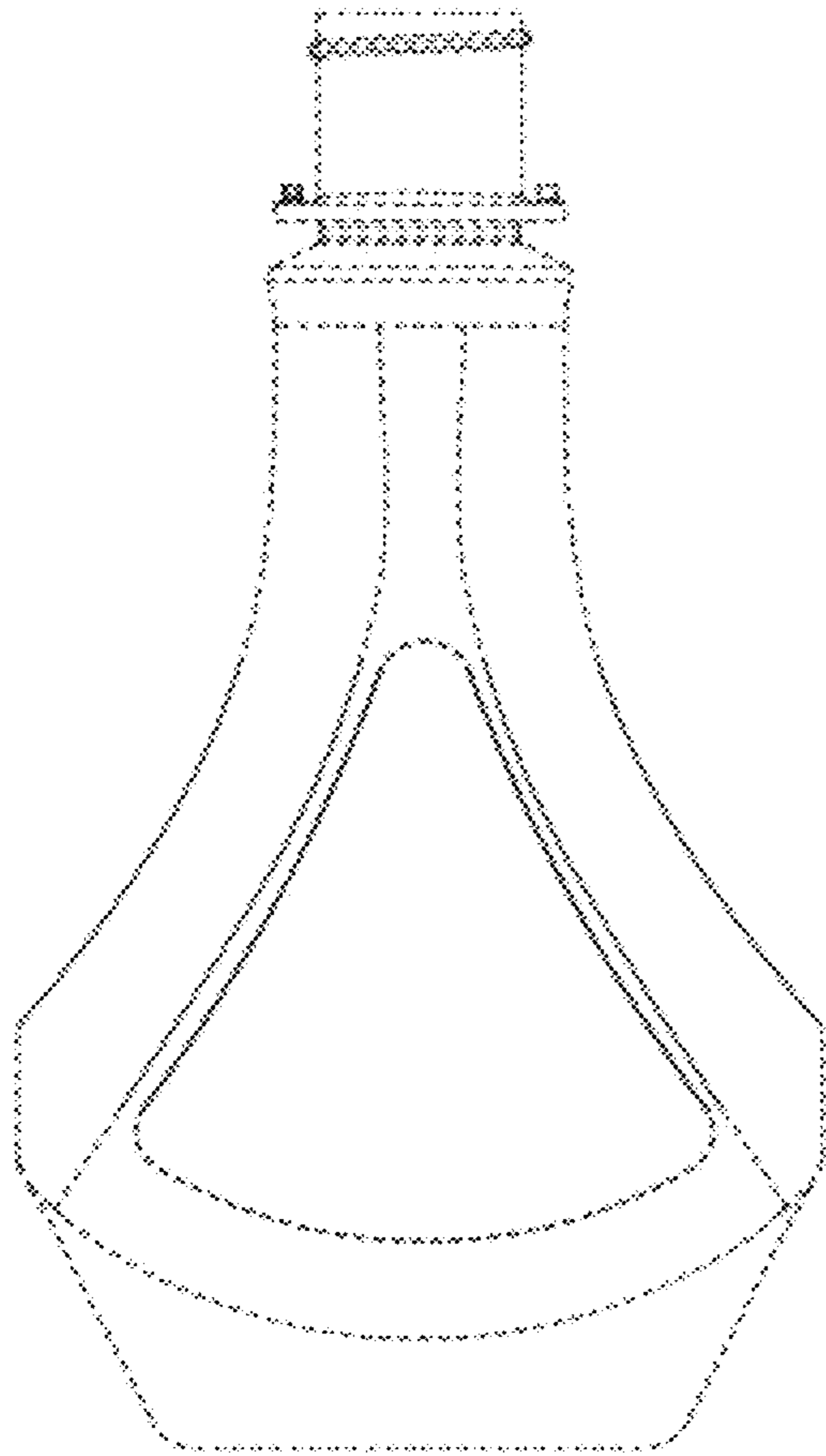

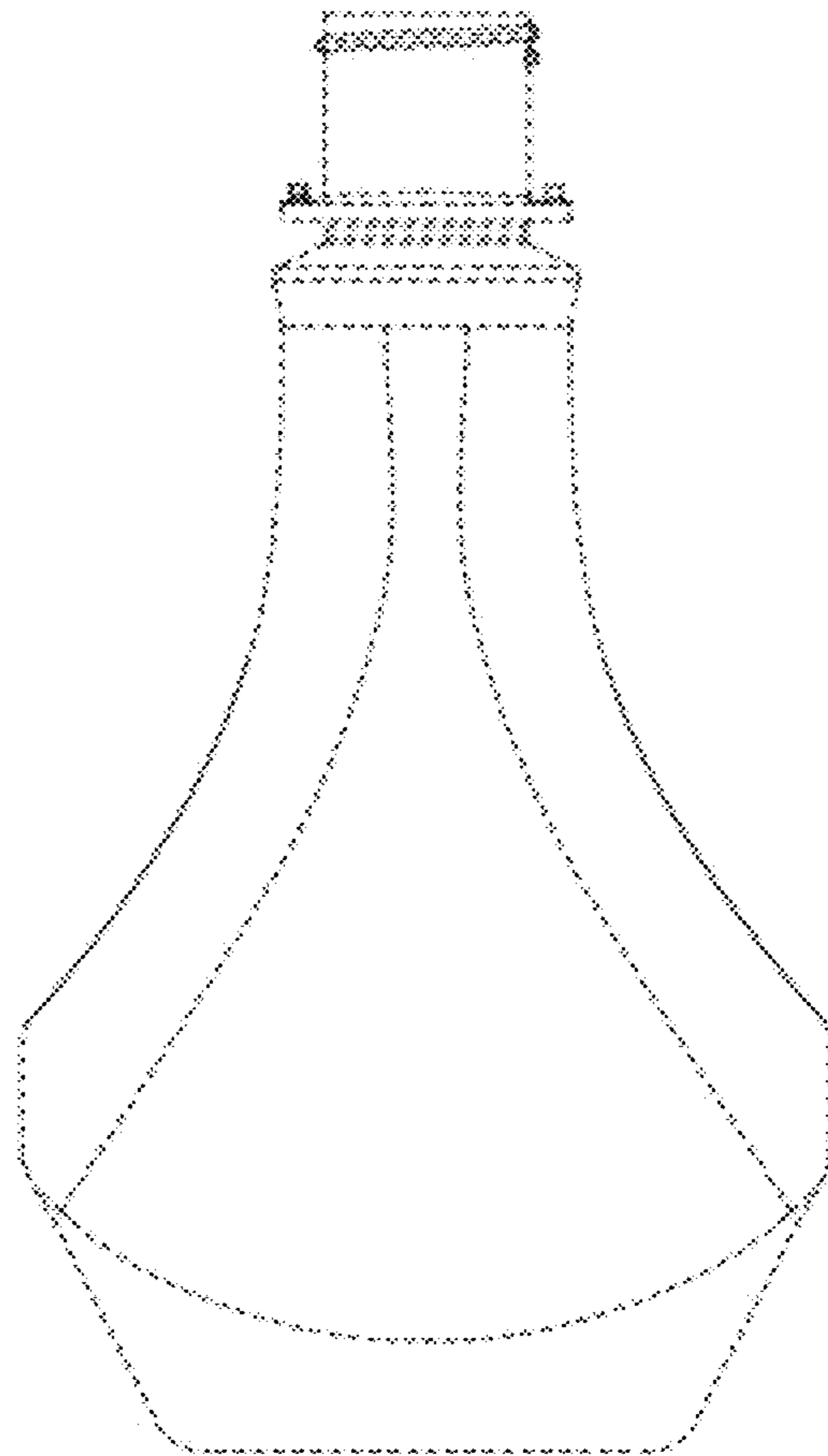

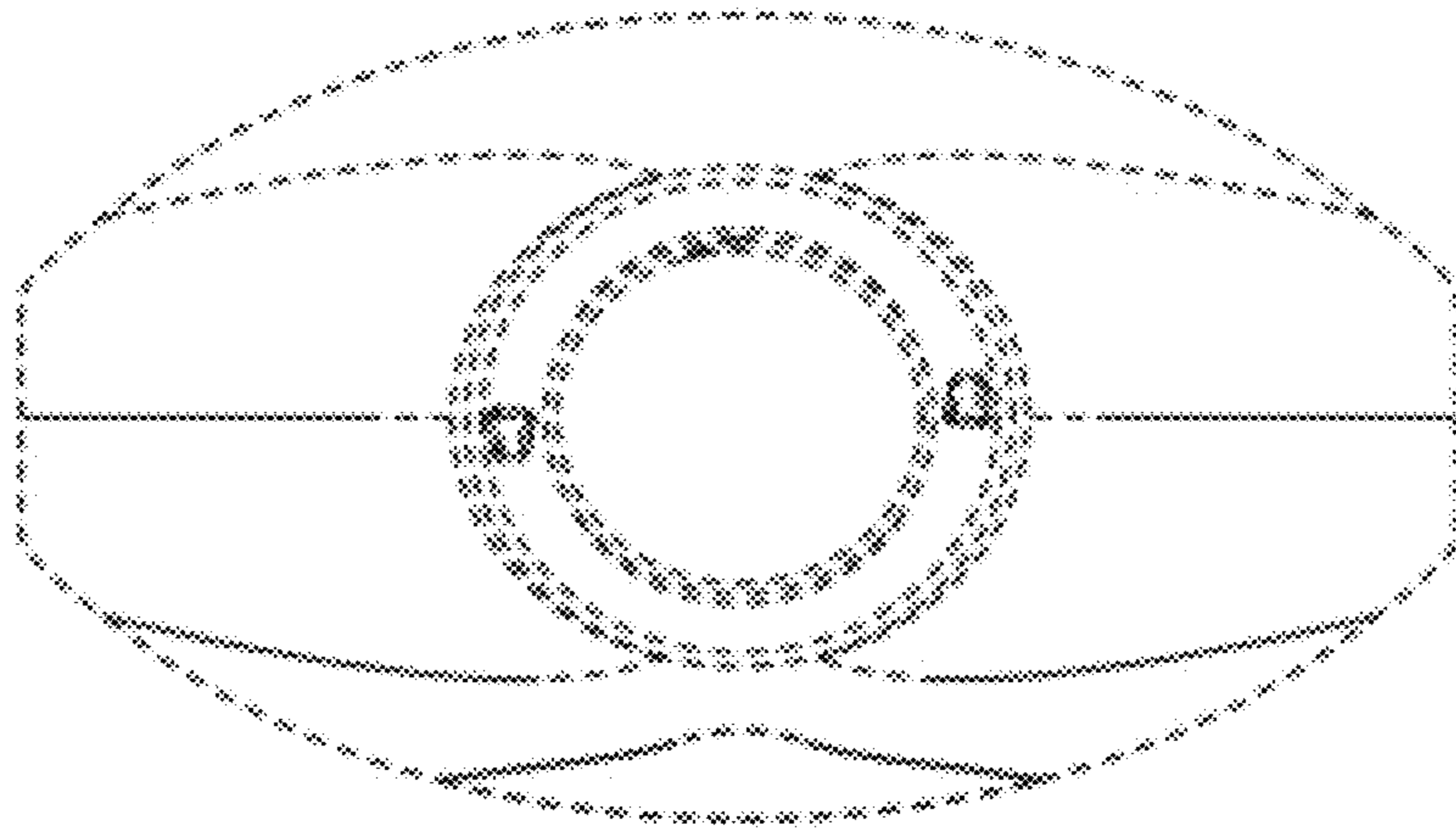

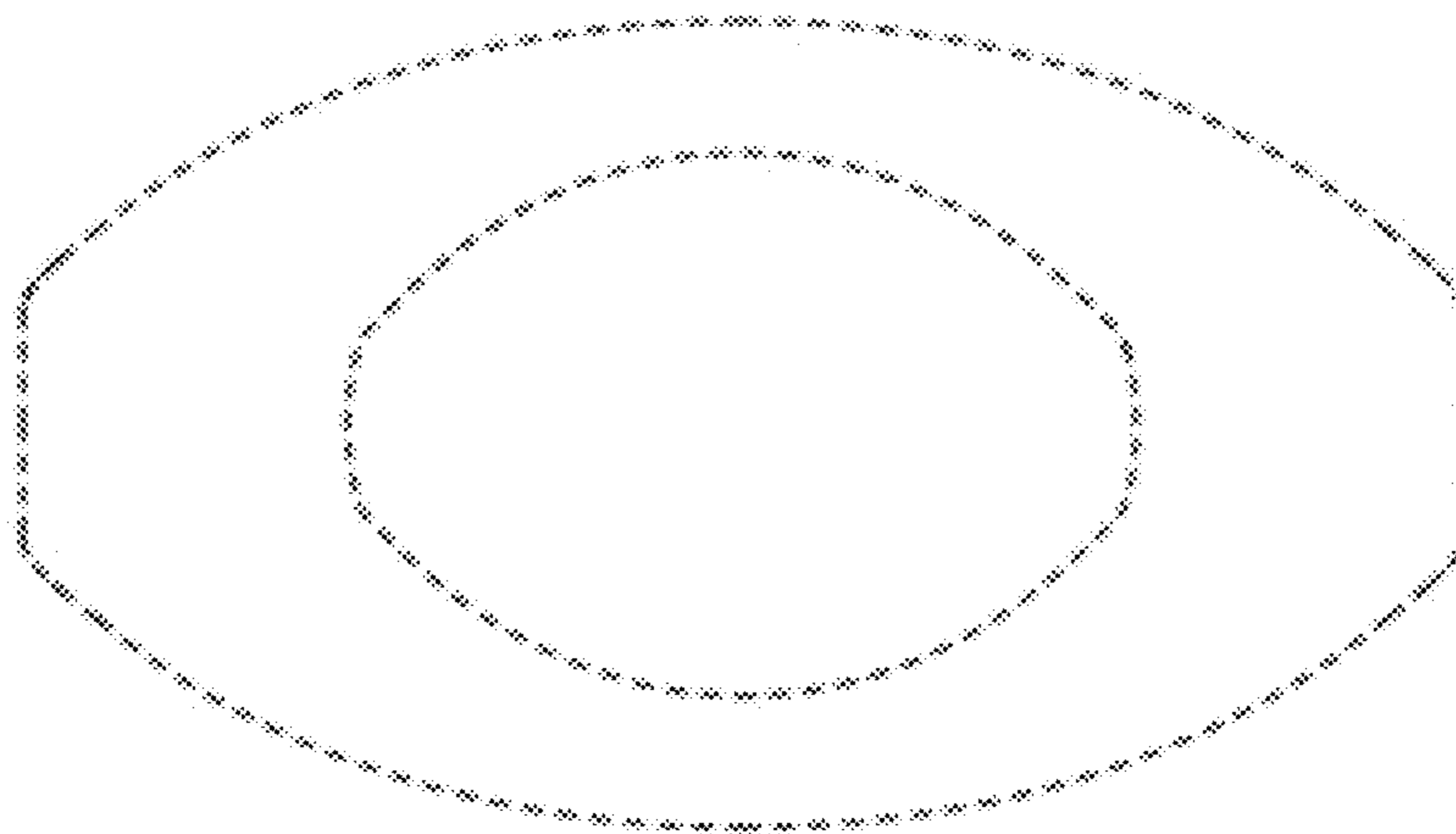
