FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image;

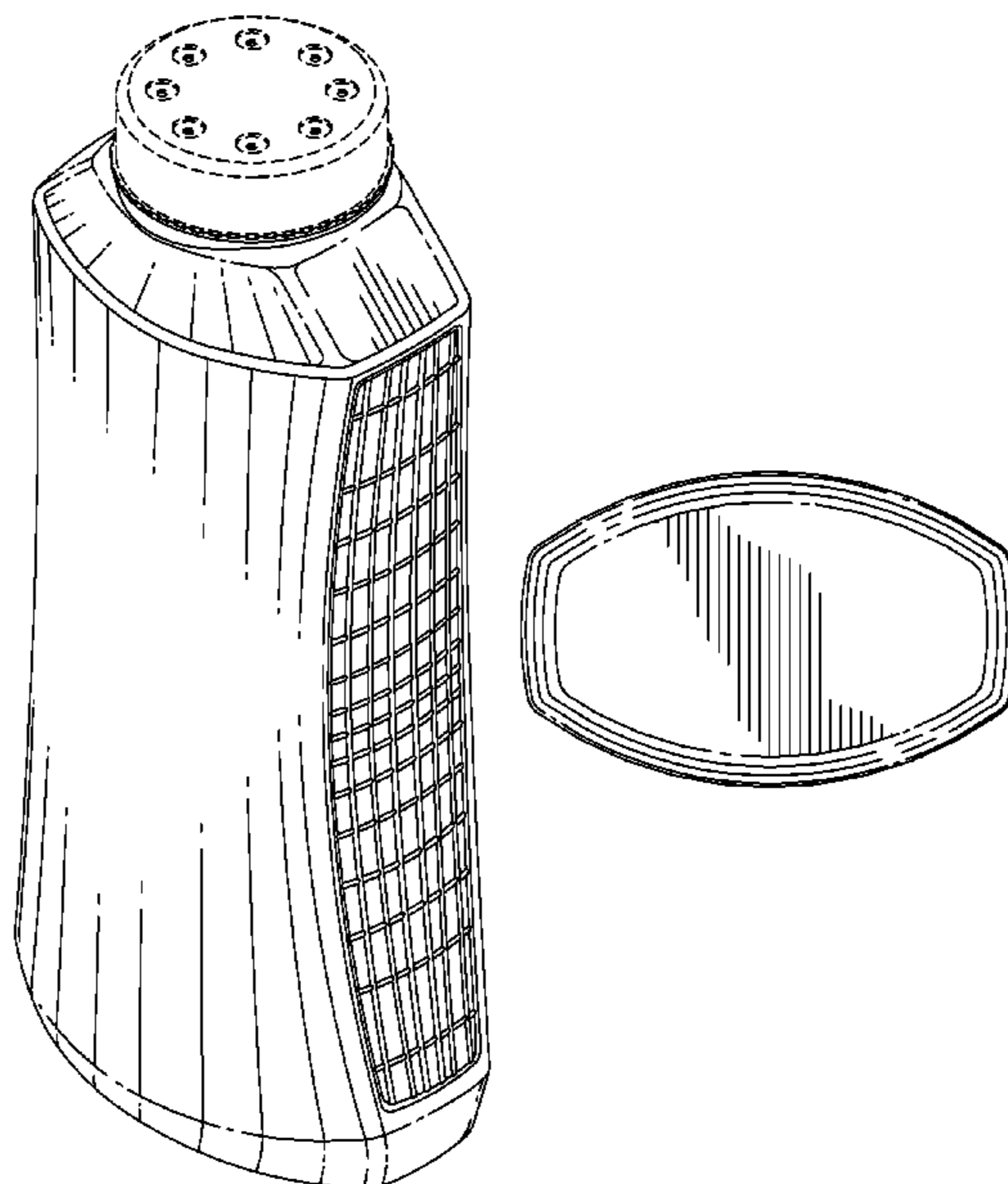
FIG. 3 is a right side elevational view thereof, the left side elevational view being a mirror image;

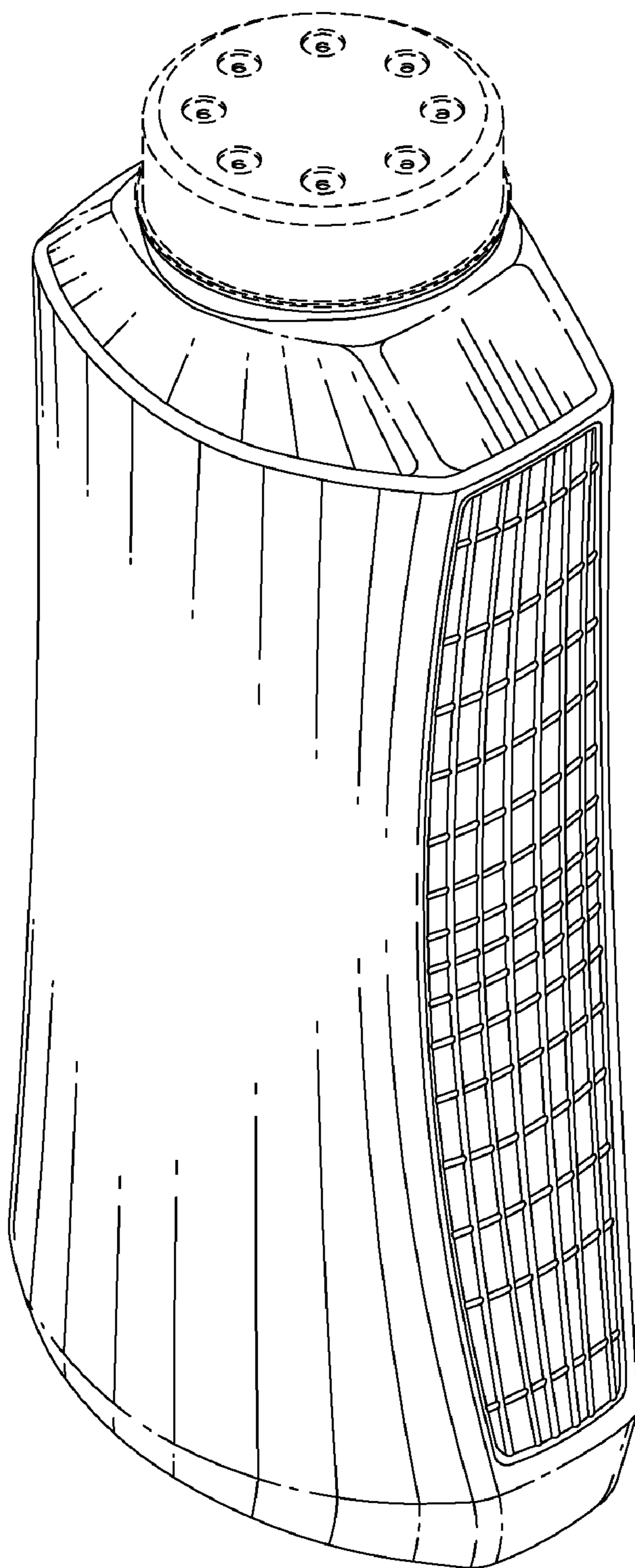
FIG. 4 is a top plan view thereof; and,

The broken line showing of a closure is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

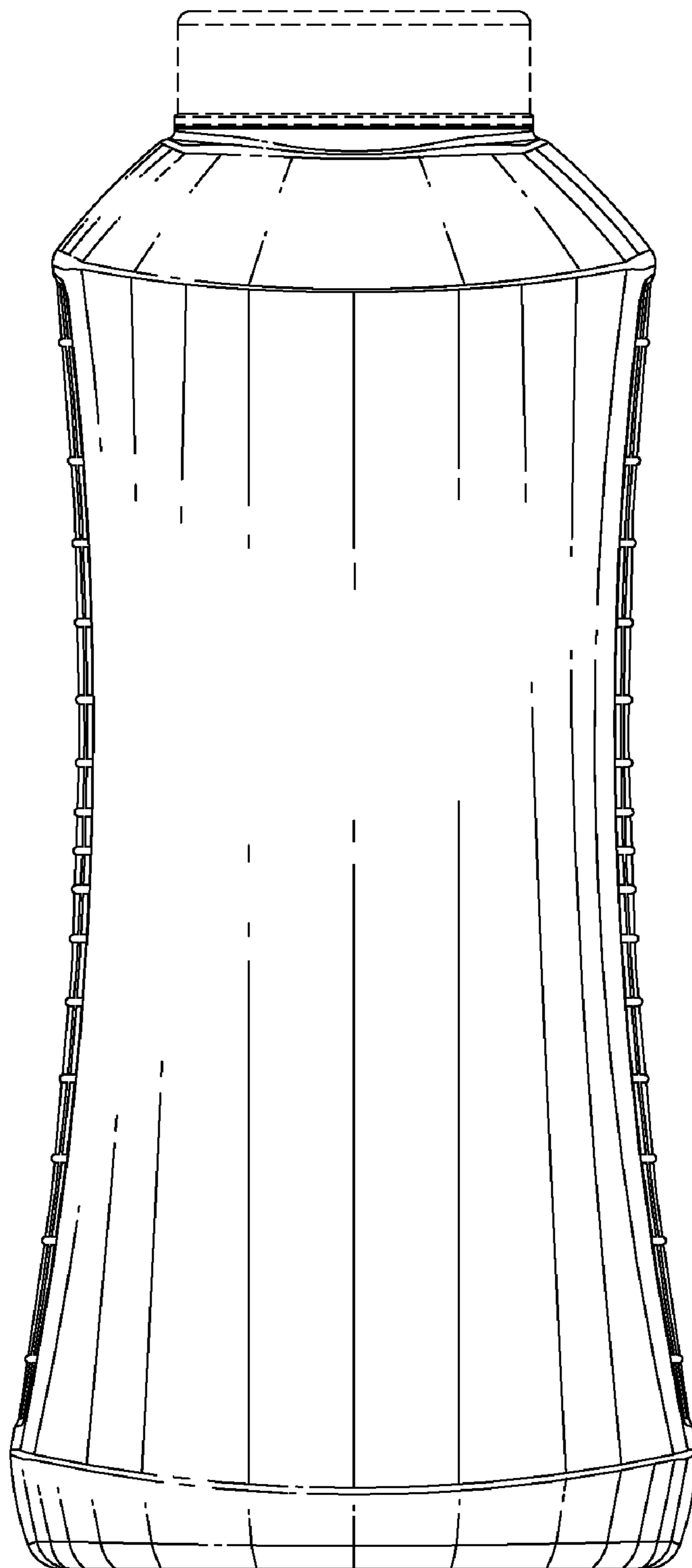

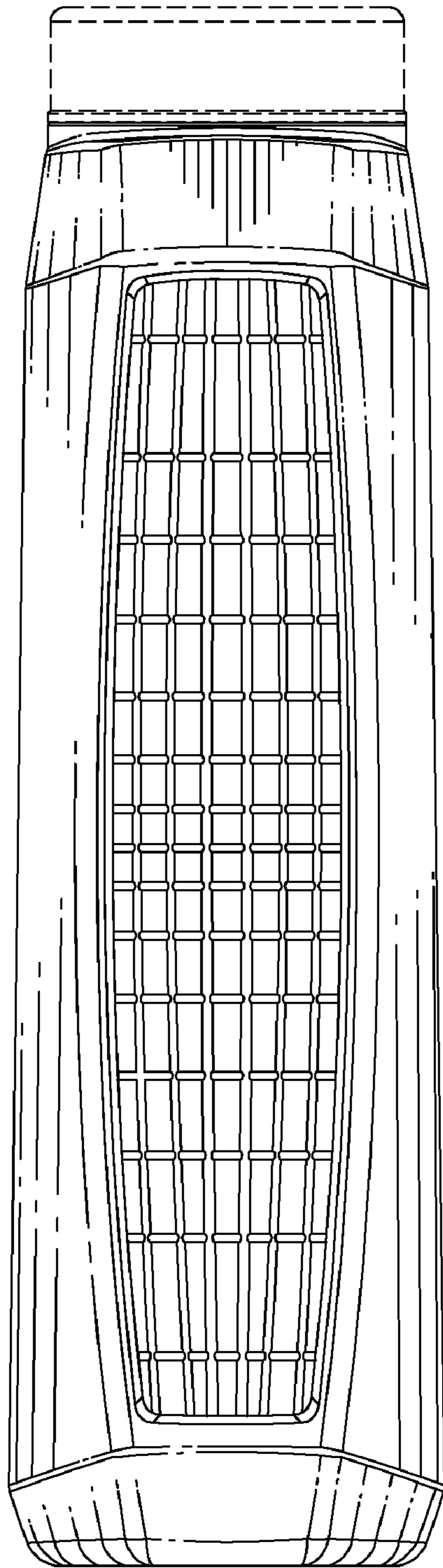

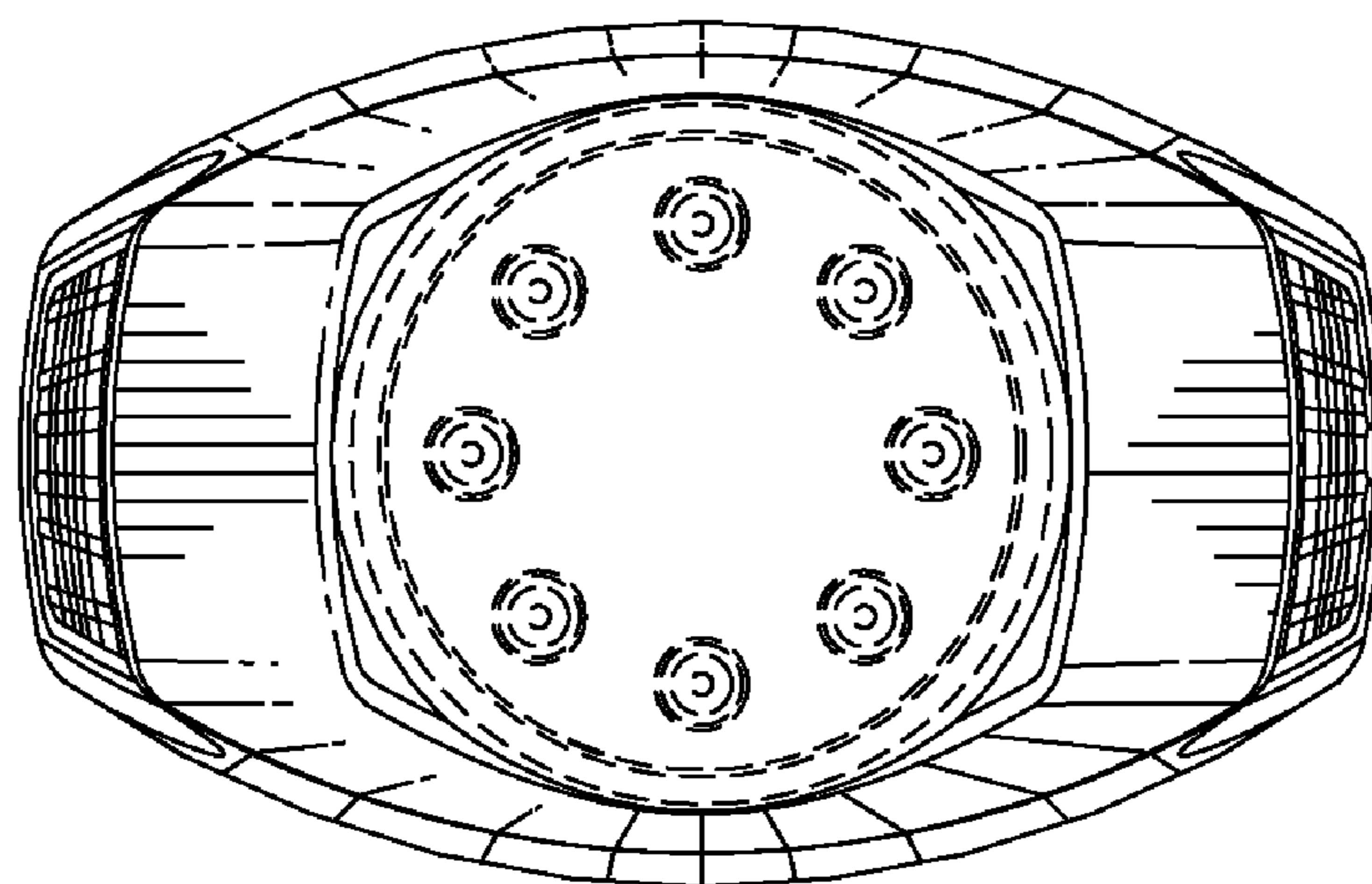

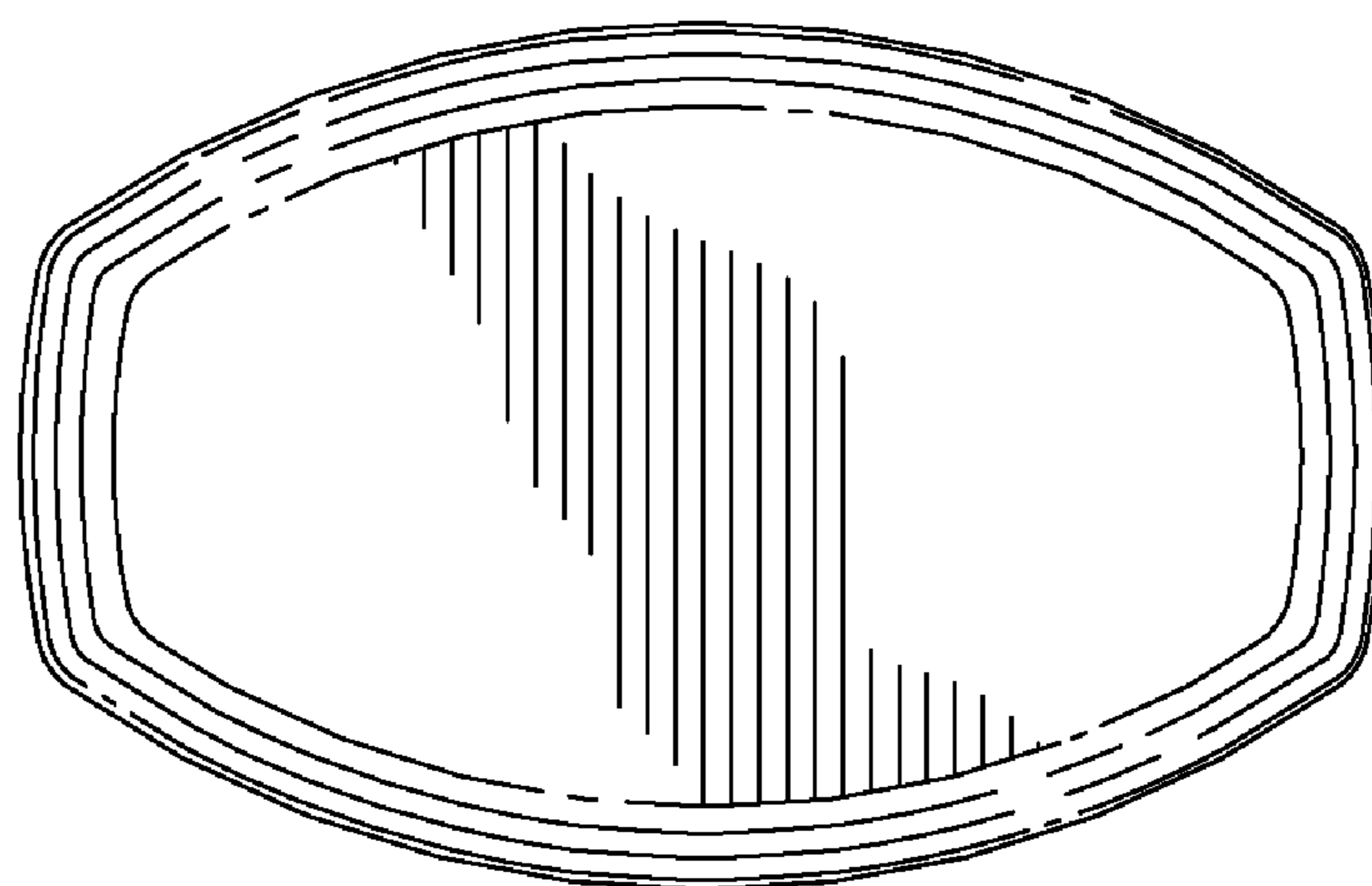
