(57) **CLAIM**

The ornamental design for a bottle, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right perspective view of a bottle embodying the new design;  
FIG. 2 is a bottom, front, right perspective view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a right side elevational view thereof;

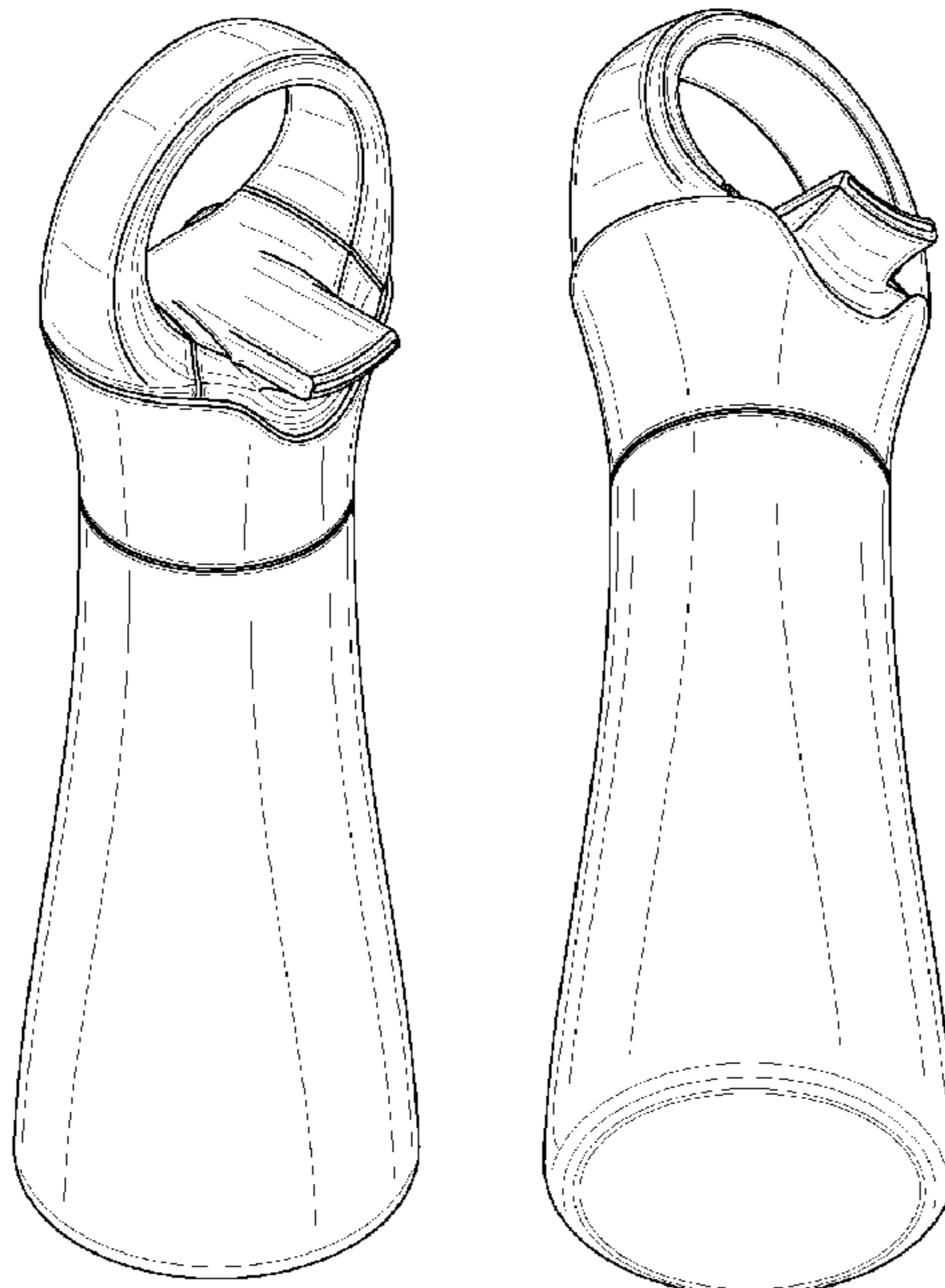

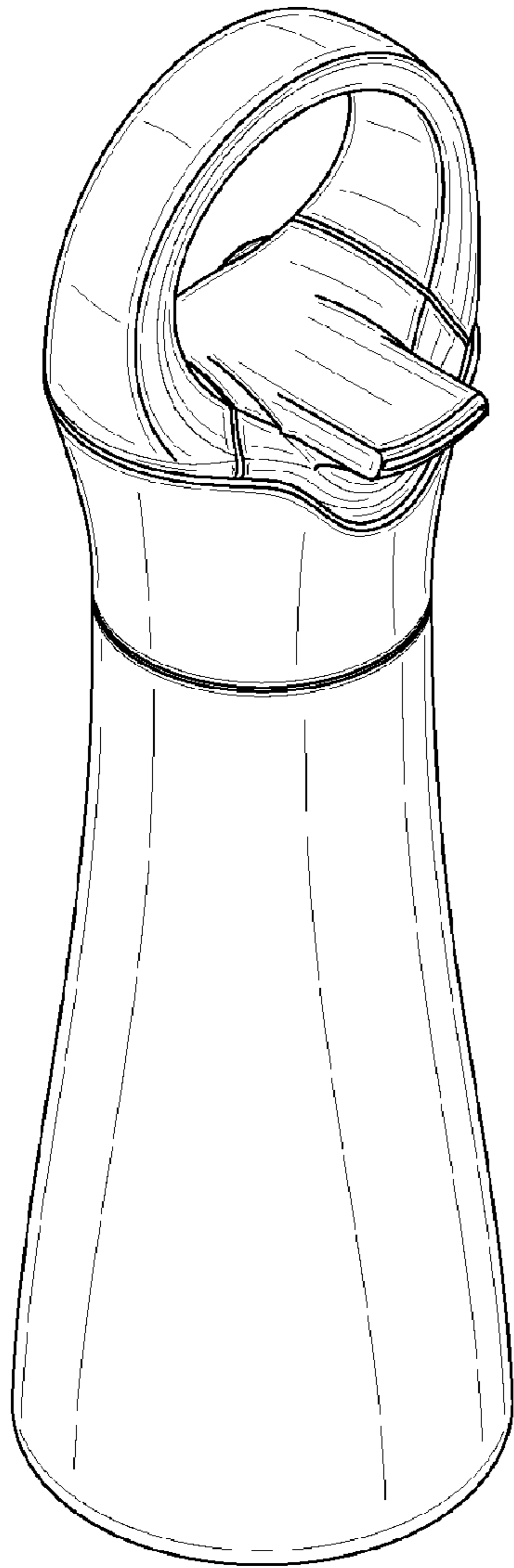

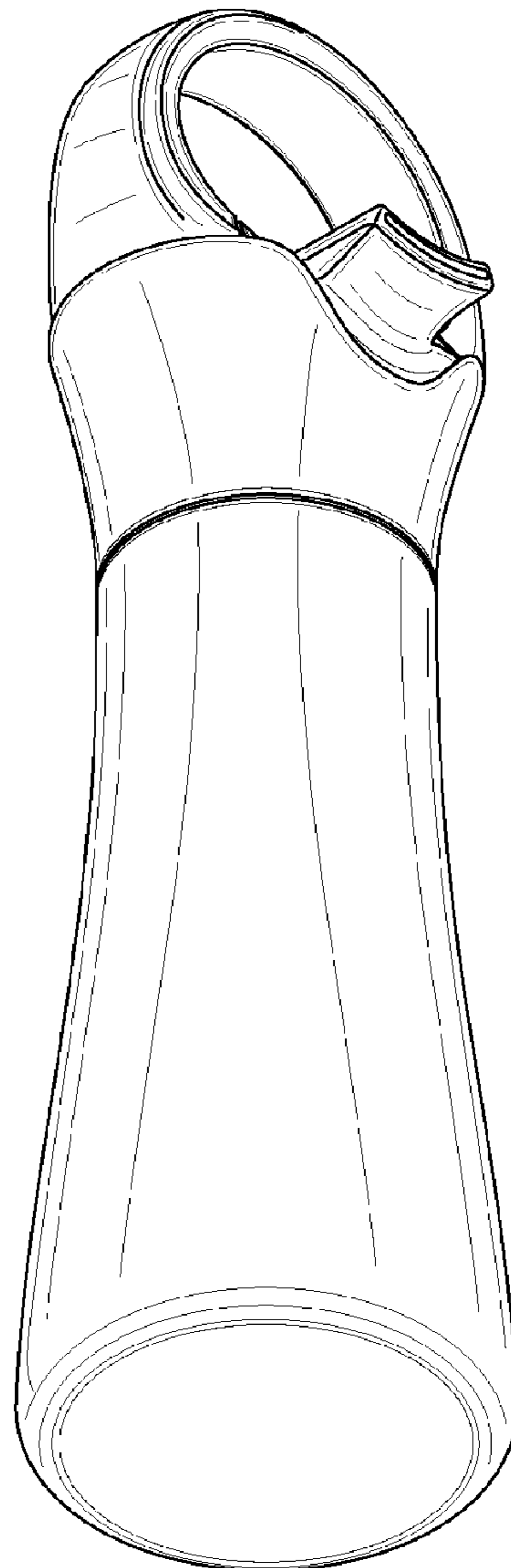

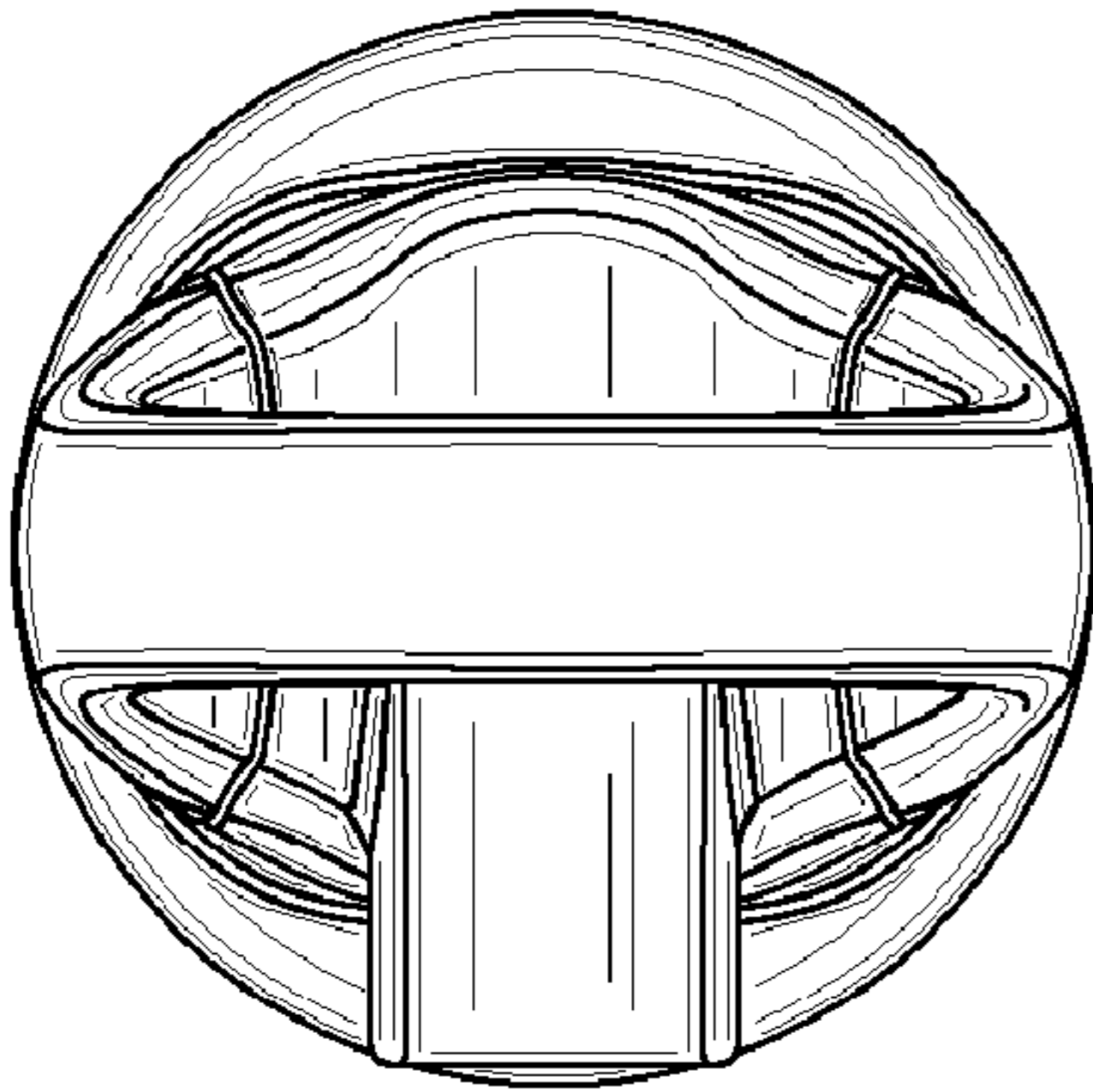
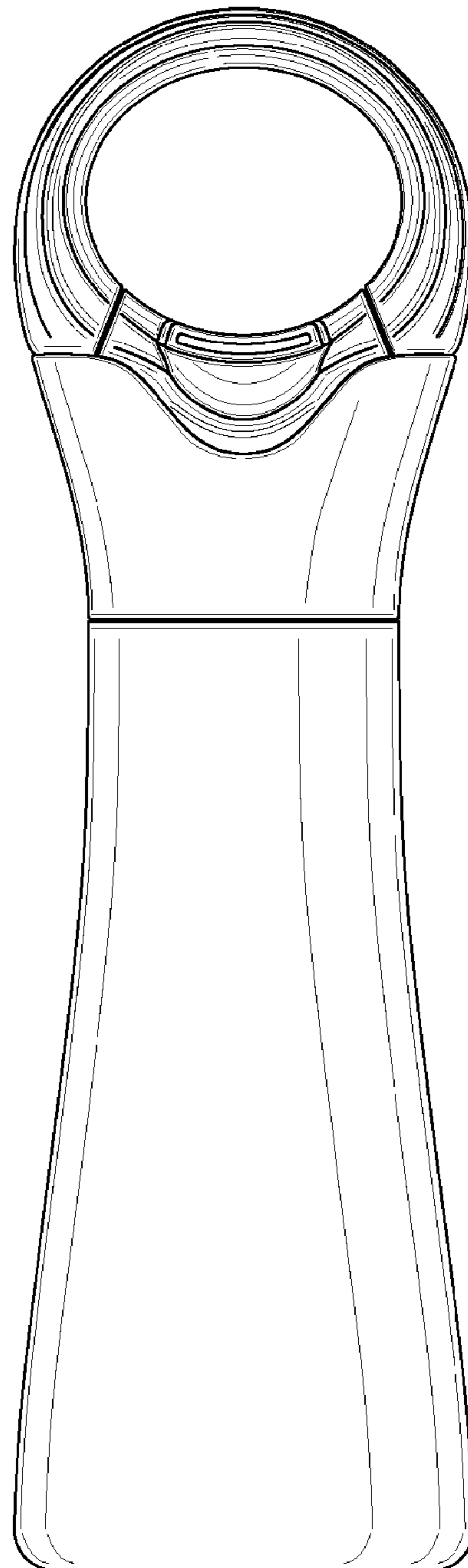
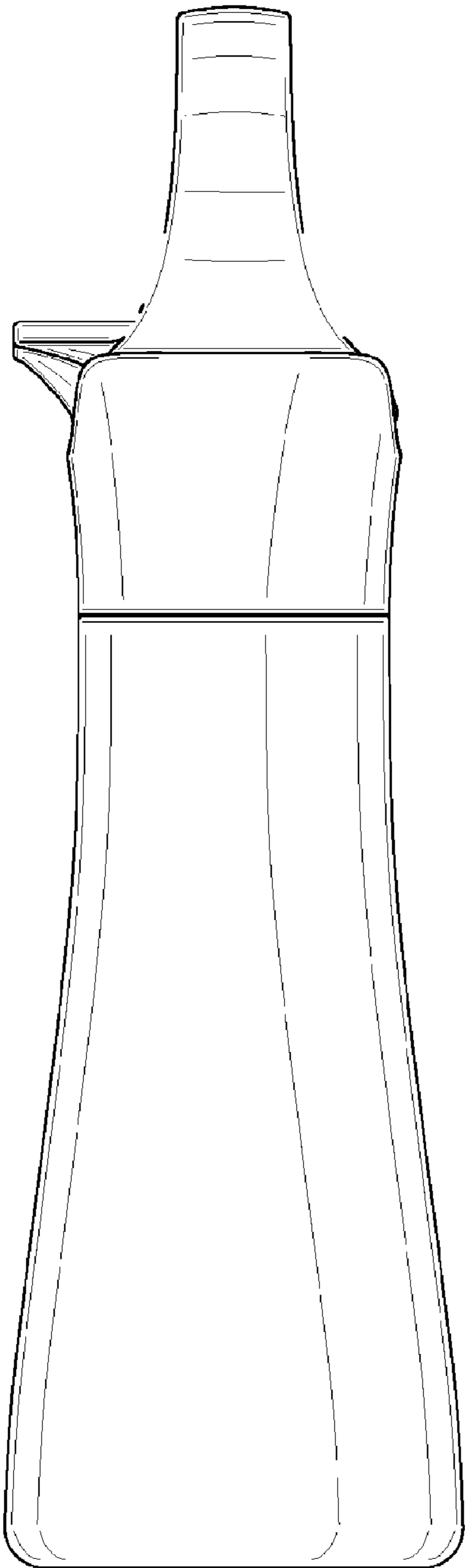

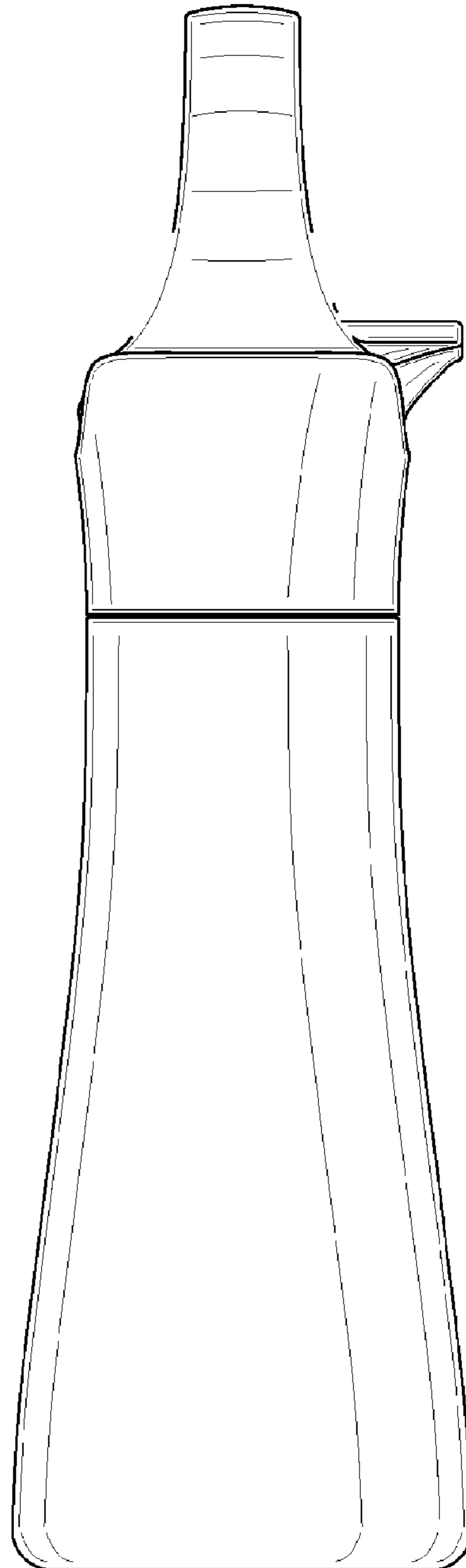

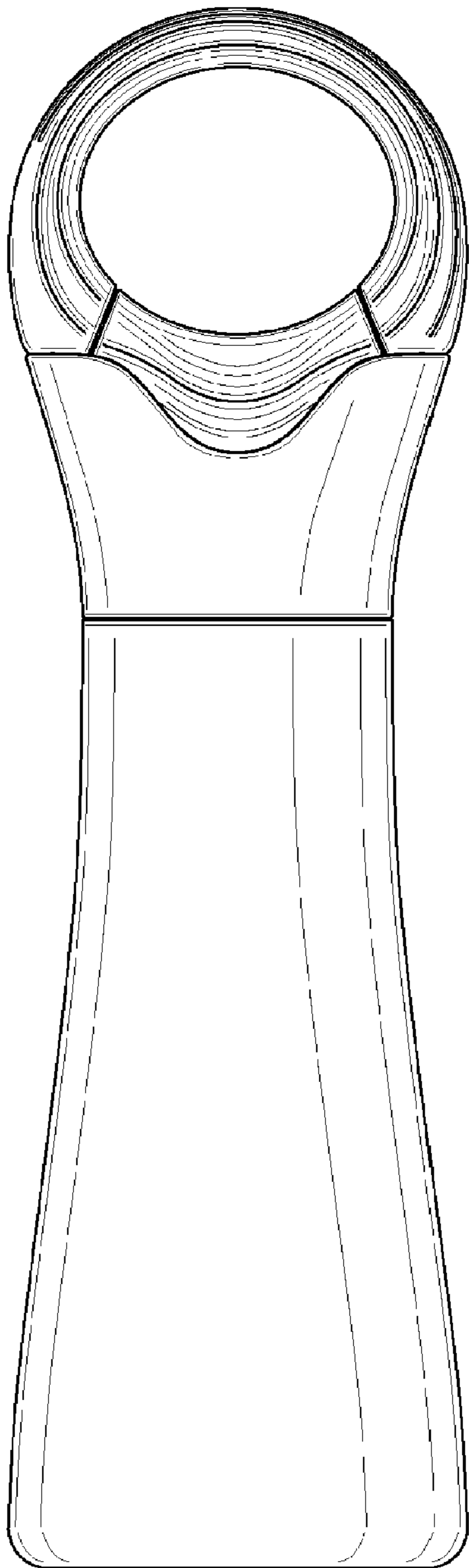
