(57) **CLAIM**

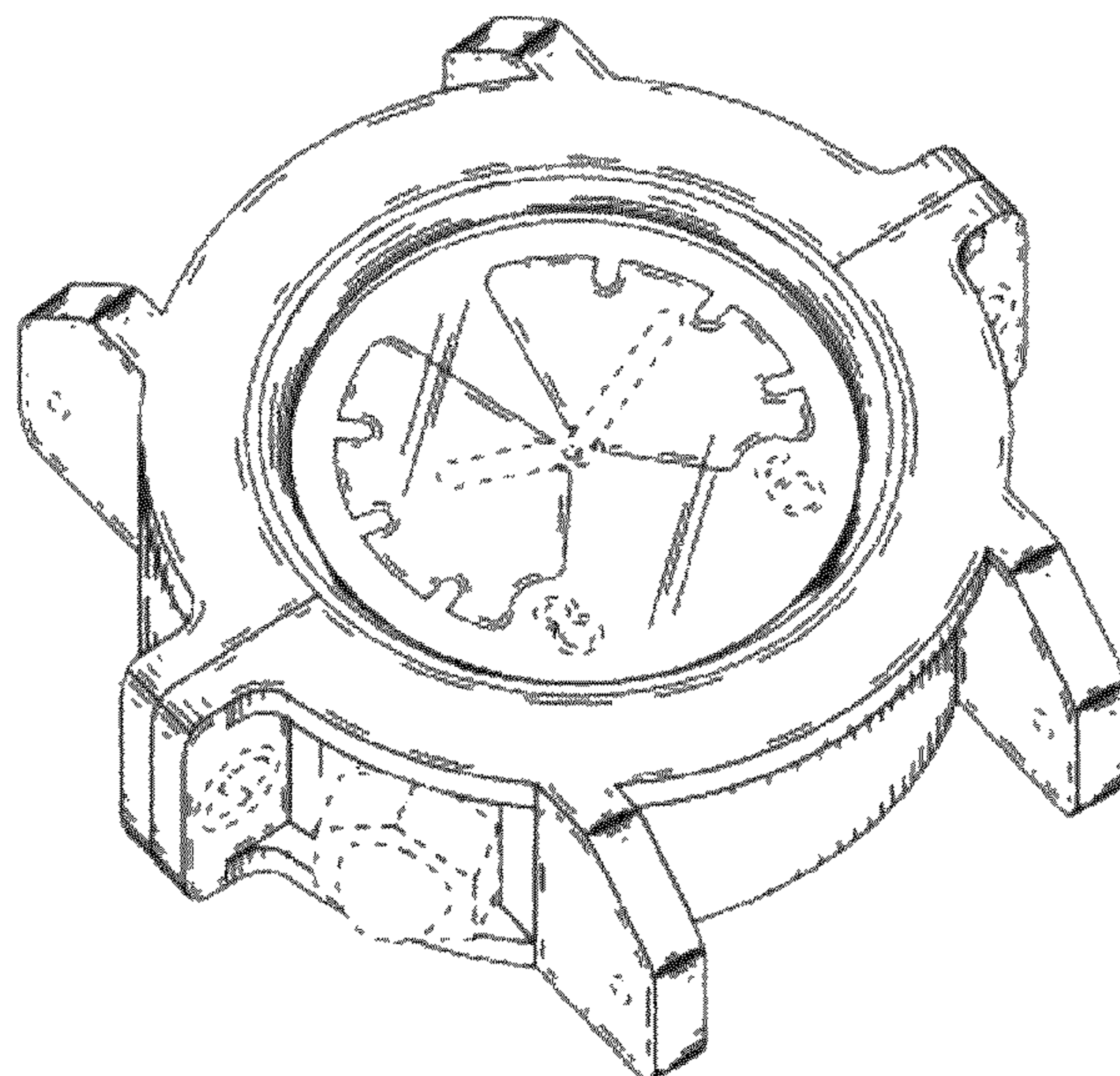
The ornamental design for a watch, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a watch showing my new design;
FIG. 2 is a front right perspective view of the same;

FIG. 6 is a back elevational view of the same;

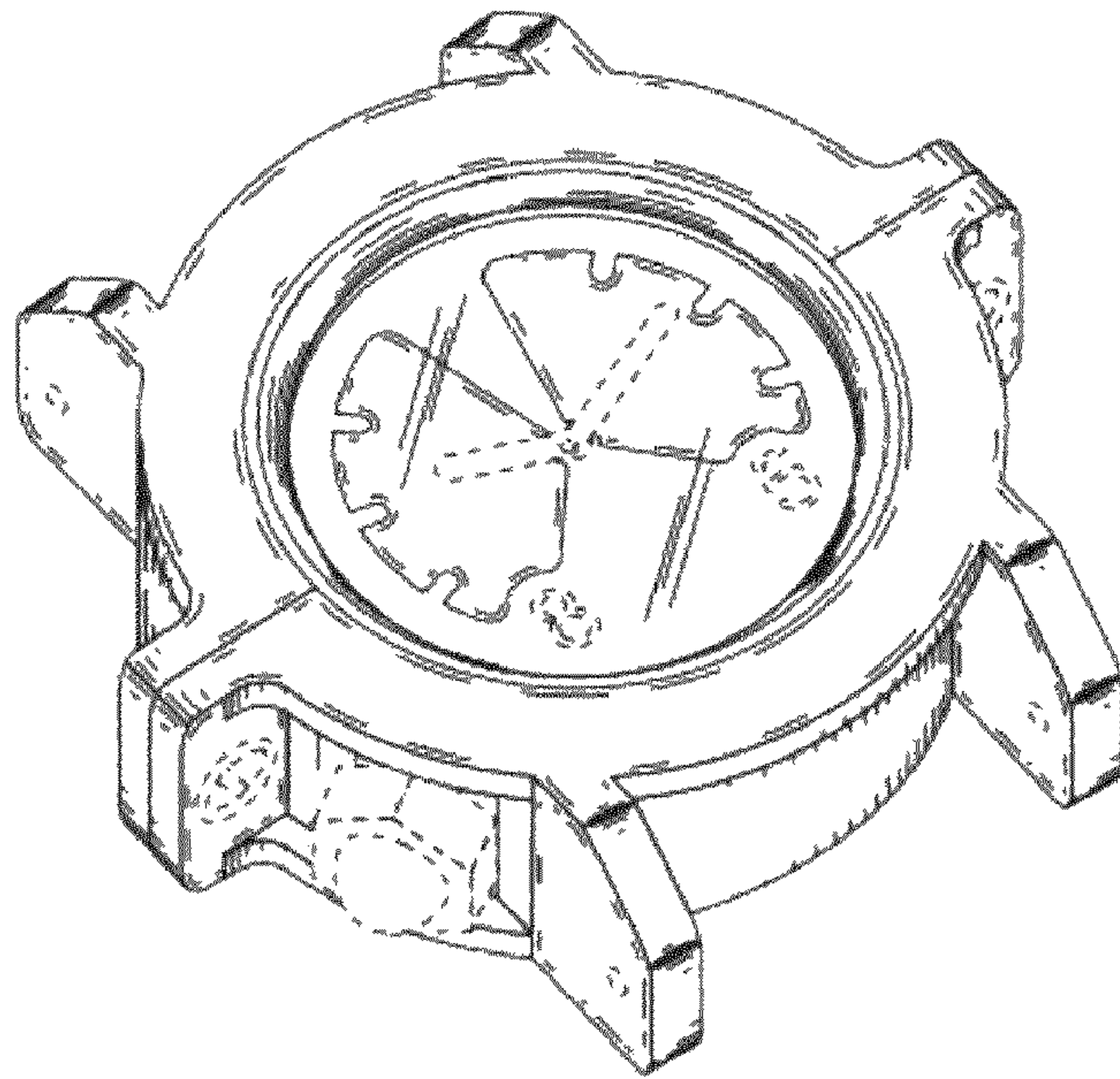

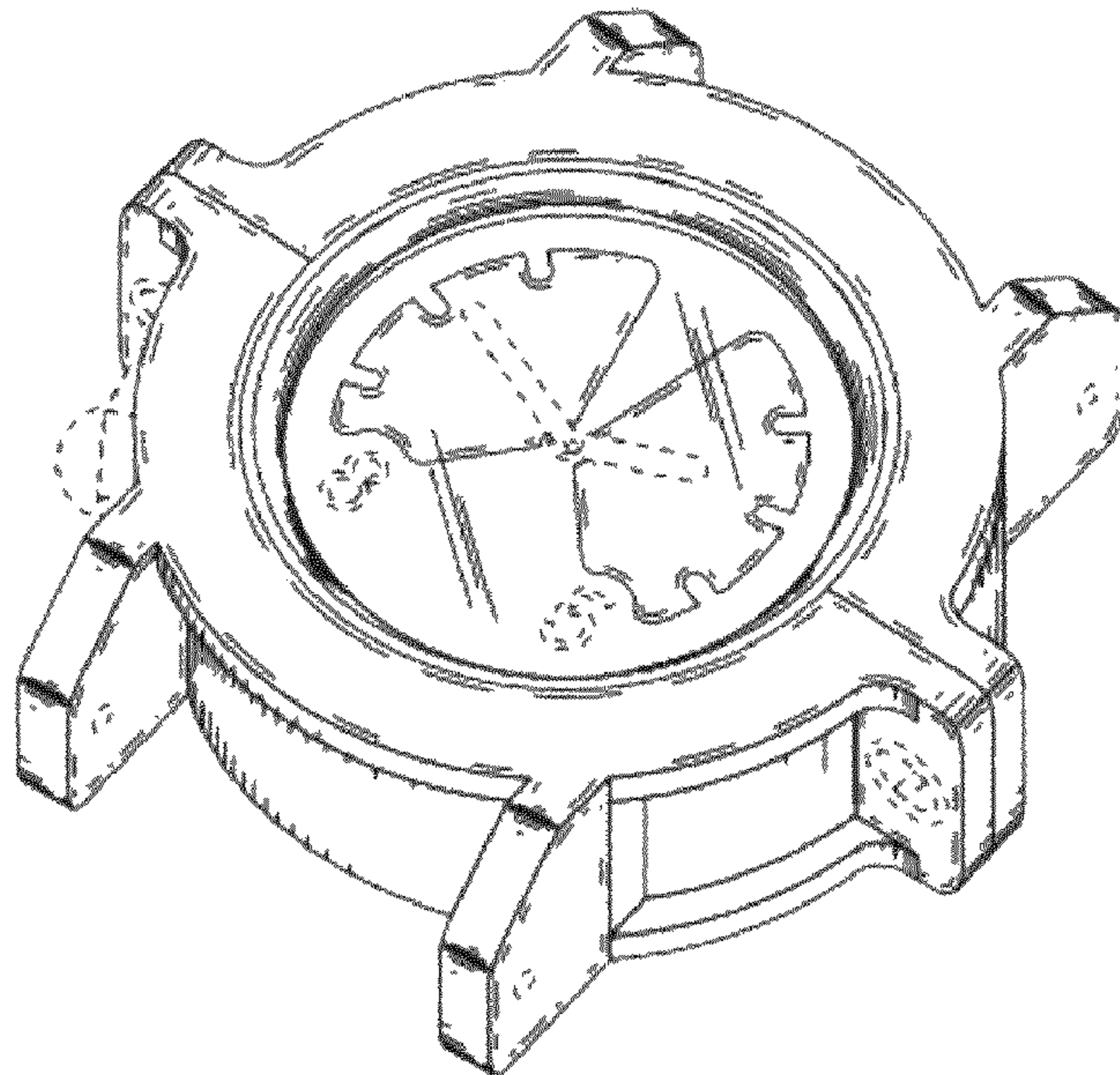

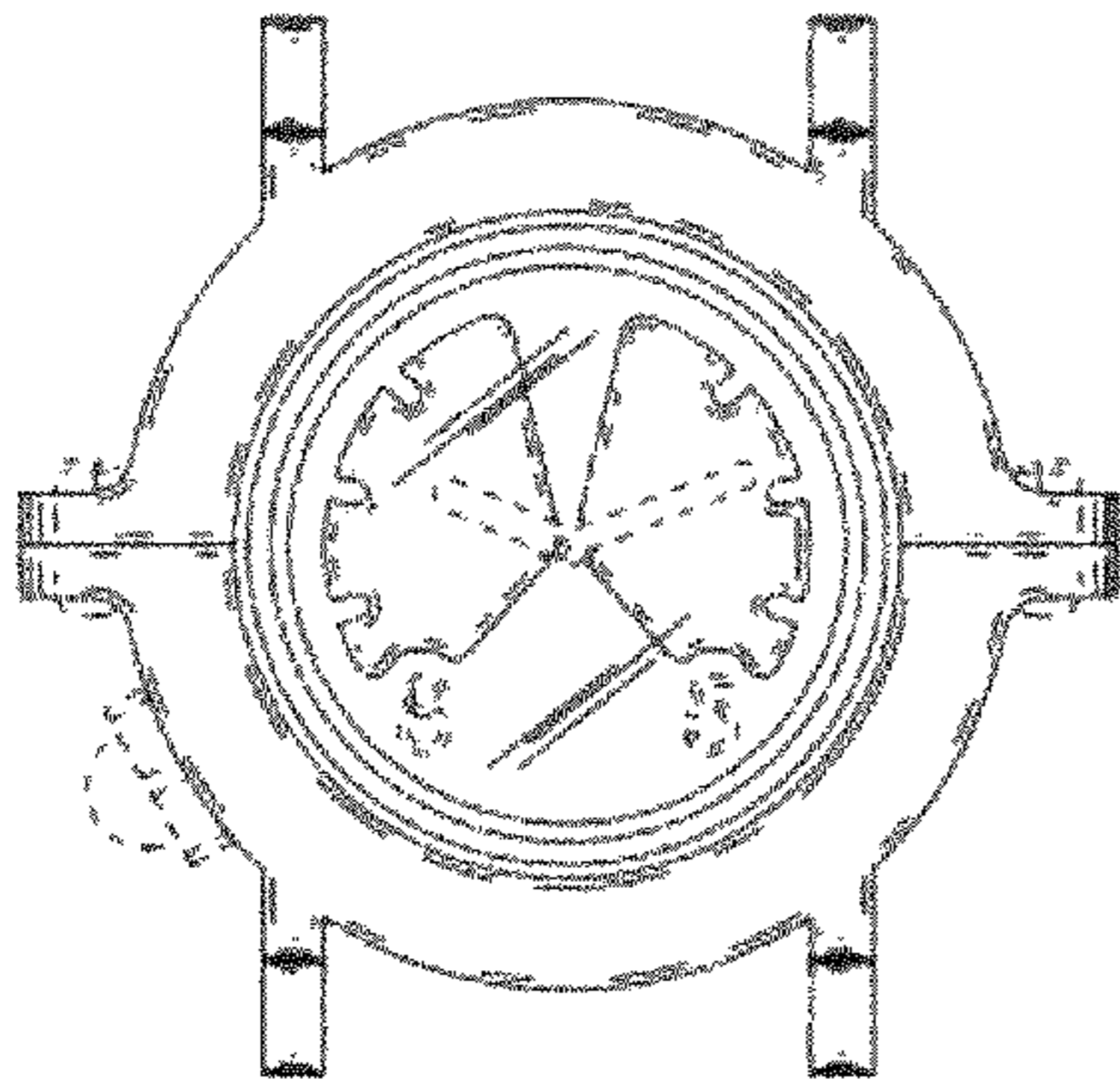

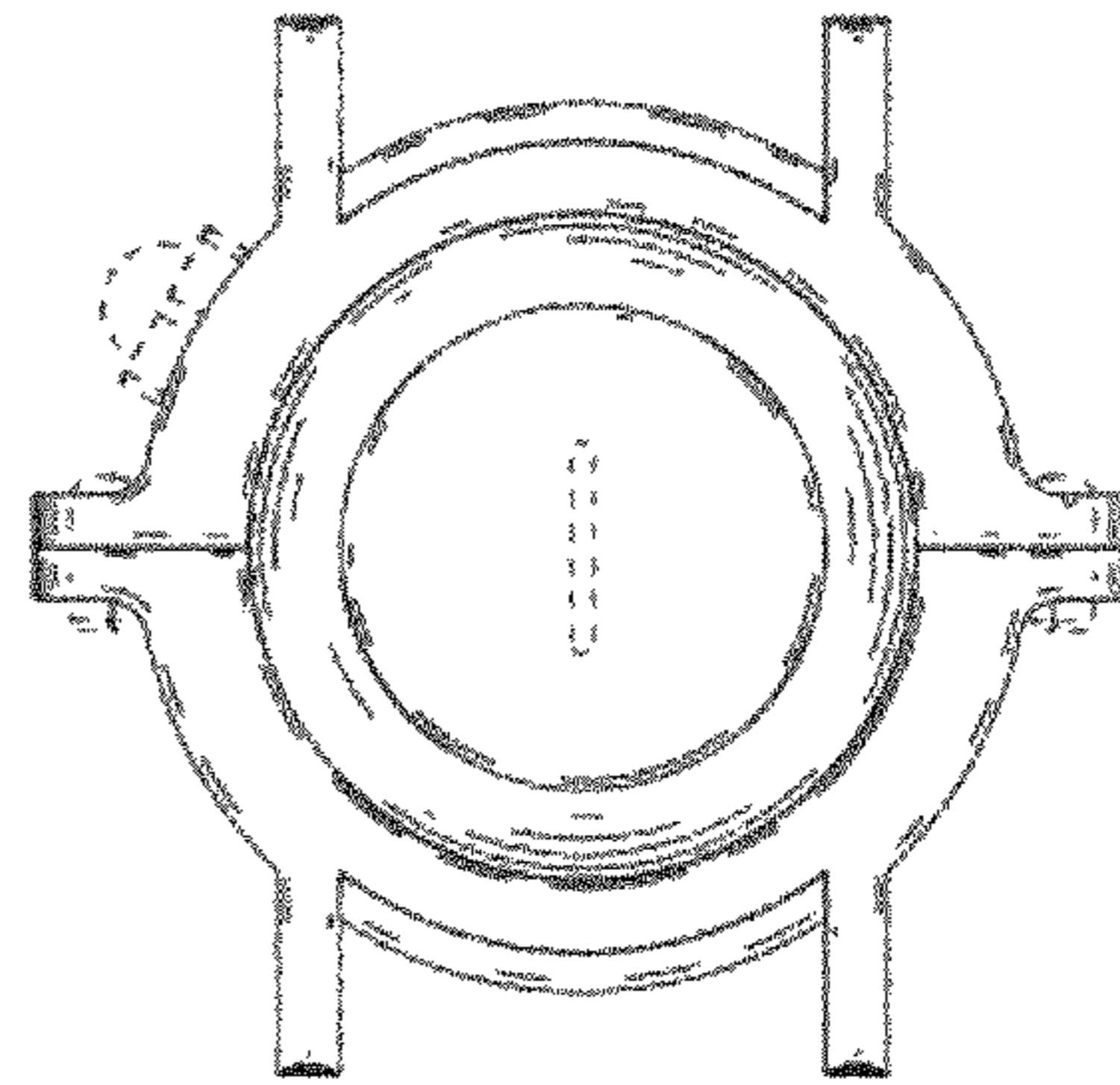

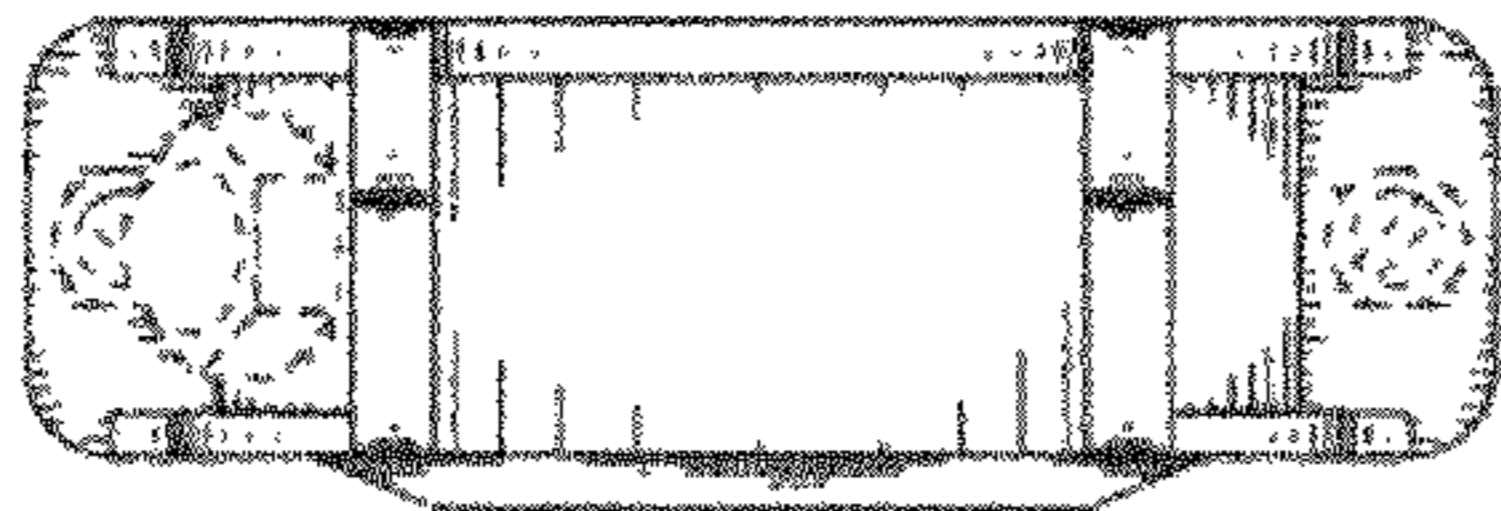

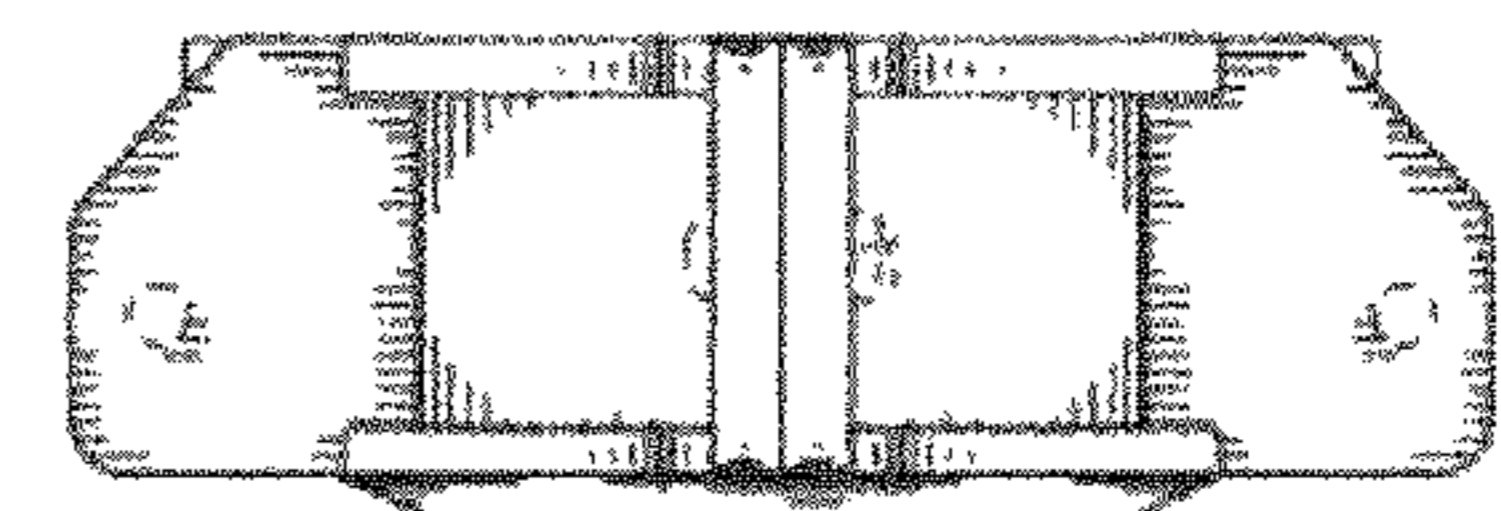

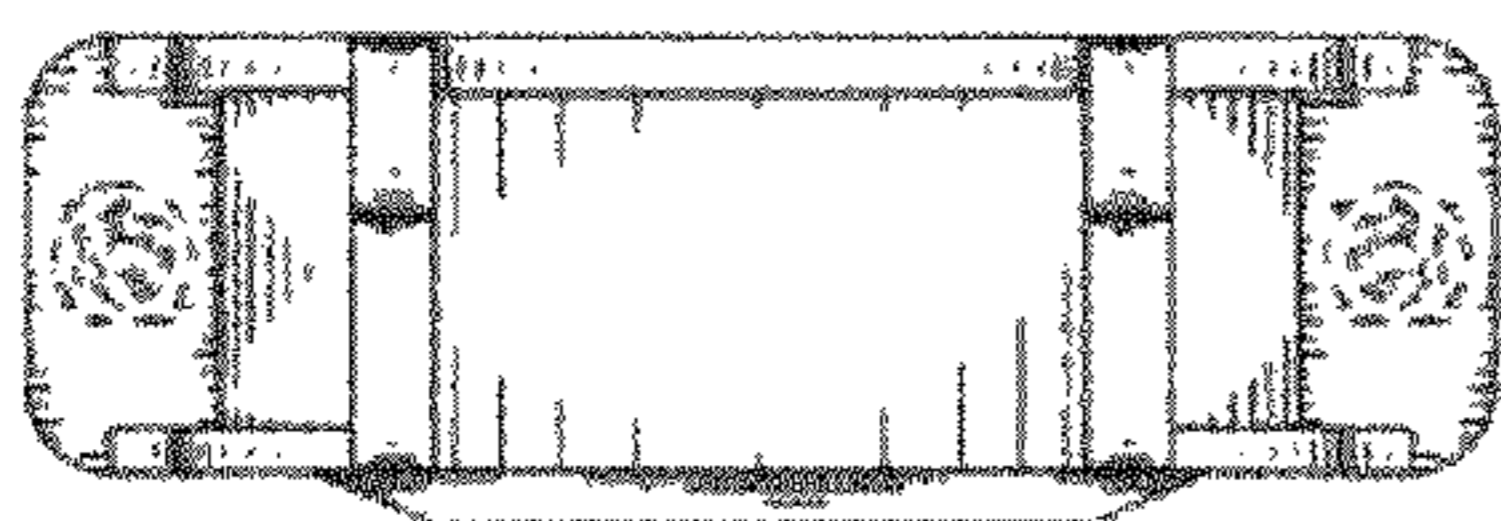

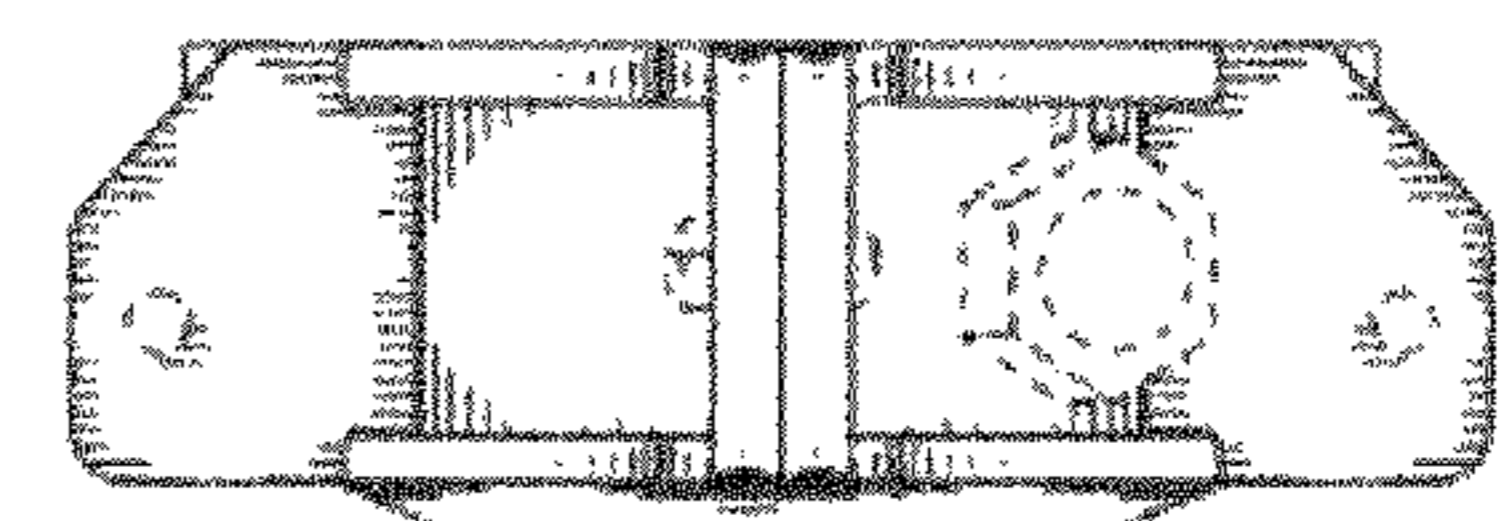

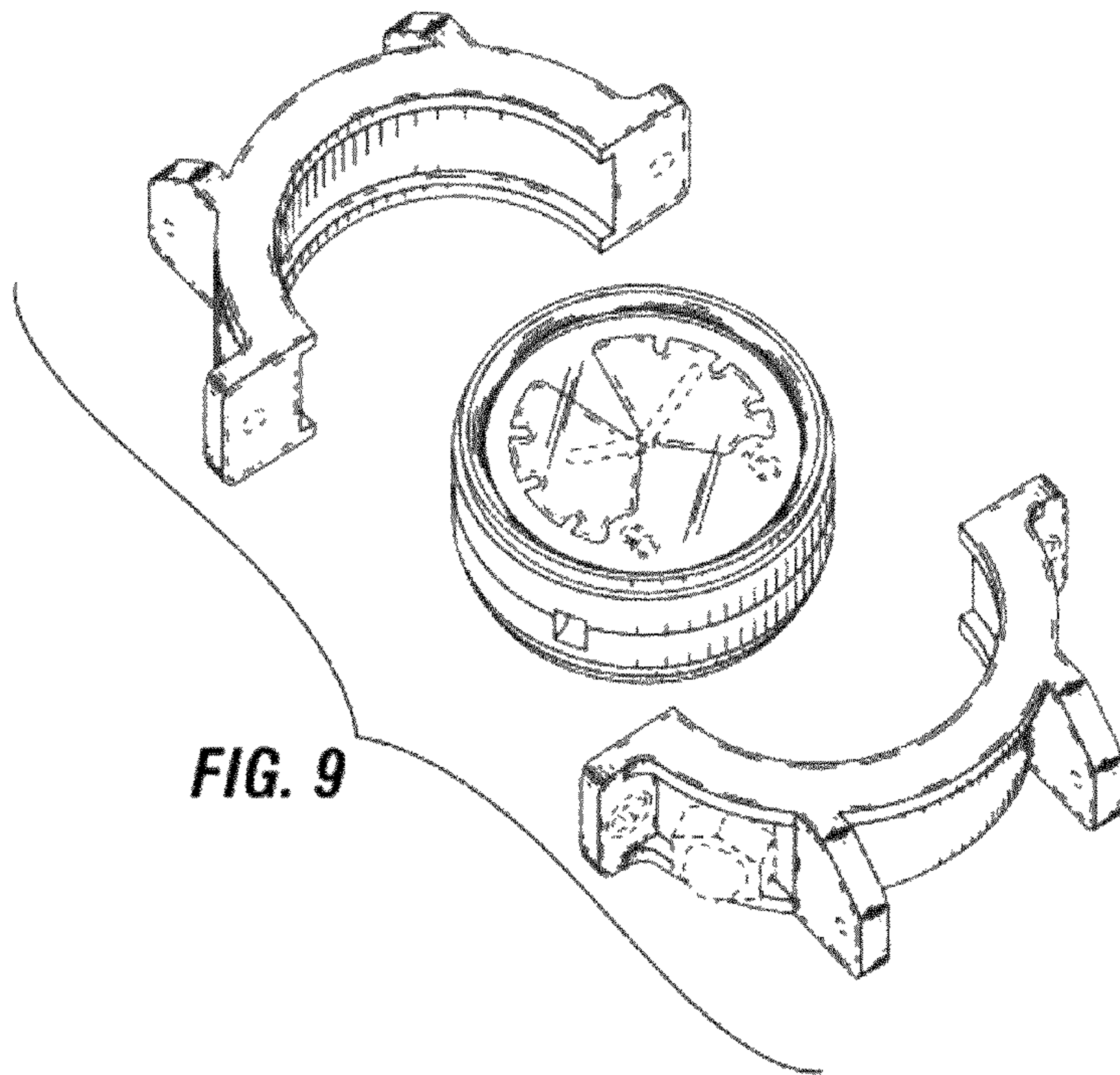

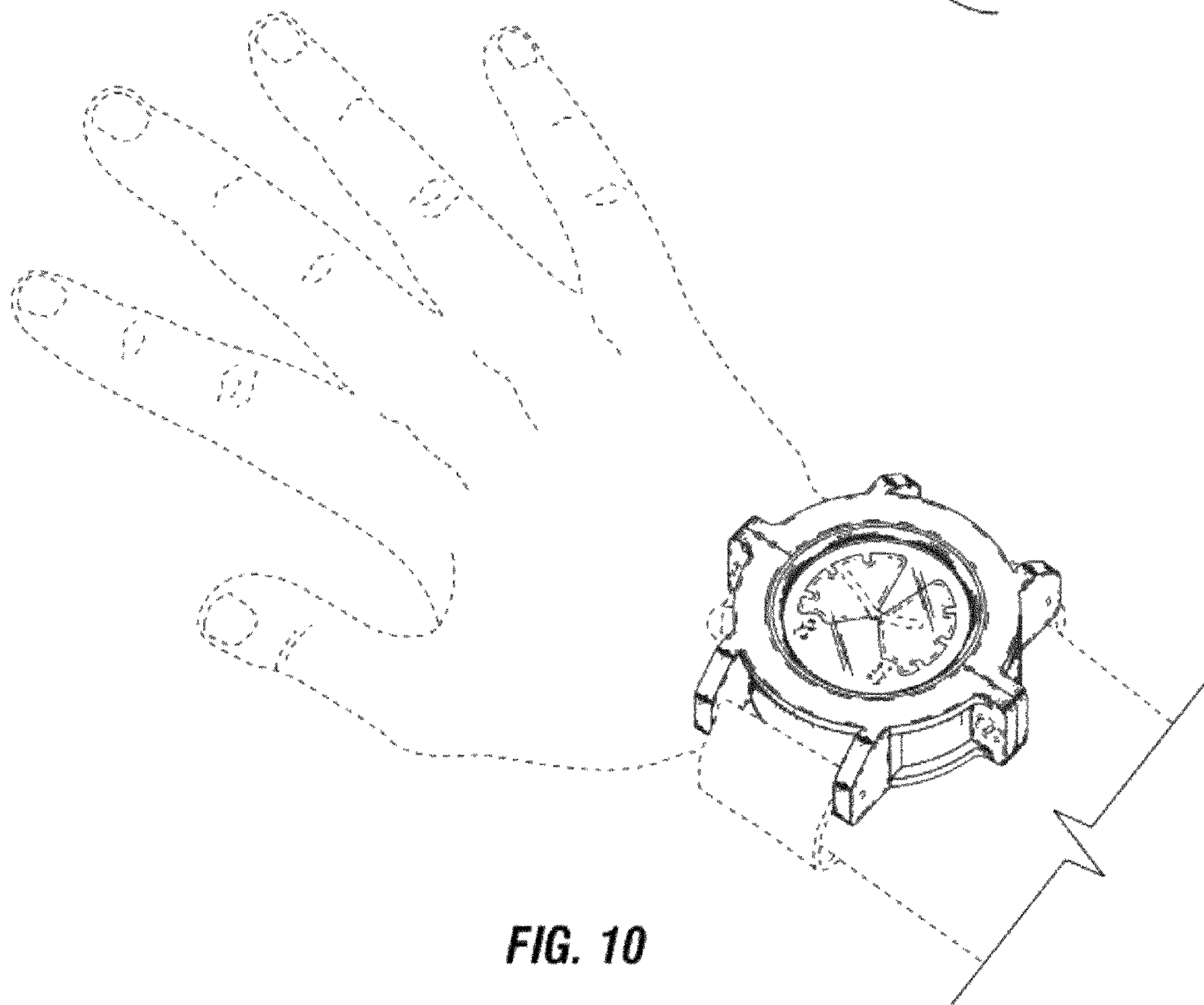
