(57) **CLAIM**

The ornamental design for a license plate frame, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective front view showing our new design for a license plate frame

FIG. 2 is a top view of the license plate frame of the present invention.

FIG. 3 is a front view of the license plate frame of the present invention.

FIG. 4 is a right side view of the license plate frame of the present invention, the left side view being the mirror image thereof.

FIG. 5 is a bottom view of the license plate frame of the present invention.

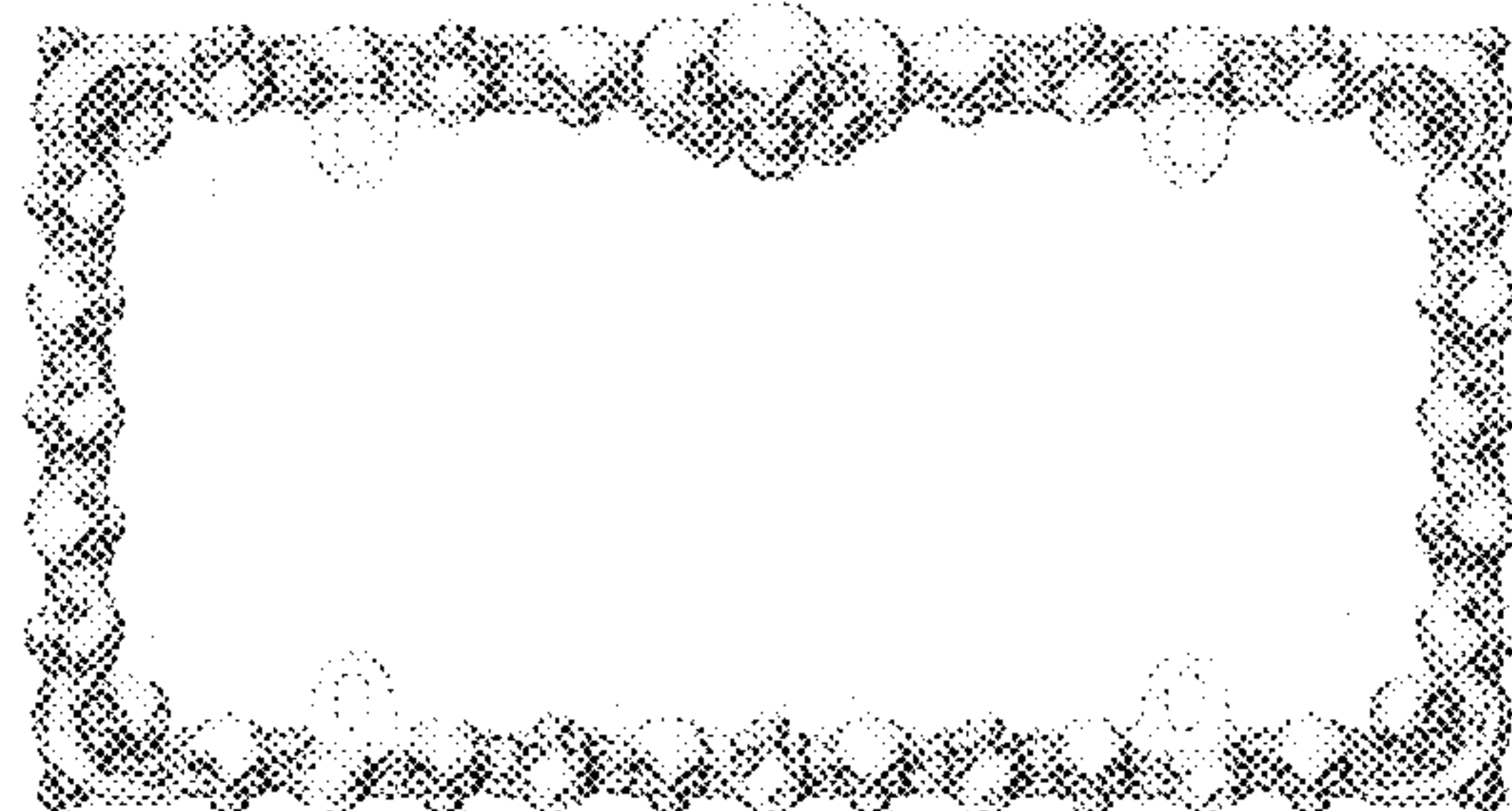
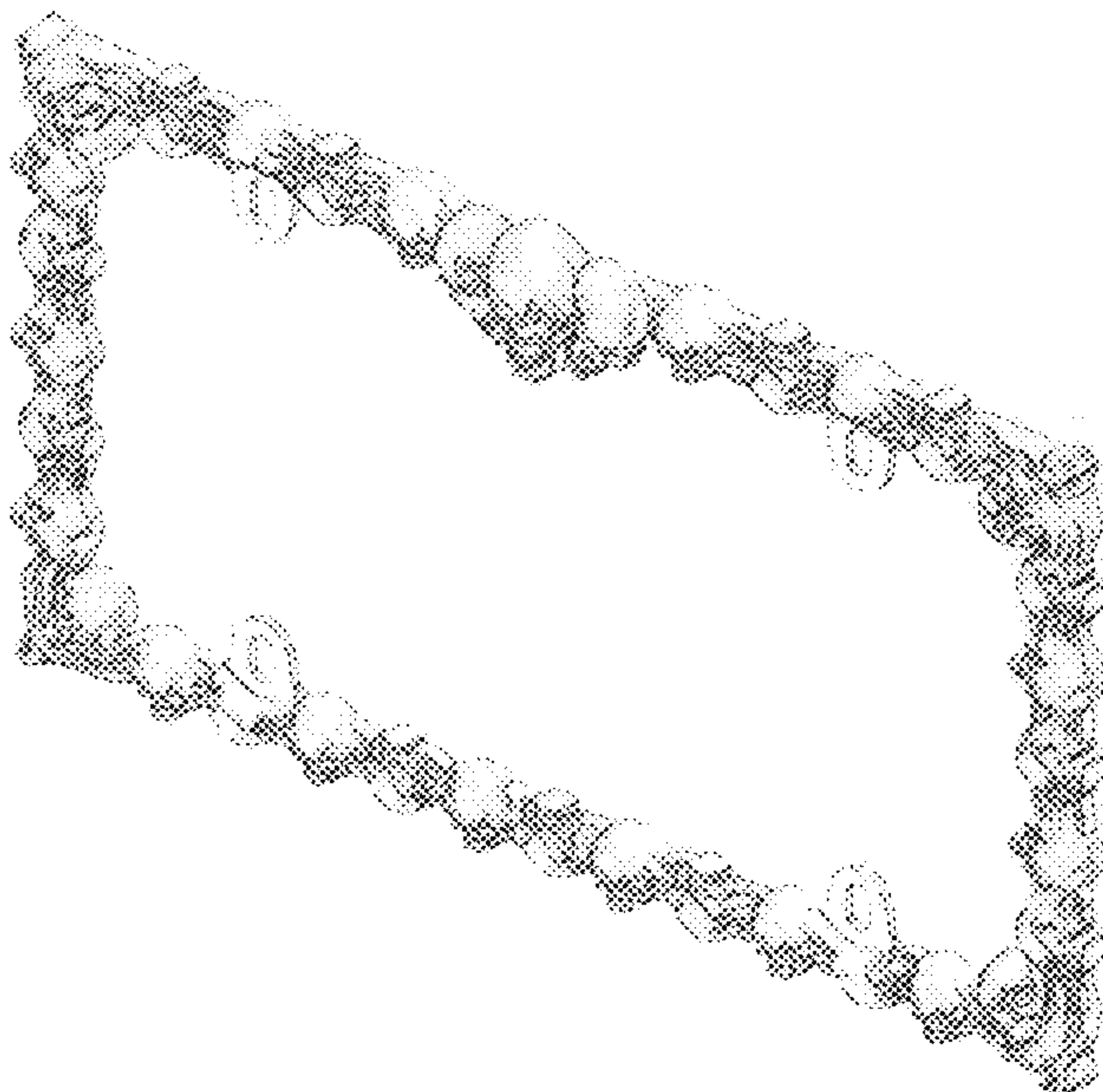
FIG. 6 is a back view of the license plate frame of the present invention.

FIG. 7 is a front view showing a second embodiment of our design for a license plate frame, with an ornament attached in a higher position on the top rung than shown in FIG. 3.

FIG. 8 is a front view showing a third embodiment of our design for a license plate frame, with an ornament attached on a bottom rung of the frame instead of on the top rung of the frame as shown in FIG. 7; and,

FIG. 9 is a front view showing a fourth embodiment of our design for a license plate frame, with an ornament attached in a higher position than shown in FIG. 8.

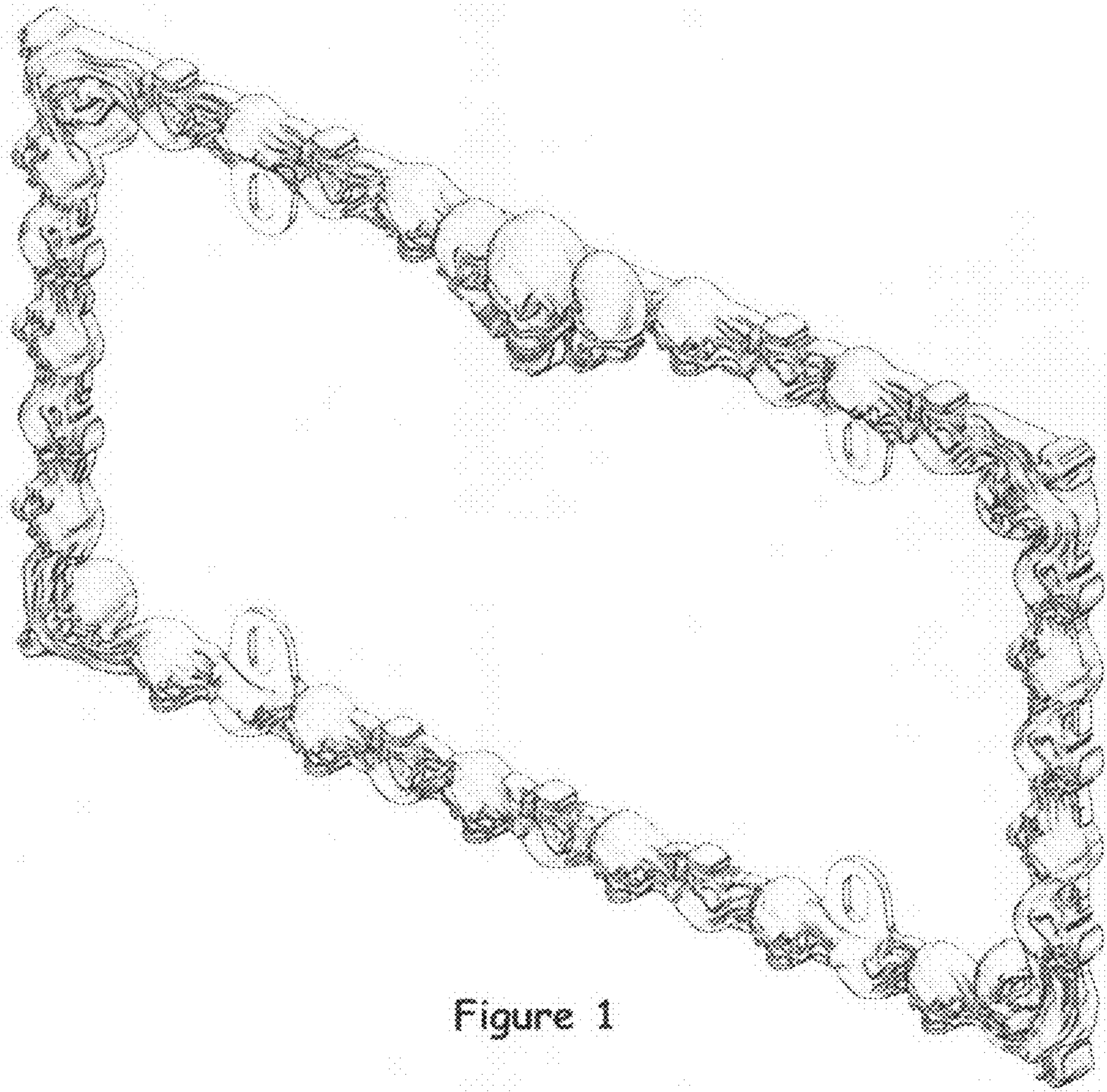

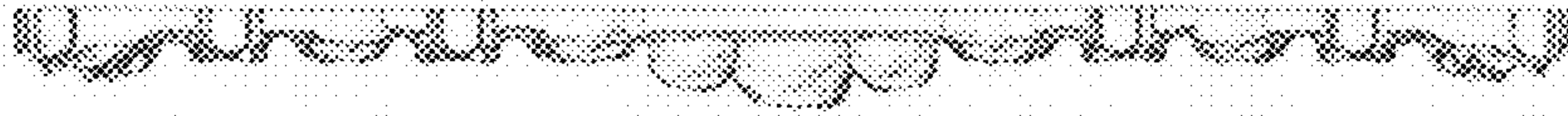

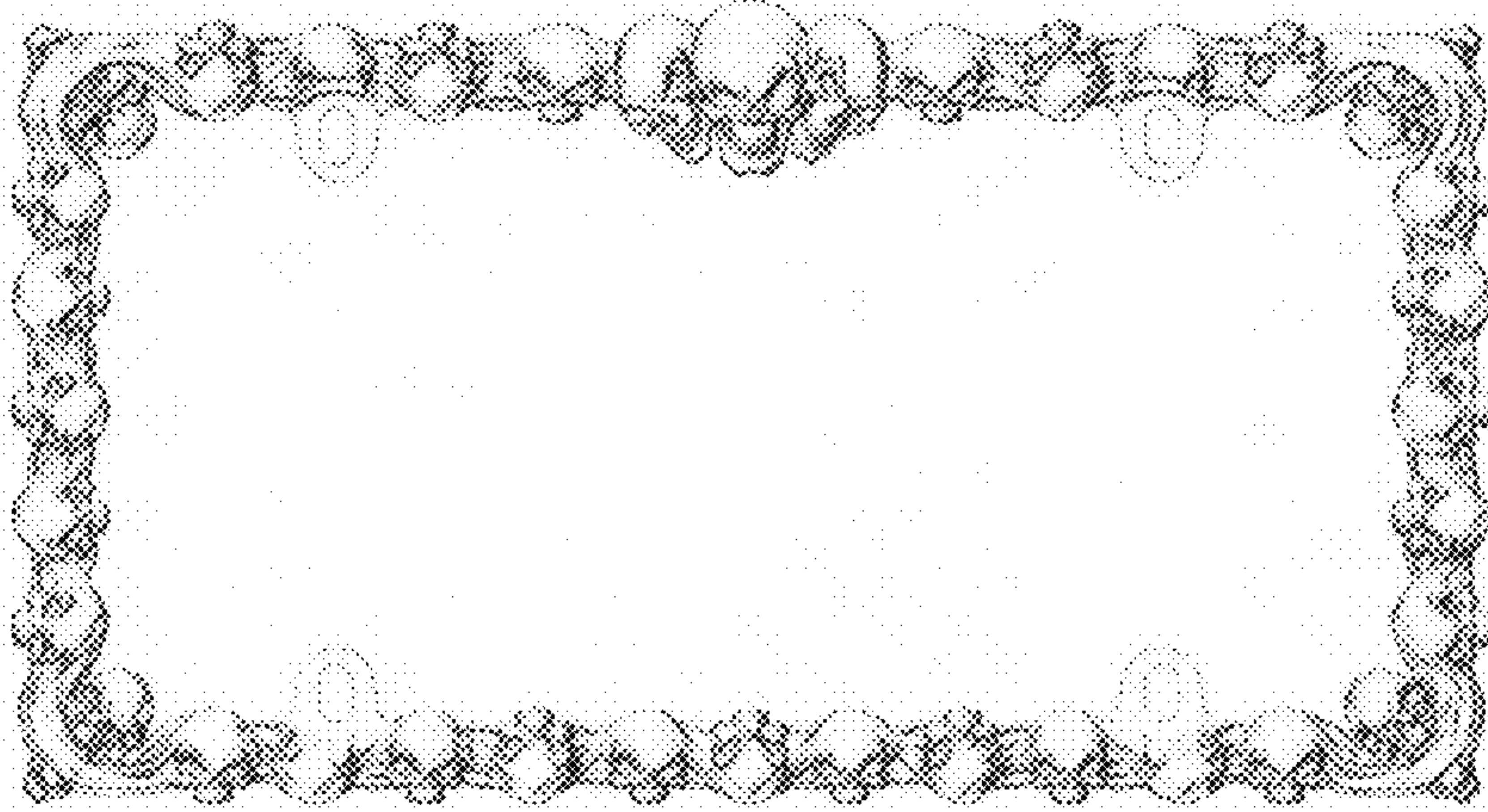

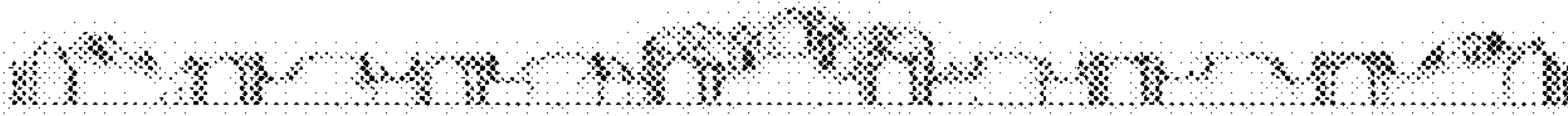
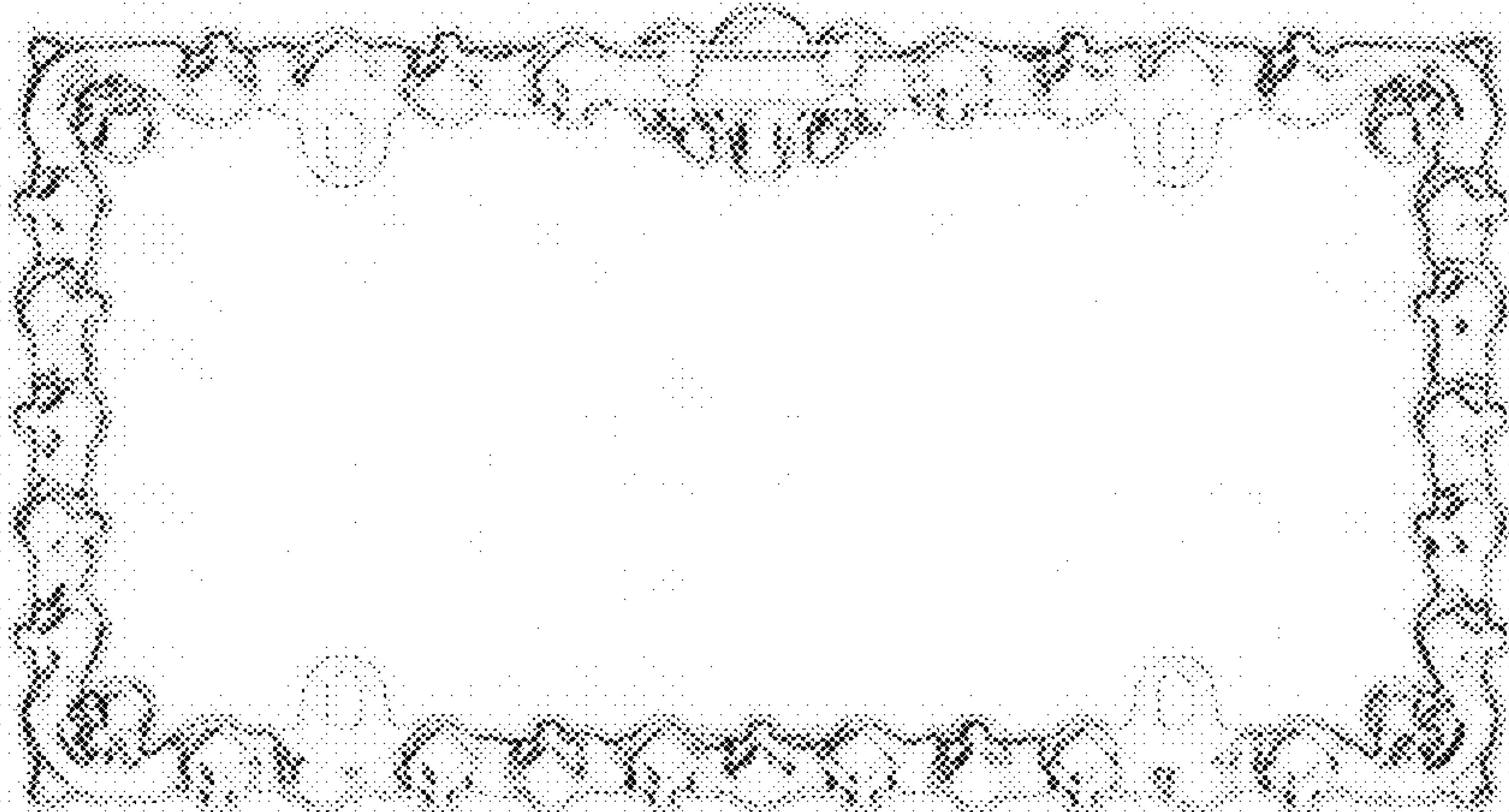

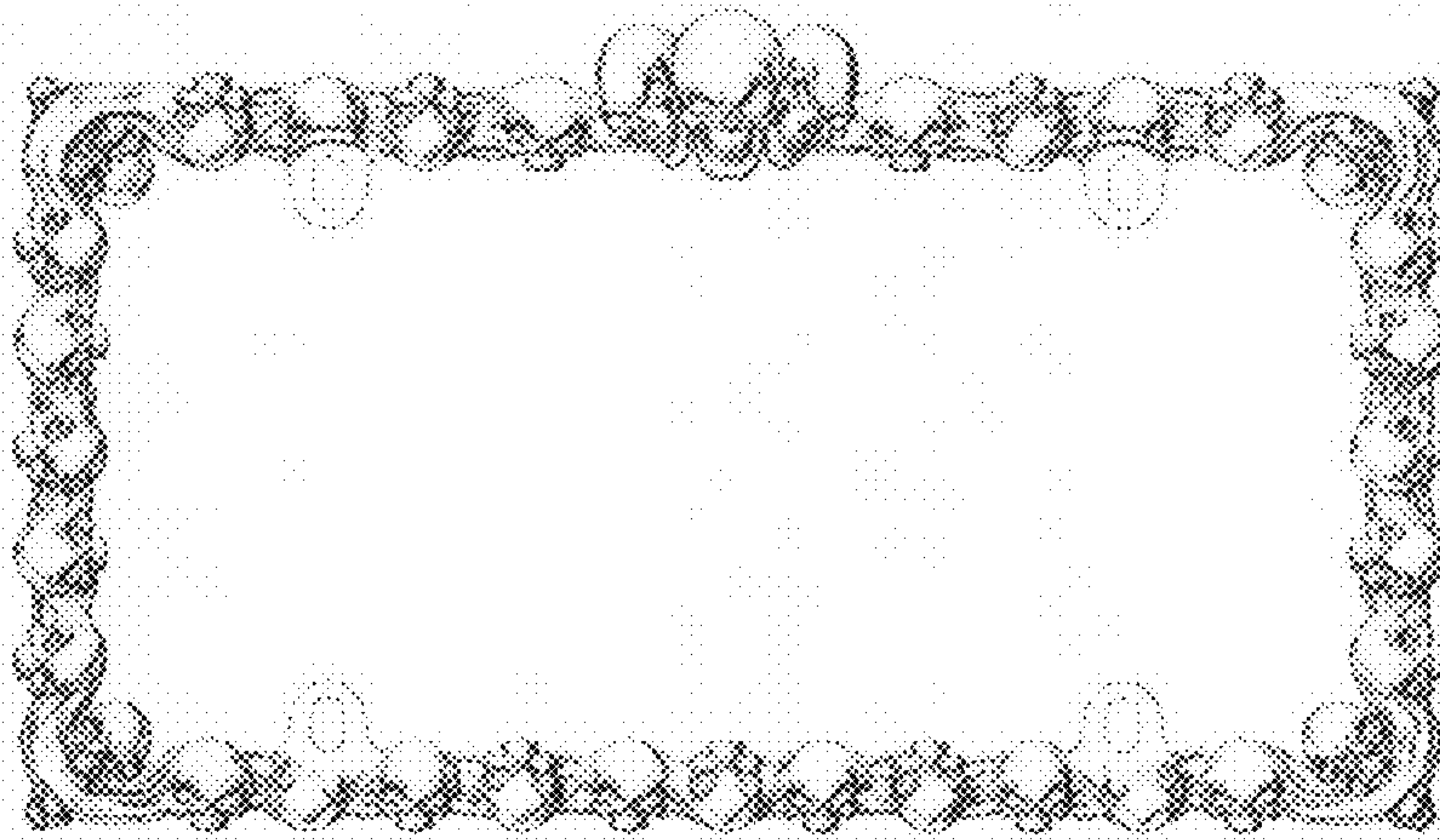

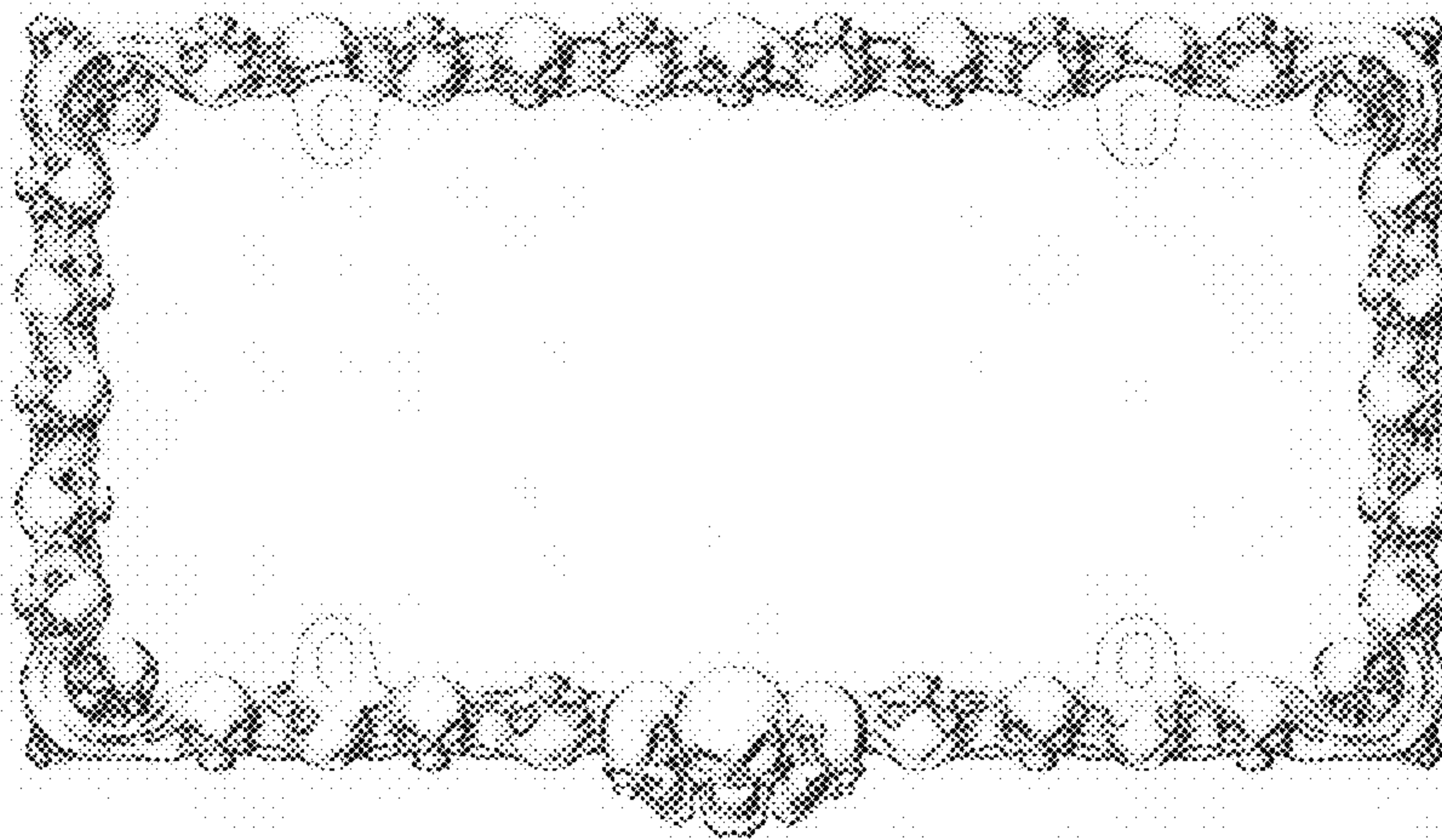

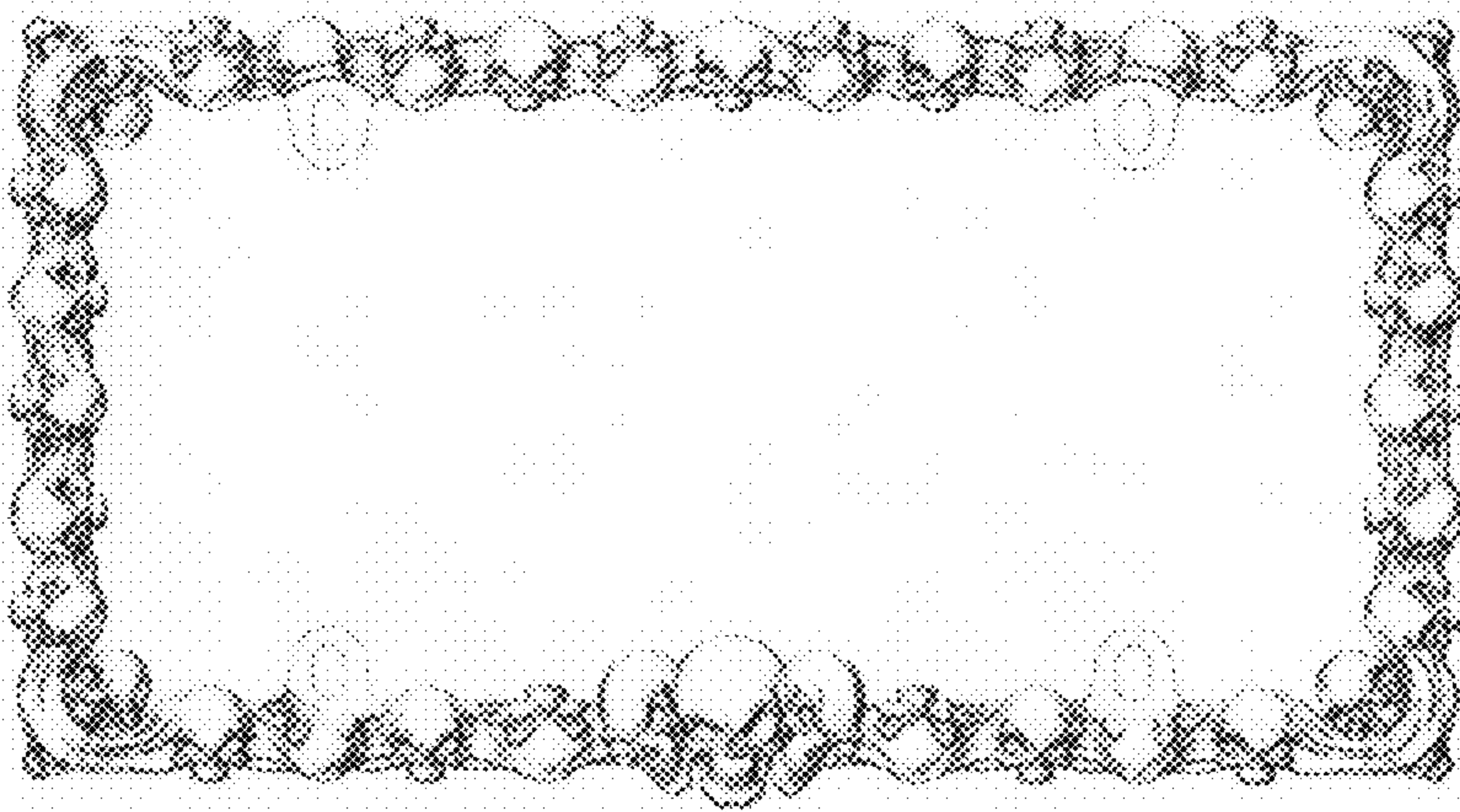
