The ornamental design for a vehicle floor tray, as shown and

**DESCRIPTION**

substantially along Line 3-3 of FIG. 2;

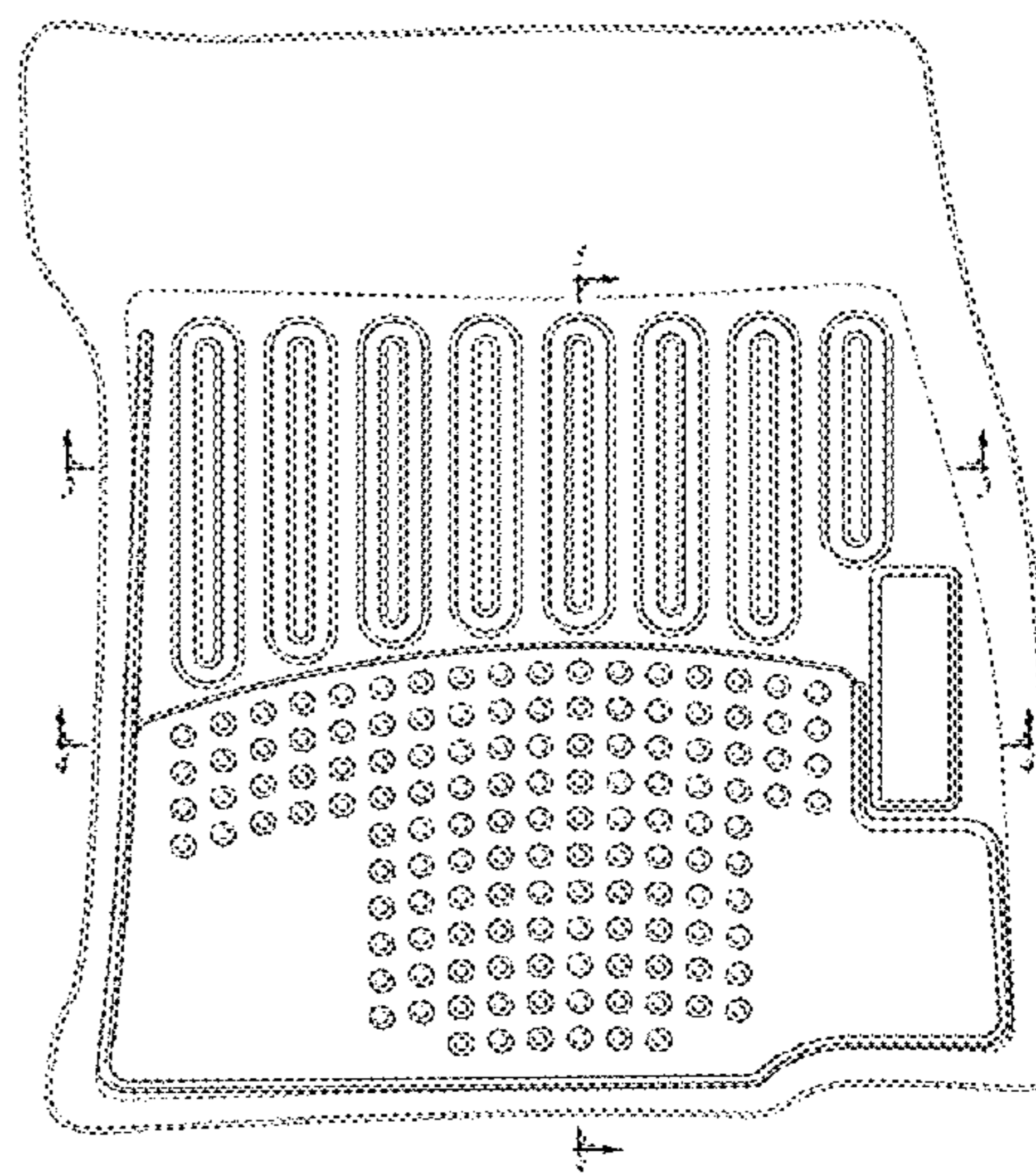
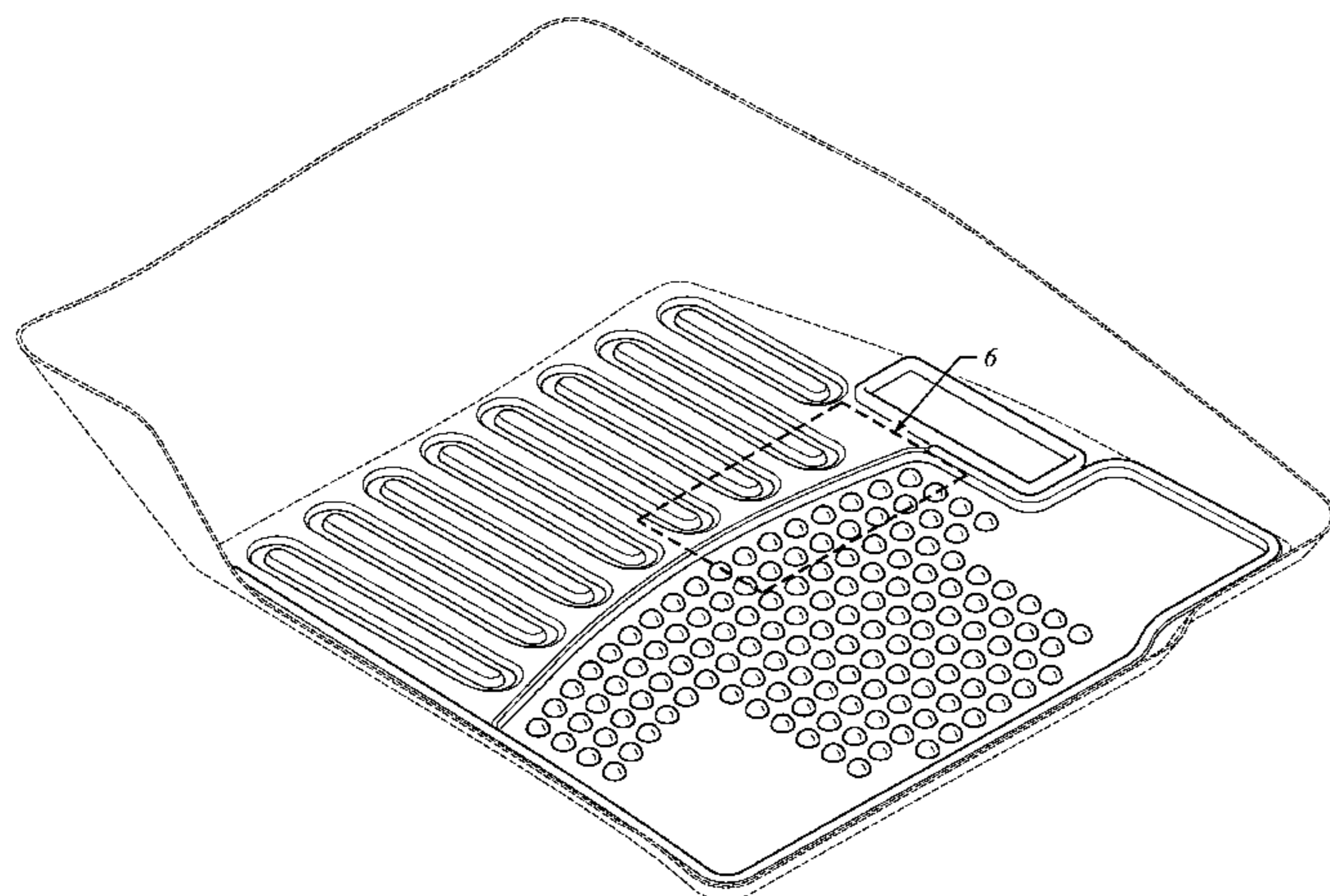
FIG. 4 is an enlarged sectional view of our design taken

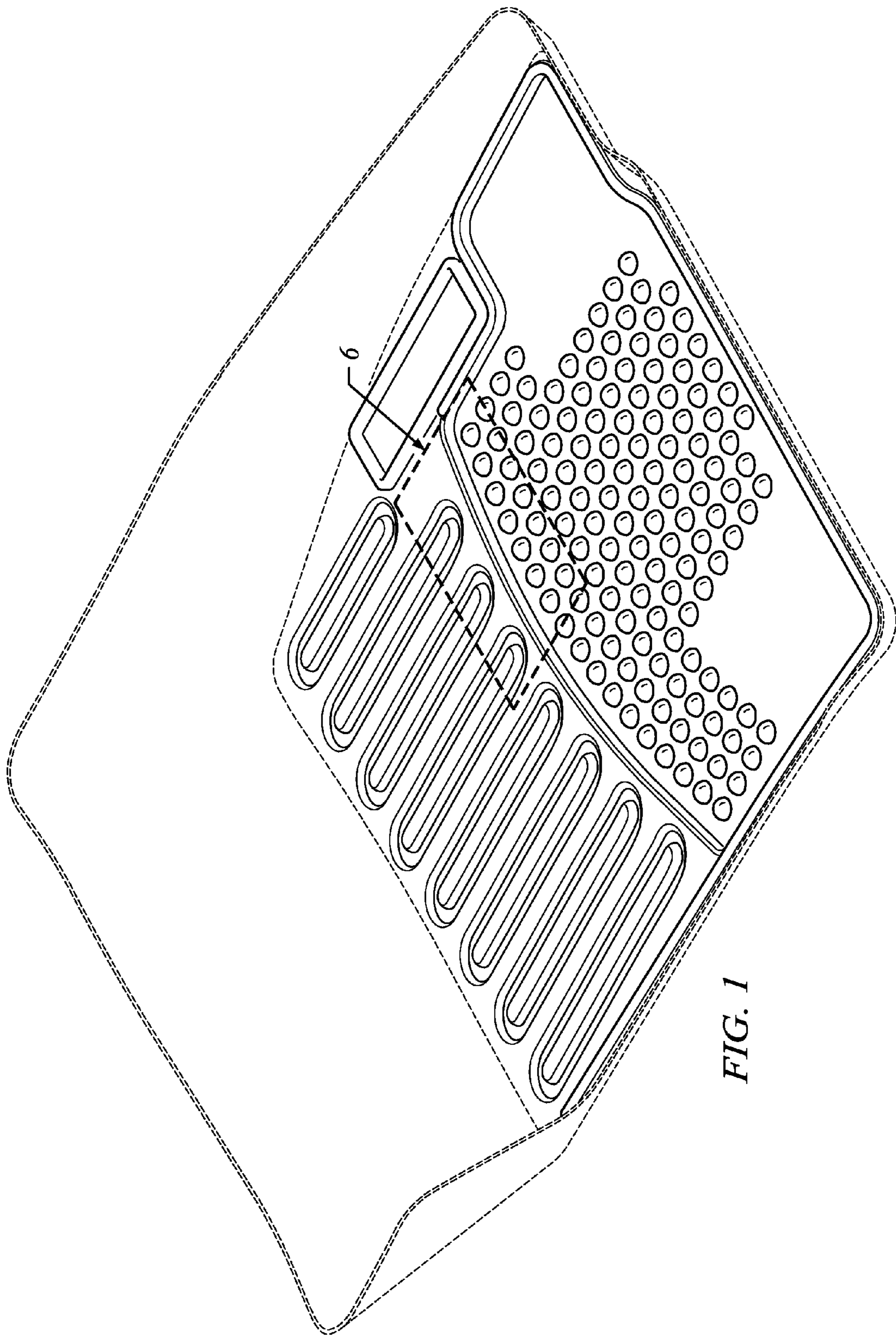

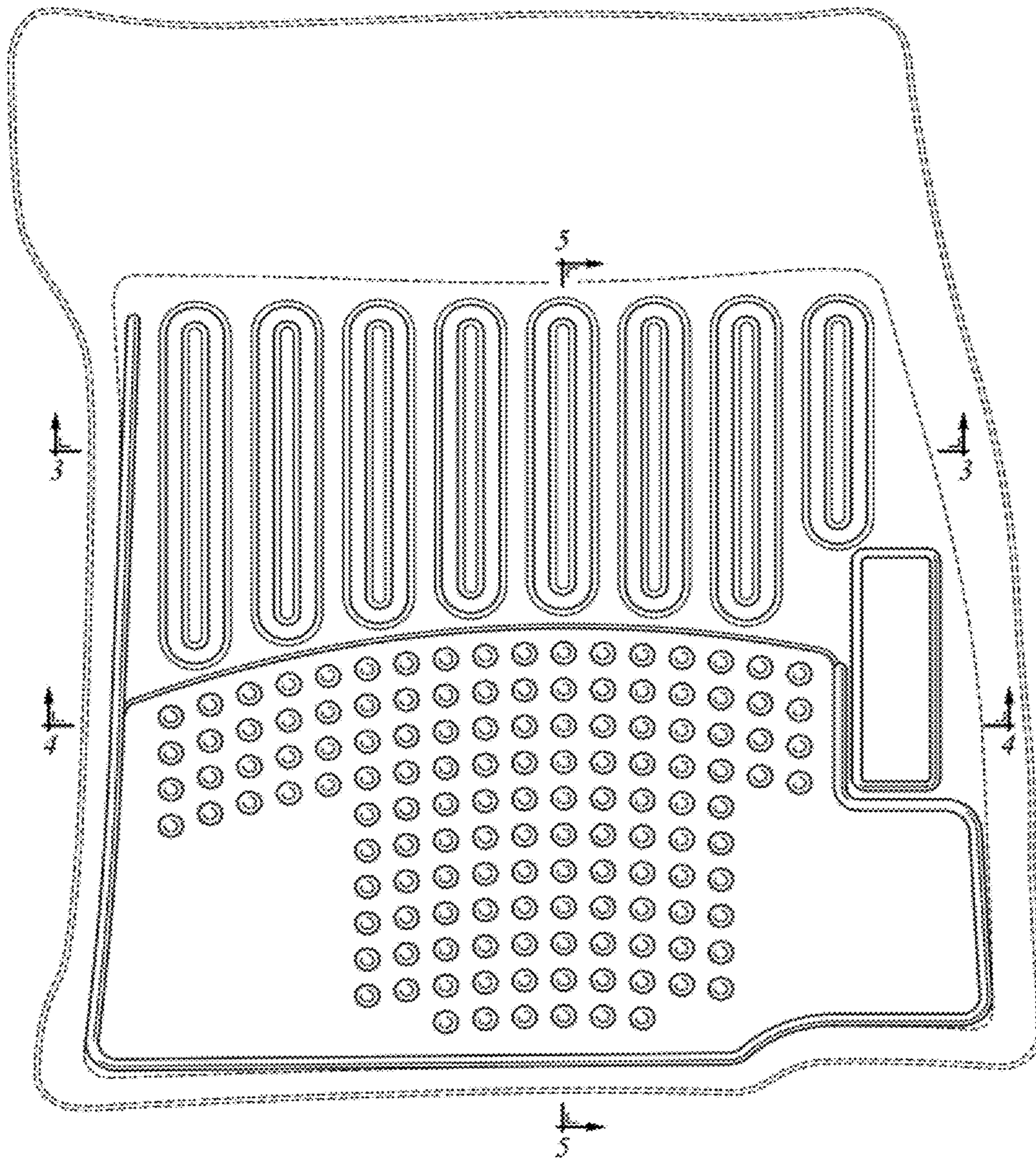

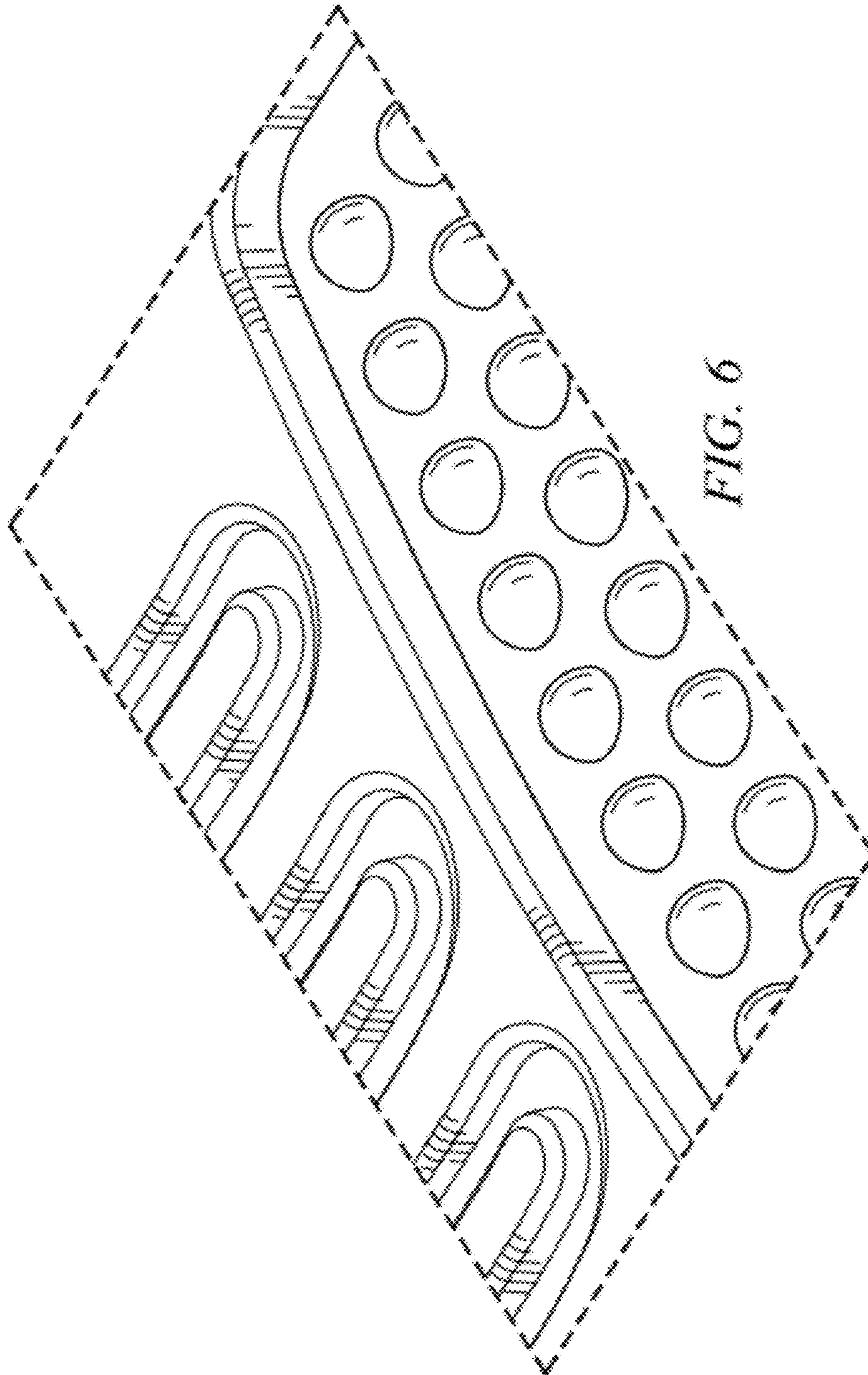
