(57) **CLAIM**

We claim the ornamental design for a charger for a lighting device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the charger for the lighting device with the lighting device attached.

FIG. 2 is a second front perspective view of the design.

FIG. 3 is a bottom perspective view of the design.

FIG. 4 is a right side view of the design. The left side view is a mirror image of the right side view.

FIG. 5 is a top view of the design.

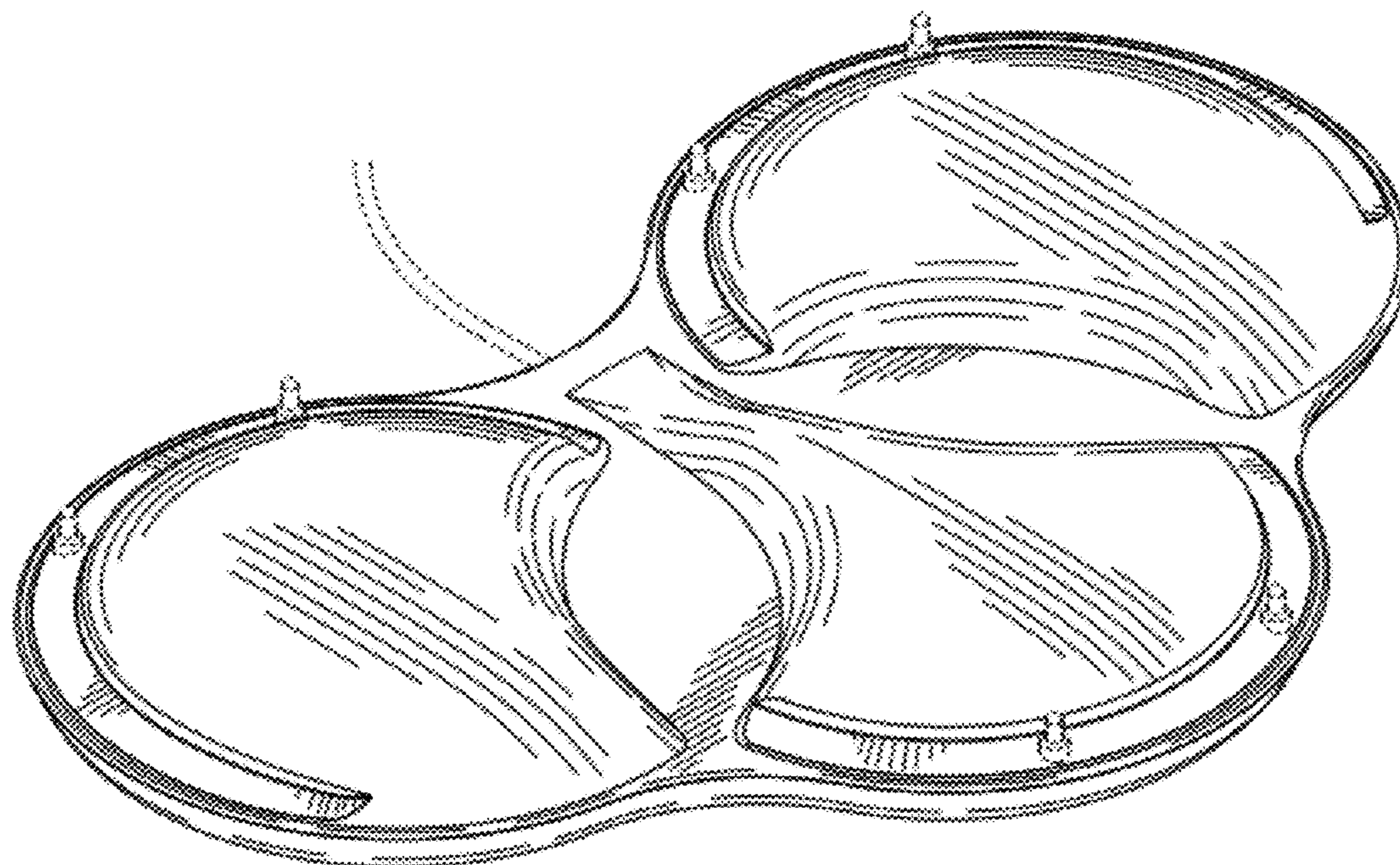
FIG. 6 is a bottom view of the design.

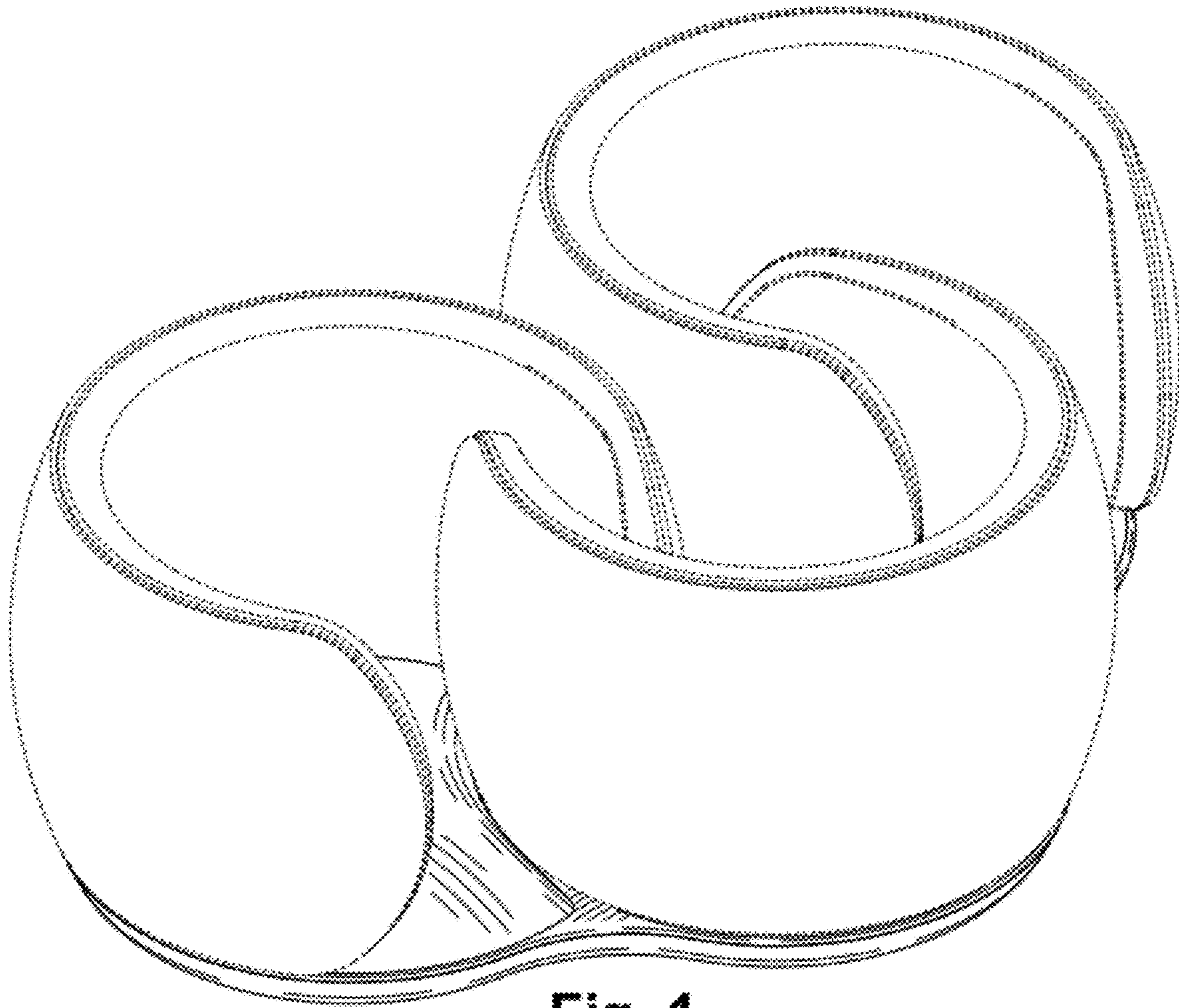

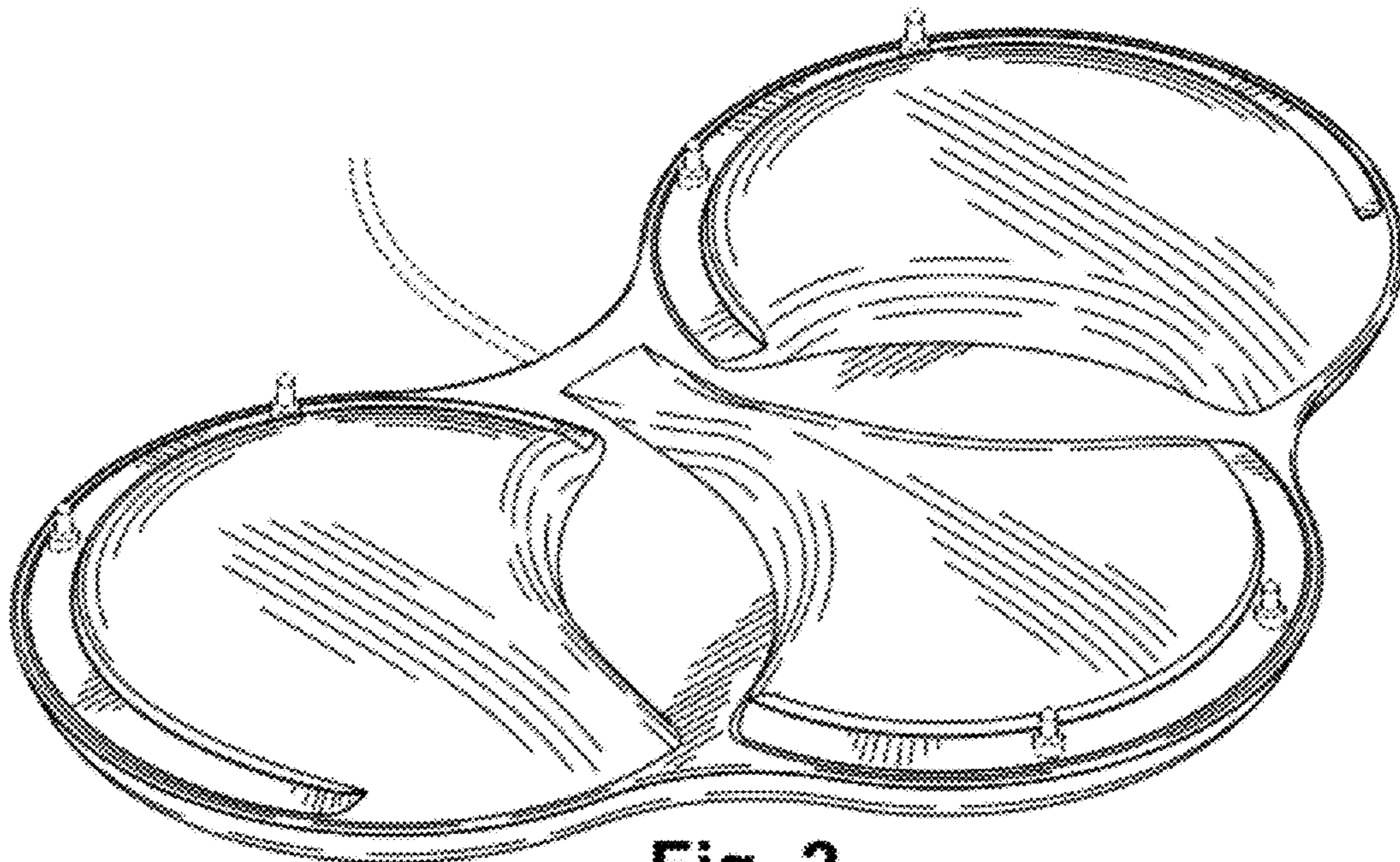

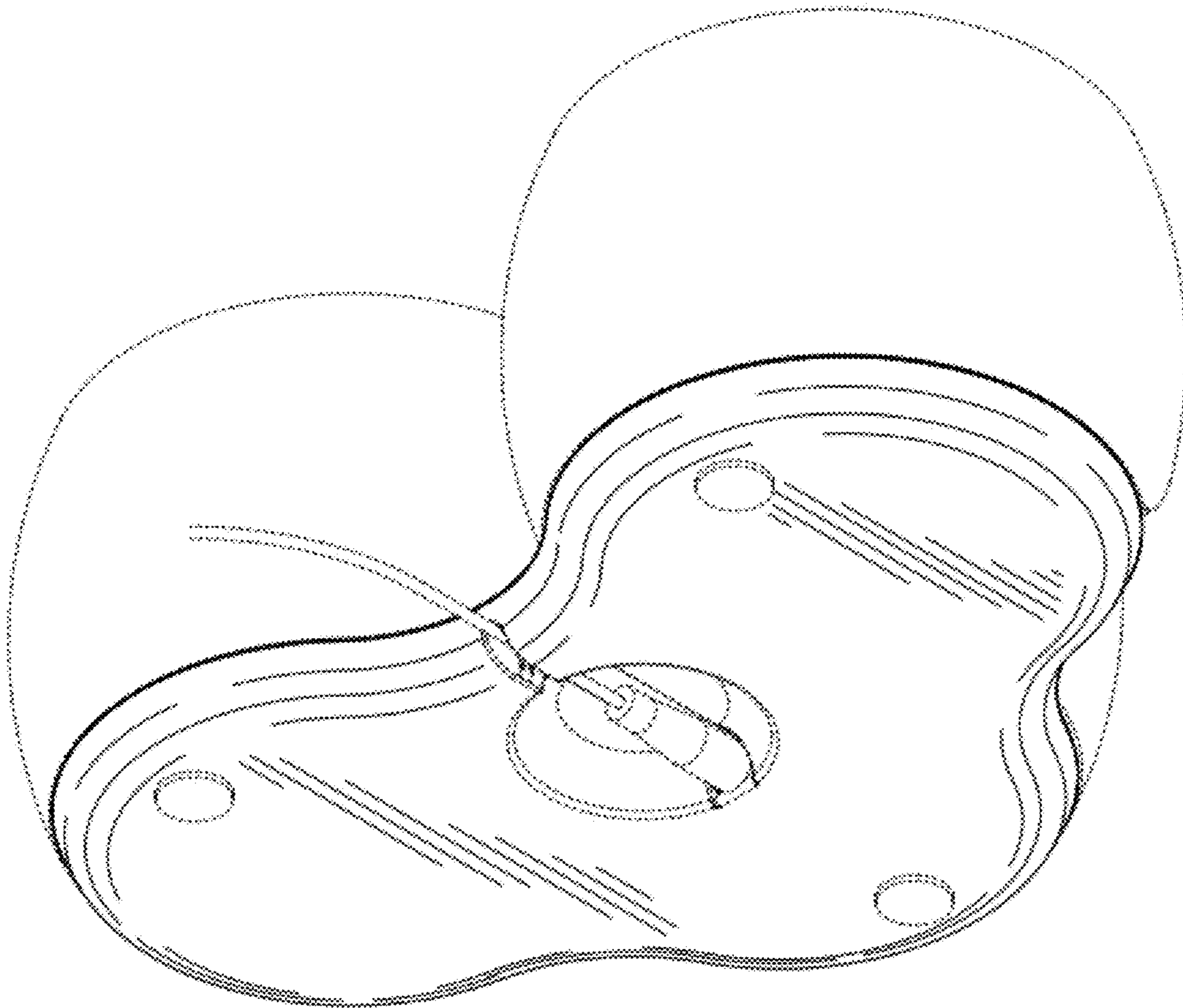

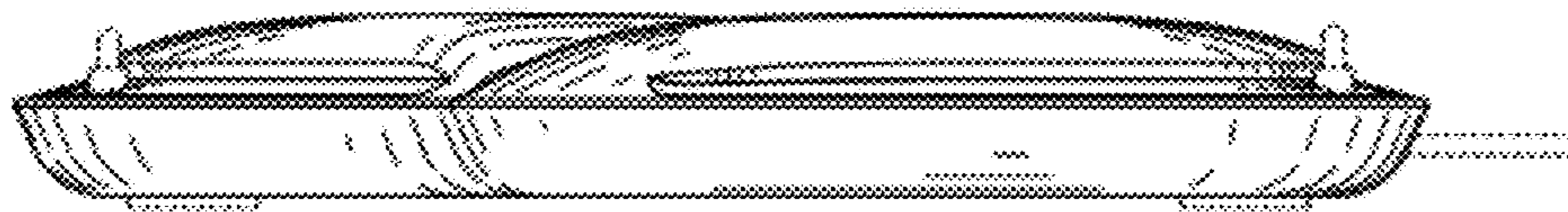

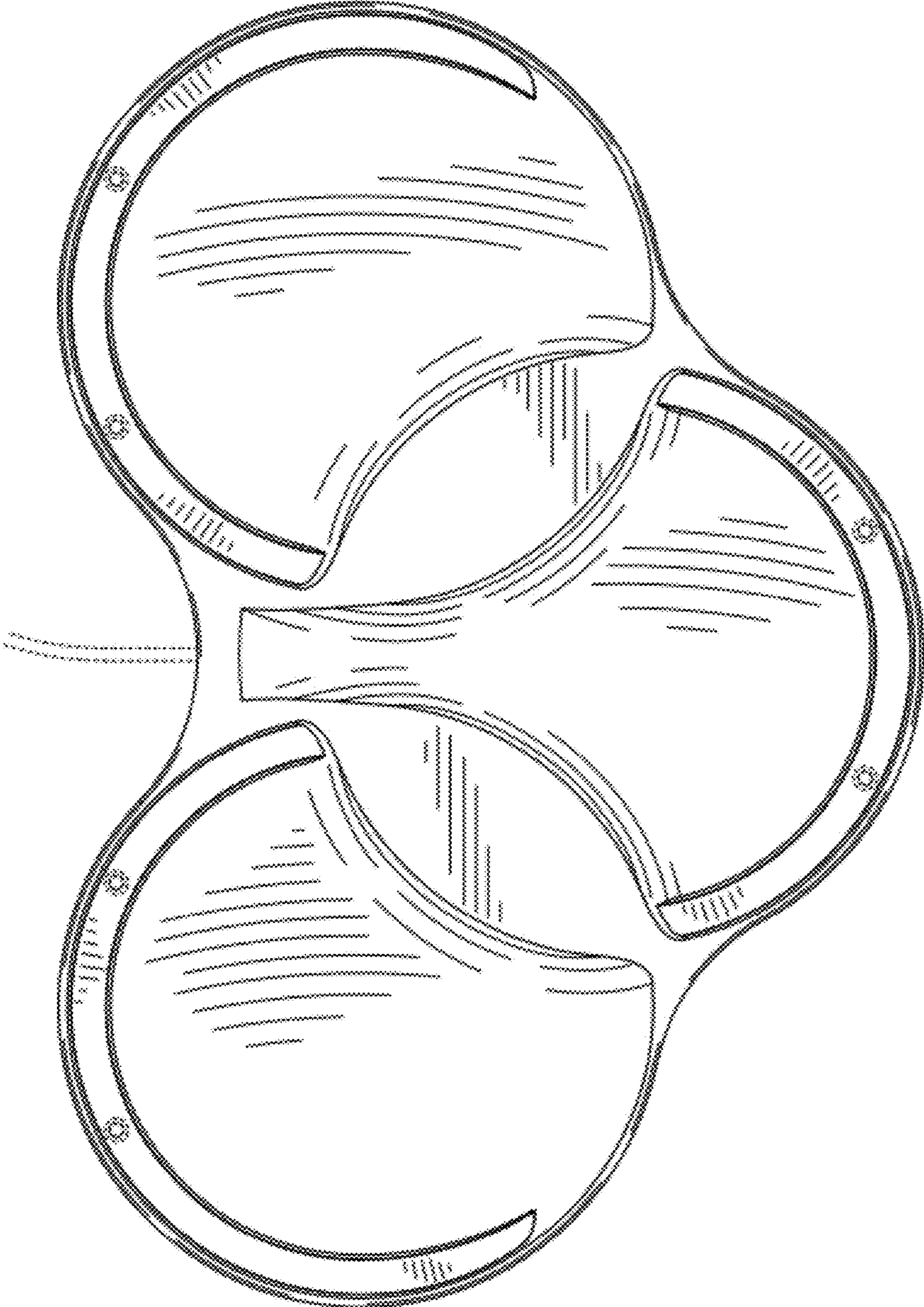

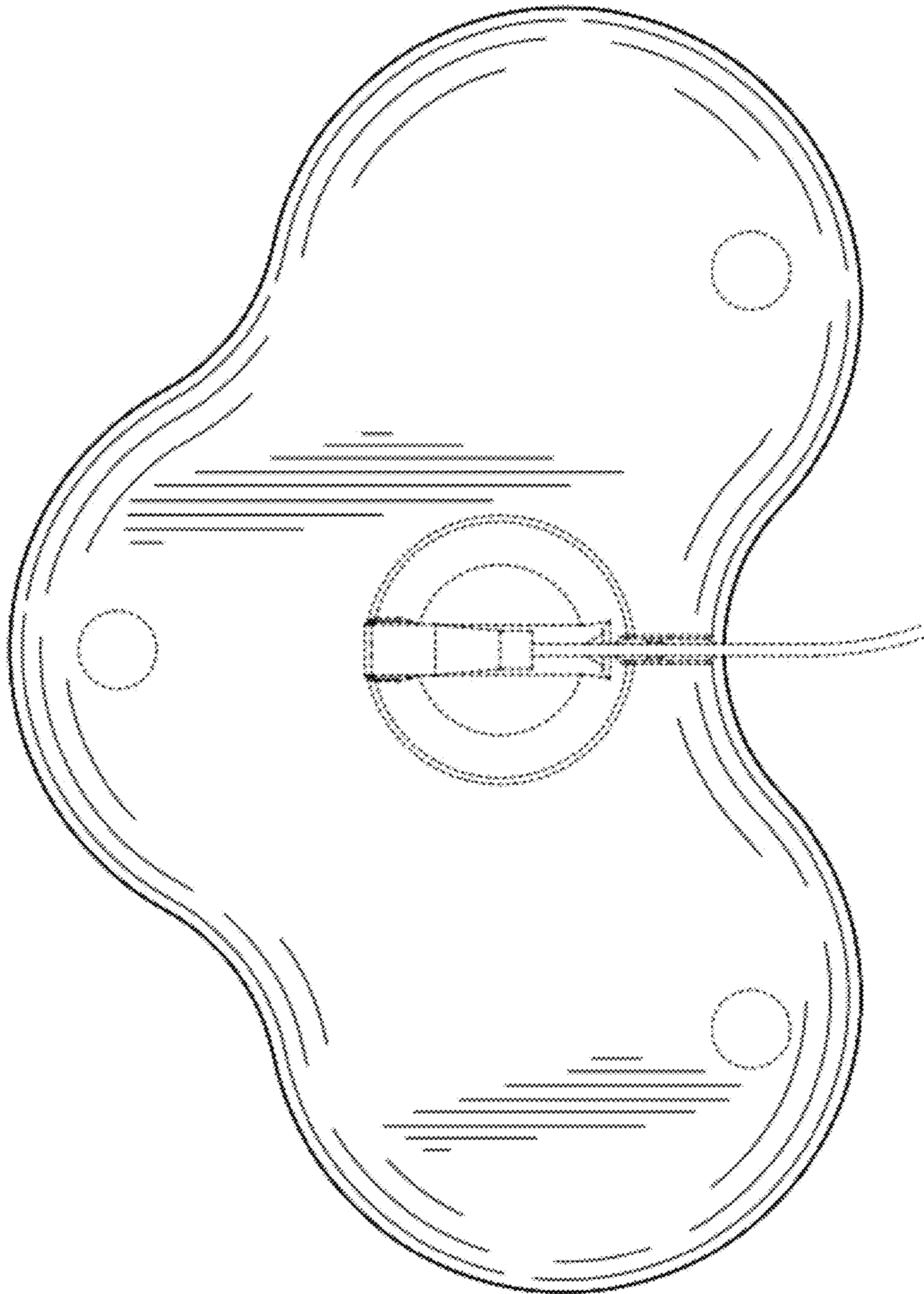

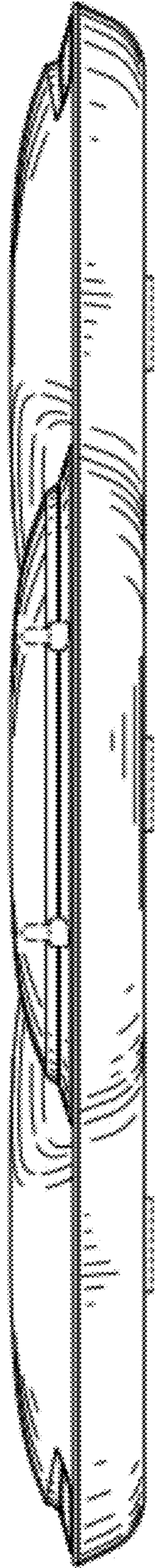

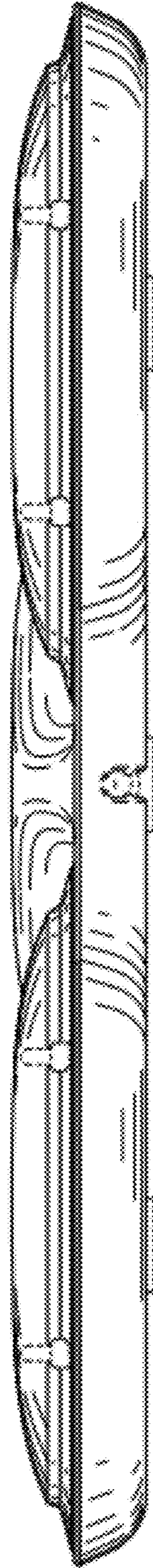
