The ornamental design for a tire pump, as shown and described.

**DESCRIPTION**

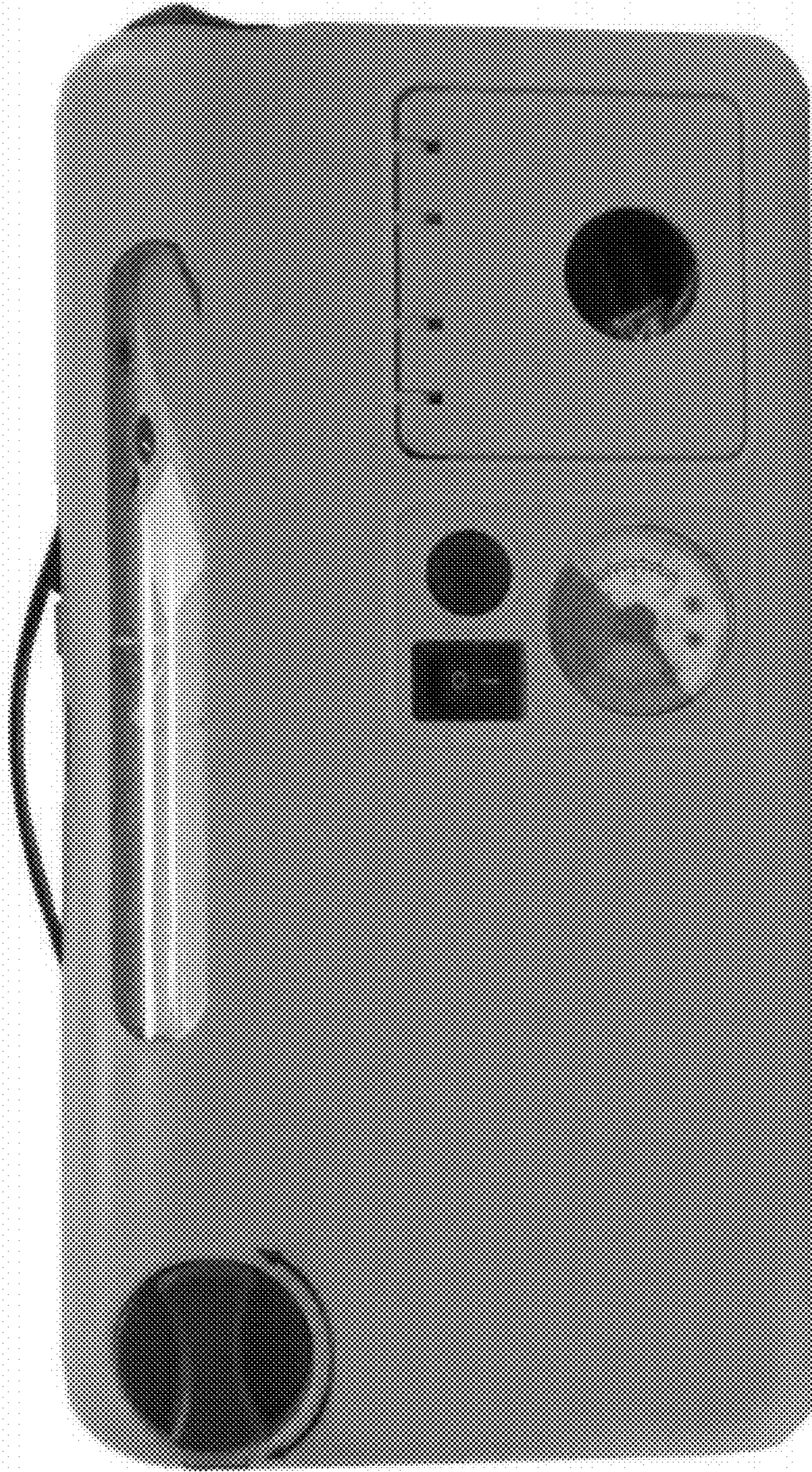

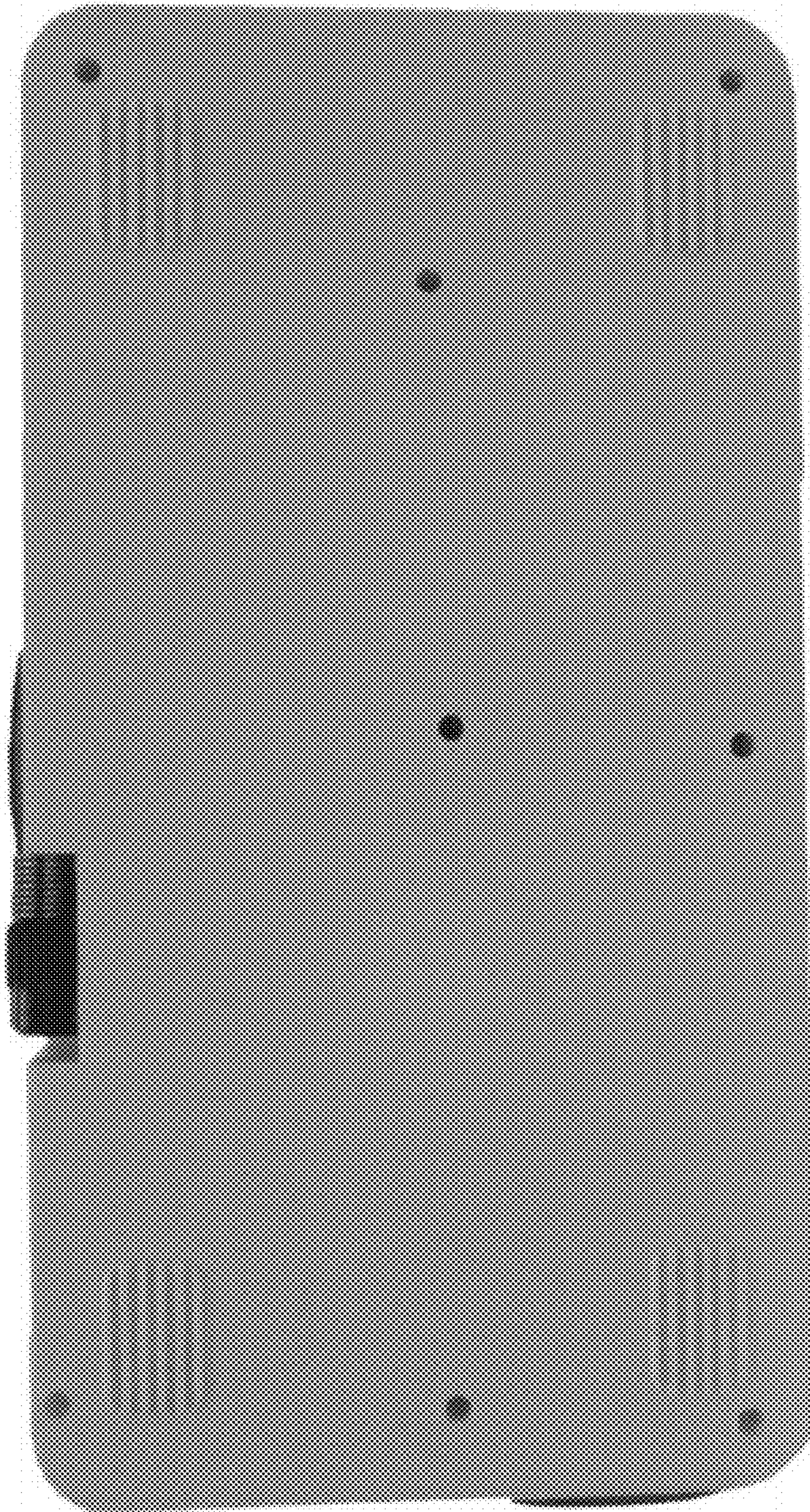

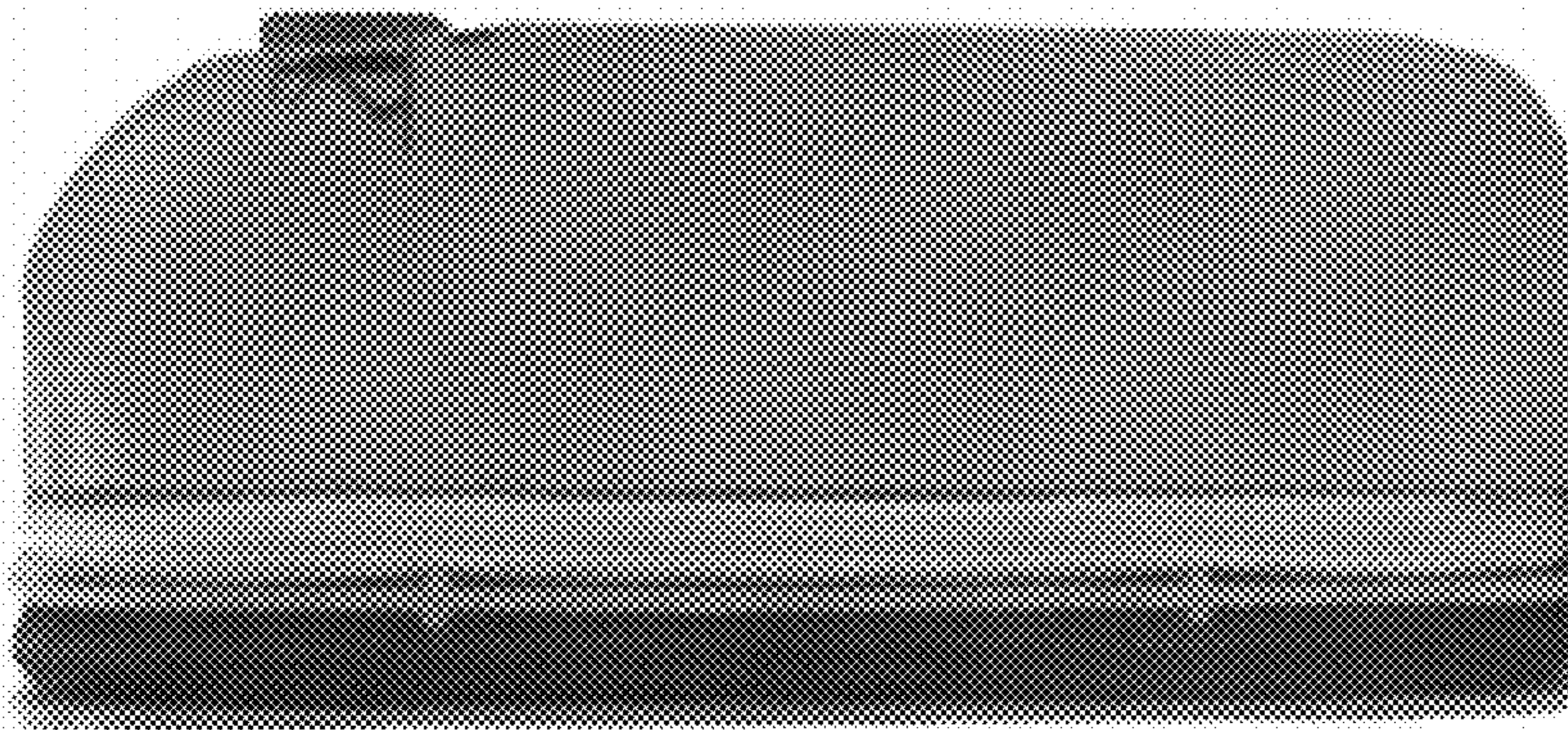

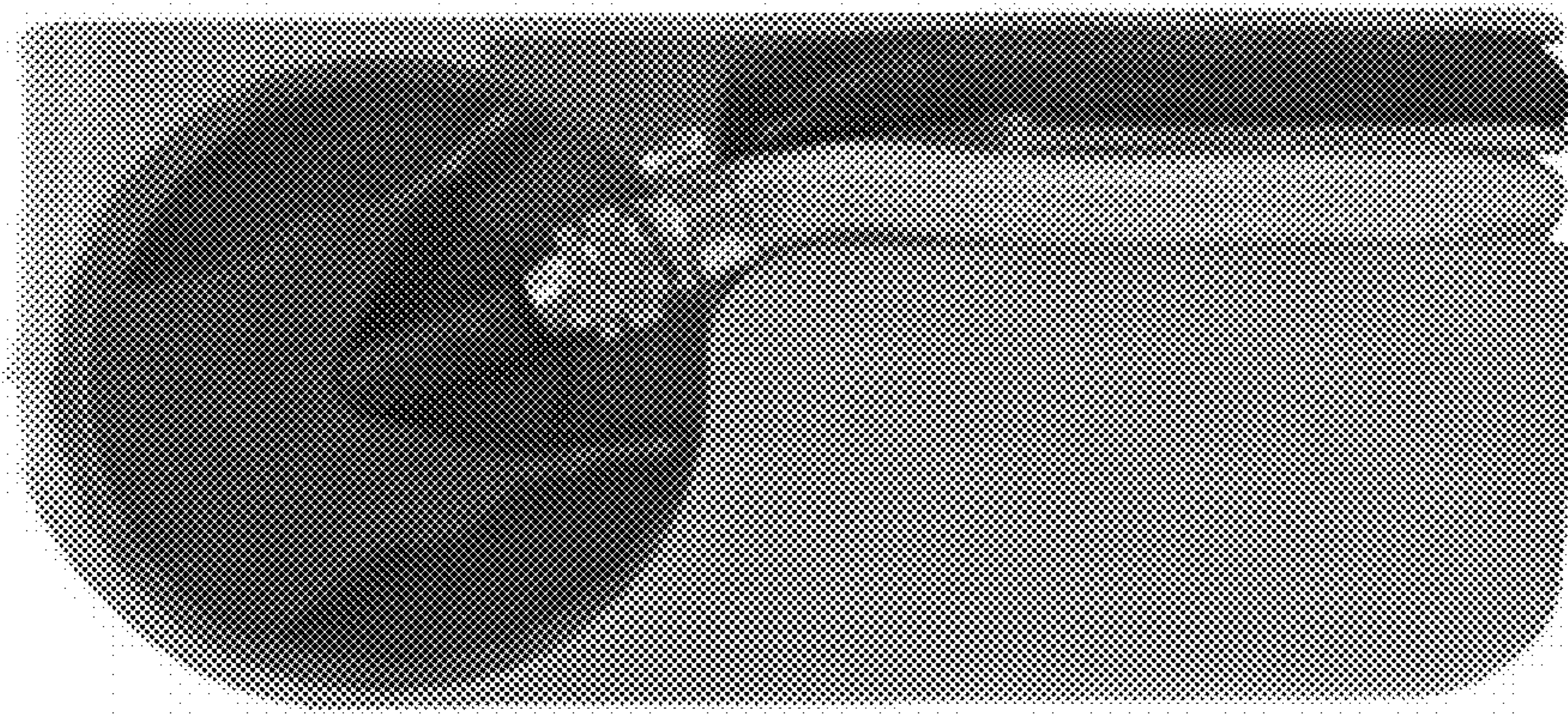

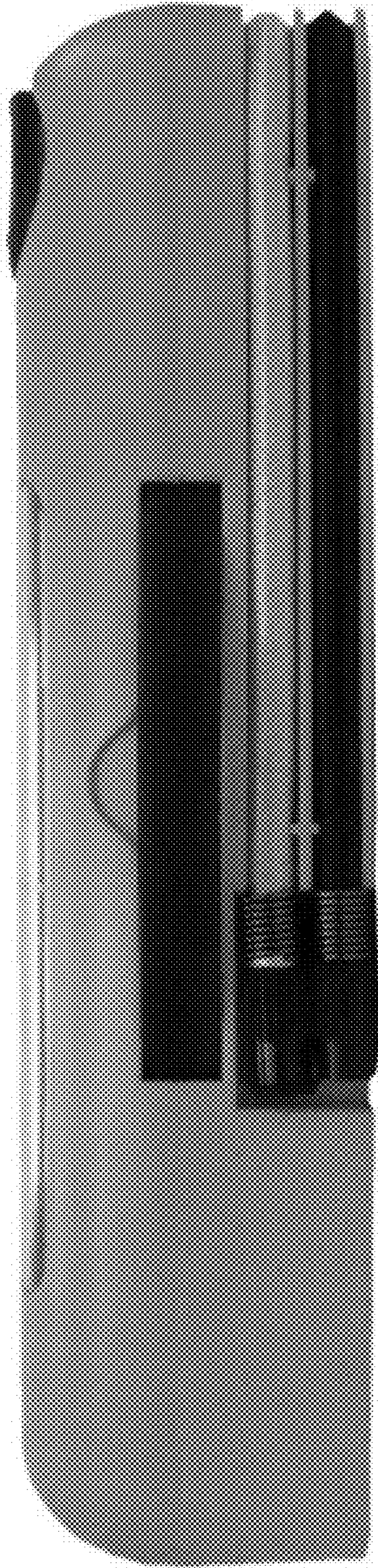

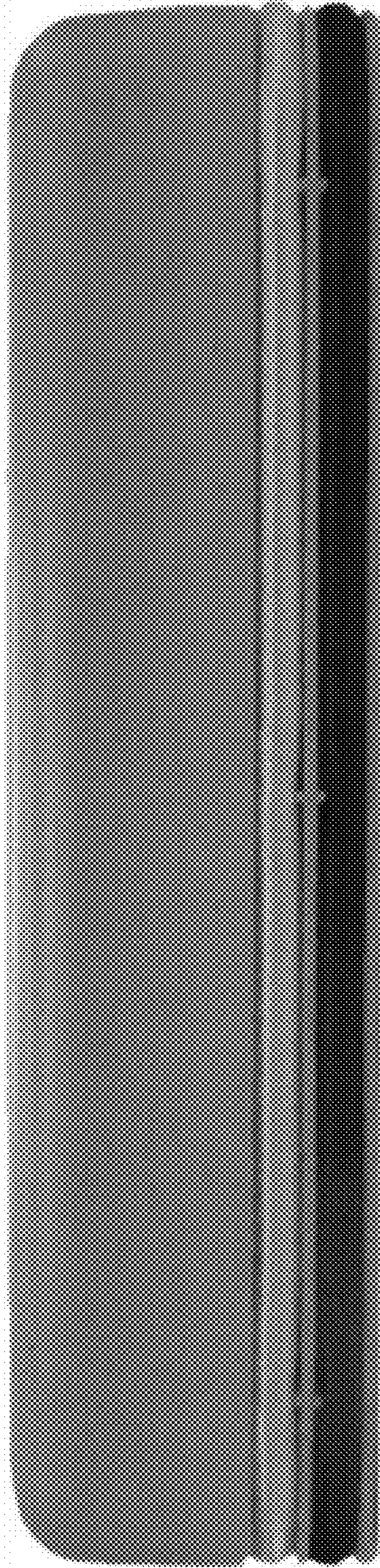

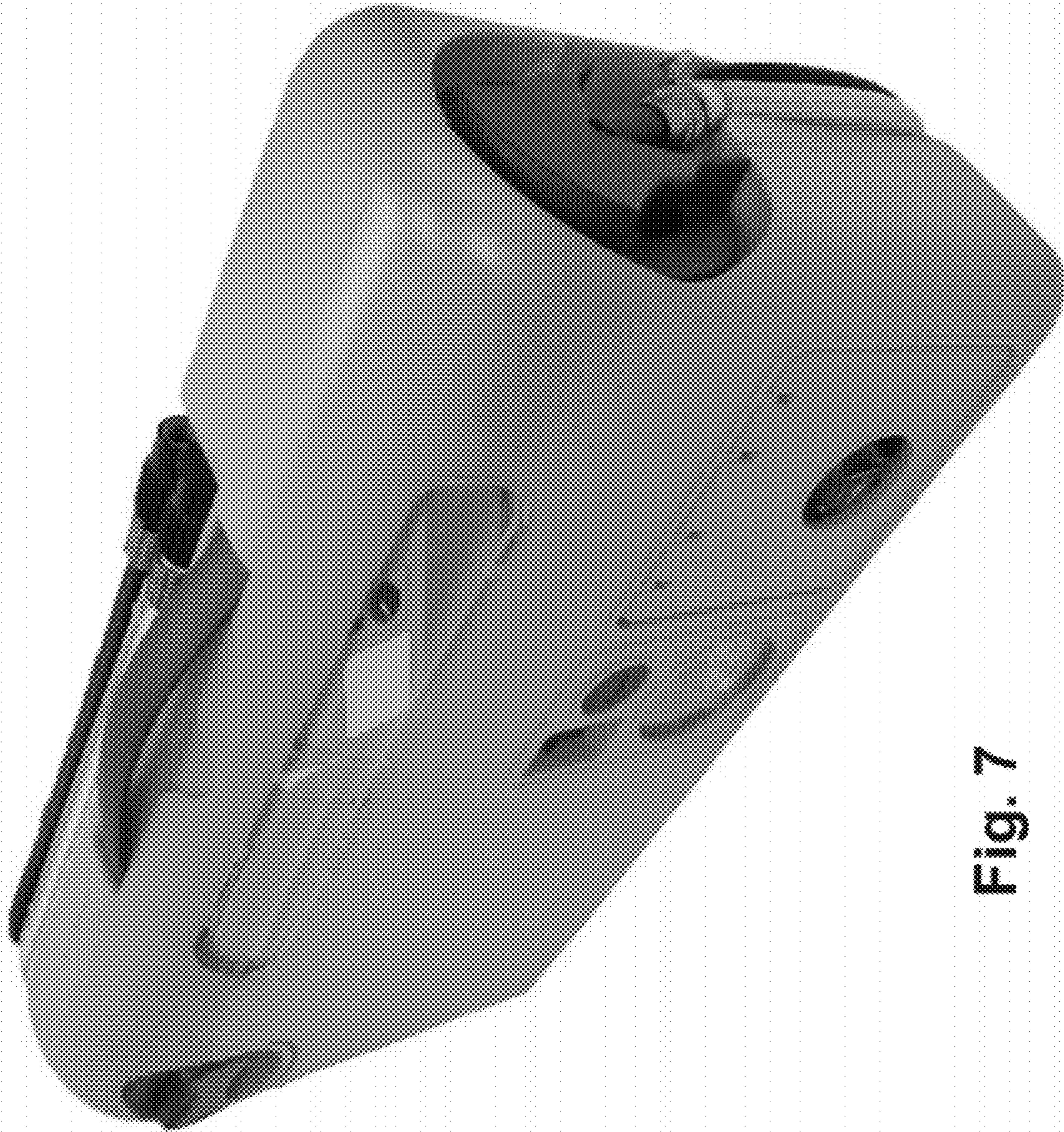
