FIG. 4 is a bottom plan view of an embodiment of a helicopter fuselage frame.

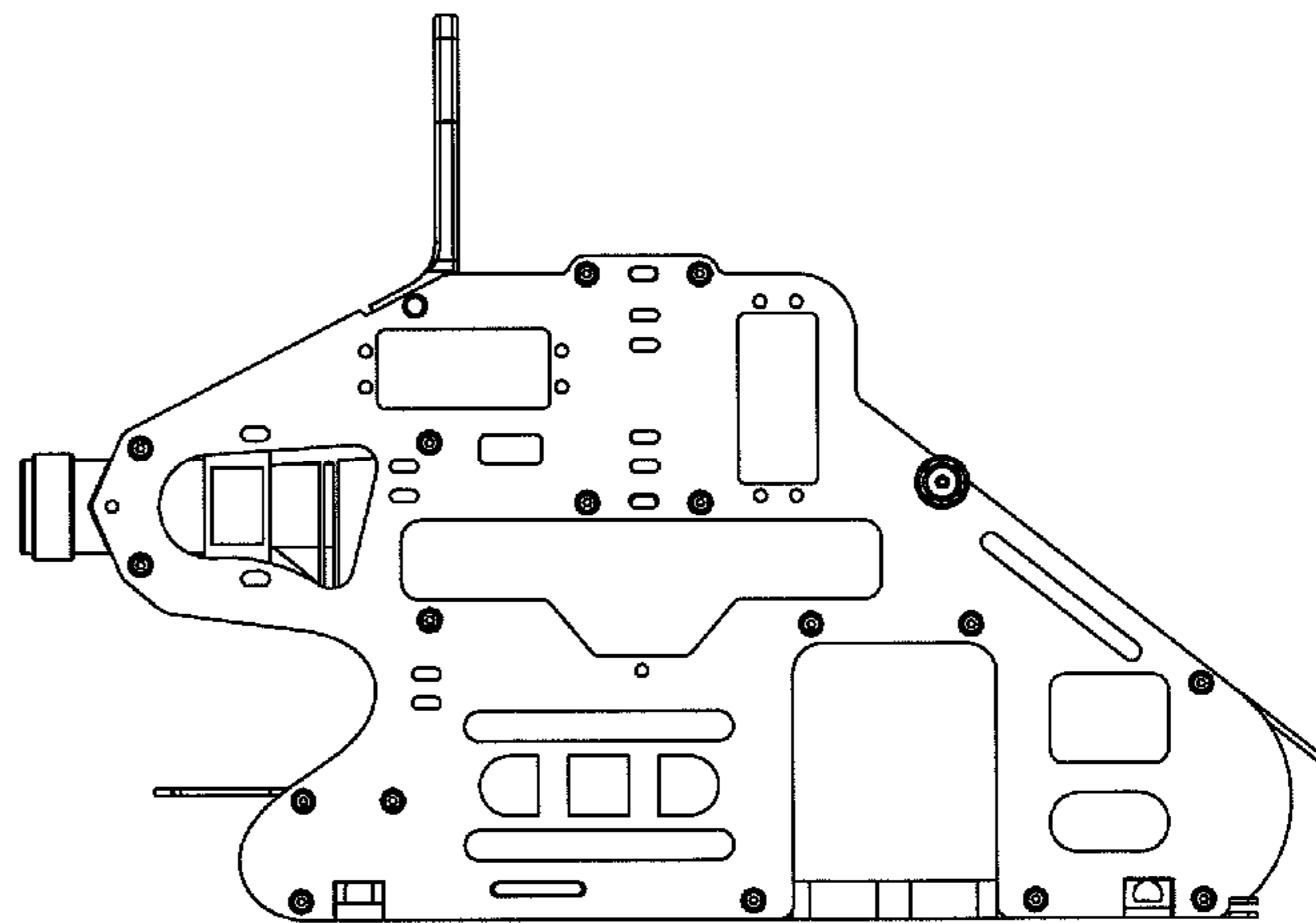
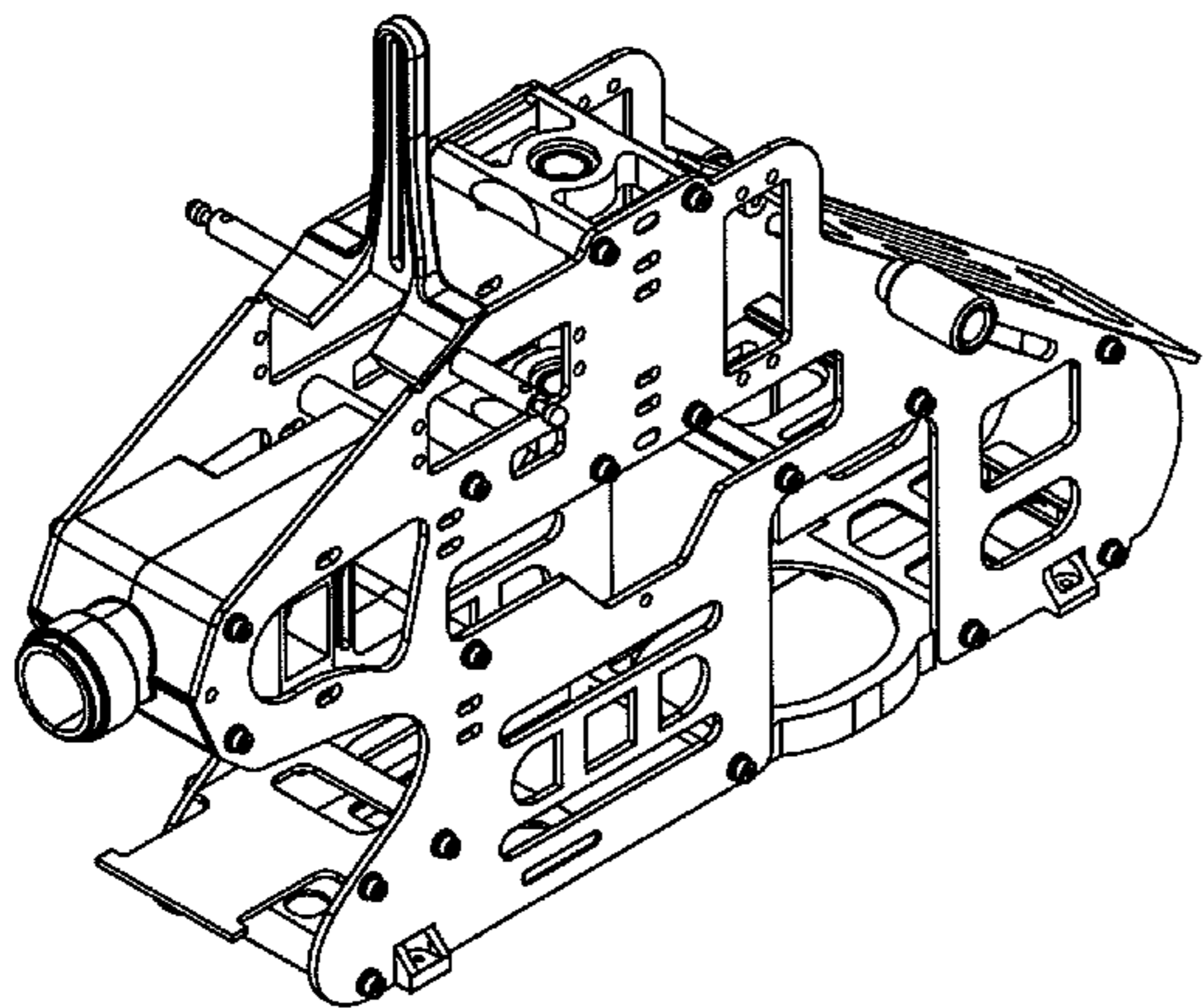
FIG. 5 is a front elevational view of an embodiment of a helicopter fuselage frame.

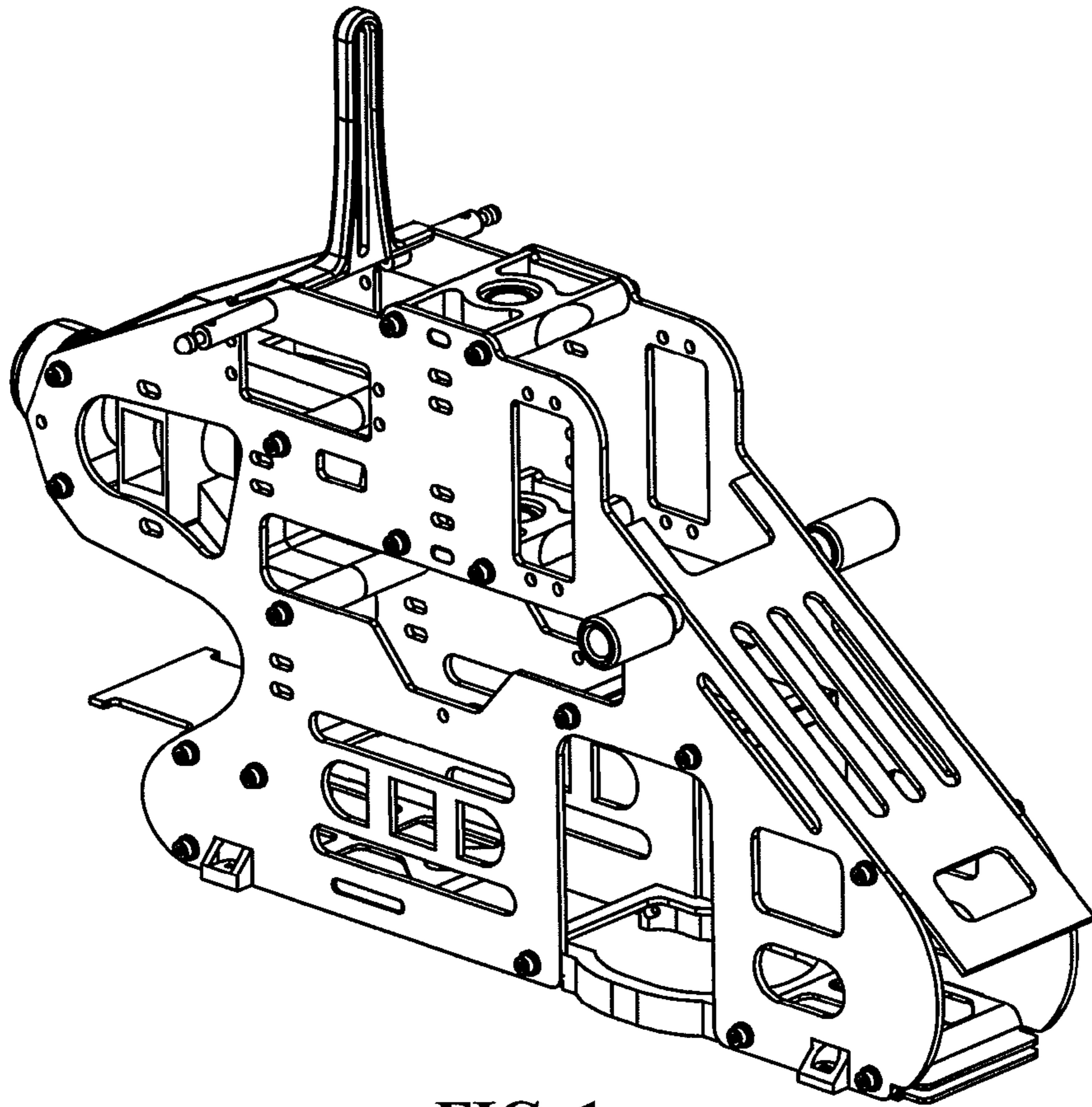

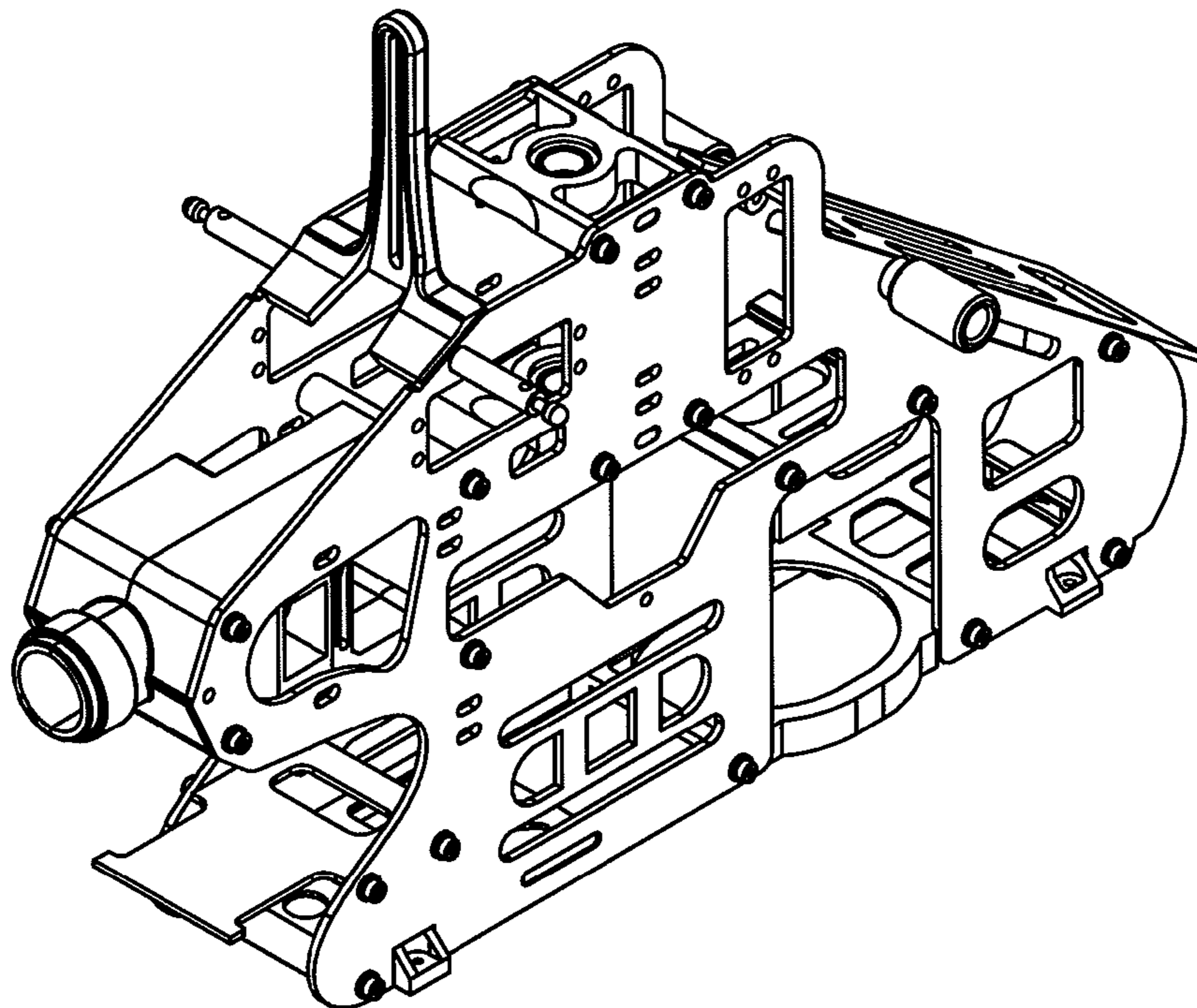

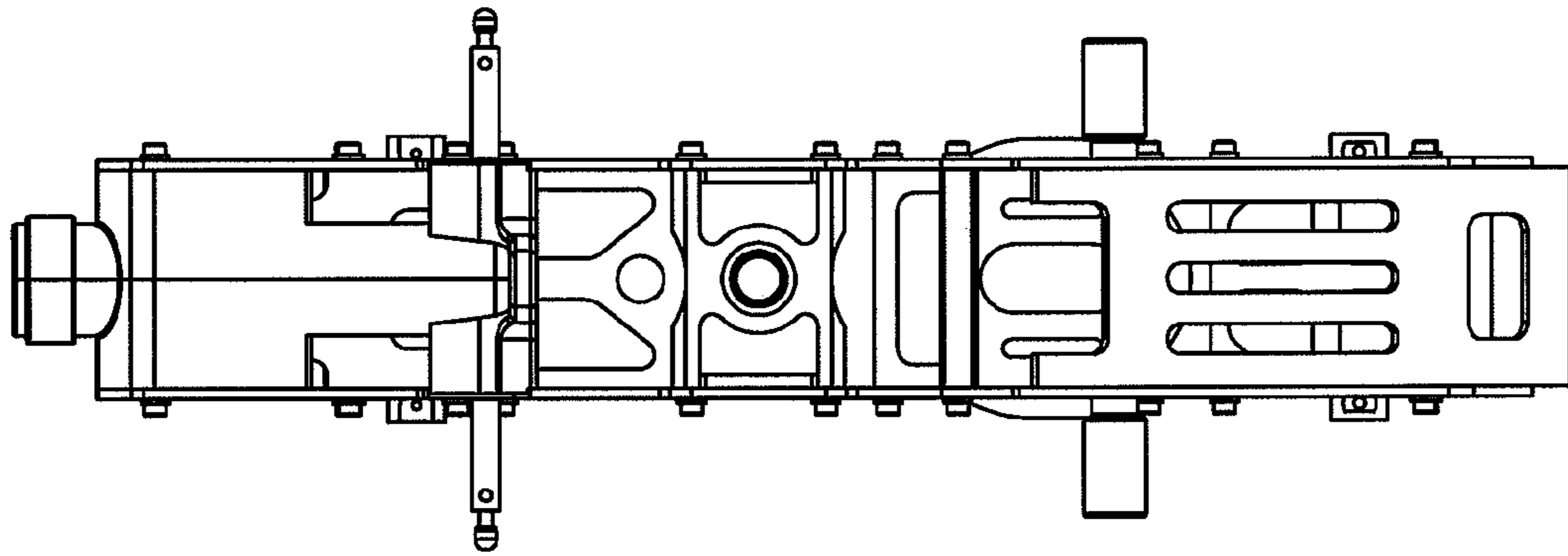

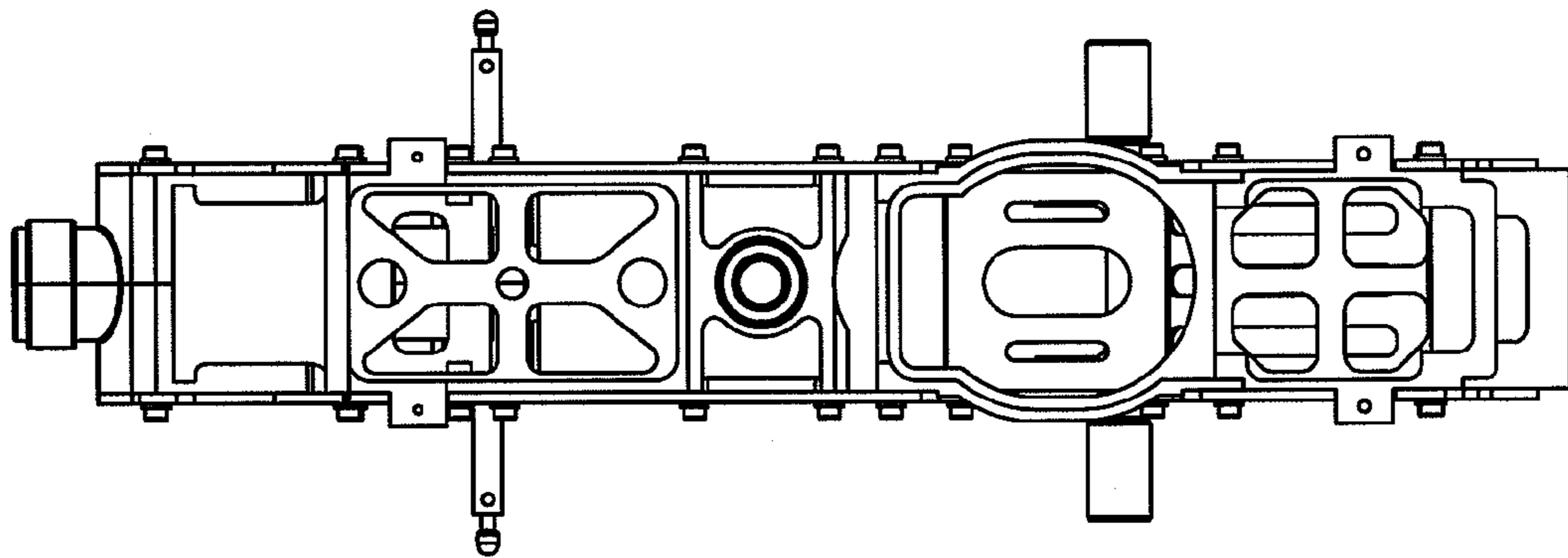

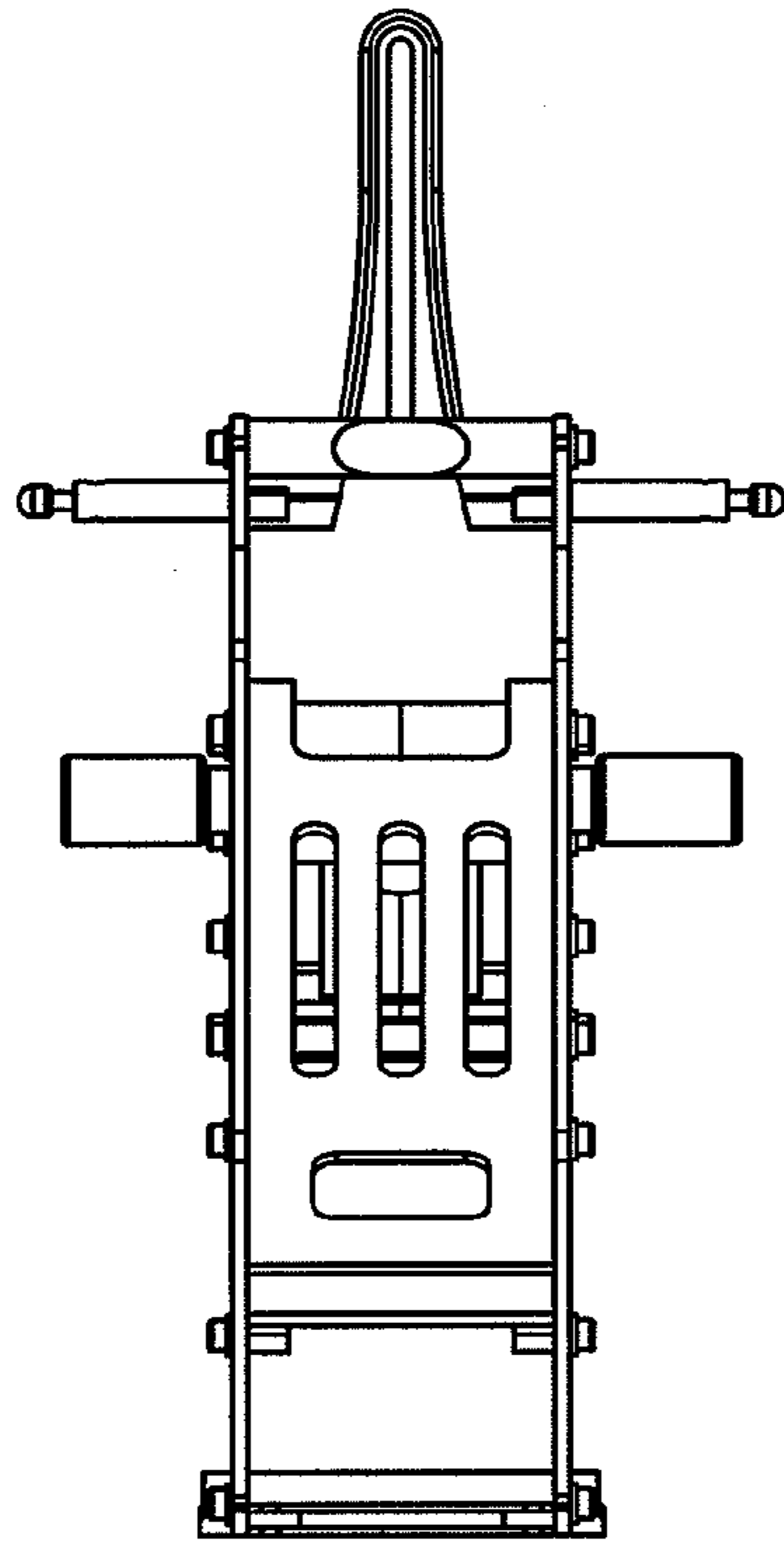

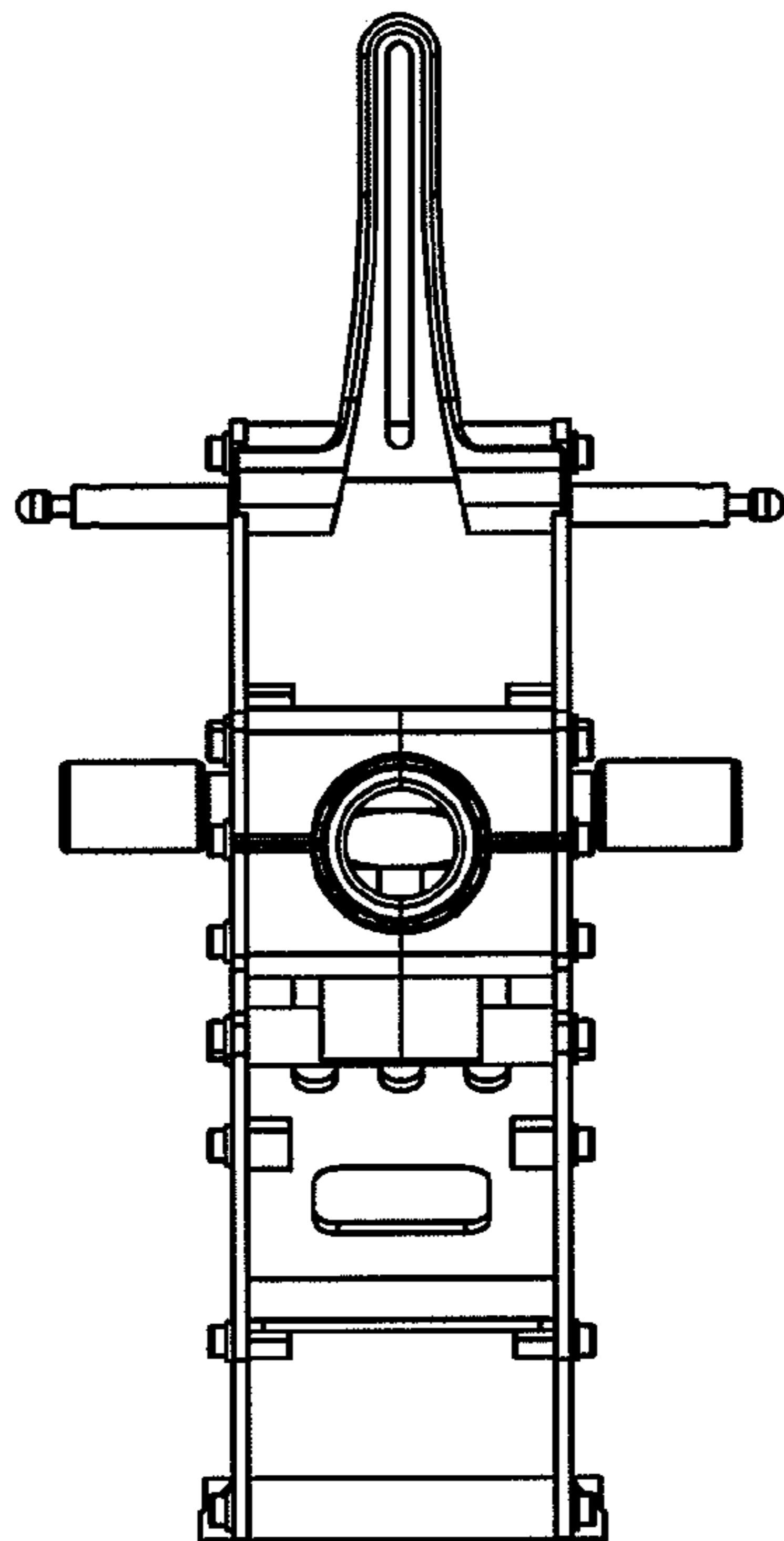

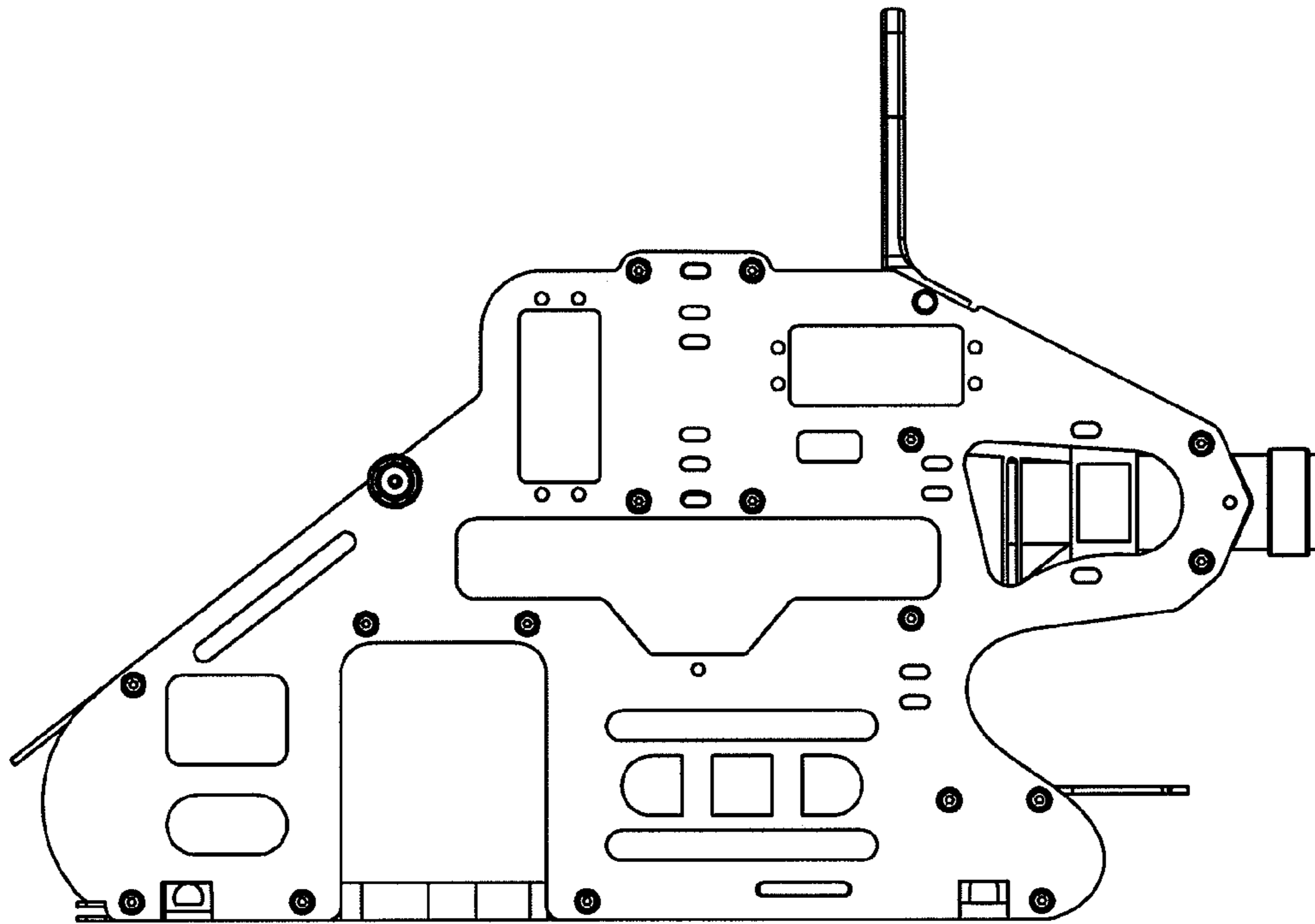

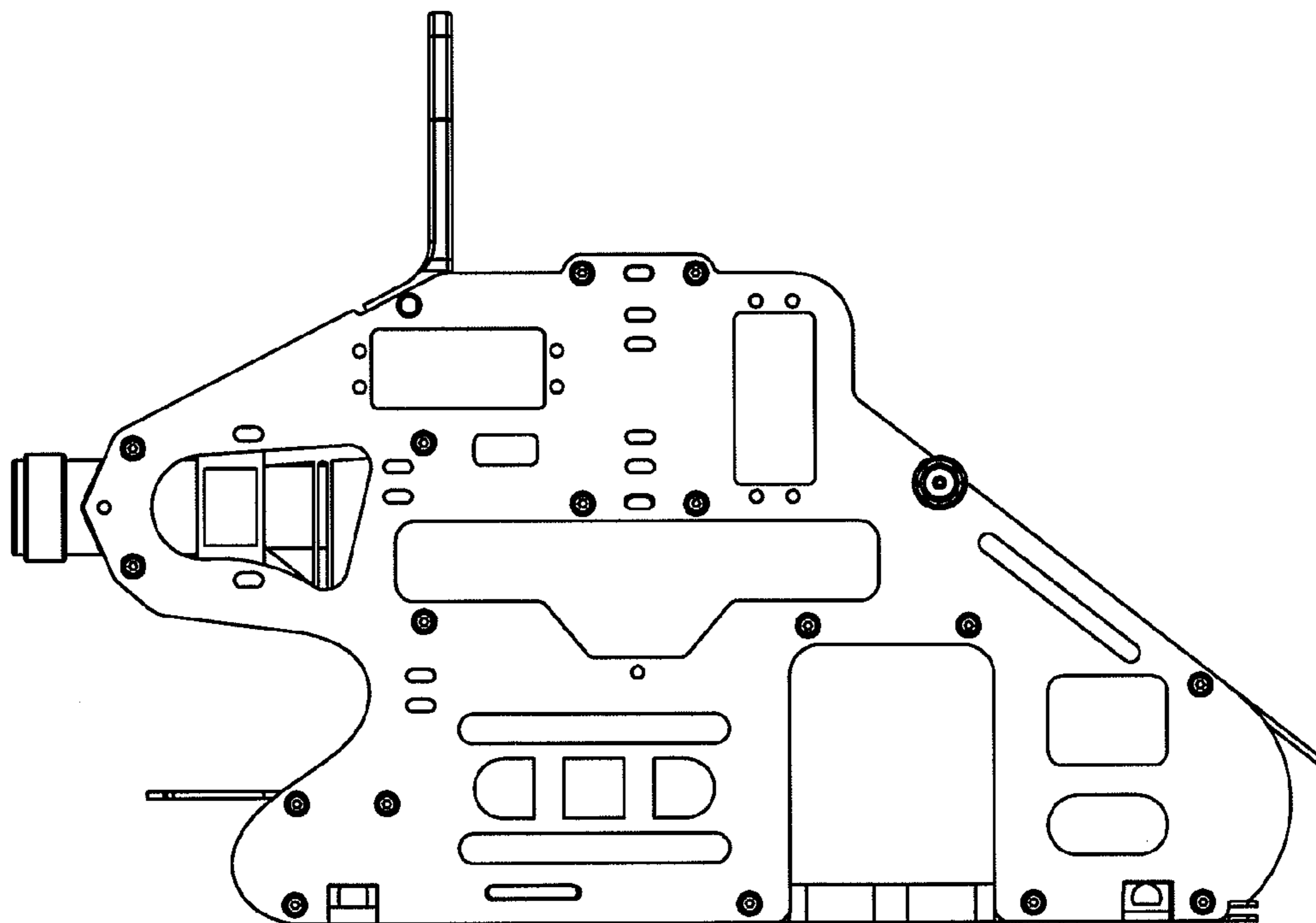
