(57) **CLAIM**

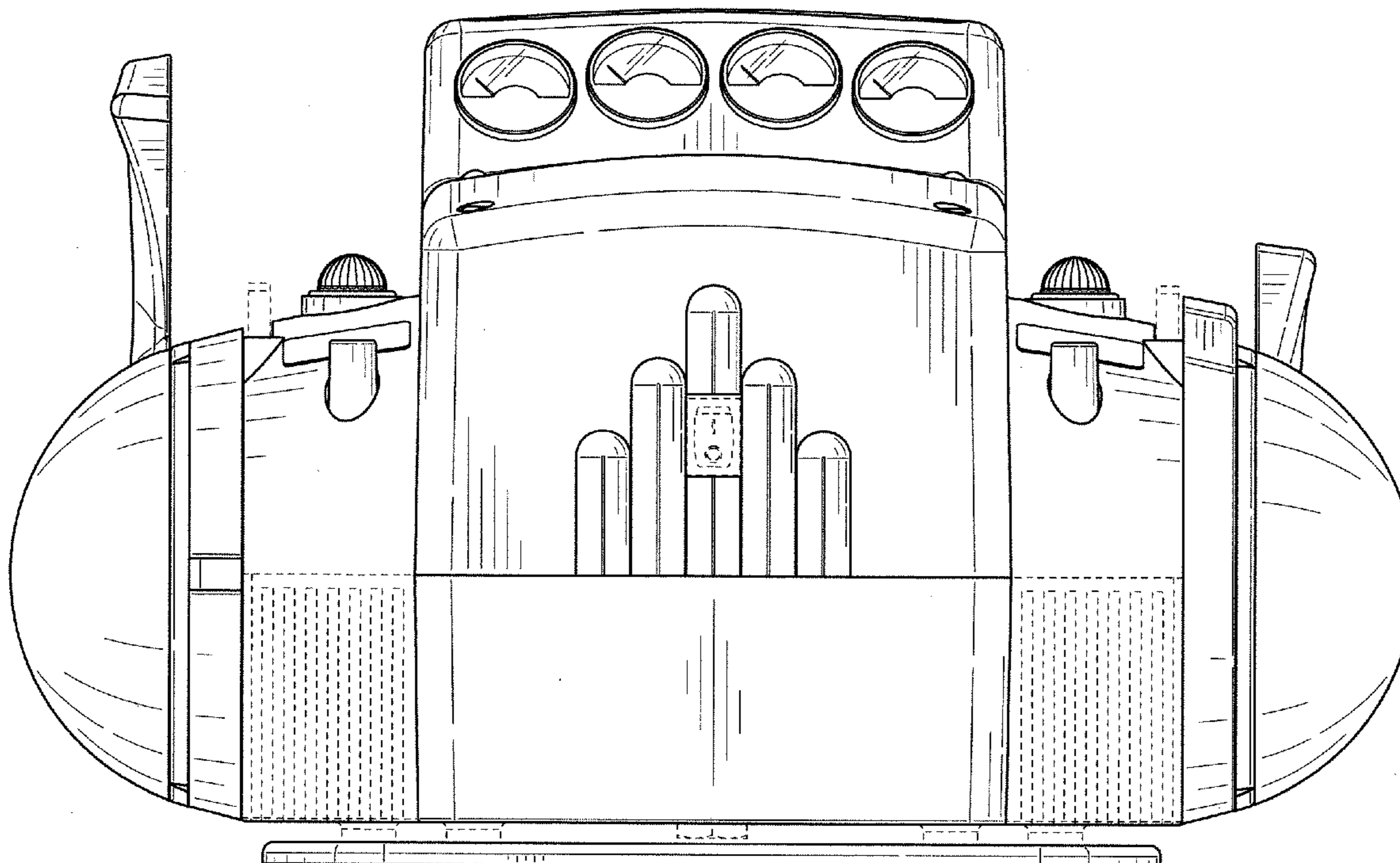
The ornamental design for an adjustable transformer for a model vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of an adjustable transformer for a model vehicle in accordance with the invention;  
 FIG. 2 is a back view of the adjustable transformer for a model vehicle;  
 FIG. 3 is a right side view of the adjustable transformer for a model vehicle;  
 FIG. 4 is a left side view of the adjustable transformer for a model vehicle;

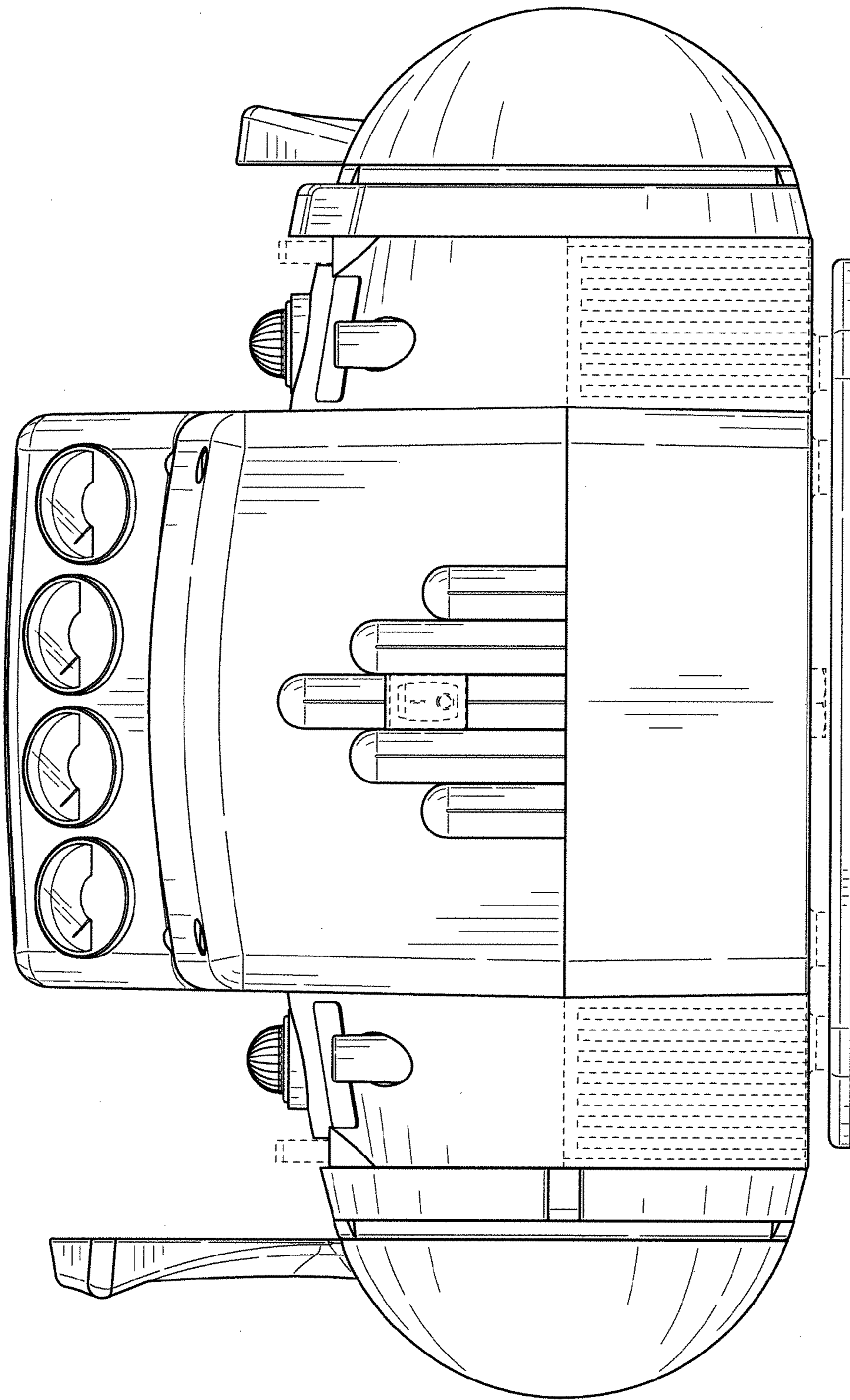

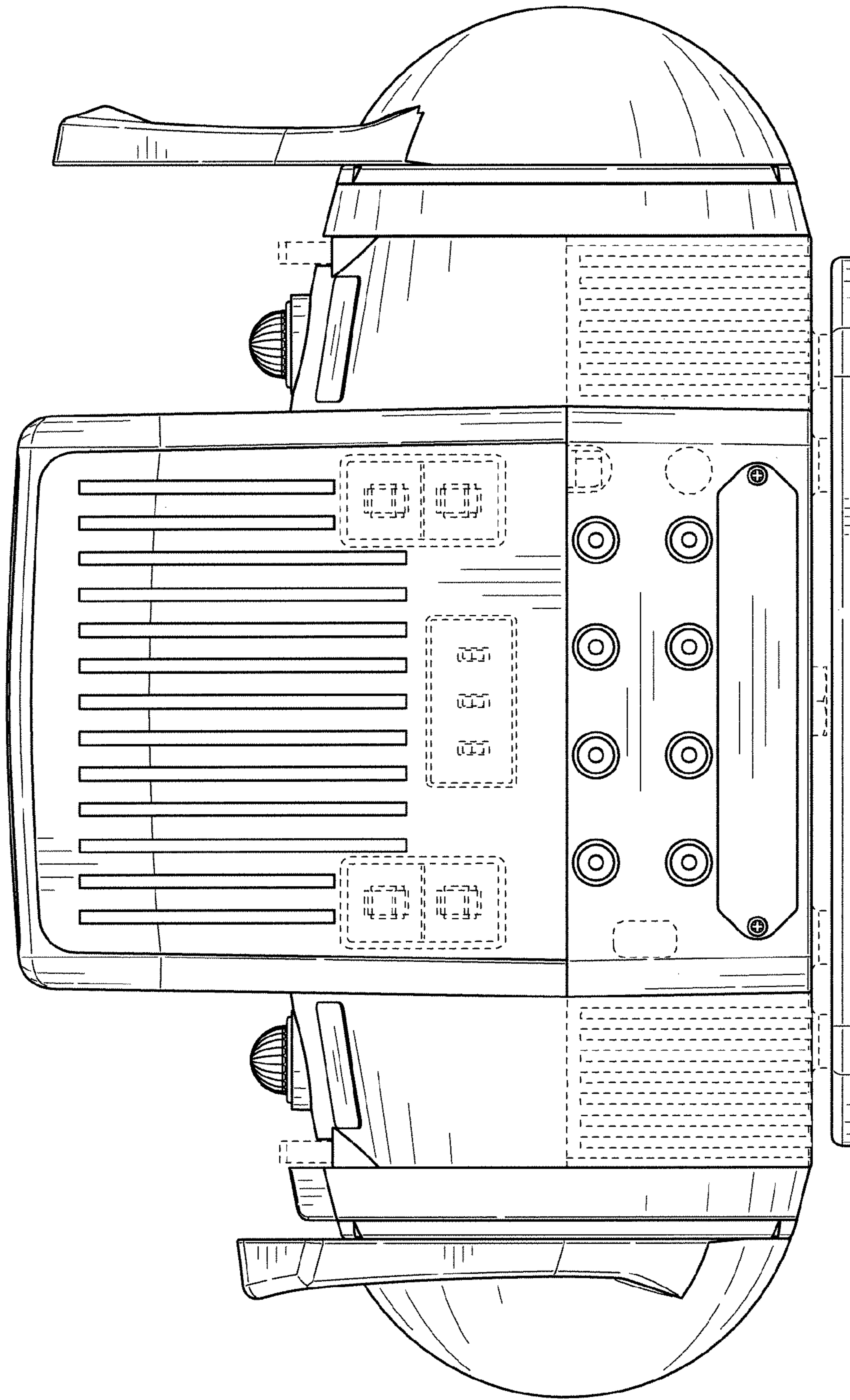

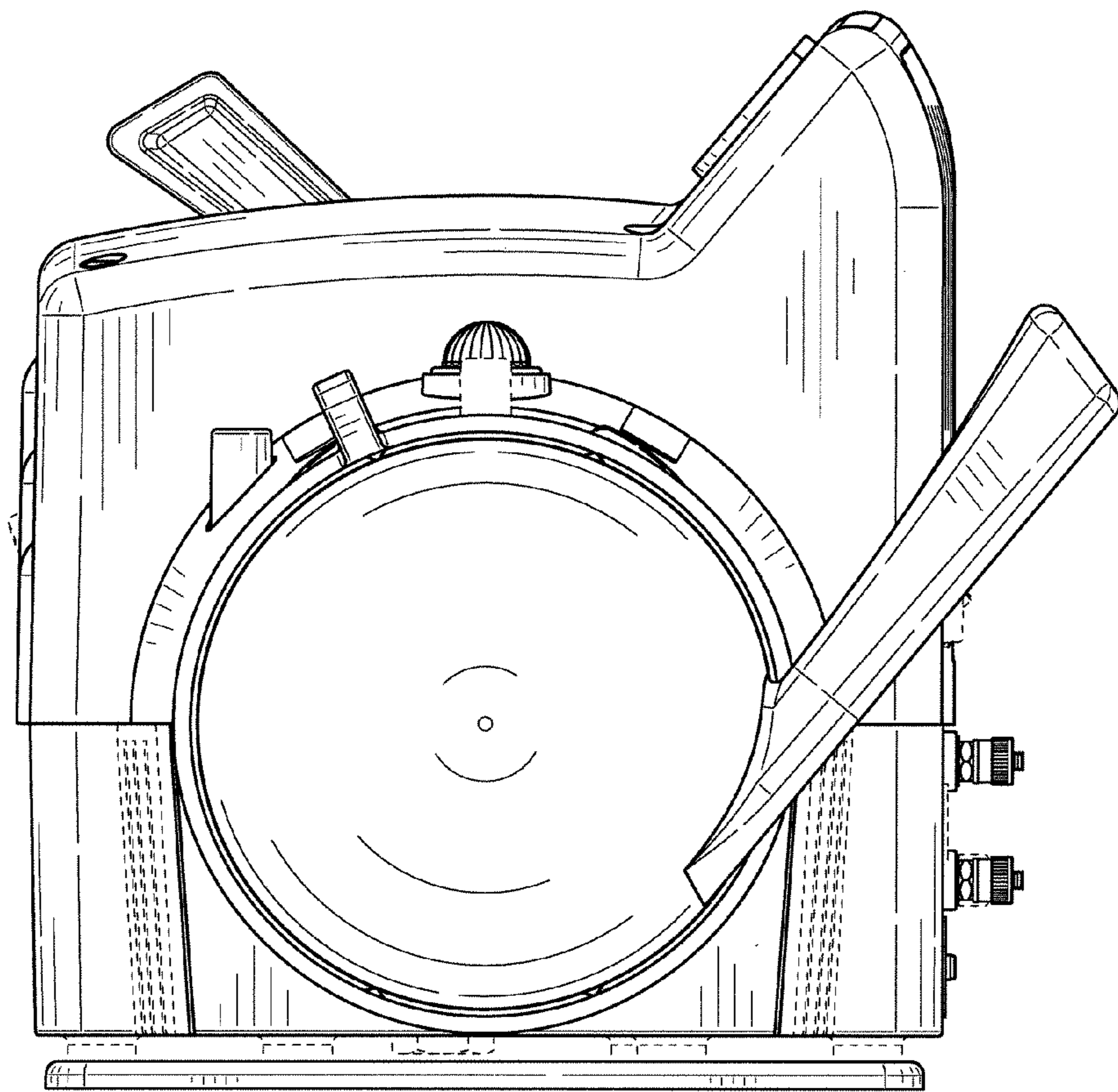

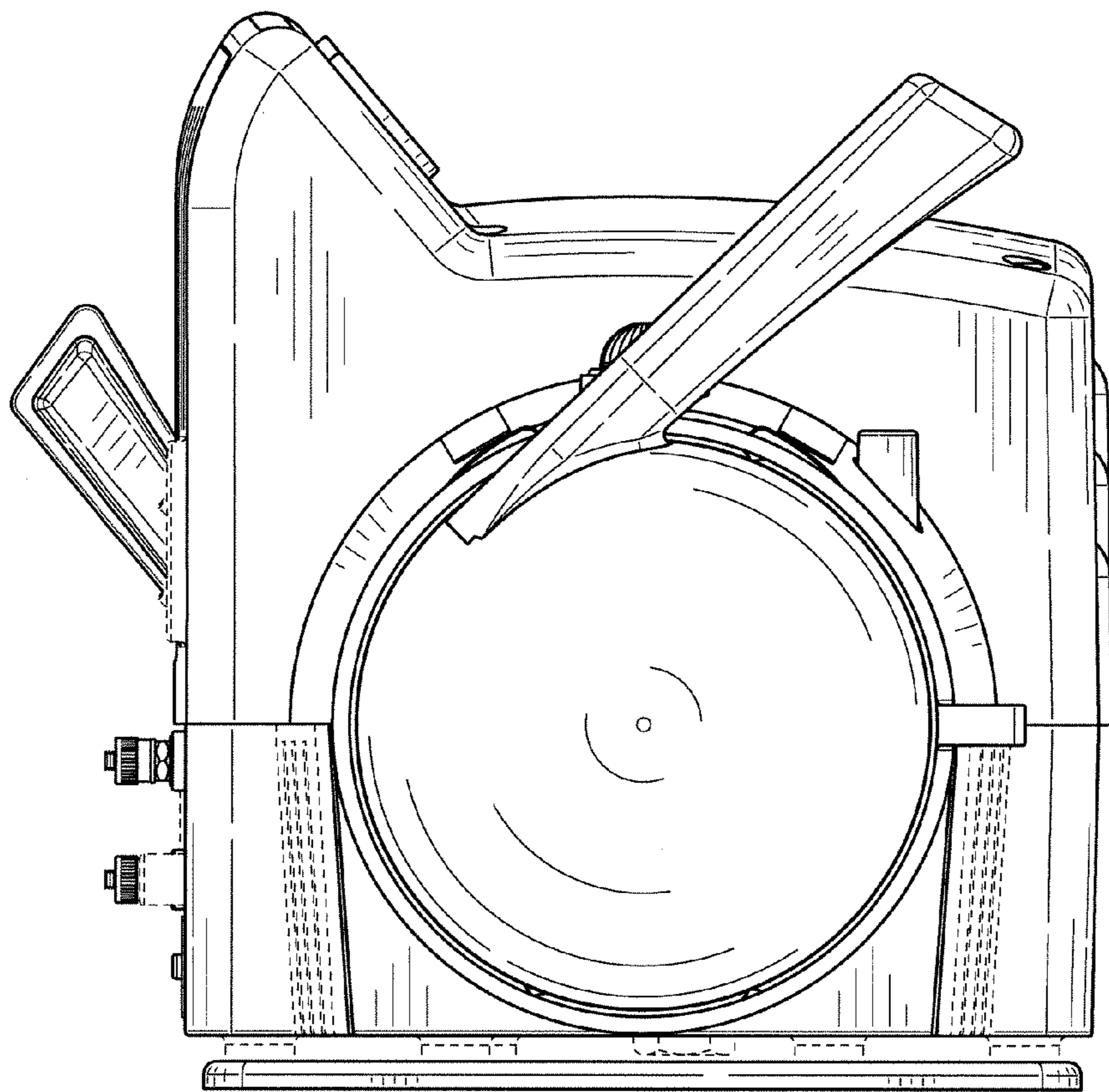

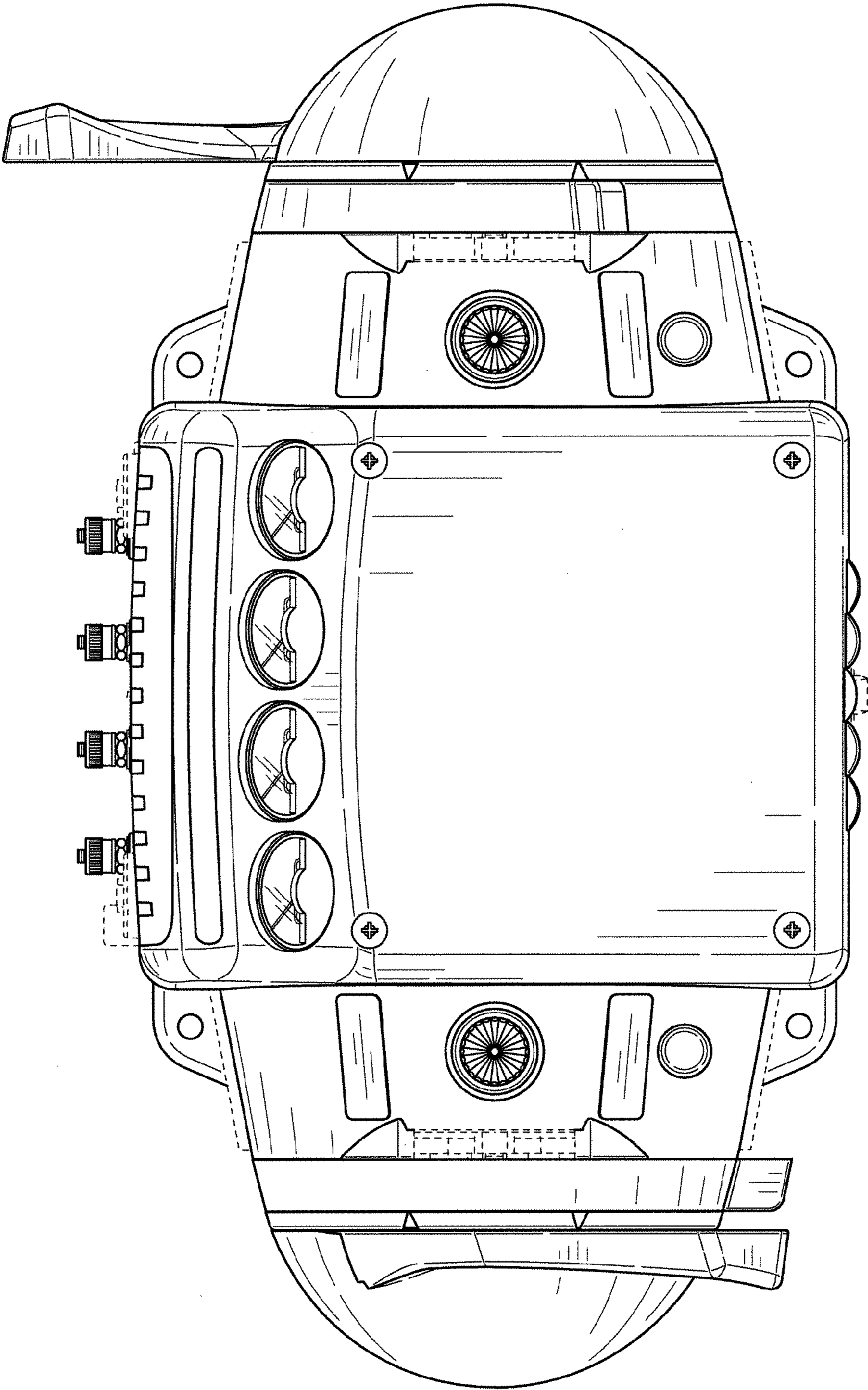

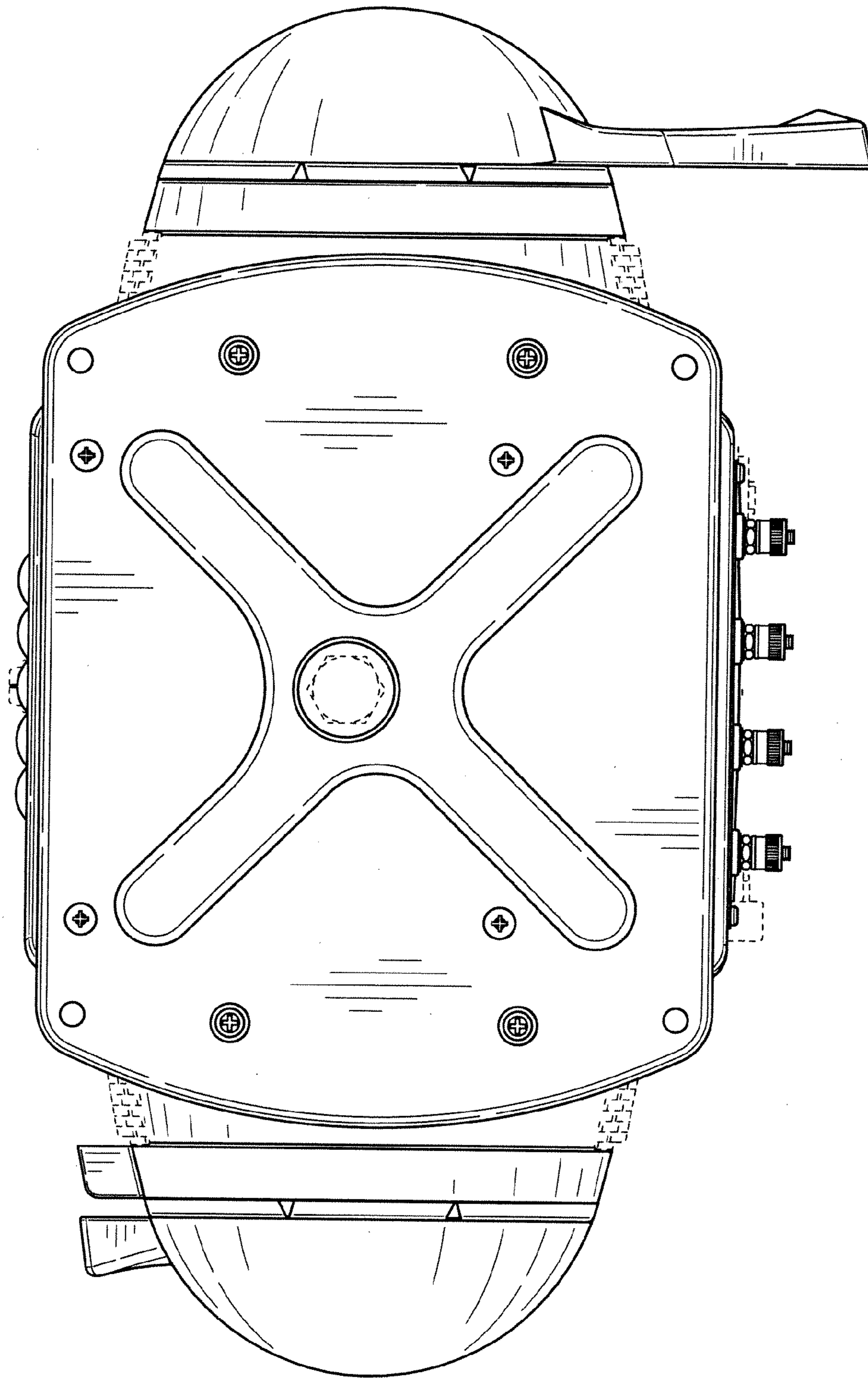
