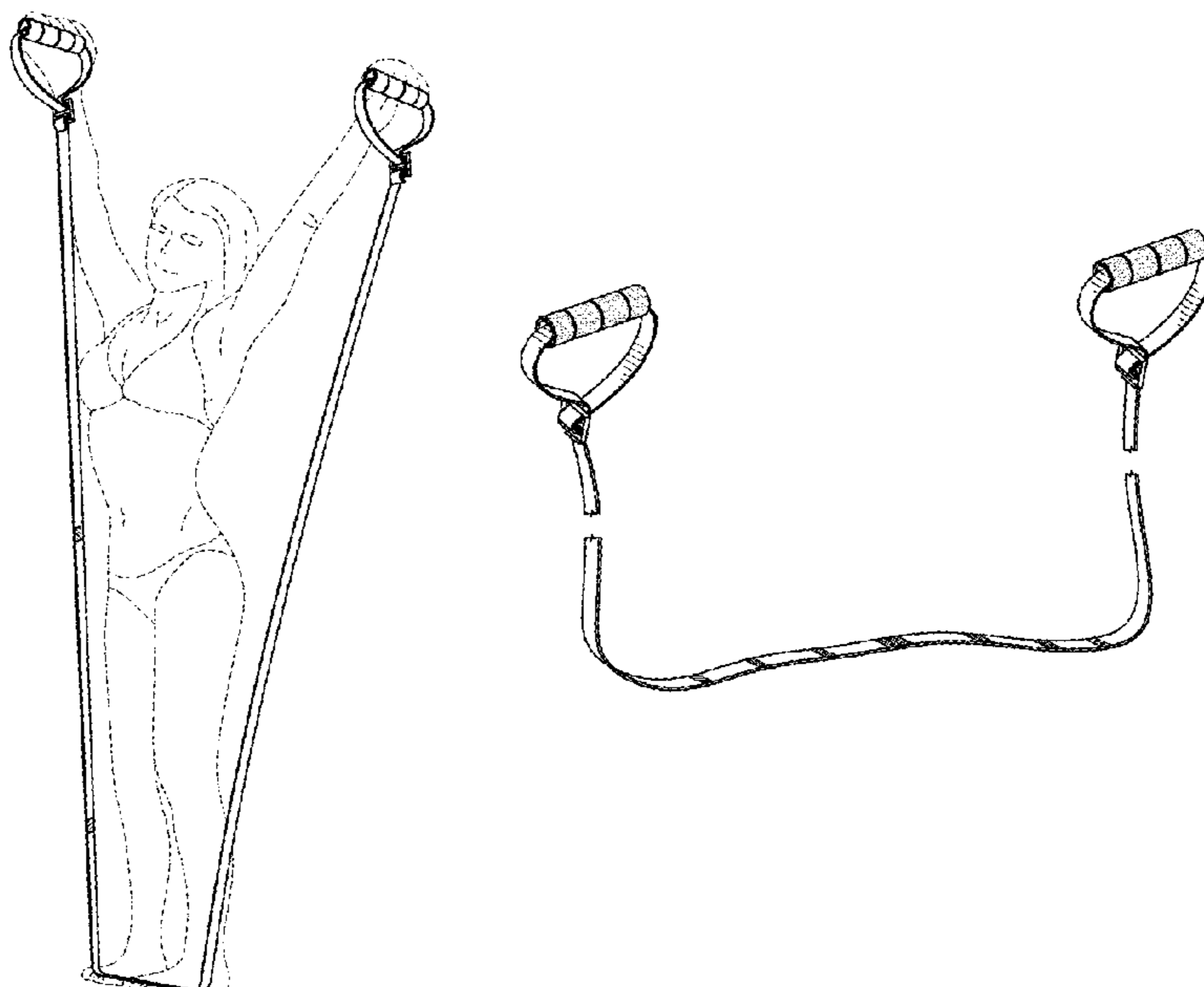
(57) **CLAIM**

I claim the ornamental design for an exercise band, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an exercise band, showing my new design in a stretched position;  
 FIG. 2 is a perspective view thereof, illustrated in a fragmented relaxed position;  
 FIG. 3 is a fragmented top plan view of FIG. 2;  
 FIG. 4 is a fragmented bottom plan view of FIG. 2;  
 FIG. 5 is a fragmented right-side elevational view of FIG. 2;  
 FIG. 6 is a fragmented left-side elevational view of FIG. 2;  
 FIG. 7 is a fragmented front elevational view of FIG. 2; and,  
 FIG. 8 is a fragmented rear elevational view of FIG. 2.  
 The broken lines showing a person in FIG. 1 depict environmental matter and form no part of the claimed design. The varying shading patterns in FIGS. 1-3 illustrate reference marks having contrasting colors. The straps are shown broken away to indicate they have no specific length.

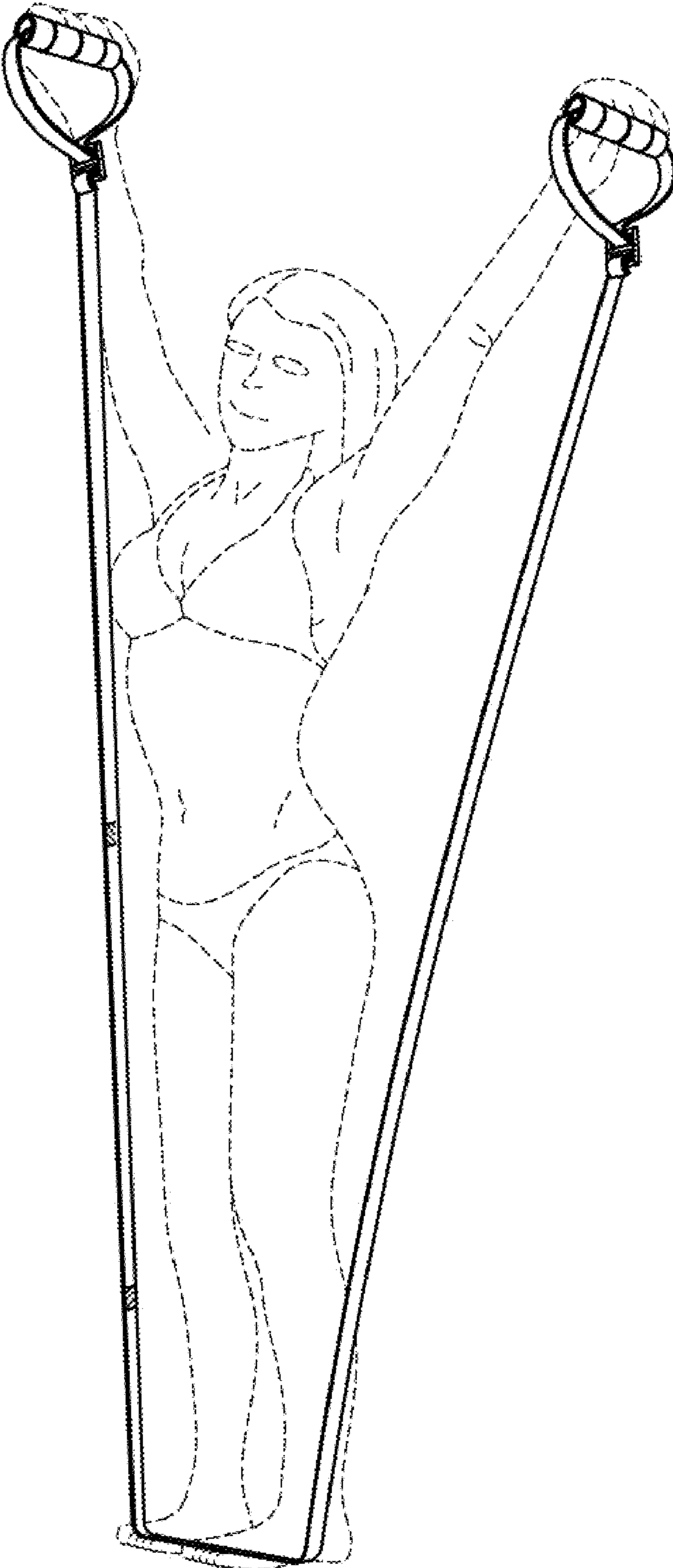
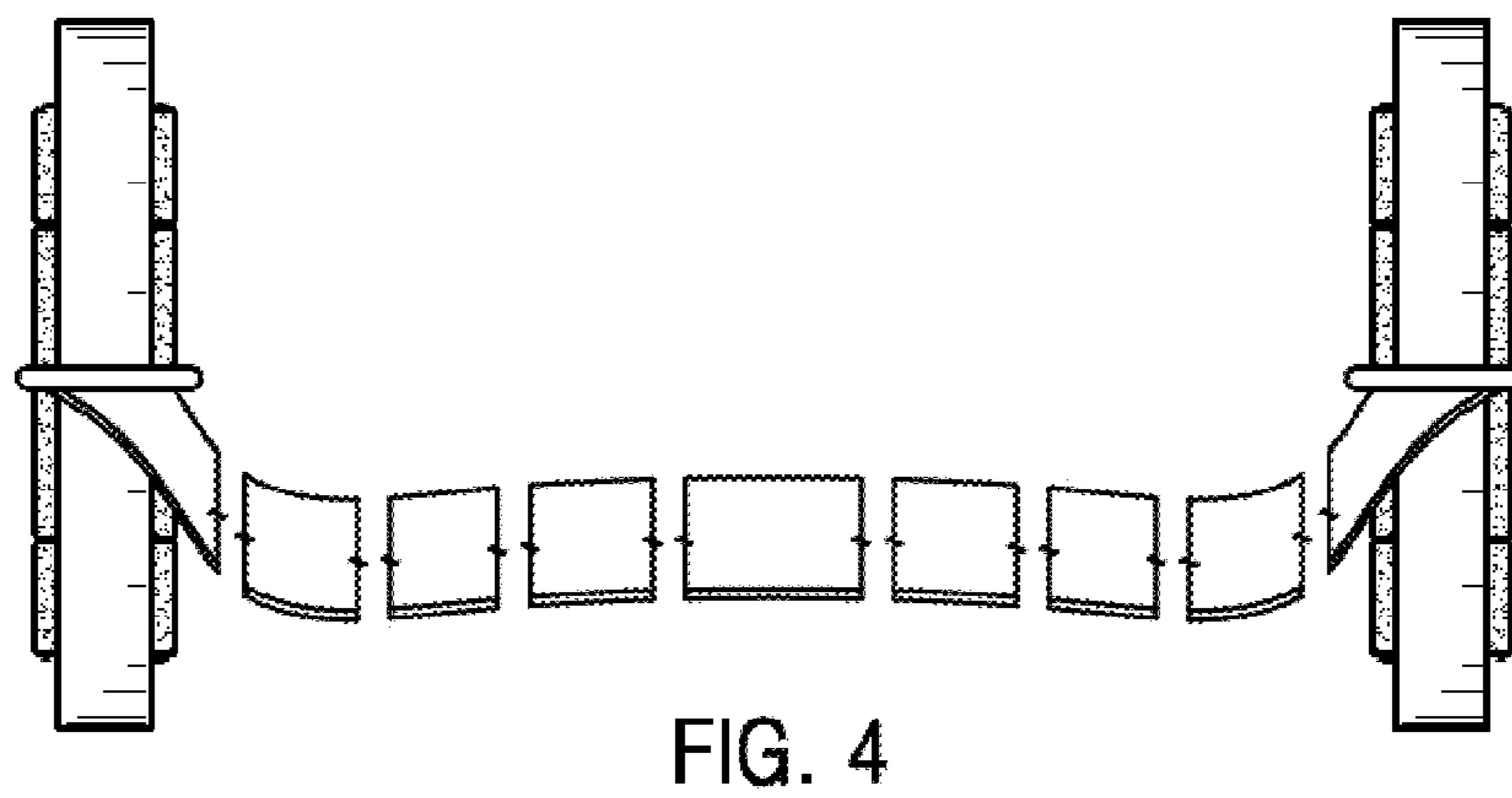
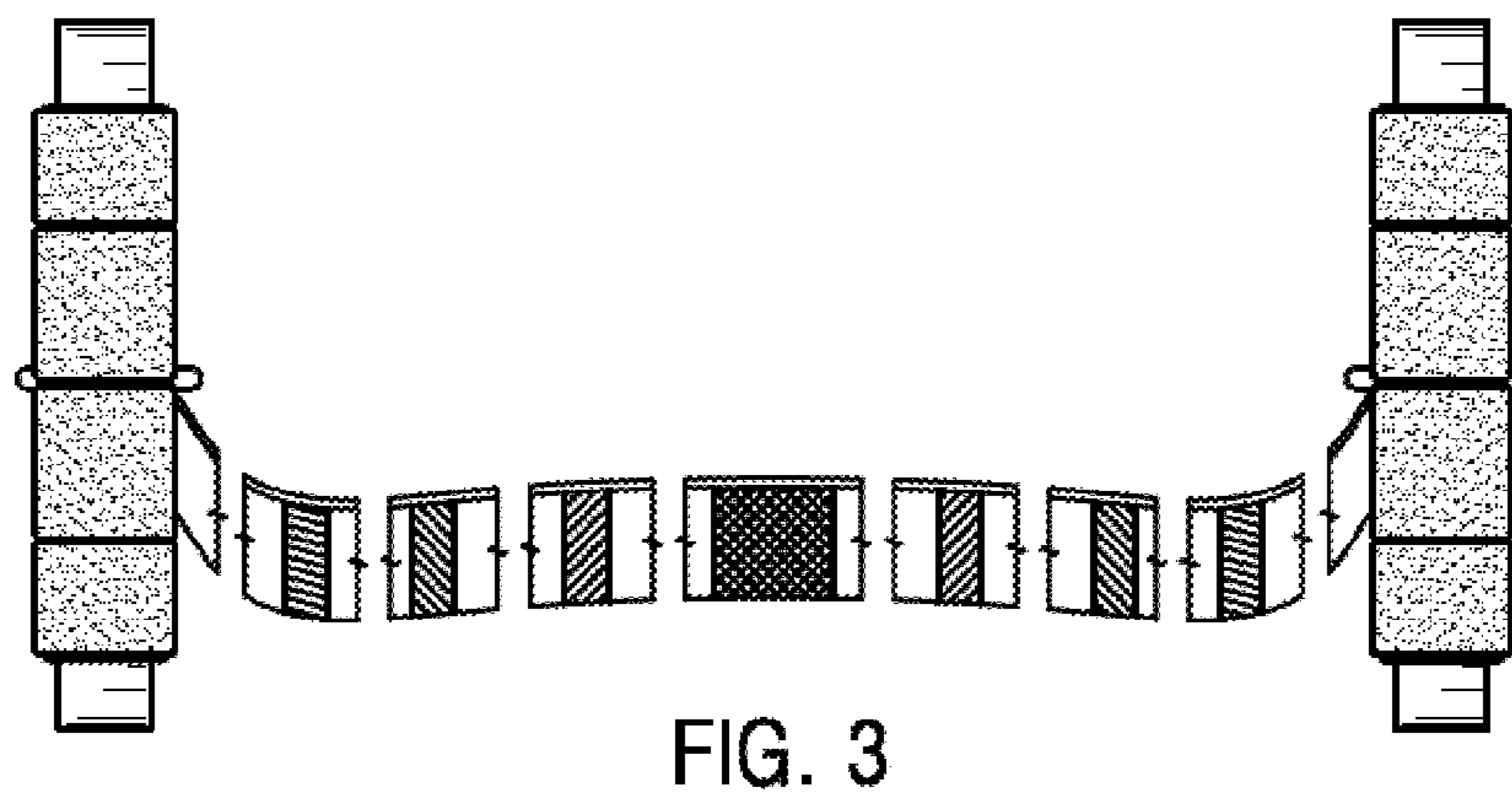
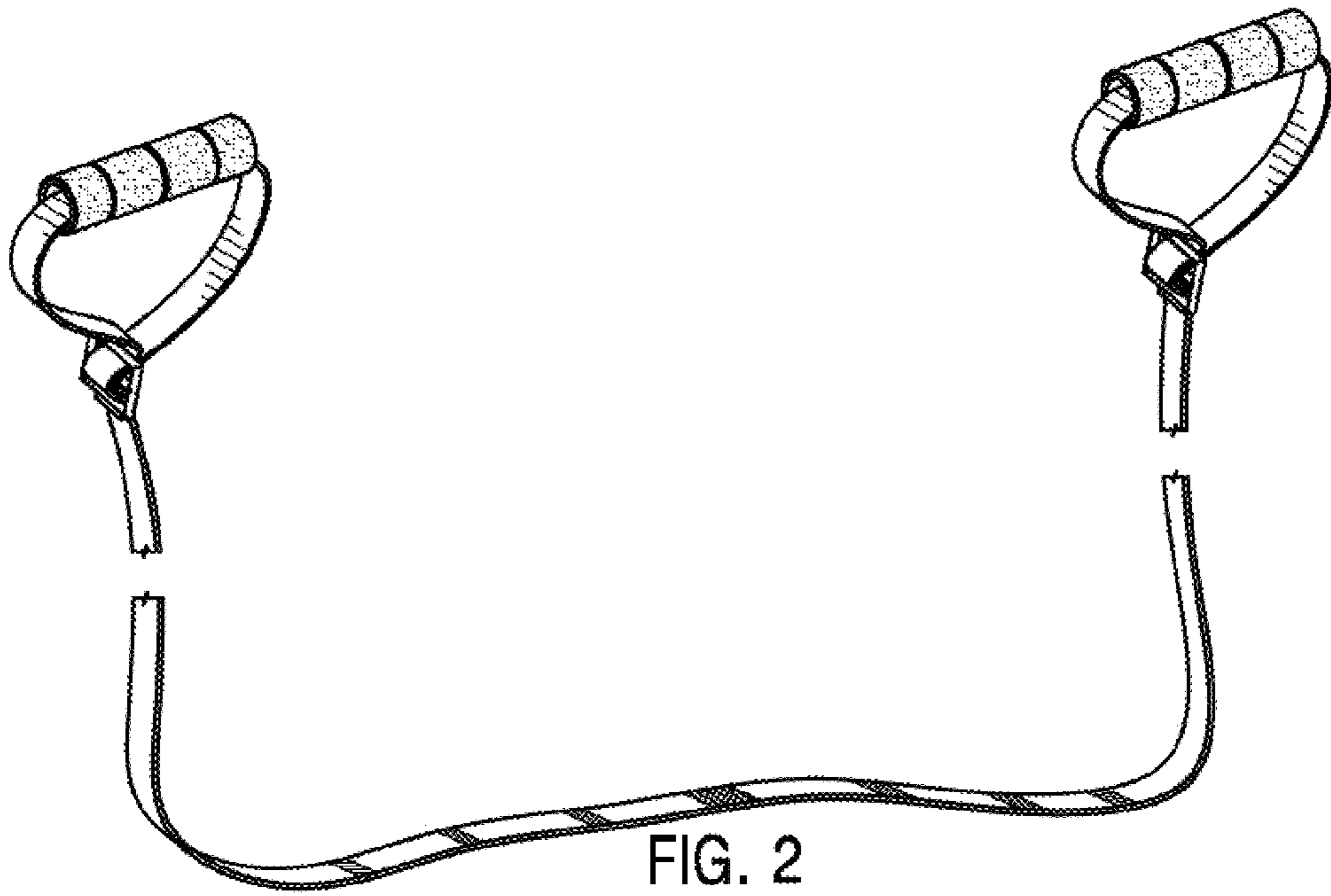

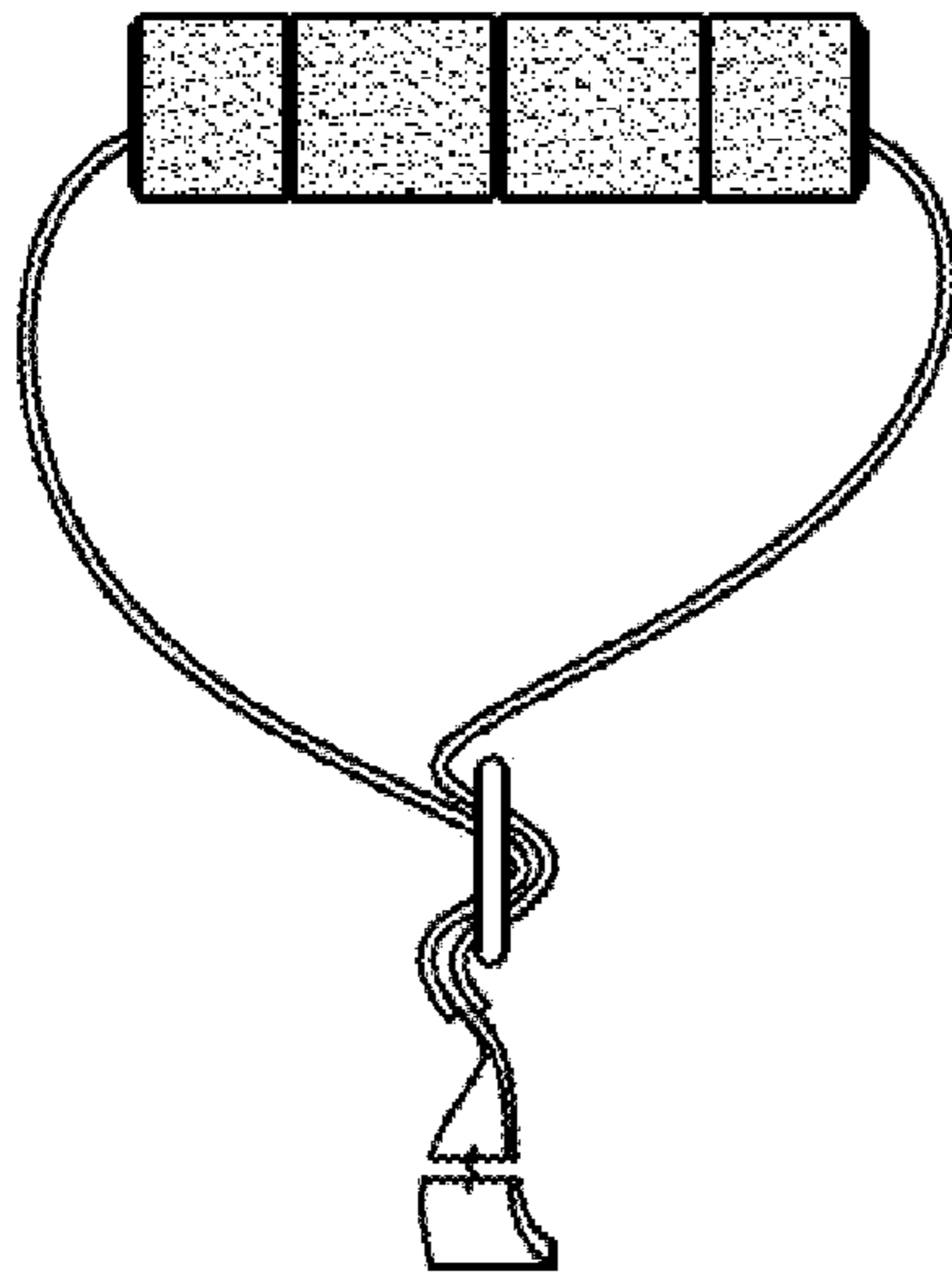

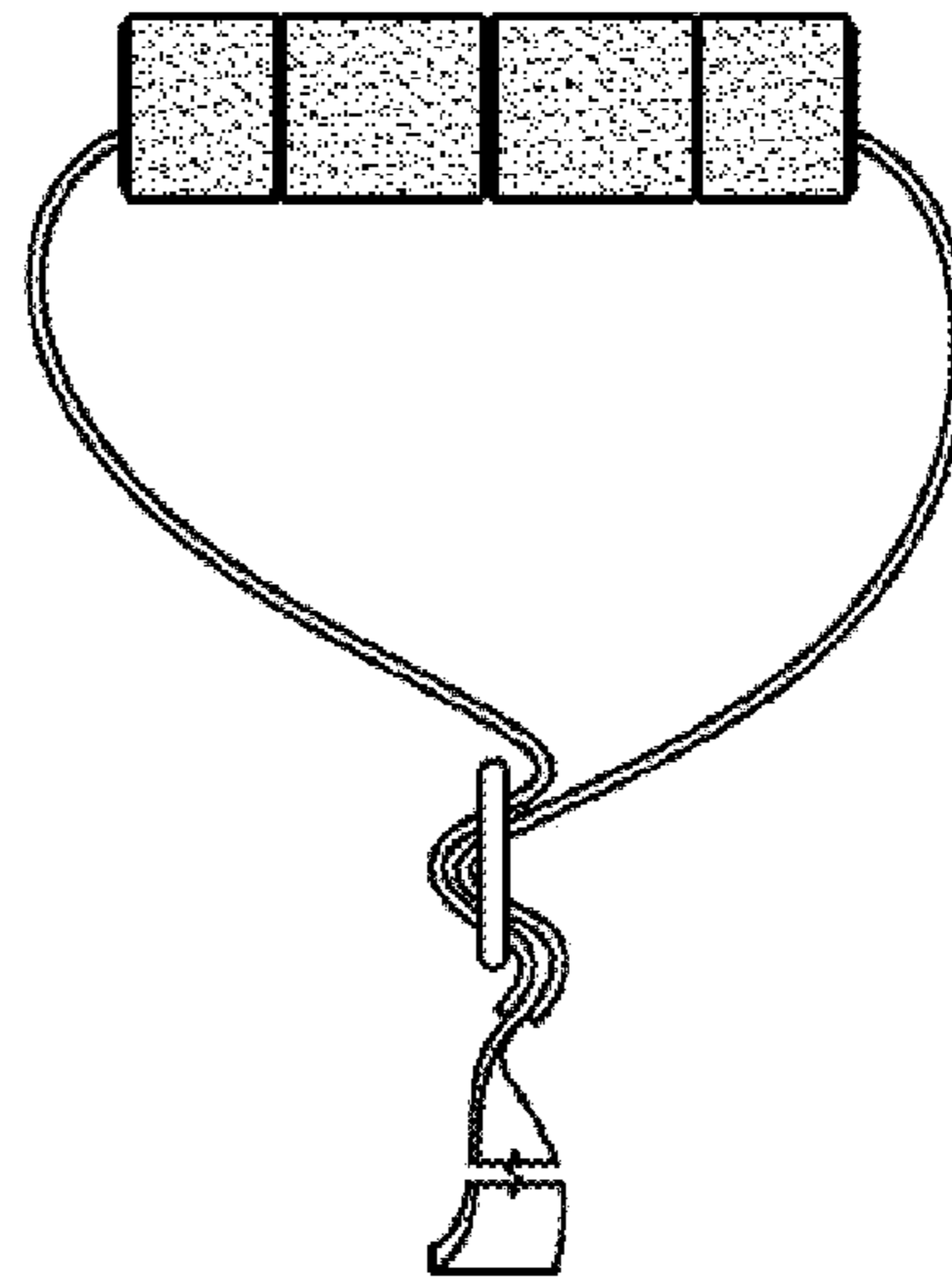

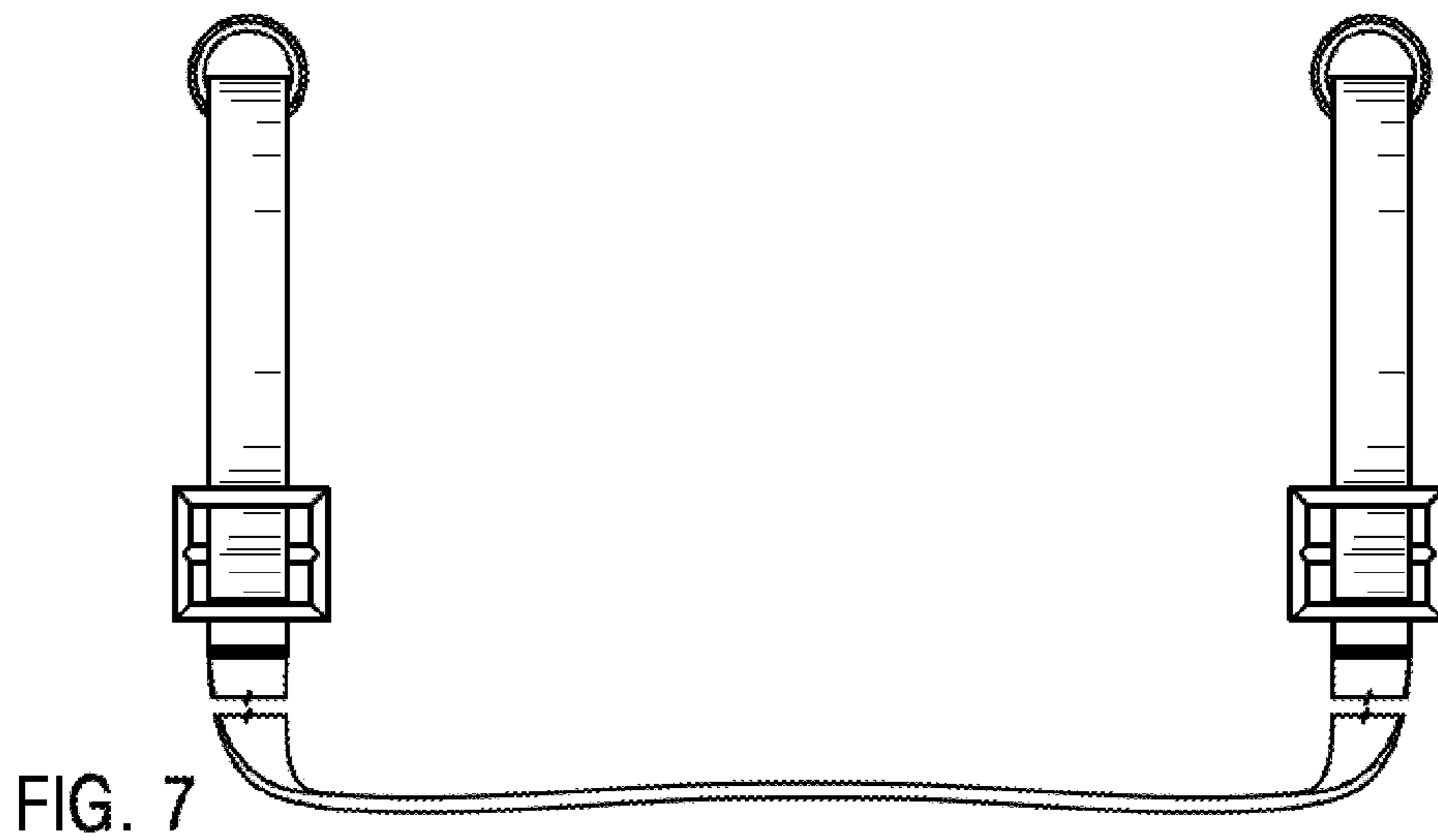

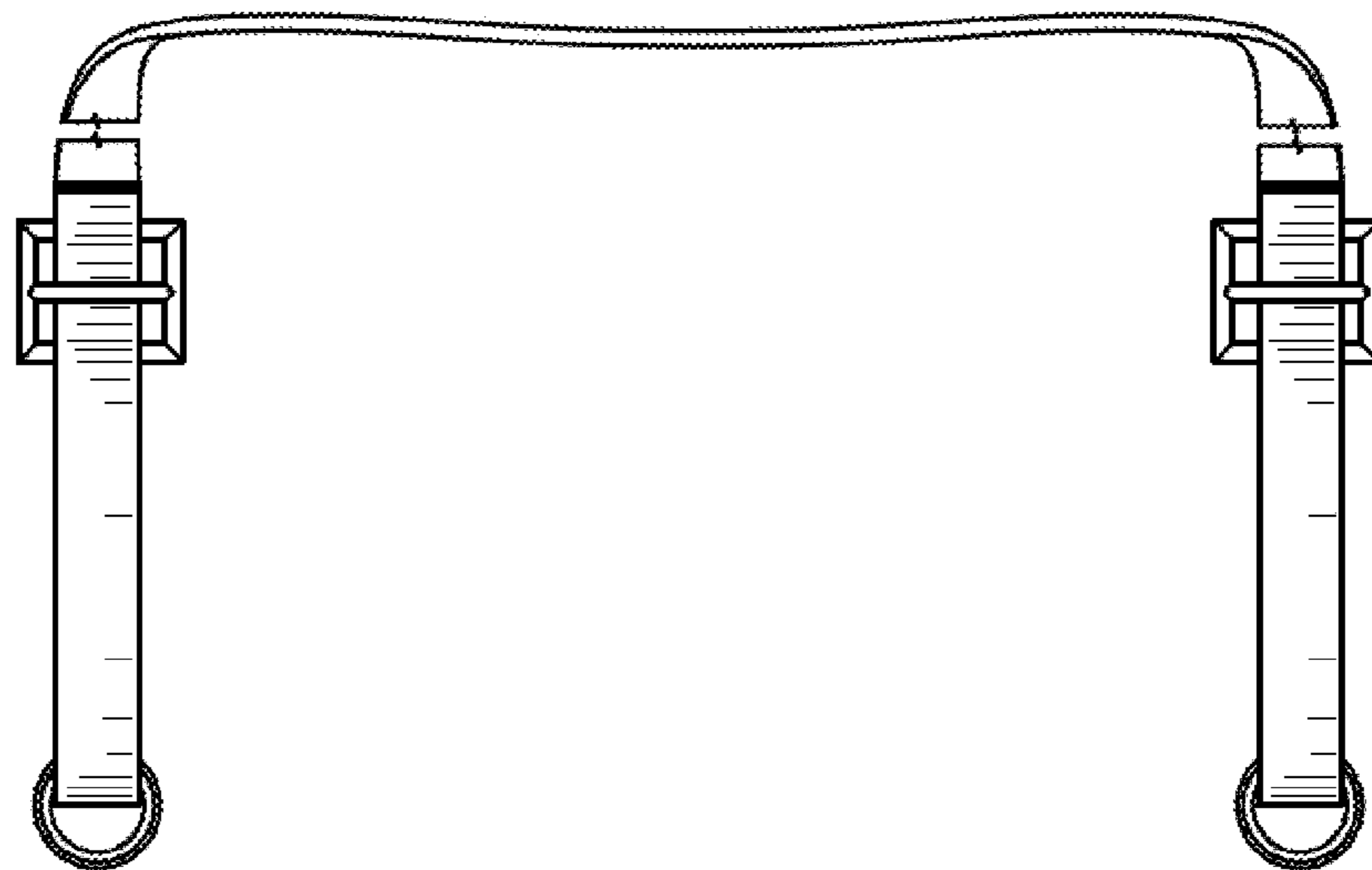
