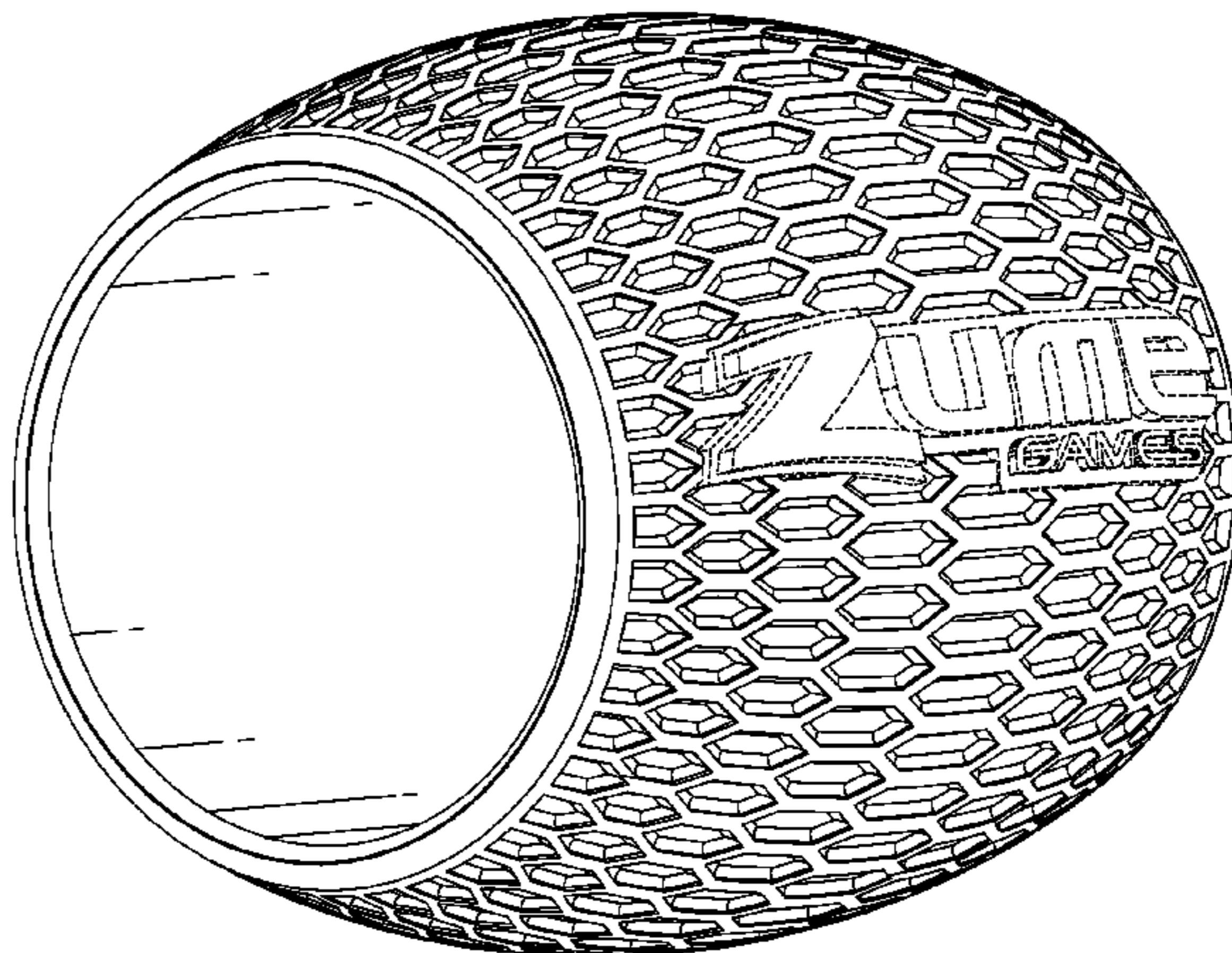
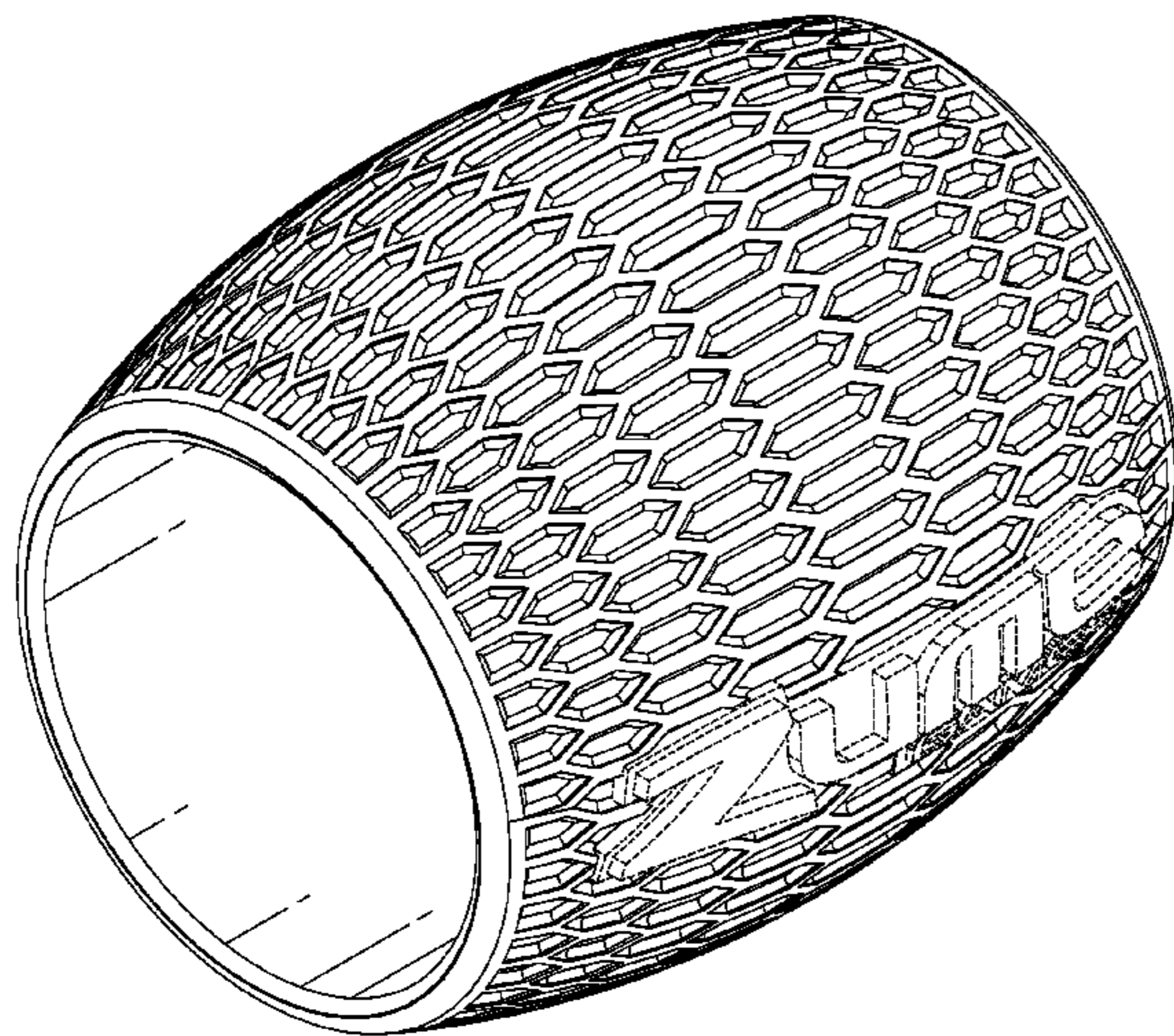
The ornamental design for a throwable cylinder, as shown and described.

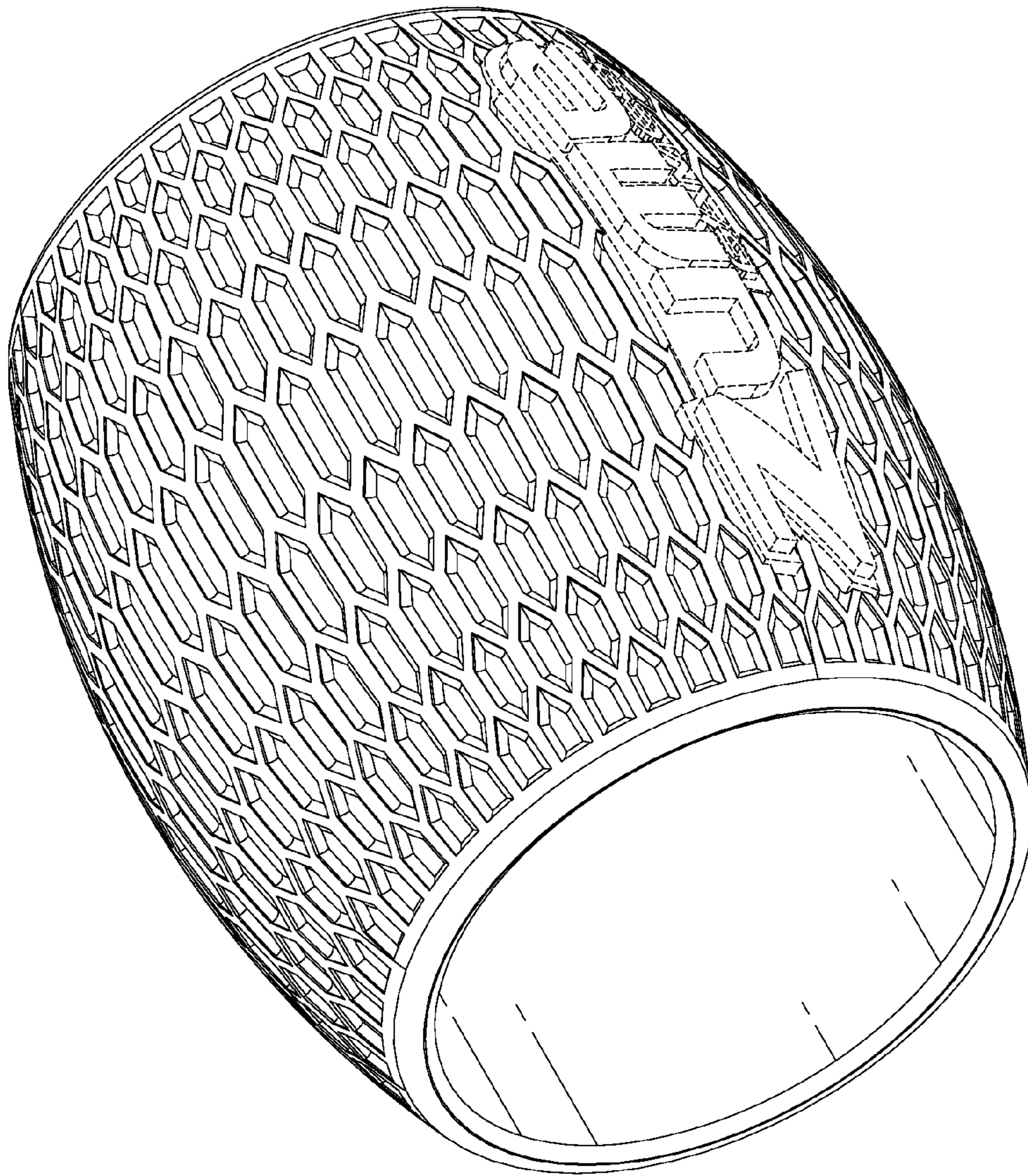
**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of the throwable cylinder showing our new design;  
FIG. 2 is a front and right side perspective view thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a top view thereof, the bottom view being a mirror image of the top view; and,  
FIG. 6 is a front end view thereof, the rear end view being a mirror image of the front end view.

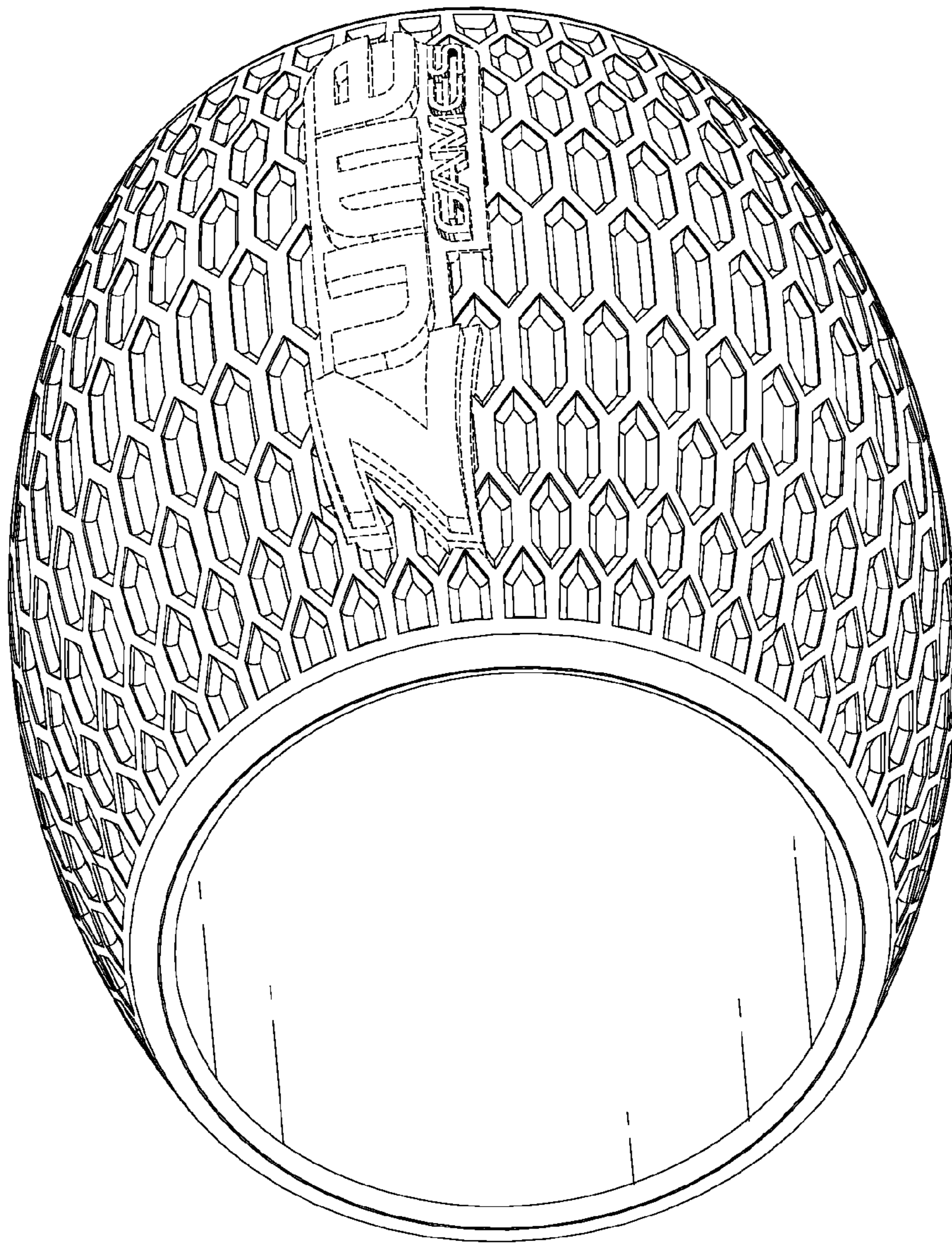
The broken lines are included for the purpose of illustrating portions of the throwable cylinder that form no part of the claimed design.

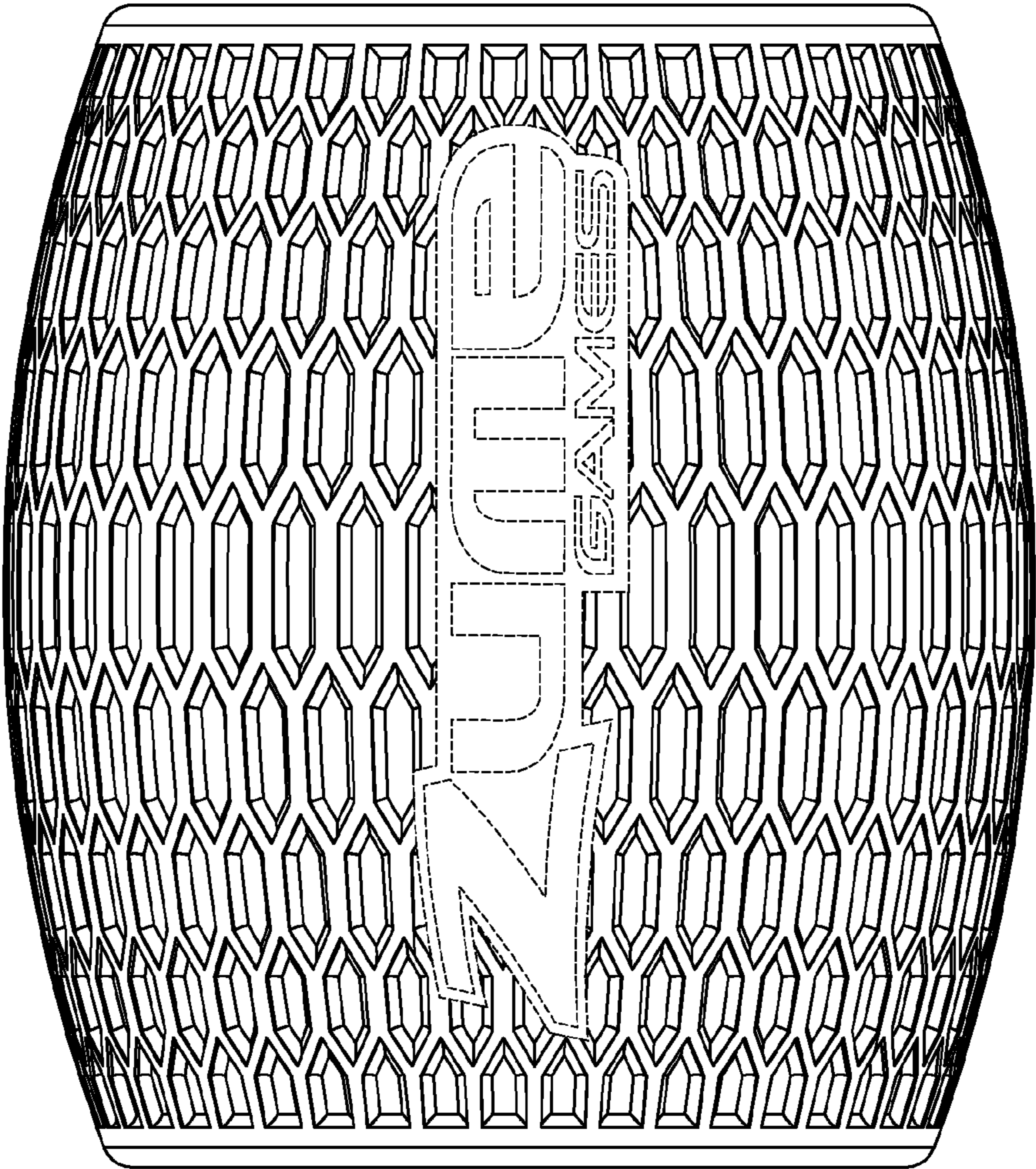




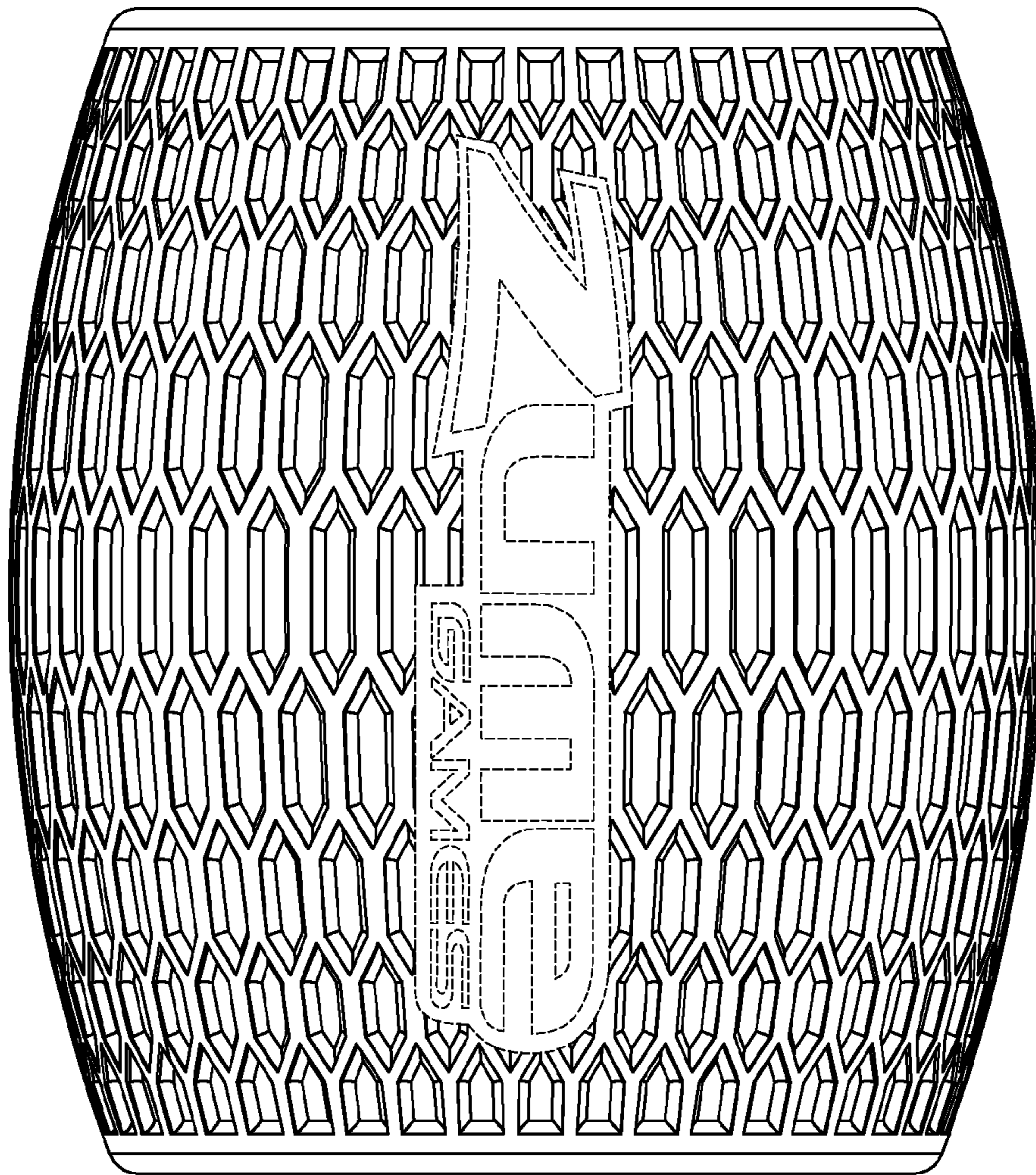

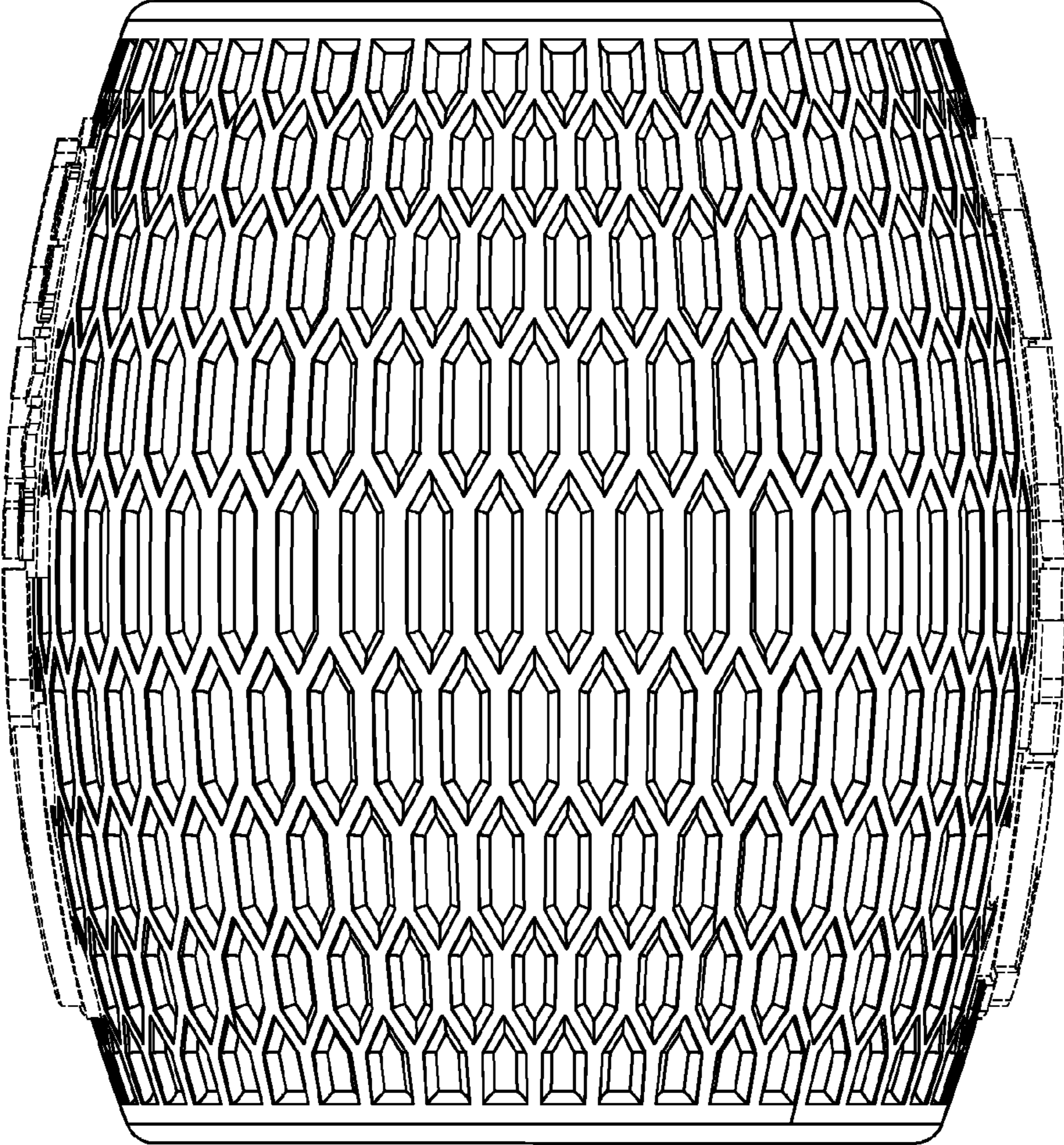

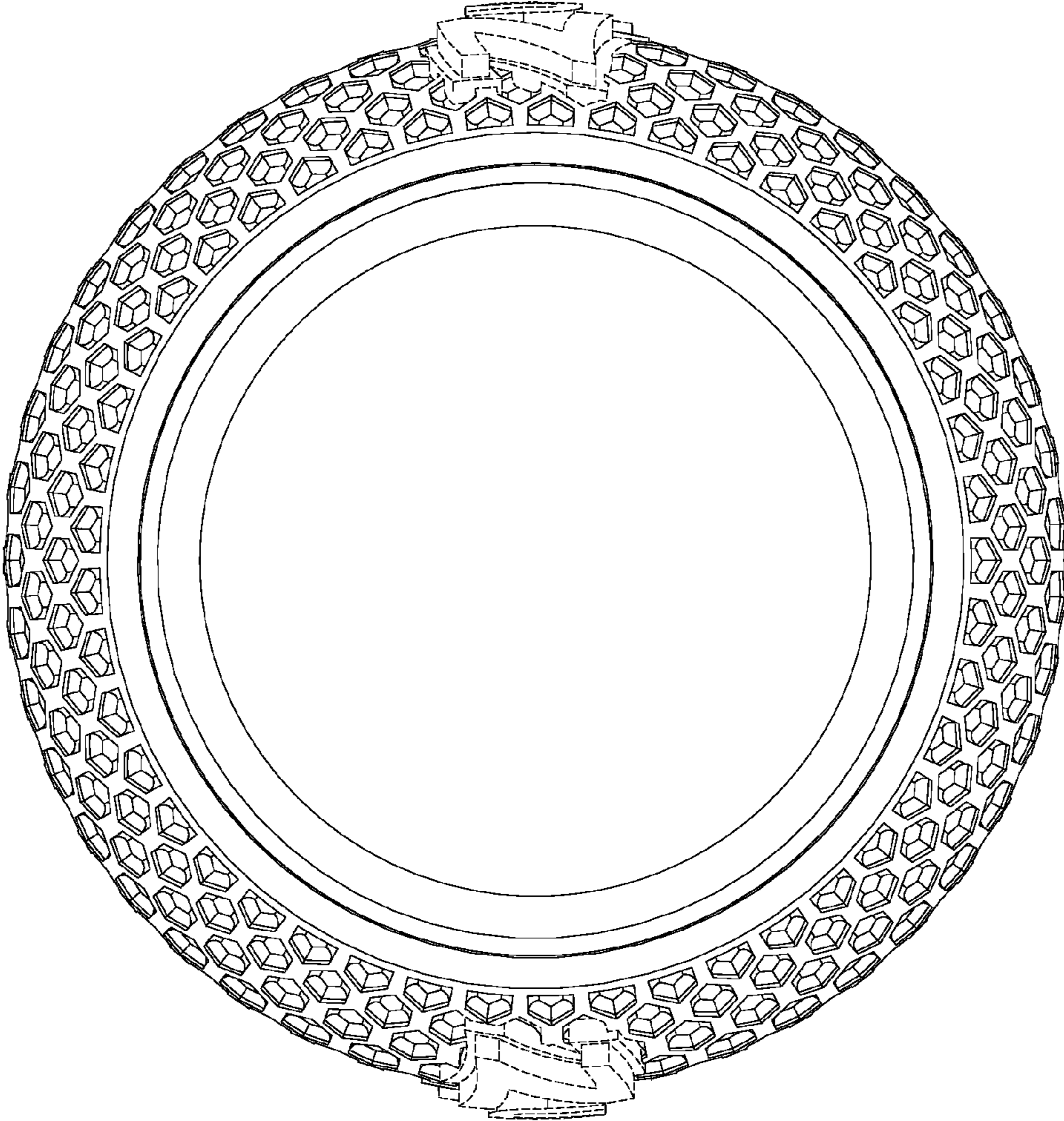
