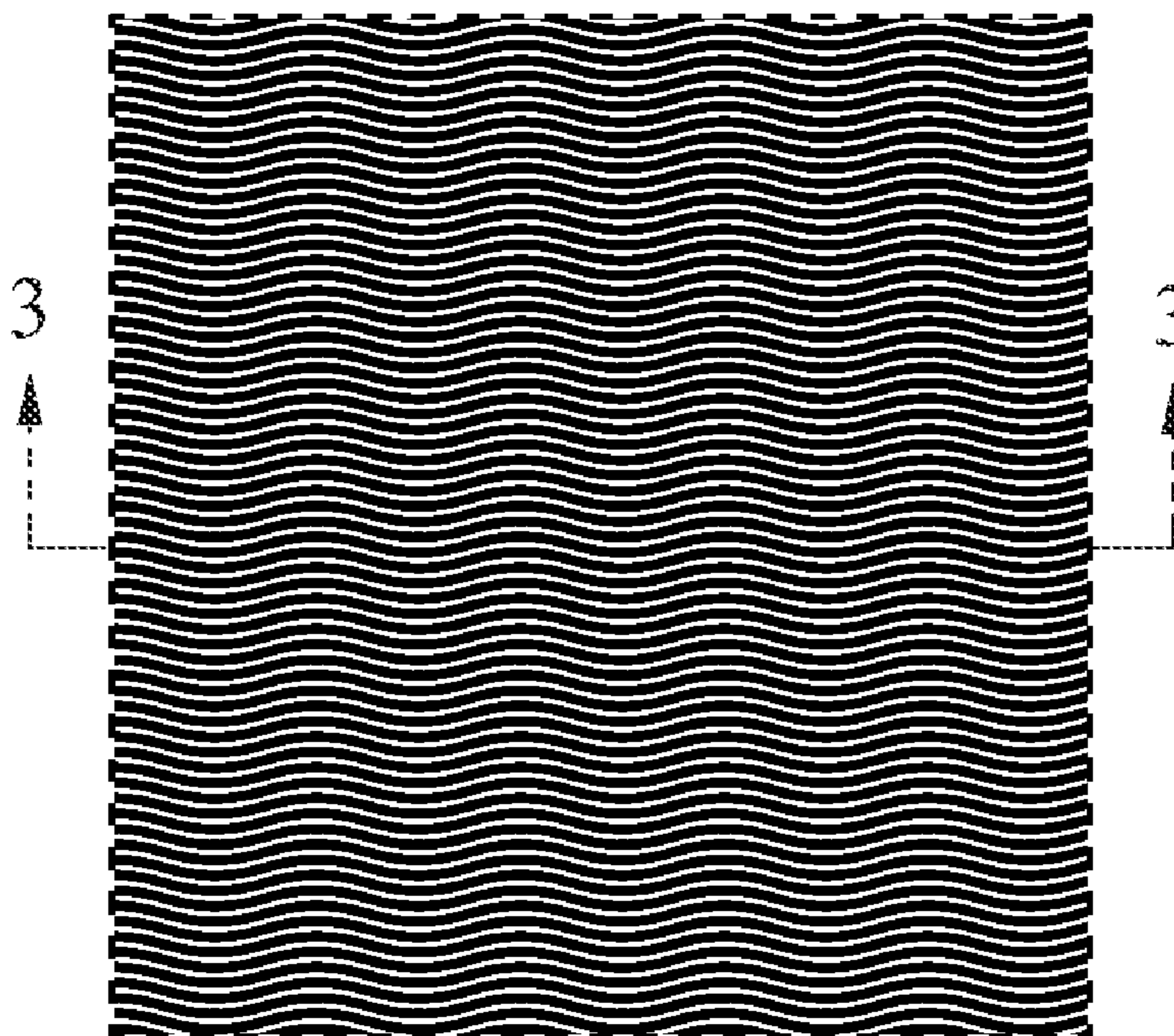

(57) **CLAIM**  
The ornamental design of a heat reflective material, as shown and described.

**DESCRIPTION**

FIG. 1 is an elevational view of a heat reflective material; FIG. 2 is an enlarged elevational view thereof, taken from any area in the design; FIG. 3 is a cross-sectional side elevational view thereof, taken in the direction of line 3-3 in FIG. 1; FIG. 4 is a top perspective view of the heat reflective material as used in a sleeping bag; FIG. 5 is a front perspective view of the heat reflective material as used in footwear; FIG. 6 is a front perspective view of the heat reflective material as used in legwear; FIG. 7 is a rear perspective view of the heat reflective material as used in a sock; FIG. 8 is a rear perspective view of the heat reflective material as used in handwear; FIG. 9 is a front perspective view of the heat reflective material as used in outerwear; and, FIG. 10 is a rear perspective view of the heat reflective material as used in footwear.

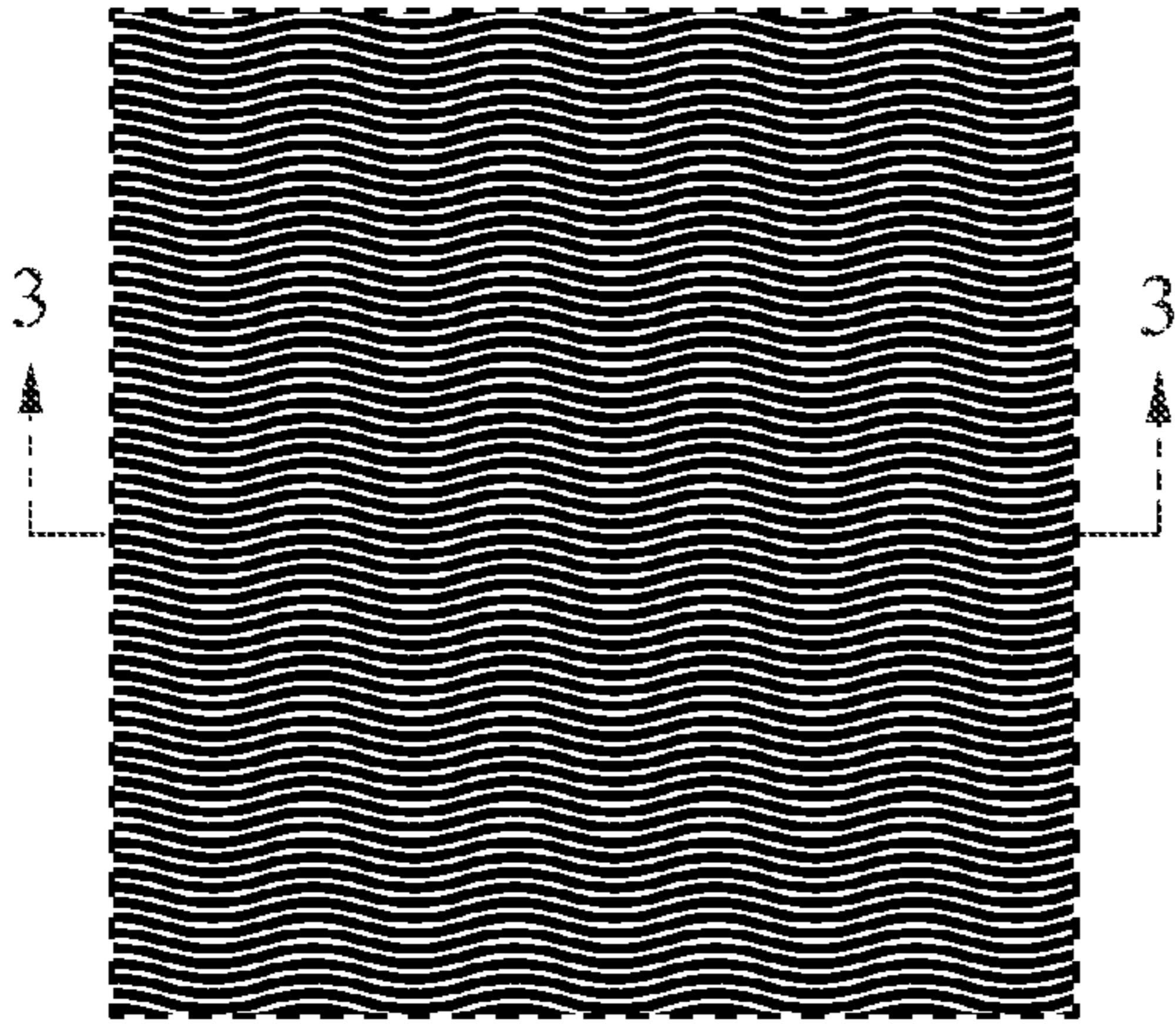

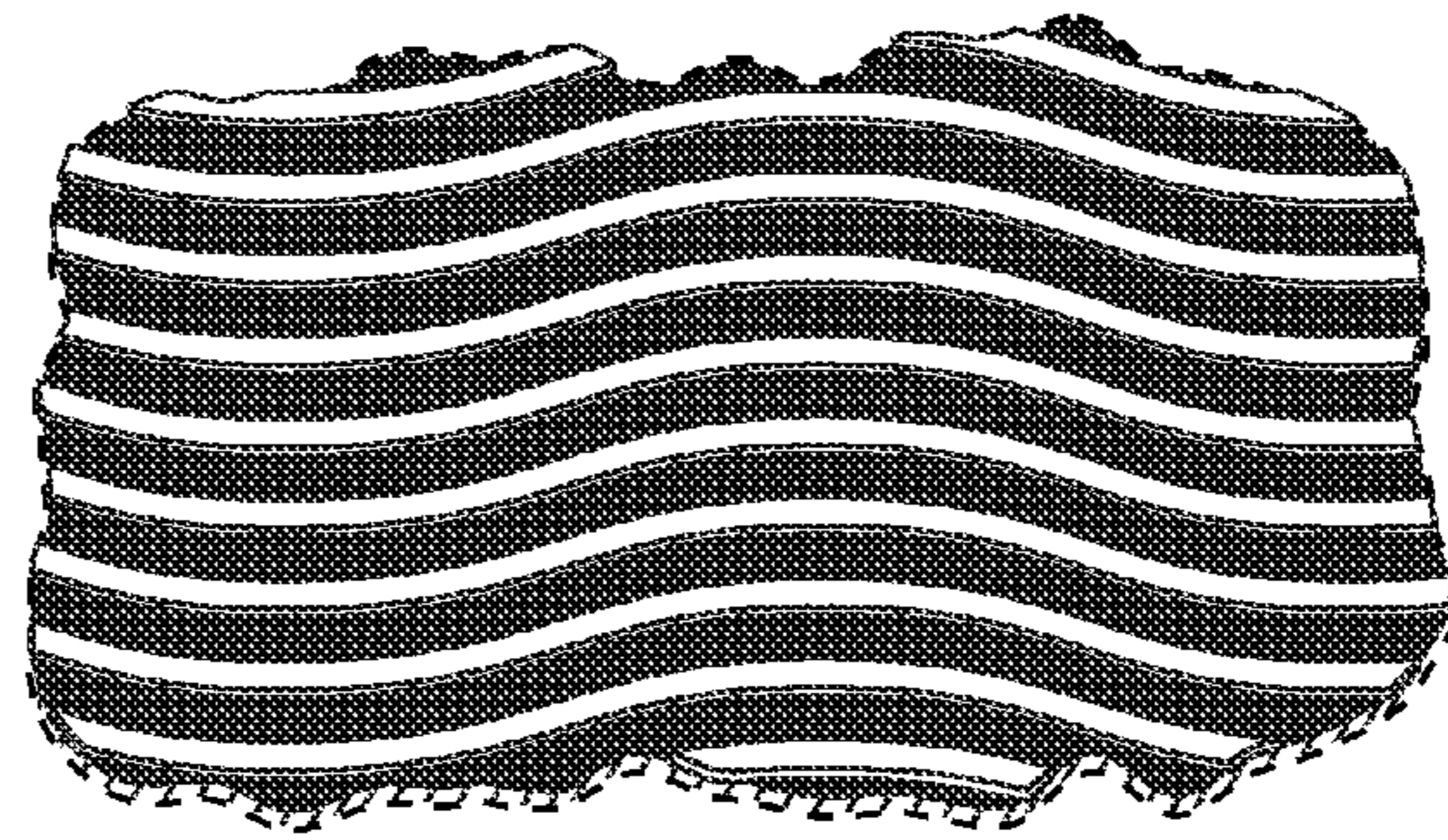

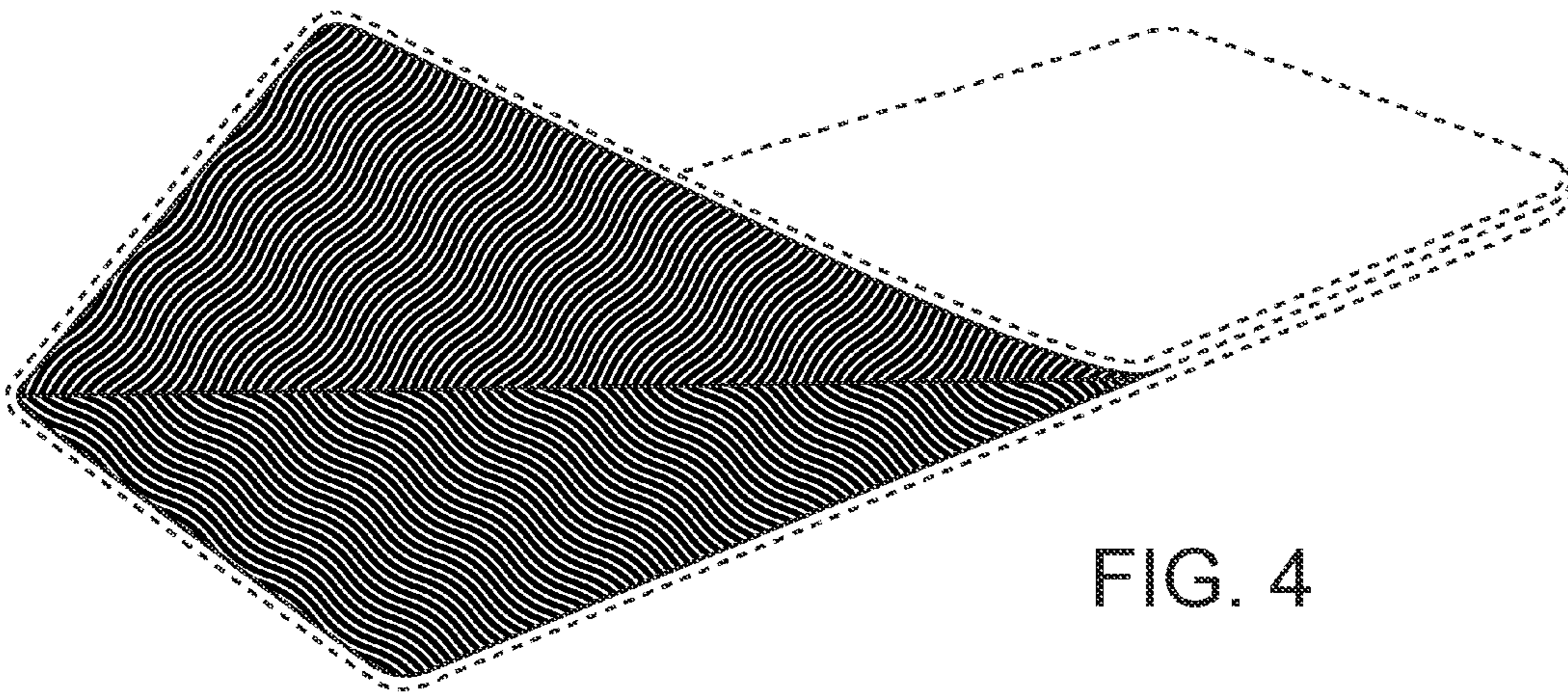

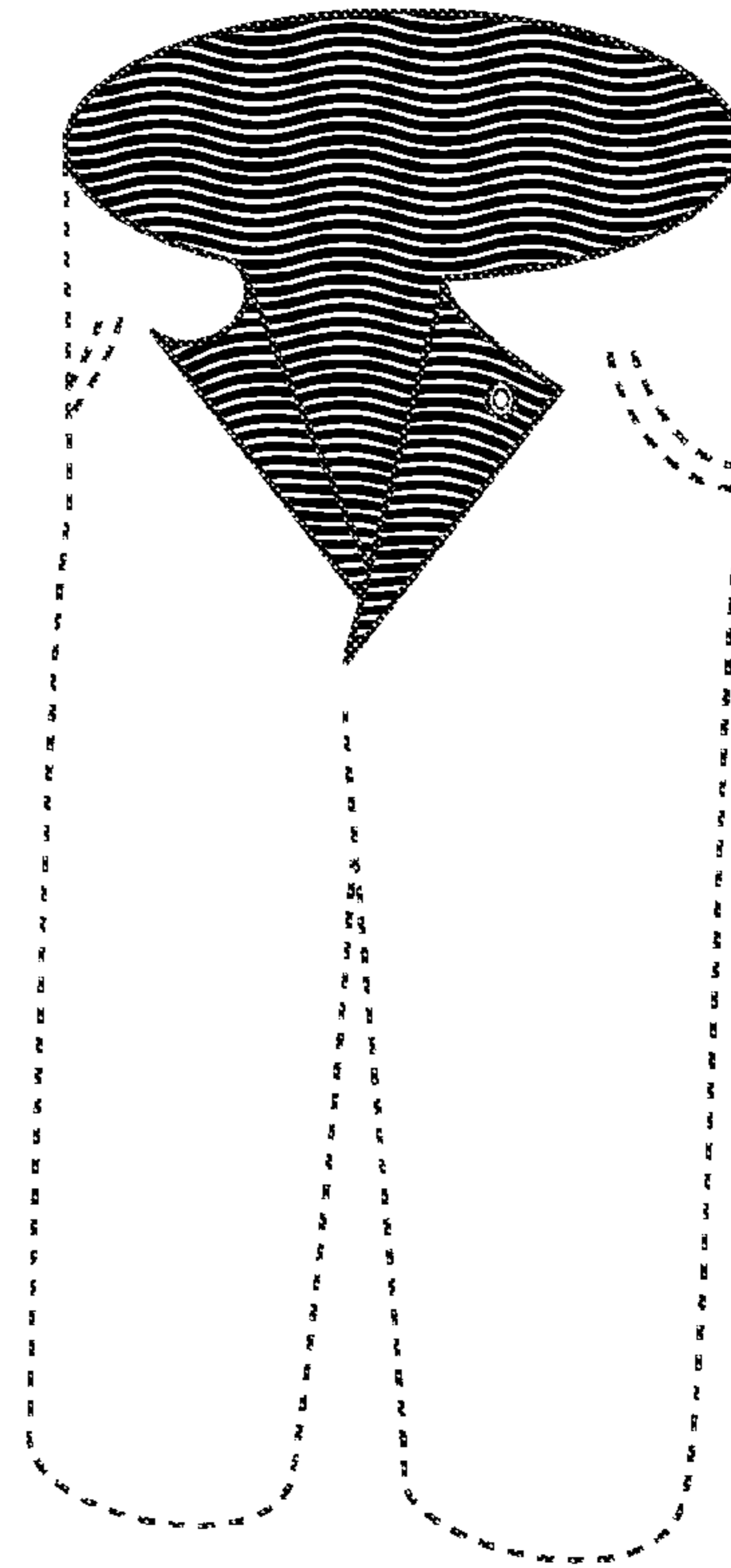

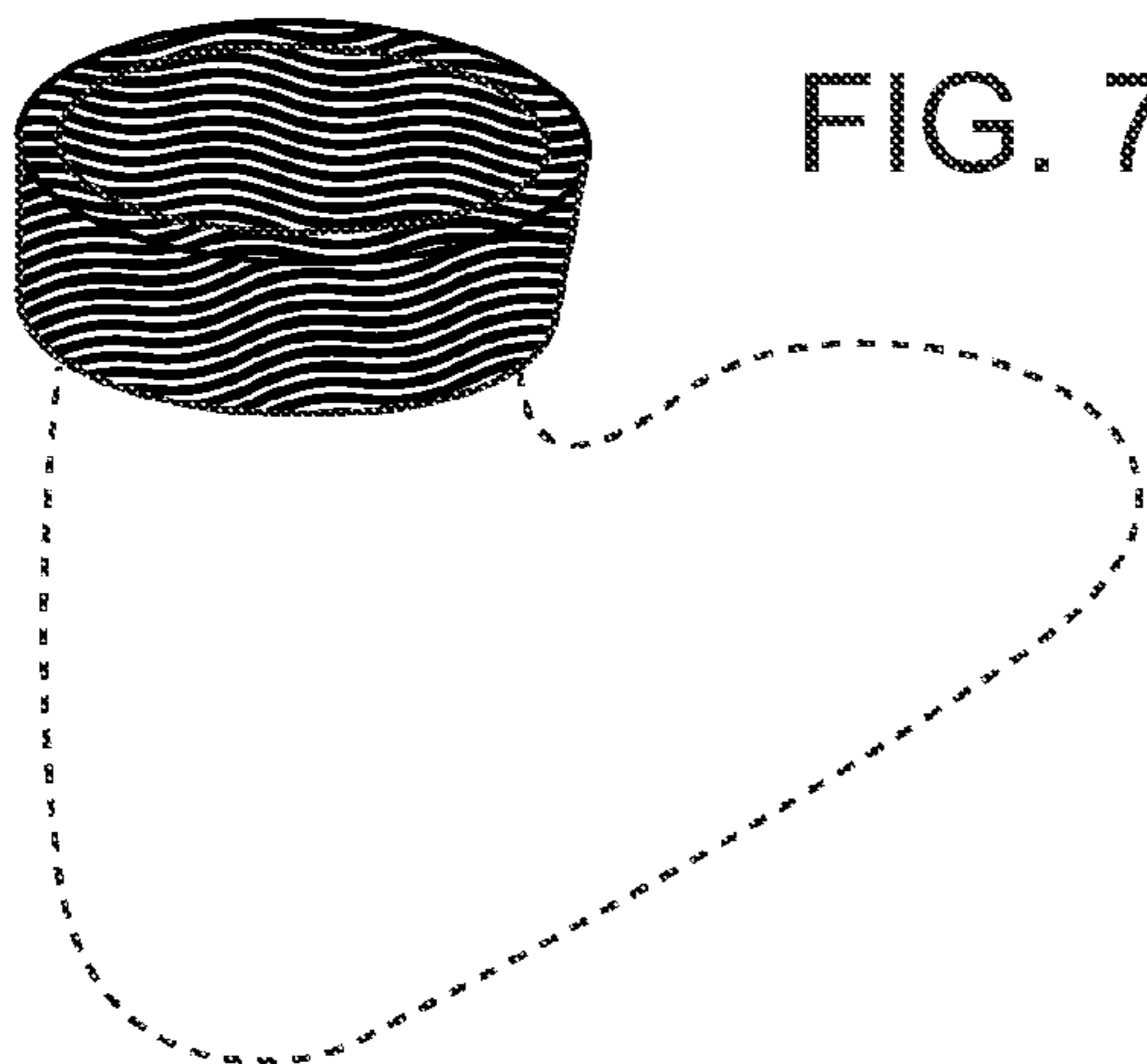

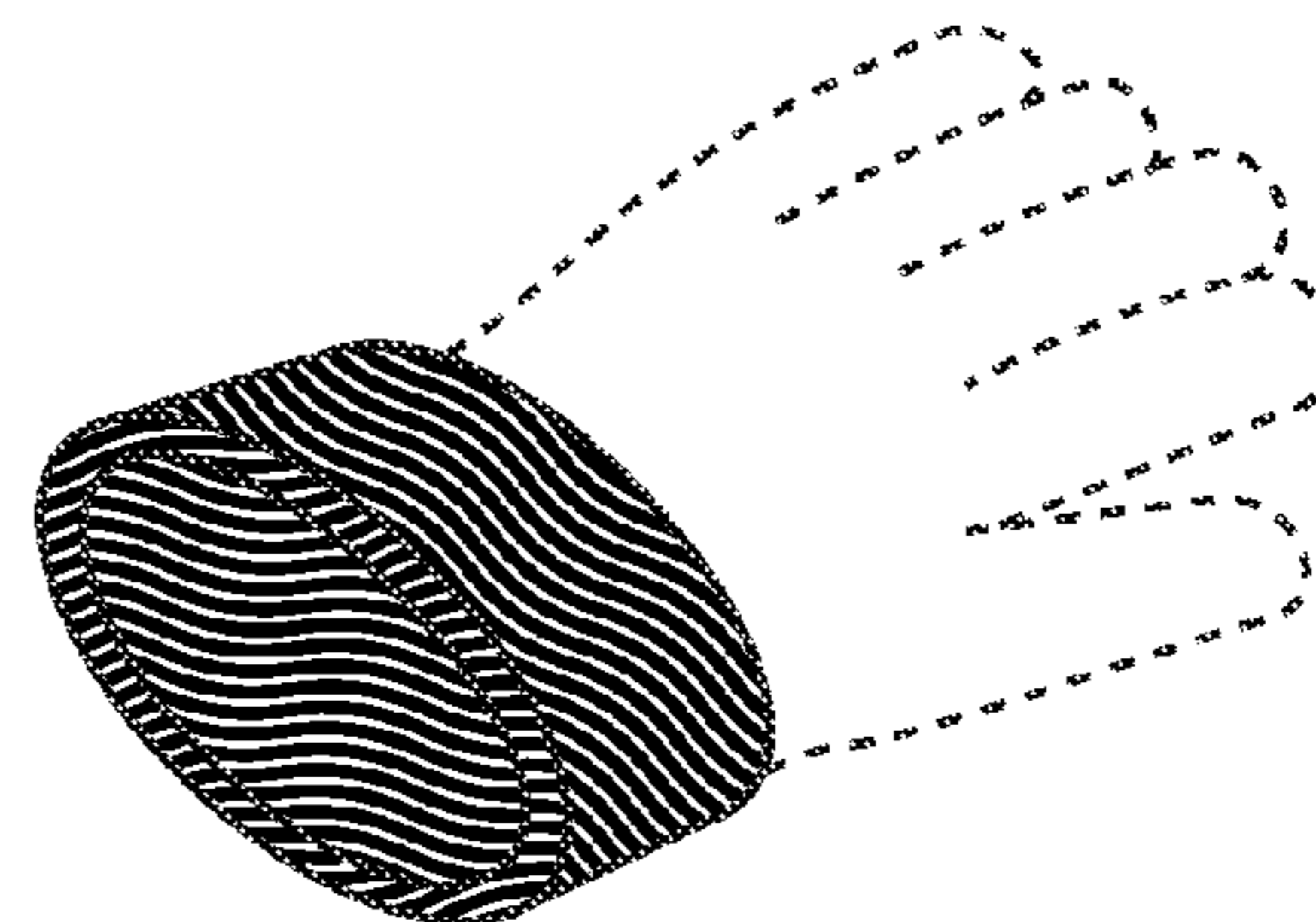

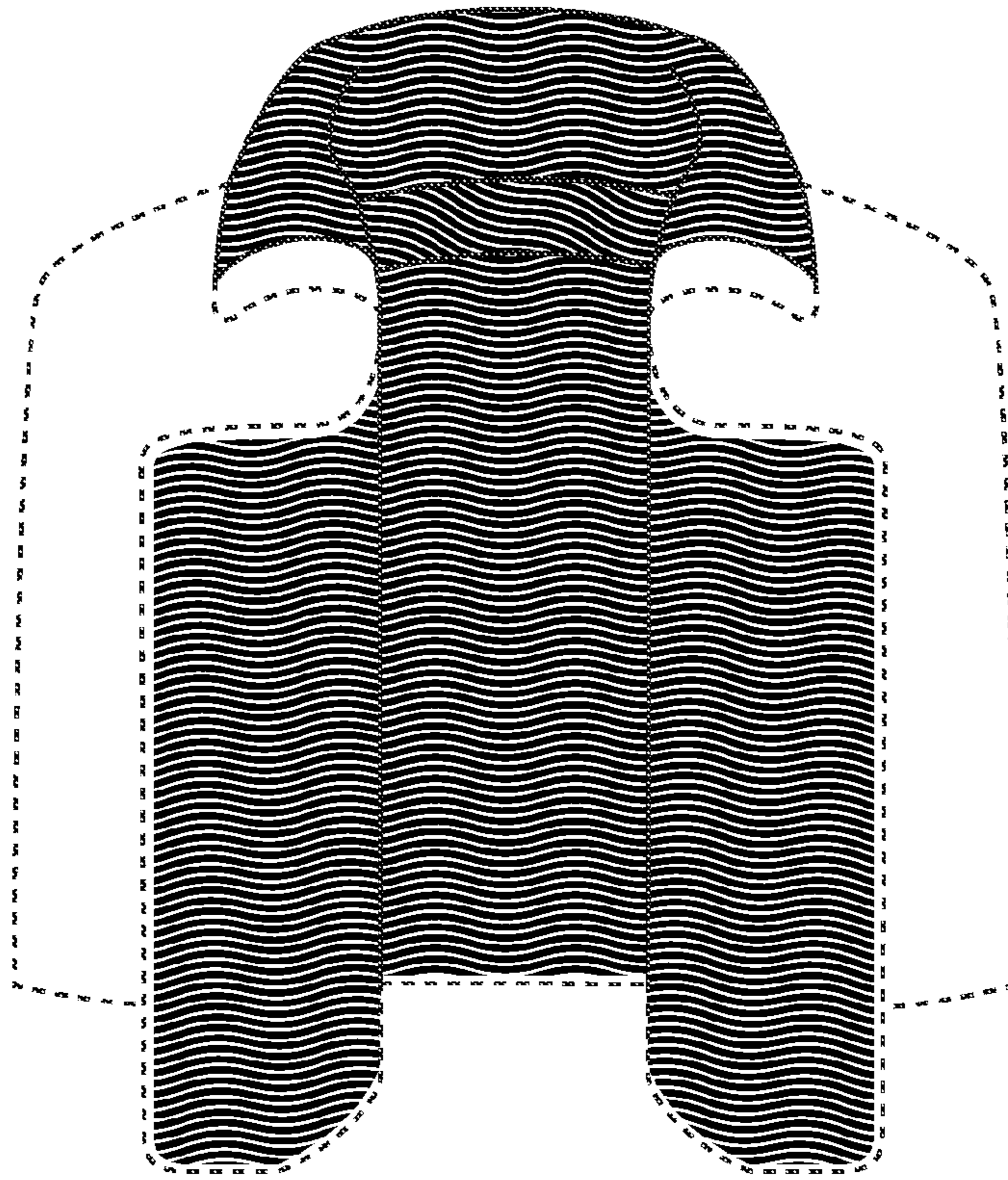
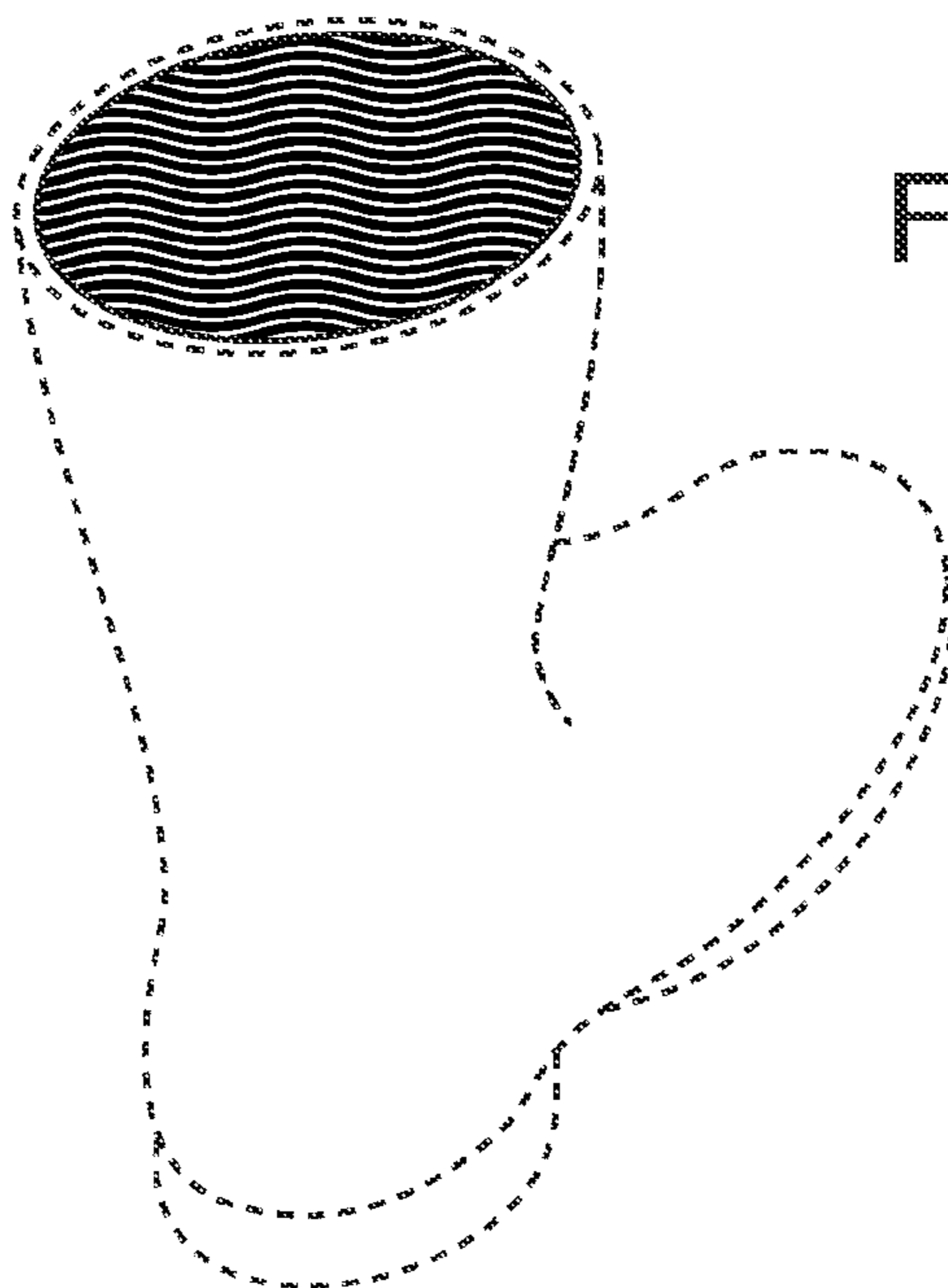
