(57) **CLAIM**

I claim the ornamental design for a stitched baseball-style cap, as shown and described.

**DESCRIPTION**

FIG. 1 is an orthogonal view of a first embodiment of a stitched baseball-style cap.

FIG. 2 is a front view of the stitched baseball-style cap of FIG. 1.

FIG. 3 is a back view of the stitched baseball-style cap of FIG. 1.

FIG. 4 is a left side view of the stitched baseball-style cap of FIG. 1 of which the right side (not shown) is a mirror image.

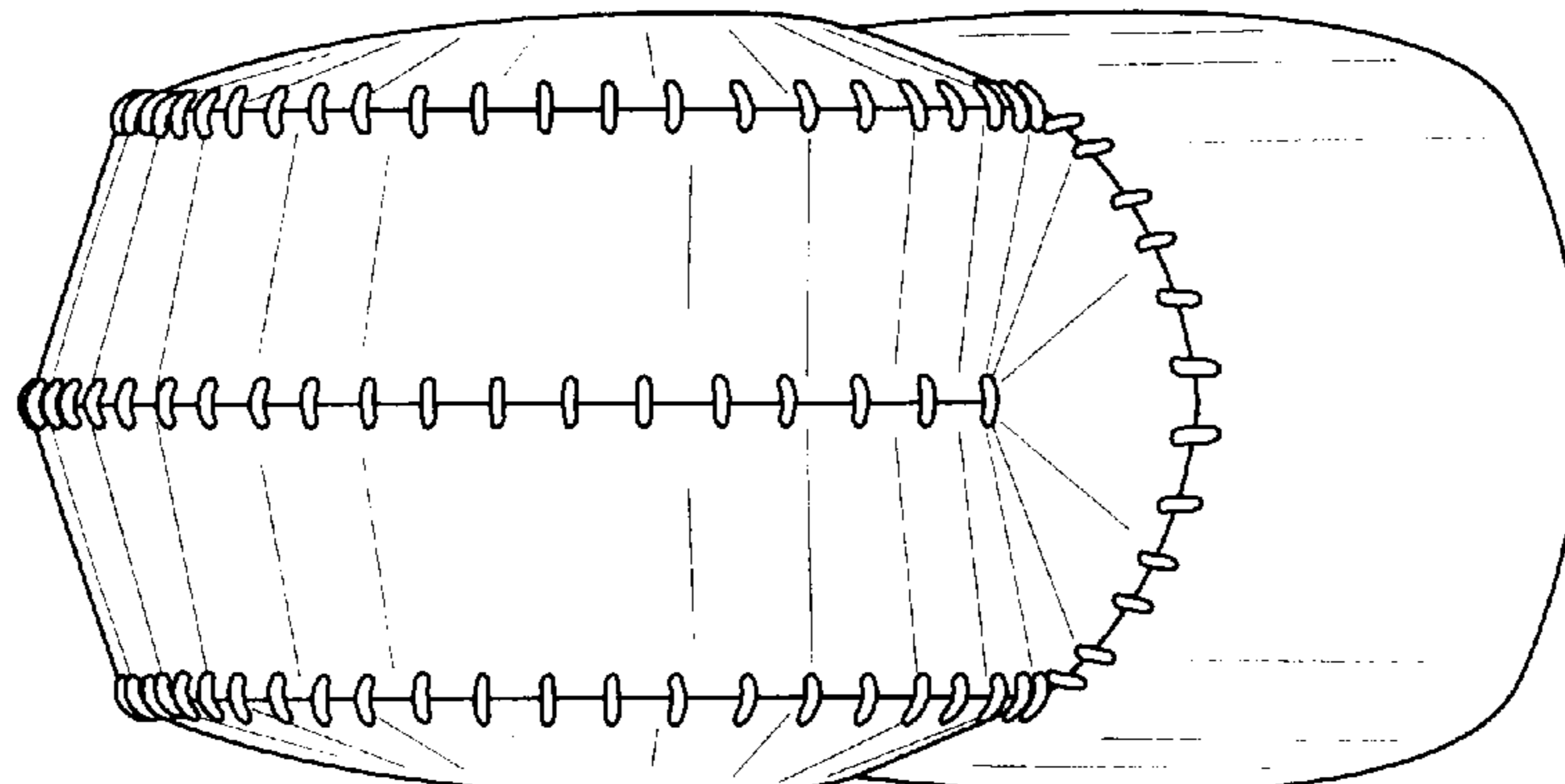
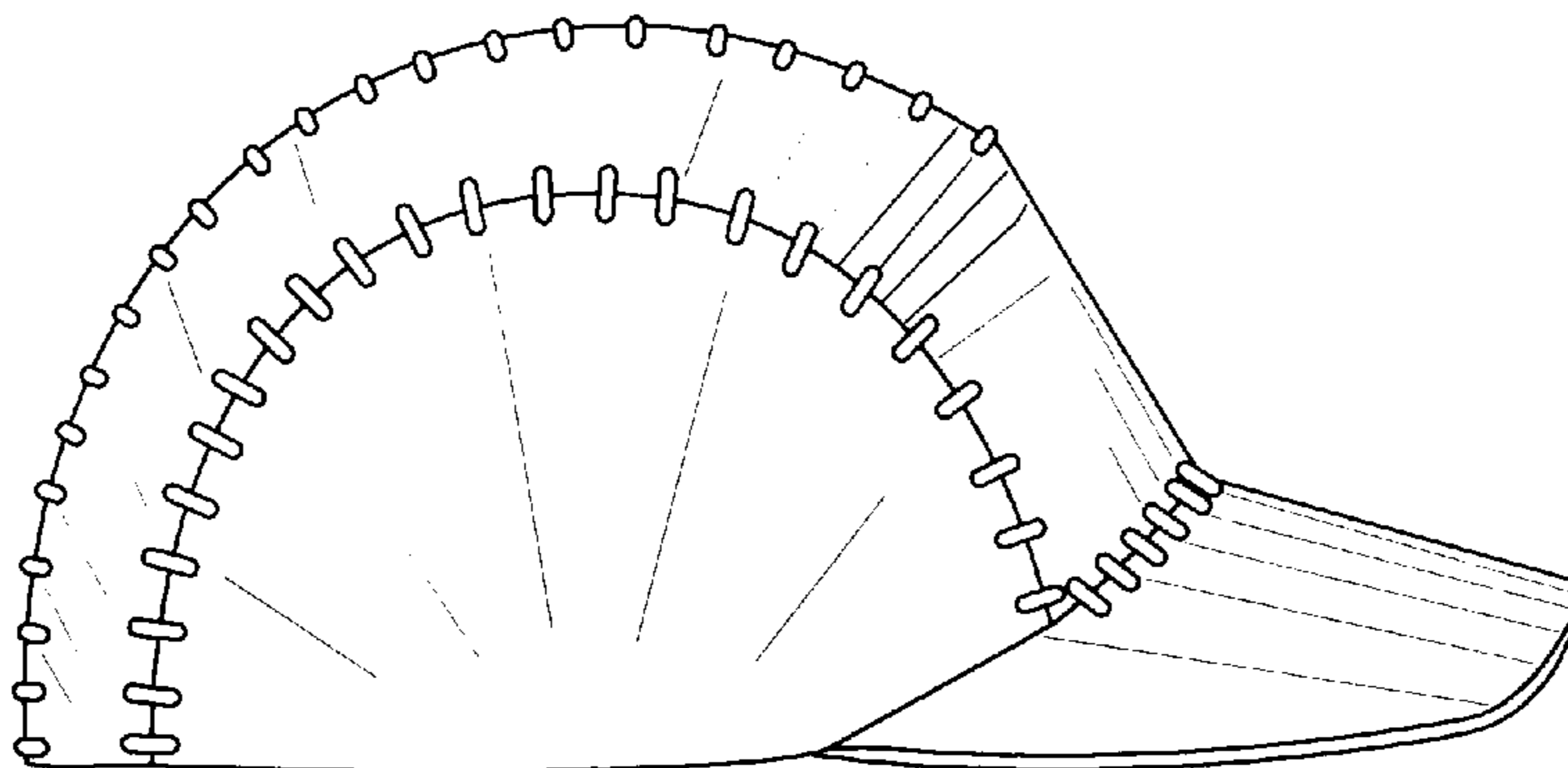
FIG. 5 is a top view of the stitched baseball-style cap of FIG. 1.

FIG. 6 is a bottom view of the stitched baseball-style cap of FIG. 1; and,

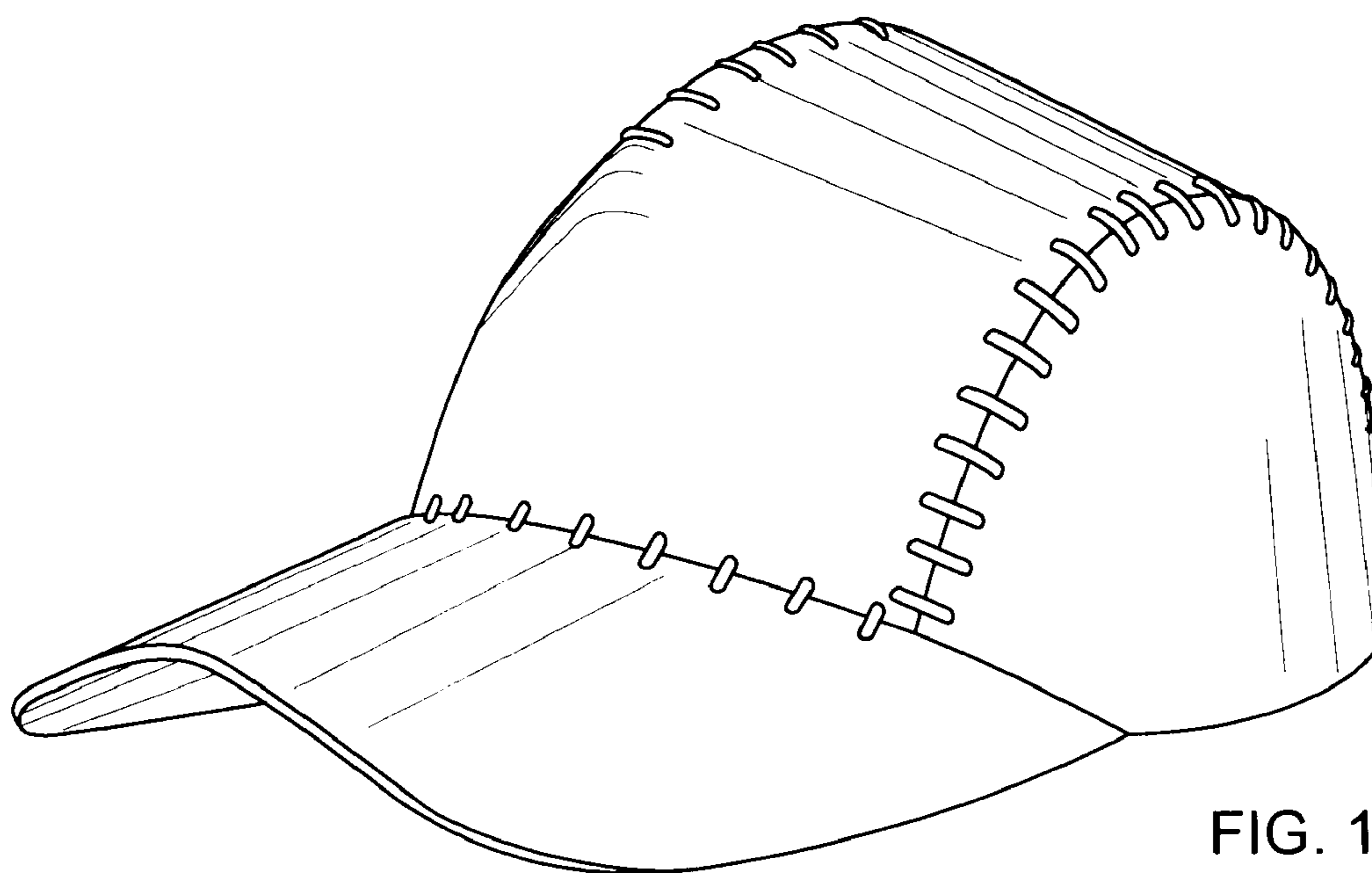

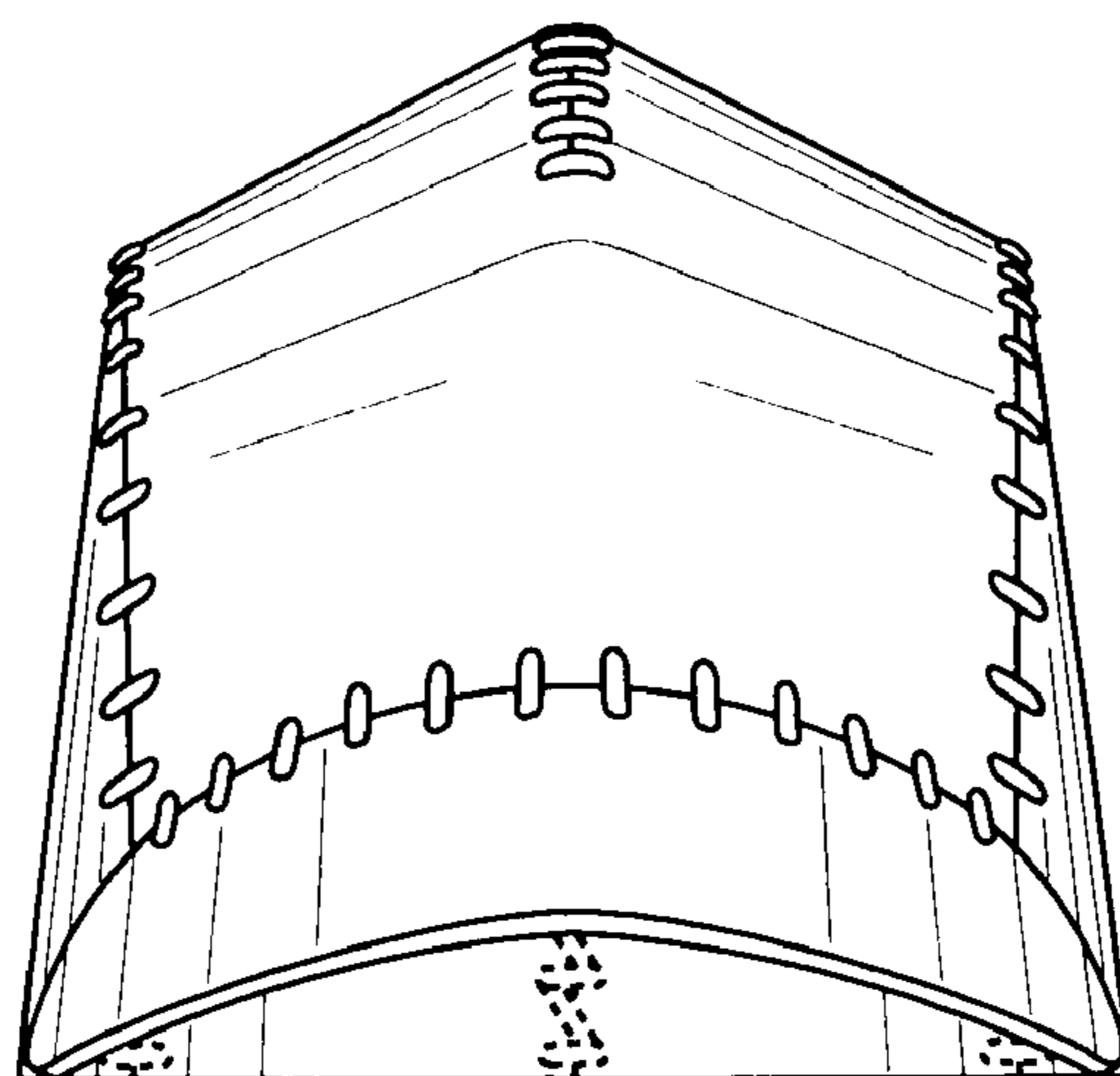

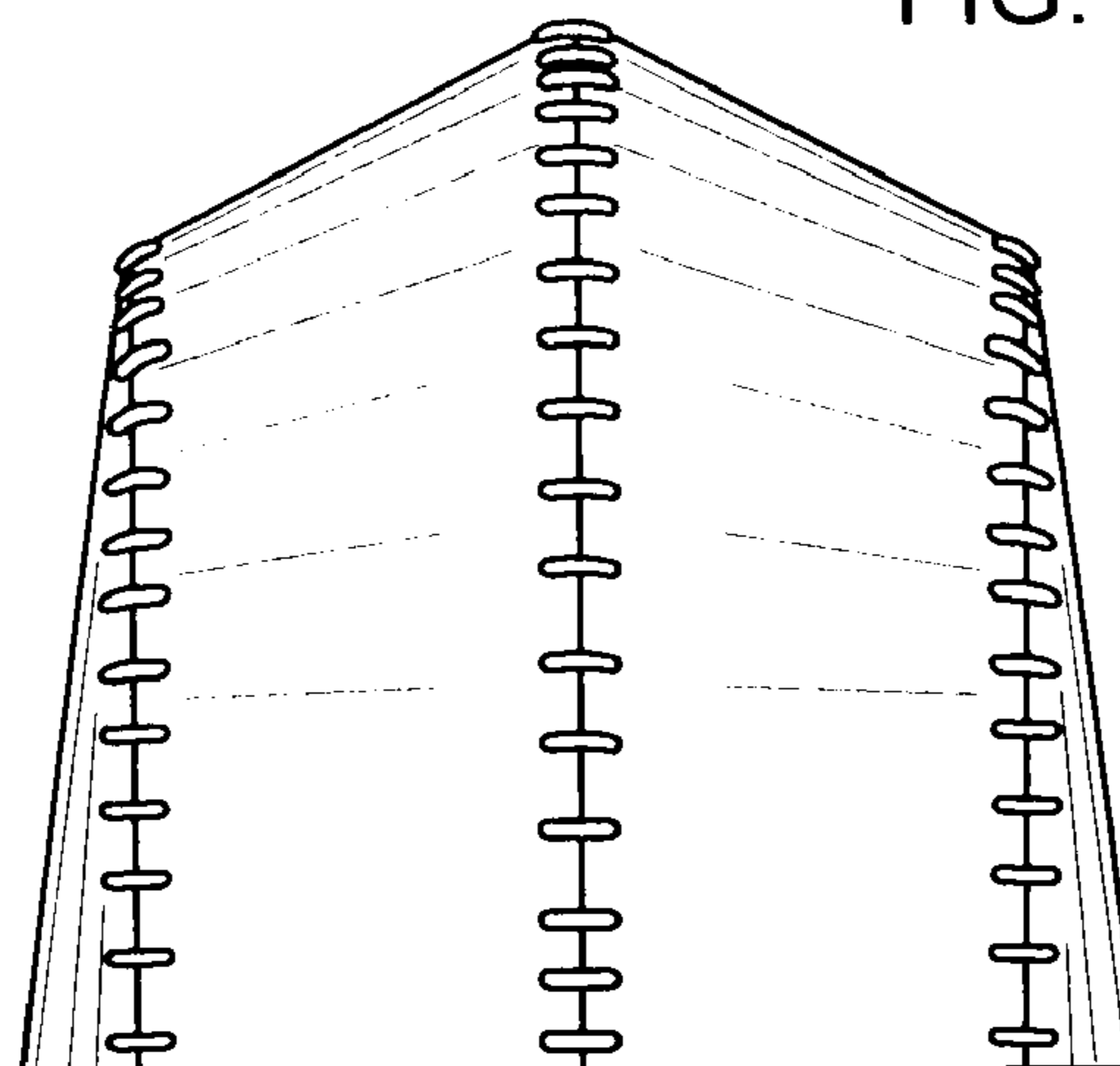

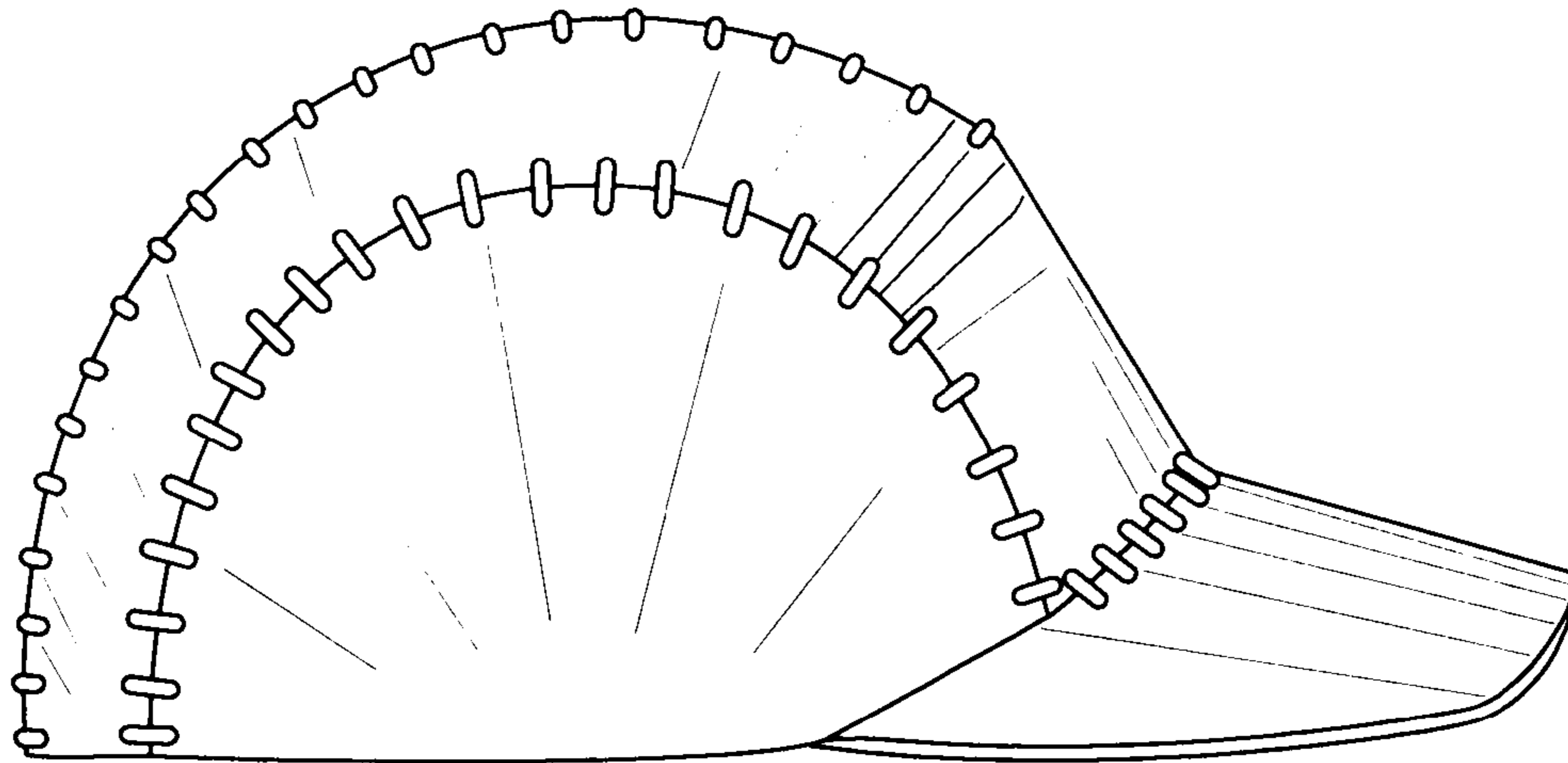

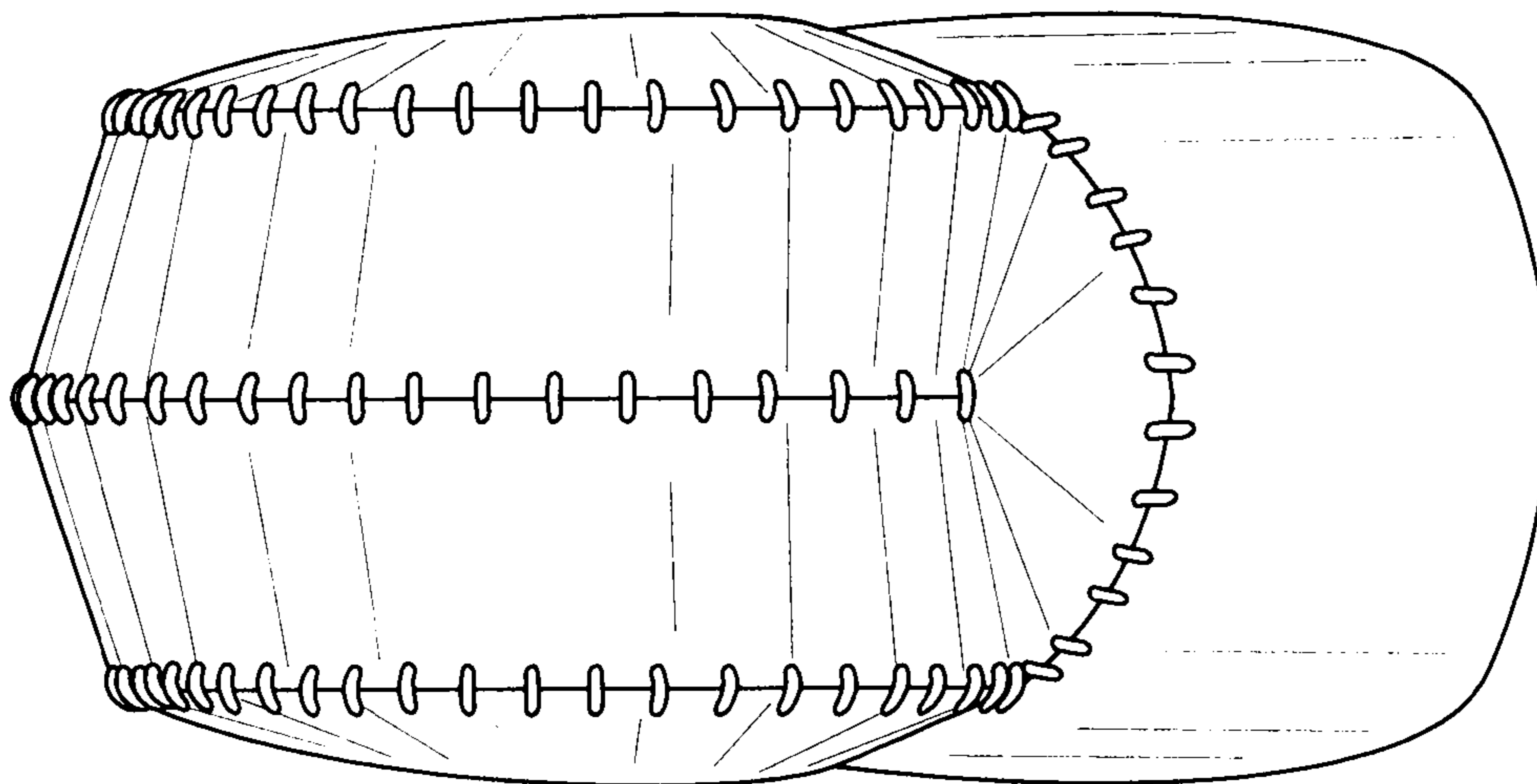

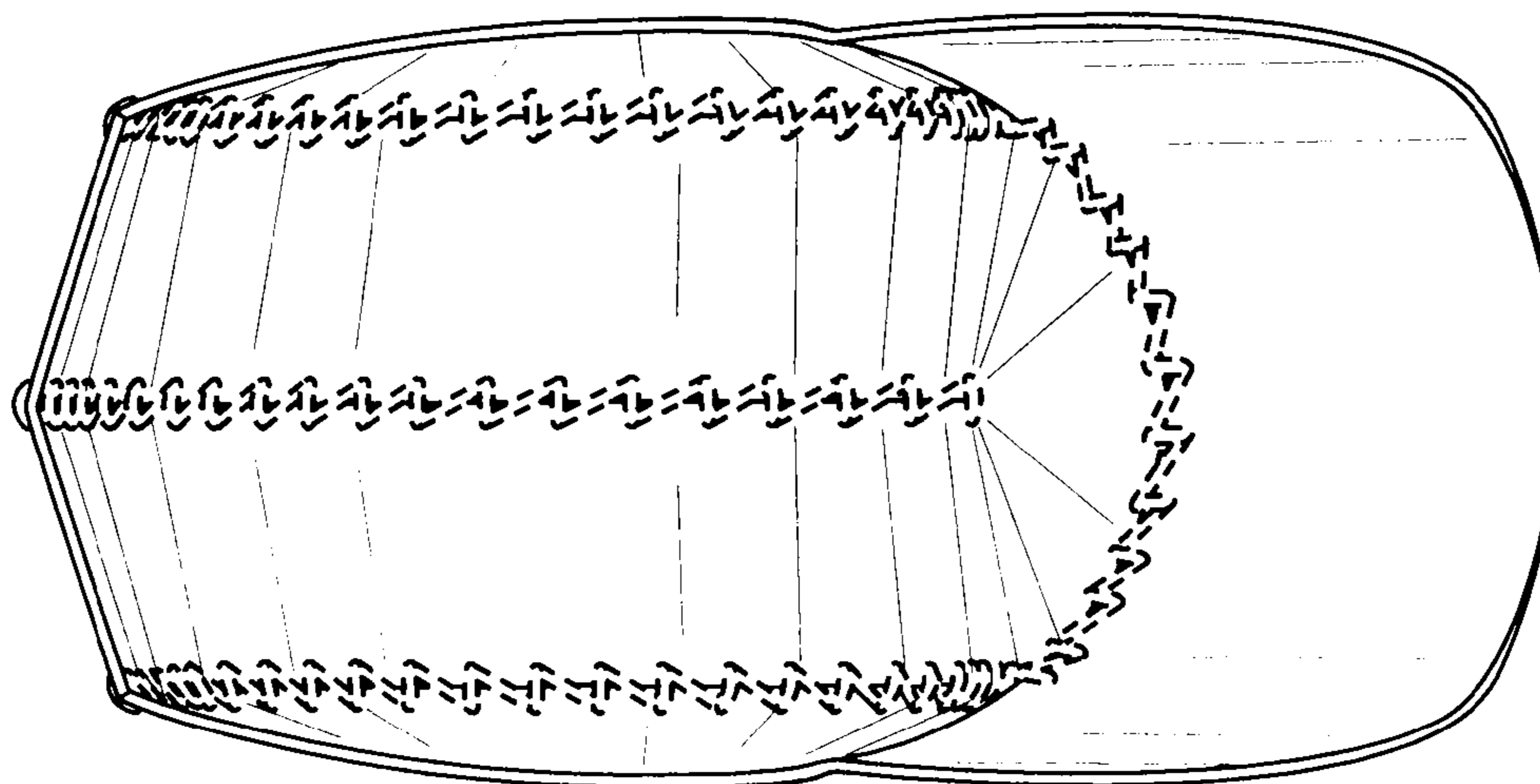

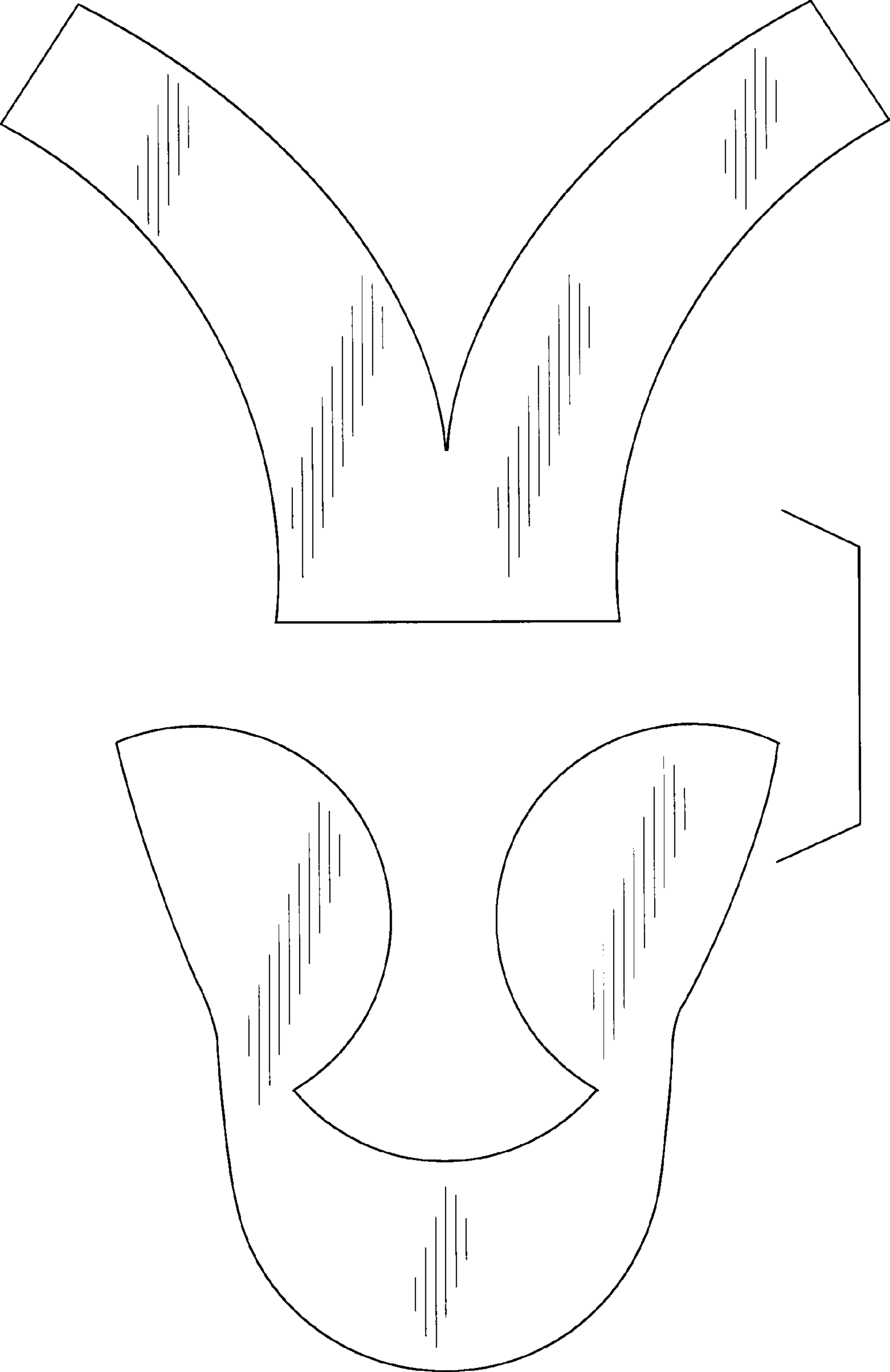
