(57) **CLAIM**

The ornamental design for a cabinet for a ceramic cooker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the cabinet for a ceramic cooker showing our new design with the door and drawer opened;

FIG. 2 is a front view showing the door and drawer in a closed position;

FIG. 3 is a right side view thereof;

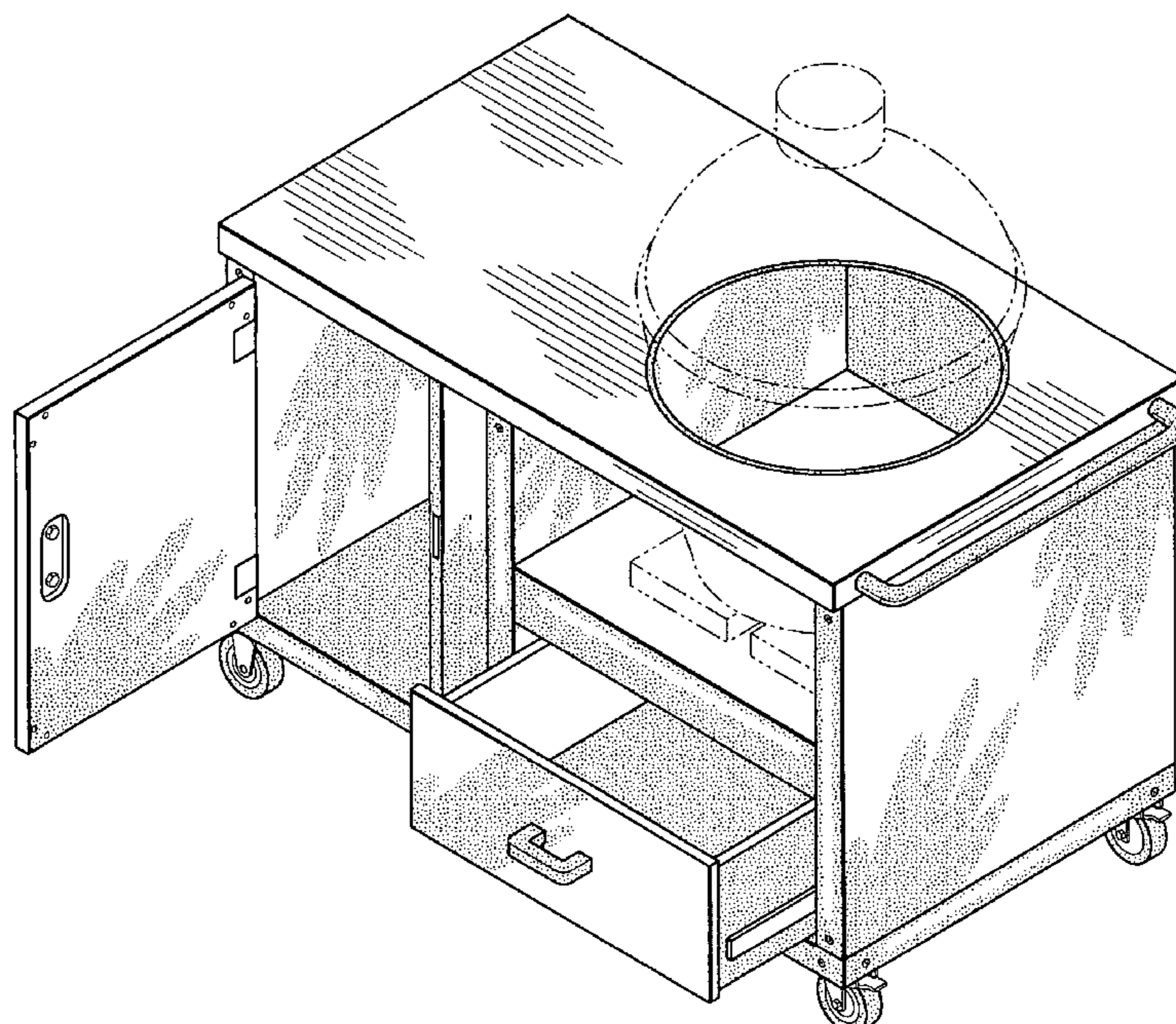
FIG. 4 is a left side view thereof;

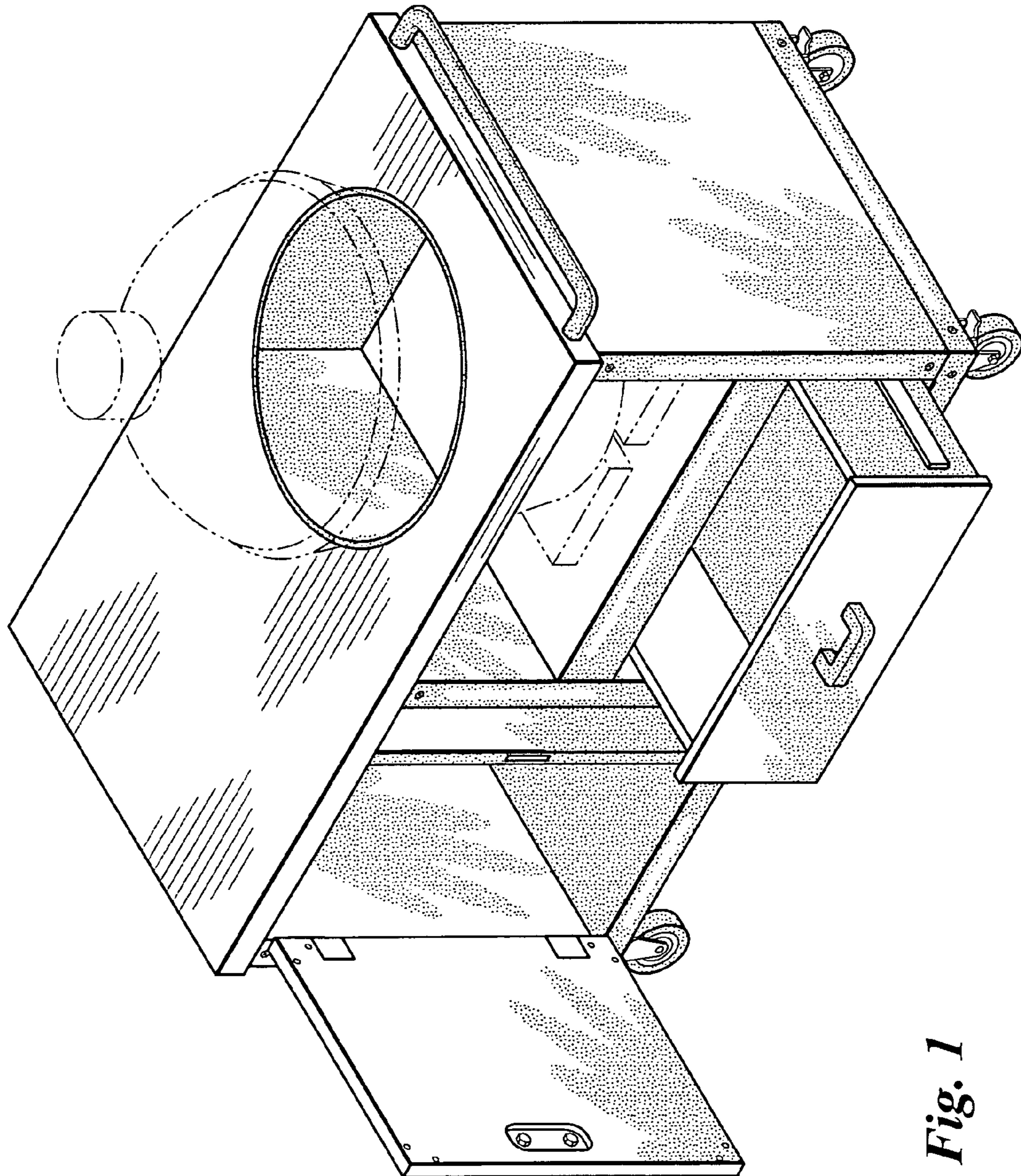

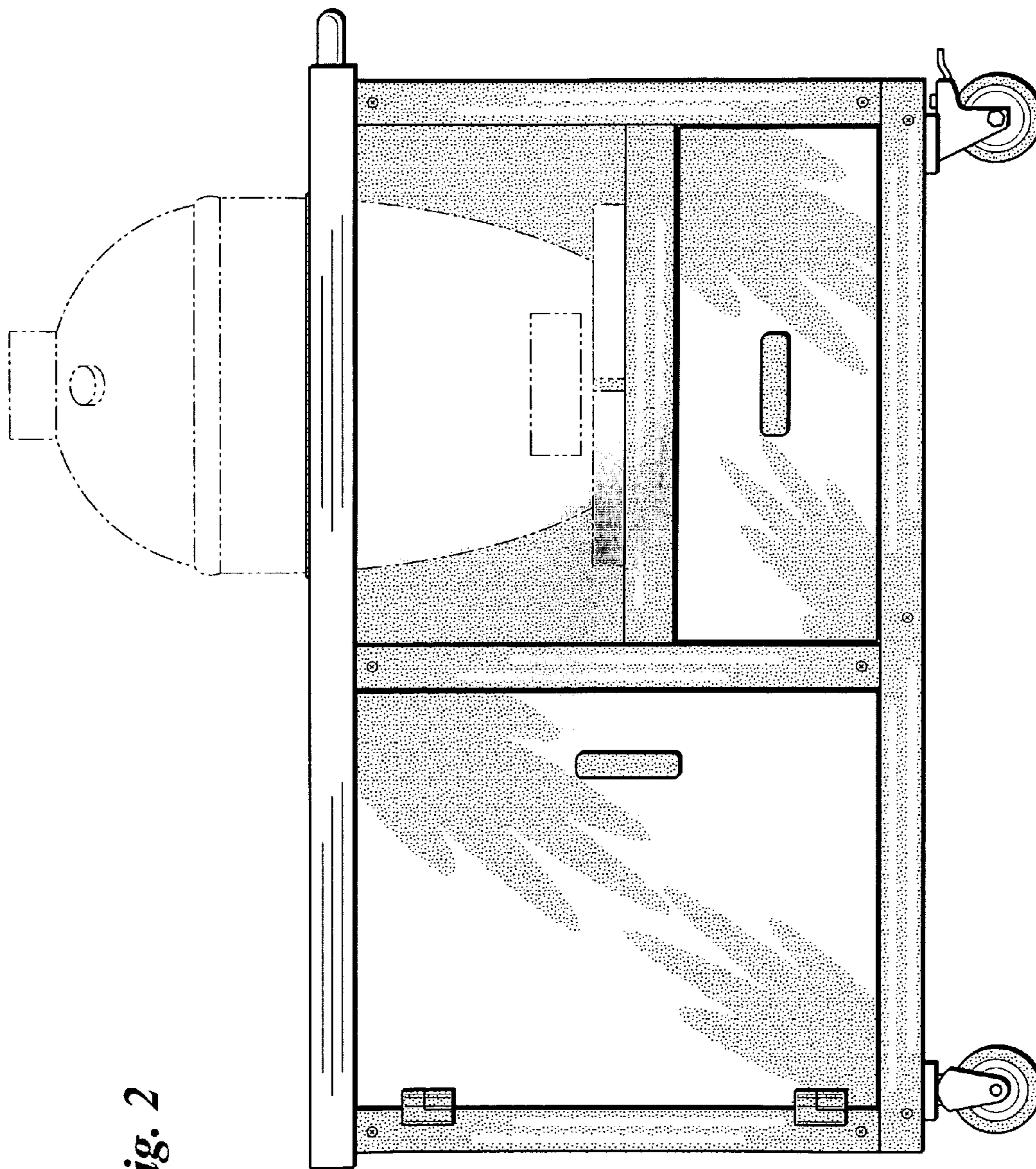

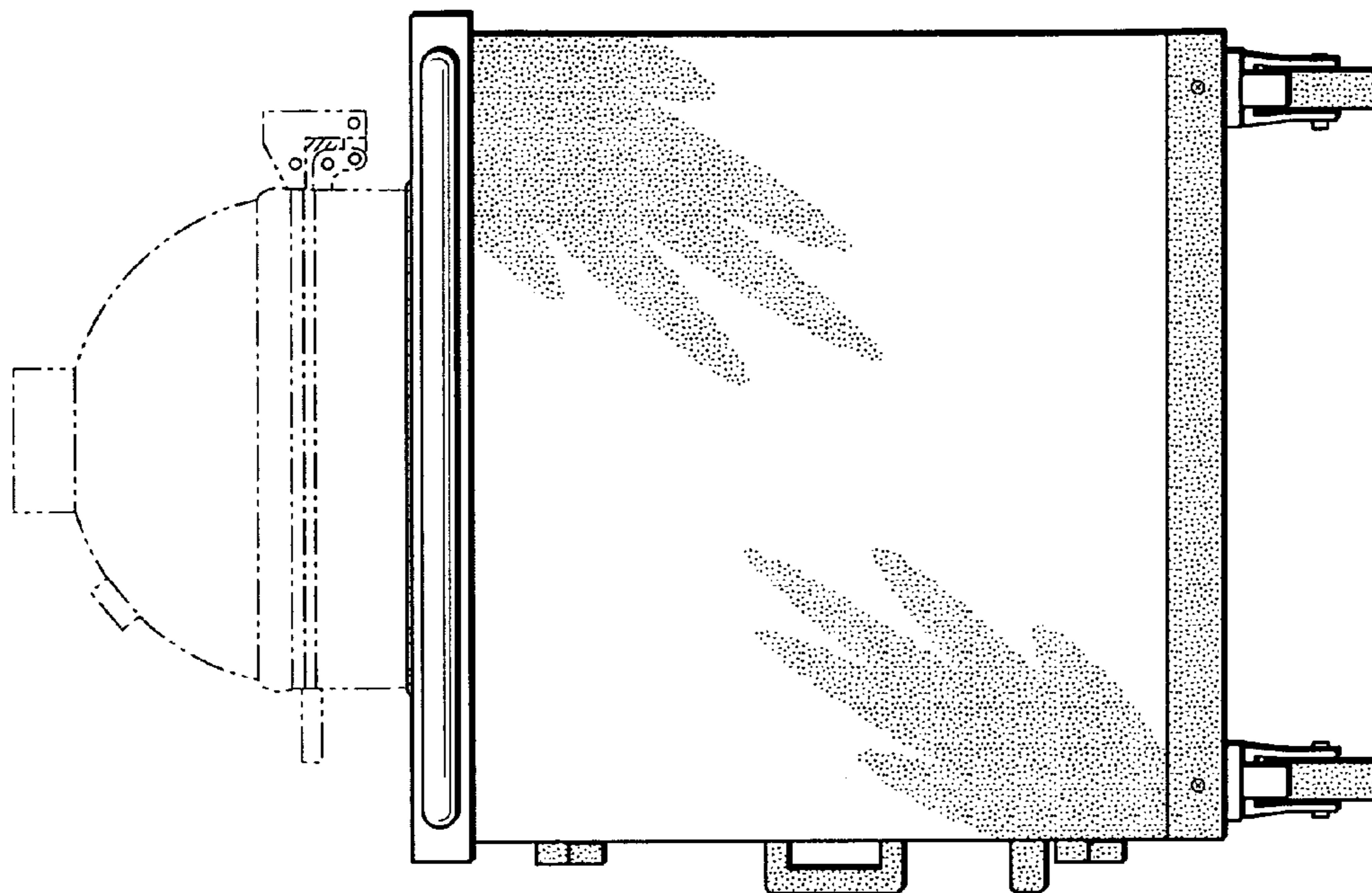

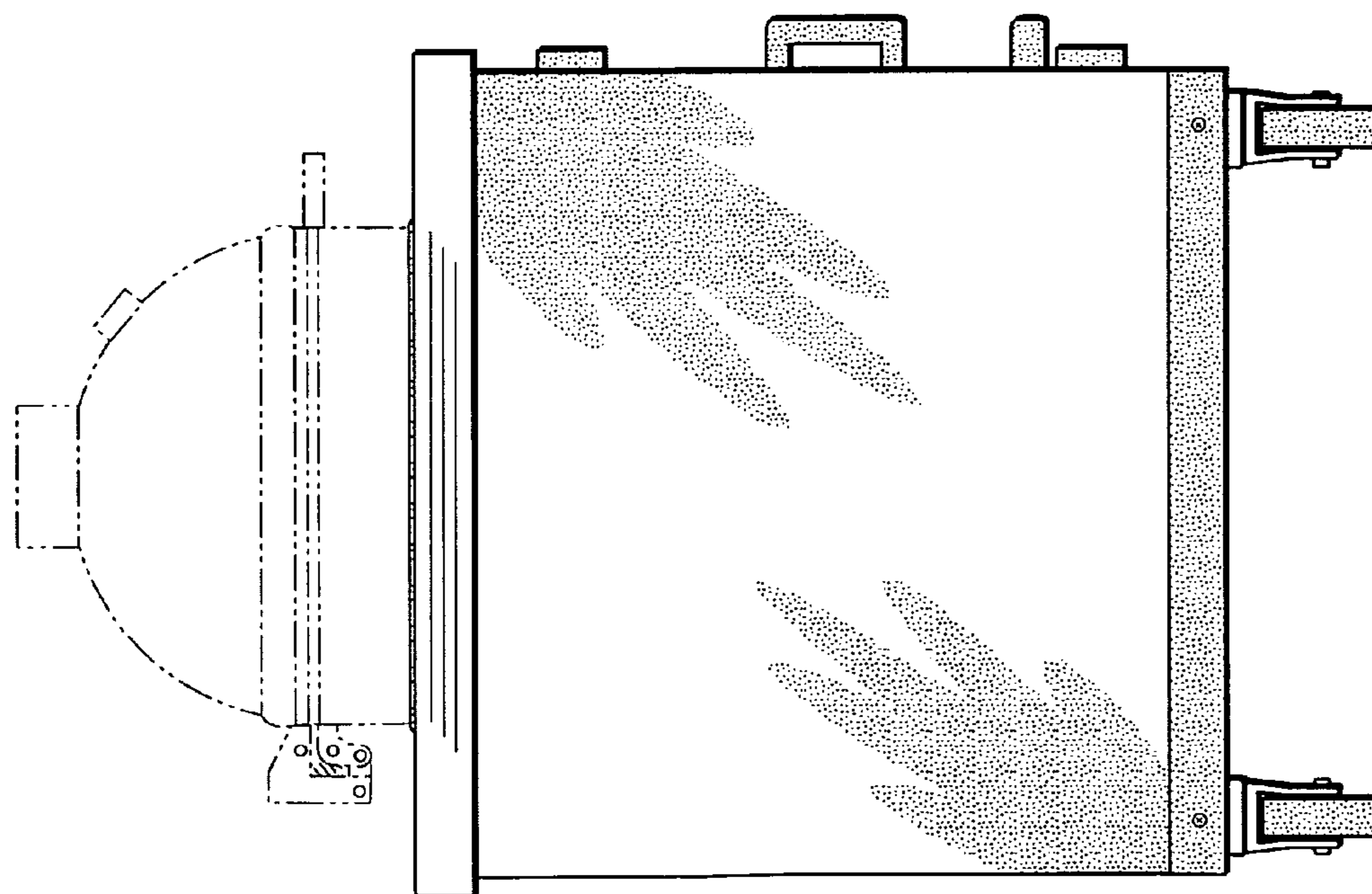

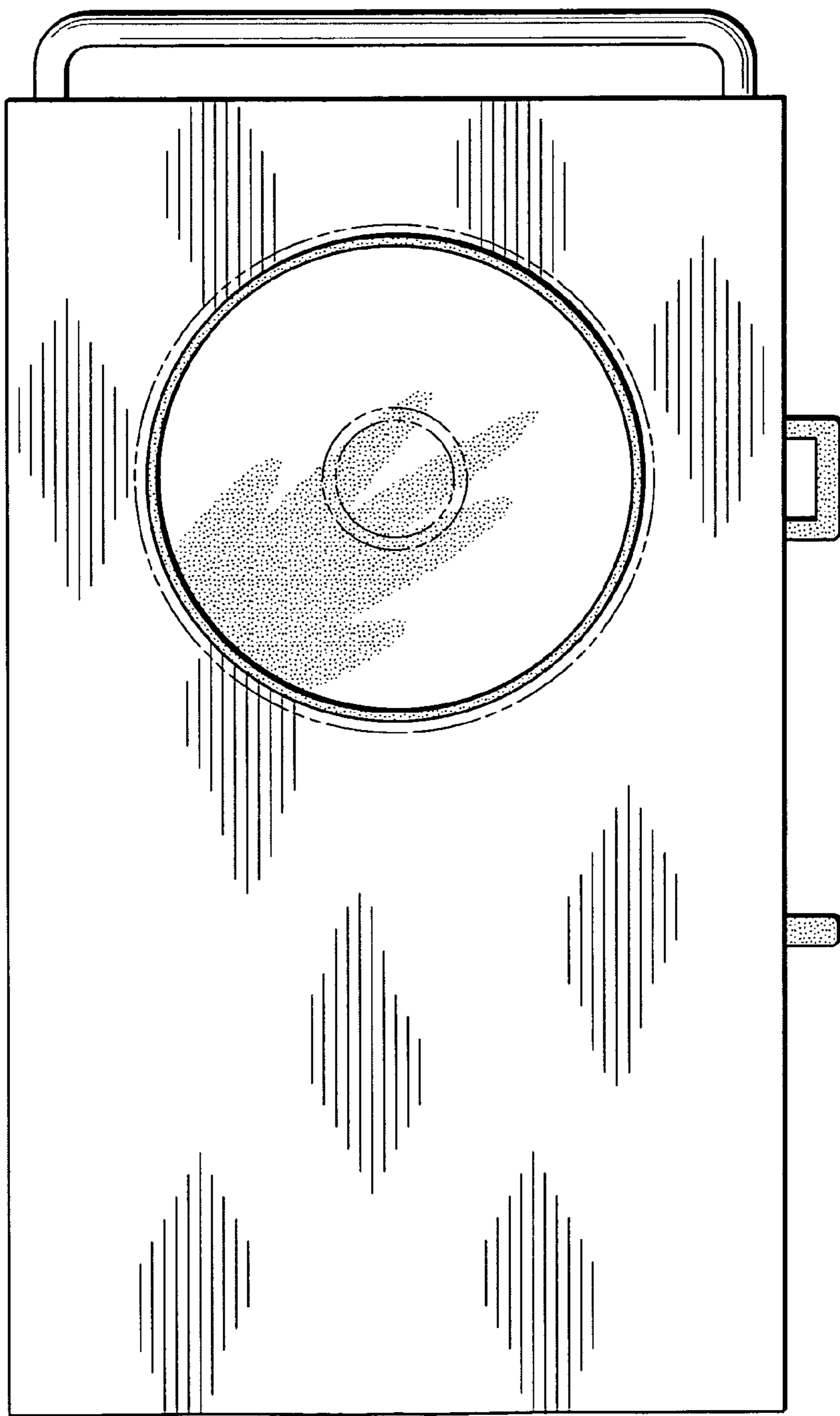

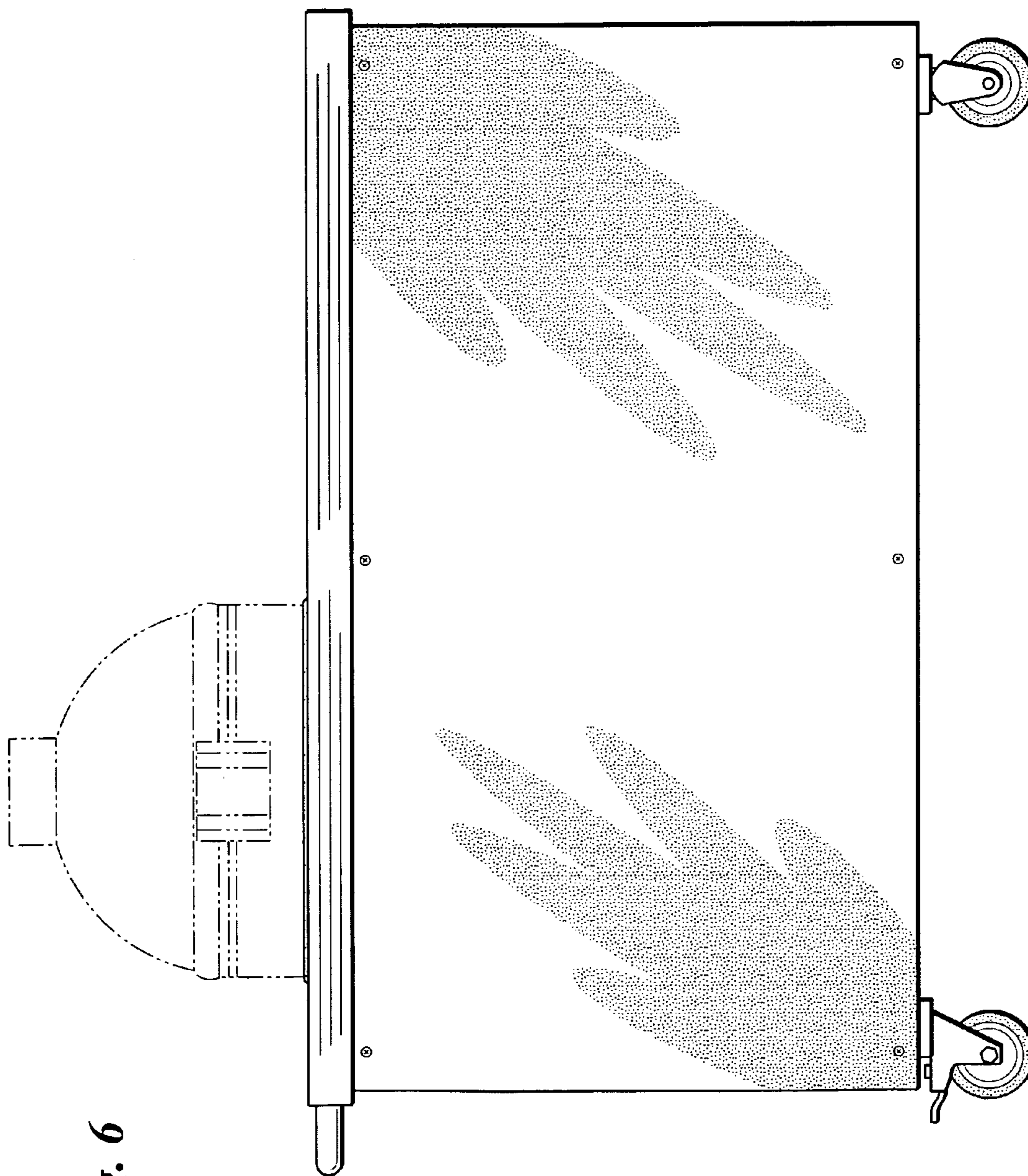
