as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of the material with medallion  
pattern showing our design.

FIG. 2 is a side view of the material with medallion pattern  
illustrated in FIG. 1.

FIG. 3 is an end view of the material with medallion pattern  
illustrated in FIG. 1.

FIG. 4 is a bottom plan view of the material with medallion  
pattern illustrated in FIG. 1; and,

FIG. 5 is a cross-sectional view of the material with medallion  
pattern taken through line 5-5 of FIG. 4.

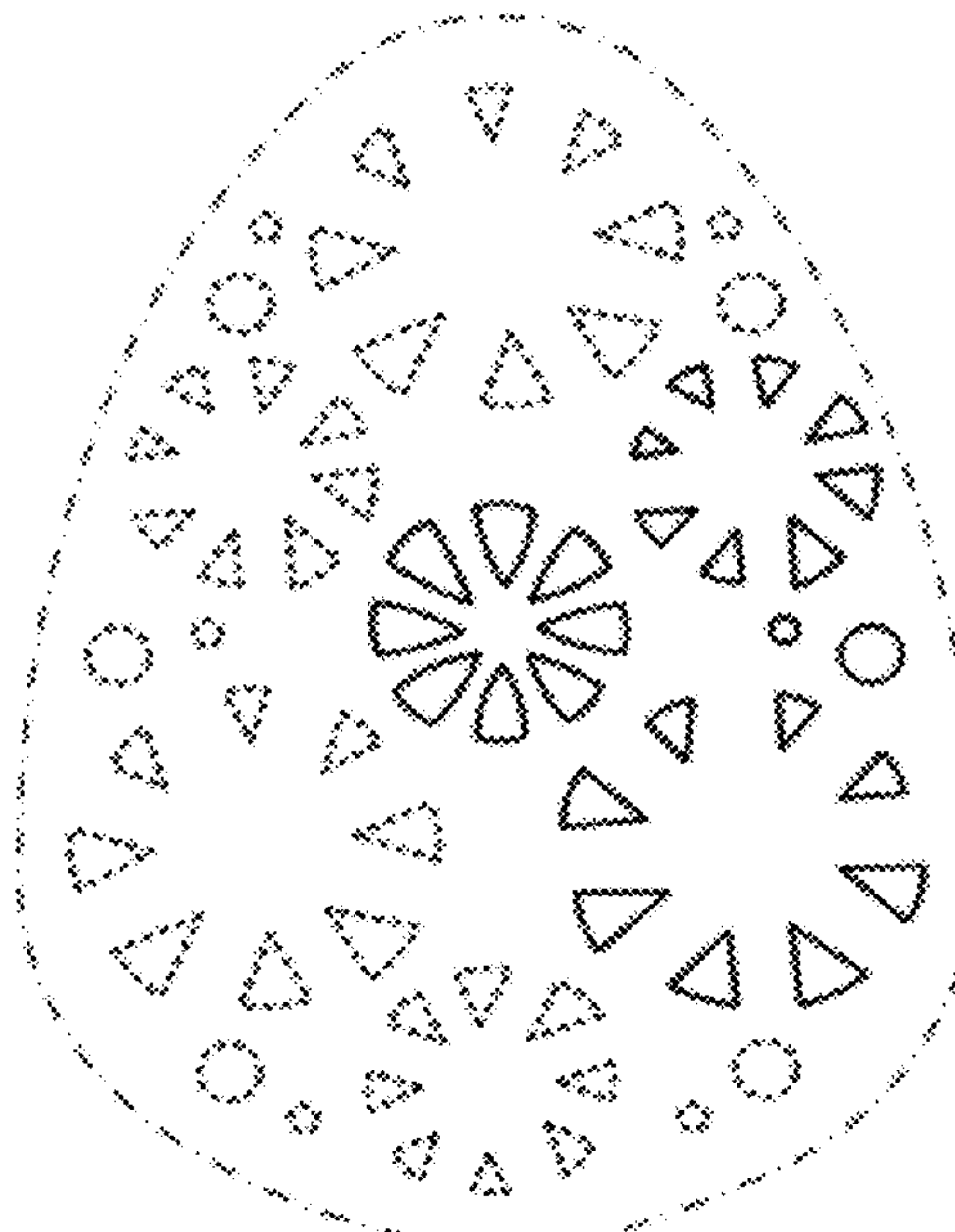

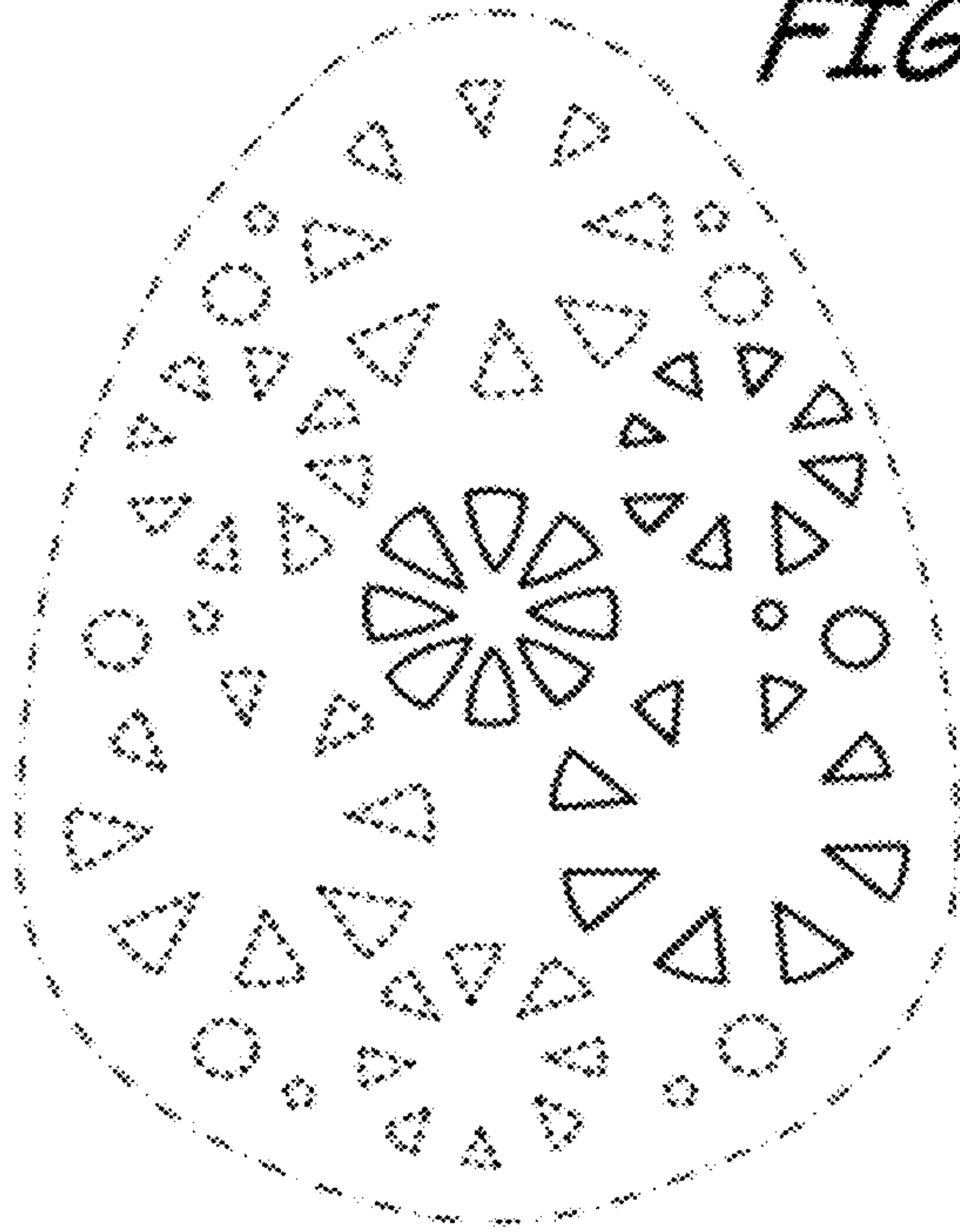

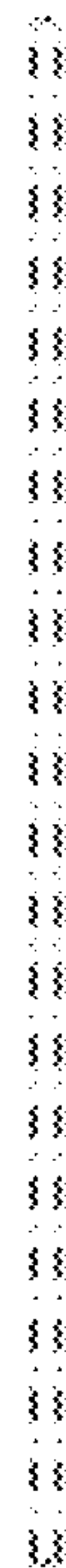
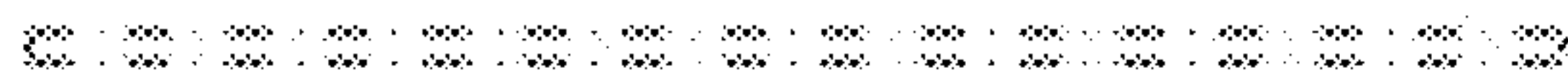

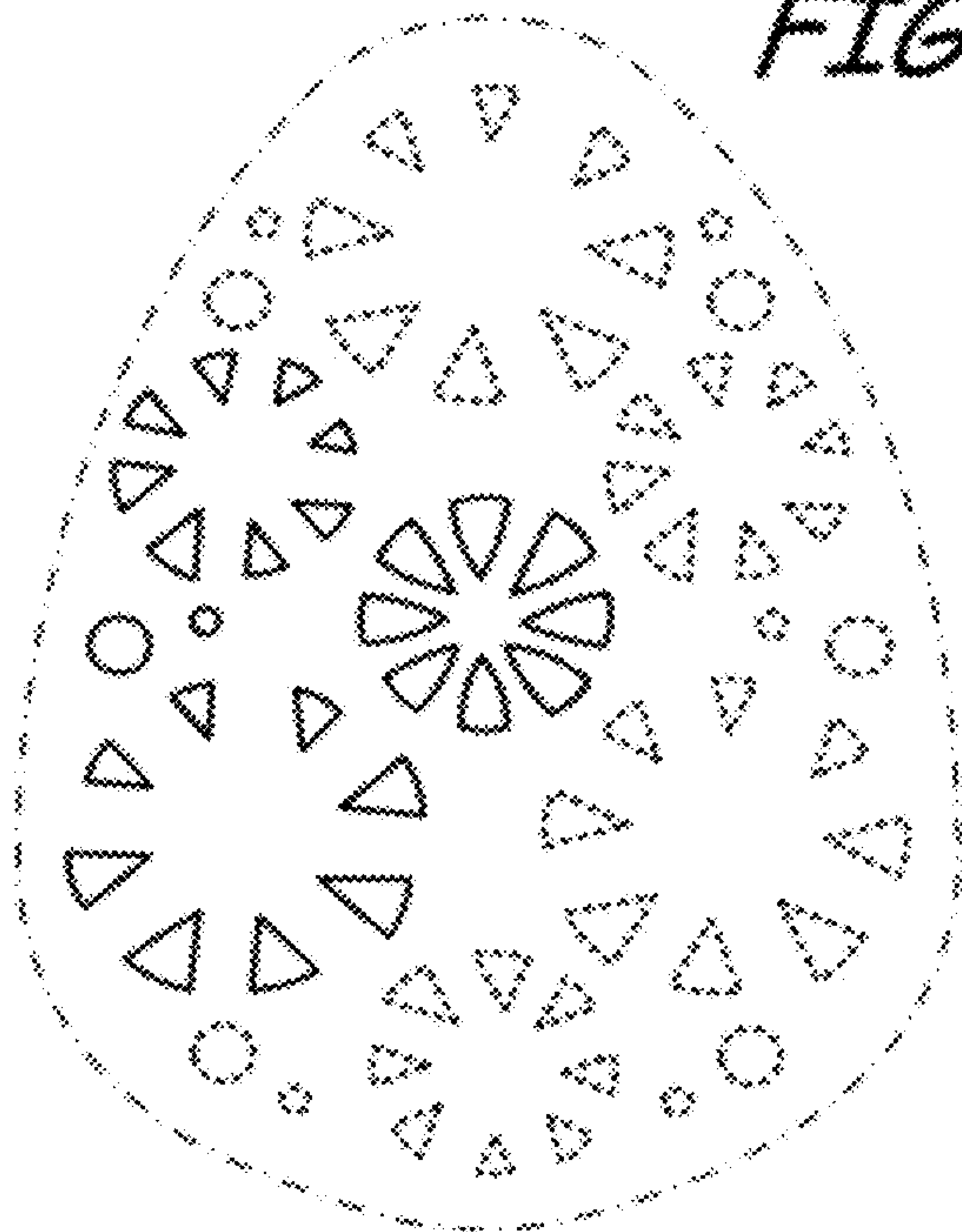
