FIG. 5 is a back side view thereof, opposite of FIG. 4;

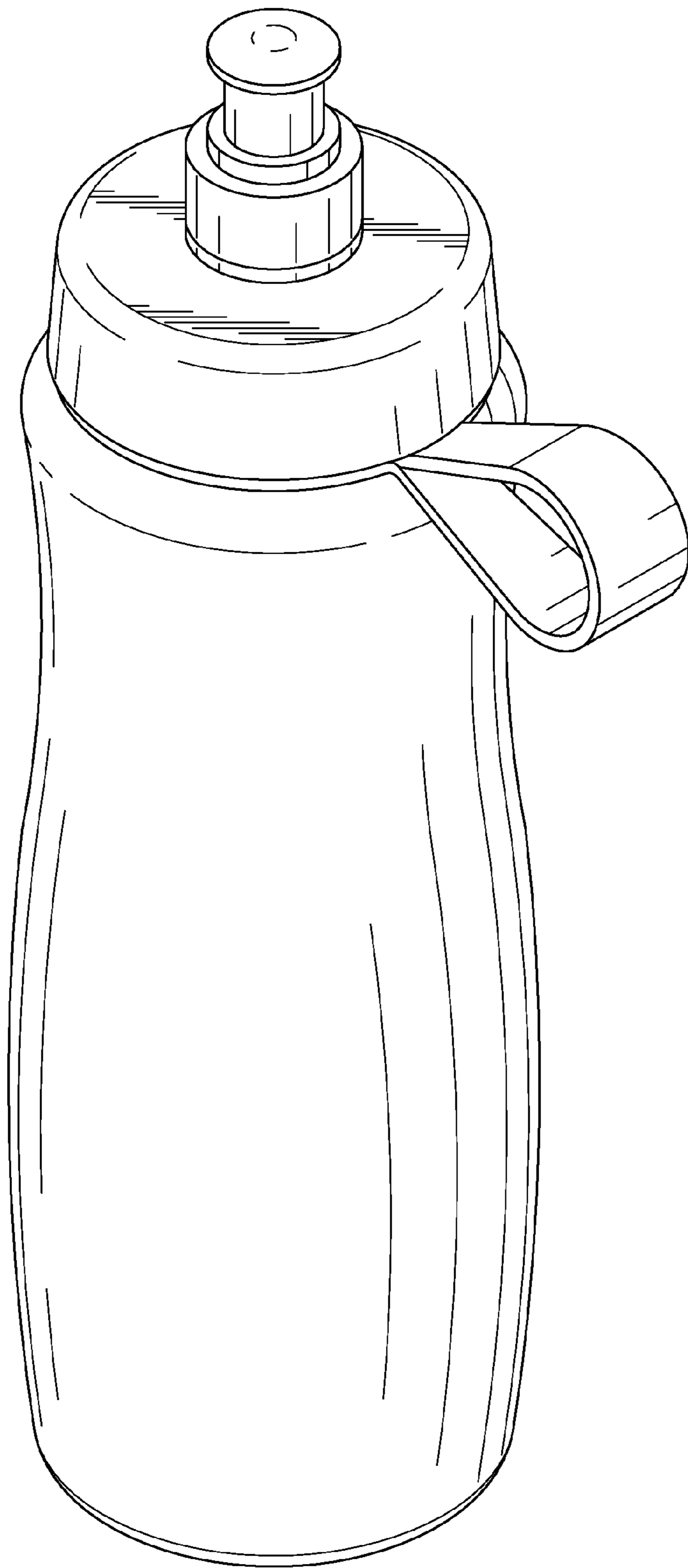
FIG. 6 is a top view thereof; and,

FIG. 7 is a bottom view thereof.

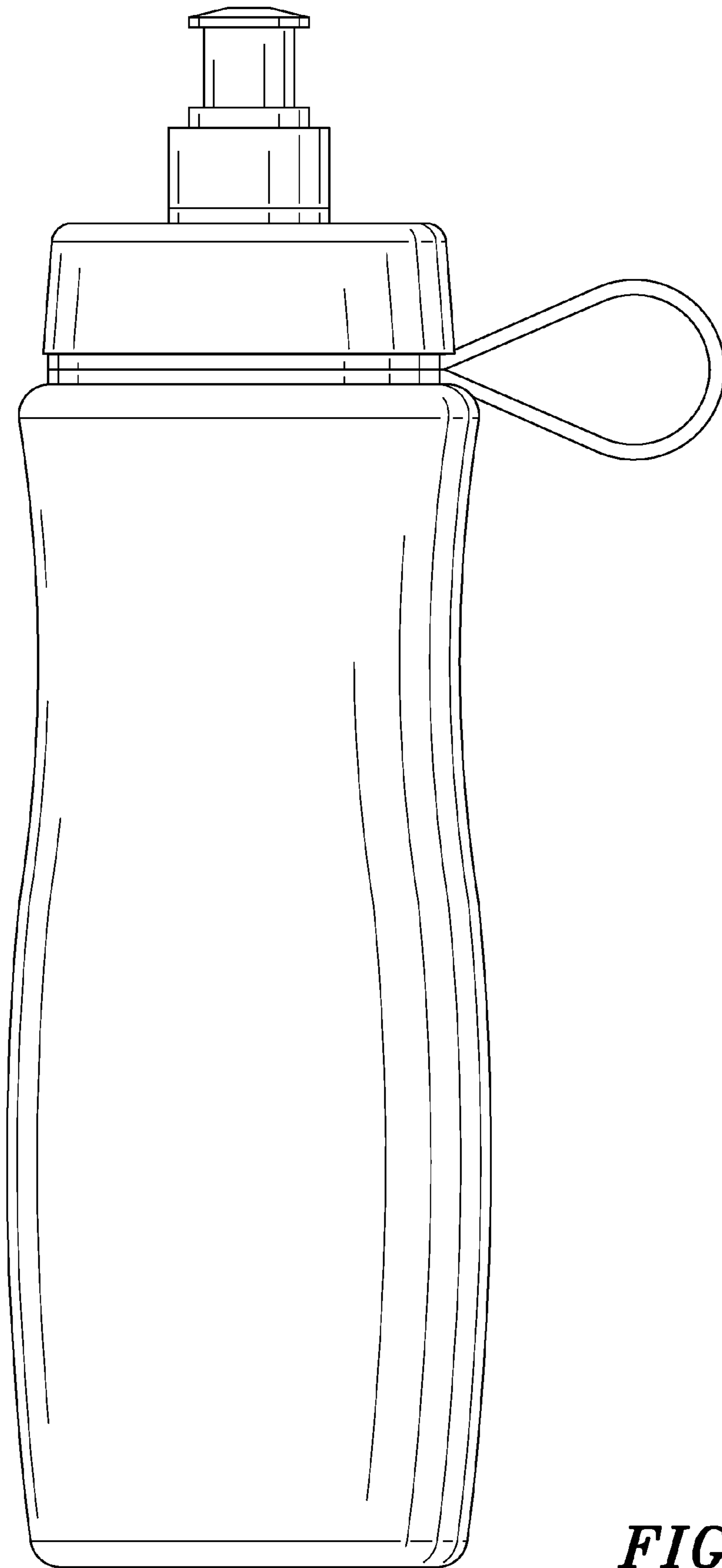

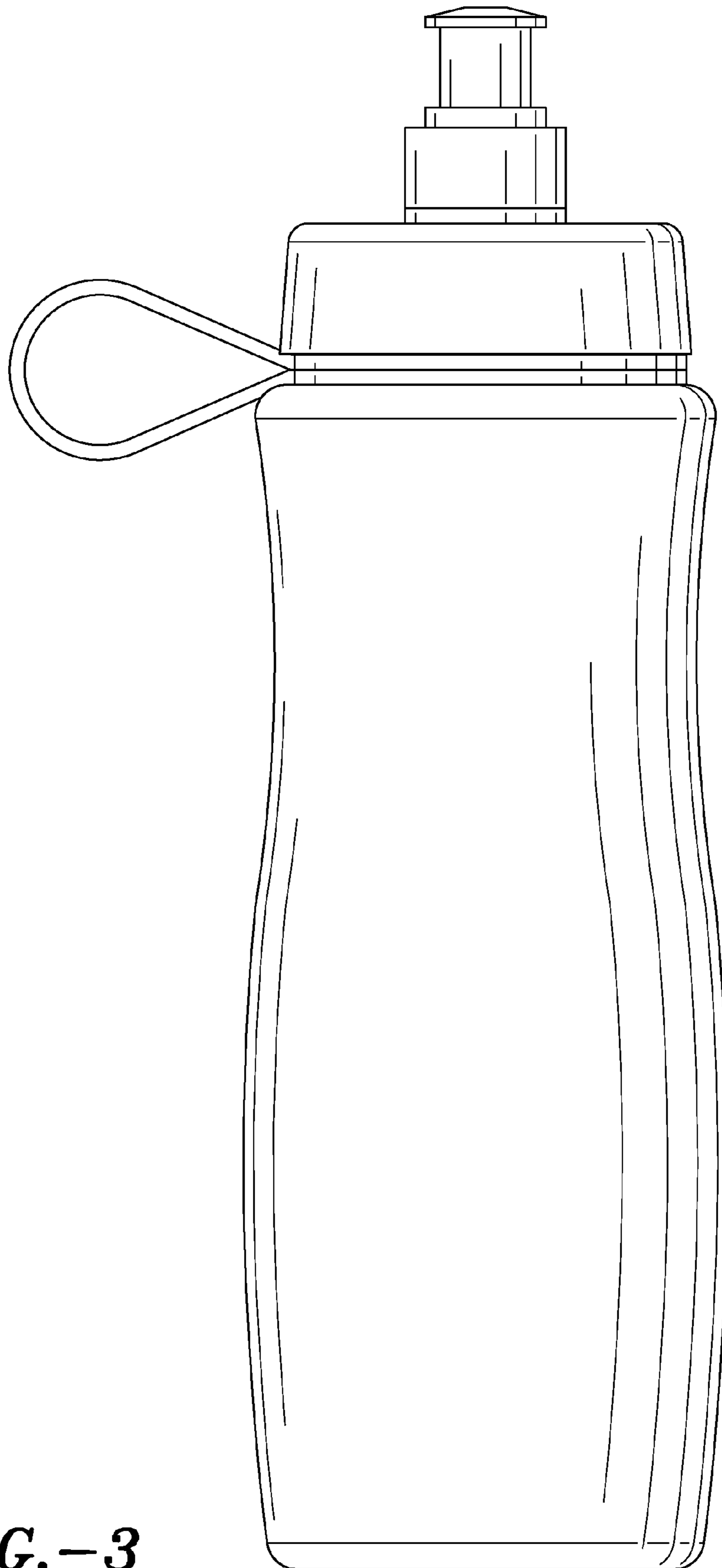




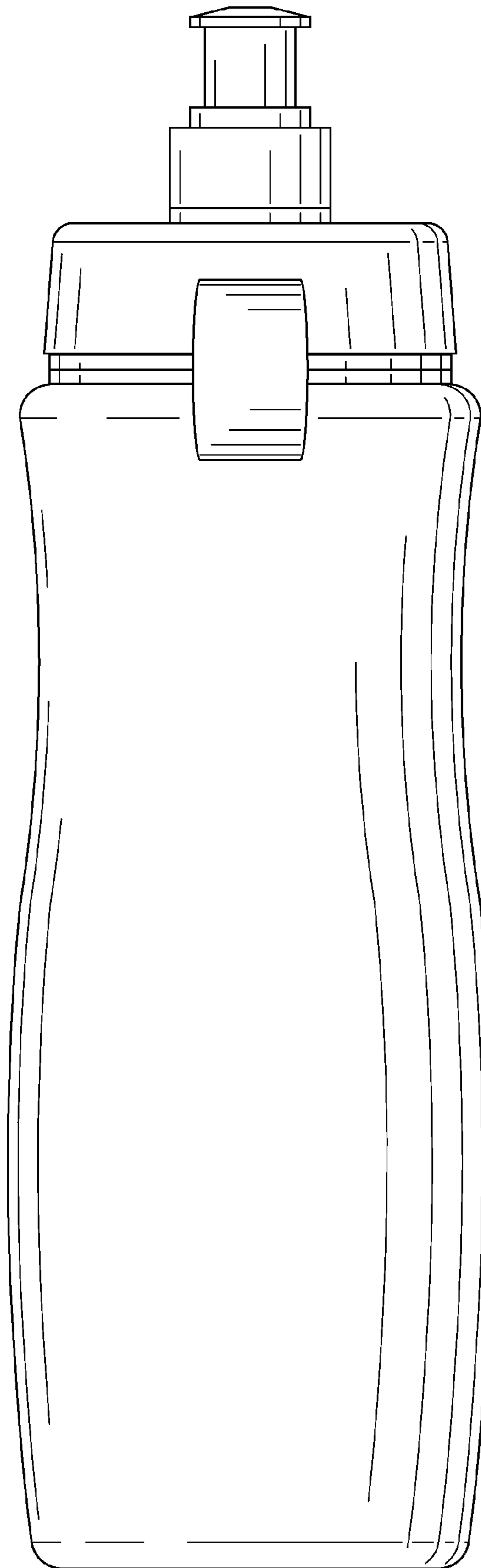

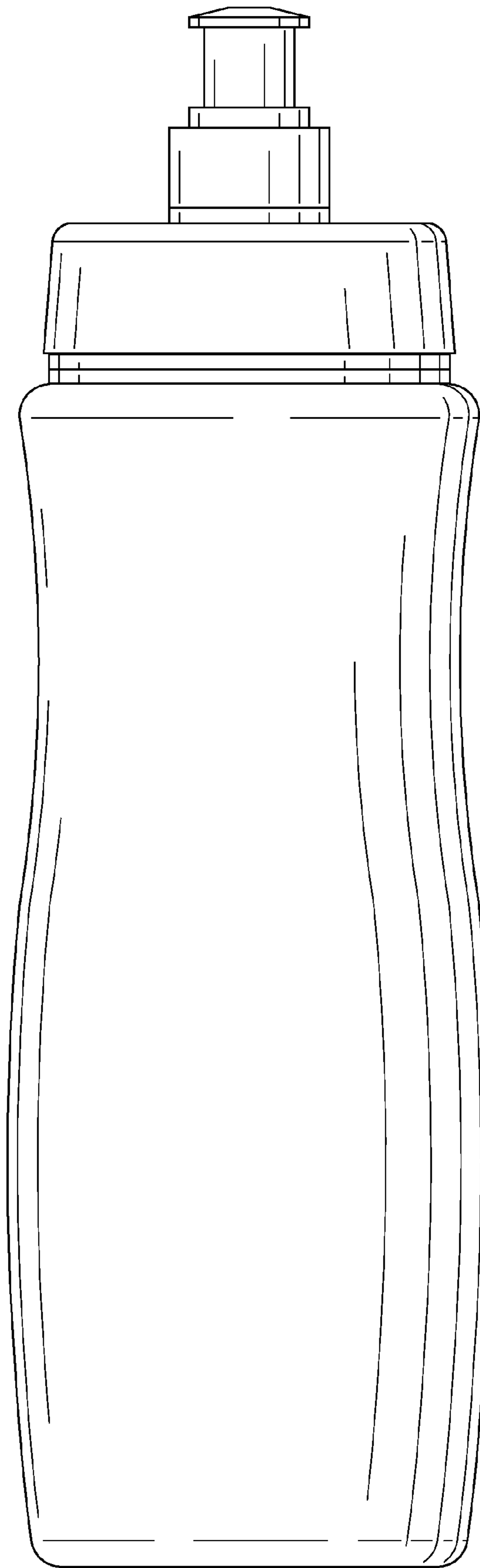

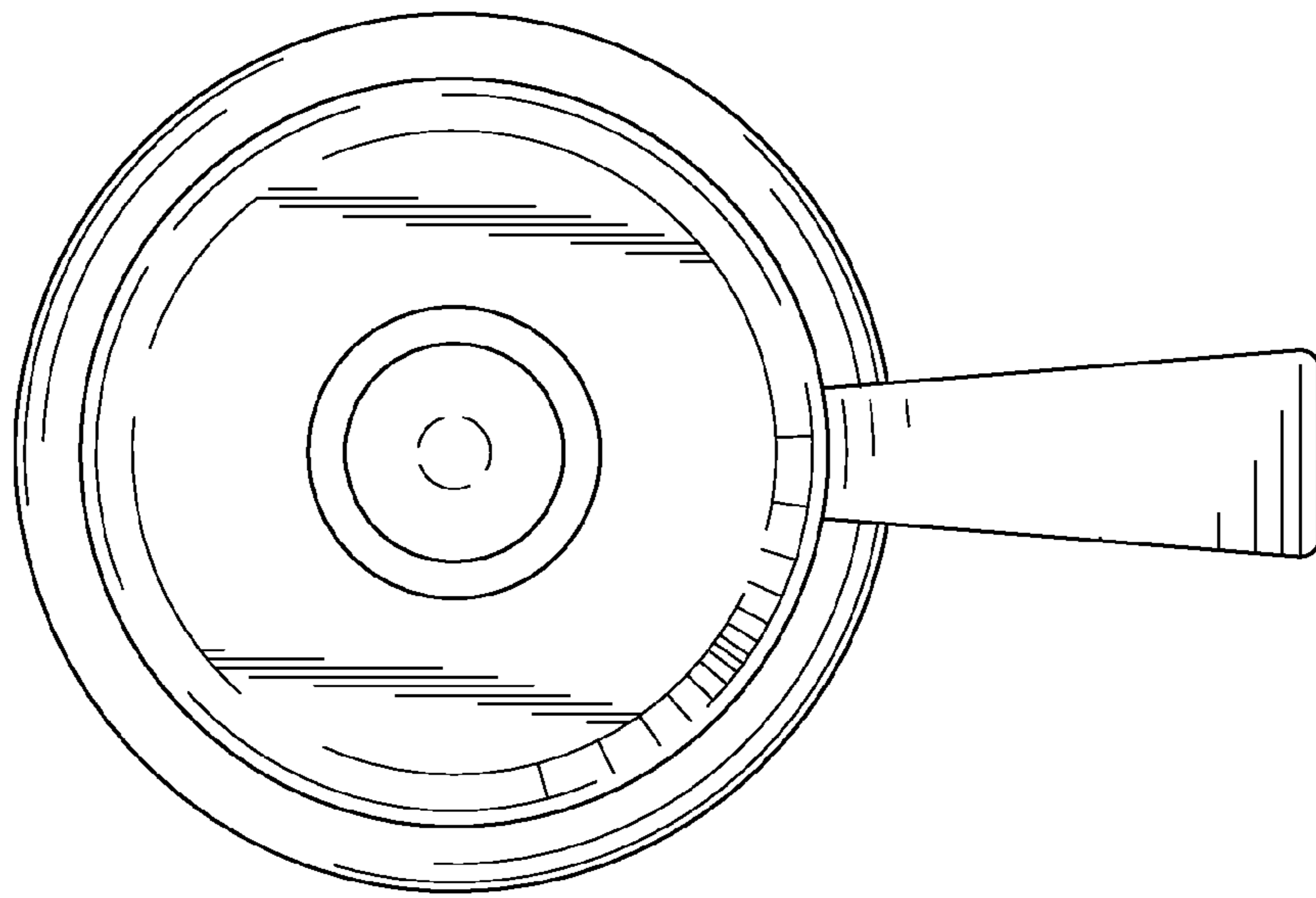

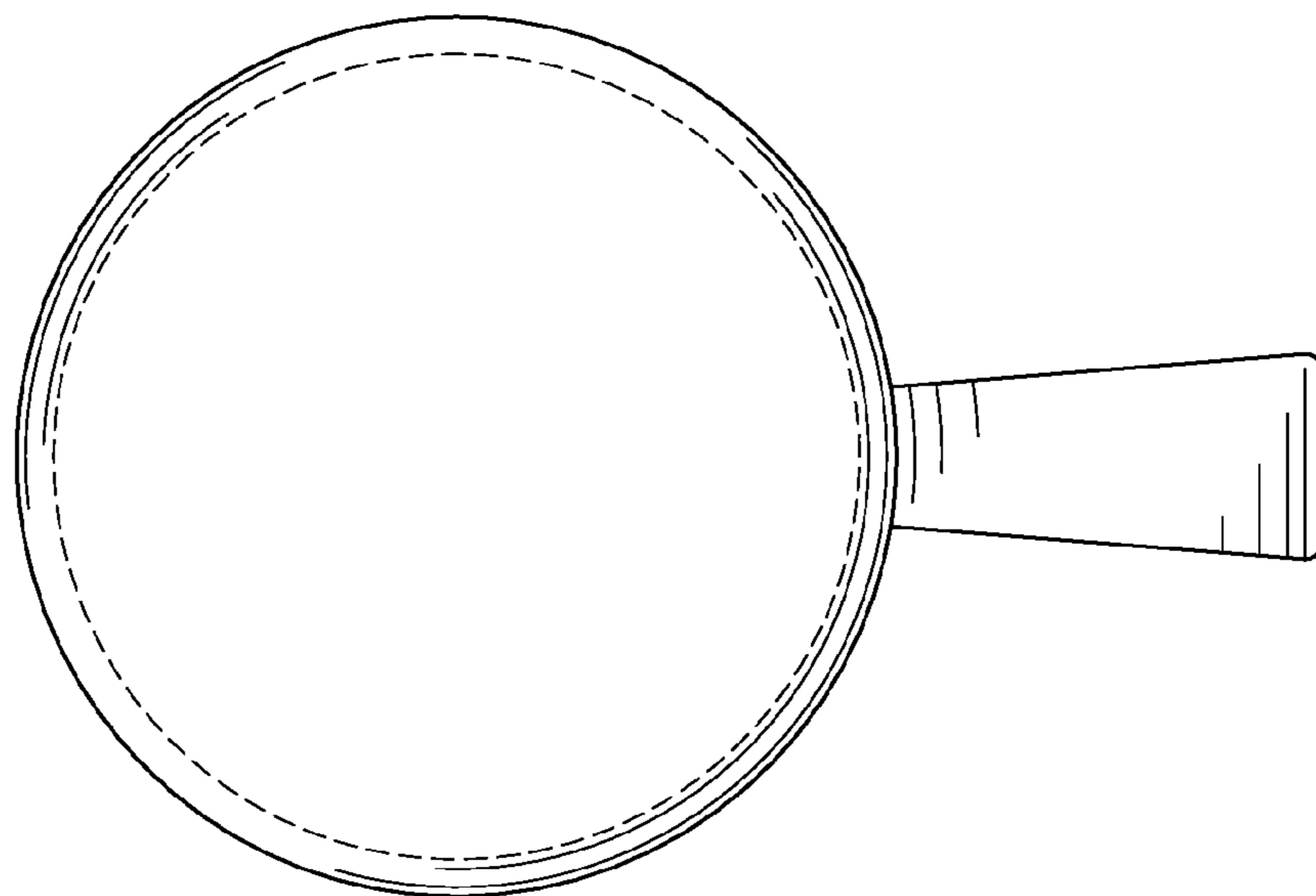
