**DESCRIPTION**

FIG. 2 is a front elevational view thereof;

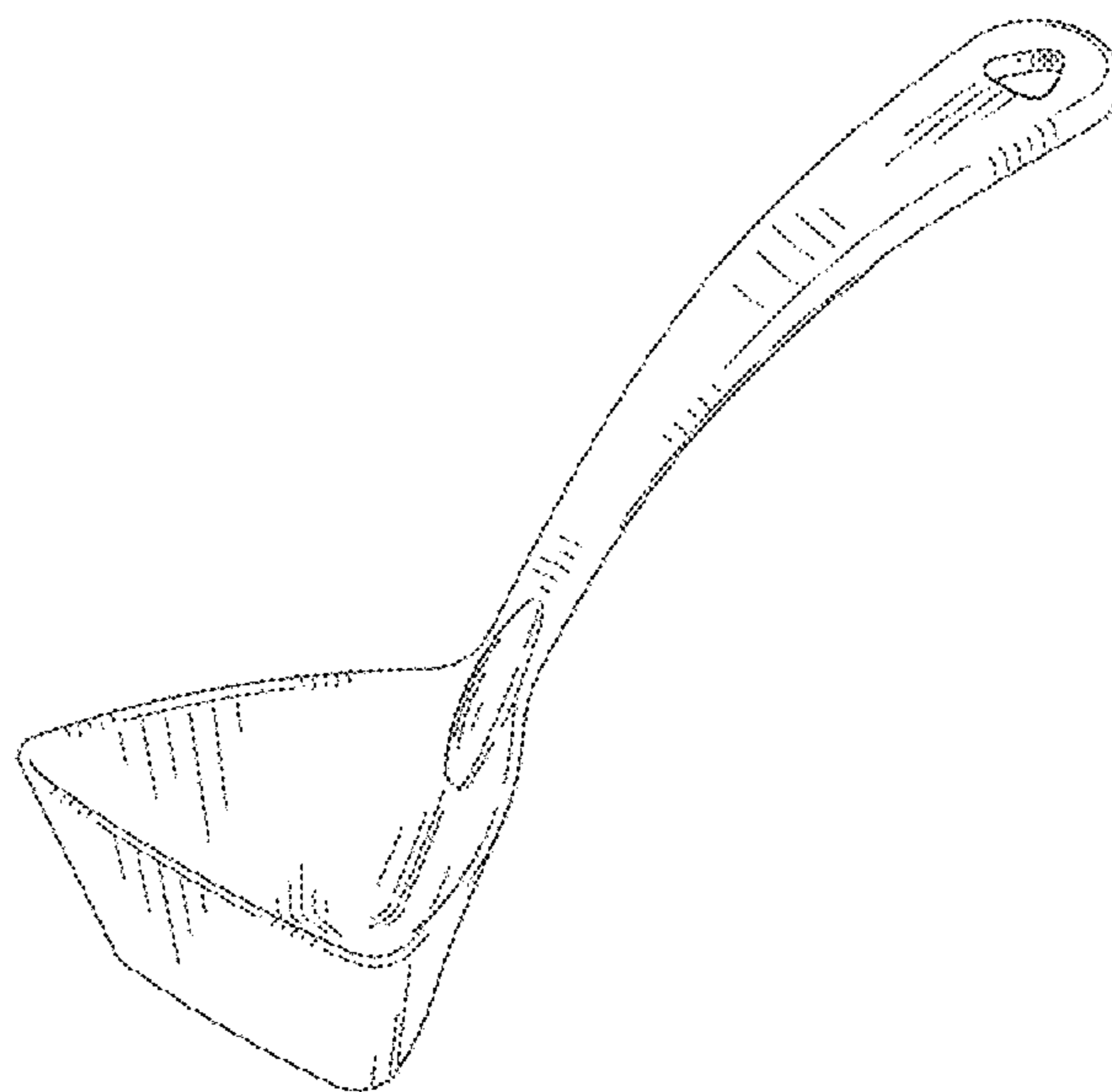
FIG. 3 is a side elevational view thereof; the opposite-side elevational view is a mirror image of the side shown;

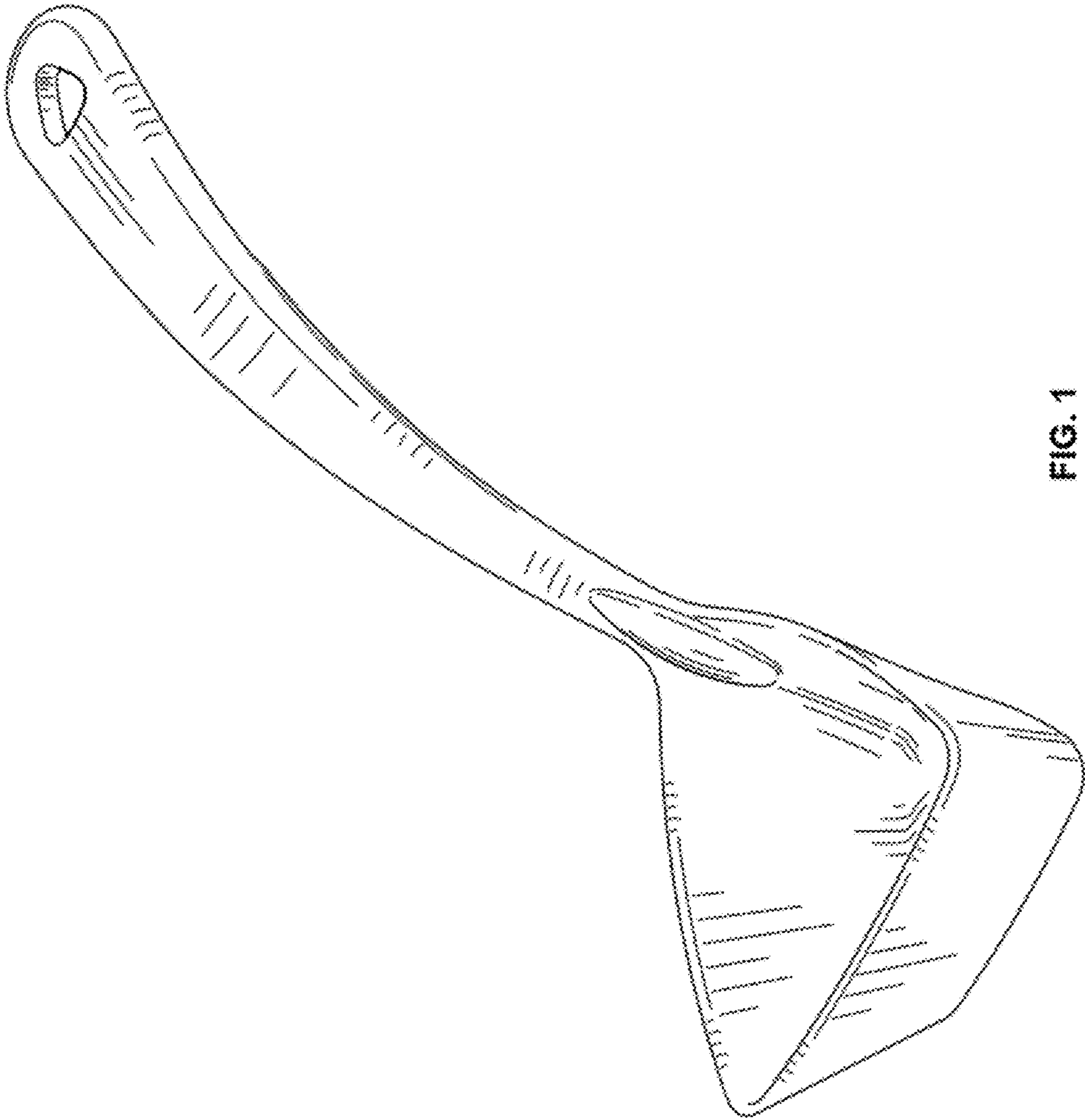

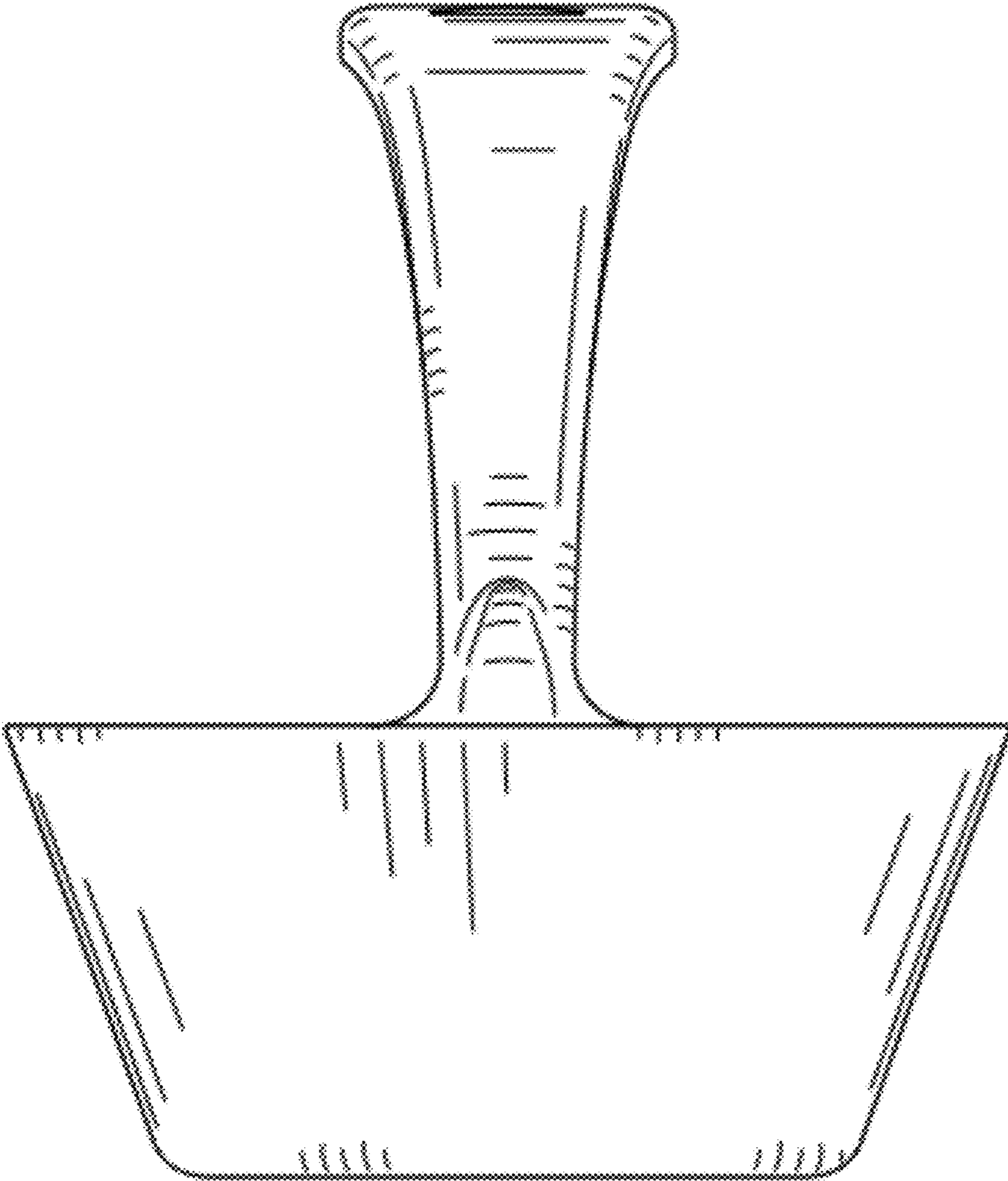

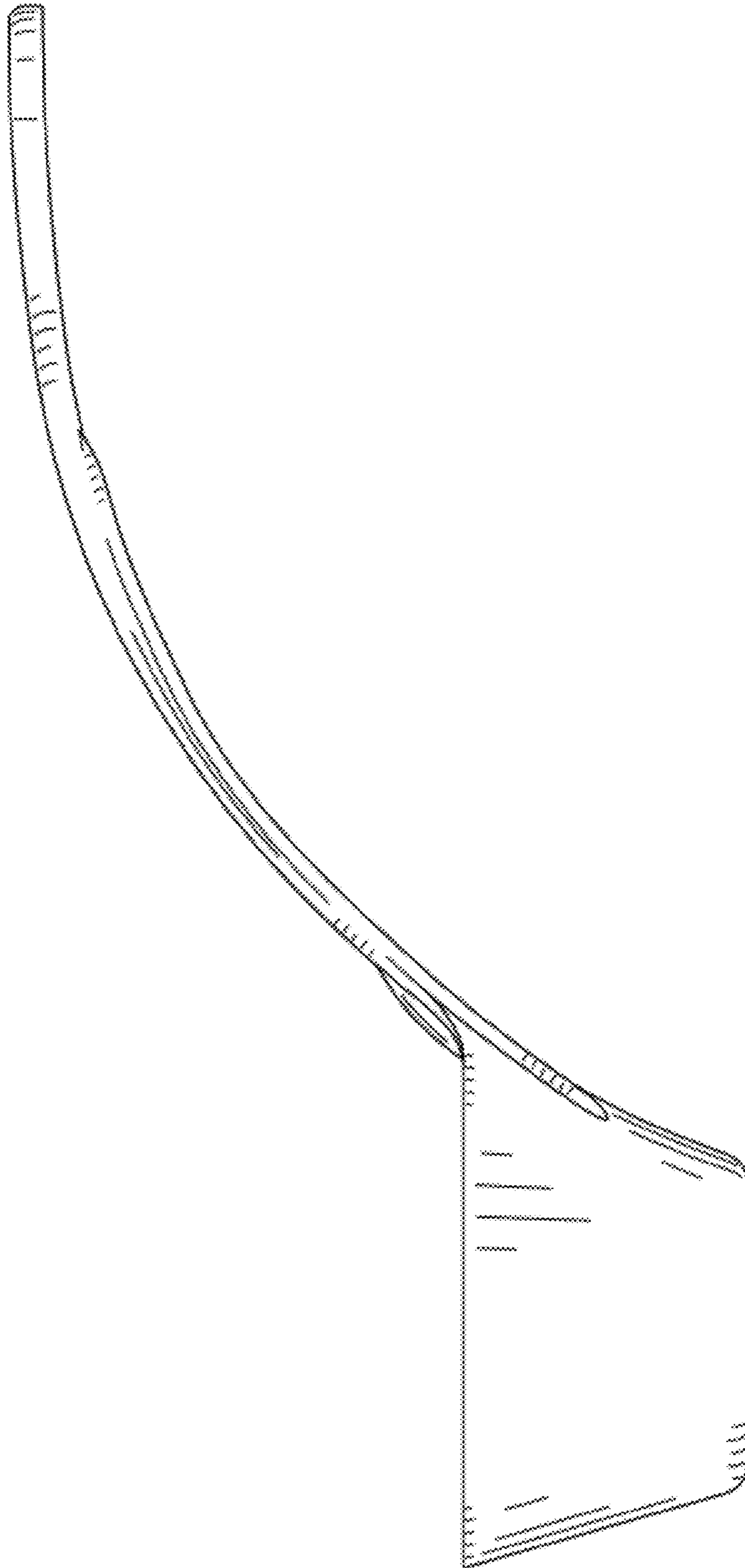

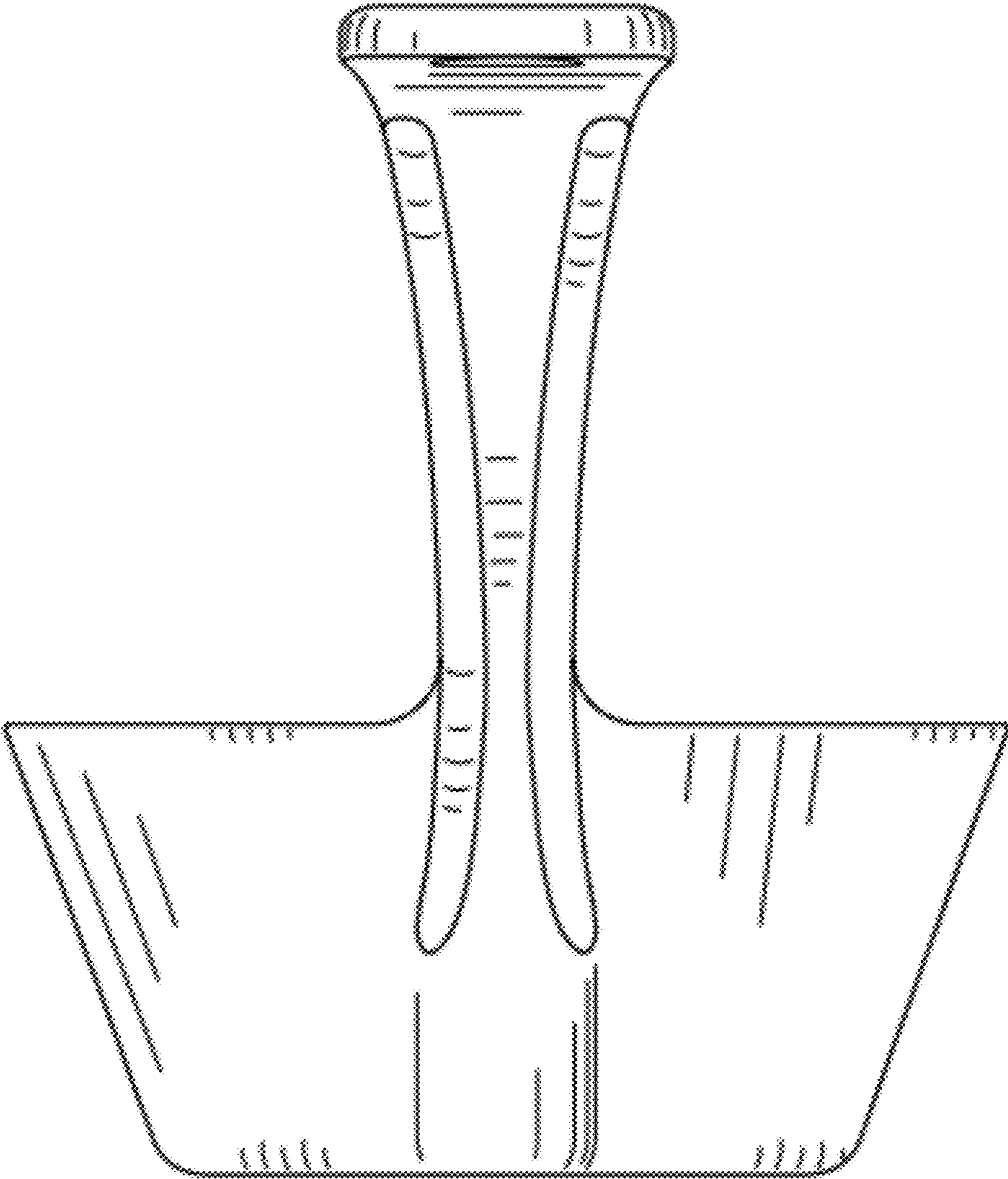

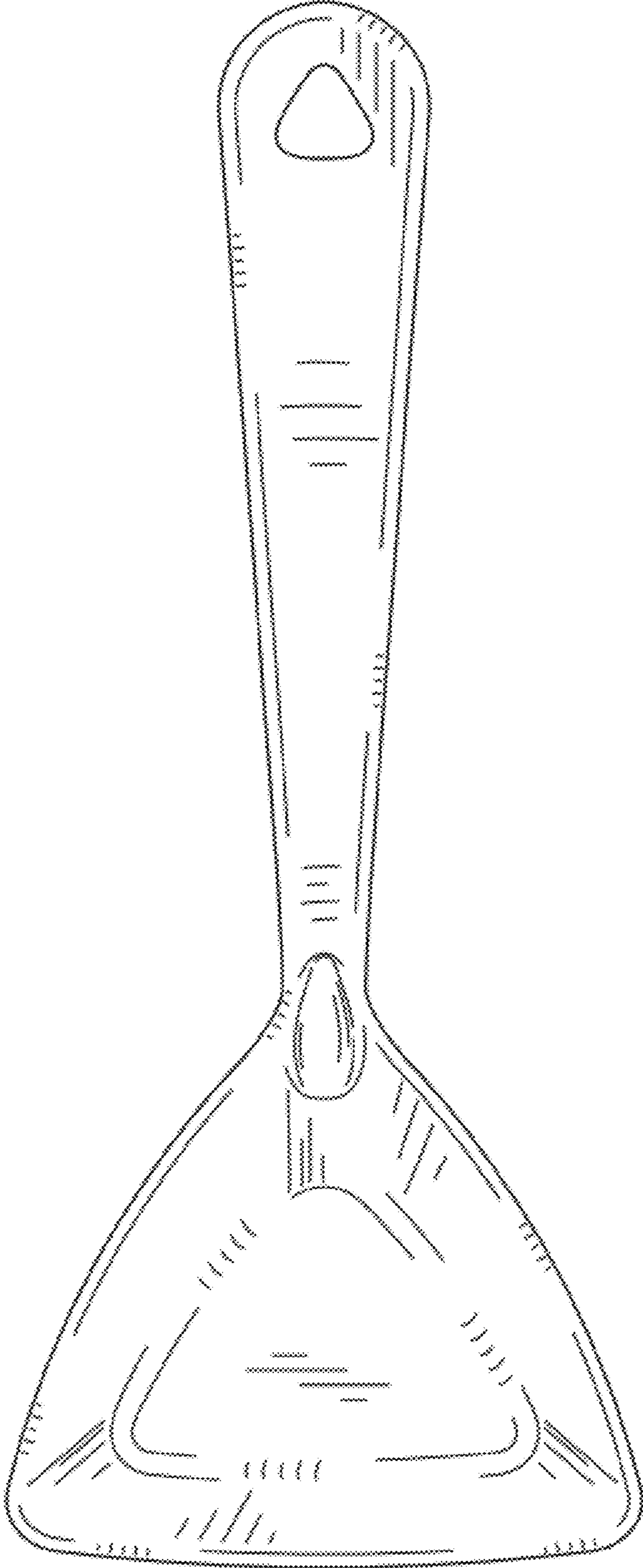

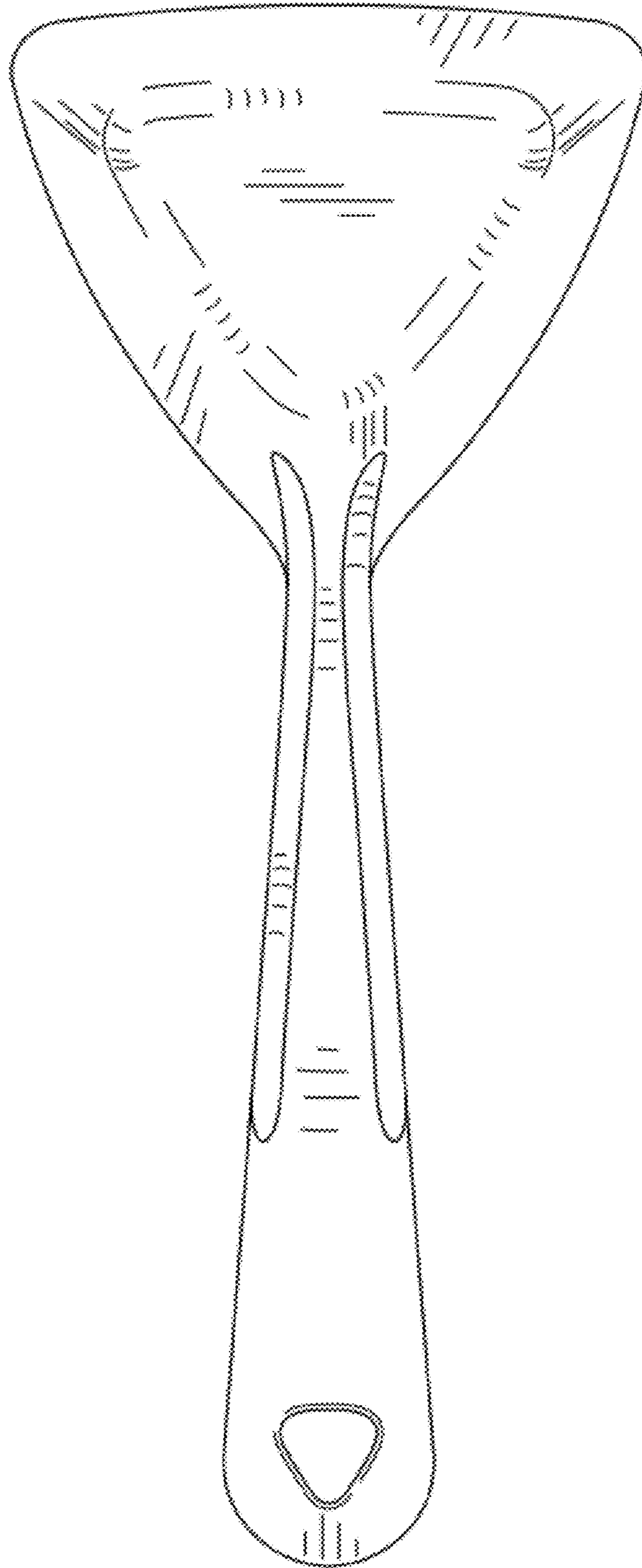
