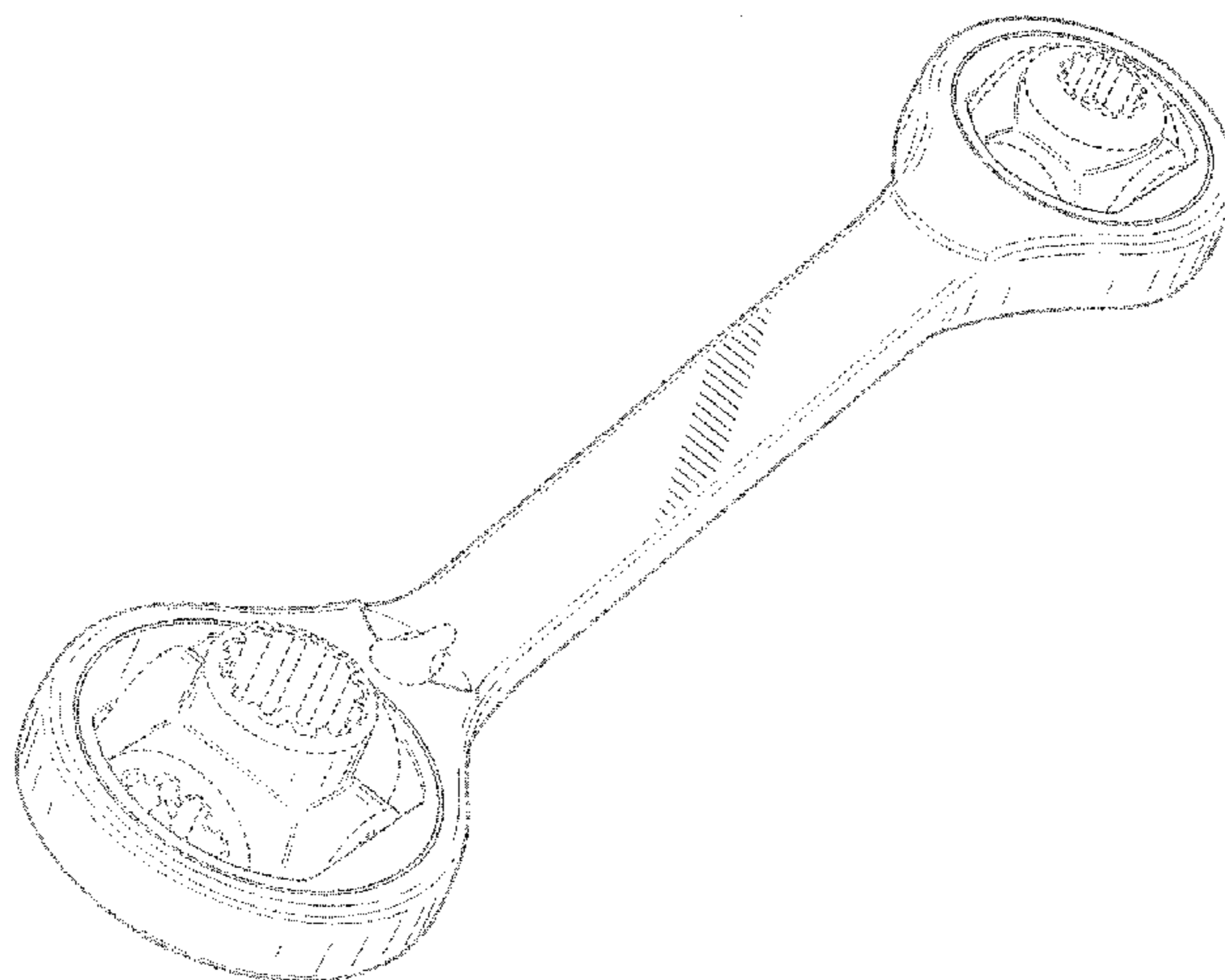
CLAIM

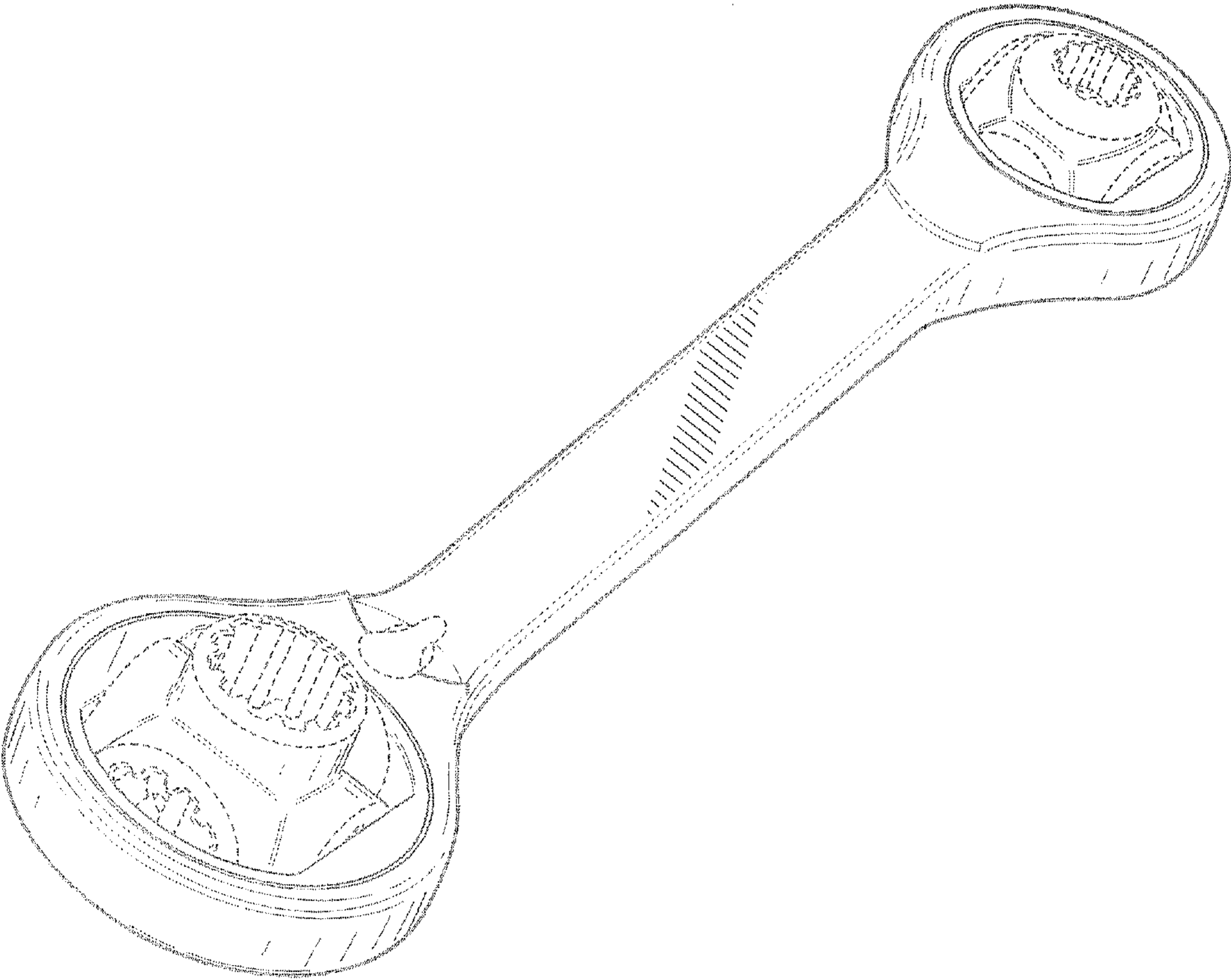
