(57) **CLAIM**

We claim the ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the container showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view, the left side elevational view being substantially a mirror image thereof;

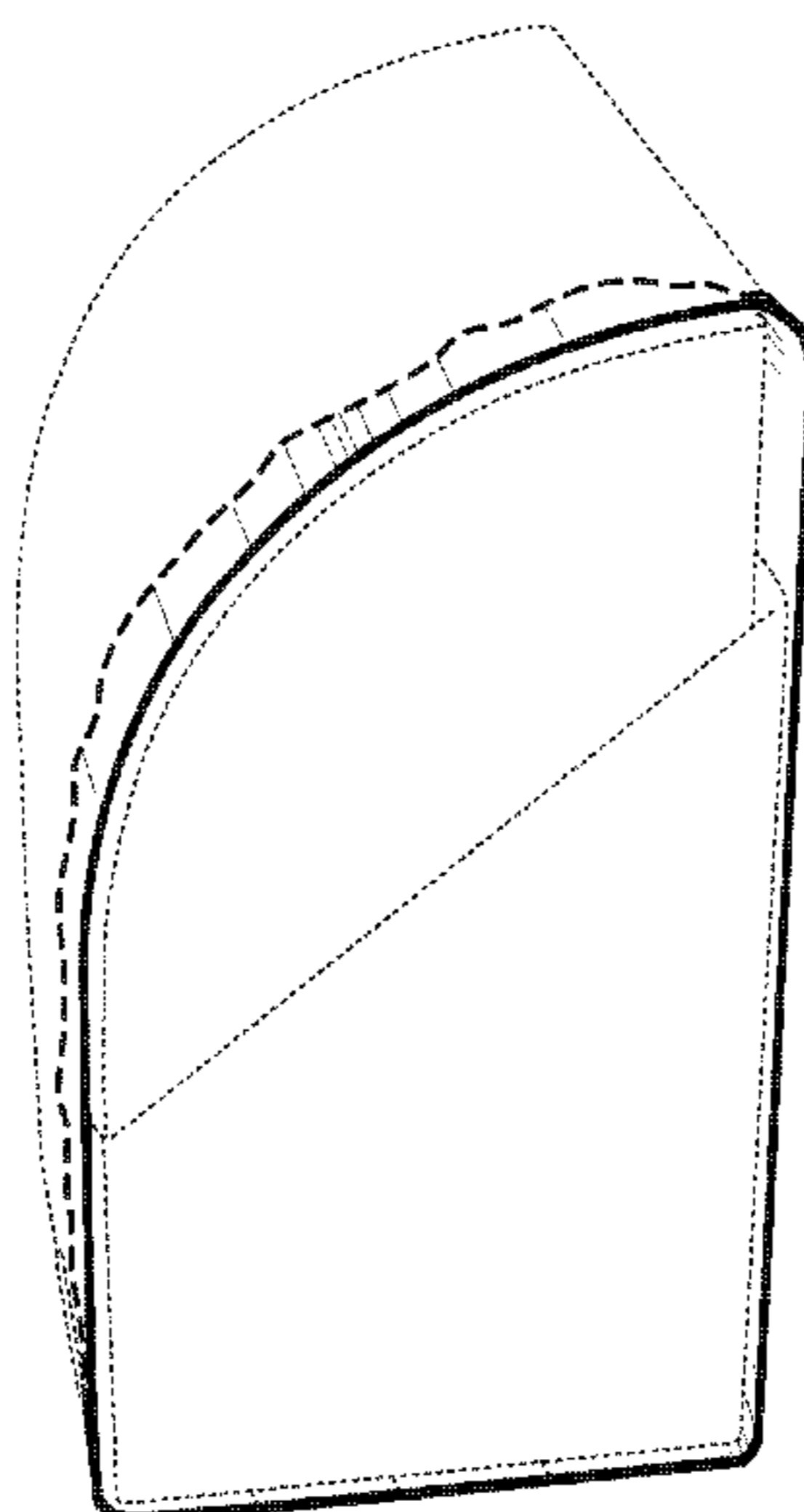
FIG. 4 is a back elevational view thereof;

FIG. 5 is a bottom view thereof; and,

FIG. 6 is a top view thereof.

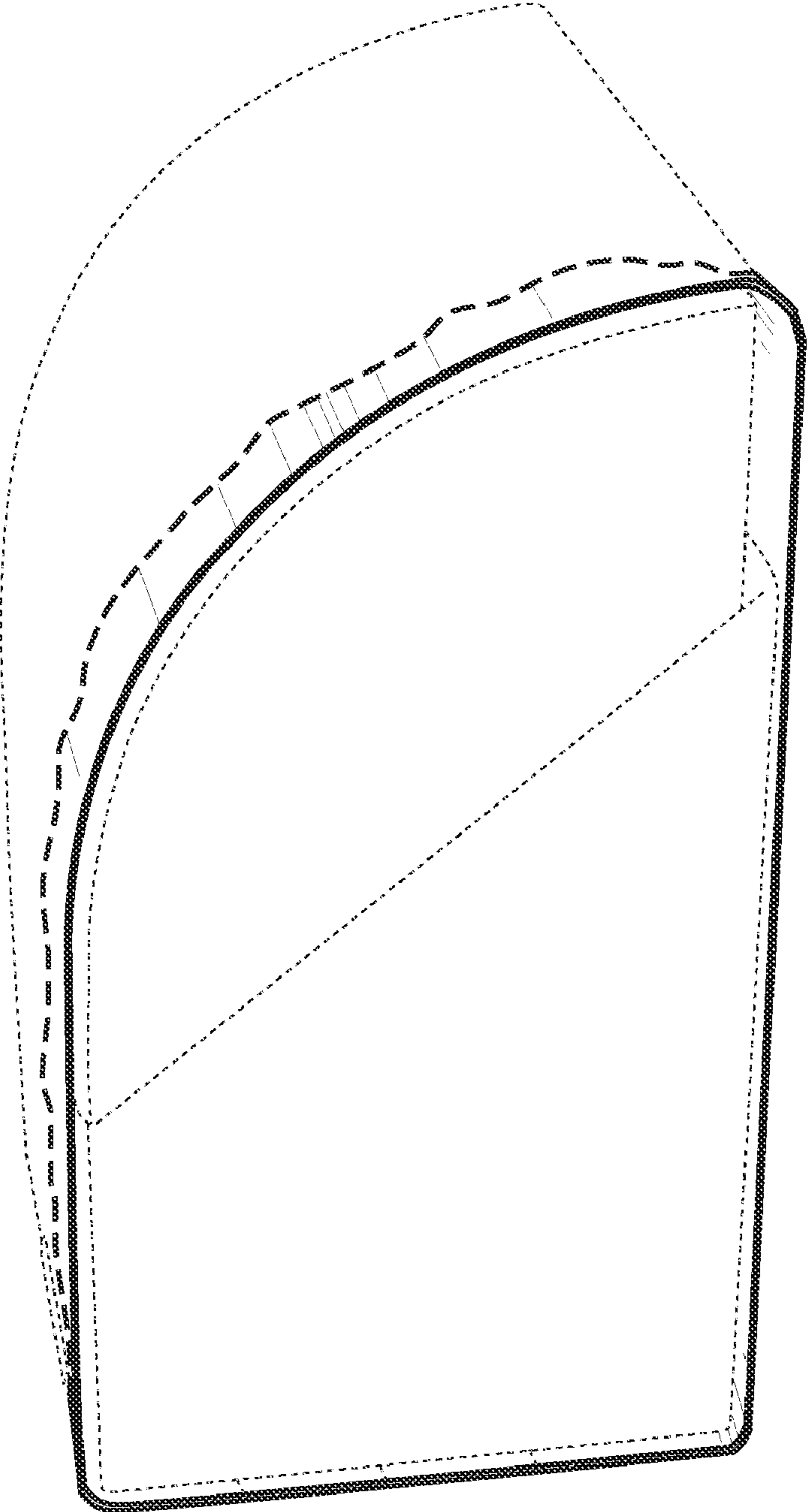

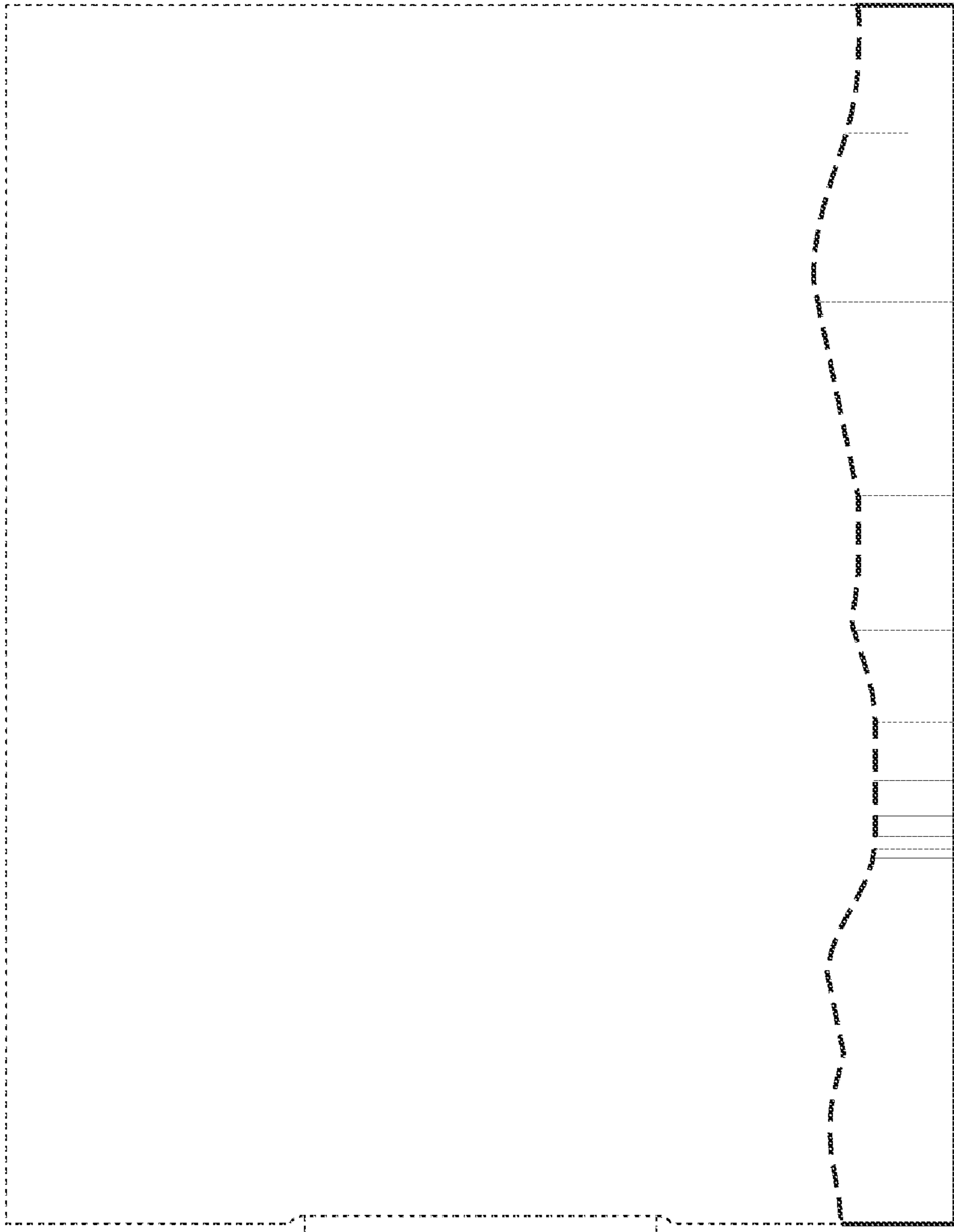

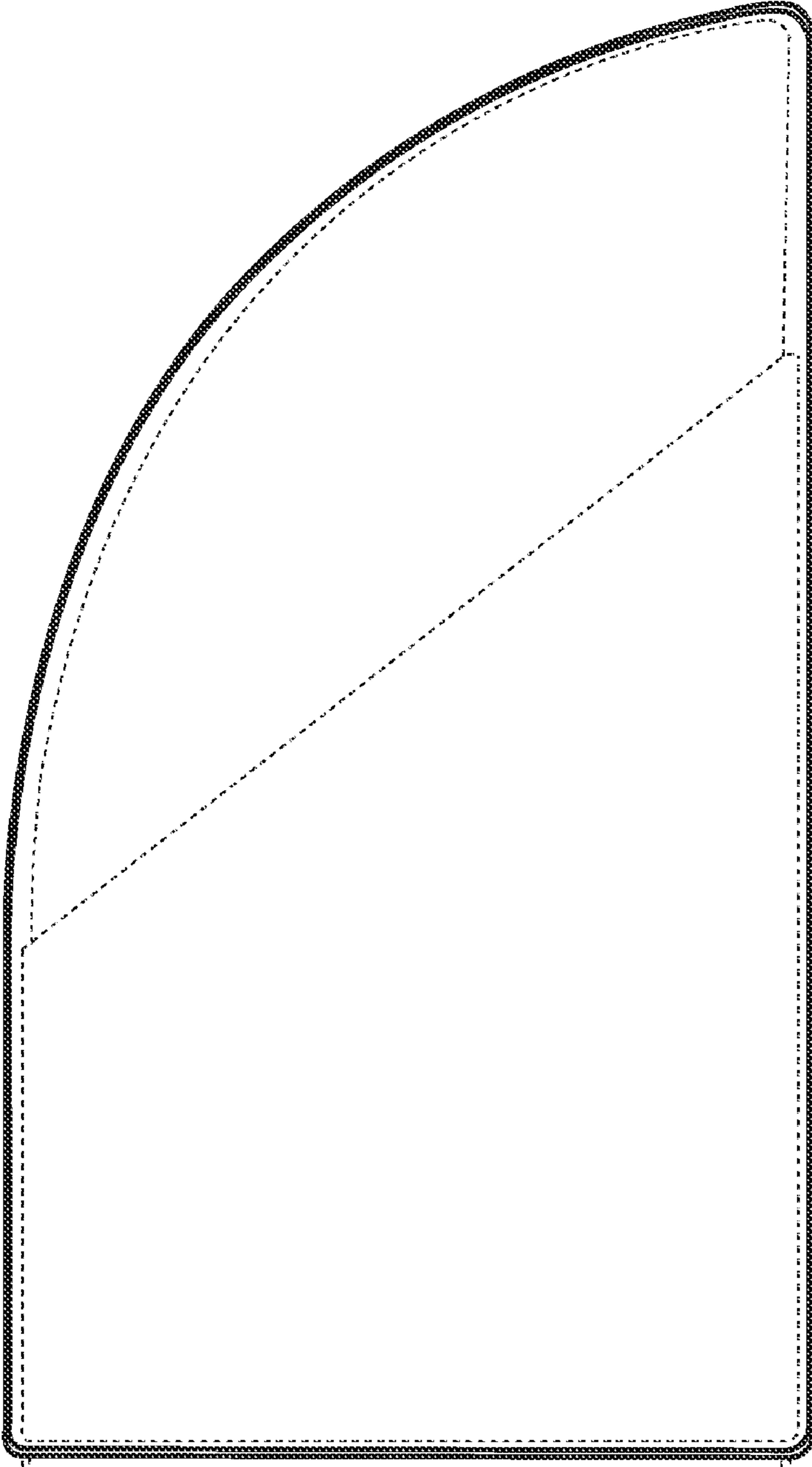

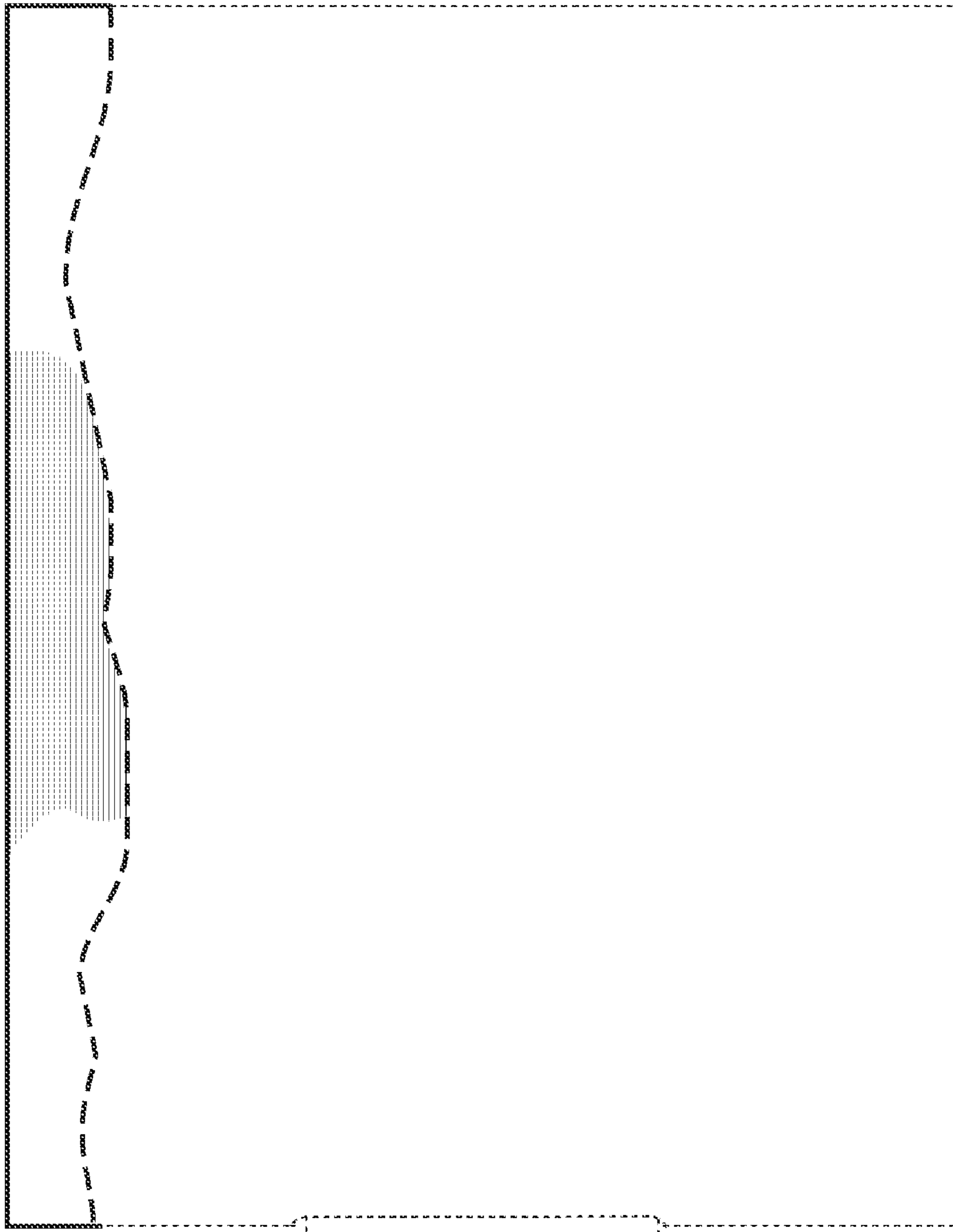

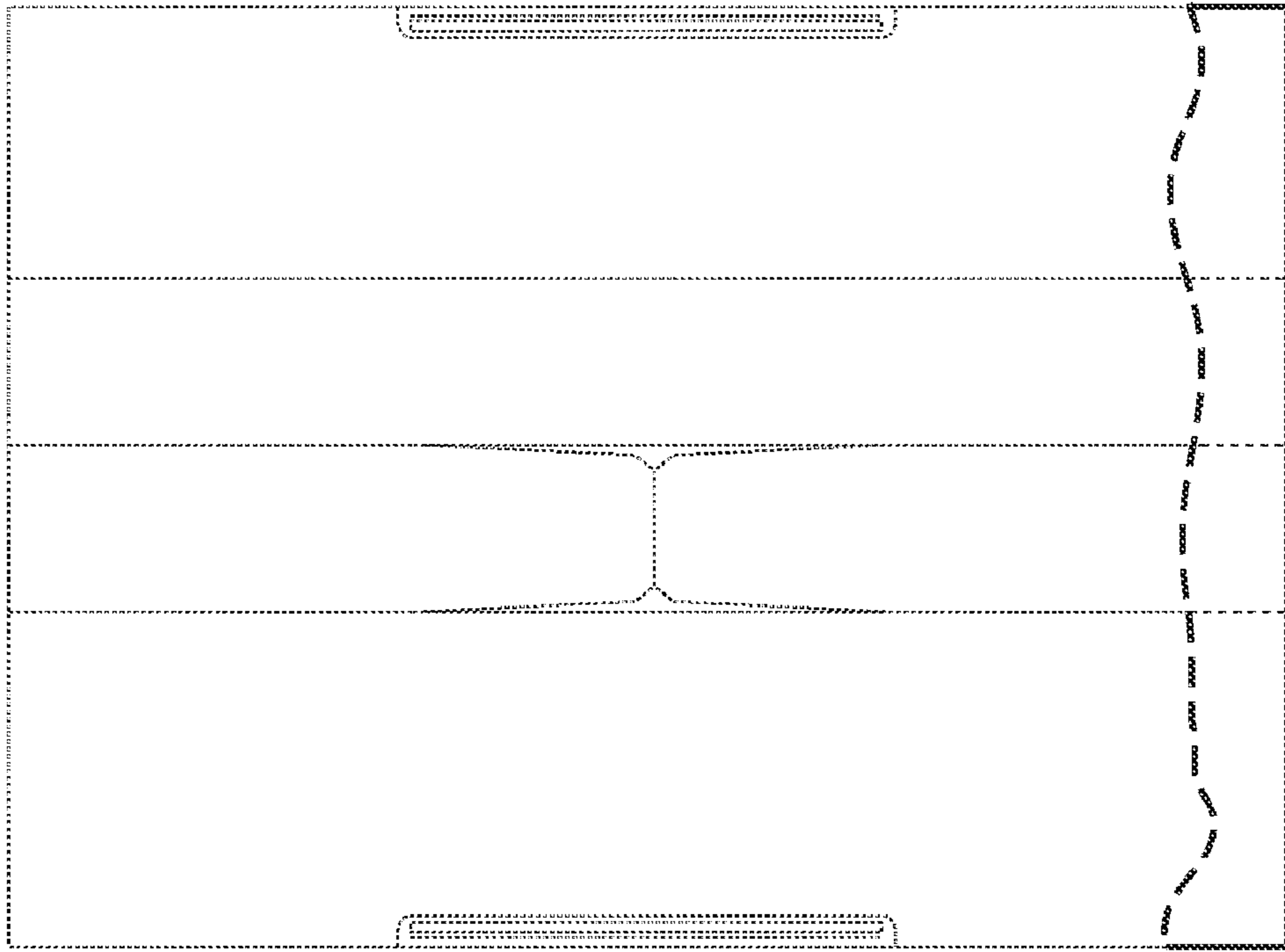
