(57) **CLAIM**

The ornamental design for a template for making tablet protectors, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a template for making tablet protectors according to a first embodiment of my new design; FIG. 2 is a front view of the template; FIG. 3 is a rear view of the template; FIG. 4 is a left side view of the template; FIG. 5 is a right side view of the template; FIG. 6 is a top plan view of the template; FIG. 7 is a bottom view of the template; FIG. 8 is a perspective view of a template for making tablet protectors according to a second embodiment of my new design; FIG. 9 is a front view of the second embodiment template; FIG. 10 is a rear view of the second embodiment template, the left side view, right side view, top plan view and bottom view of the second embodiment template being identical to those of the first embodiment template; FIG. 11 is a perspective view of a template for making tablet protectors according to a third embodiment of my new design; FIG. 12 is a front view of the third embodiment template; and, FIG. 13 is a rear view of the third embodiment template, the left side view, right side view, top plan view and bottom view of the third embodiment template being identical to those of the first embodiment template.

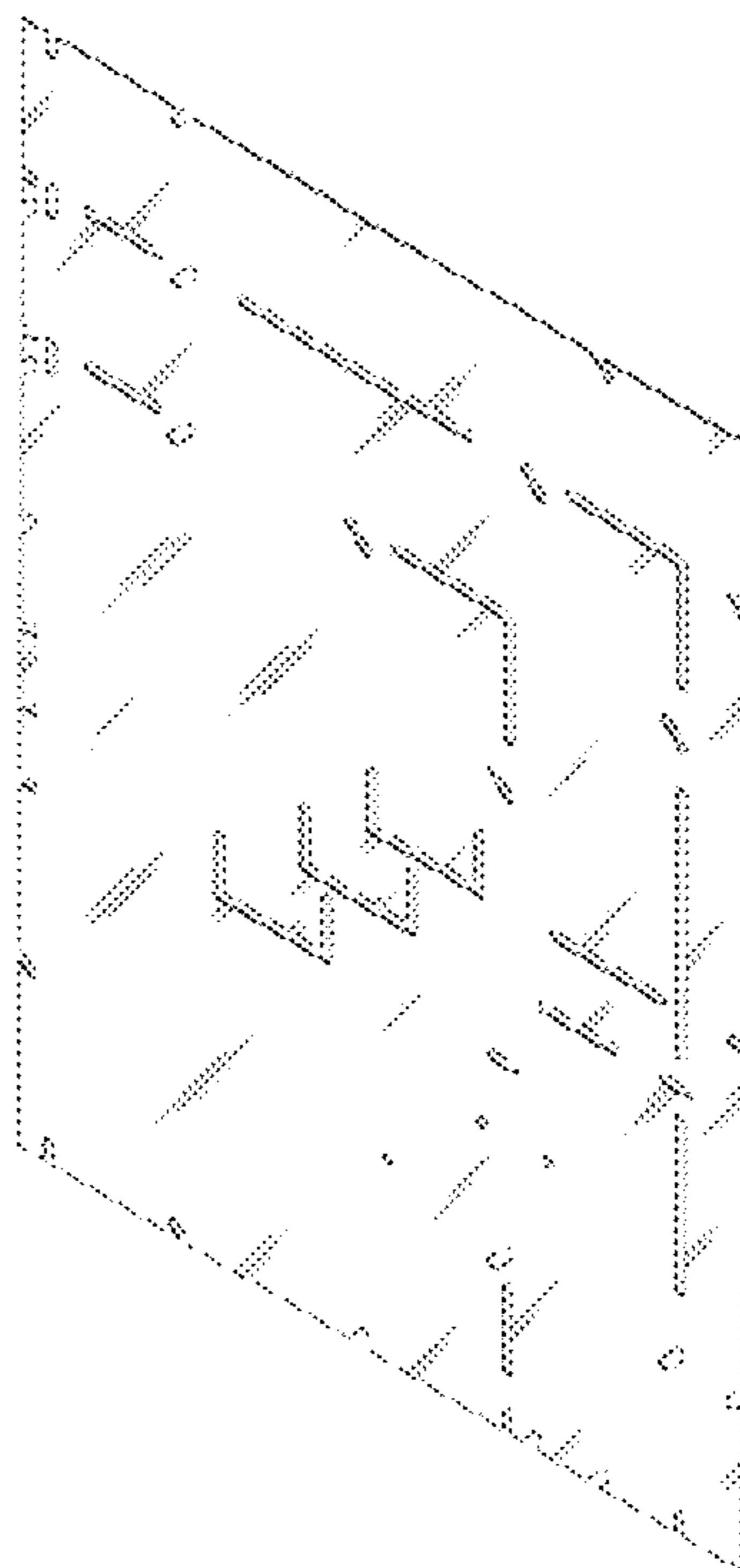

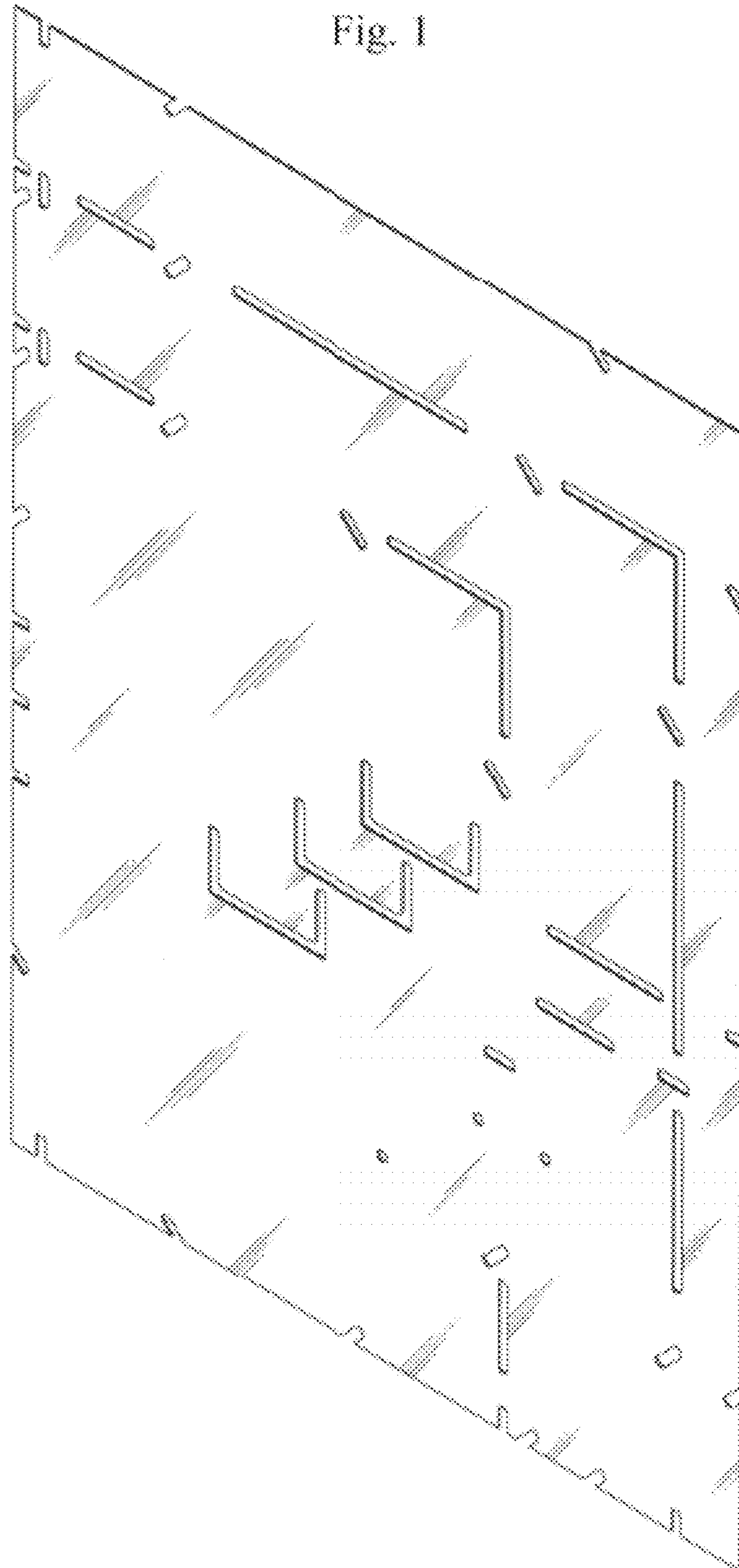

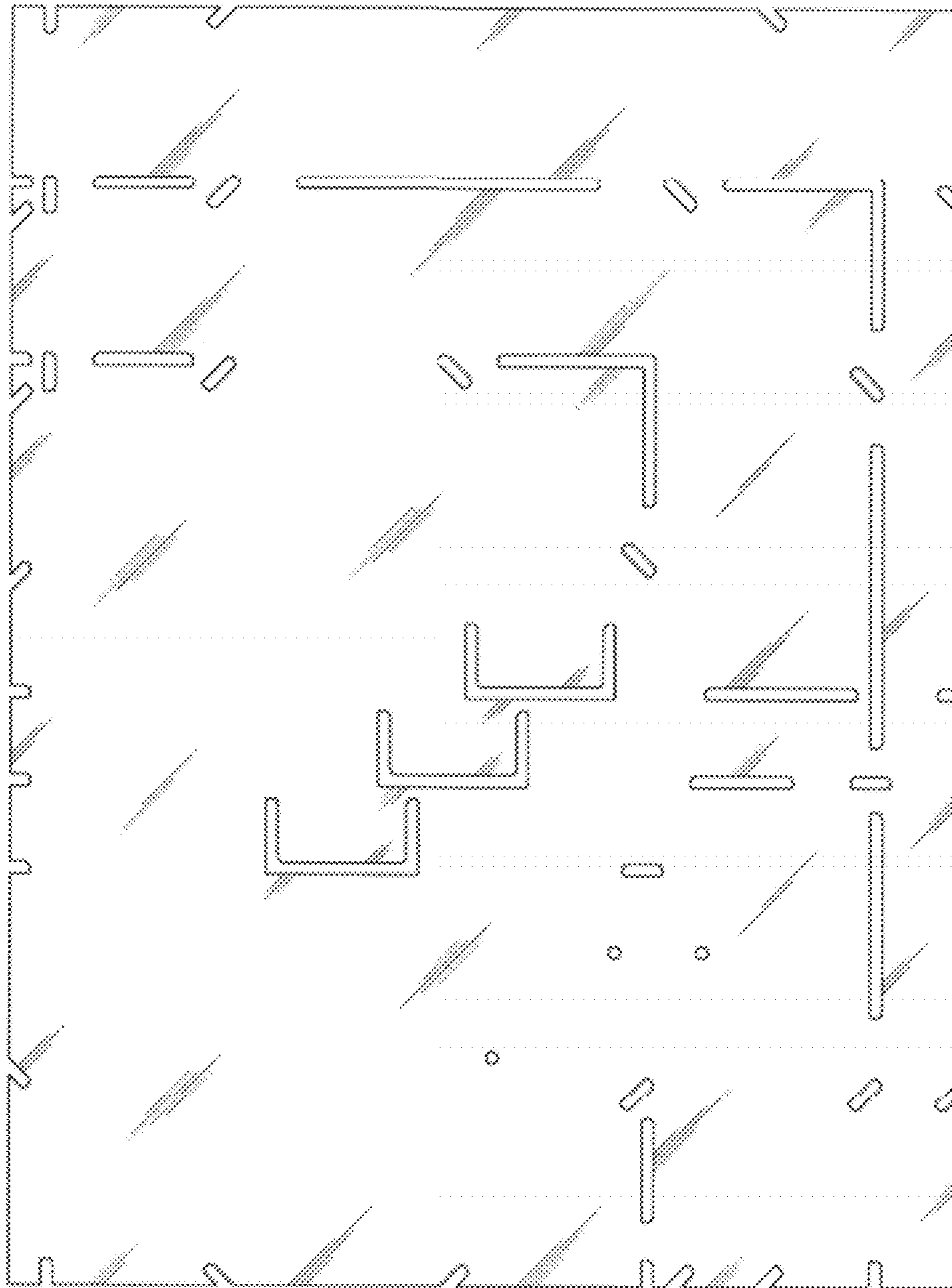

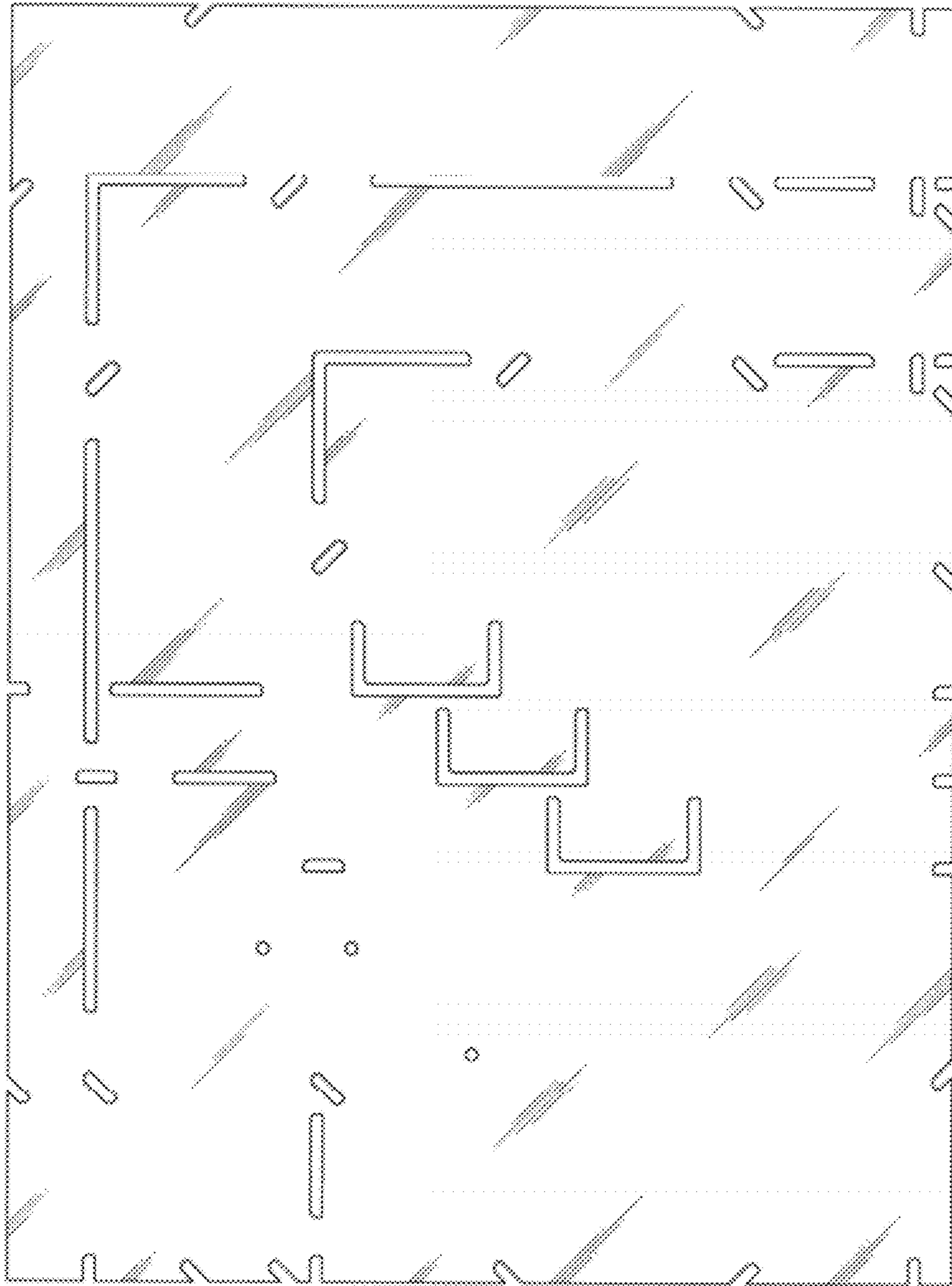

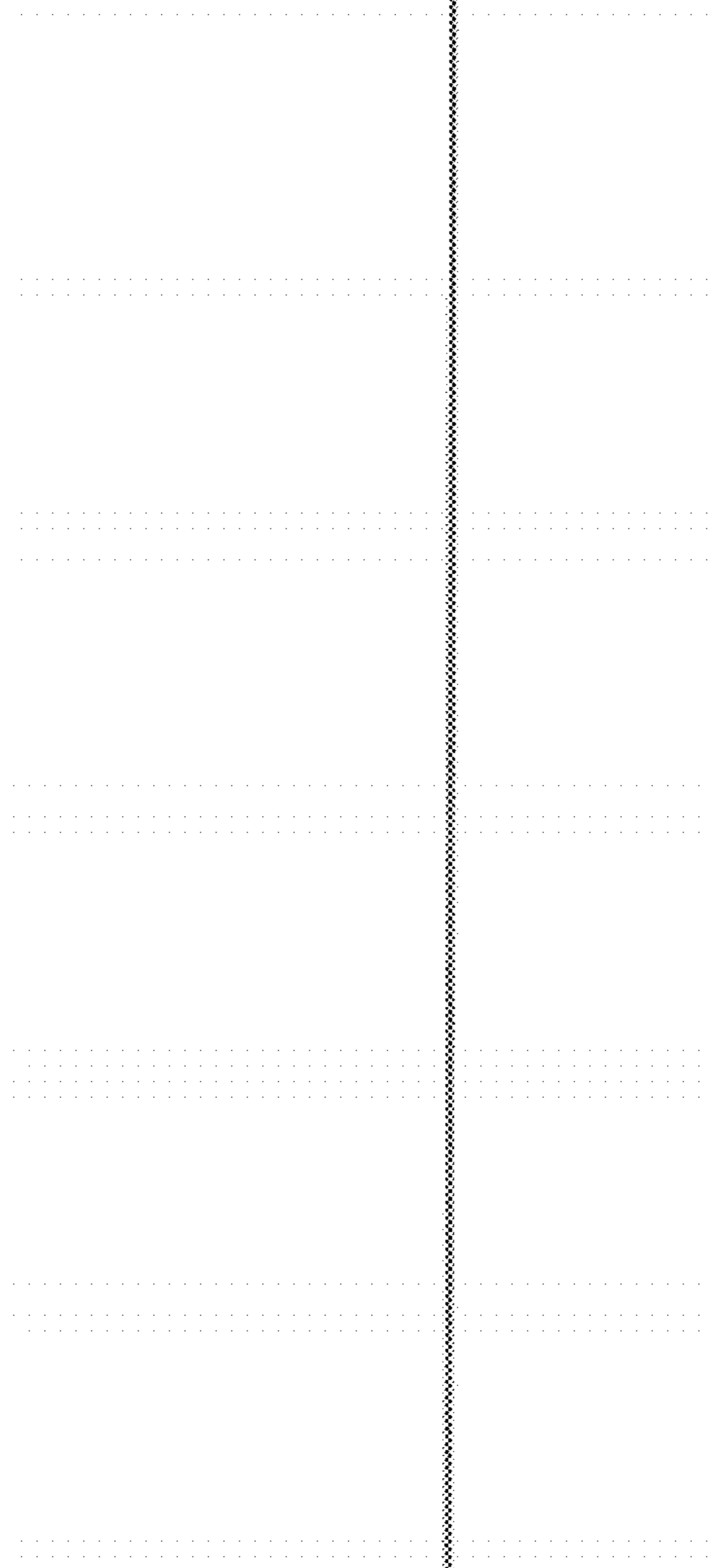

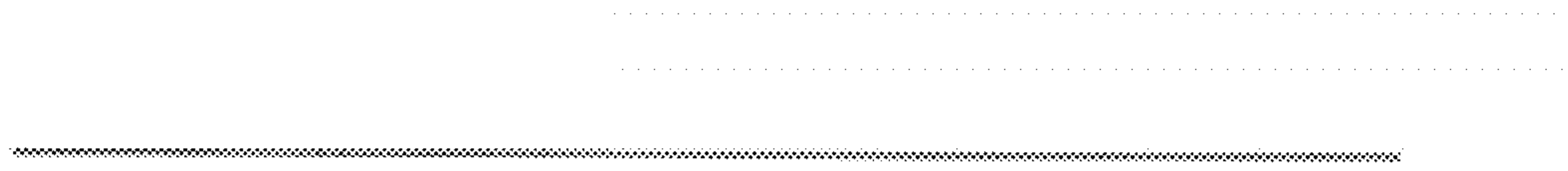

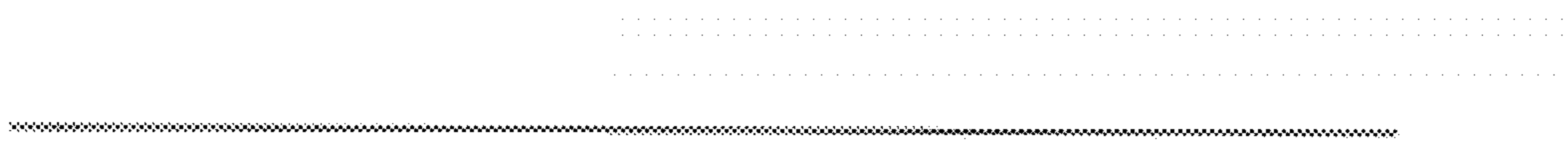

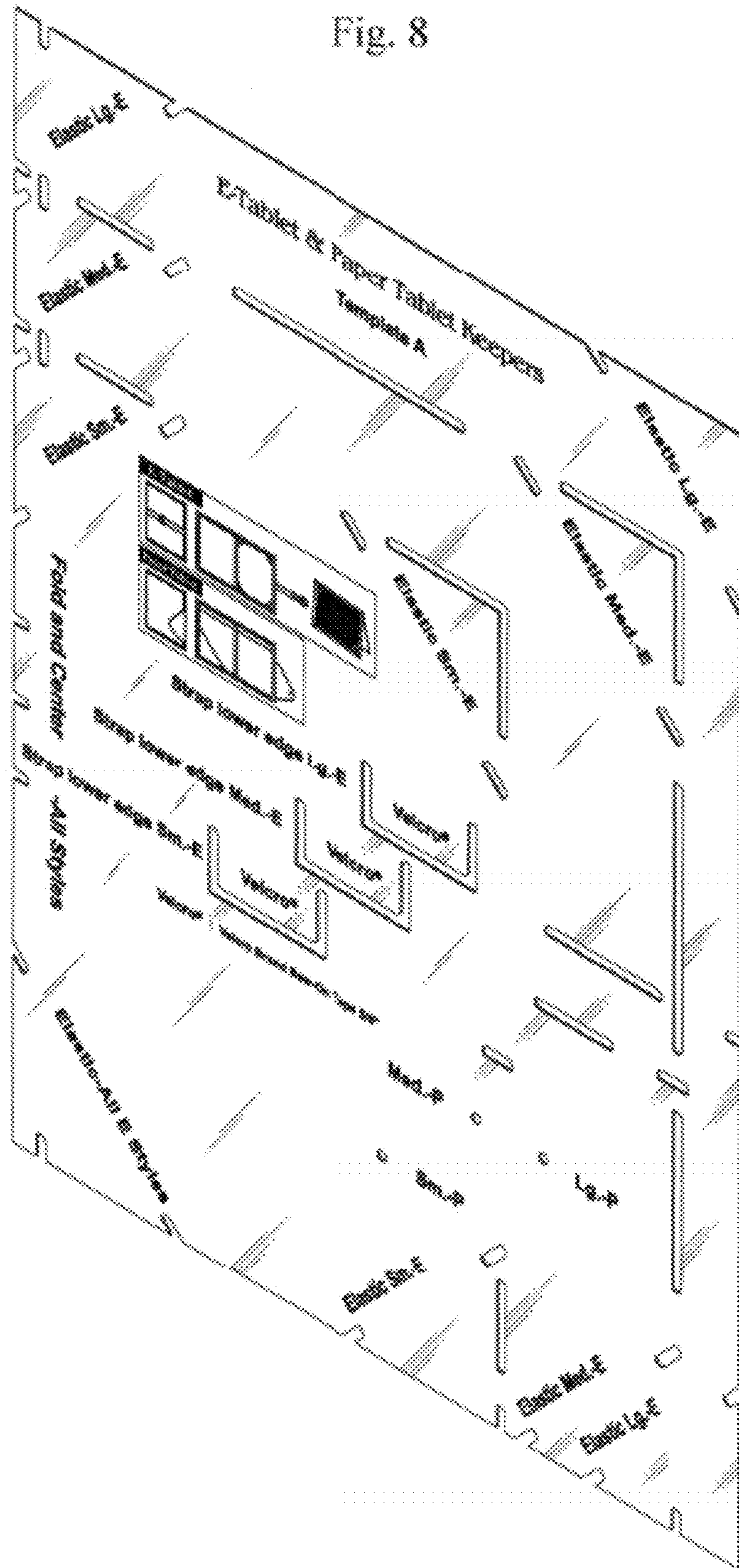

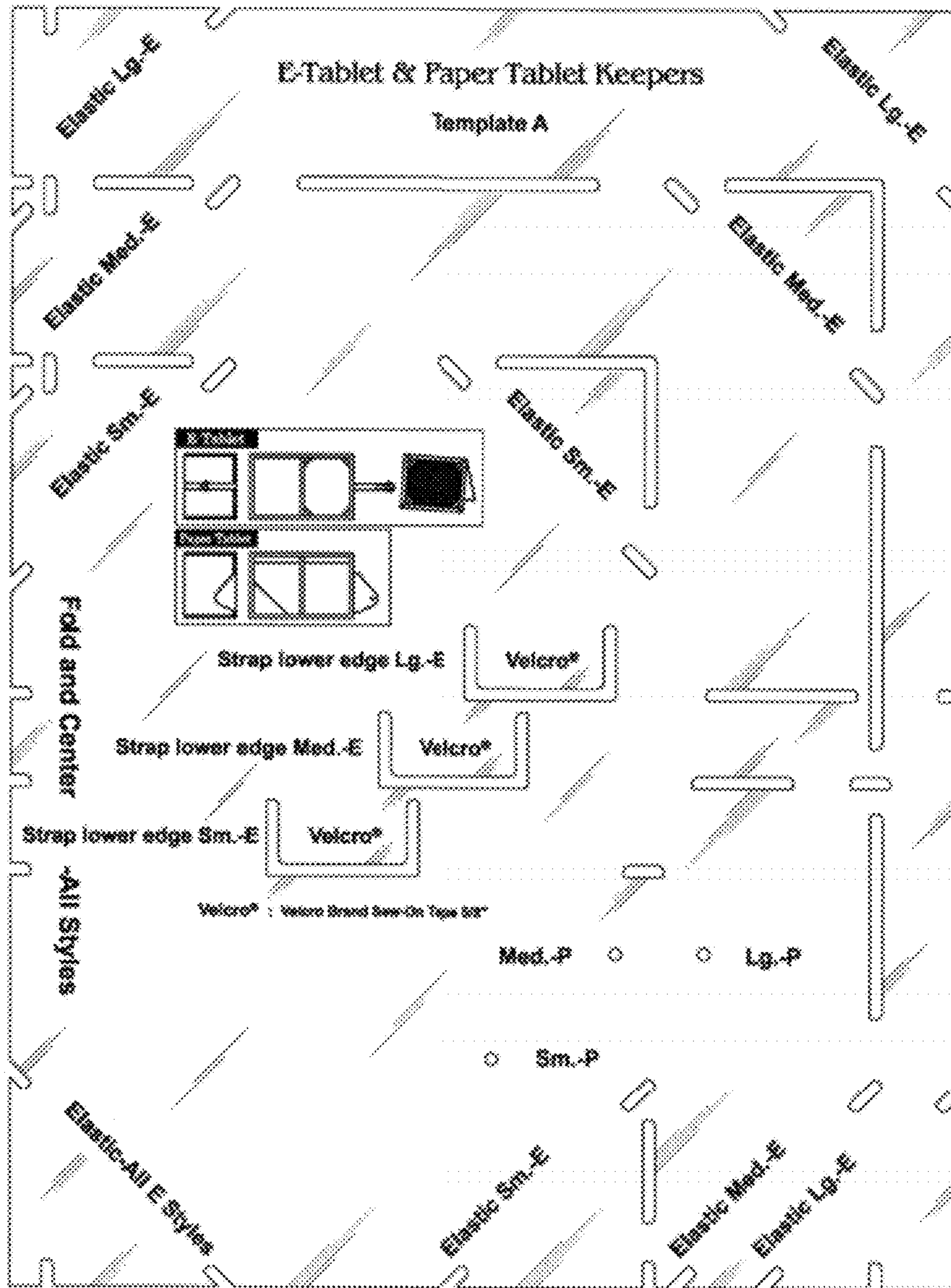

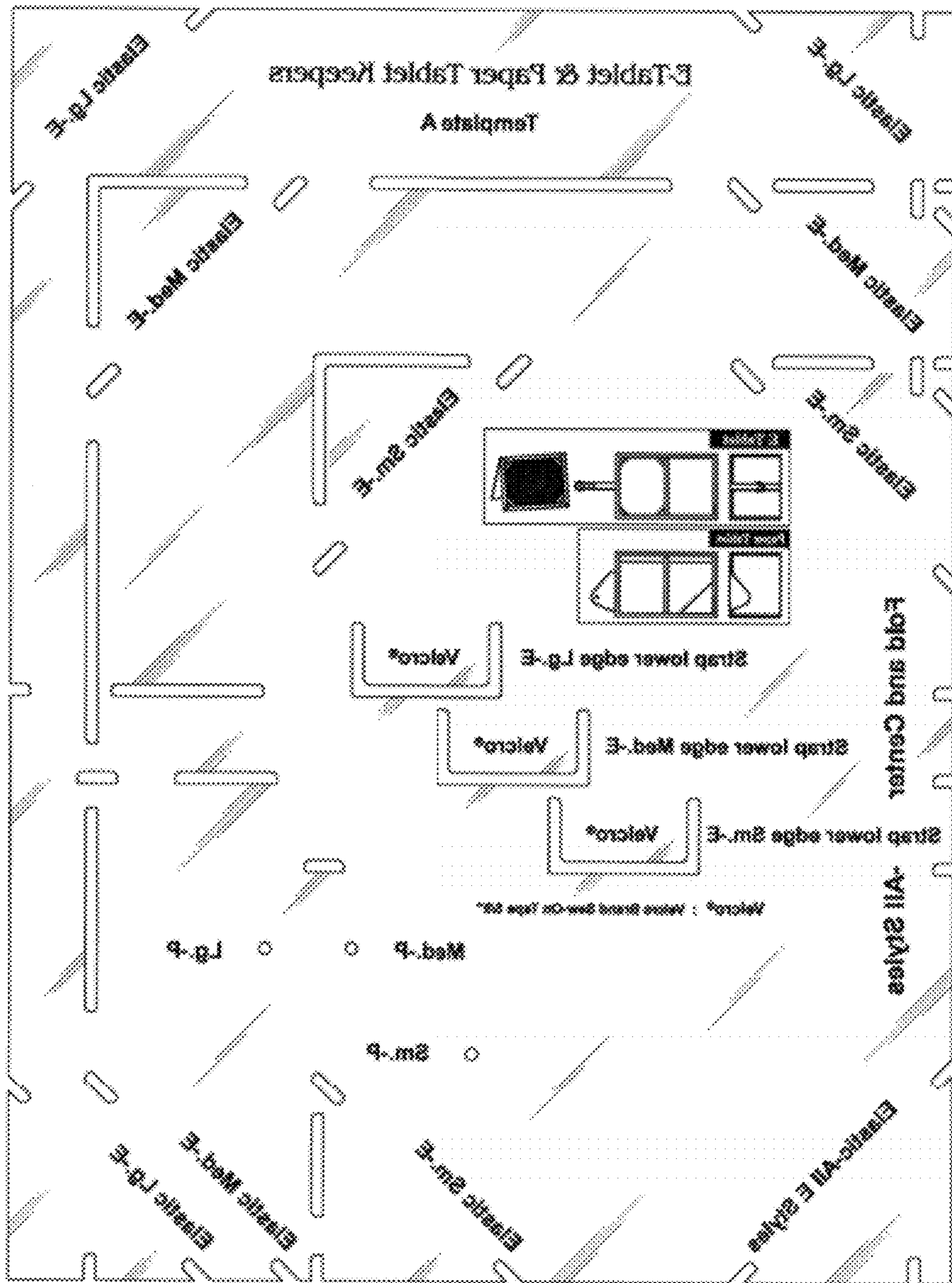

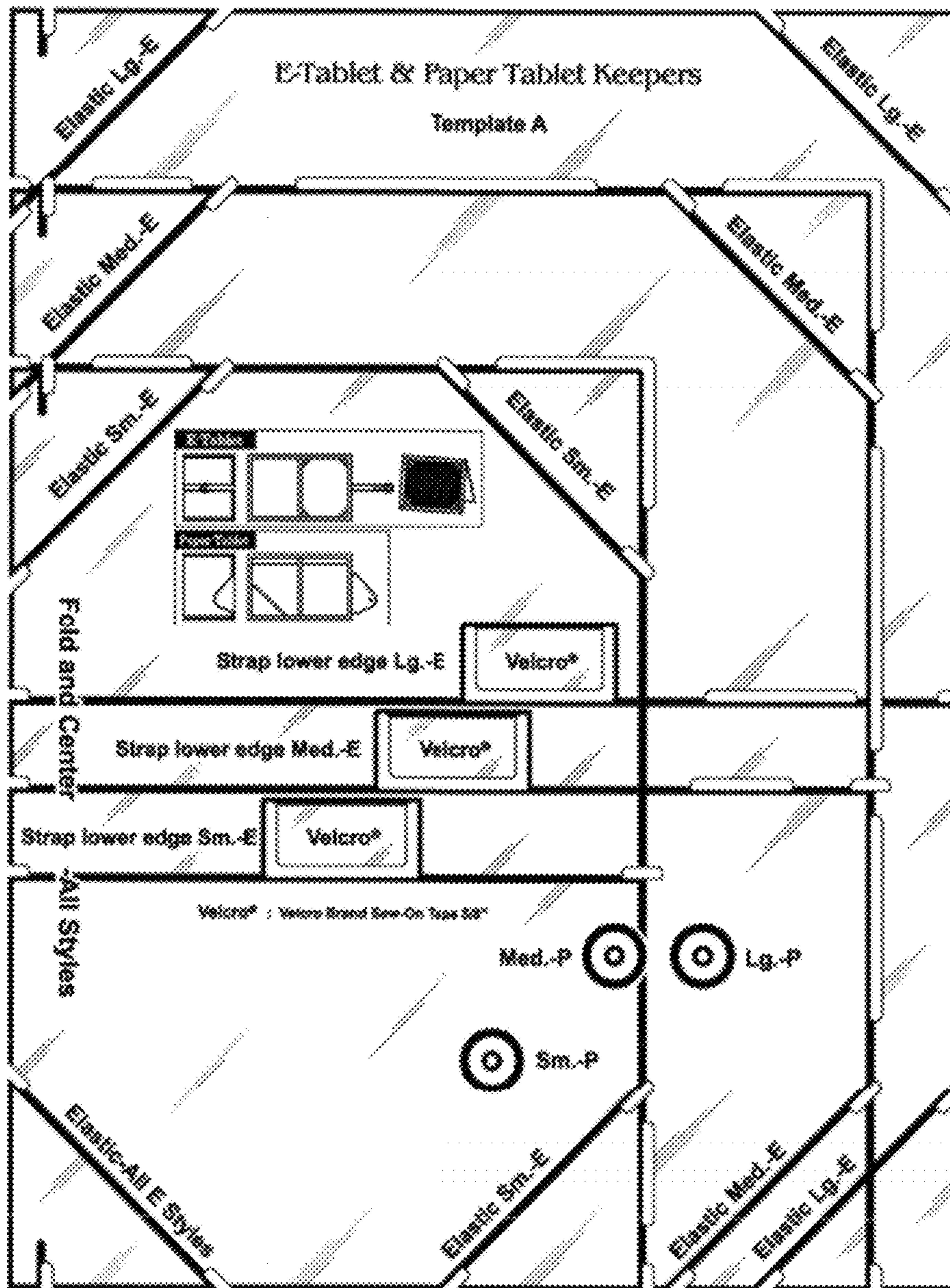
