The ornamental design for a jewelry element for earrings, necklaces, bracelets, brooches, hair jewelry or the like, as shown and described.

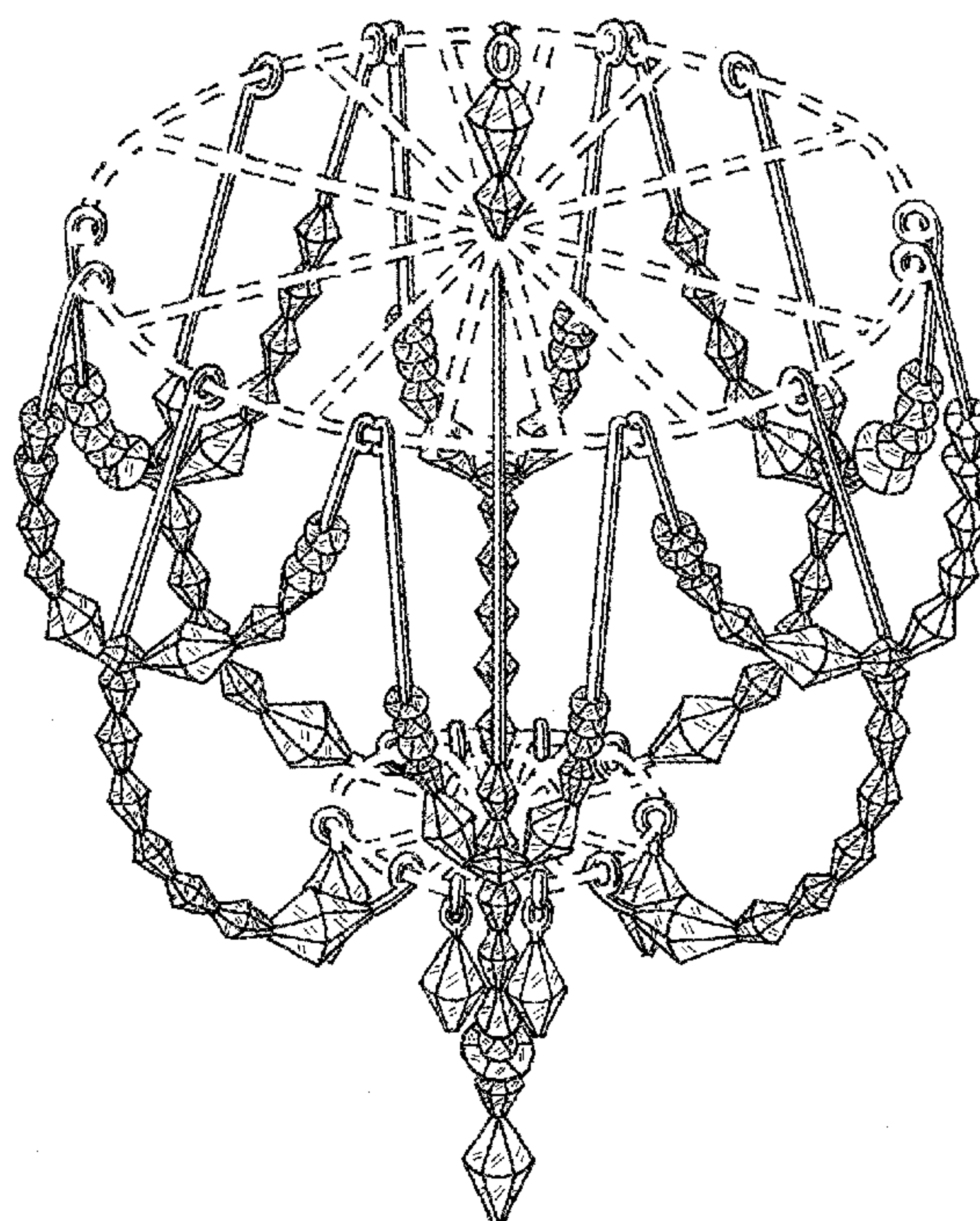
DESCRIPTION

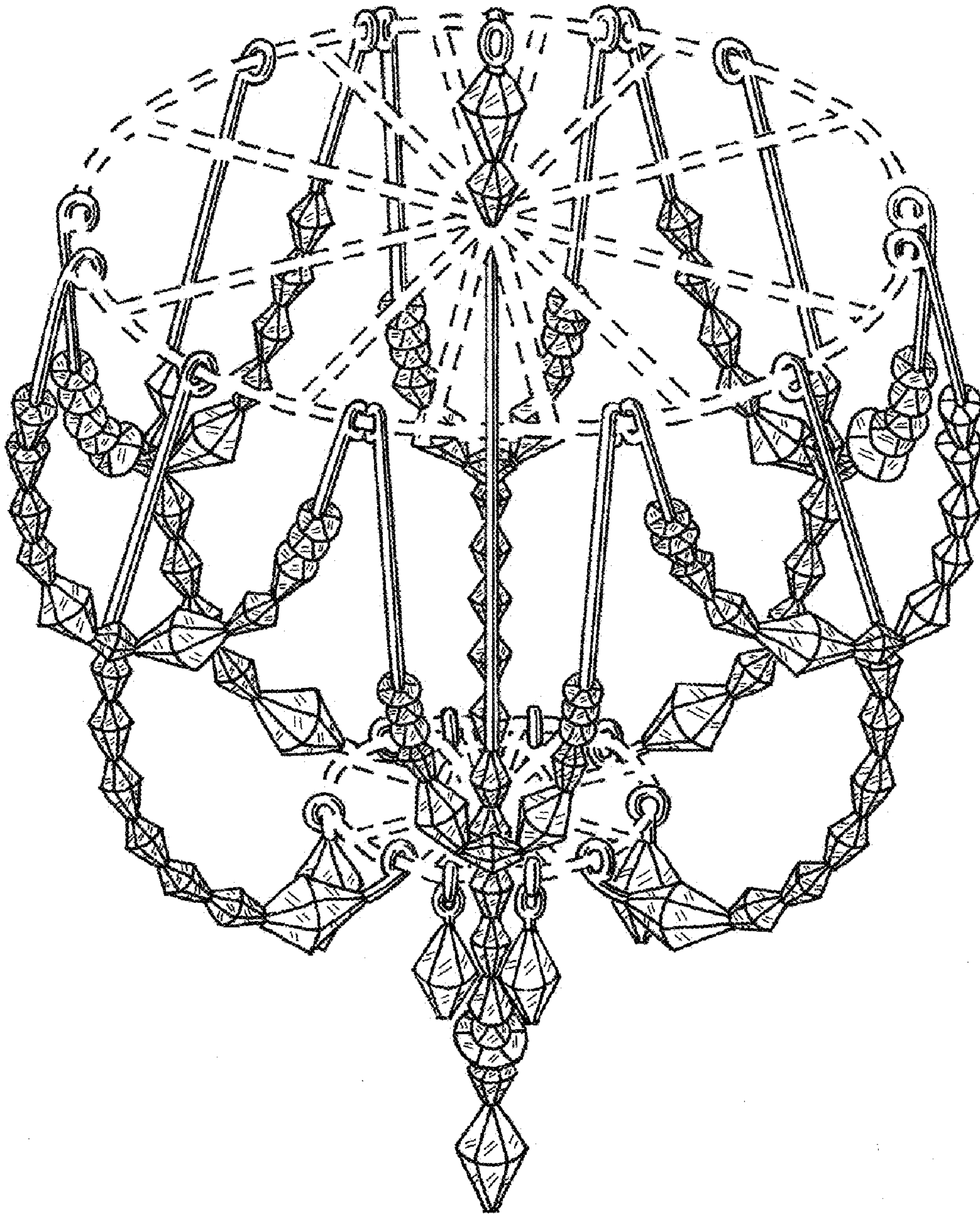

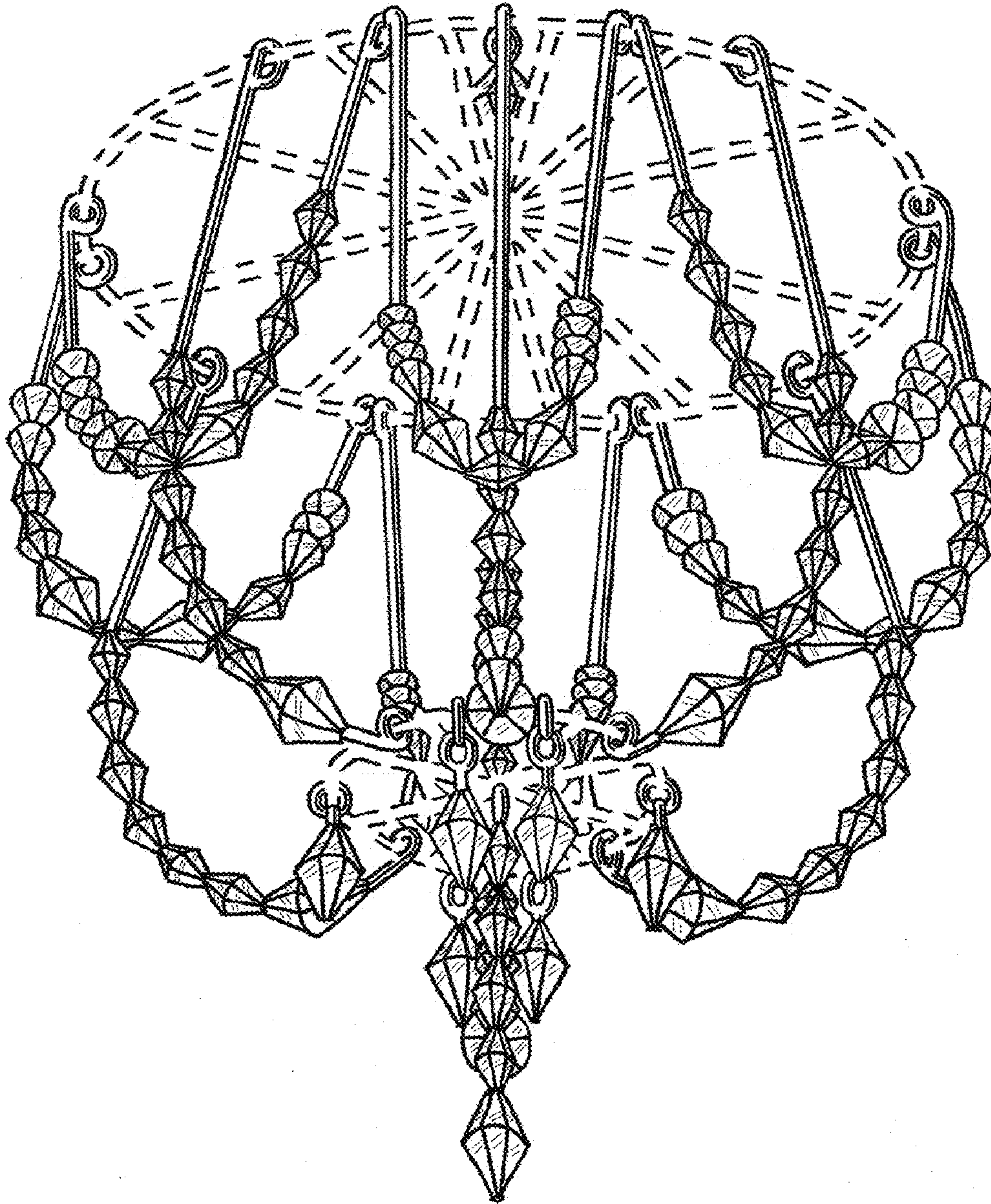

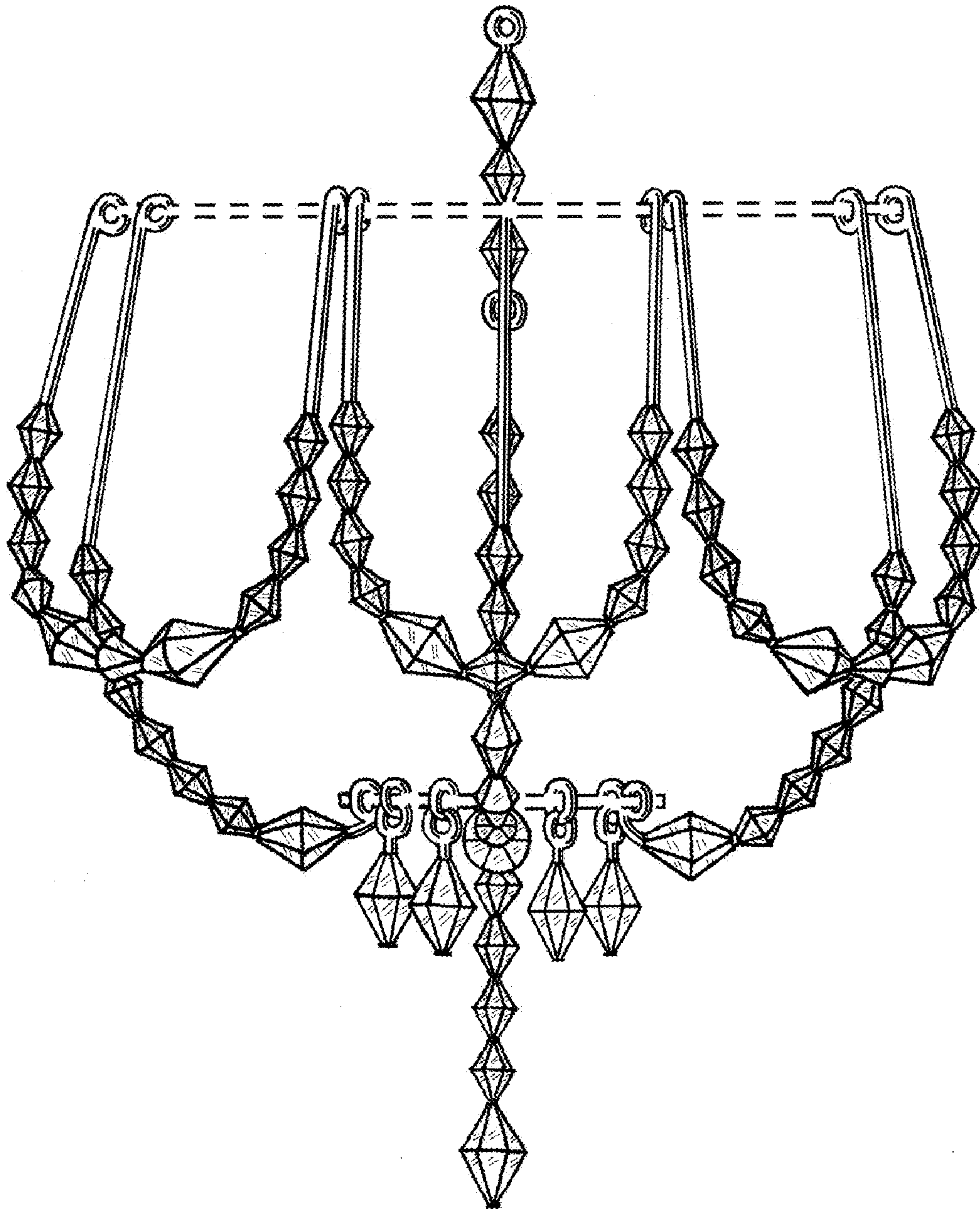

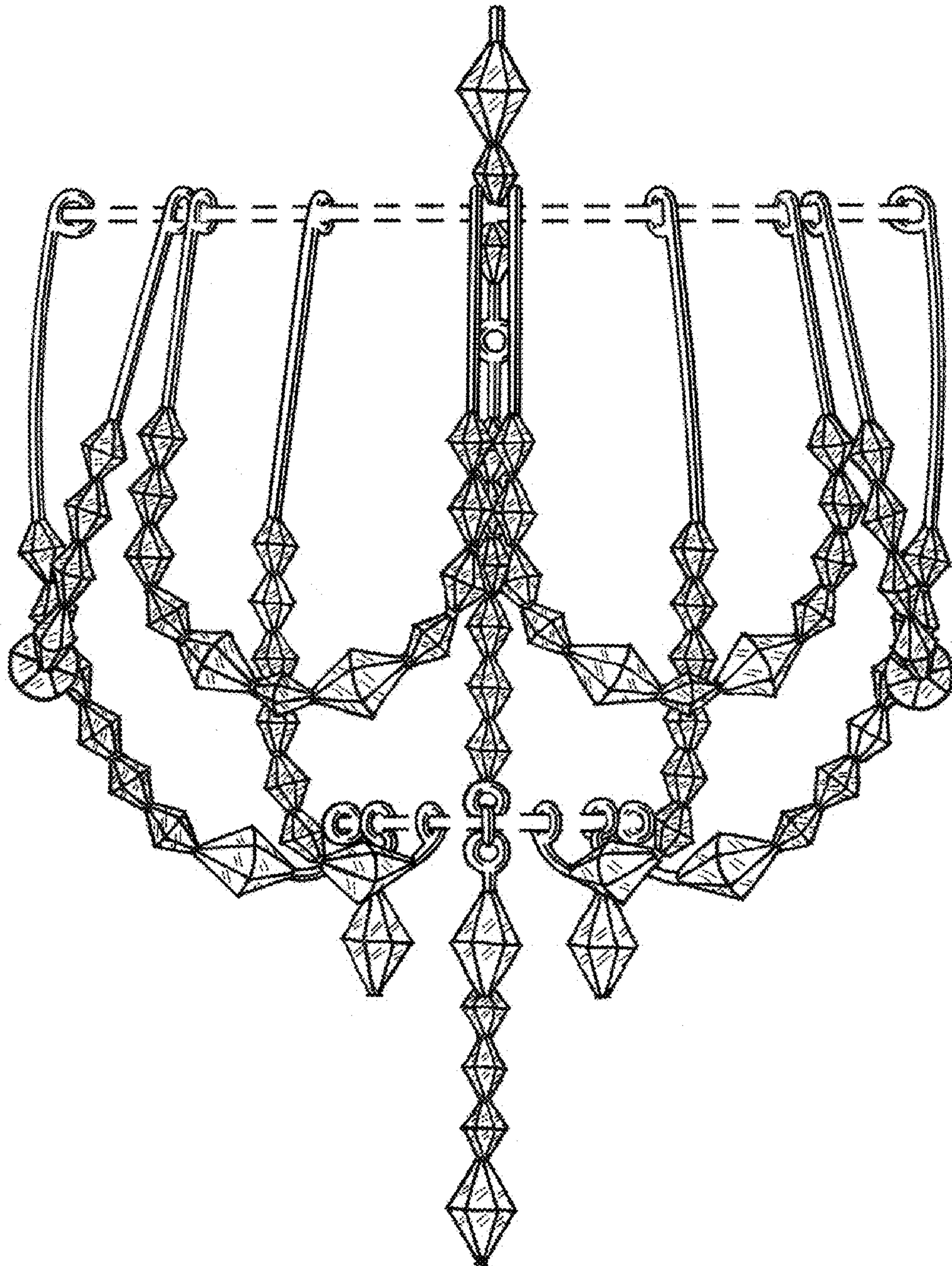

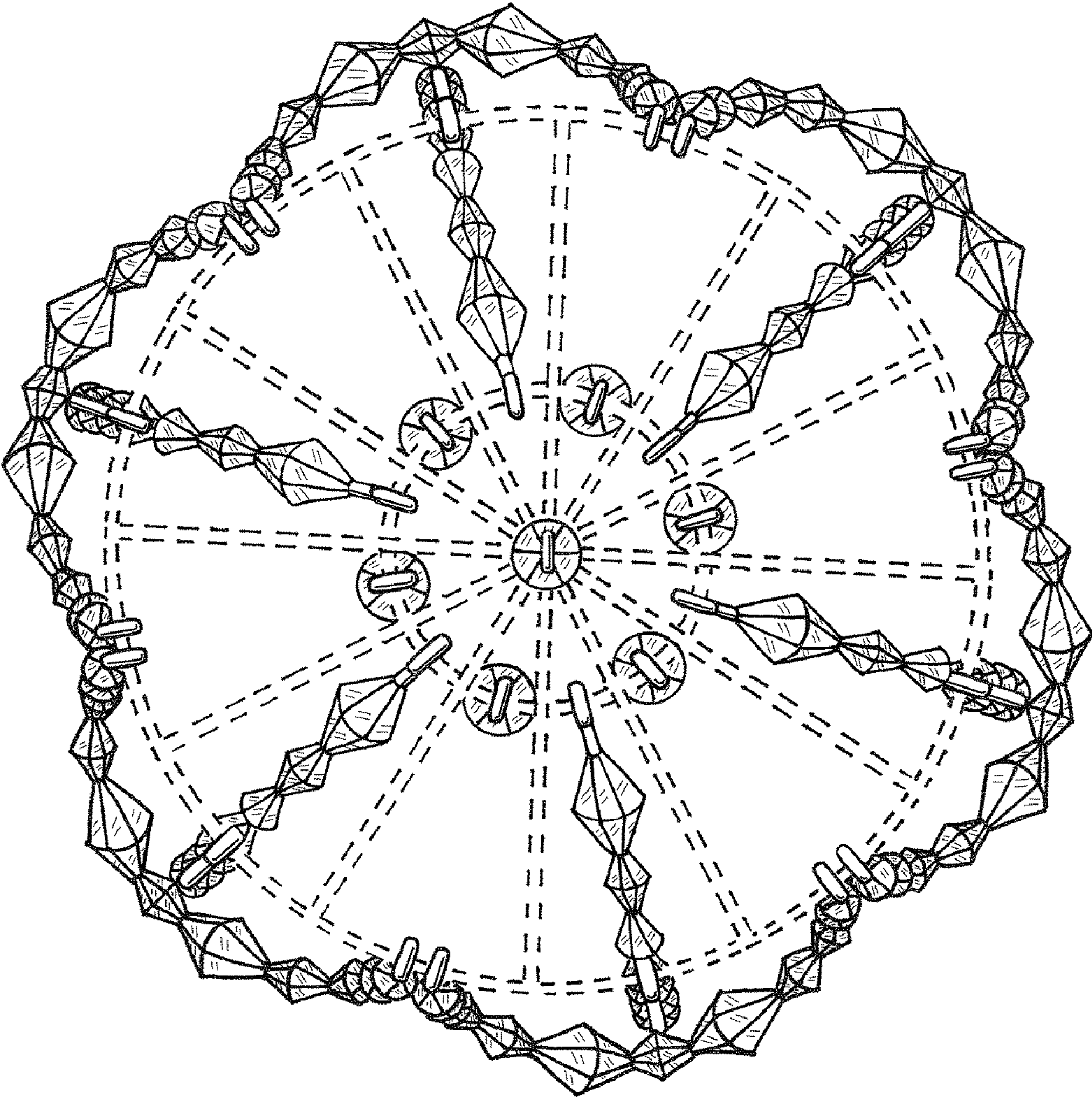

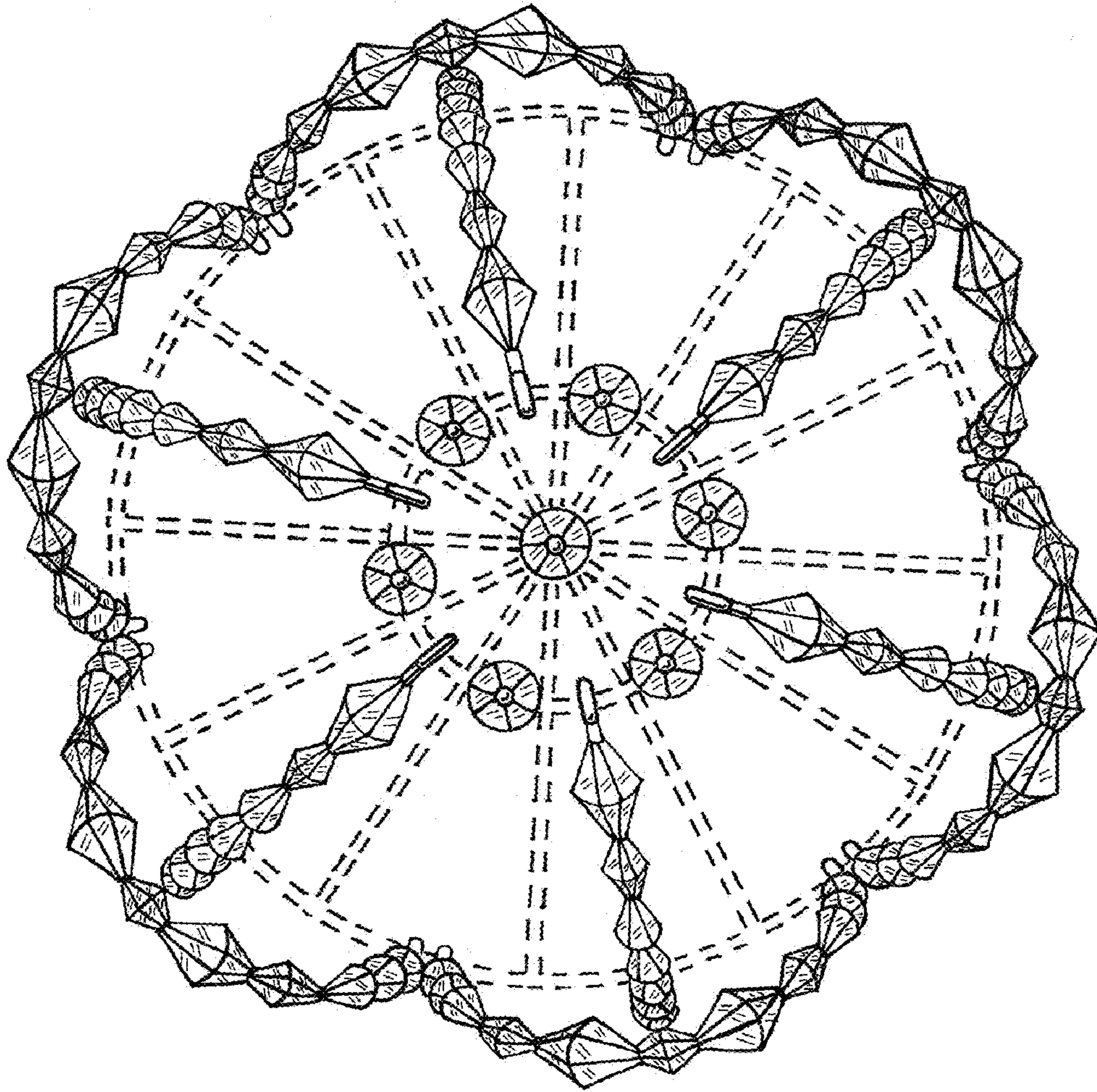

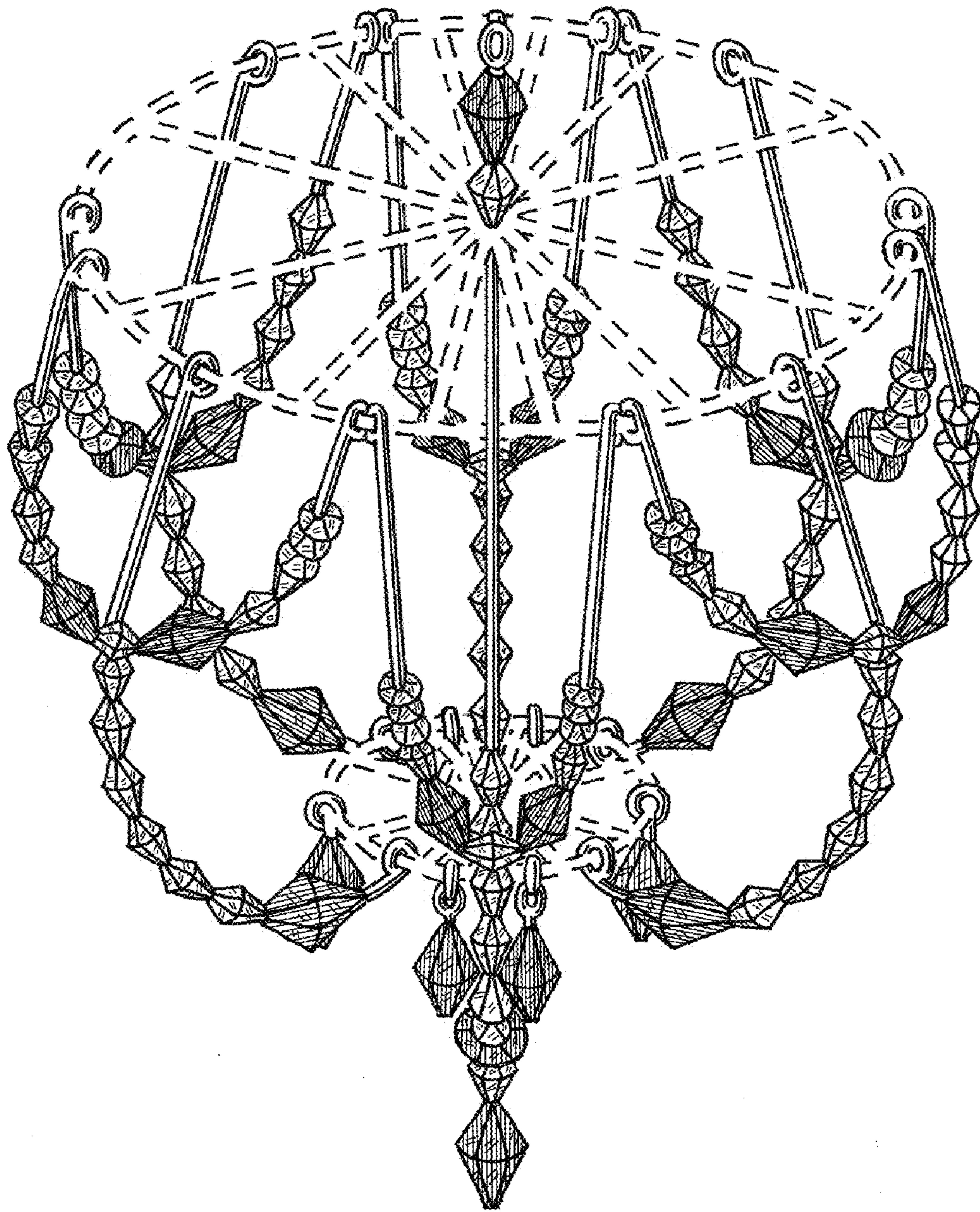

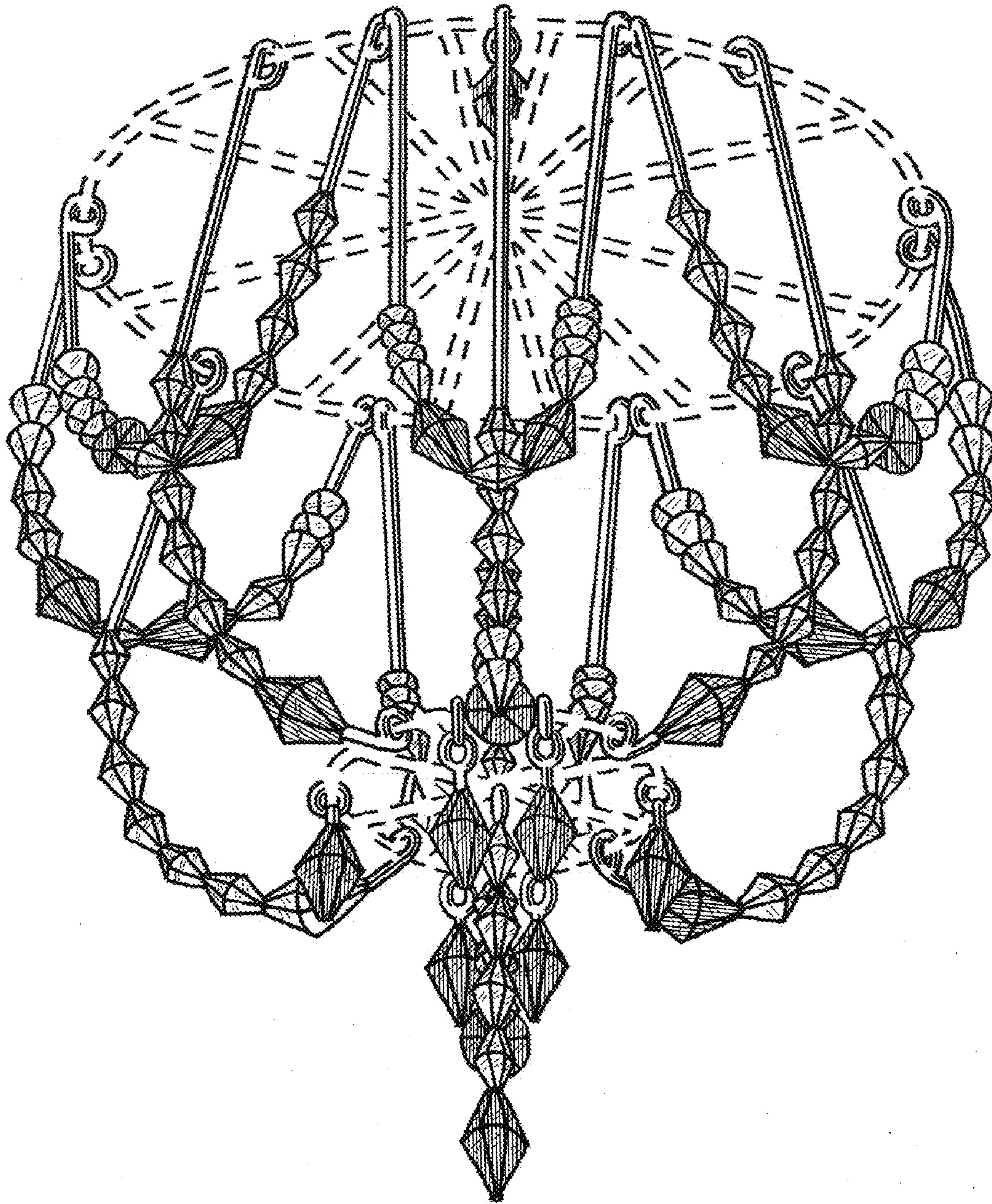

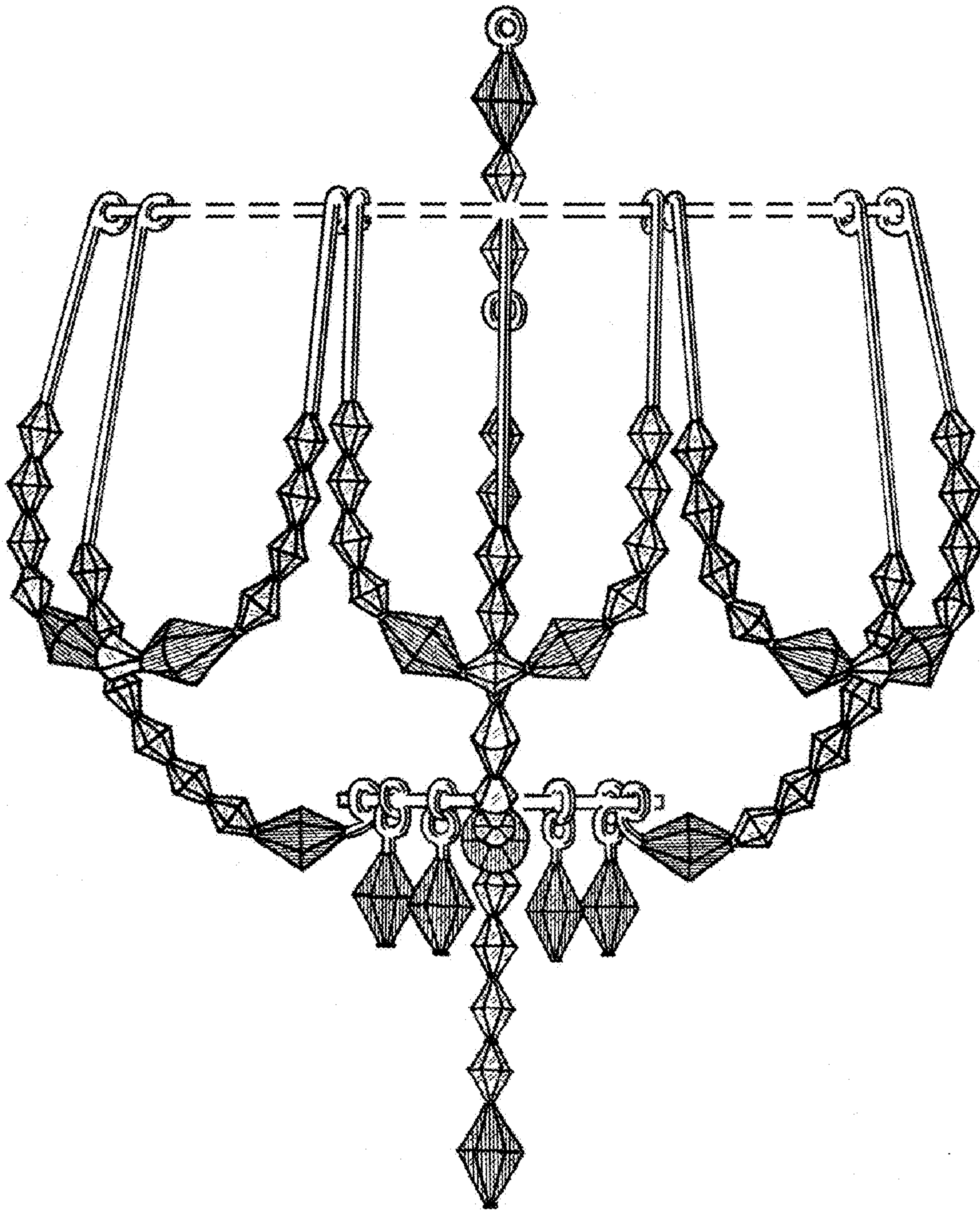

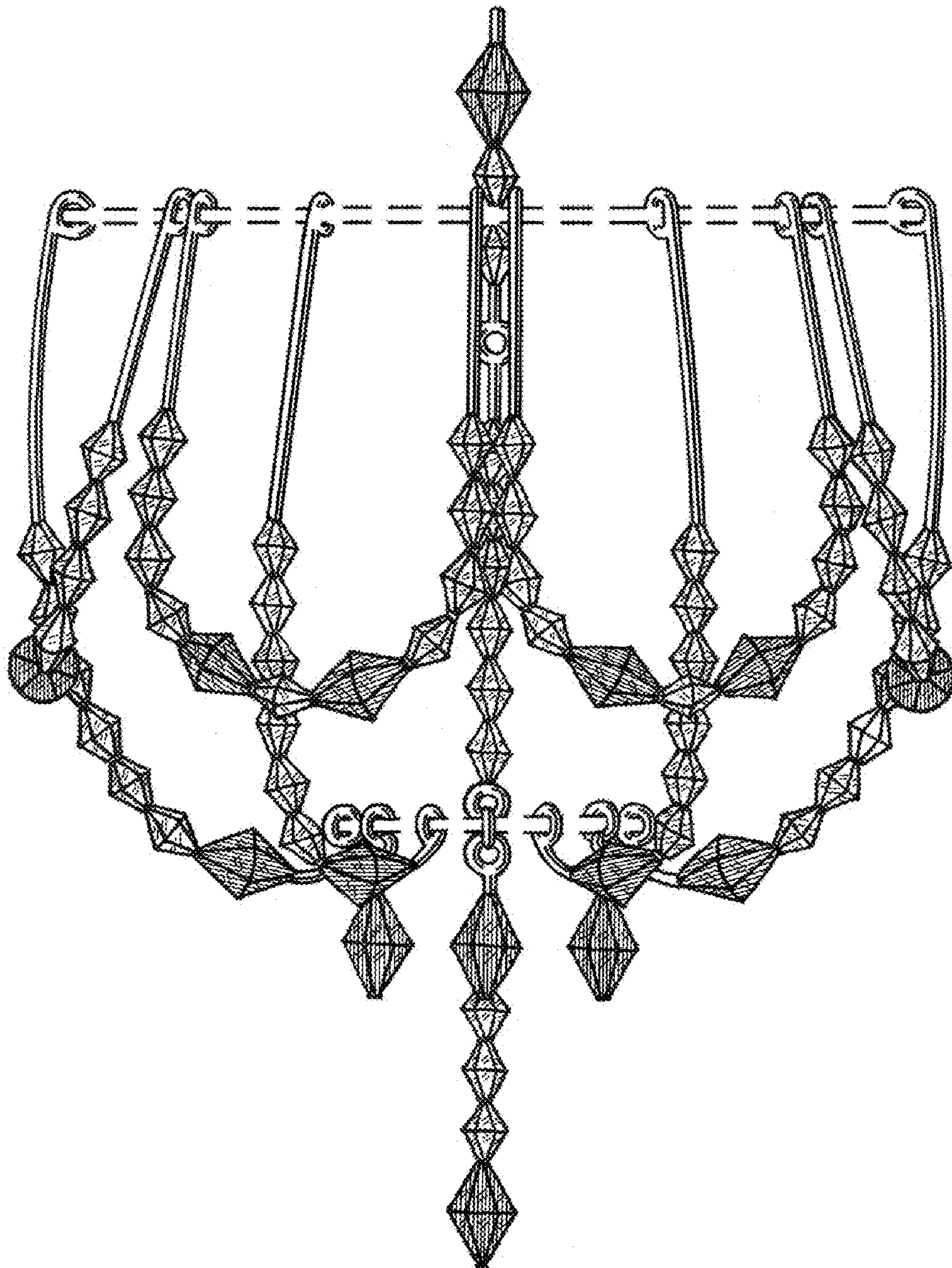

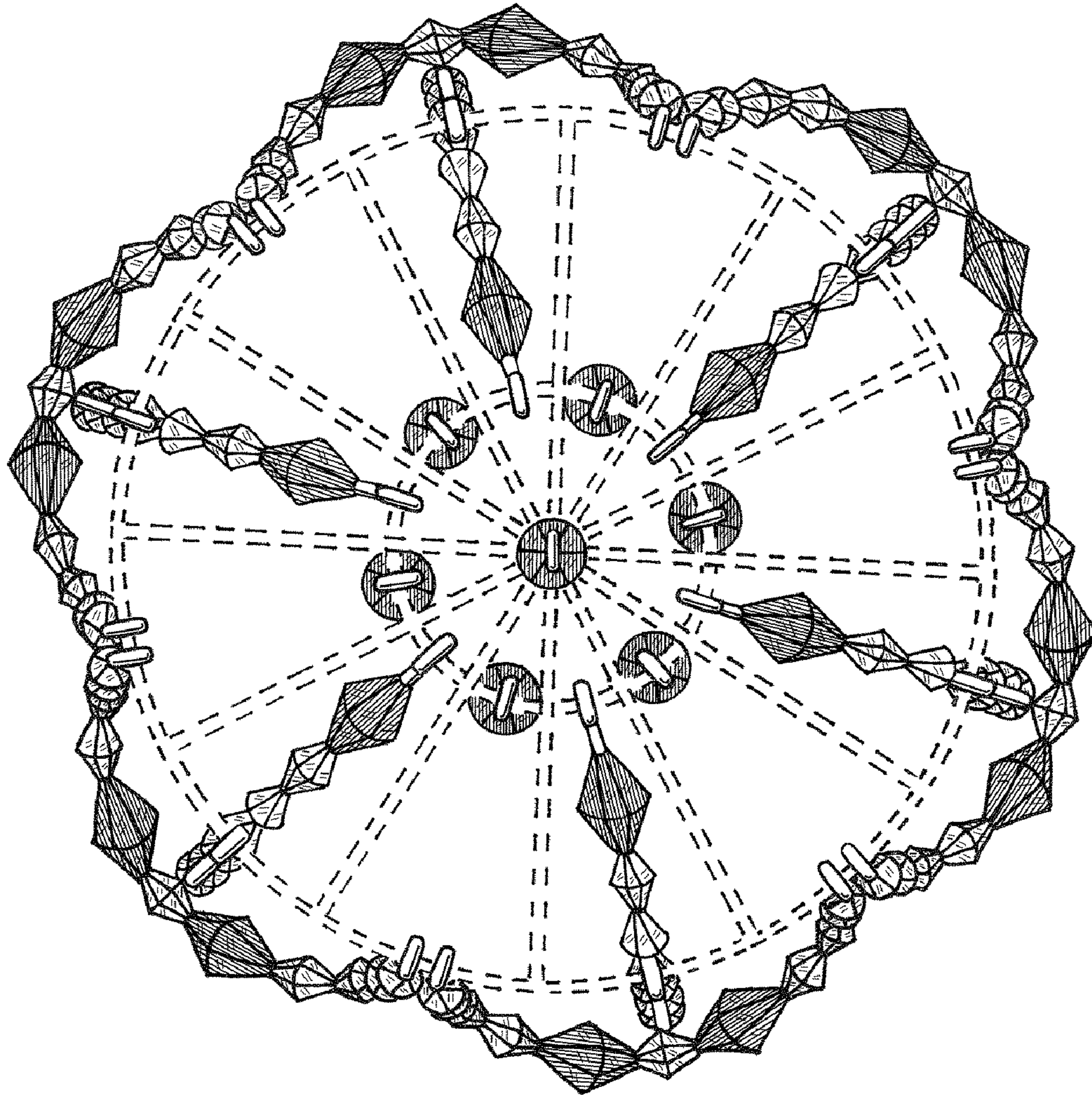

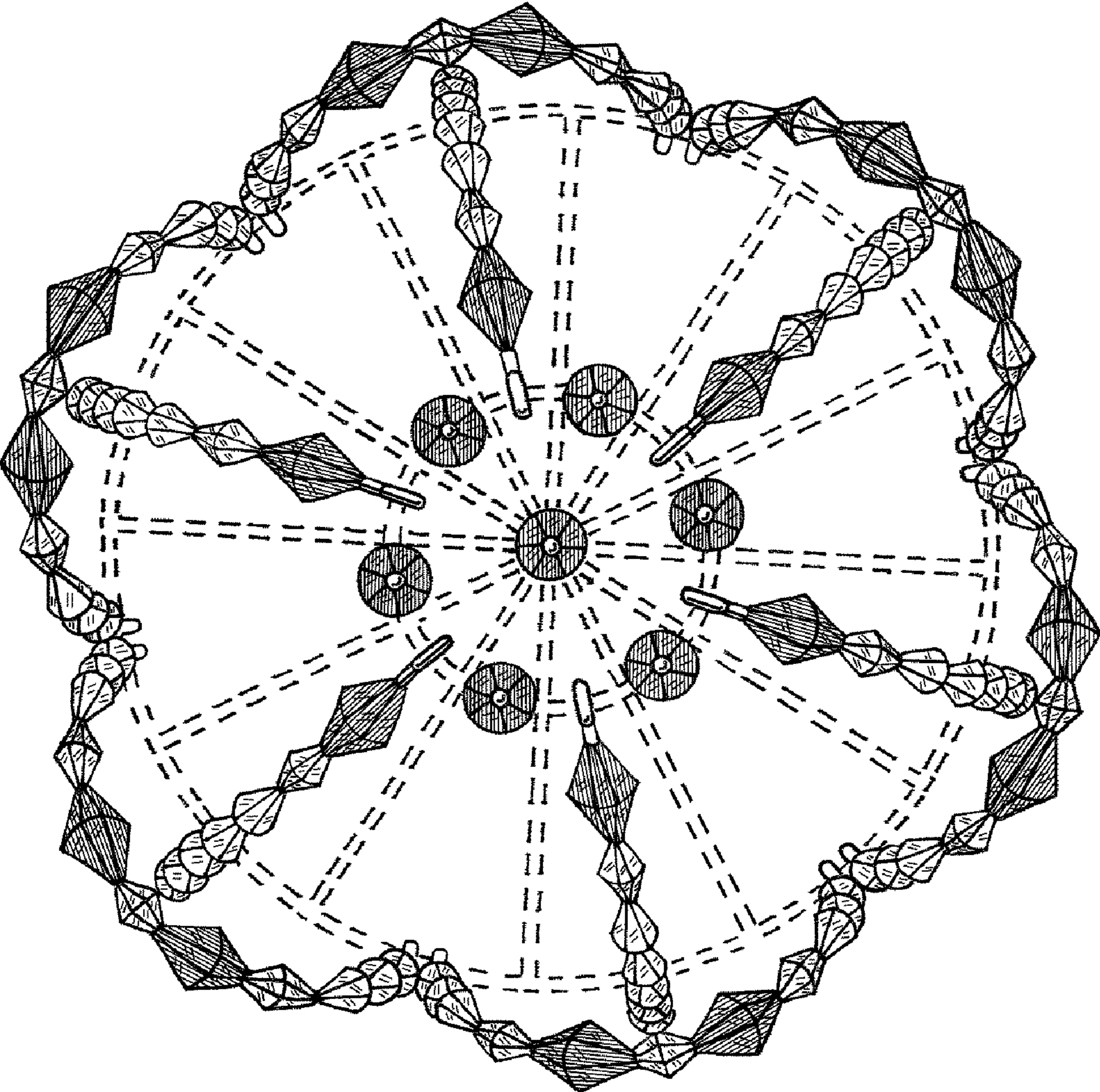
