DESCRIPTION

FIG. 1 is a perspective illustration of a heart design element and associated jewelry according to the new design.

FIG. 2 is a front plan view thereof.

FIG. 3 is a rear plan view.

FIG. 4 is an elevation view from below in FIG. 2.

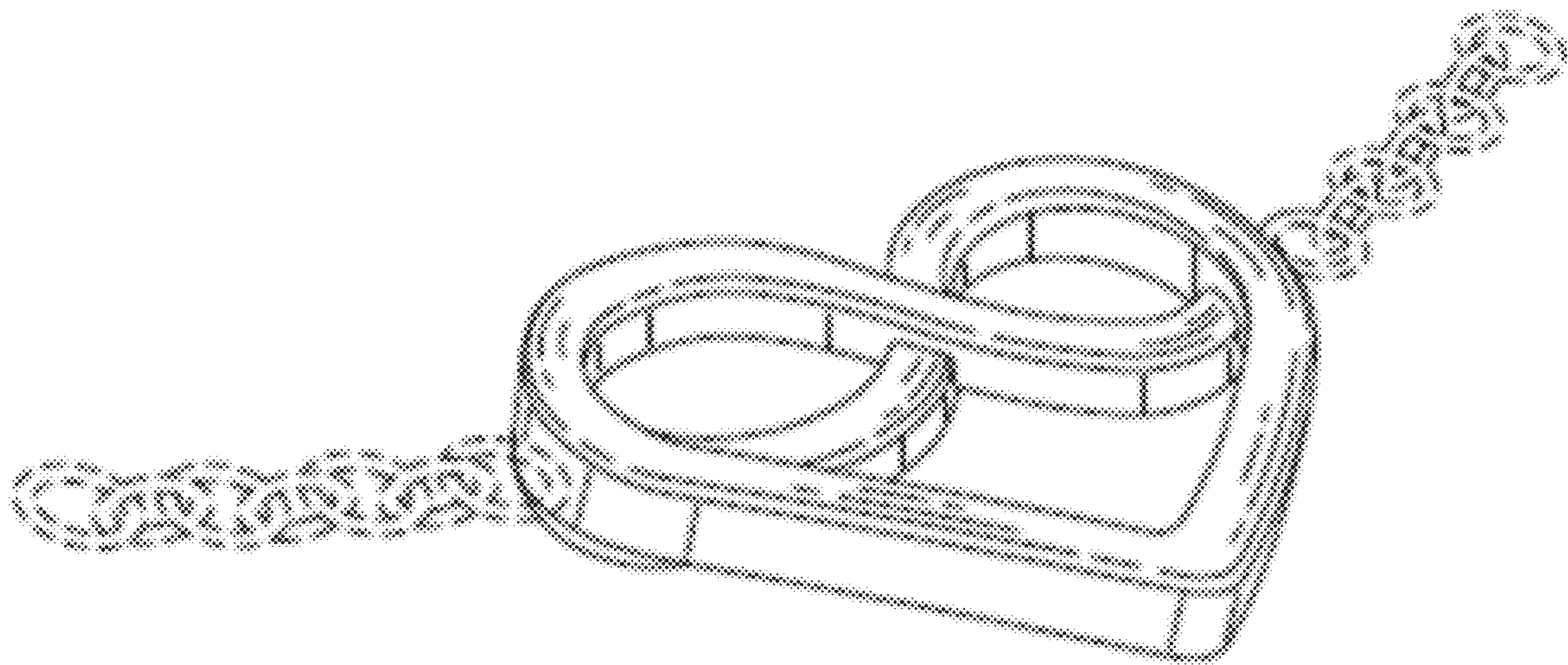
FIG. 5 is an elevation view from above in FIG. 2.

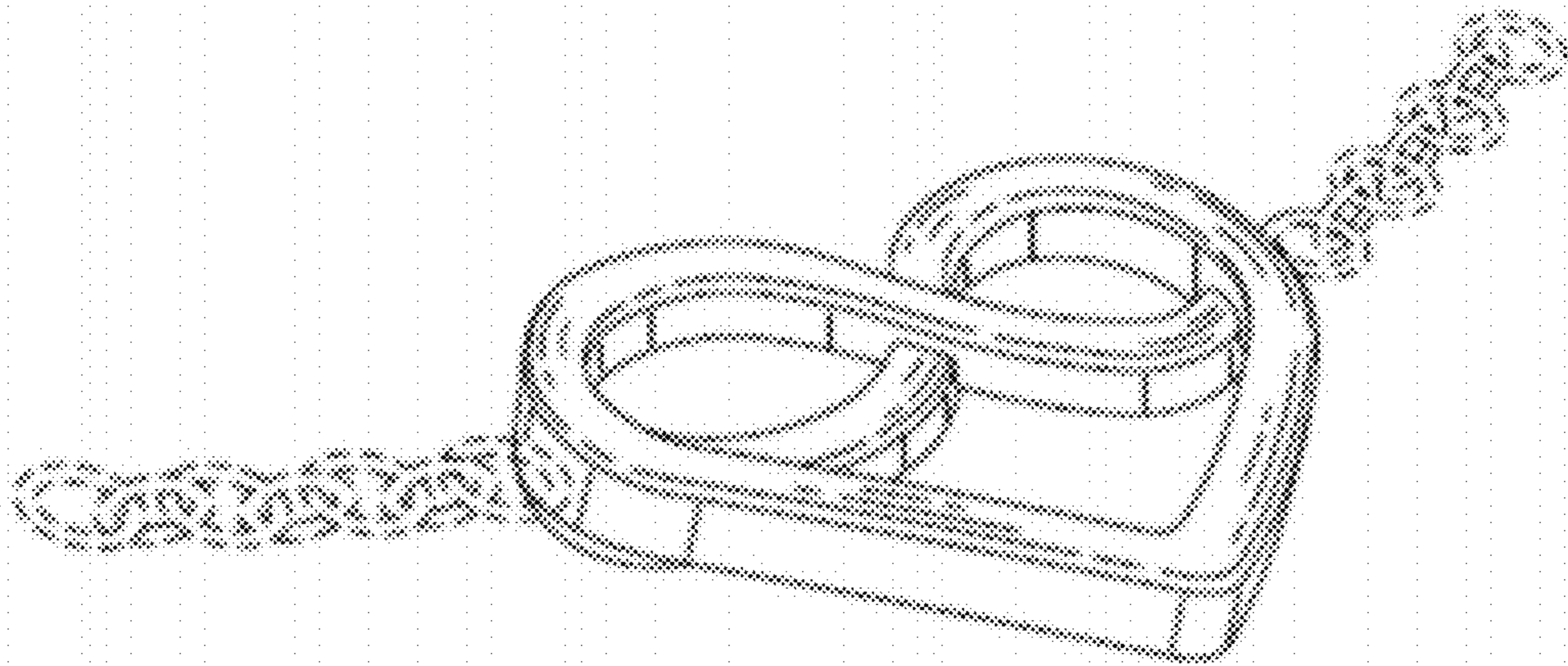

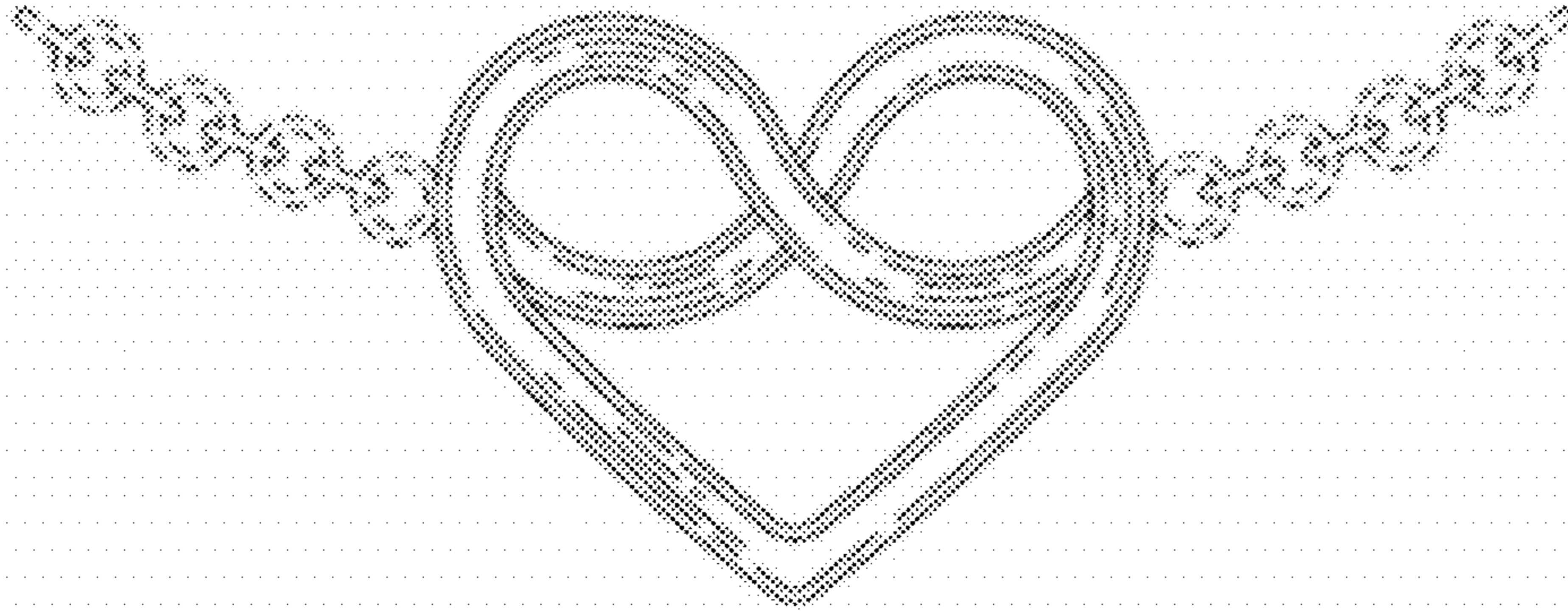

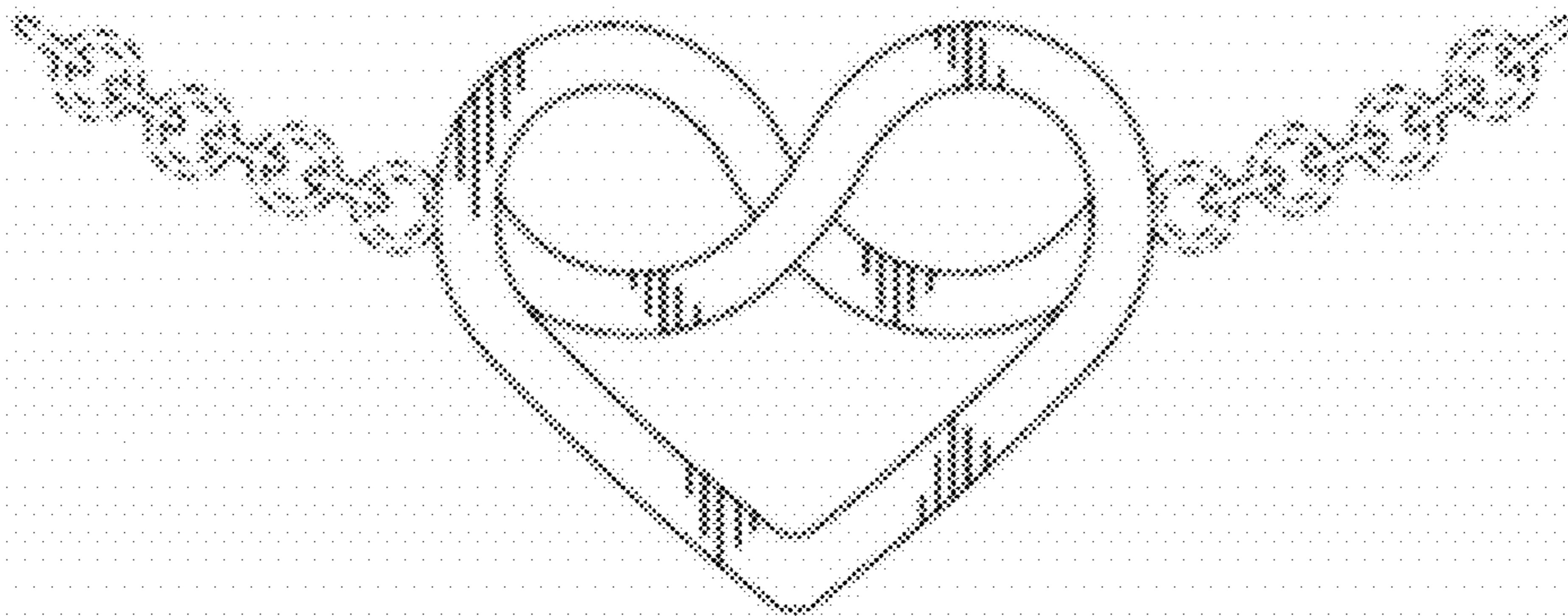

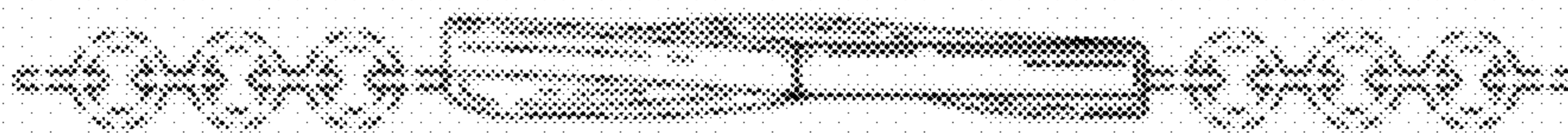

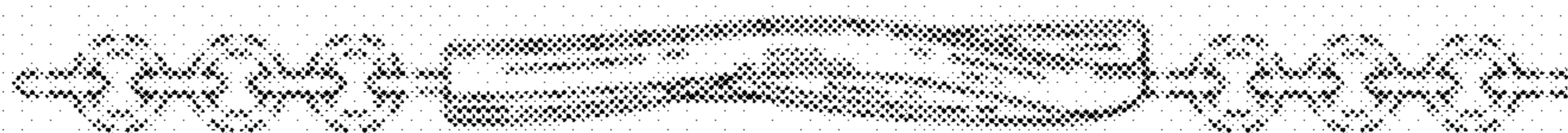

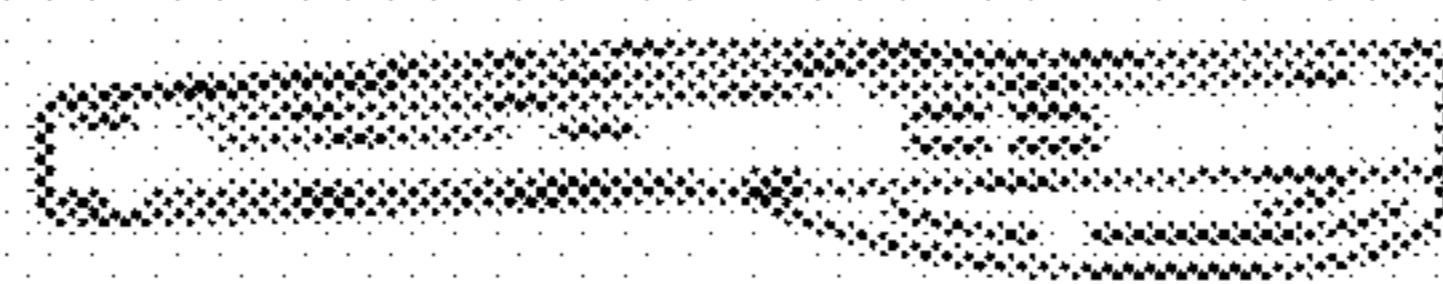
