The ornamental design for a radiator grill for a vehicle, as shown and described.

Application Ser. No. 29/371,278, filed herewith and entitled "Radiator Grill for a Vehicle".

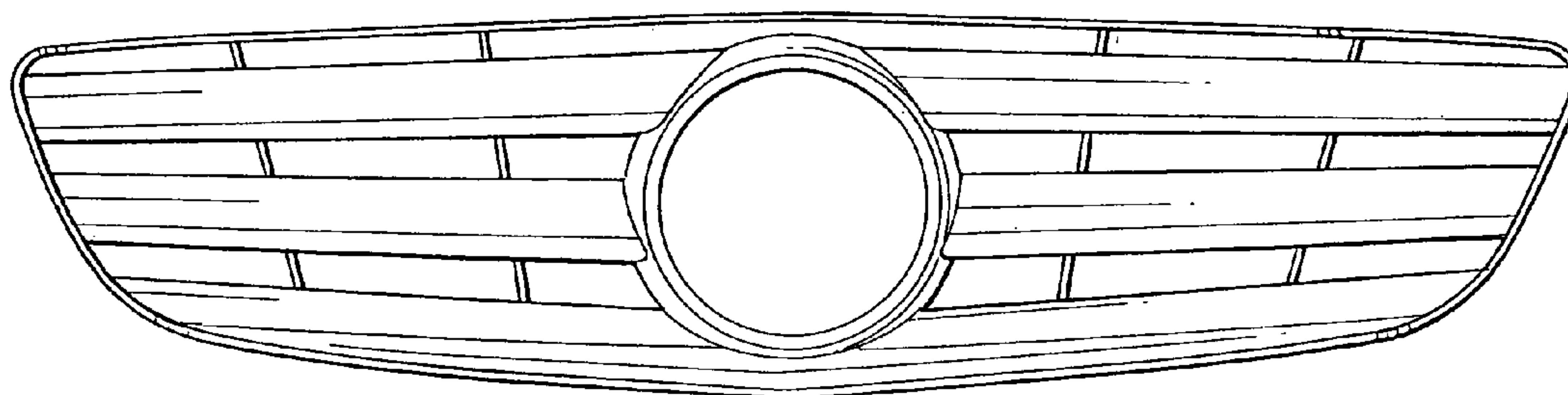
FIG. 1 is a left perspective view of a radiator grill for a vehicle according to our design, the right perspective view being mirror symmetrical;

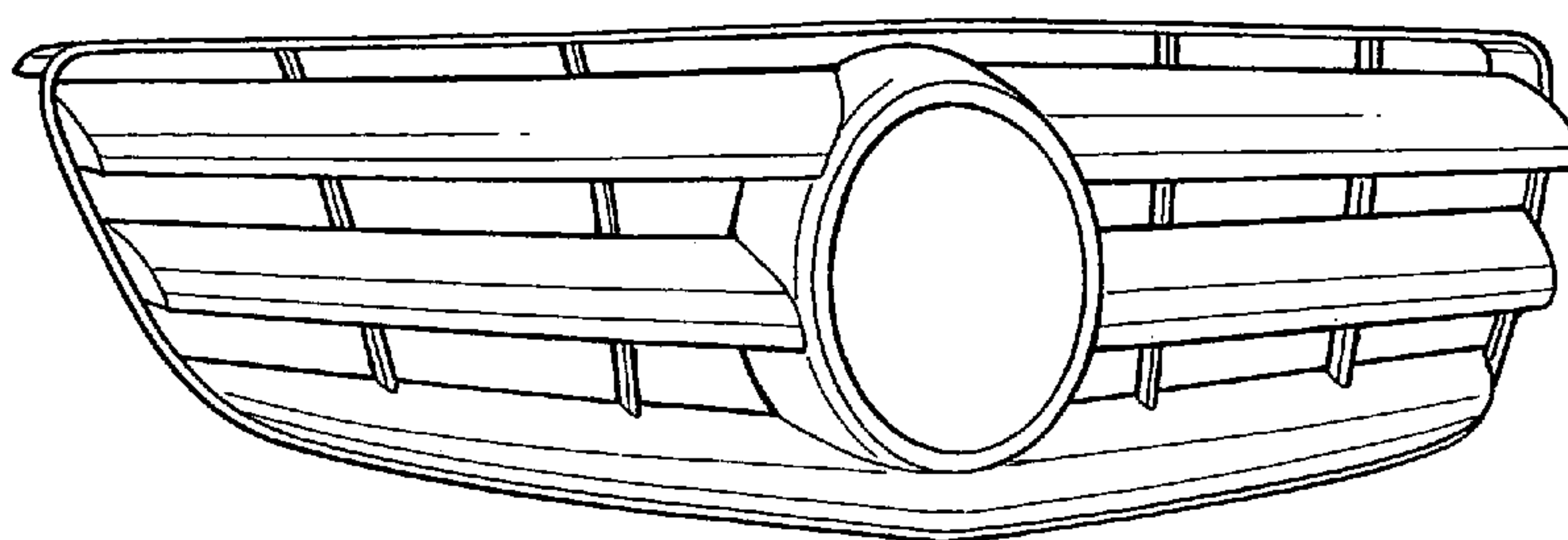

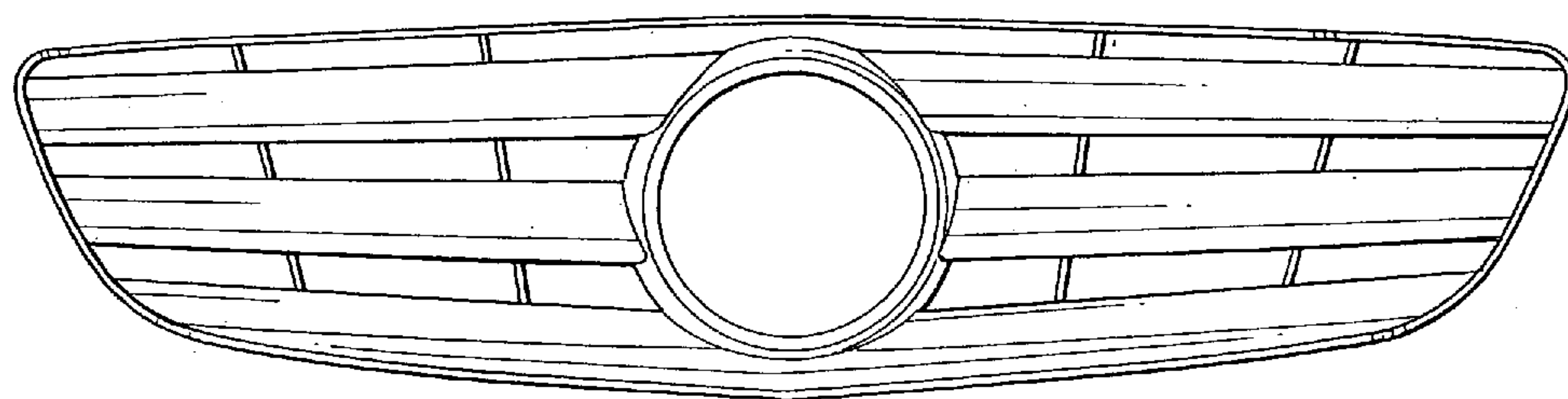

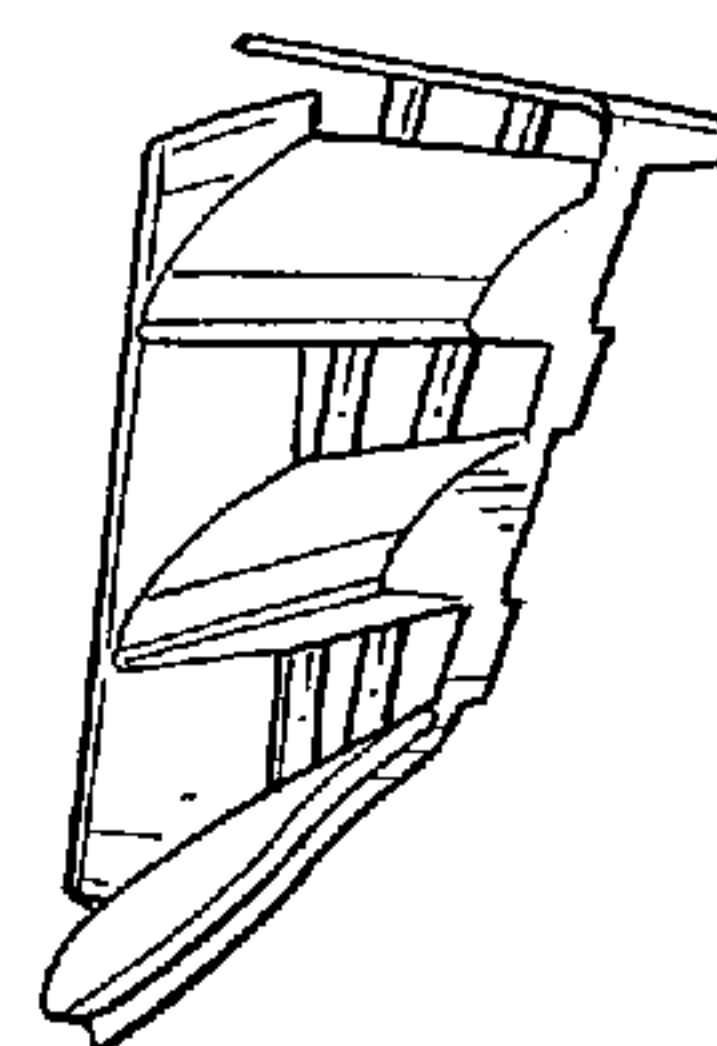

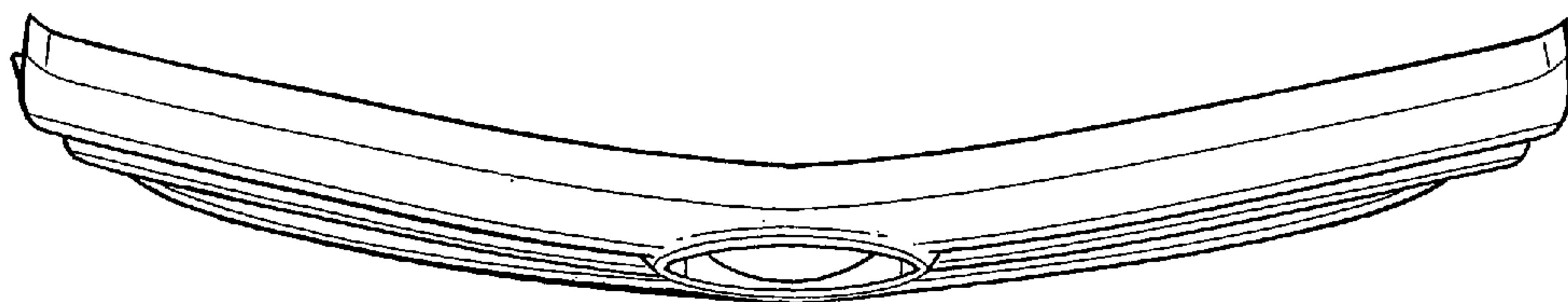
