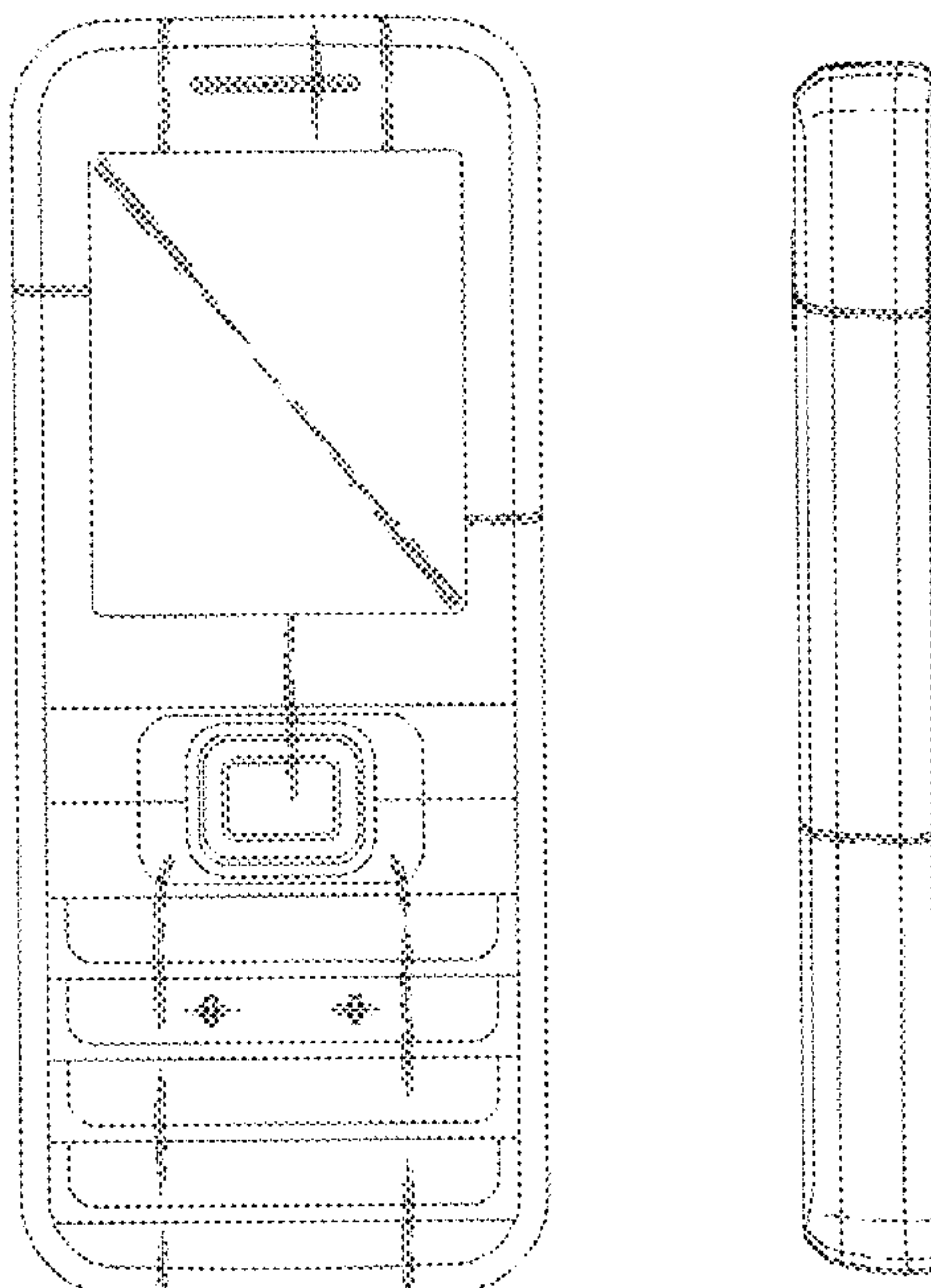
CLAIM

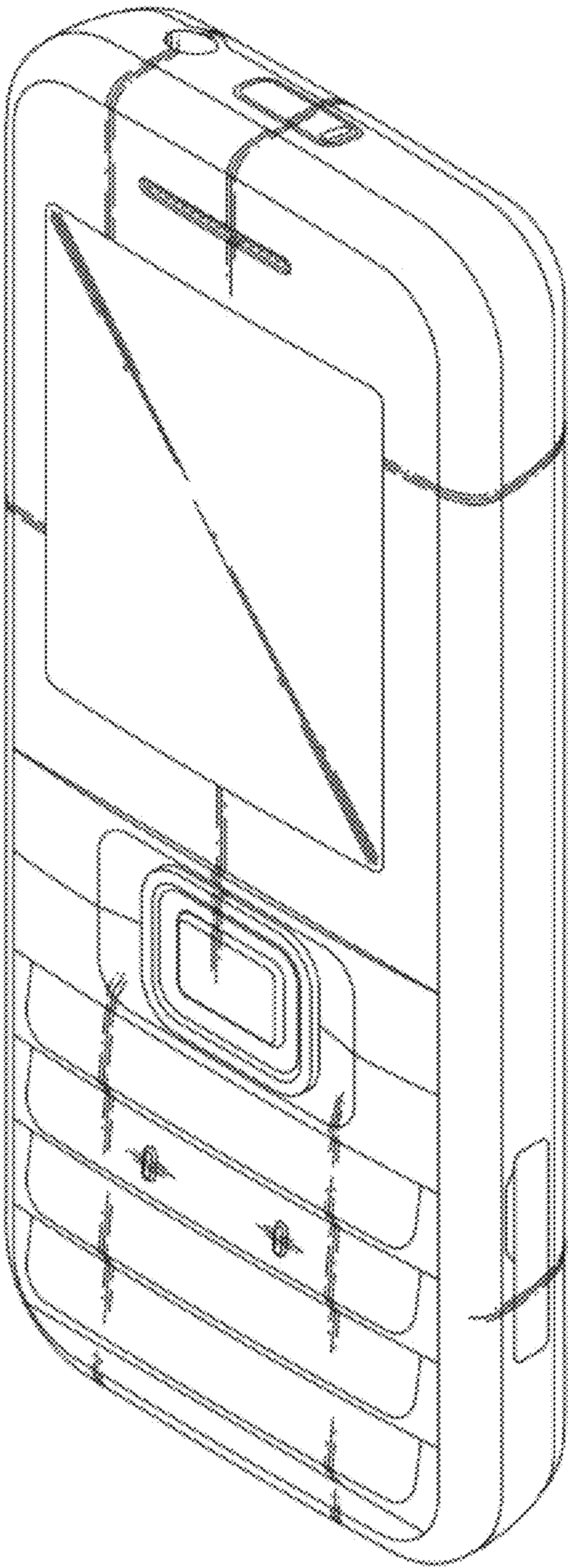

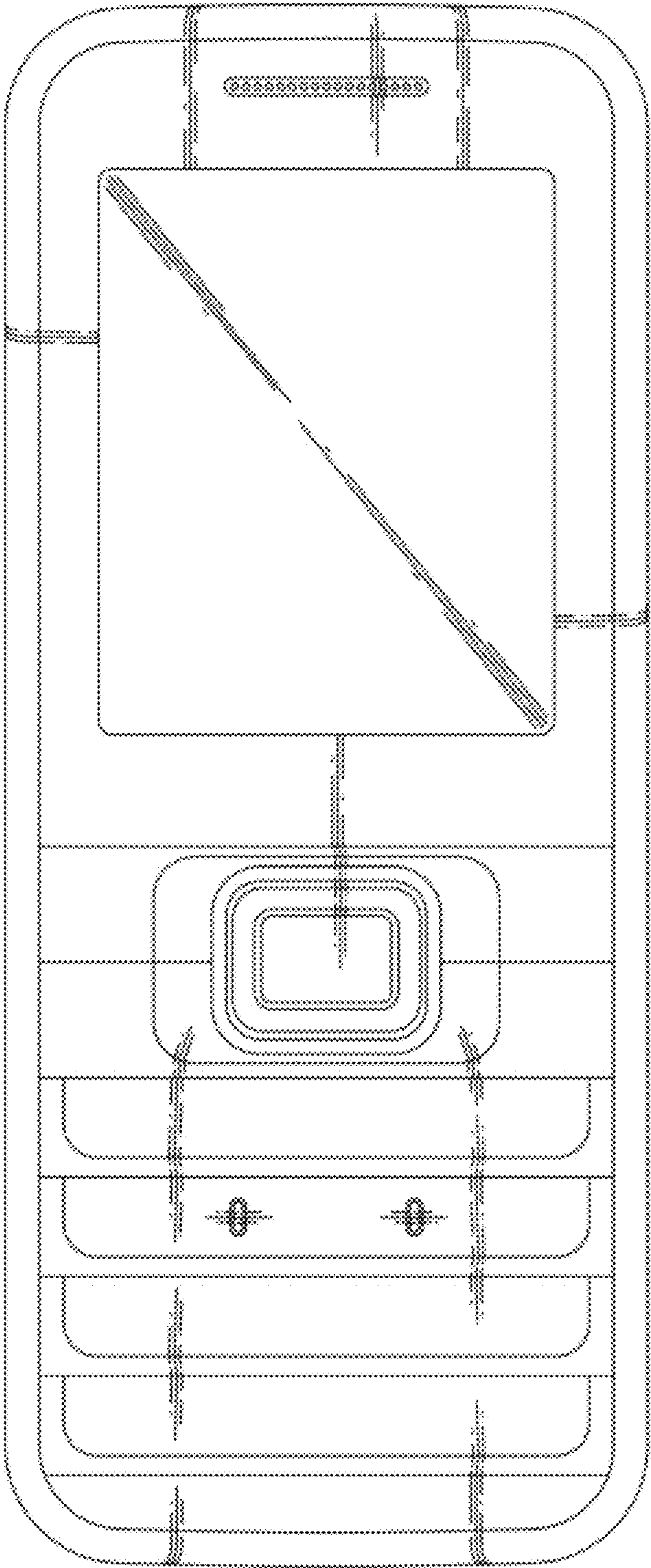

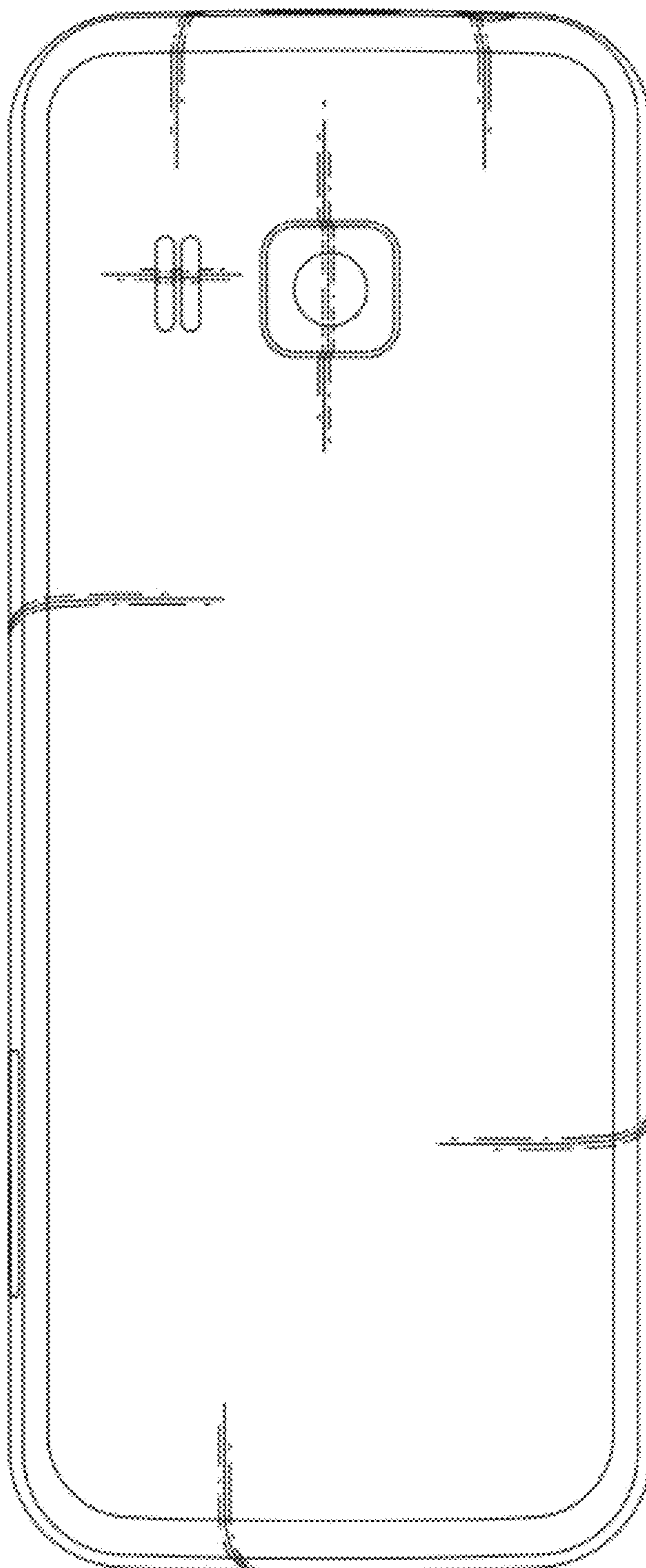

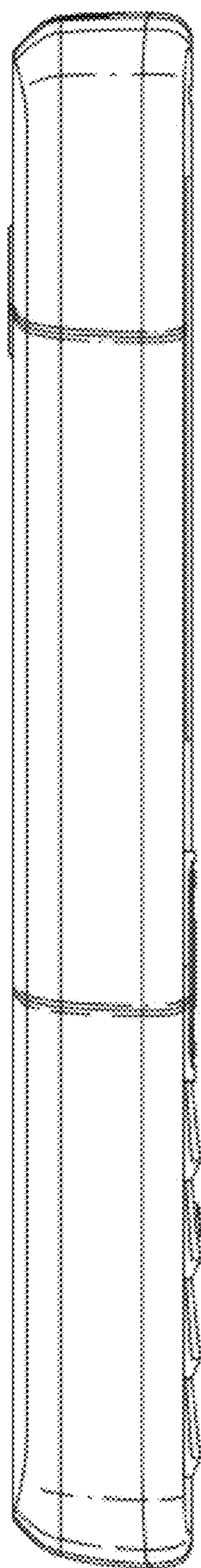

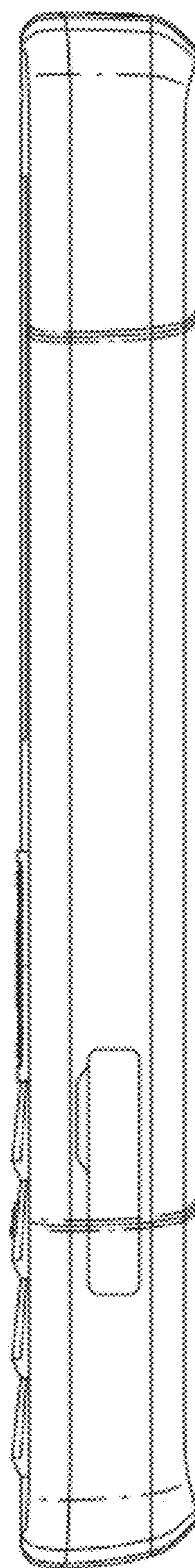

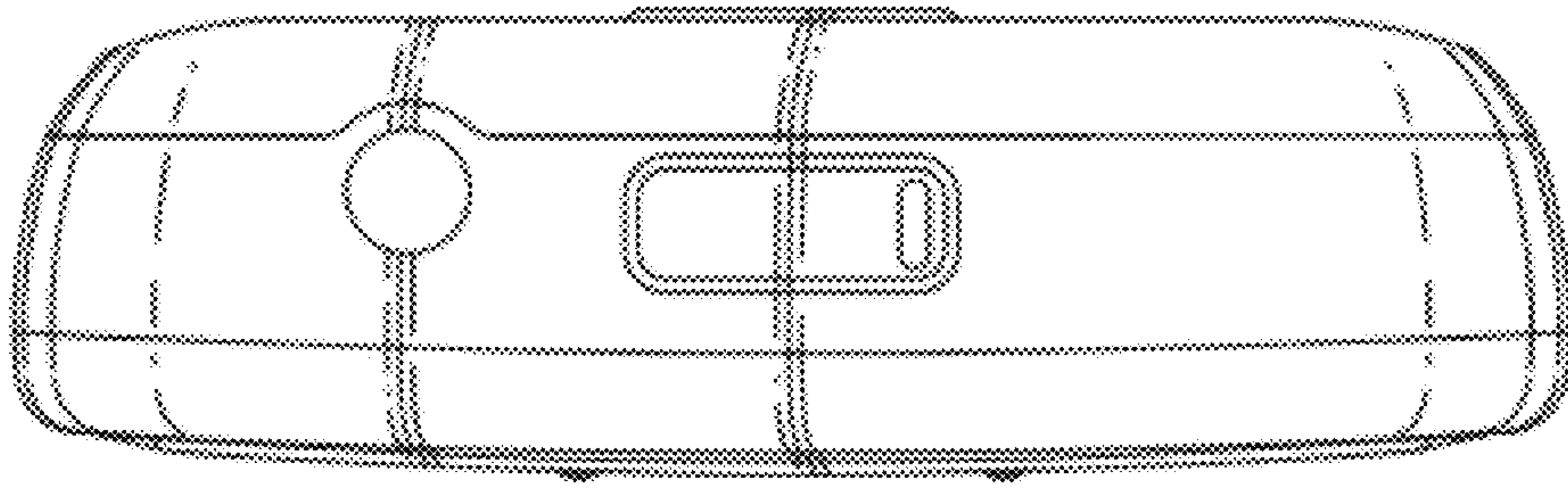
