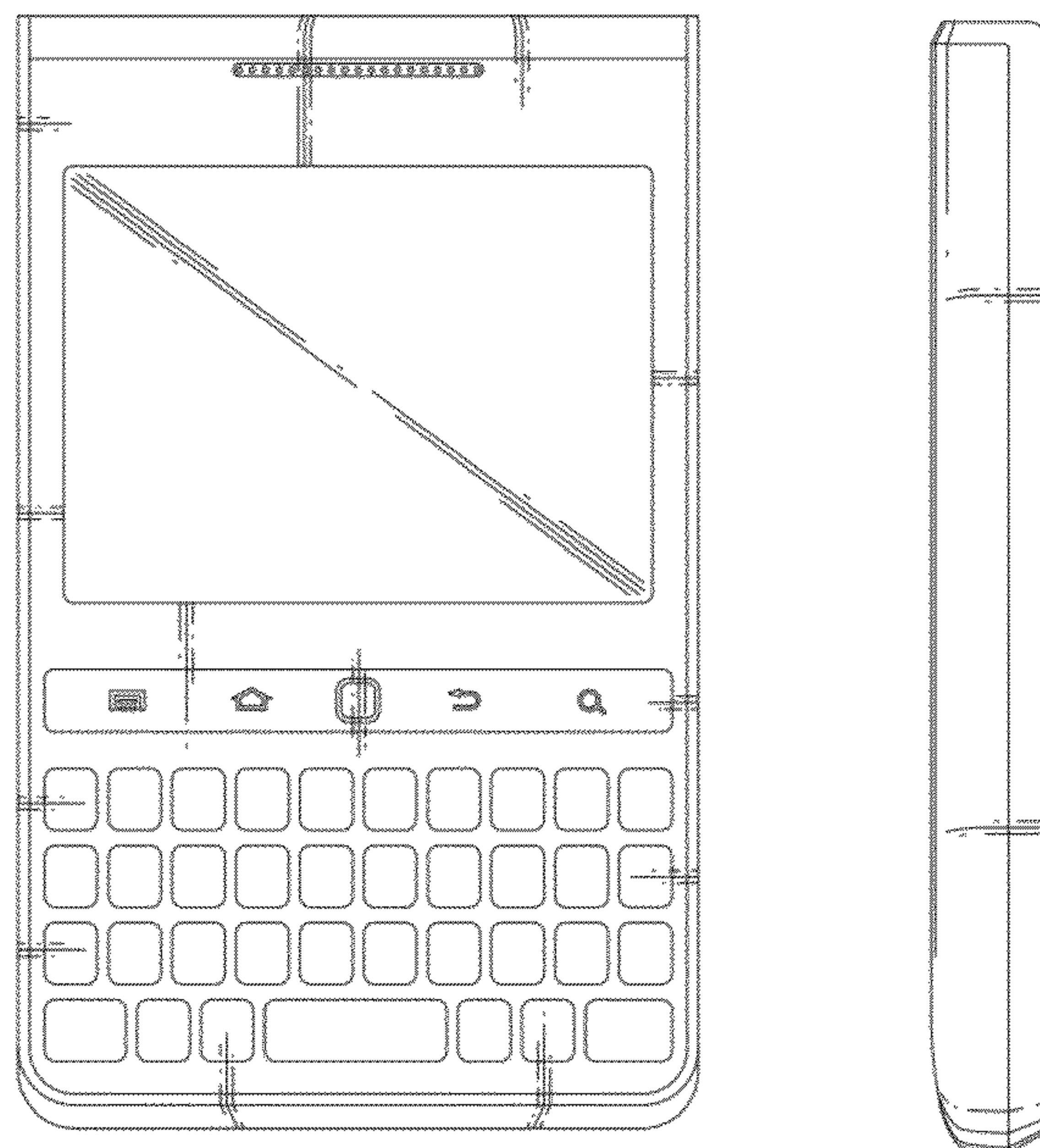
CLAIM

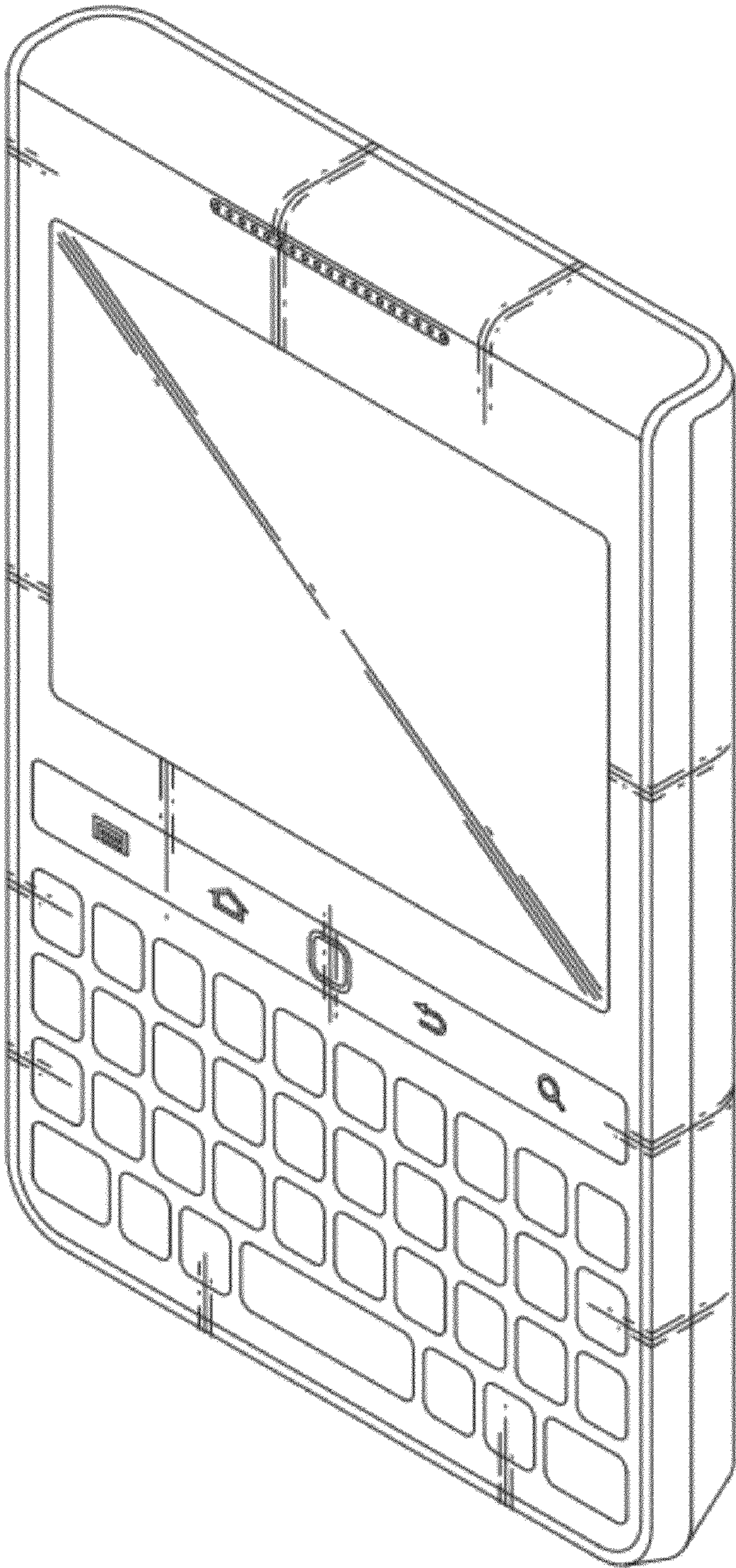

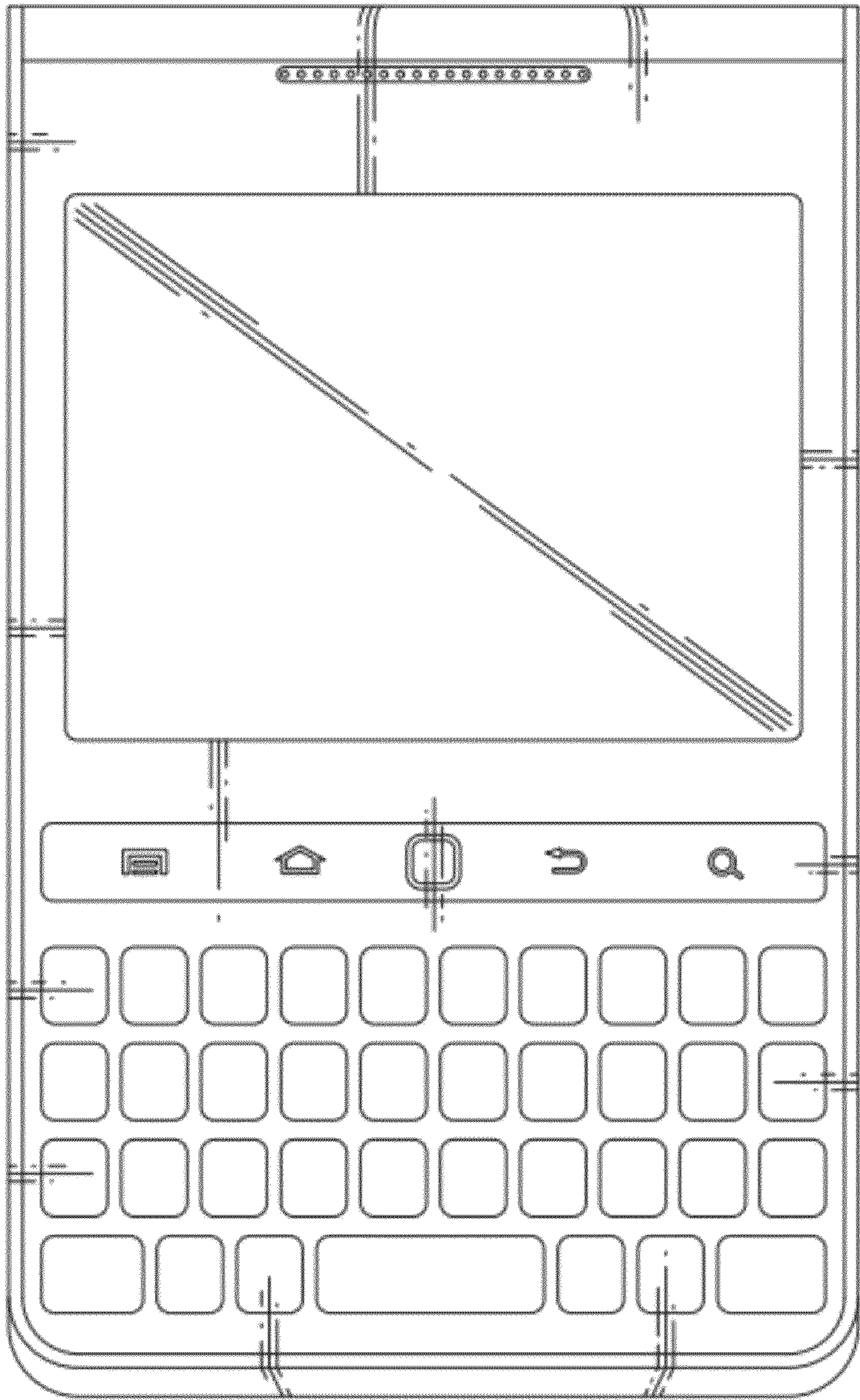

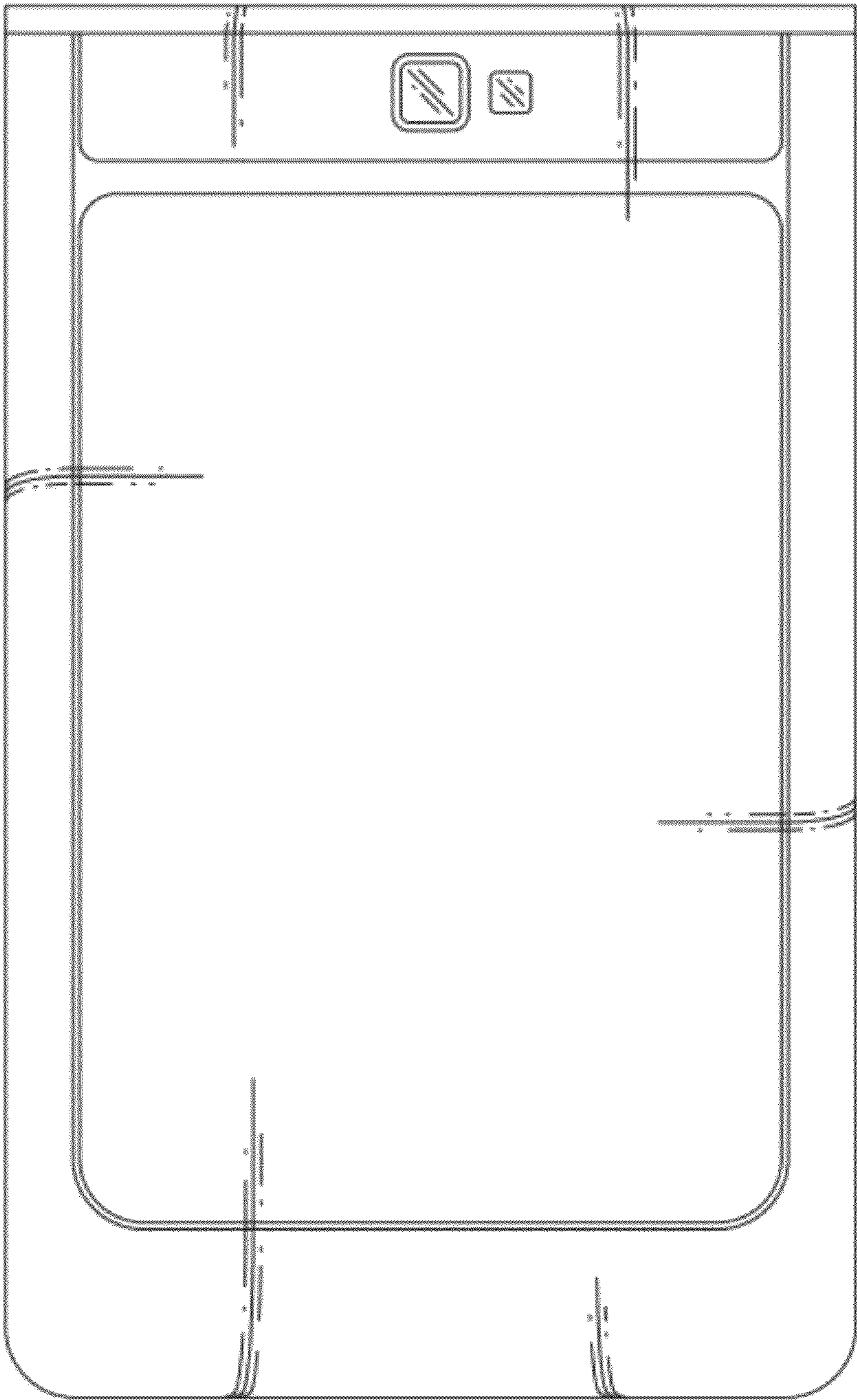

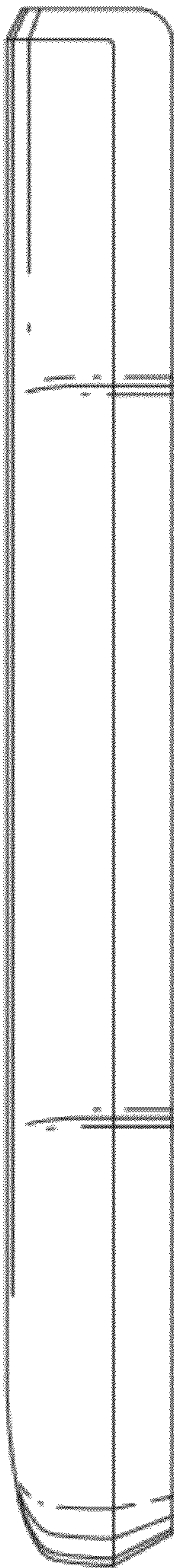

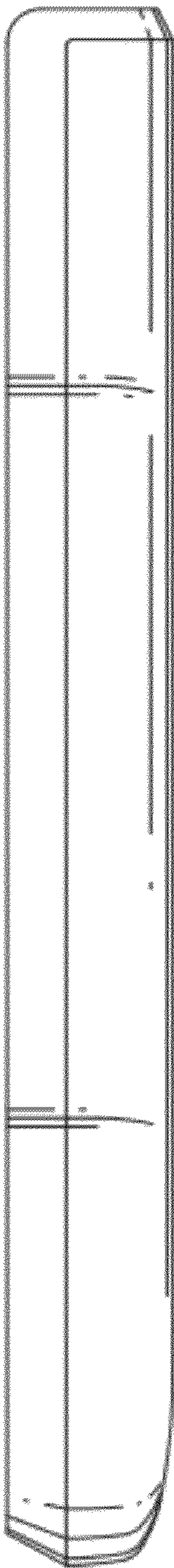
