(57) **CLAIM**

The ornamental design for a mobile phone case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mobile phone case; FIG. 2 is a front view of the mobile phone case of FIG. 1; FIG. 3 is a rear view of the mobile phone case of FIG. 1; FIG. 4 is a left-side view of the mobile phone case of FIG. 1; FIG. 5 is a right-side view of the mobile phone case of FIG. 1; FIG. 6 is a top plan view of the mobile phone case of FIG. 1; FIG. 7 is a bottom plan view of the mobile phone case of FIG. 1; and, FIG. 8 is a perspective view of the mobile phone case of FIG. 1 shown in an open state. In FIG. 8, the broken lines depict an unclaimed mobile phone. The broken lines form no part of the claimed design.

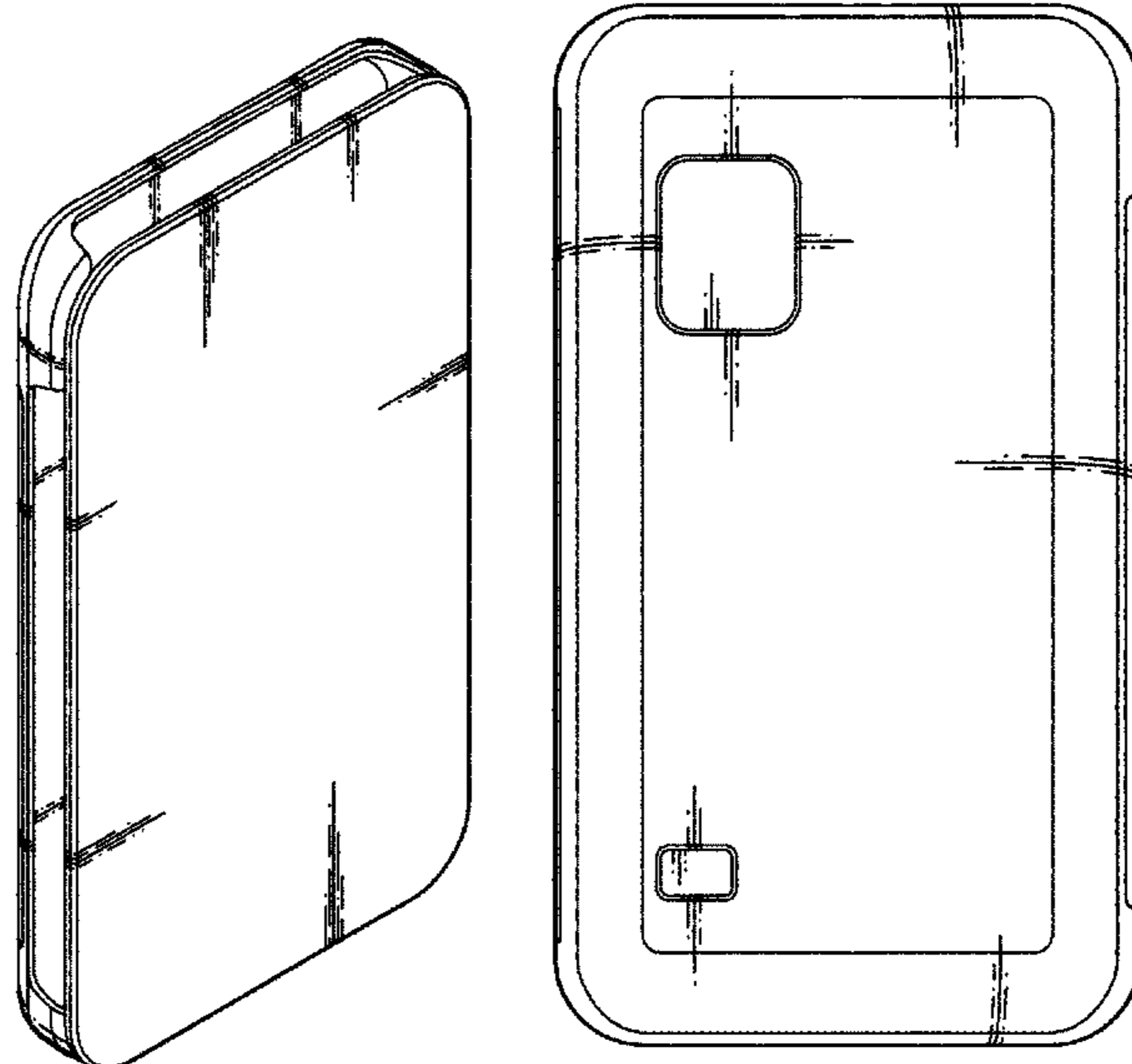

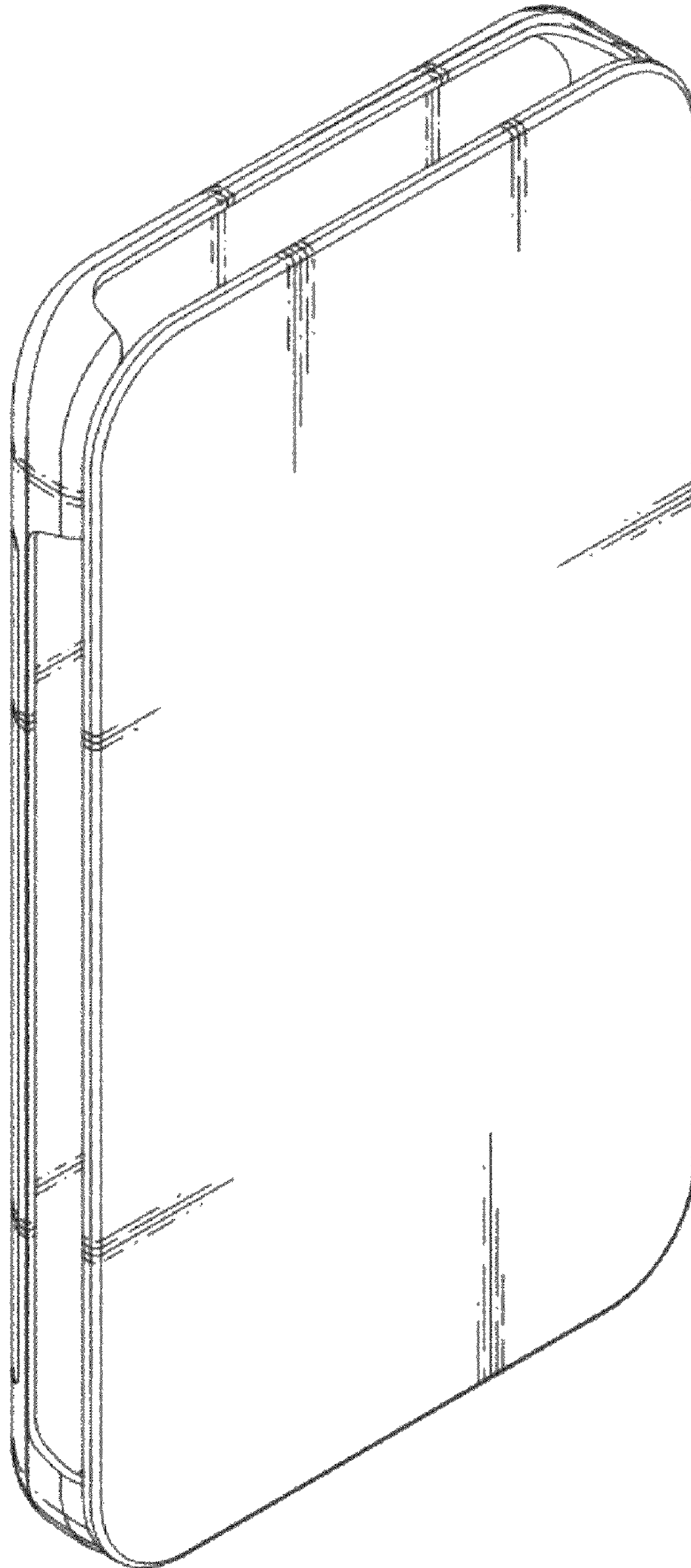

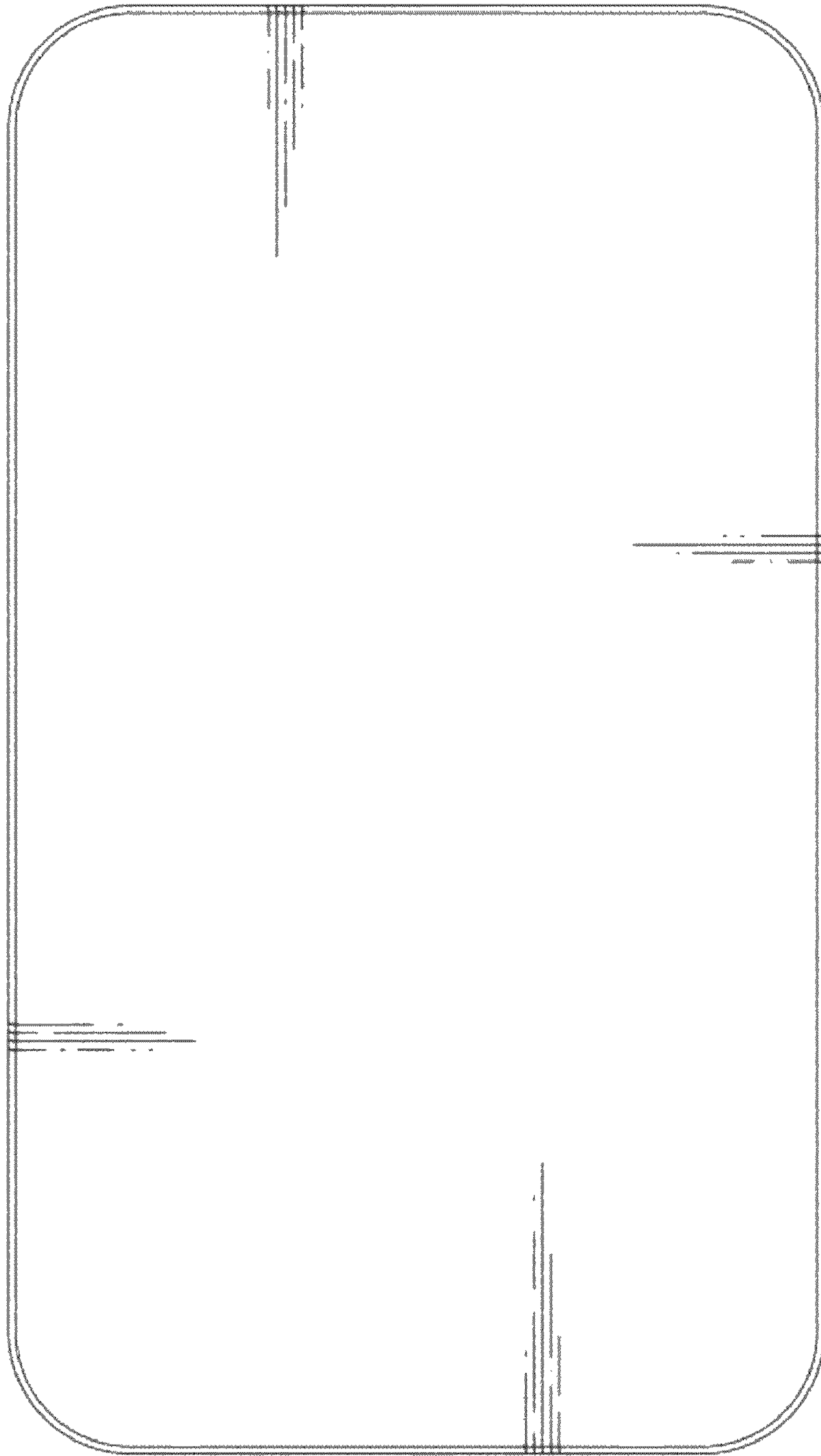

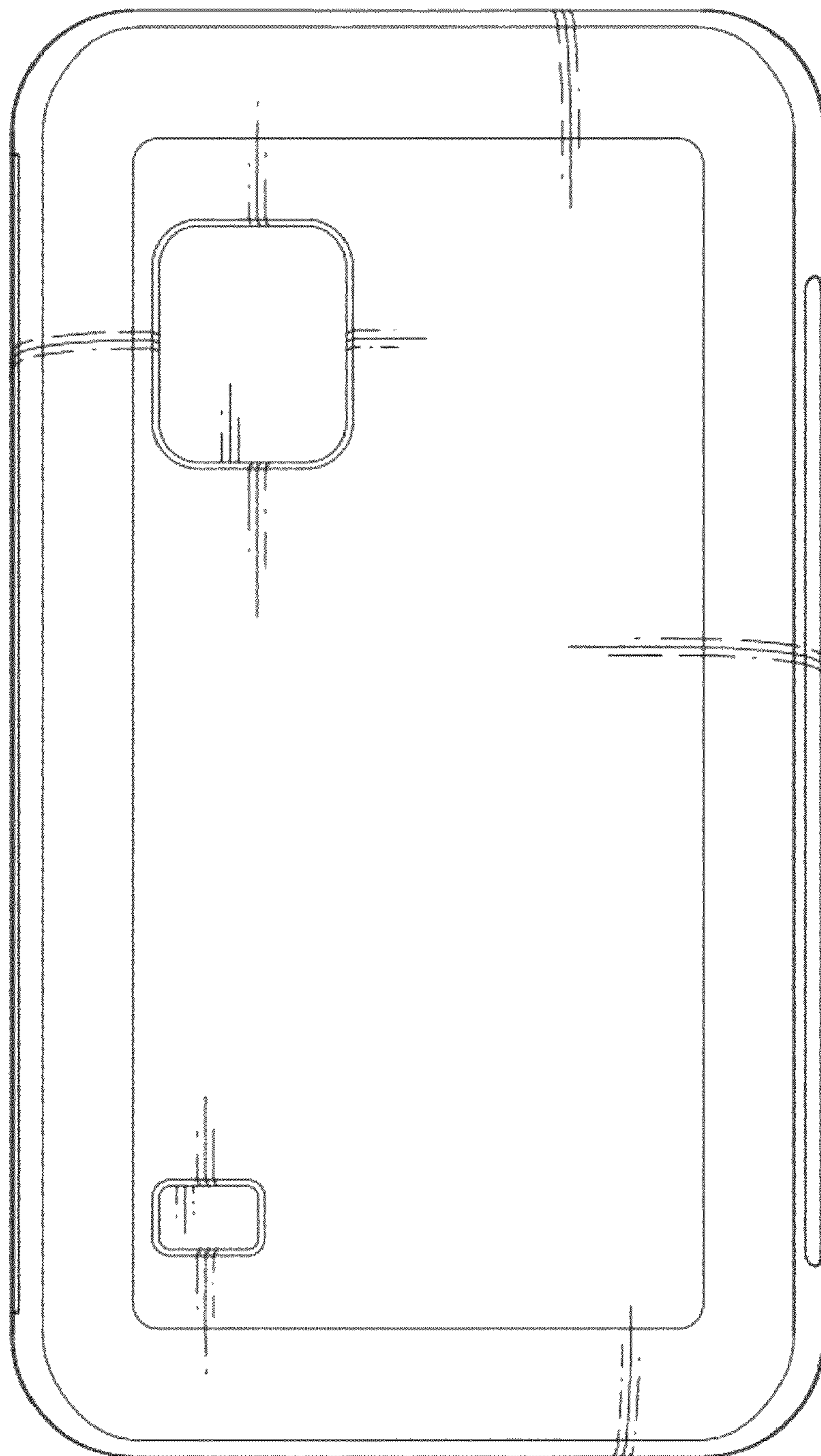

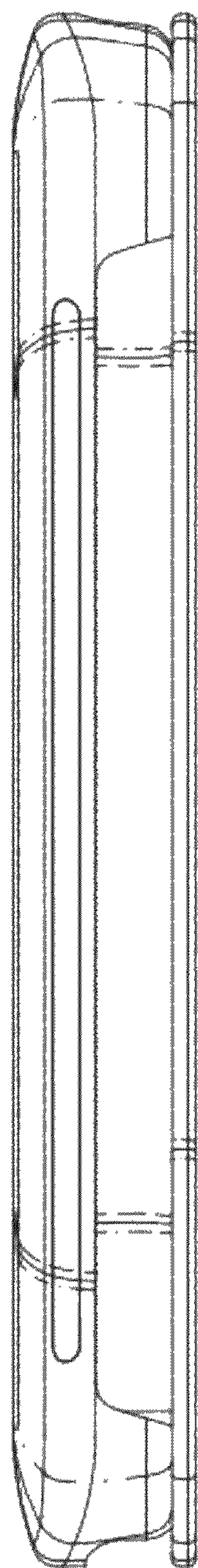

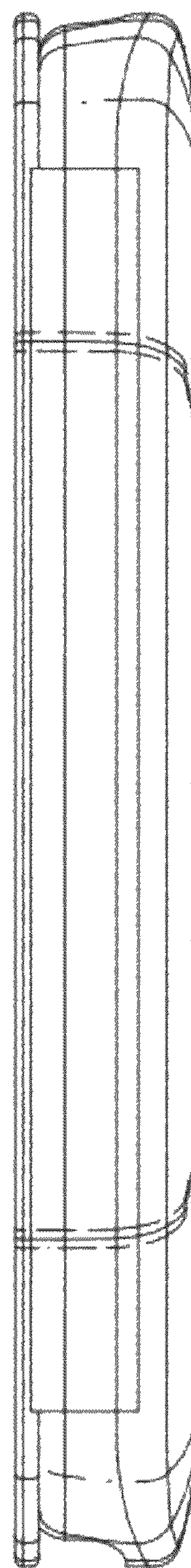

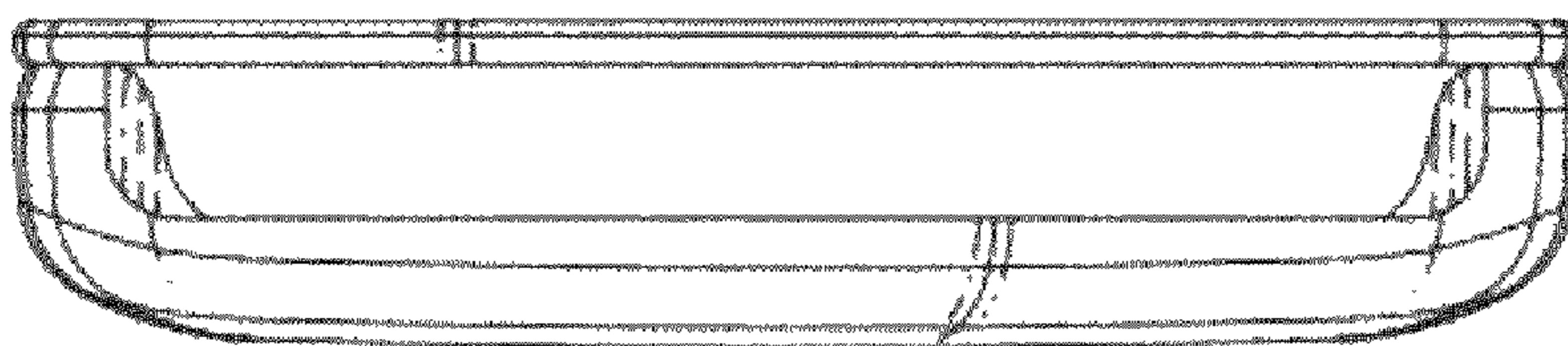
