I claim the ornamental design for a card for electronic computer, as shown and described.

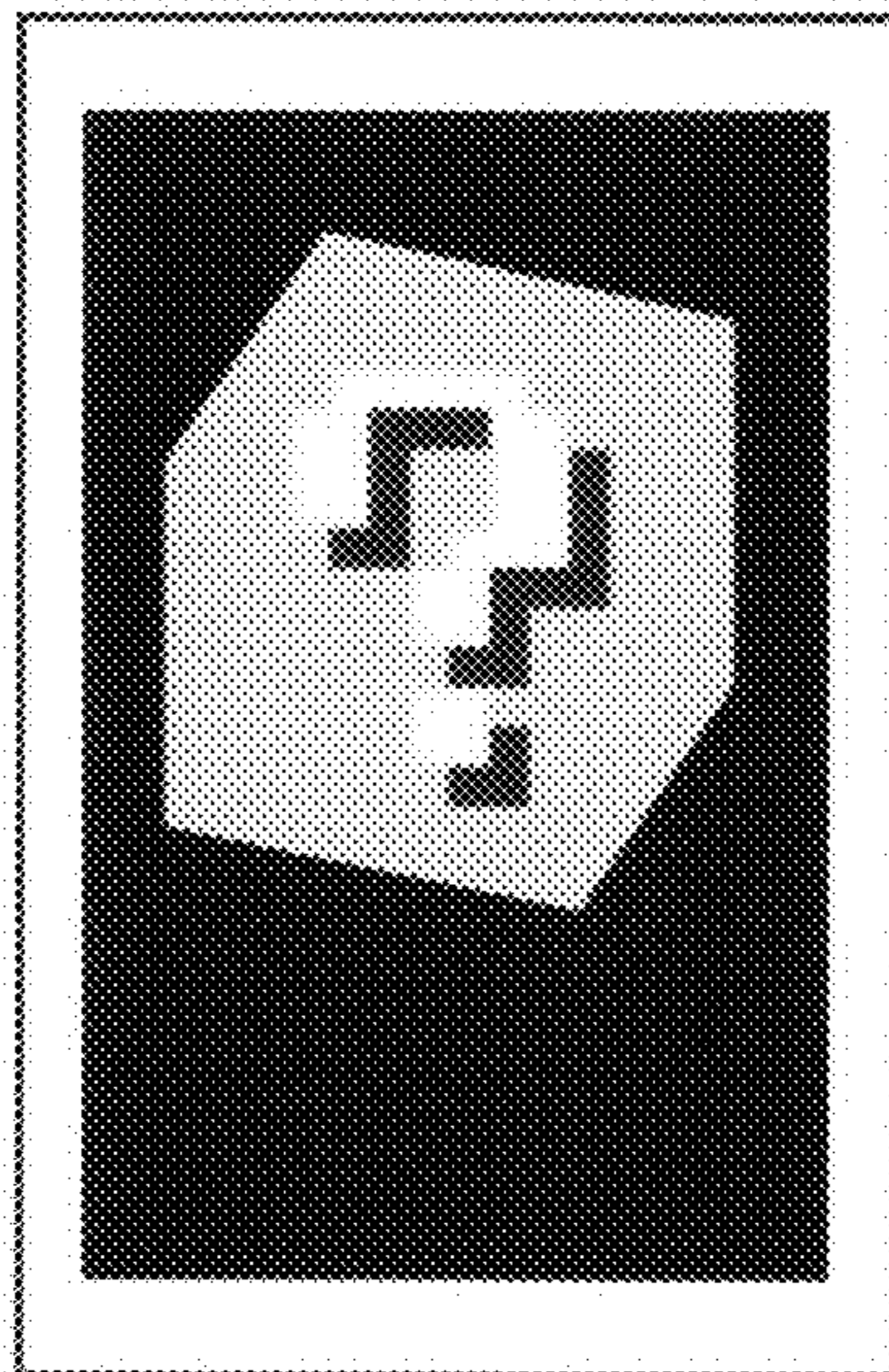
DESCRIPTION
