FIG. 2 is a front view of the writing board of Applicant's invention.

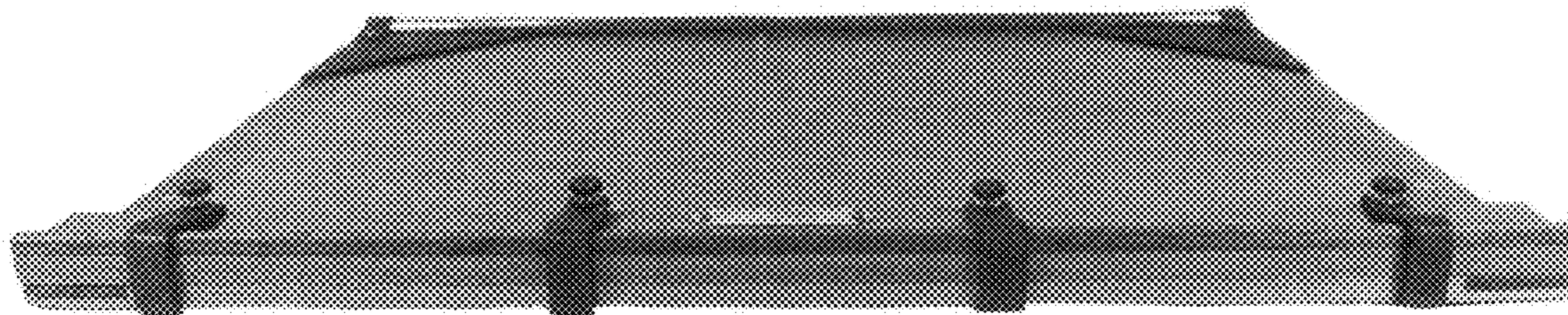
FIG. 3 is a back view of the writing board of Applicant's invention.

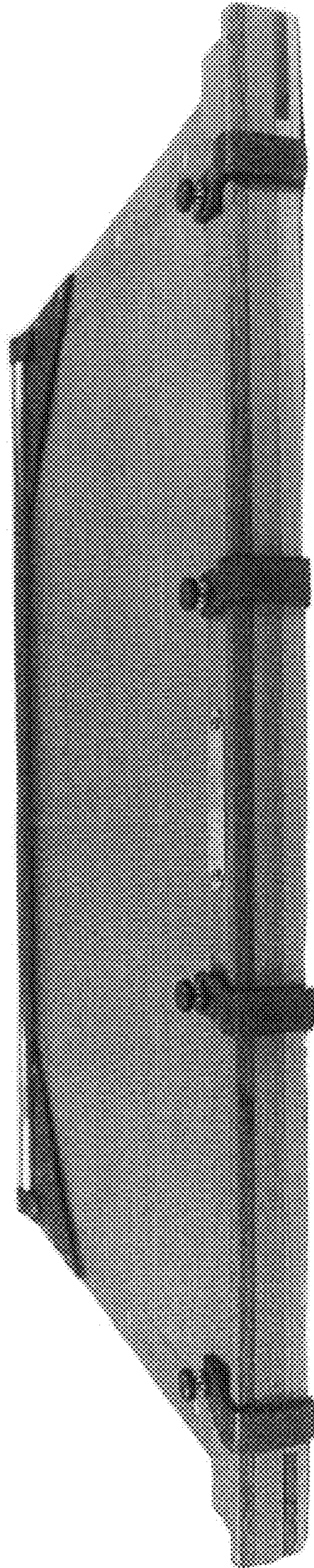

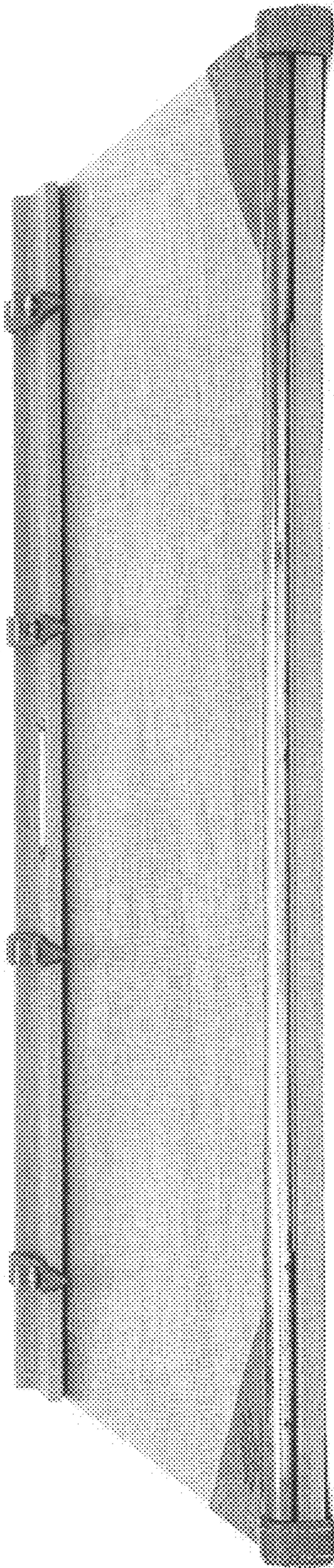

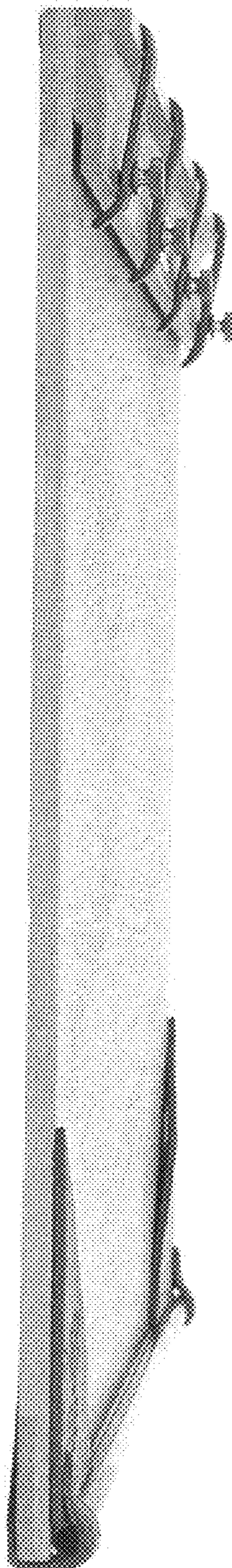

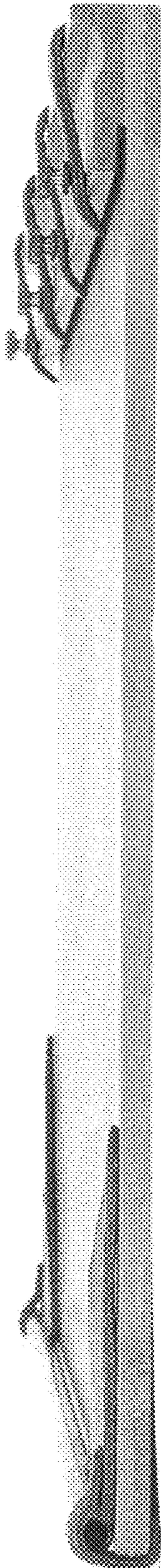
