**DESCRIPTION**

FIG. 1 is a rear elevational view of a combustion tube;  
FIG. 2 is a right side elevational view thereof; a left side  
elevational view is identical as the right side elevational view;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is an enlarged detail taken from FIG. 3 thereof;  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a rear perspective view thereof.

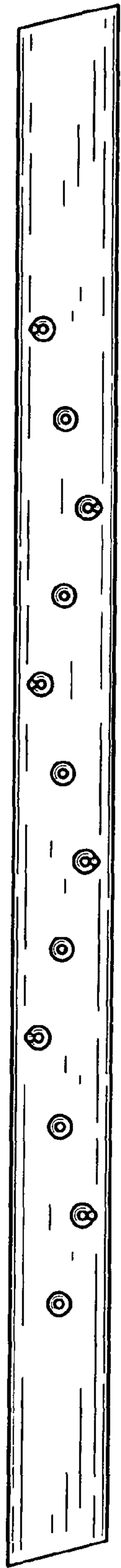

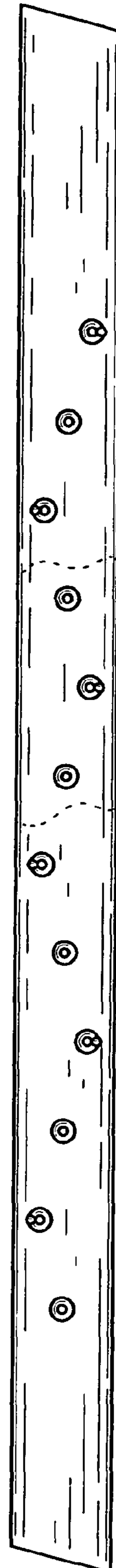

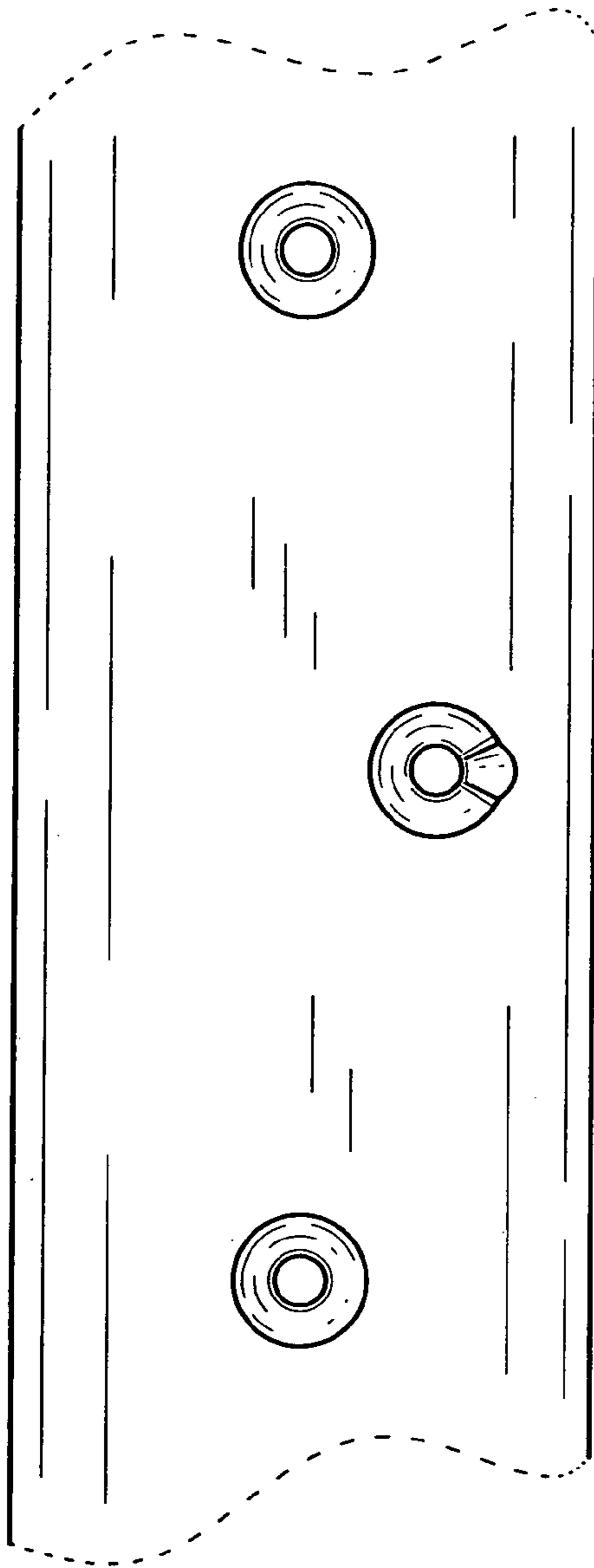

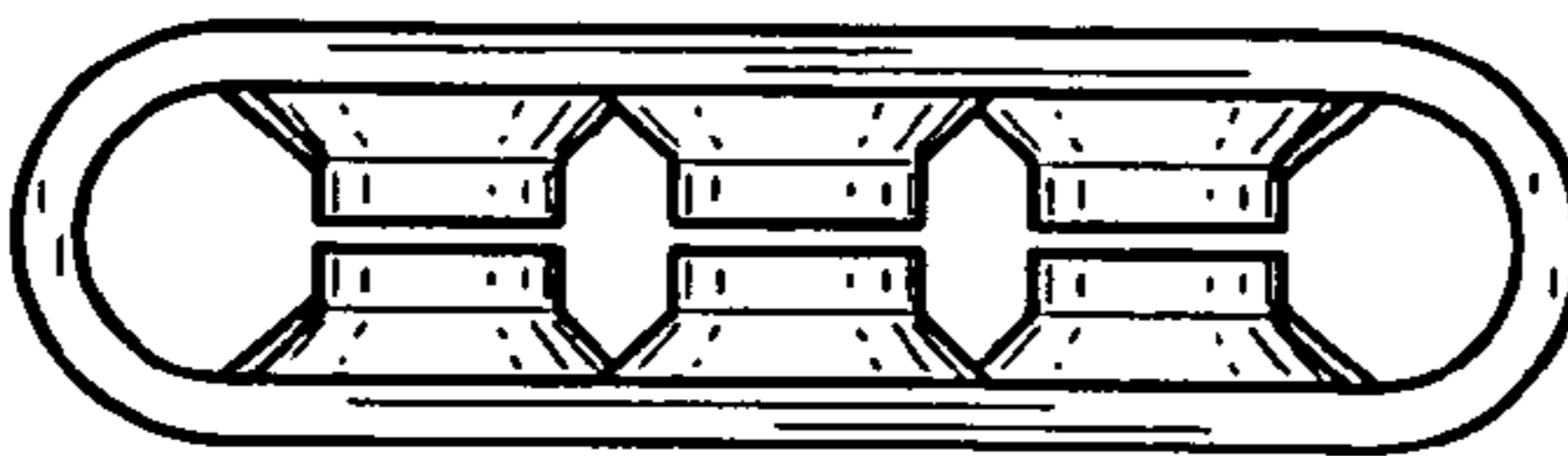

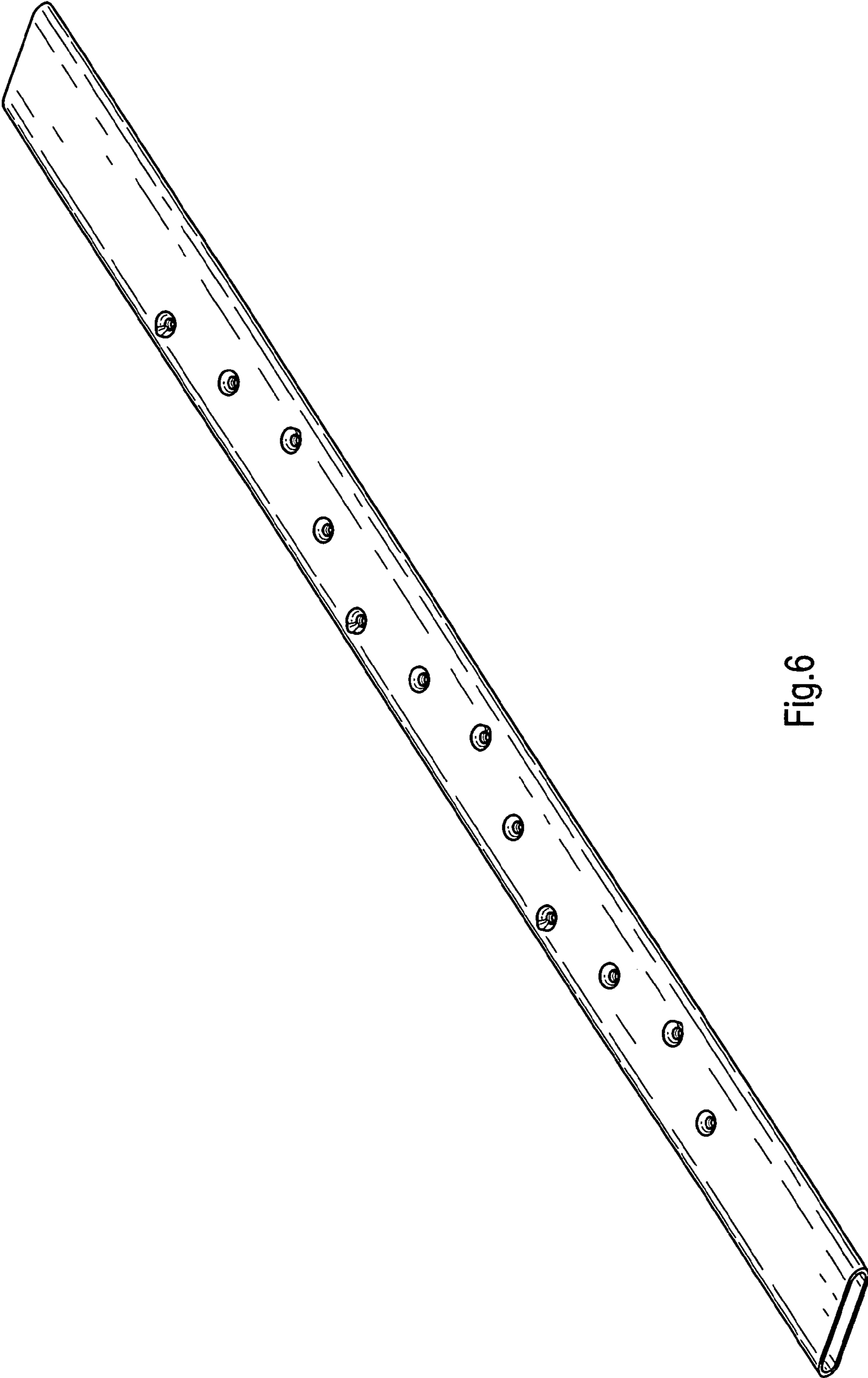
