(57) **CLAIM**

The ornamental design for a soft cup chin guard, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper perspective view of the soft cup chin guard showing my design.

FIG. 2 is a front elevation view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

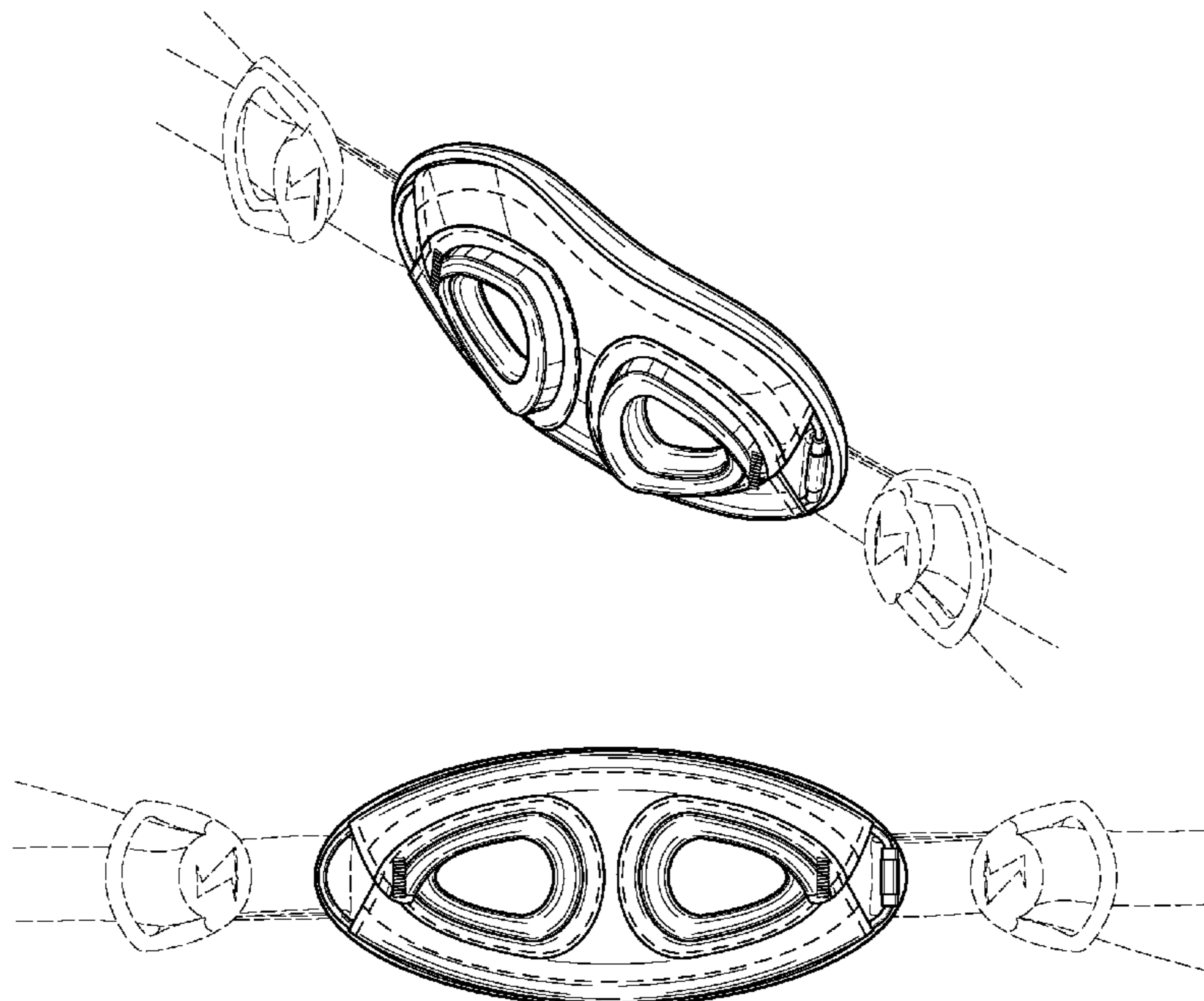
FIG. 5 is back elevation view thereof;

FIG. 6 is a side elevation view thereof; and,

FIG. 7 is an opposite side elevation view thereof.

In the drawings, the broken lines extending outwards from the soft cup chin guard in FIGS. 1-7 depict portions of the design that form no part of the claim. The broken lines on the soft cup chin guard in FIGS. 1-7 represent stitching.

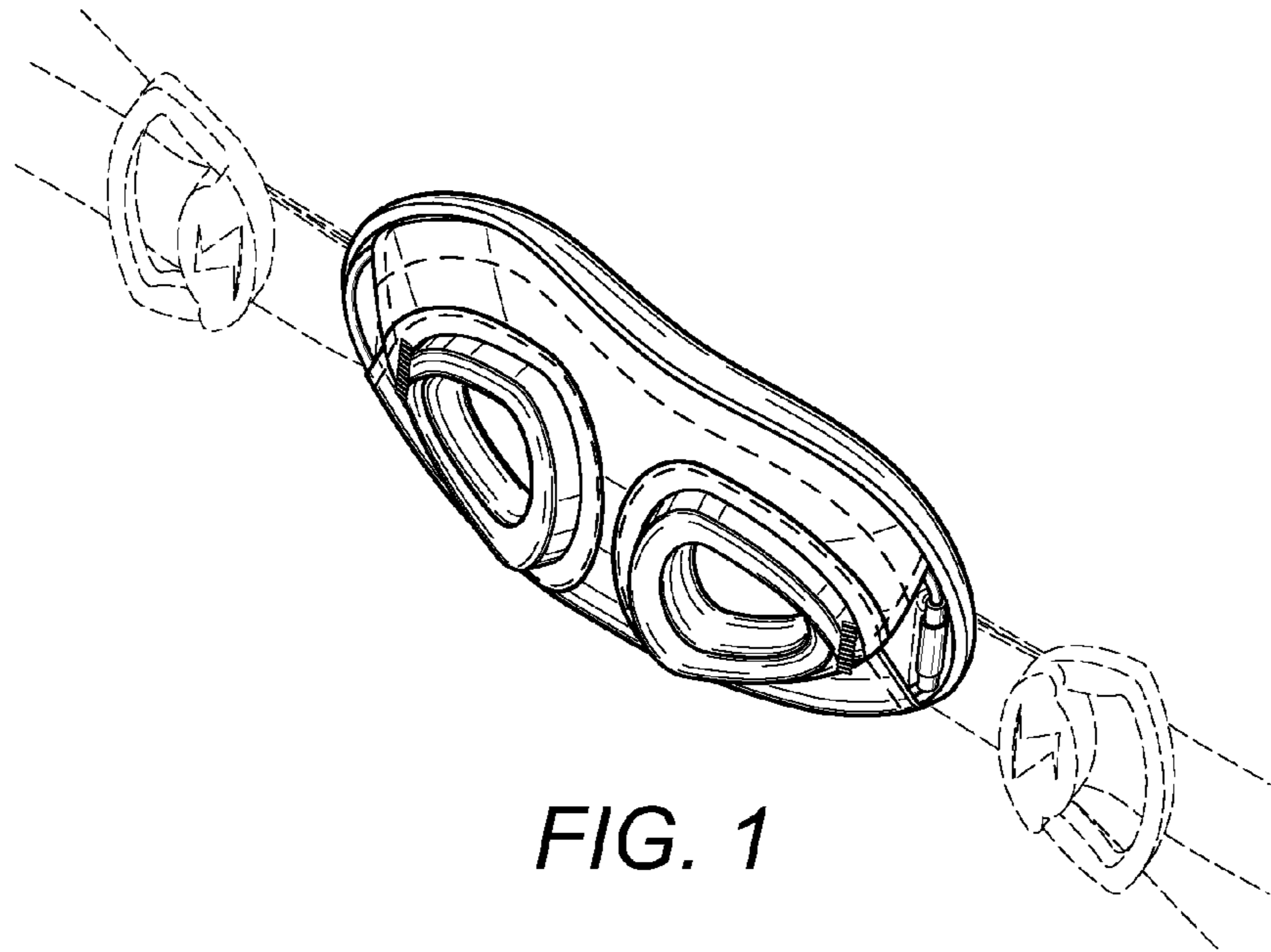

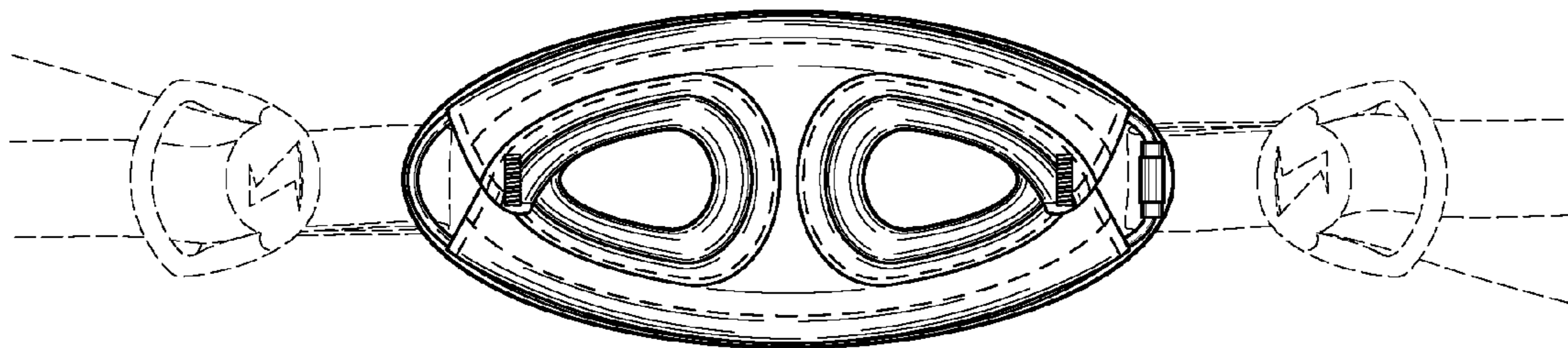

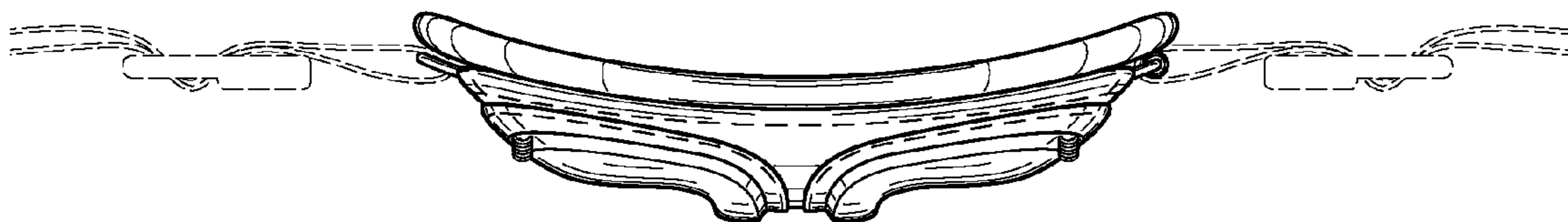

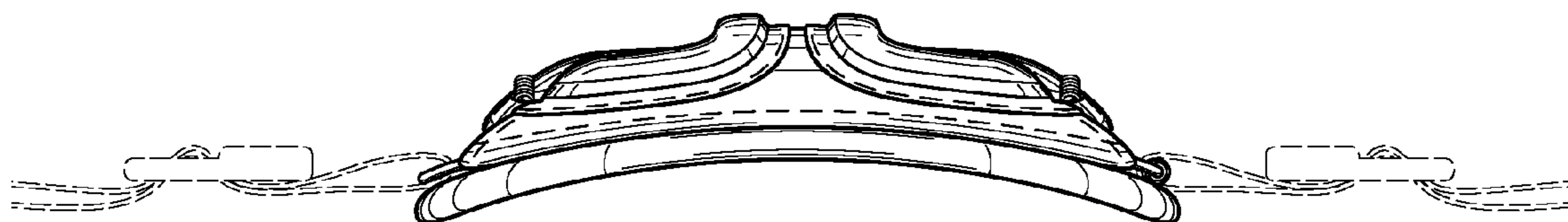

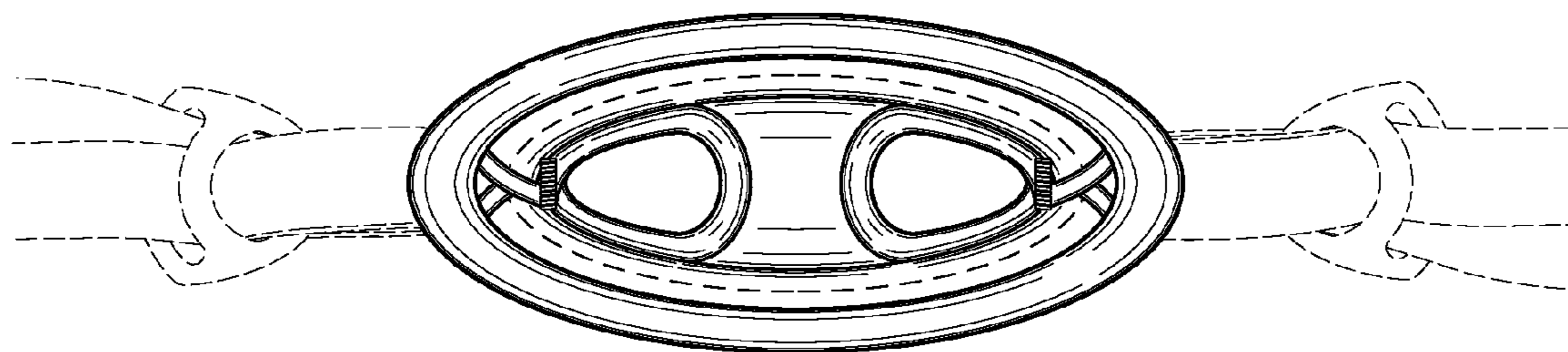

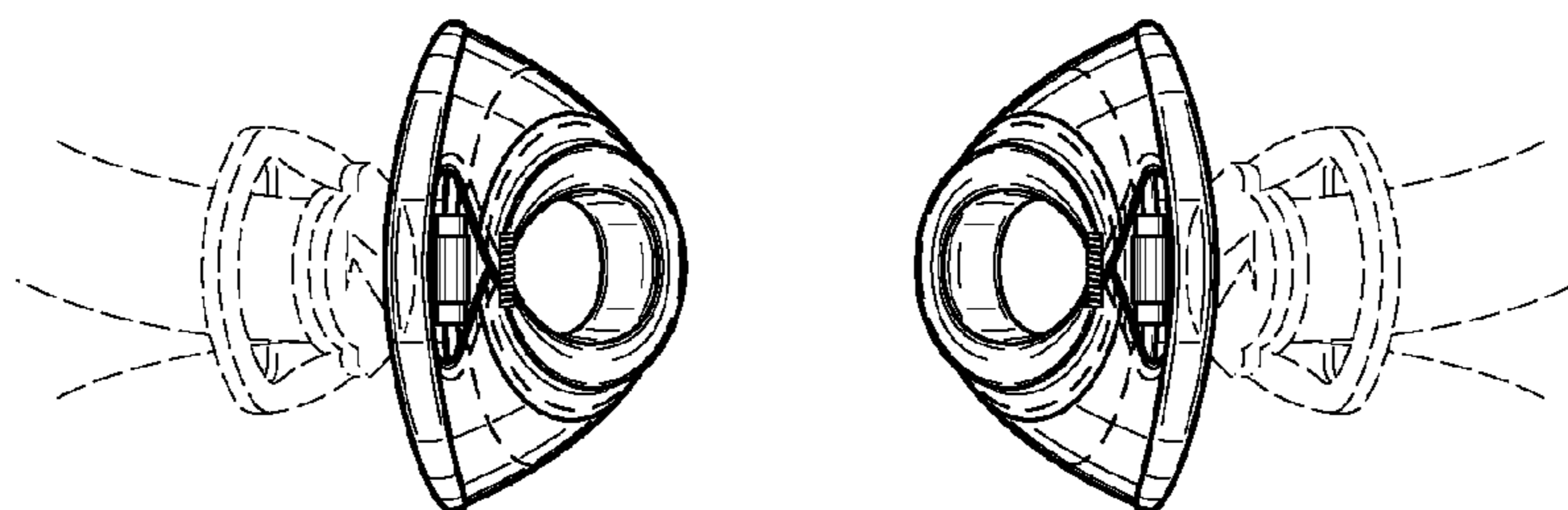
